(57) **CLAIM**

The ornamental design for a surgical scrub mock neck shirt with panels, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a surgical scrub mock neck shirt with panels showing our new design according to a first embodiment;

FIG. 2 is a rear view of the design shown in FIG. 1;

FIG. 3 is a front view of a surgical scrub mock neck shirt with panels showing our new design according to a second embodiment;

FIG. 4 is a rear view of the design shown in FIG. 3;

FIG. 5 is a front view of a surgical scrub mock neck shirt with panels showing our new design according to a third embodiment;

FIG. 6 is a rear view of the design shown in FIG. 5;

FIG. 7 is a front view of a surgical scrub mock neck shirt with panels showing our new design according to a fourth embodiment;

FIG. 8 is a rear view of the design shown in FIG. 7;

FIG. 9 is a front view of a surgical scrub mock neck shirt with panels showing our new design according to a fifth embodiment;

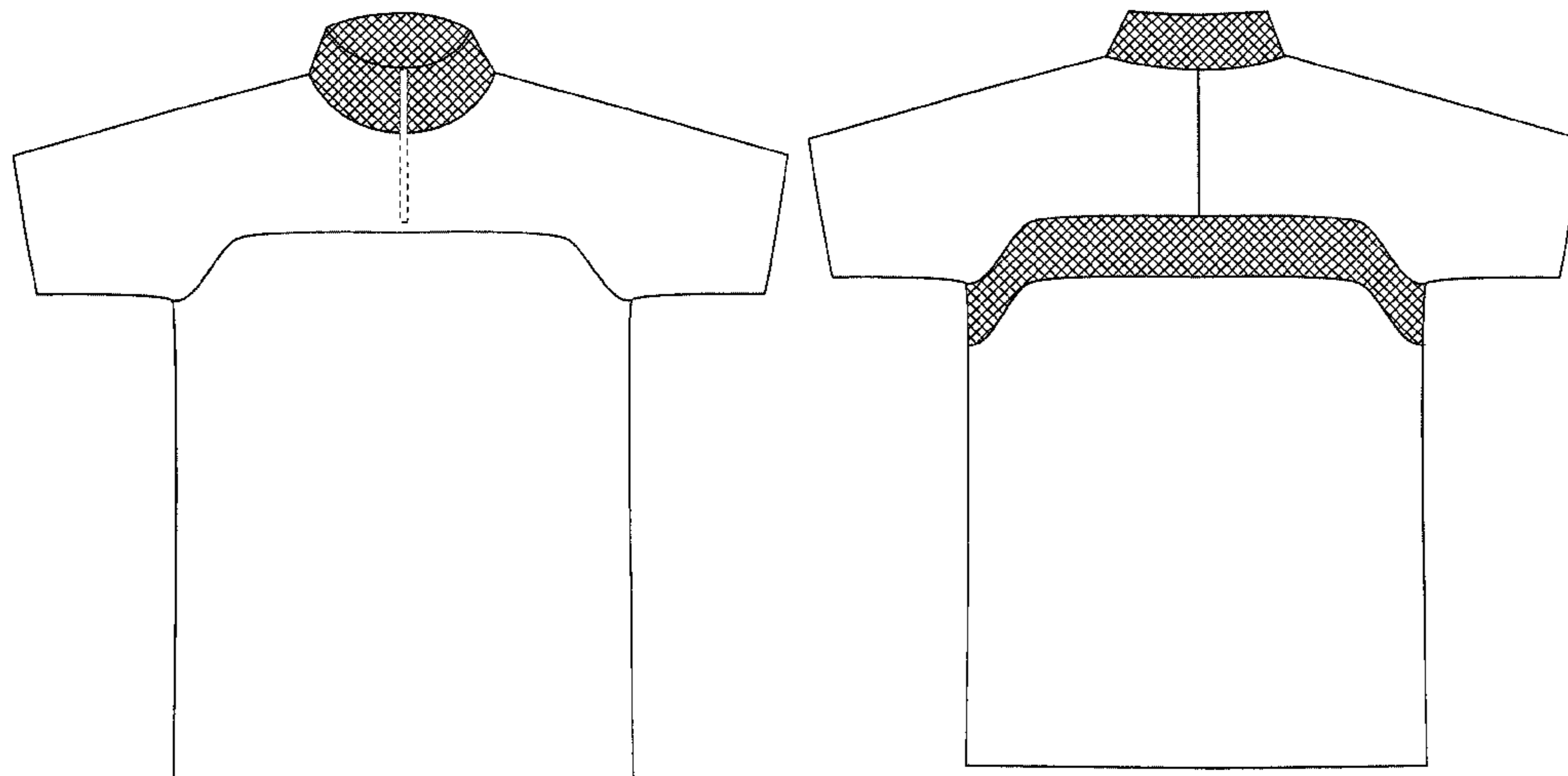
FIG. 10 is a rear view of the design shown in FIG. 9;

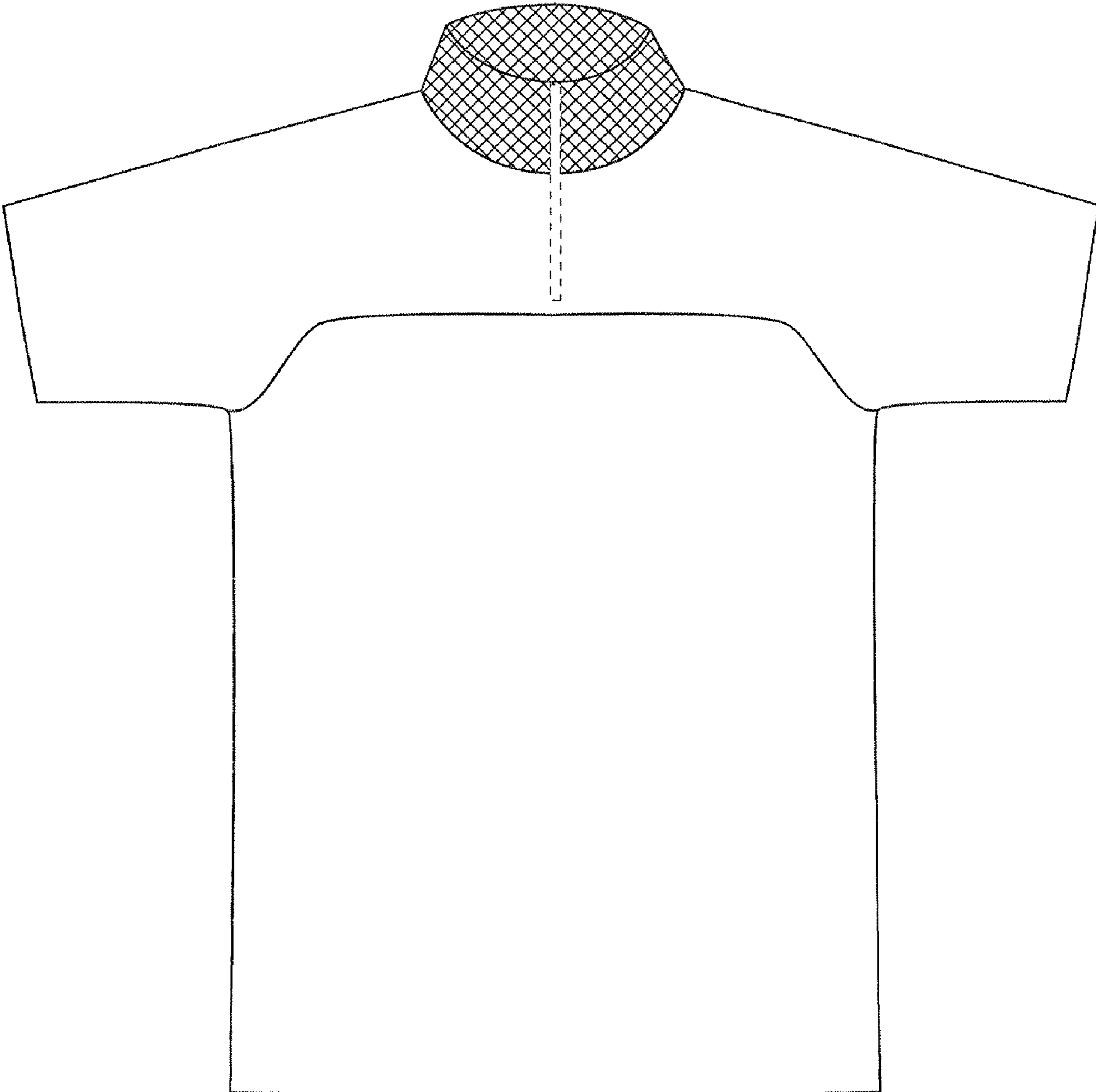

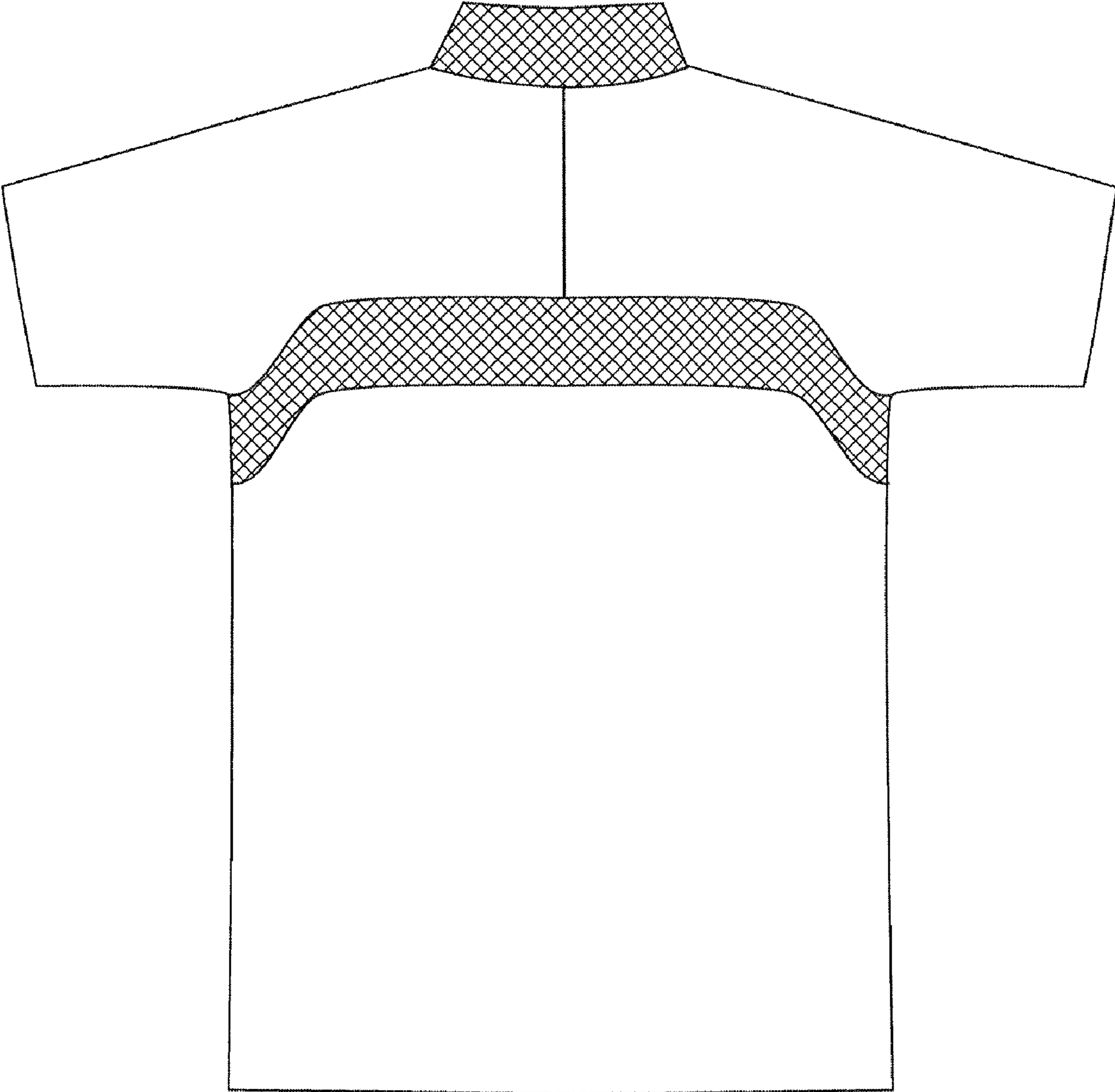

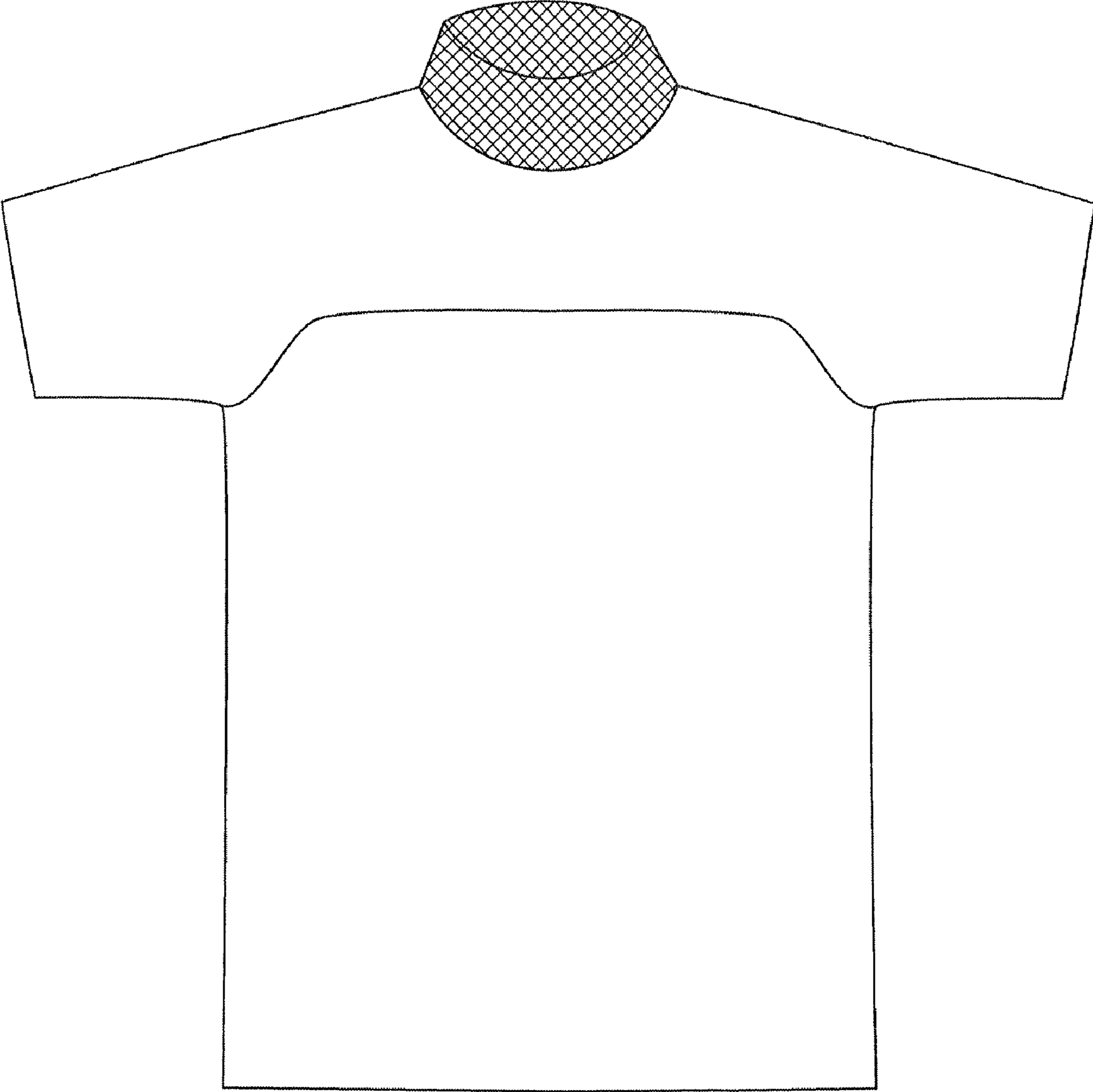

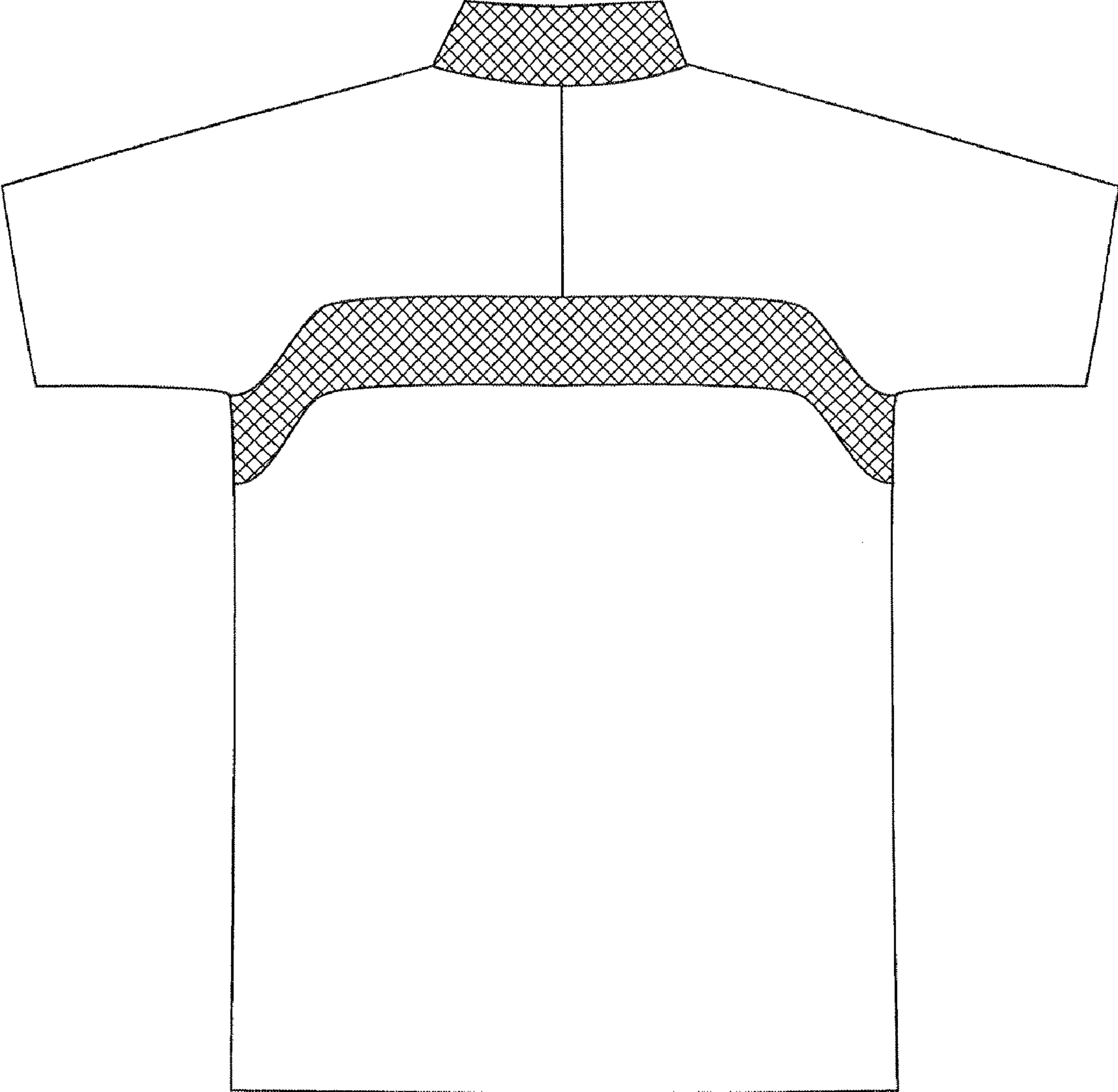

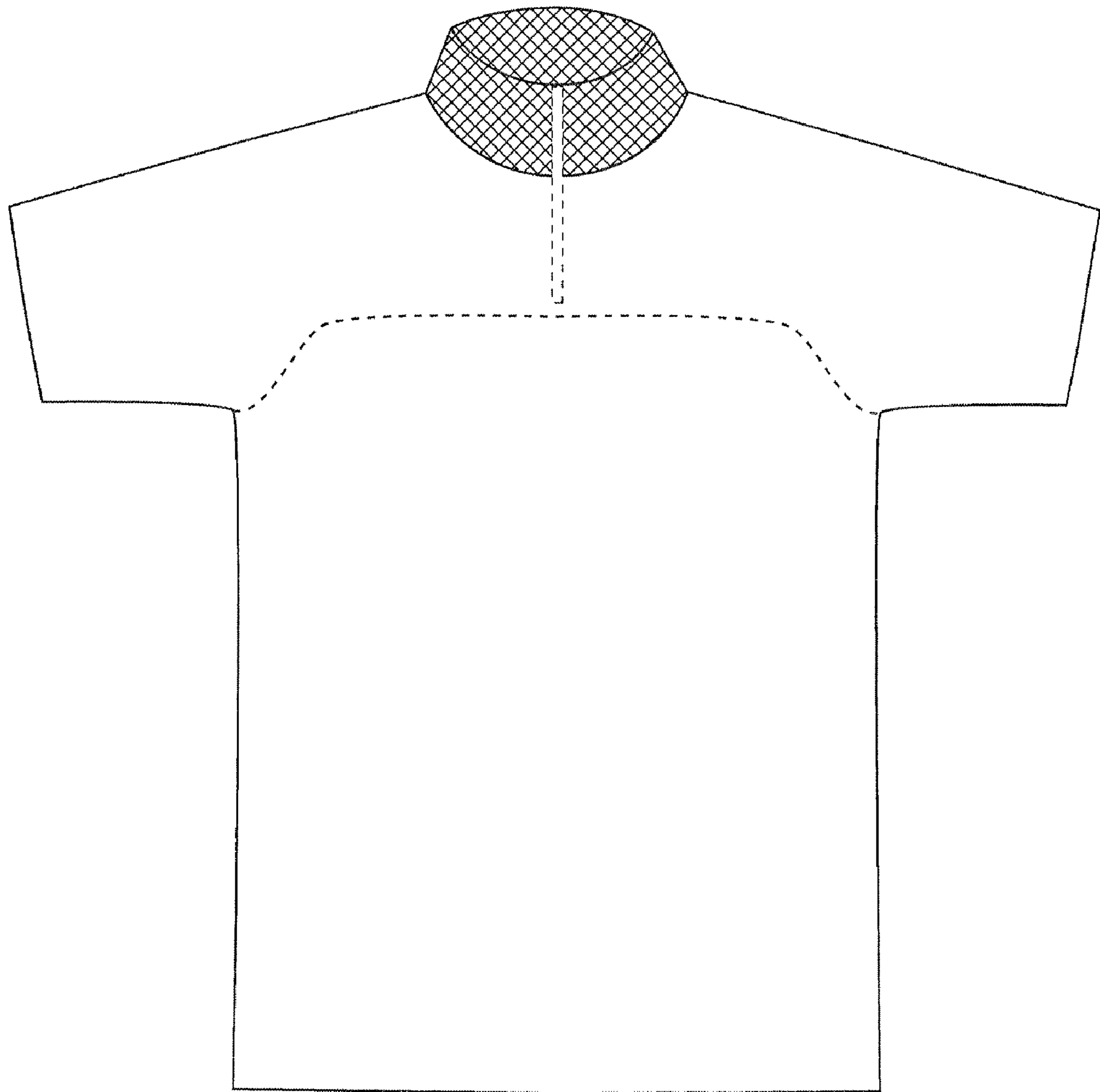

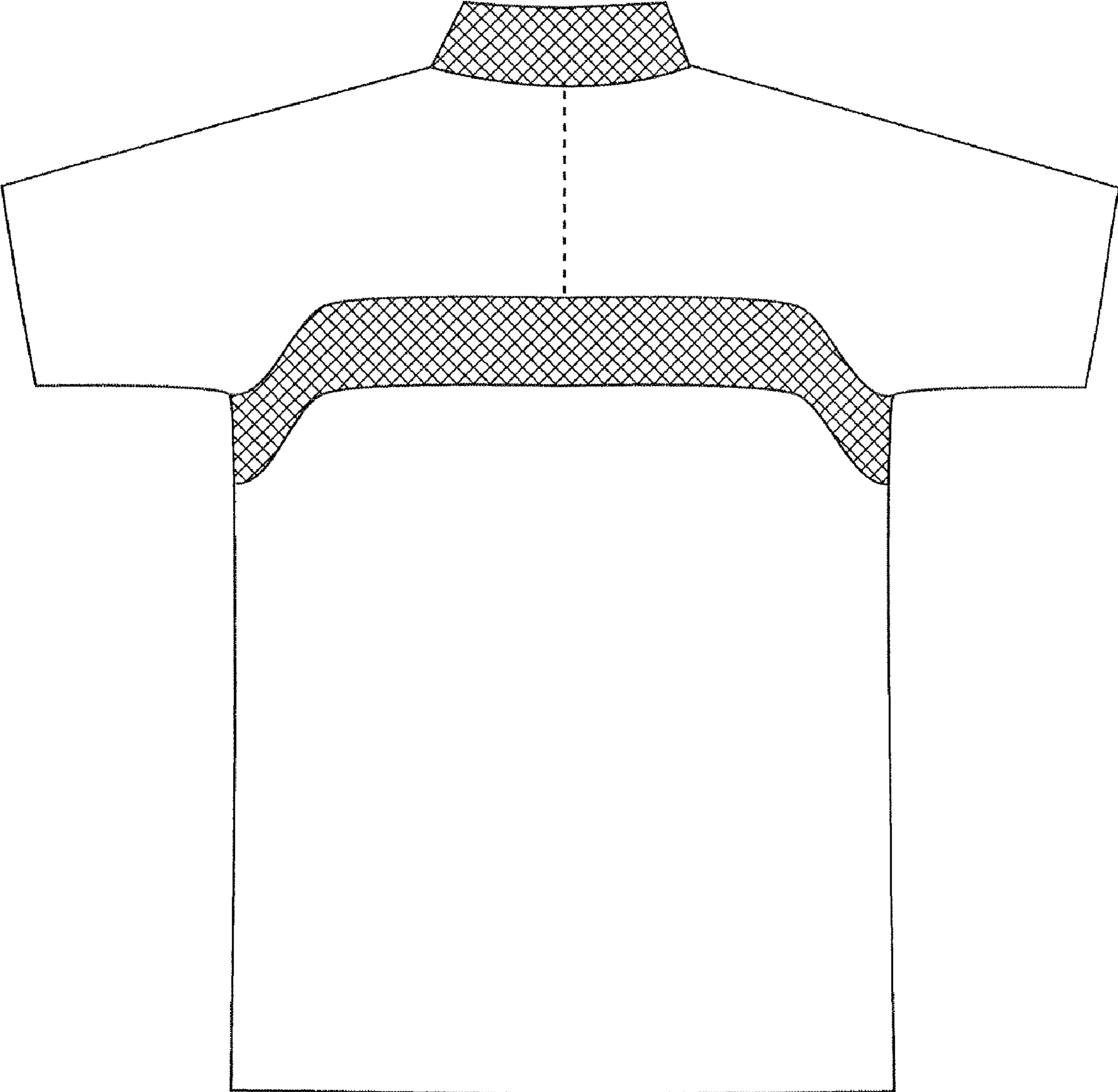

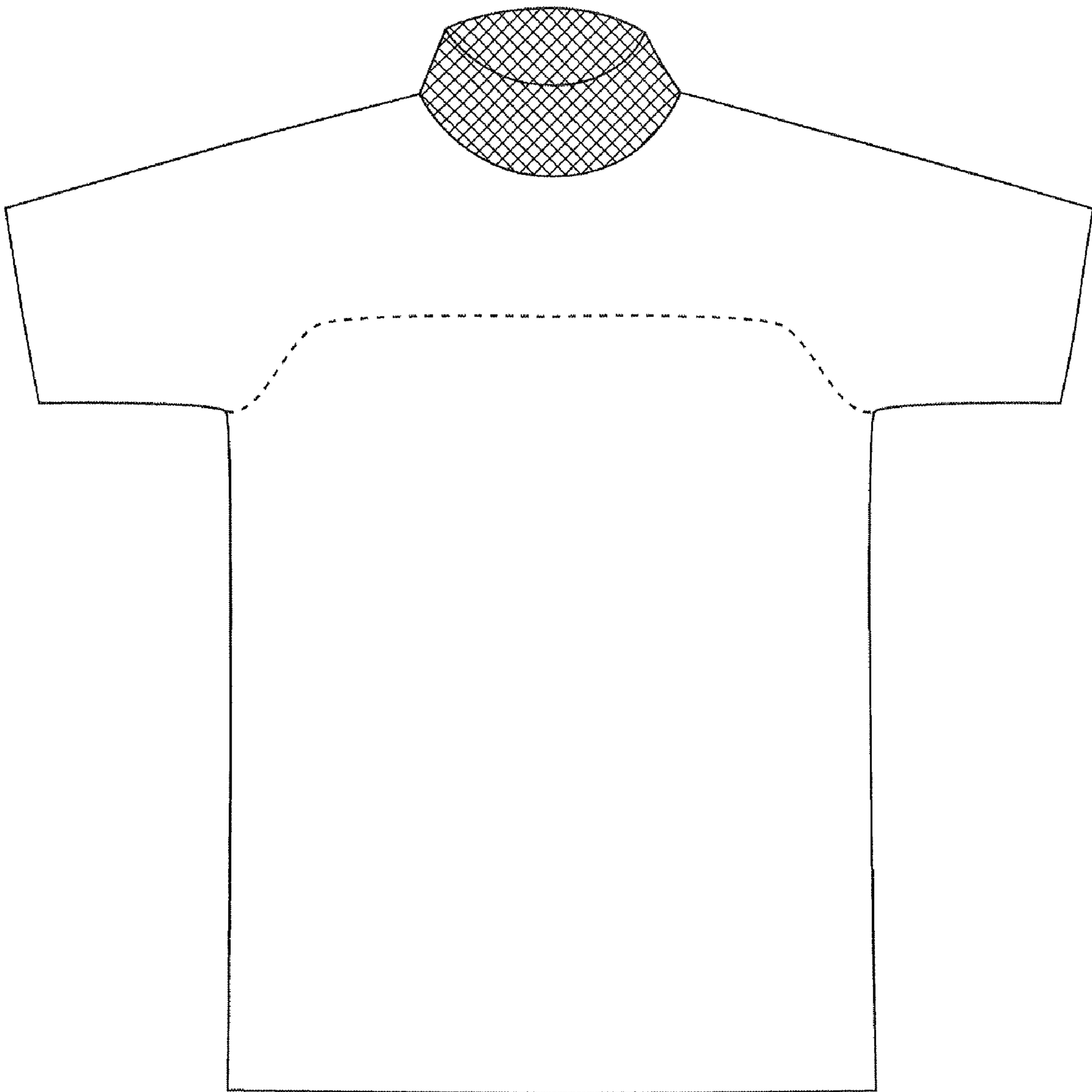

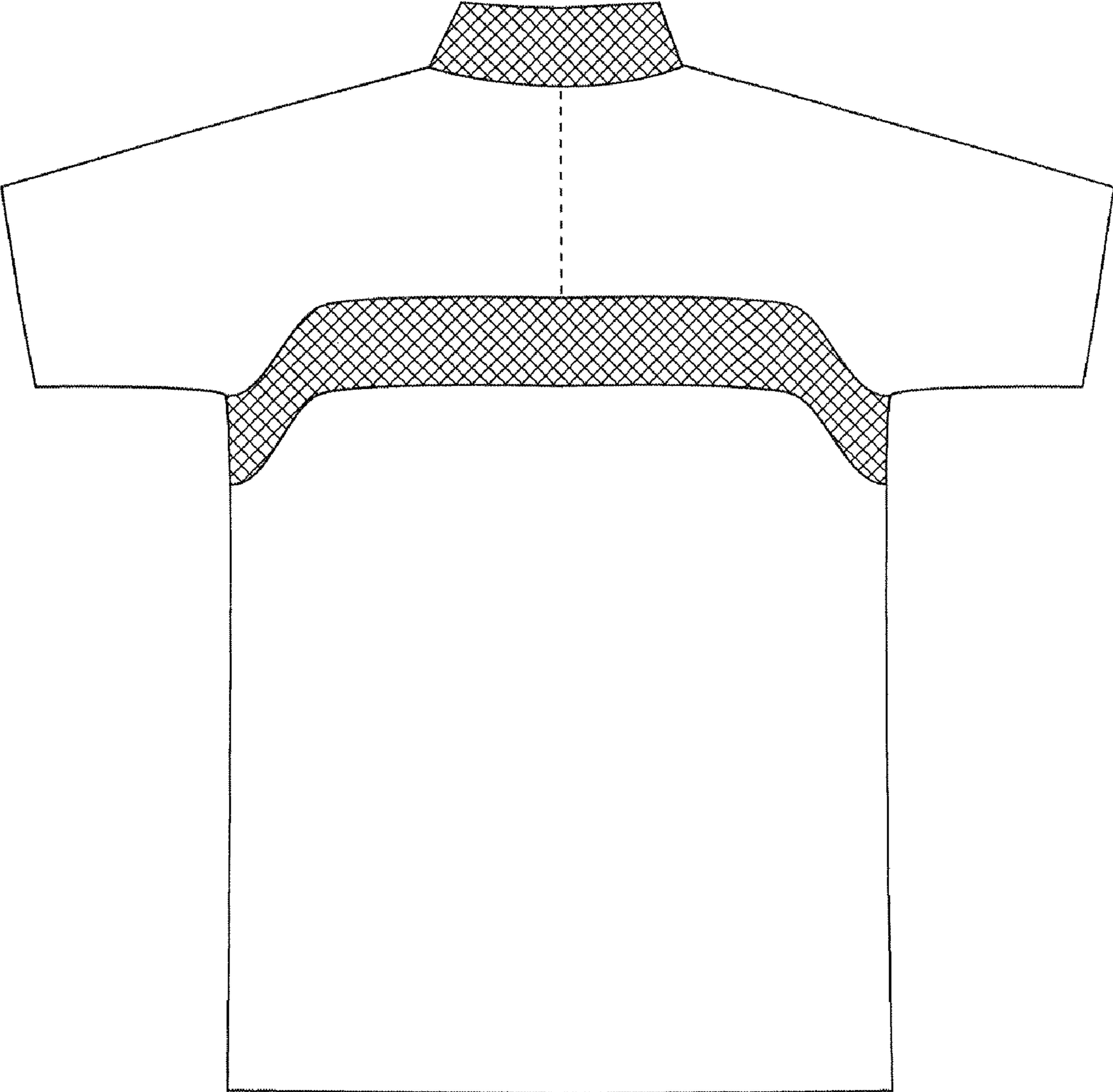

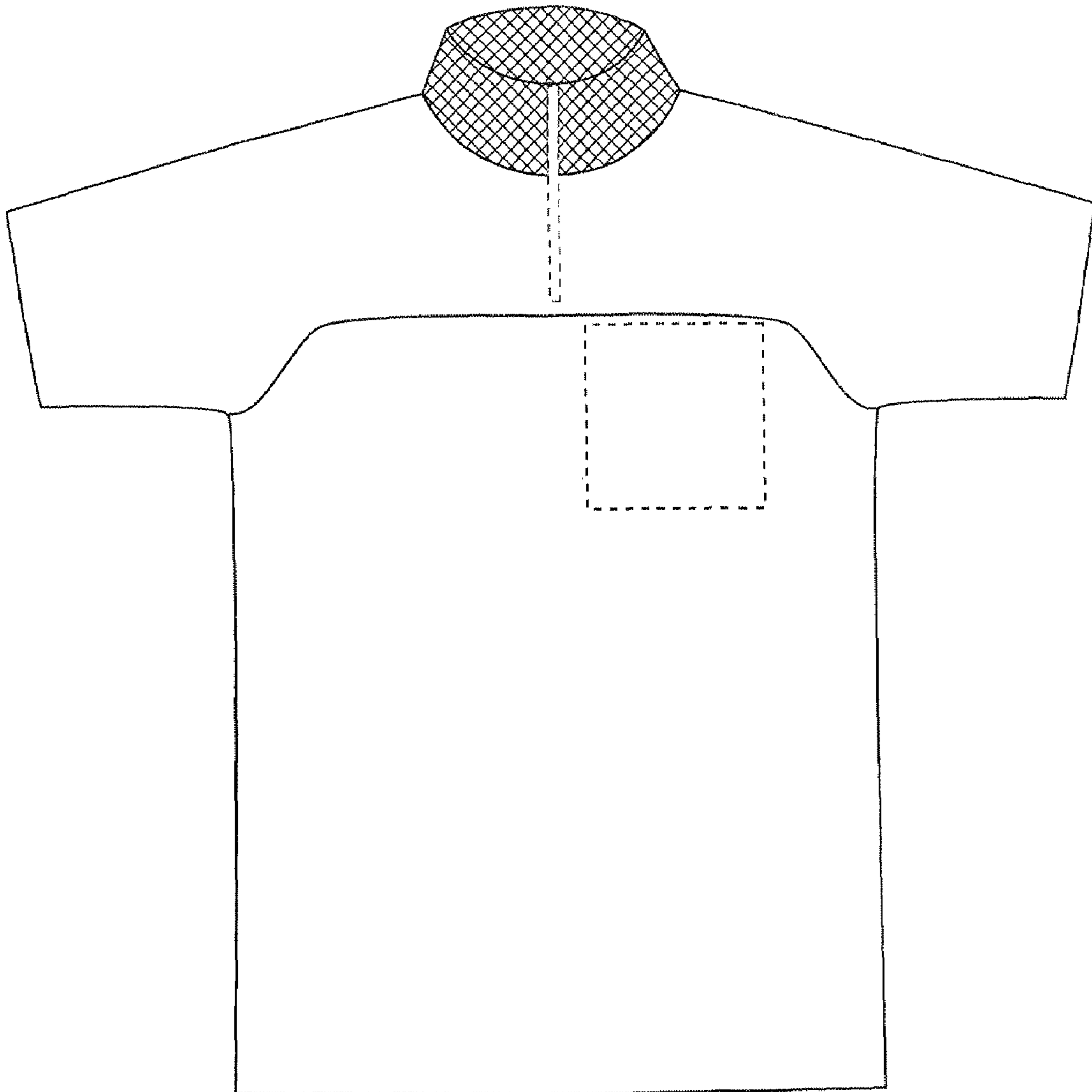

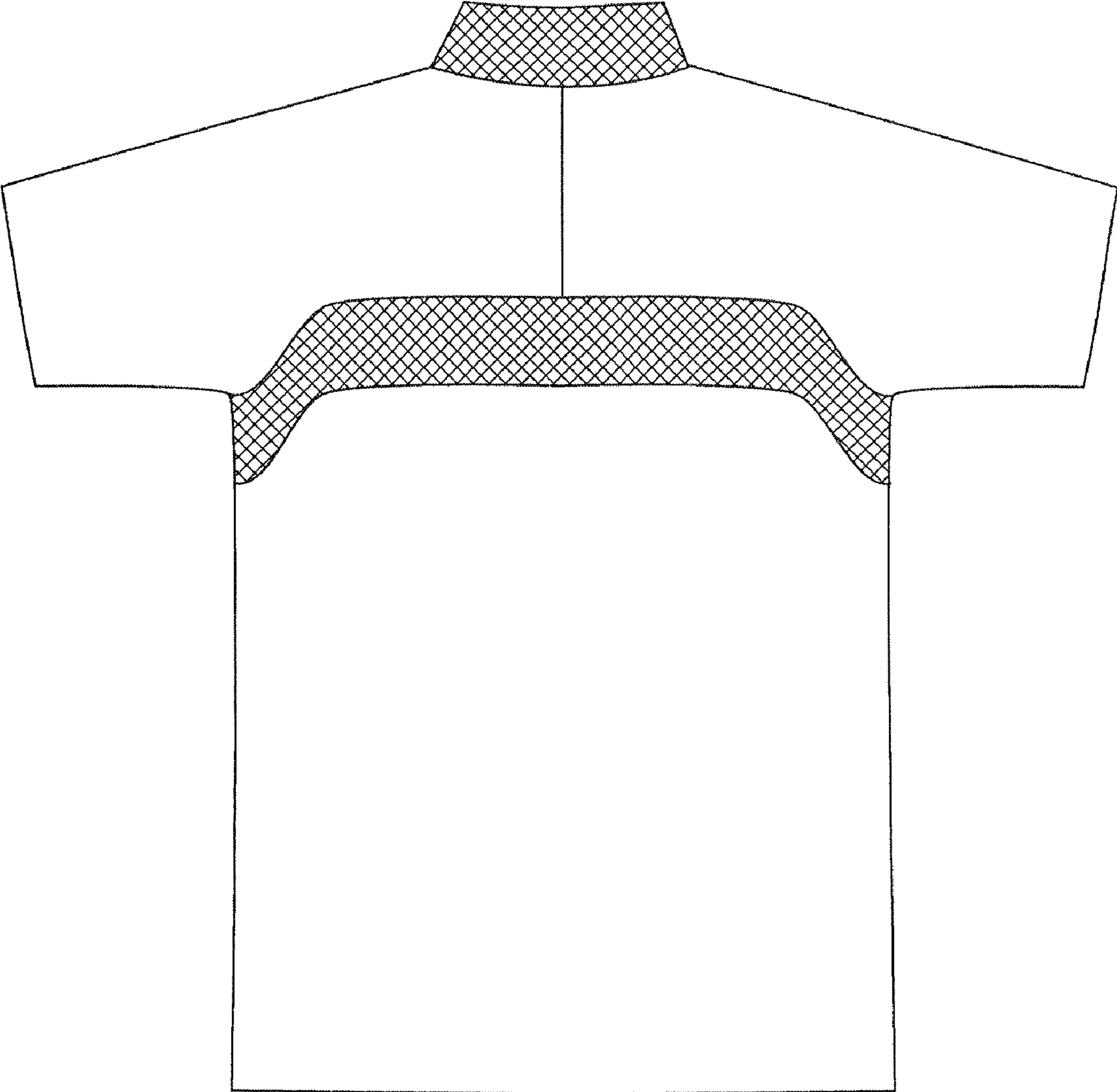

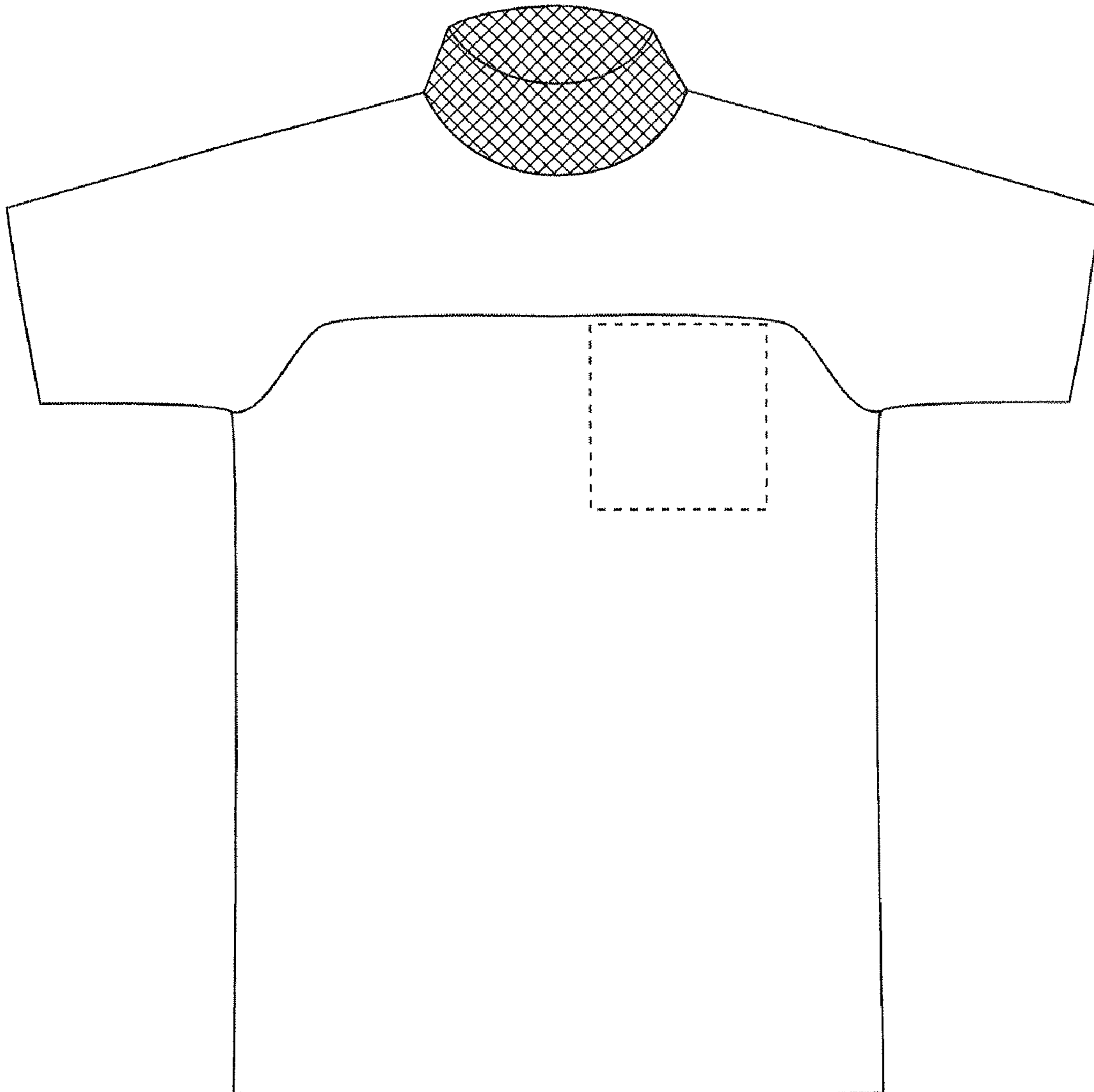
