(57) **CLAIM**

The ornamental design for a laptop sleeve, substantially as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of the laptop sleeve.

FIG. 2 is a front view of the laptop sleeve.

FIG. 3 is a rear view of the laptop sleeve.

FIG. 4 is a left view of the laptop sleeve.

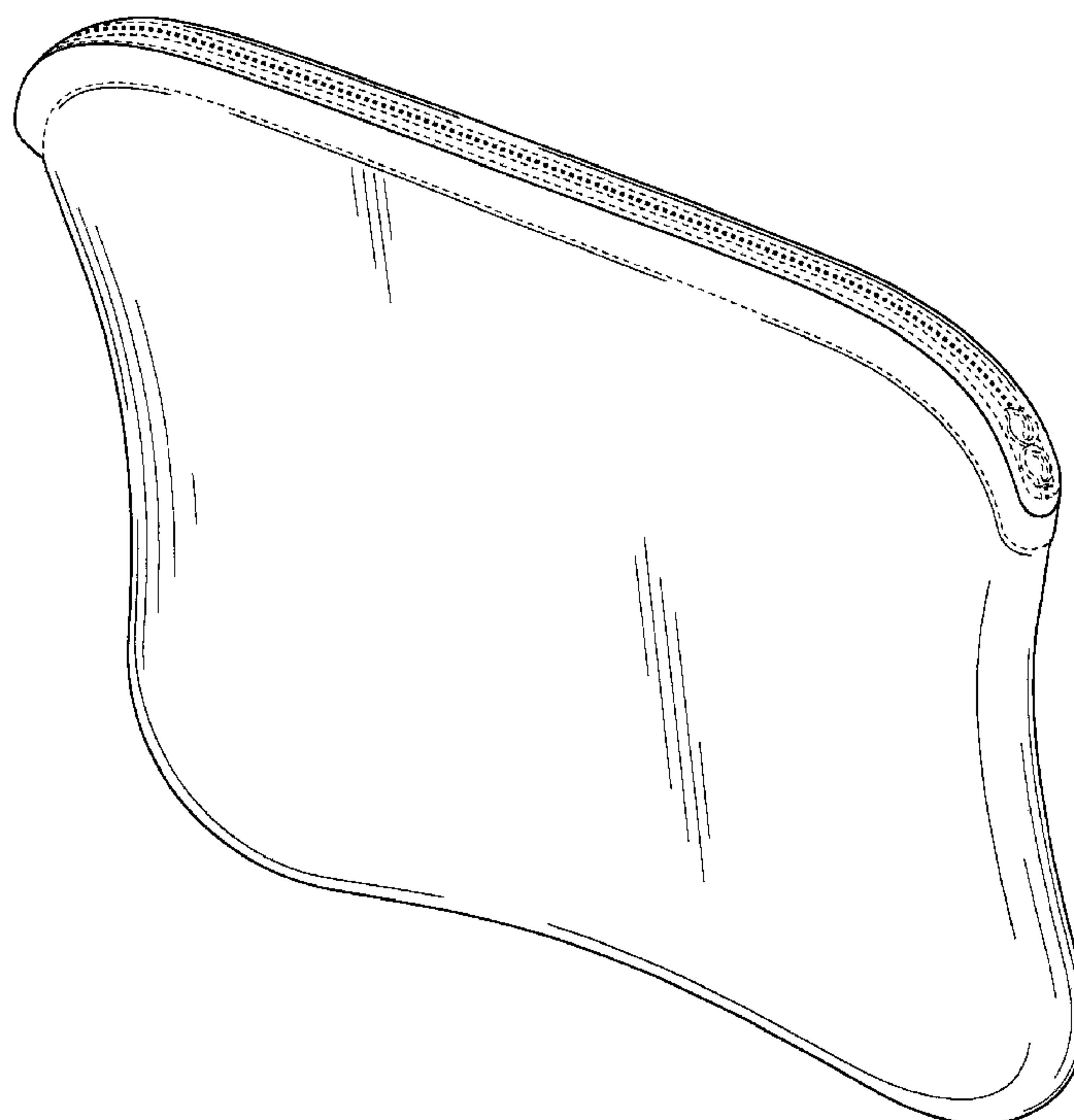
FIG. 5 is a right view of the laptop sleeve.

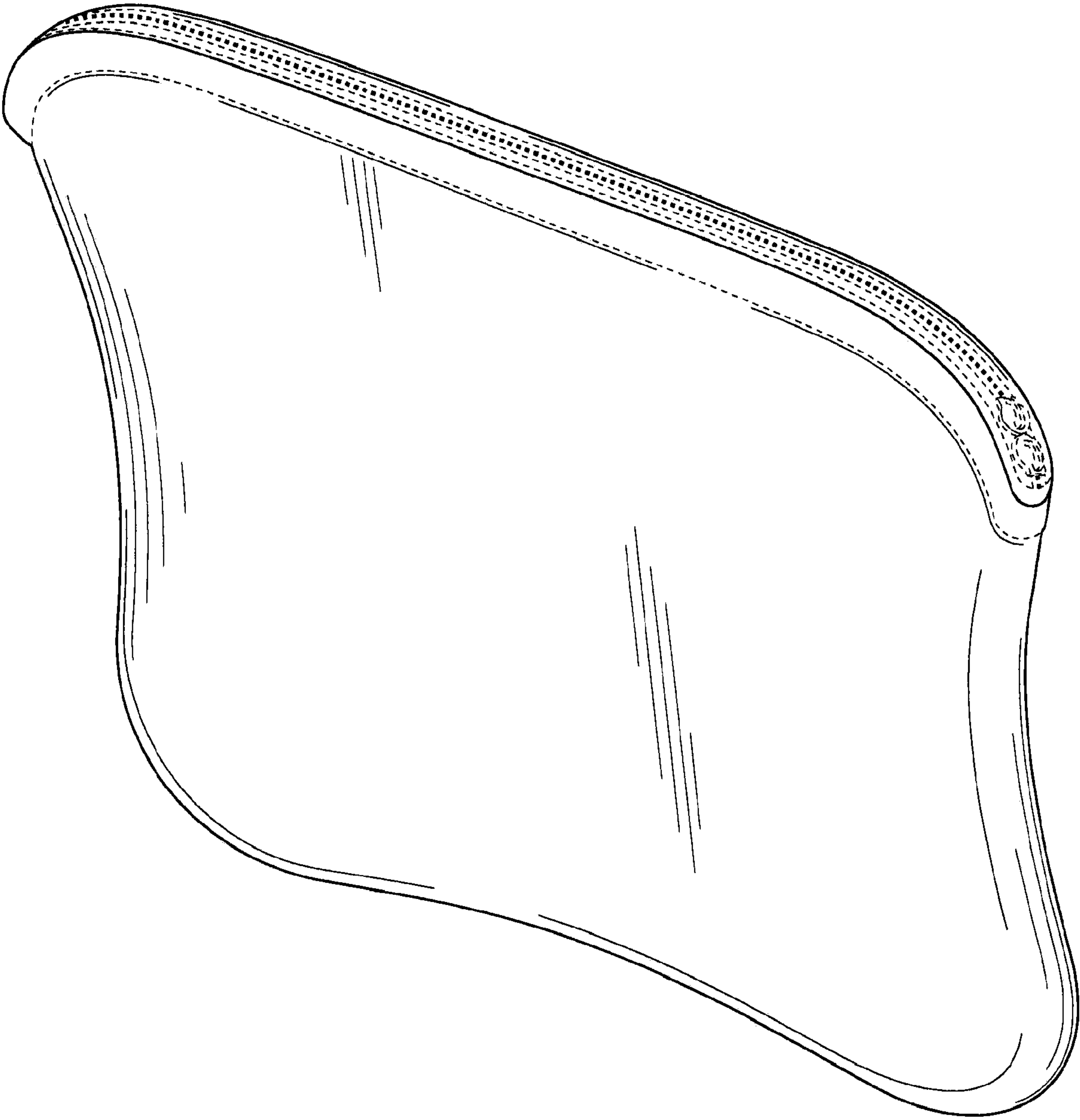

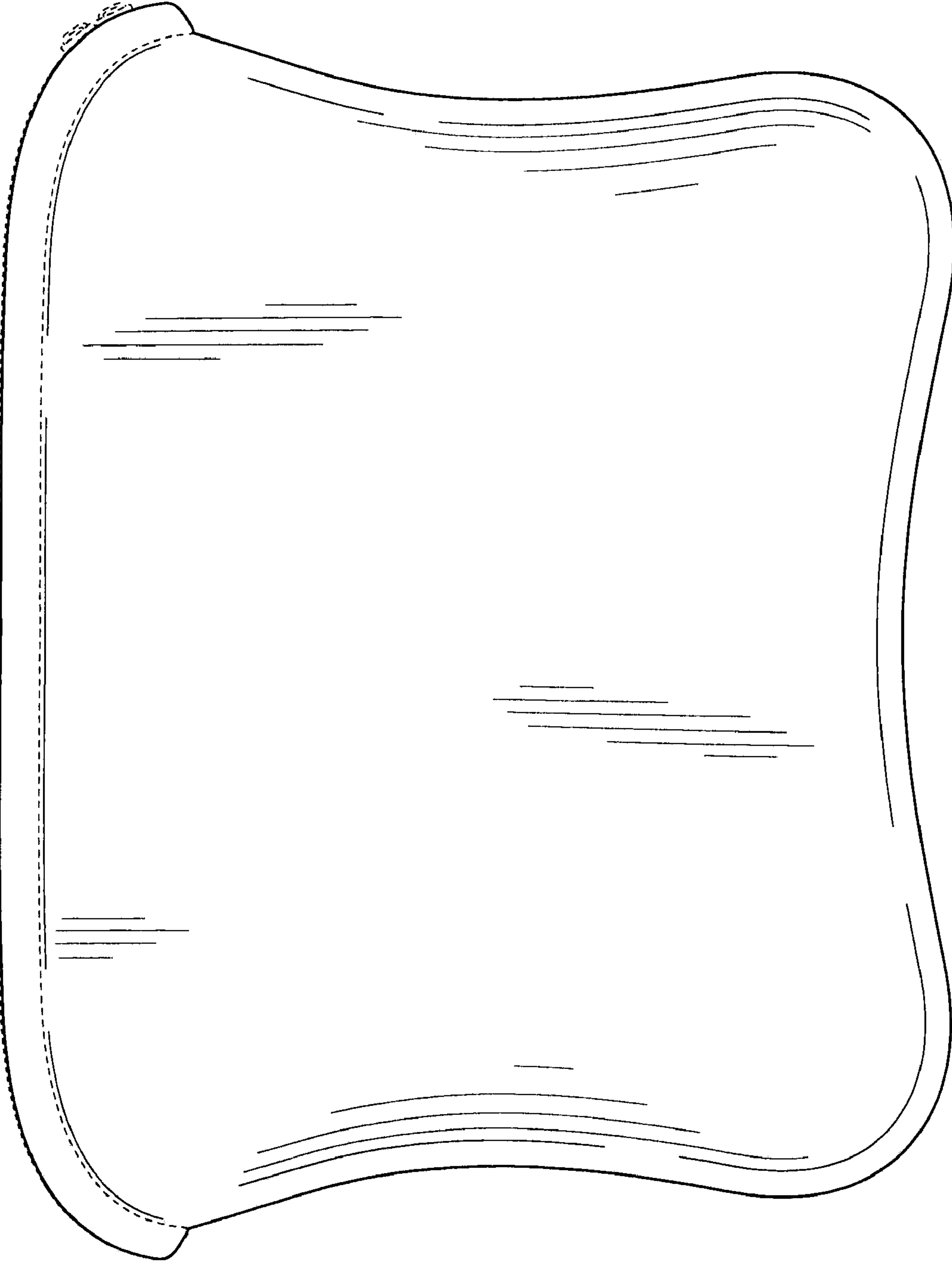

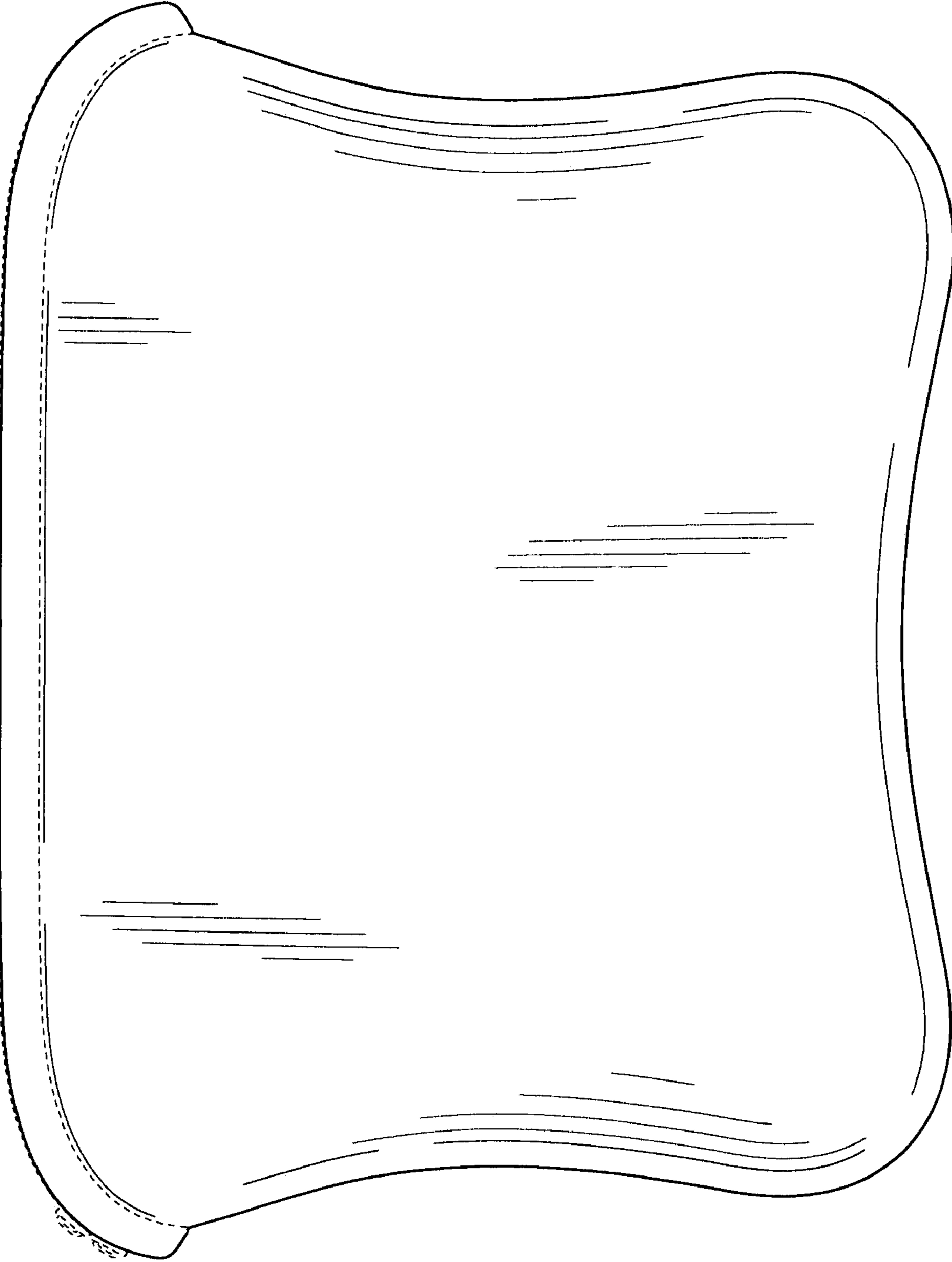

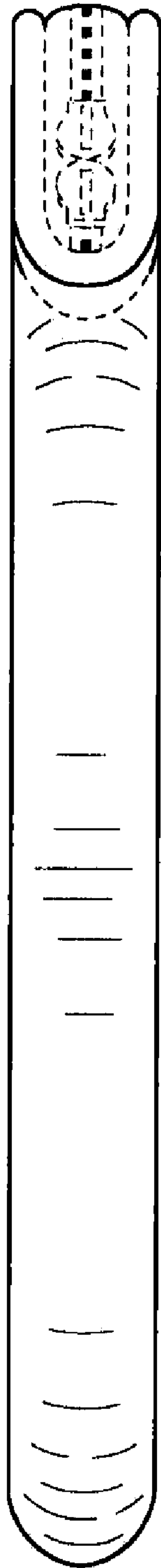

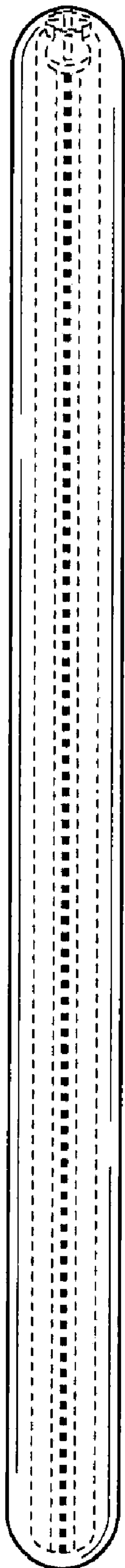

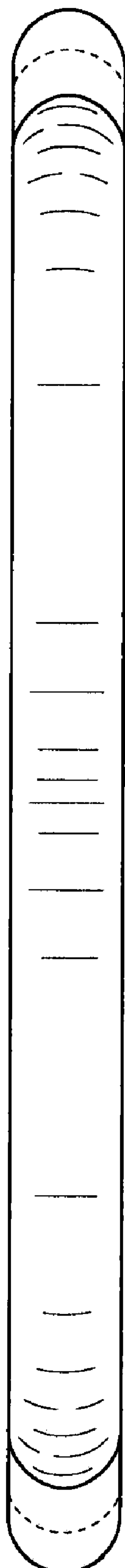
