I claim the ornamental design for a football uprights themed tap dispenser, as shown and described.

FIG. 4 is a left side elevation view thereof;

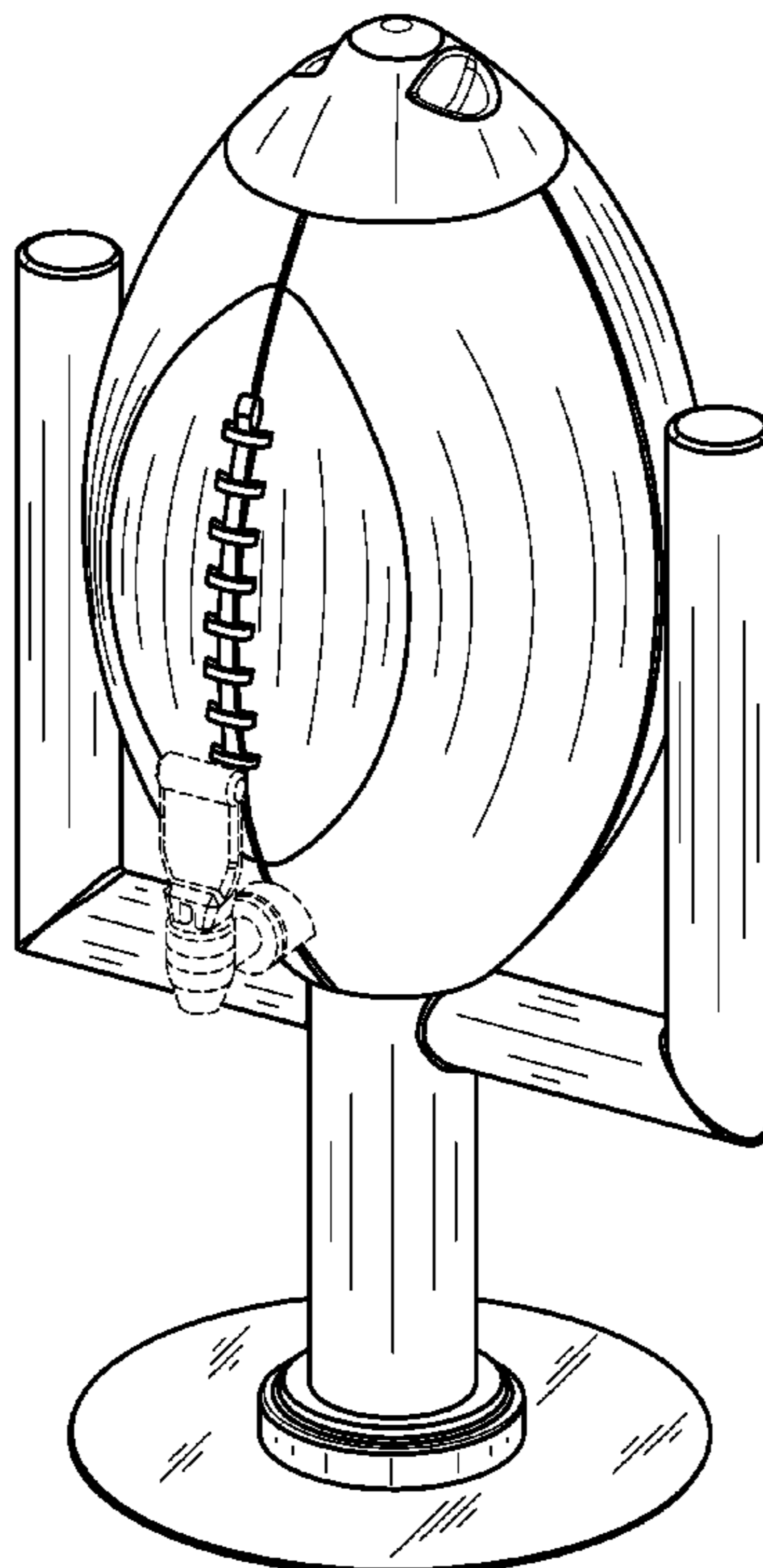
FIG. 5 is a right side elevation view thereof;

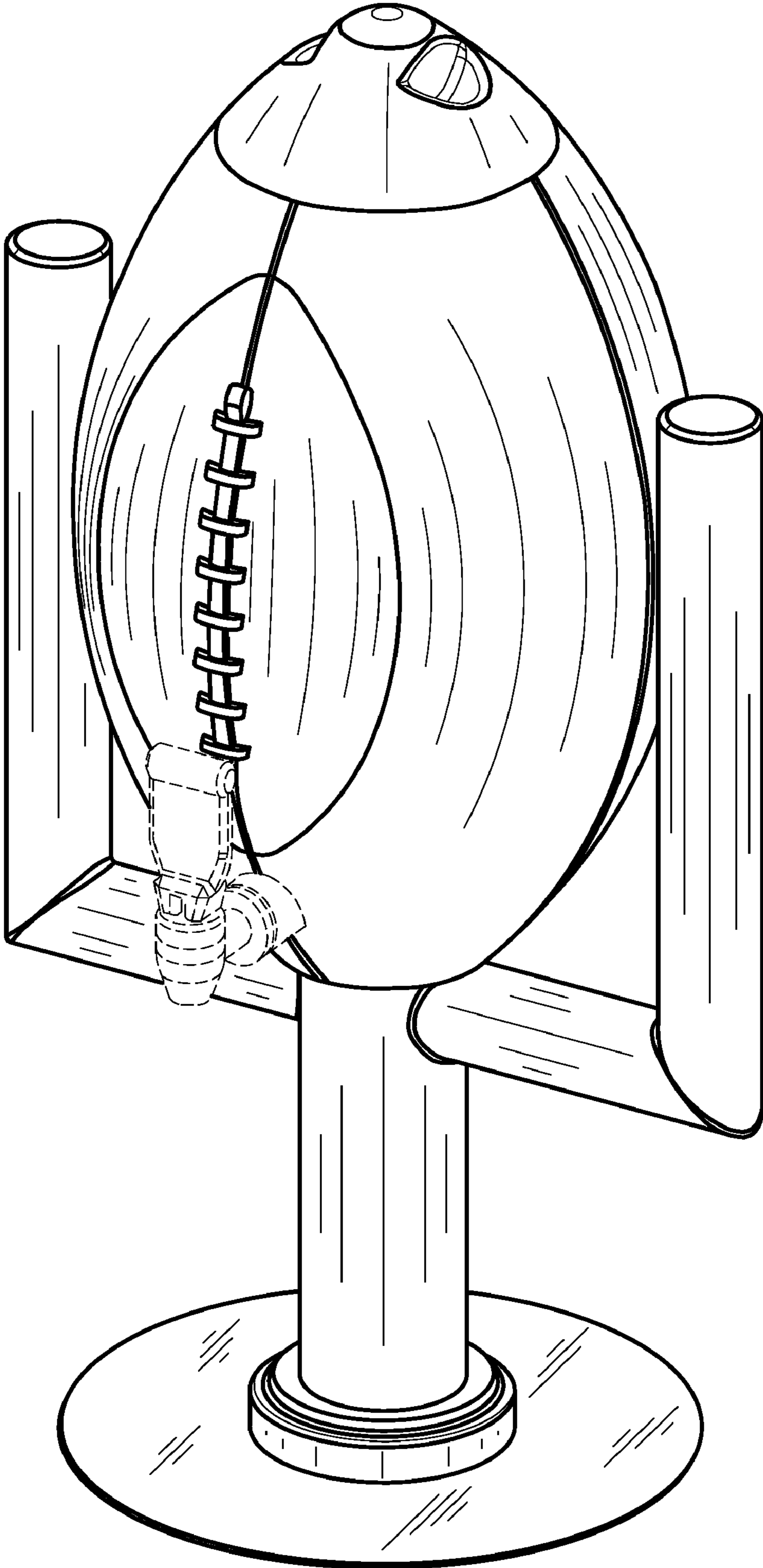

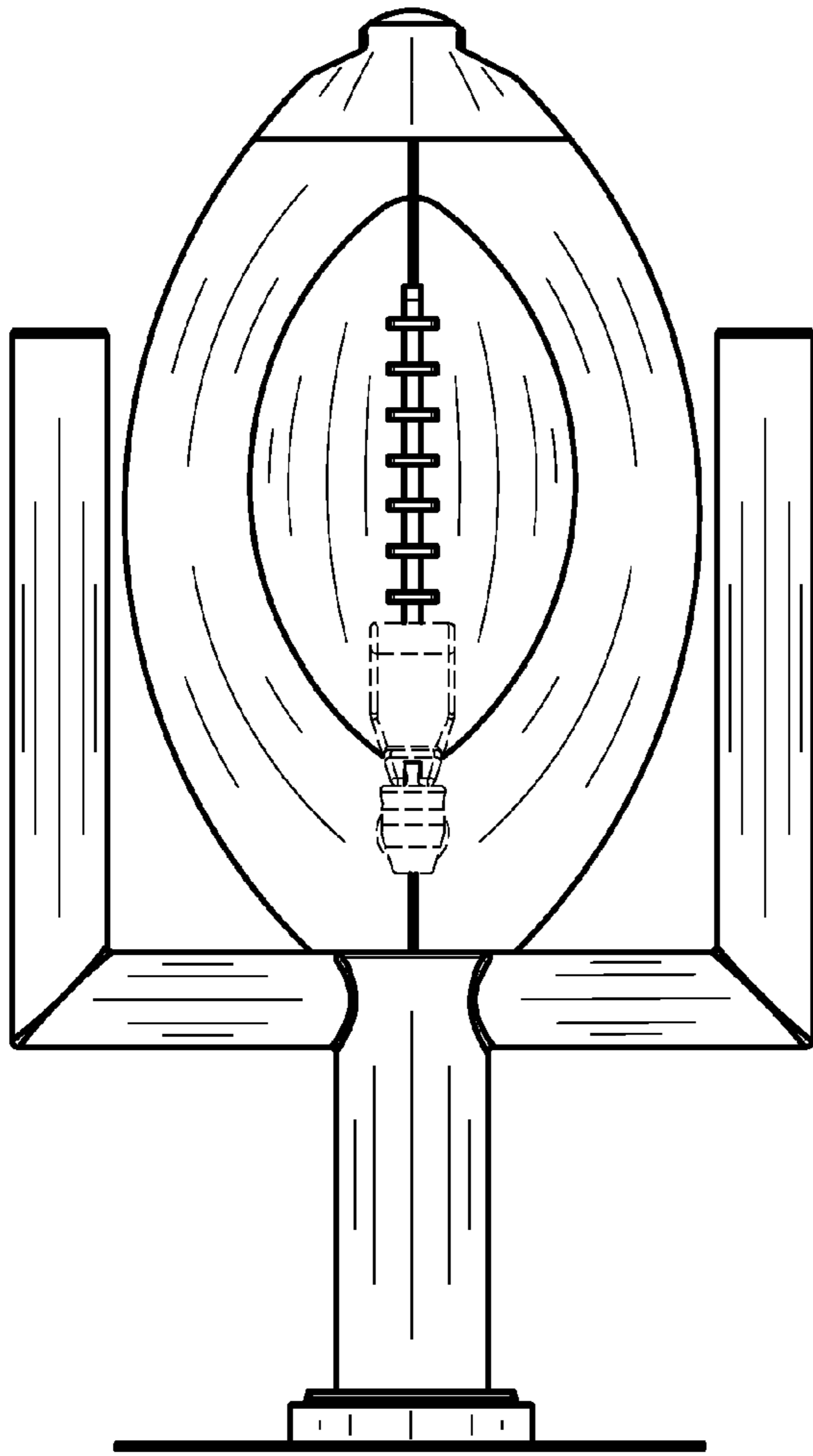

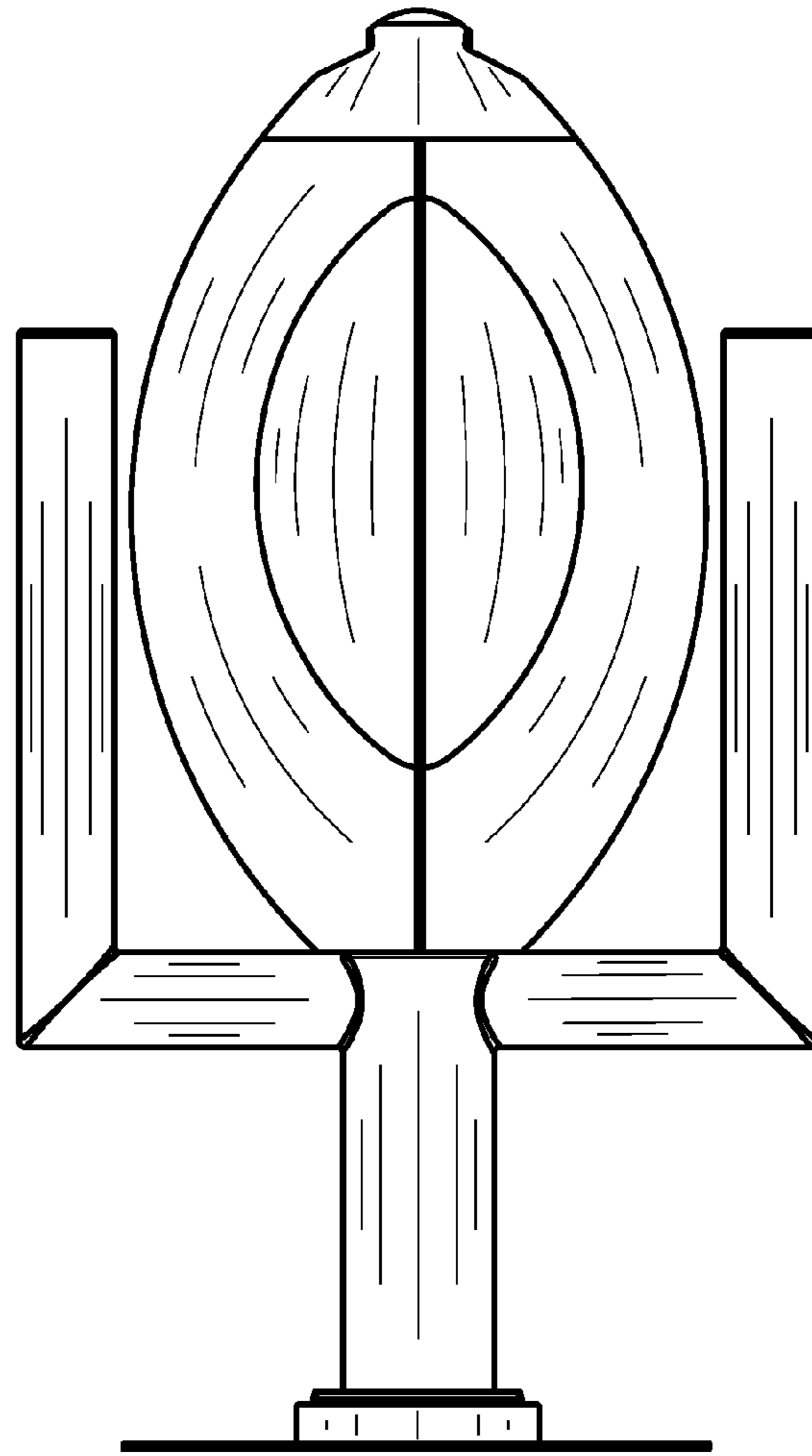

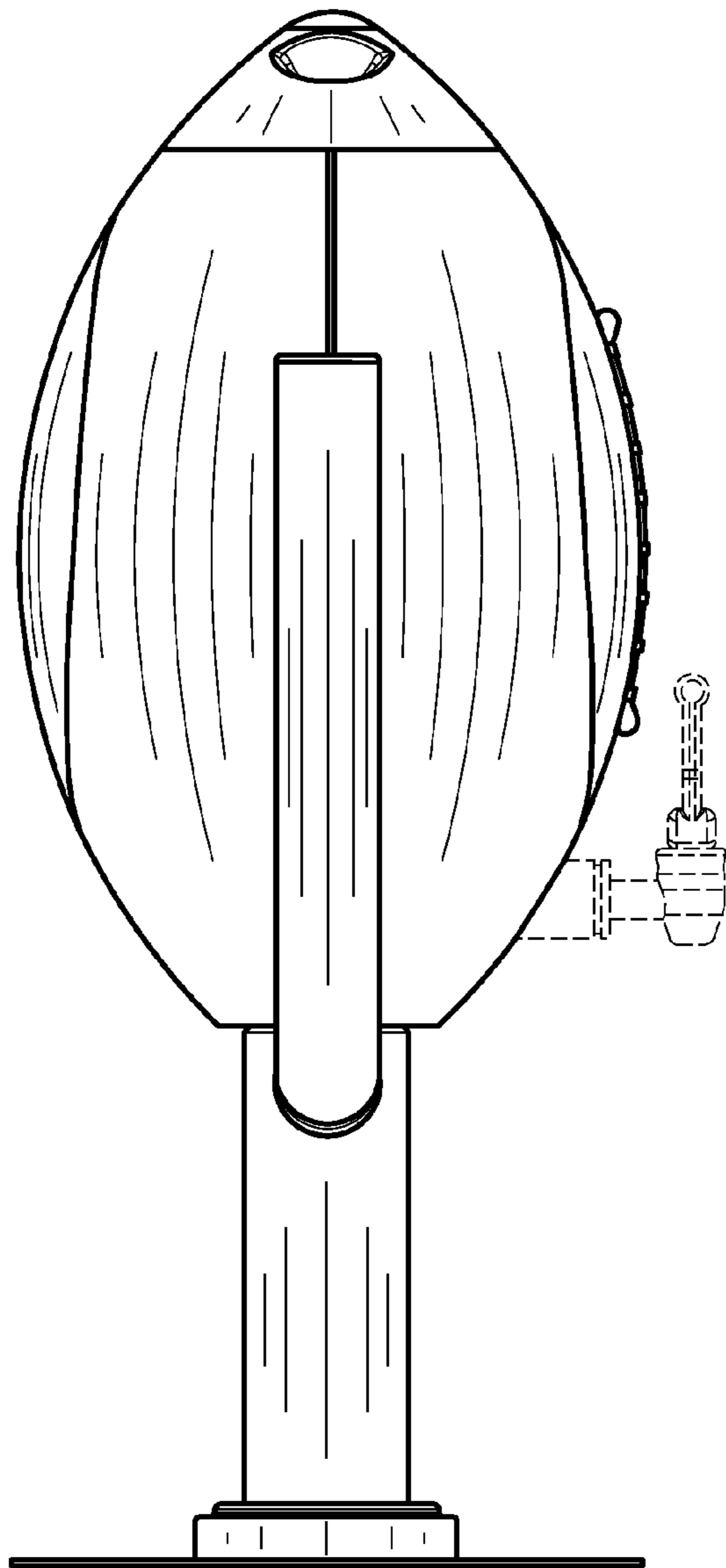

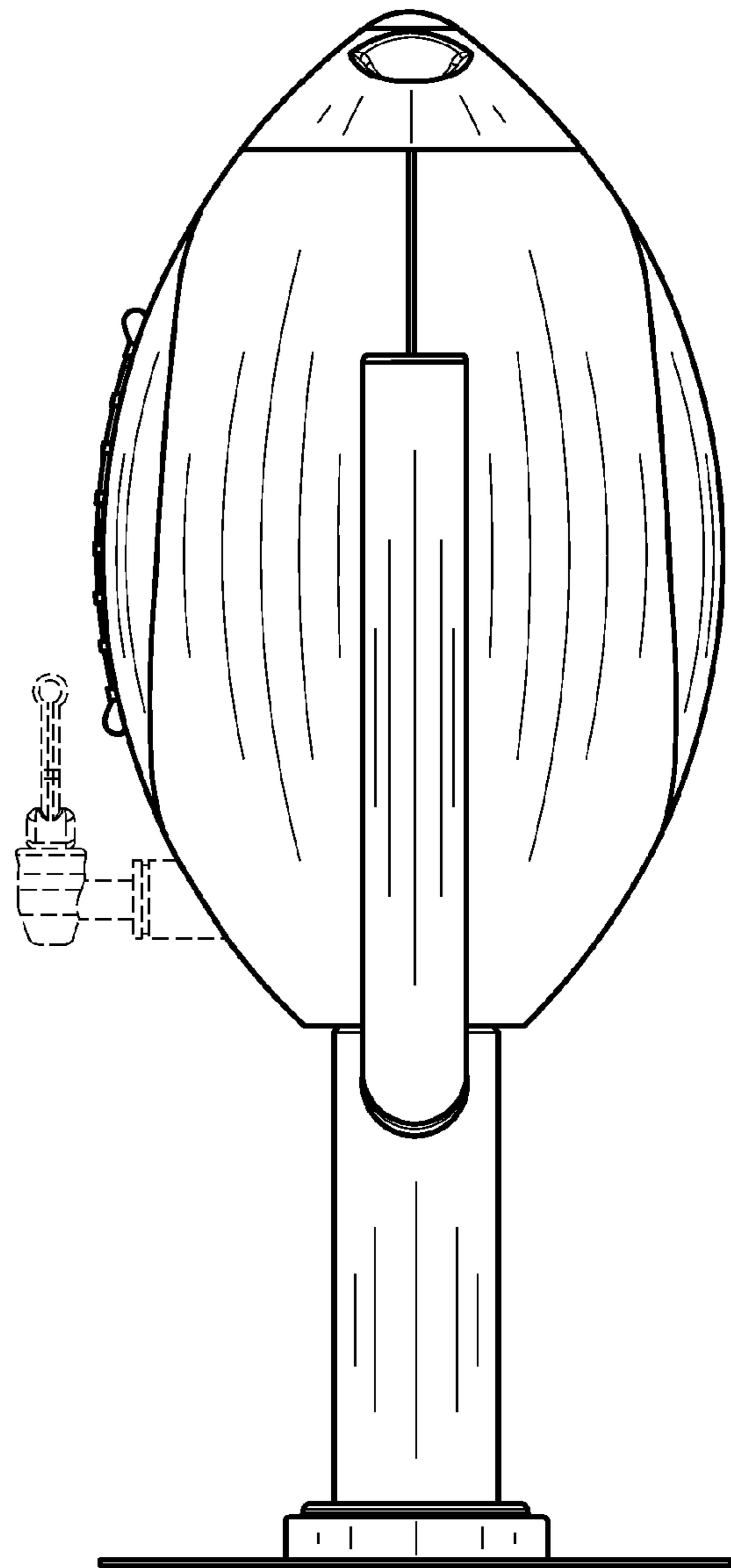

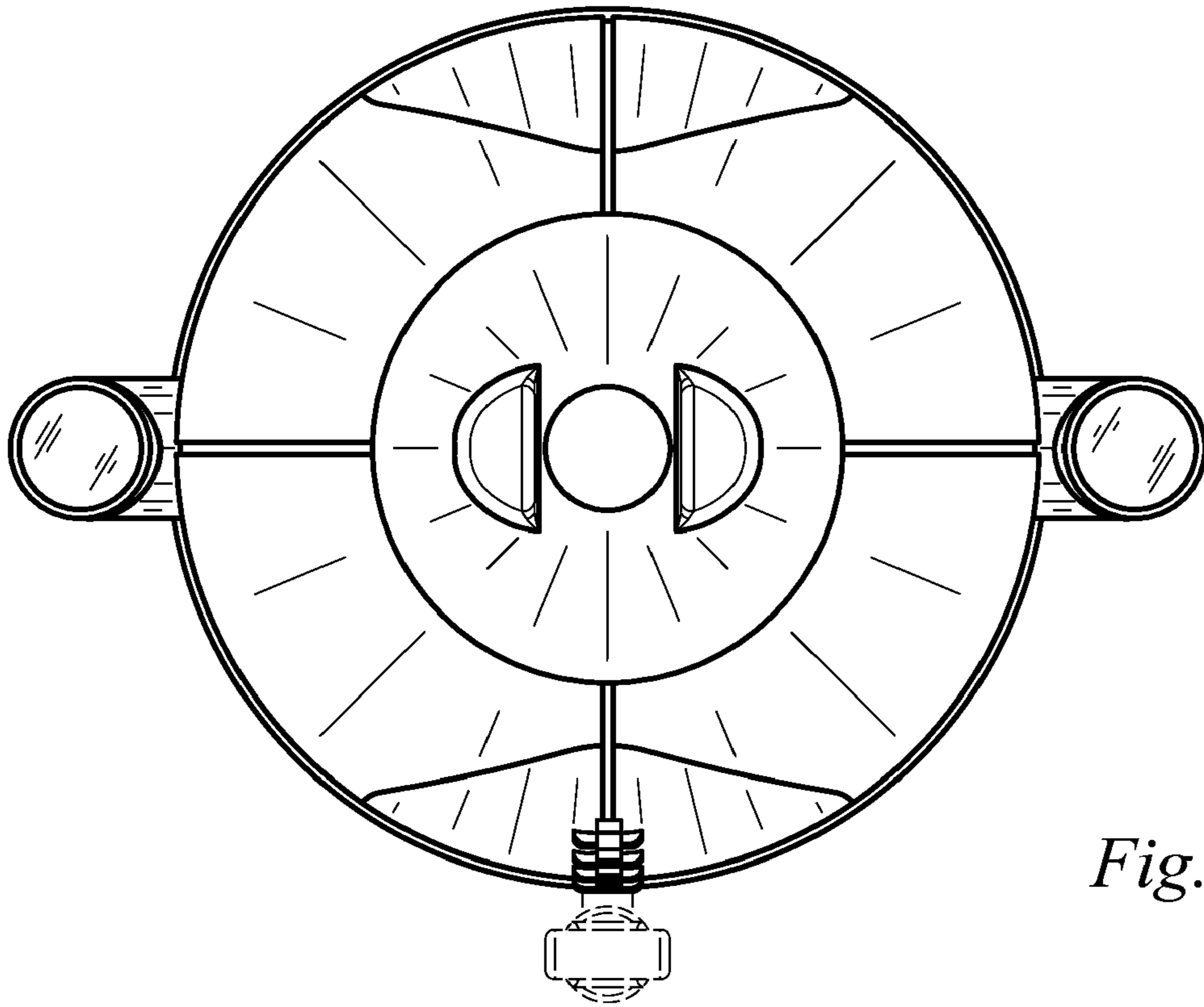

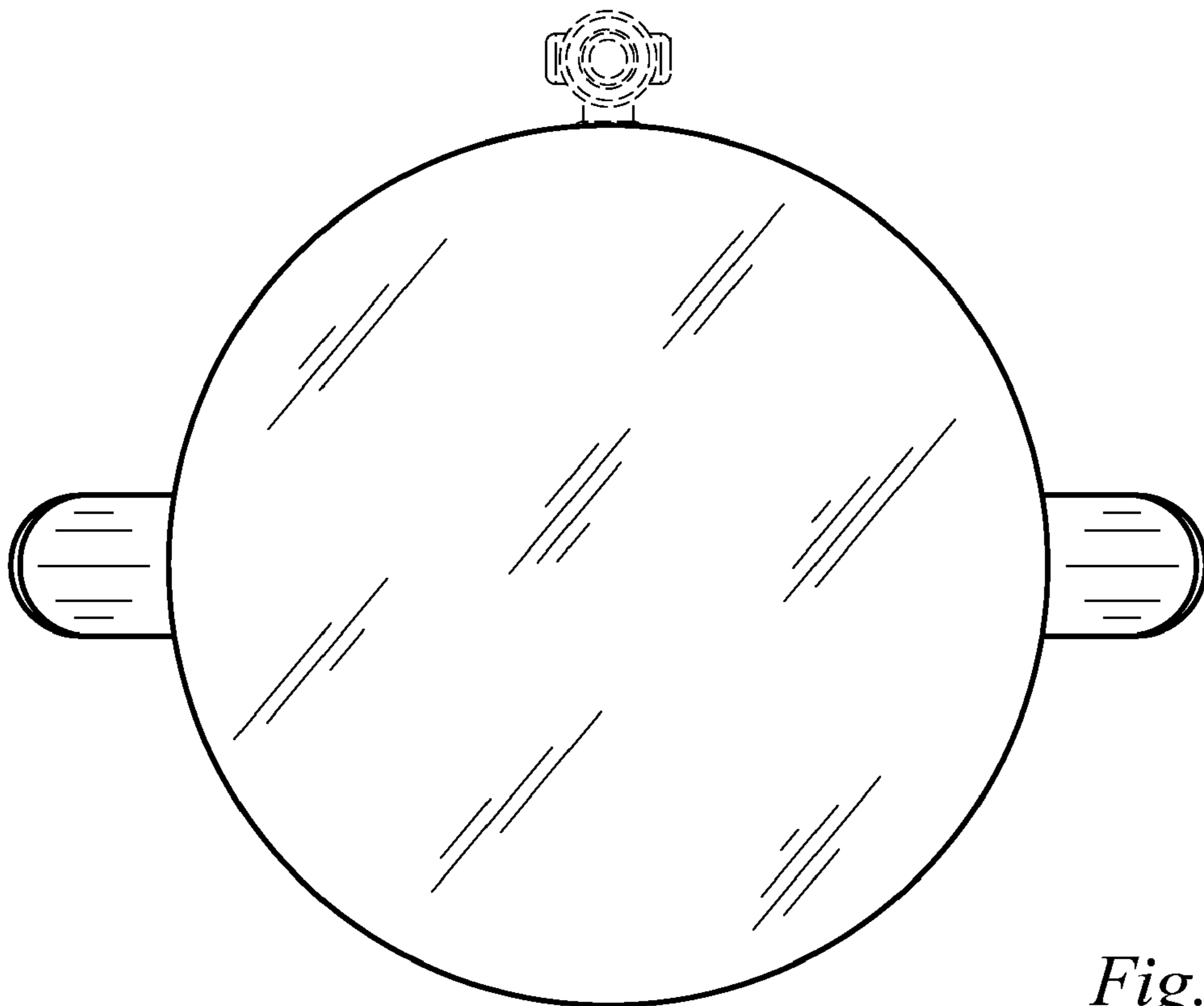
