FIG. 3 is a rear view thereof;

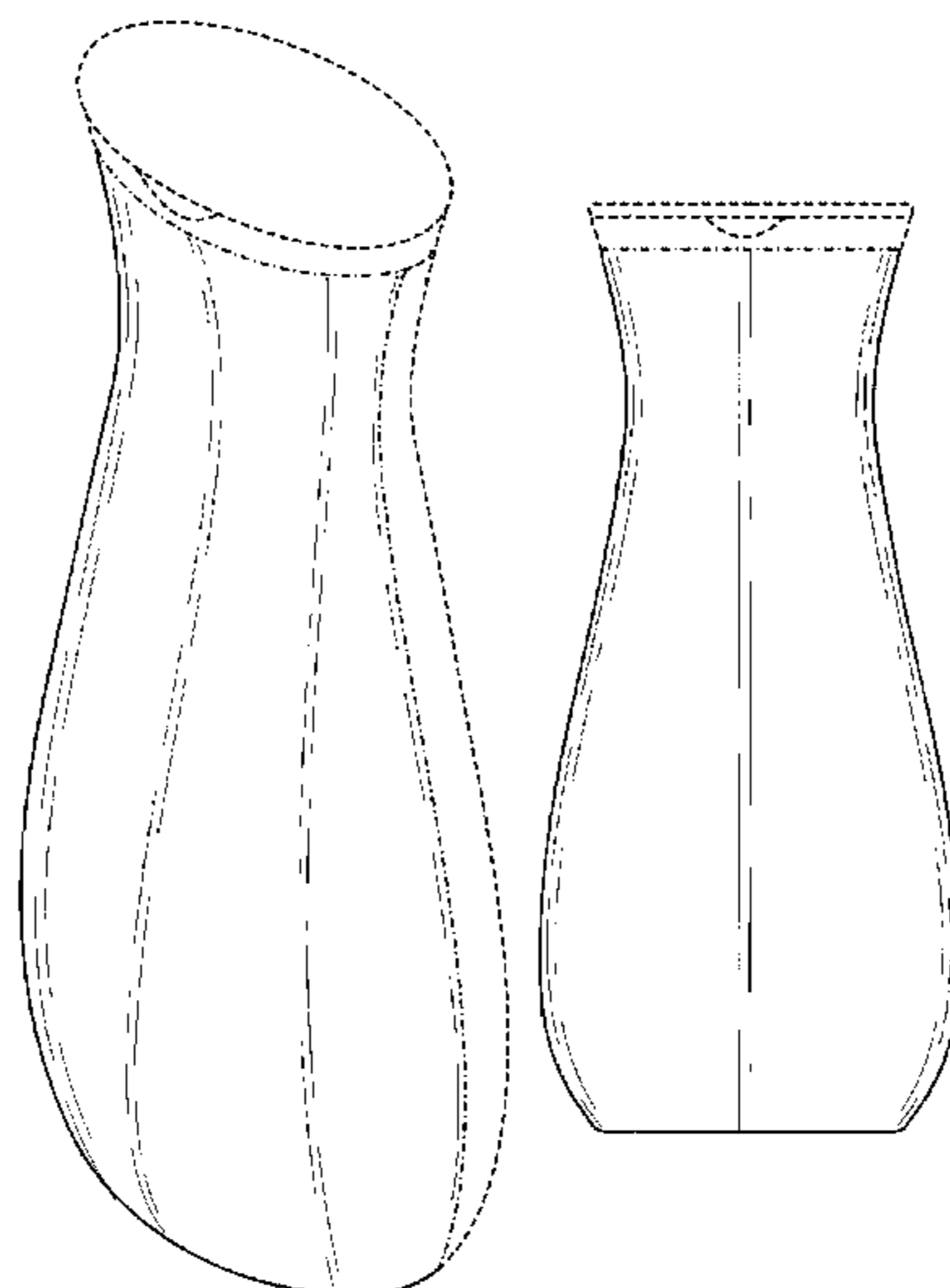
FIG. 4 is a side view thereof, the opposite side view being a mirror image thereof;

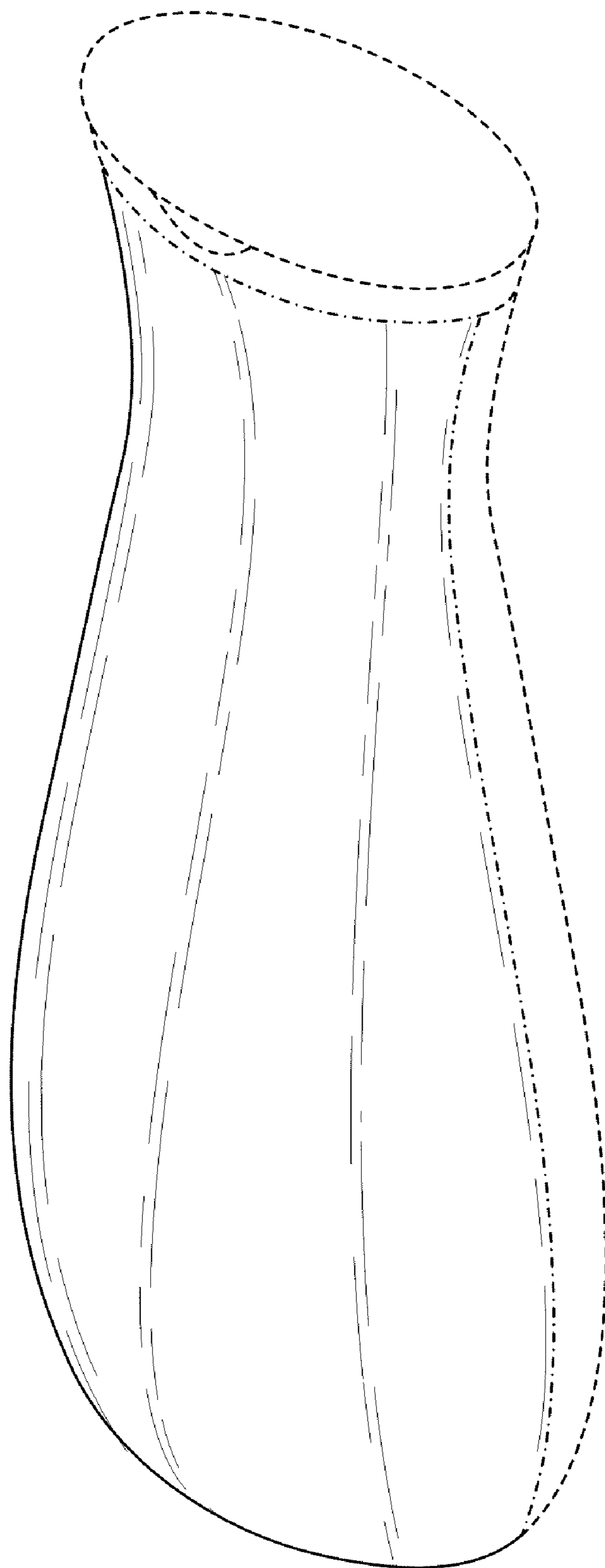

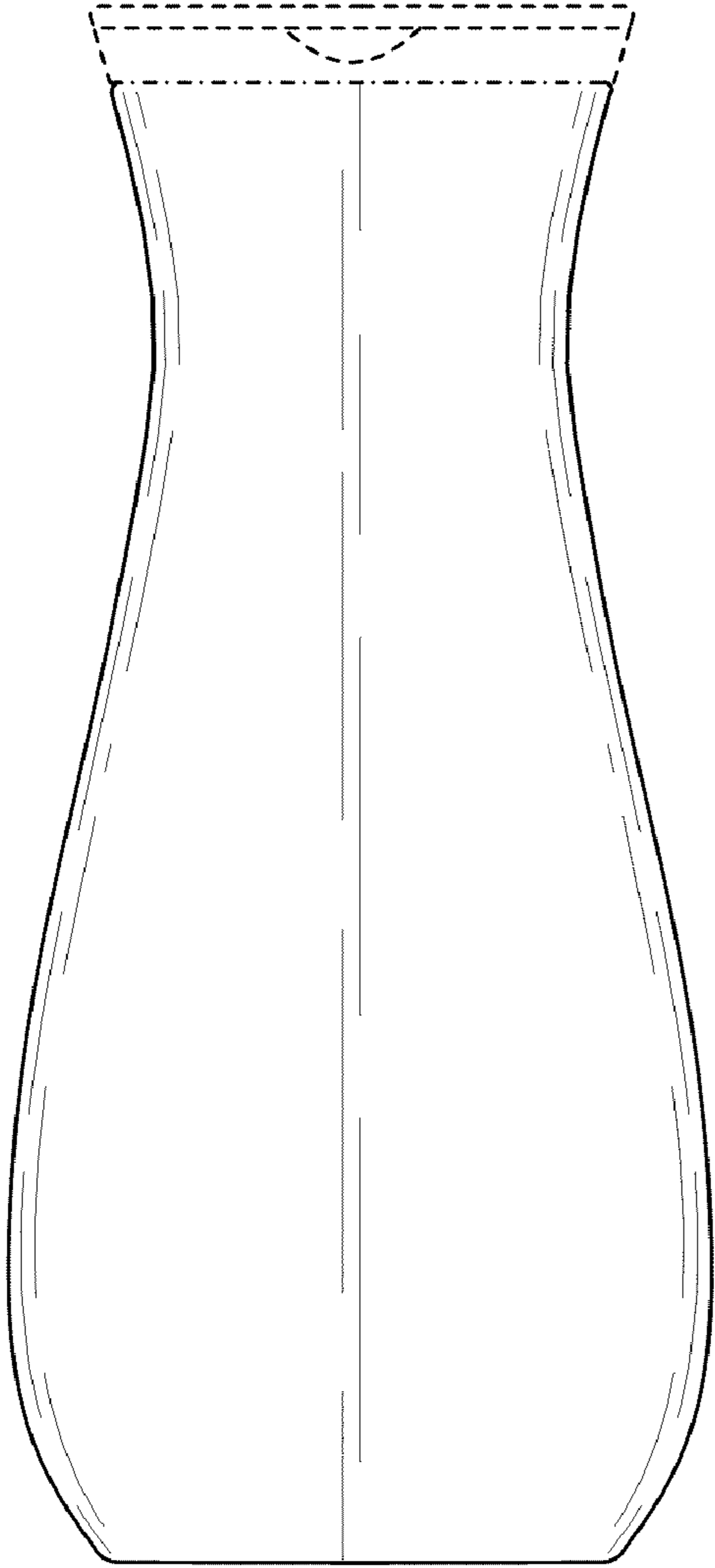

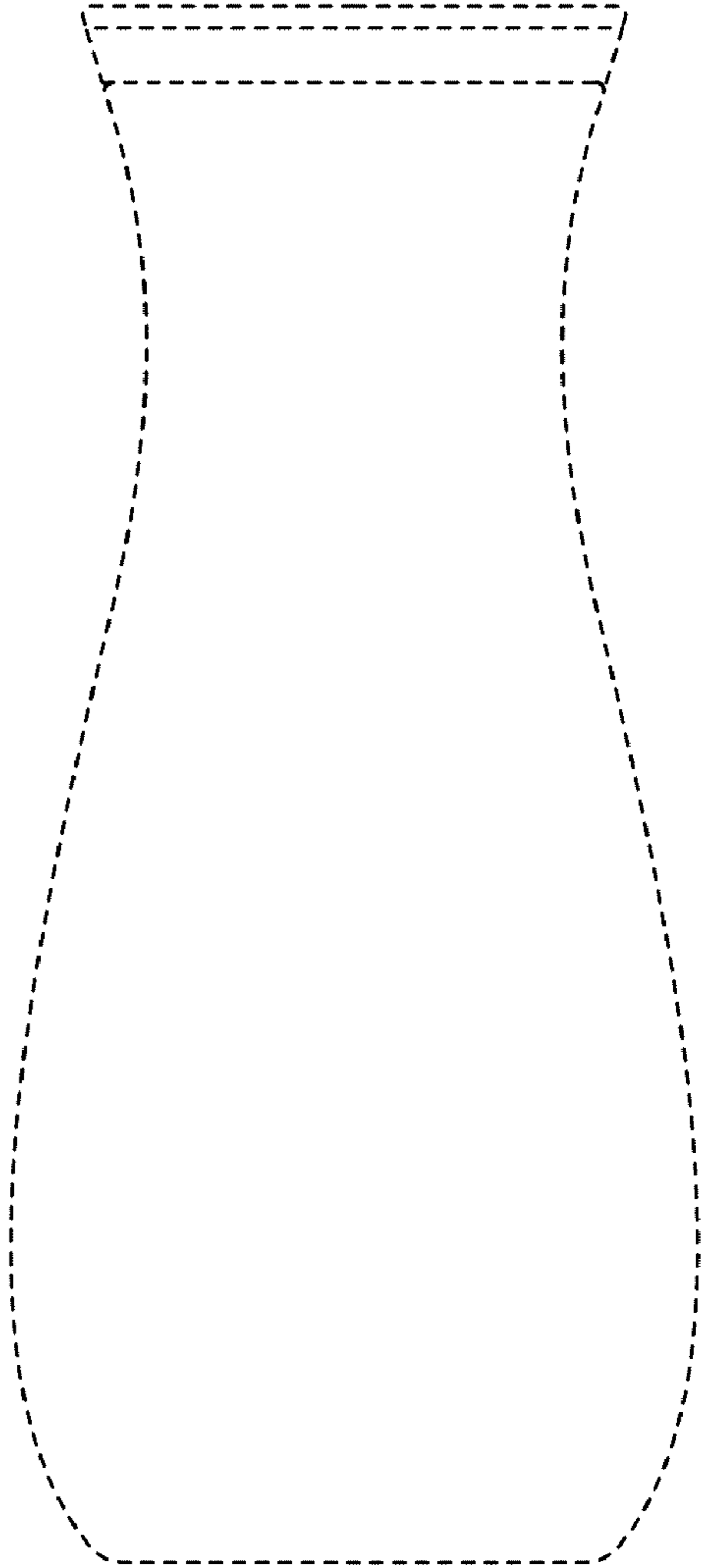

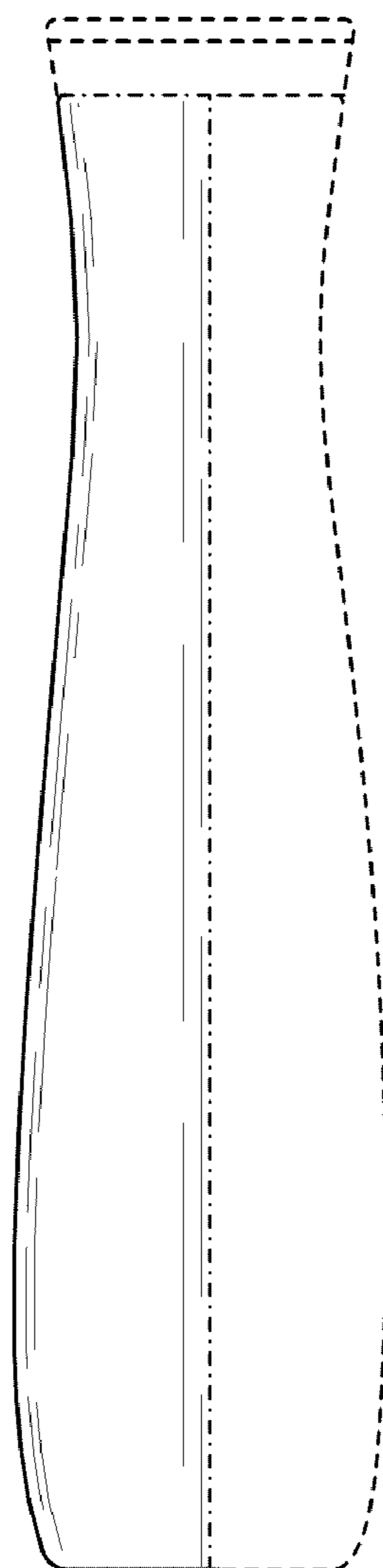

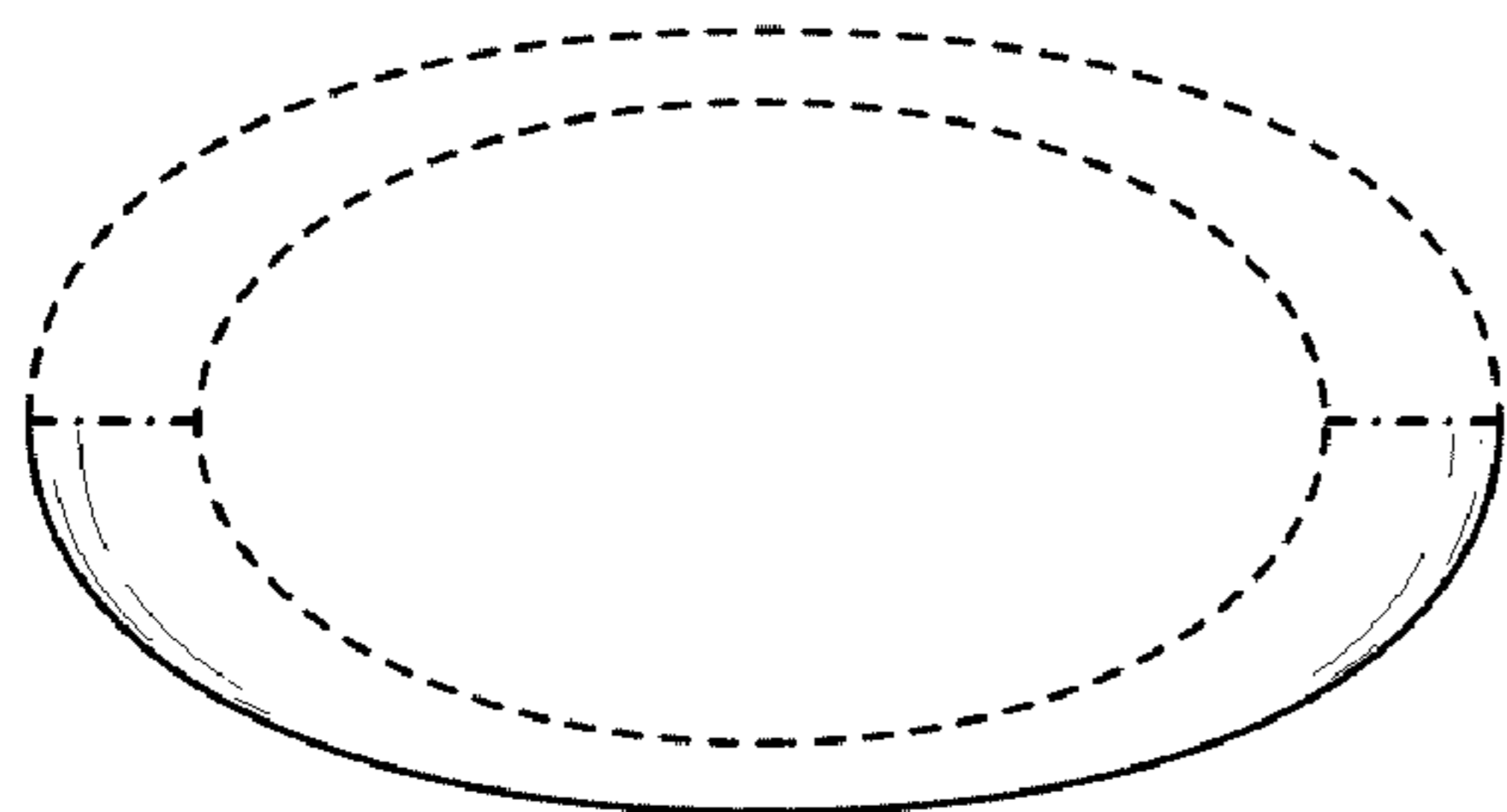

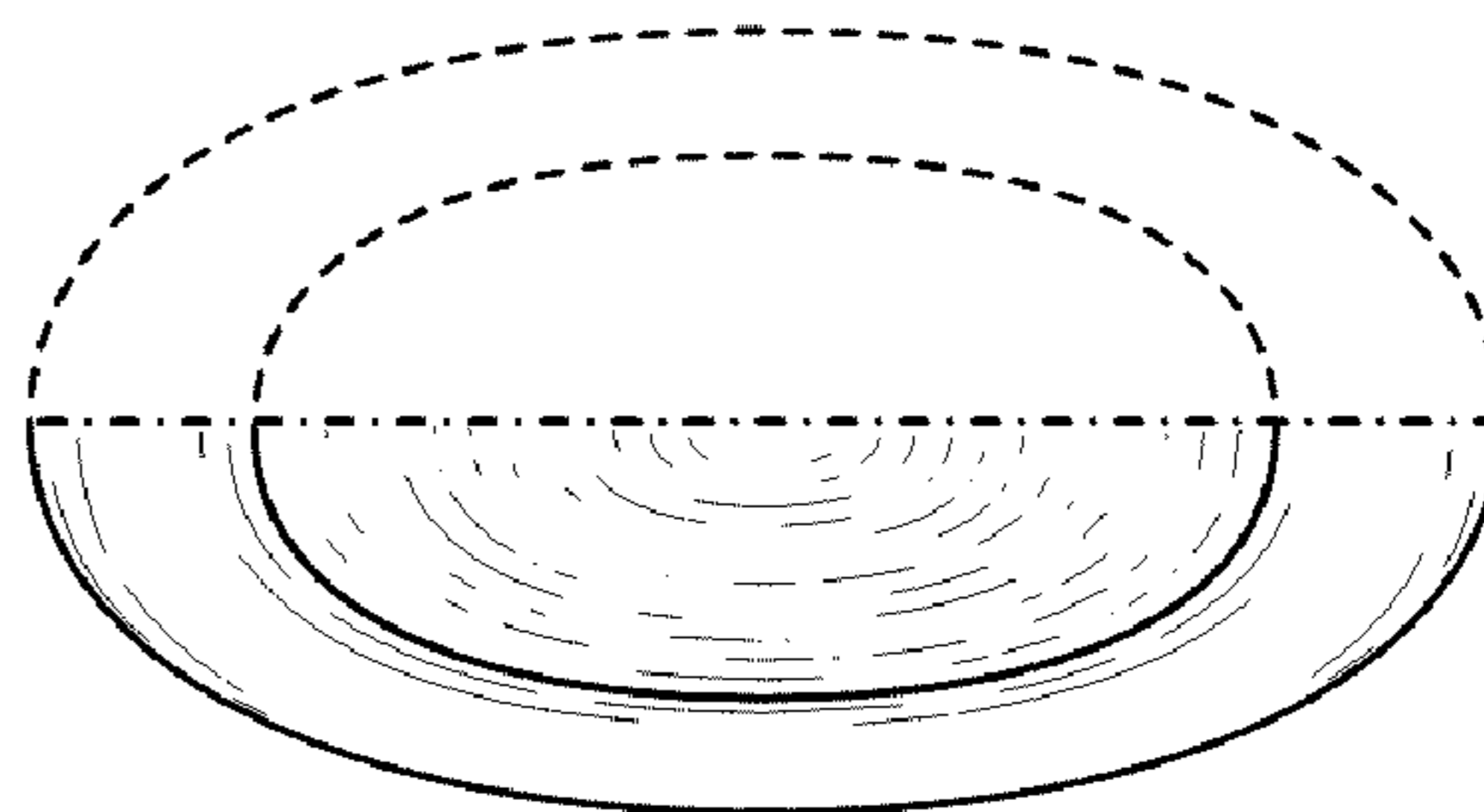
