(57) **CLAIM**

The ornamental design for aircraft furniture, as shown and described

DESCRIPTION

FIG. 1 is a top, rear, right side perspective view of a piece of aircraft furniture according to our design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a left side elevation view thereof;

FIG. 4 is a rear elevation view thereof;

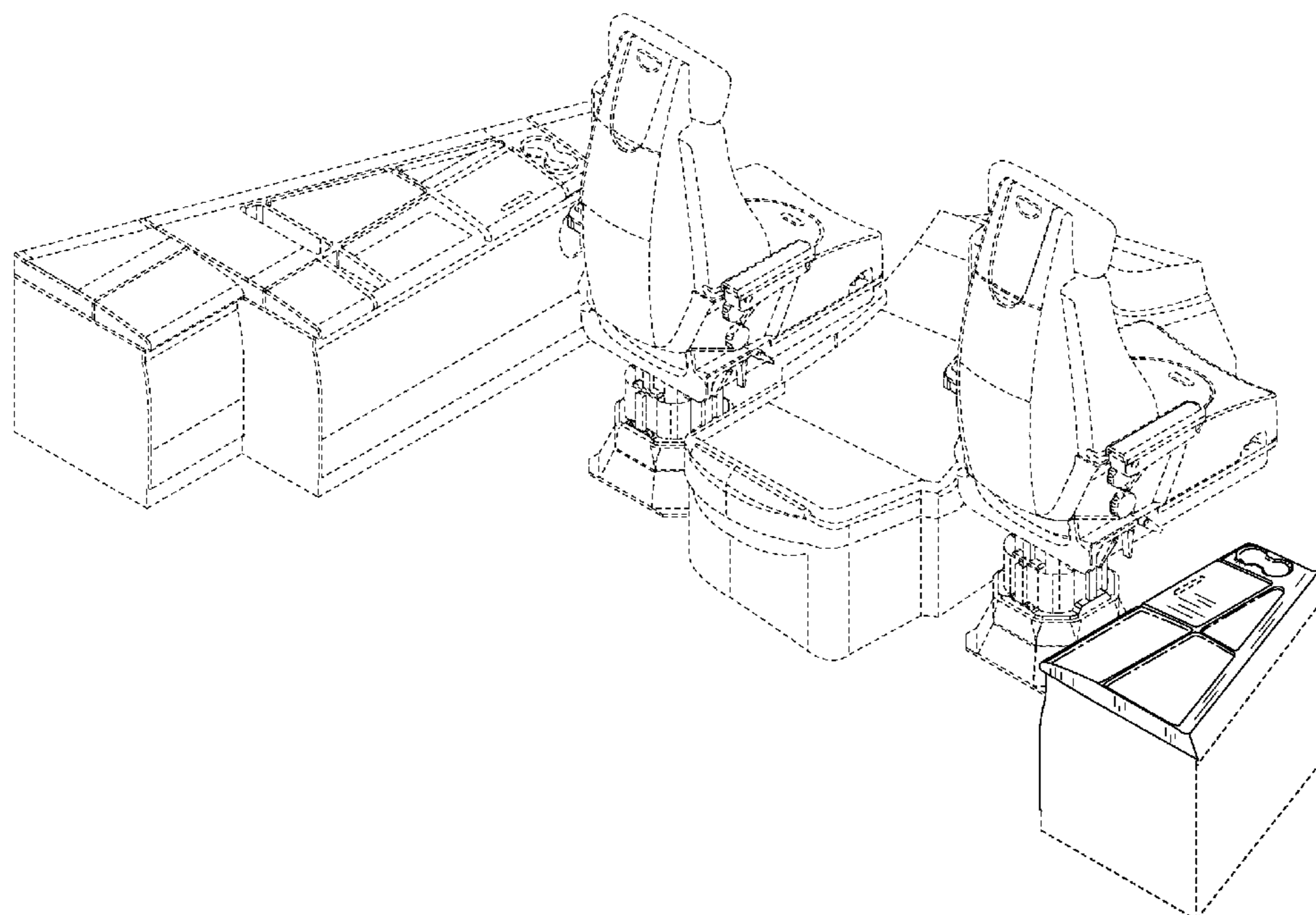
FIG. 5 is a front elevation view thereof; and,

FIG. 6 is a top, rear, right side perspective view of the piece of aircraft furniture of FIG. 1 shown with unclaimed environmental structure of additional elements of an aircraft cockpit.

Throughout the Figures, the dashed broken lines represent environmental matter and/or unclaimed portions of the aircraft furniture and form no part of the claimed design. The dash-dot broken lines represent the boundary between claimed and unclaimed areas and form no part of the claimed design.

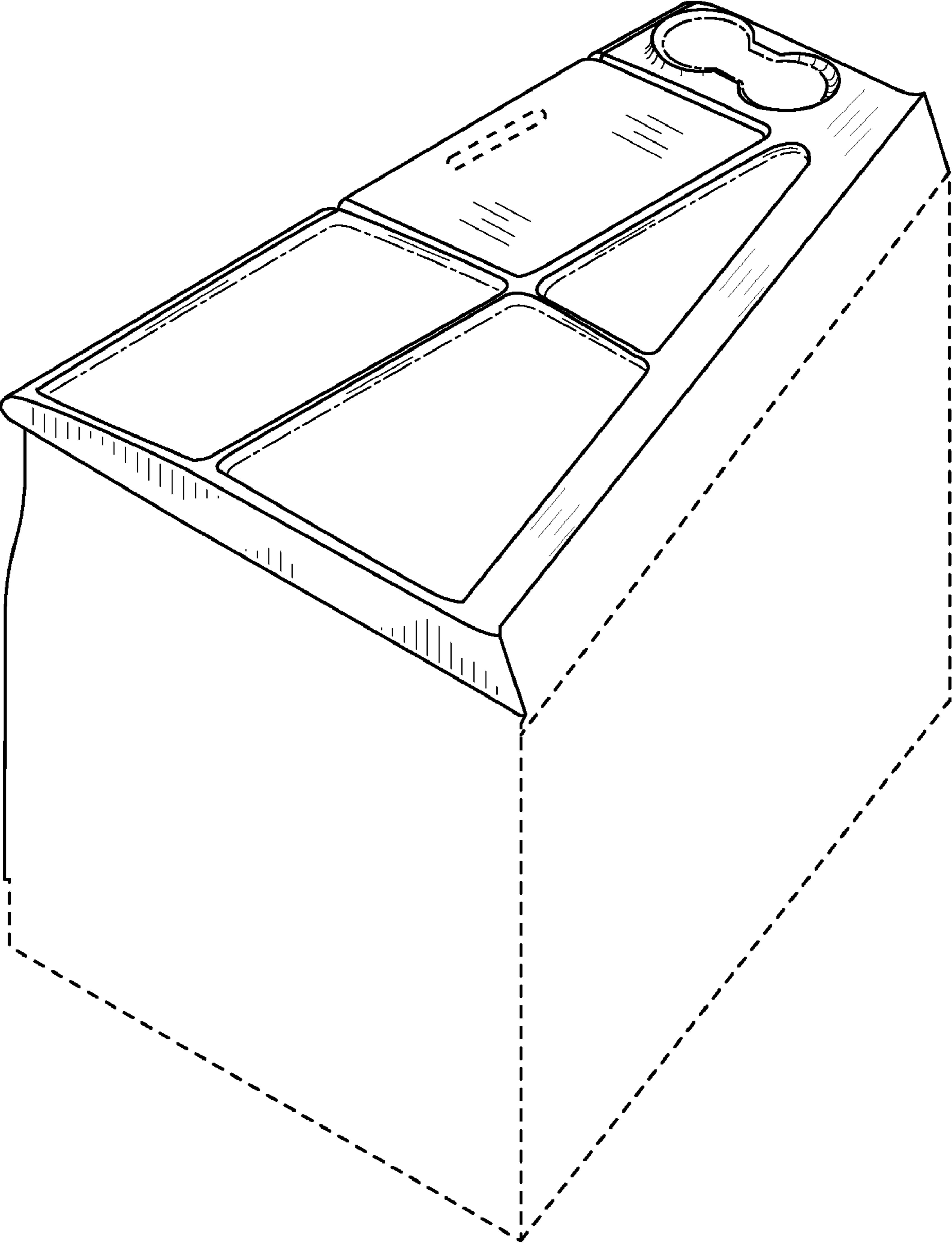

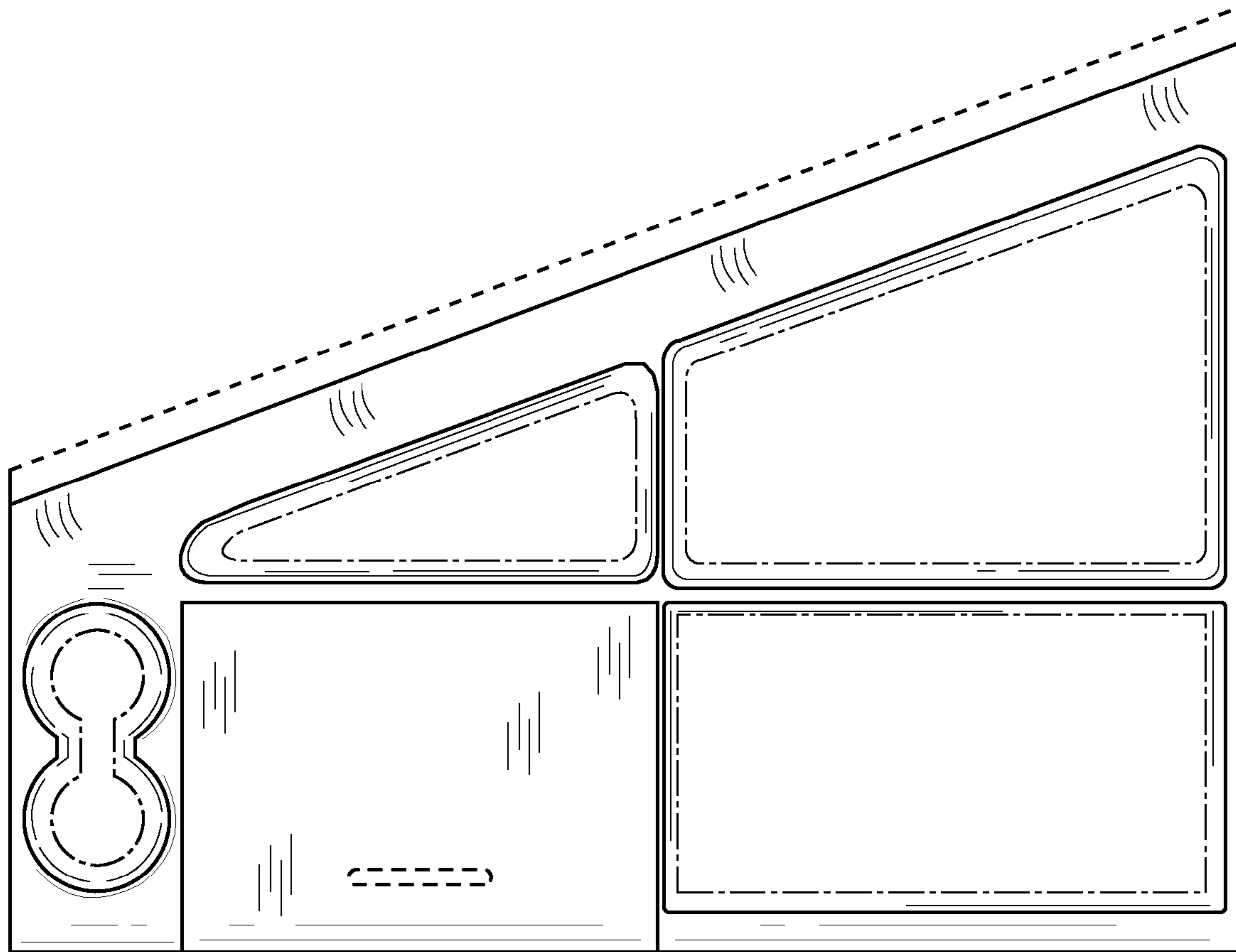

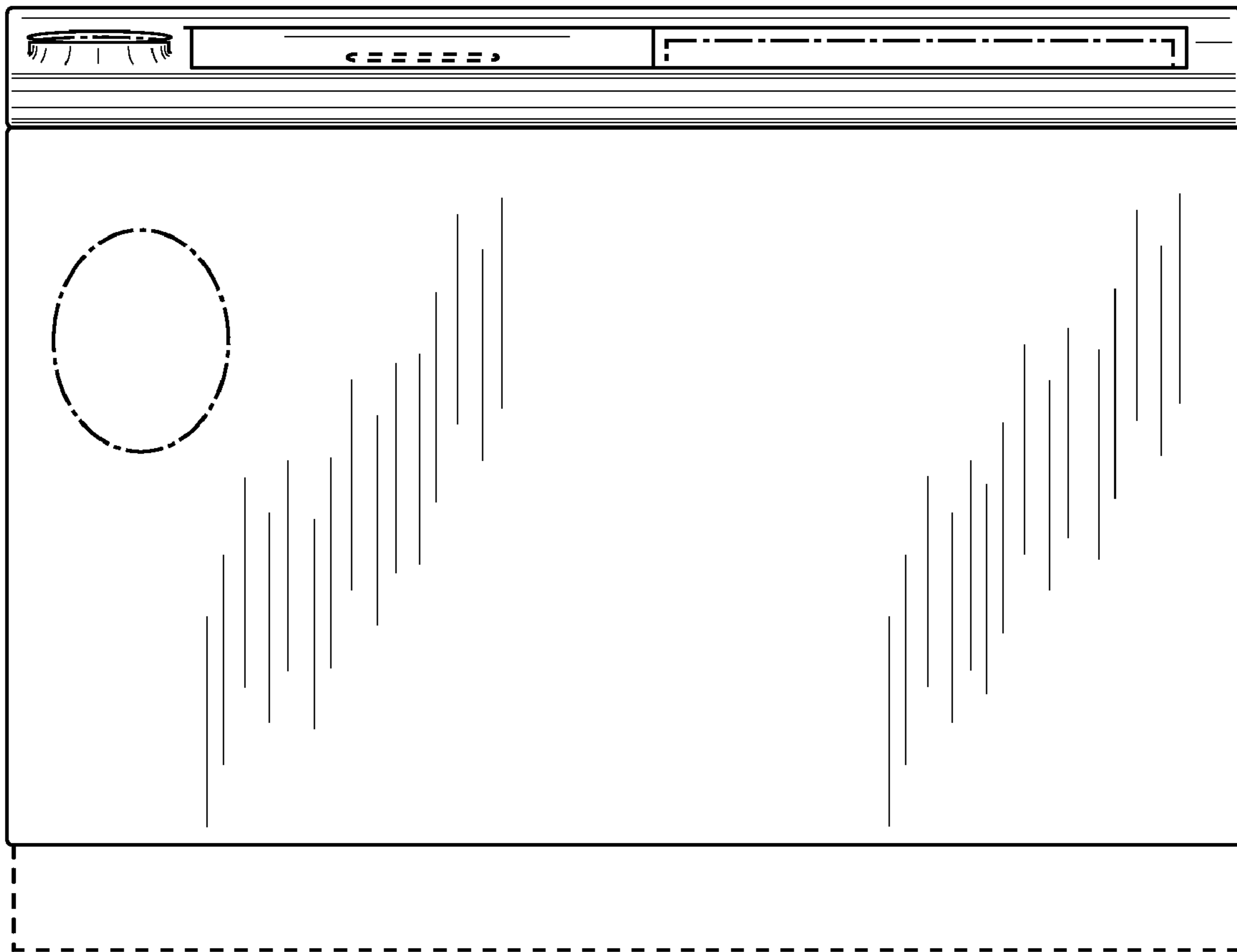

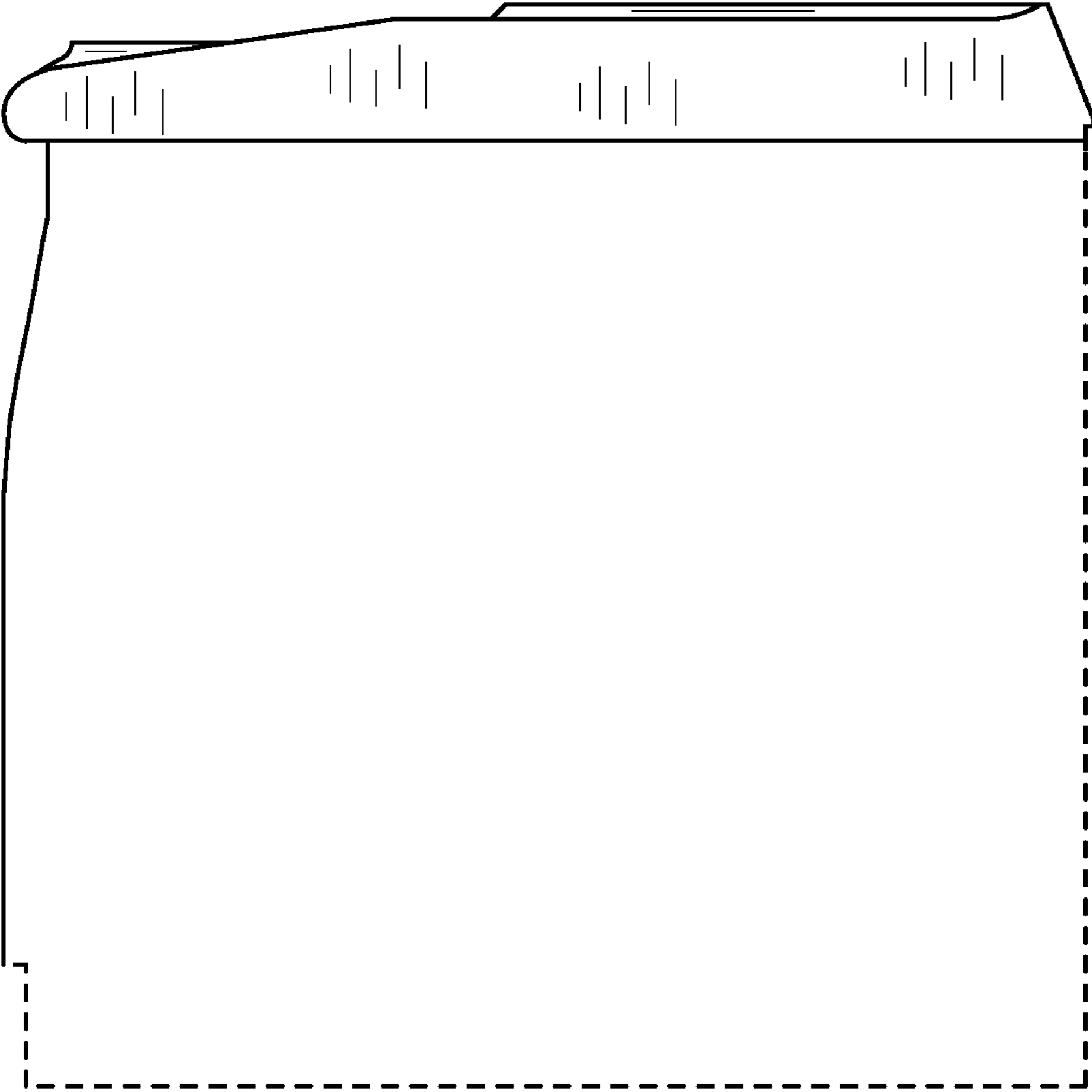

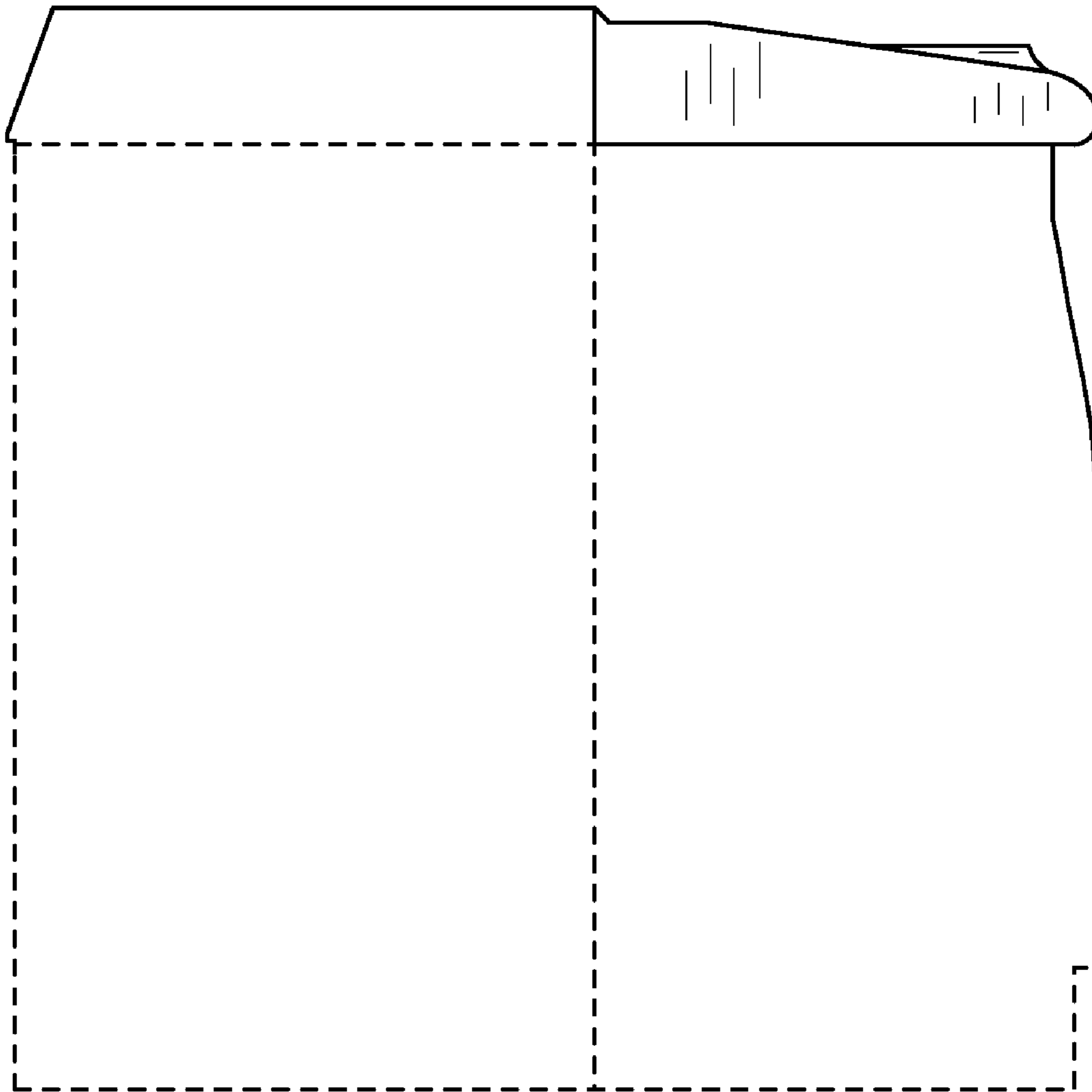

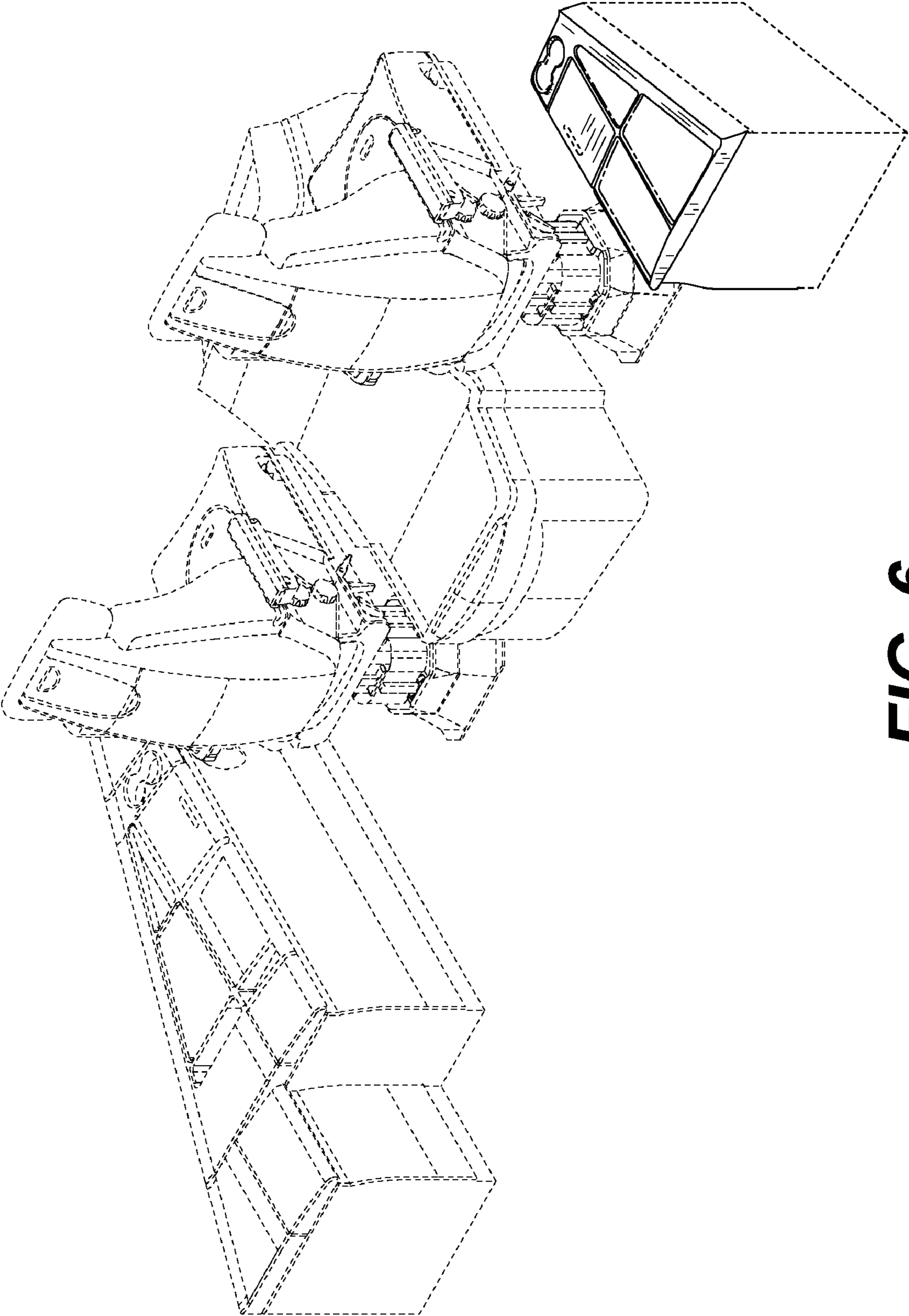
