FIG. 5 is a right side elevational view;

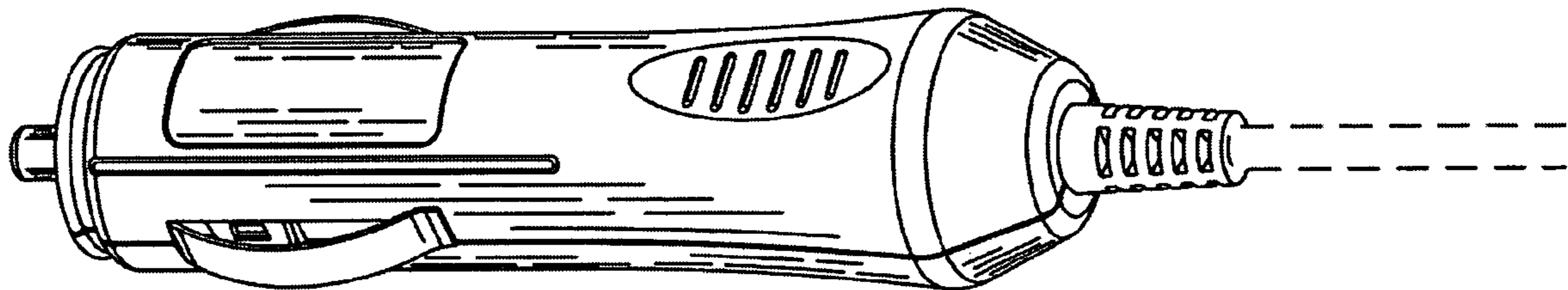
FIG. 6 is a front elevational view thereof; and,

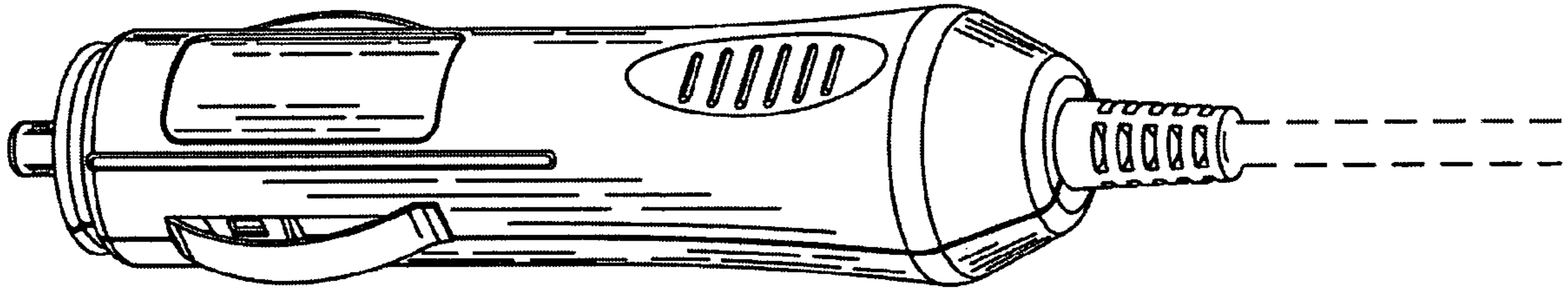

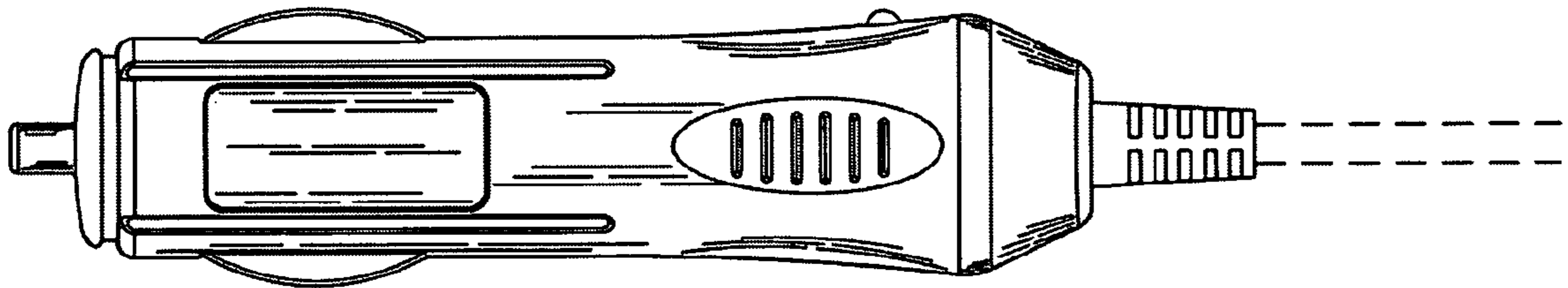

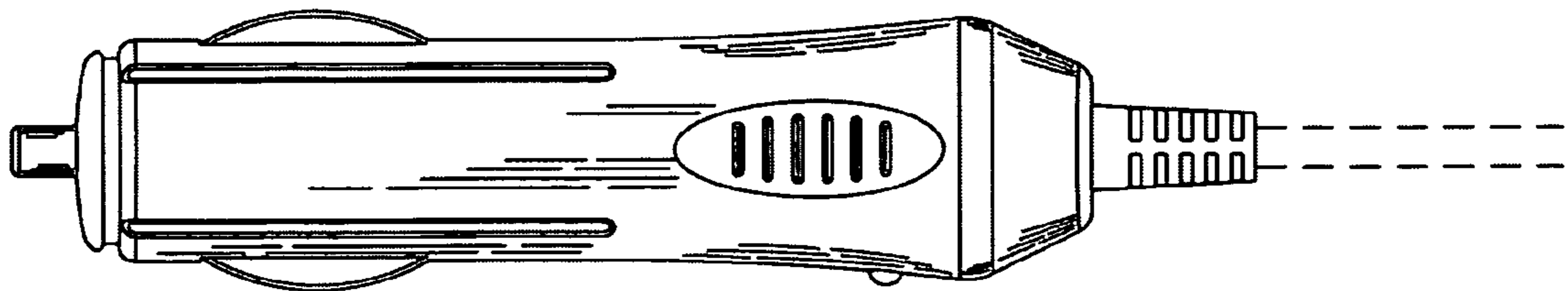

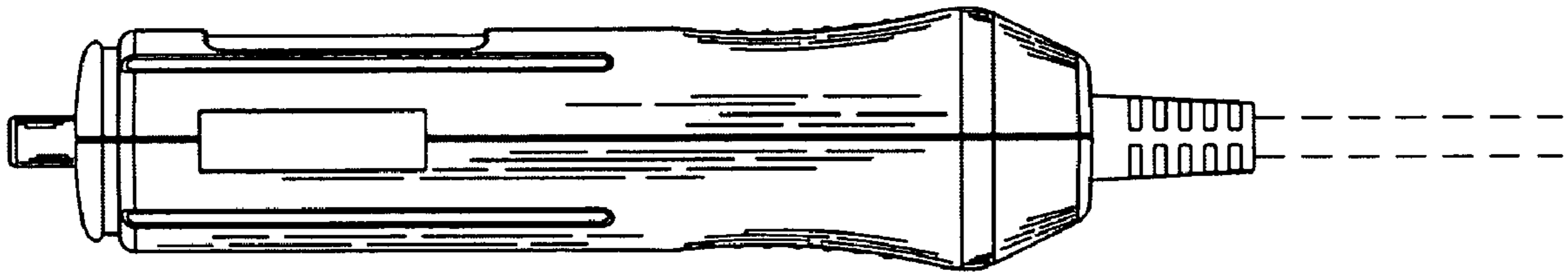

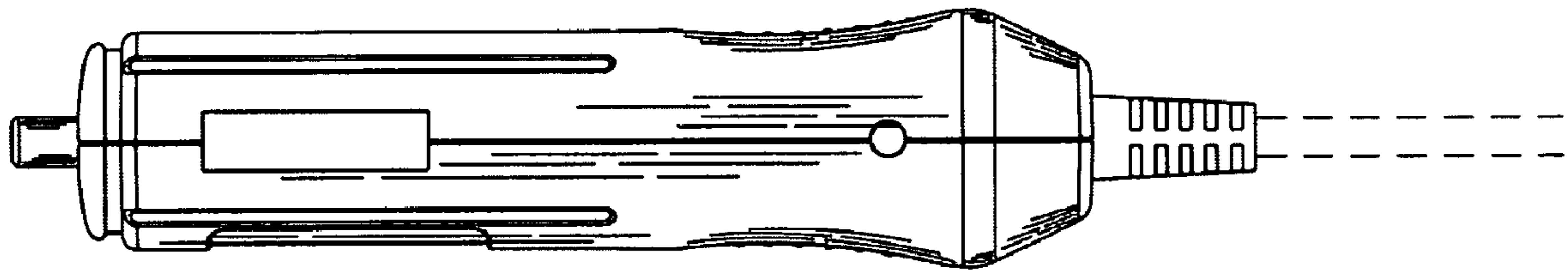

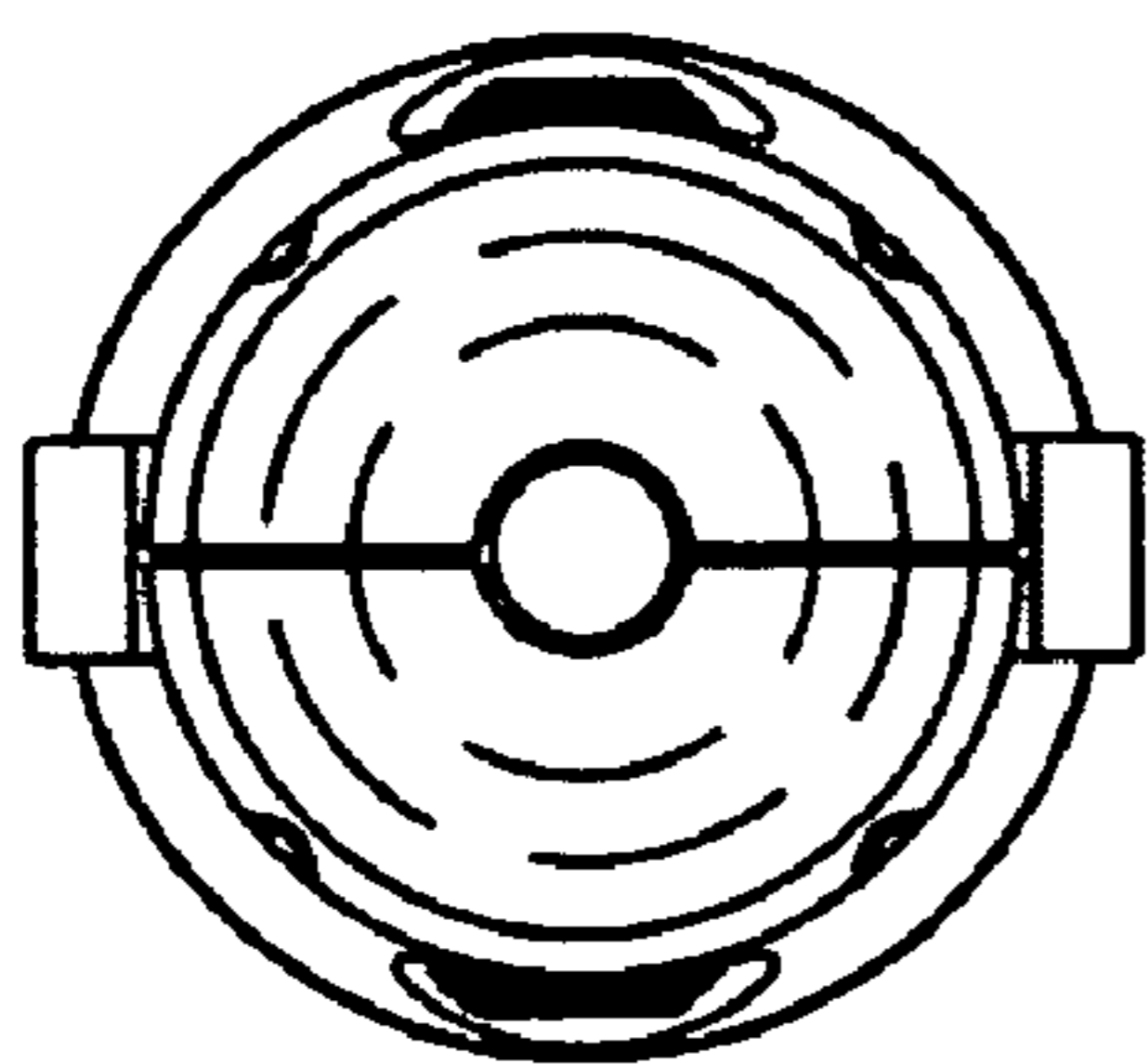

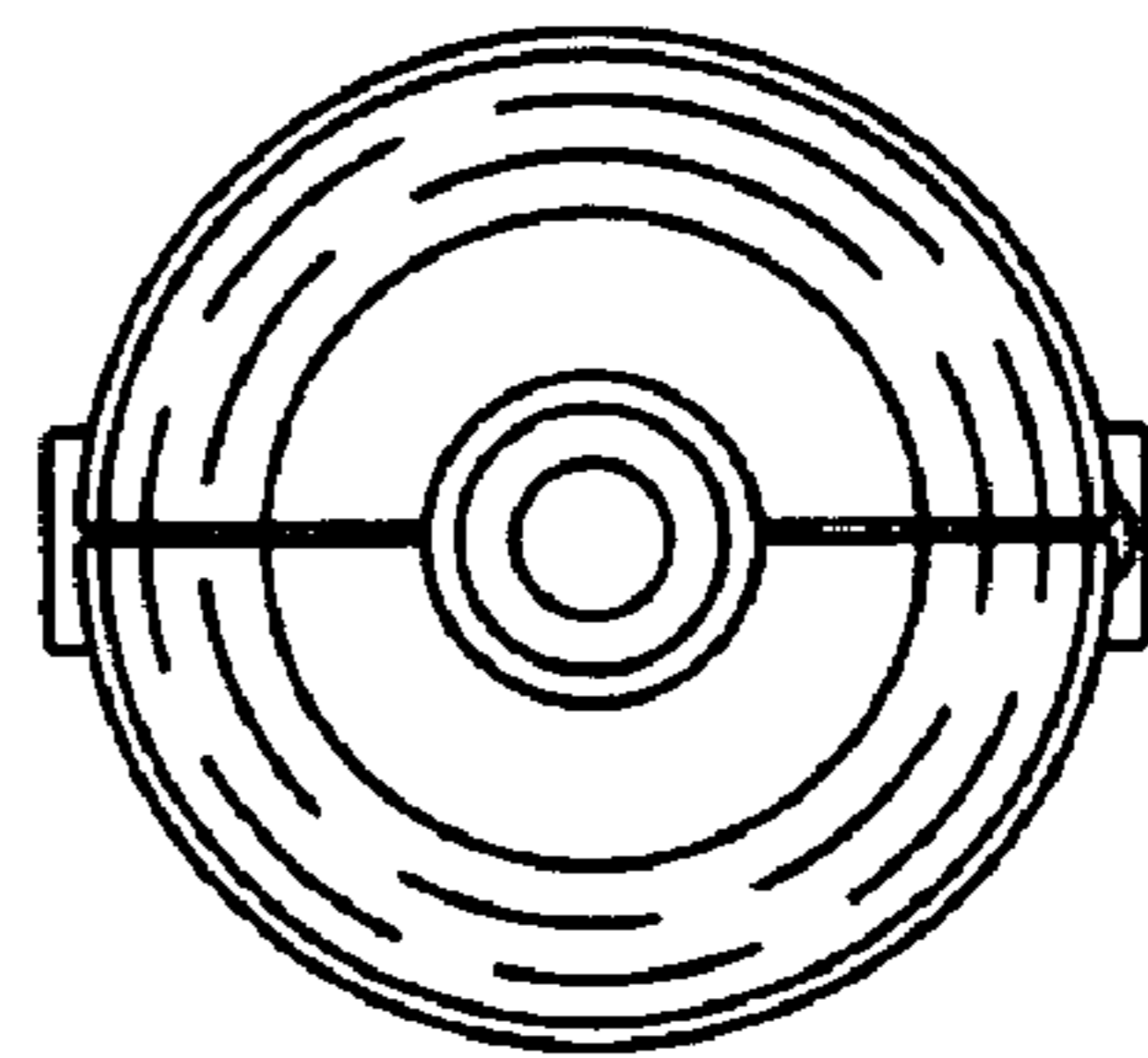
