(57) **CLAIM**

The ornamental design for a wireless modem, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the wireless modem of the present invention;

FIG. 2 is a front elevation view of the wireless modem shown in FIG. 1;

FIG. 3 is a rear elevation view of the wireless modem shown in FIG. 1;

FIG. 4 is a left side elevation view of the wireless modem shown in FIG. 1;

FIG. 5 is a right side elevation view of the wireless modem shown in FIG. 1;

FIG. 6 is a top plan view of the wireless modem shown in FIG. 1;

FIG. 7 is a bottom plan view of the wireless modem shown in FIG. 1; and,

FIG. 8 is a perspective view of the wireless modem shown in FIG. 1 with the front cover opened and the USB plug rotated.

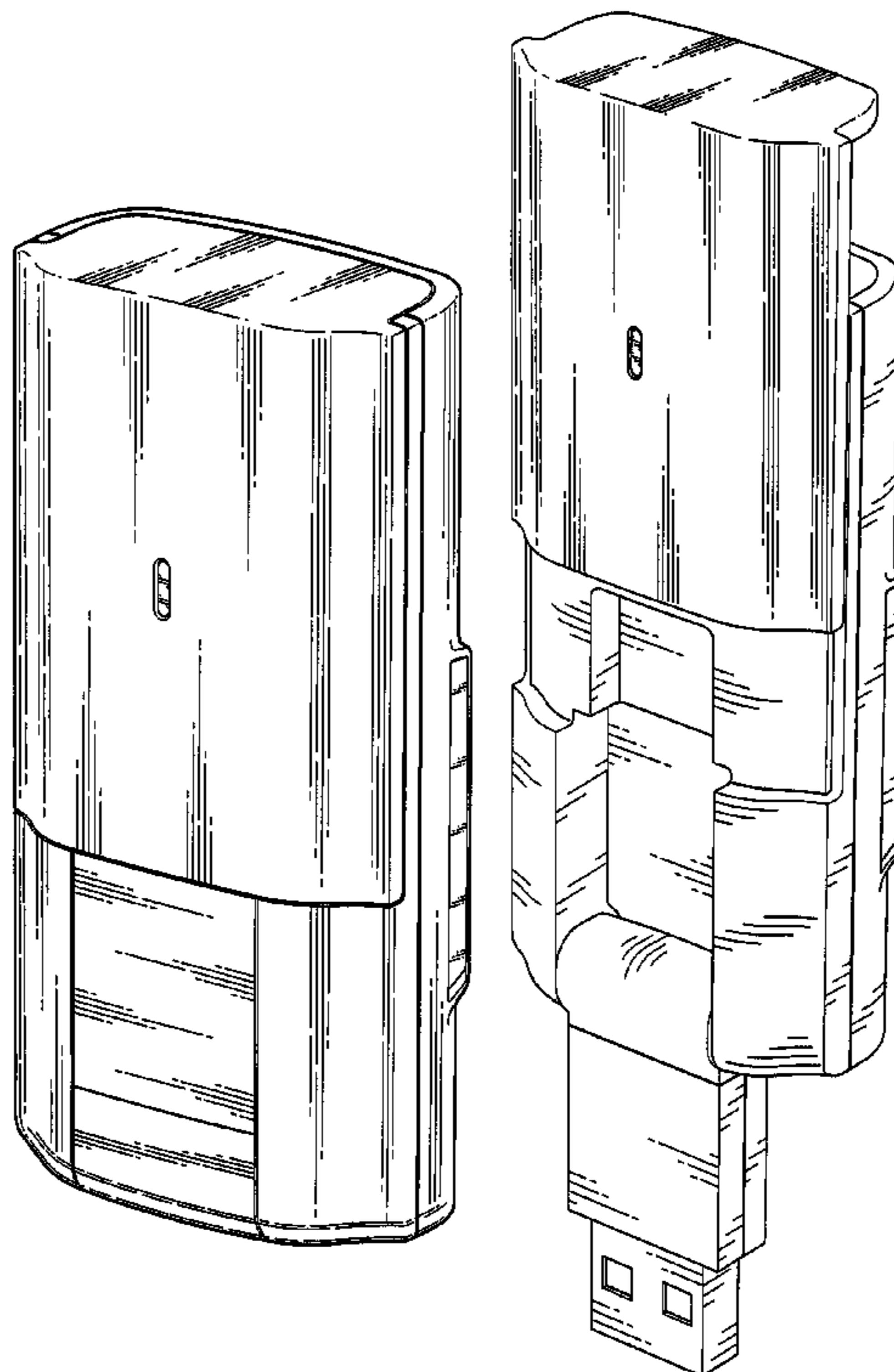
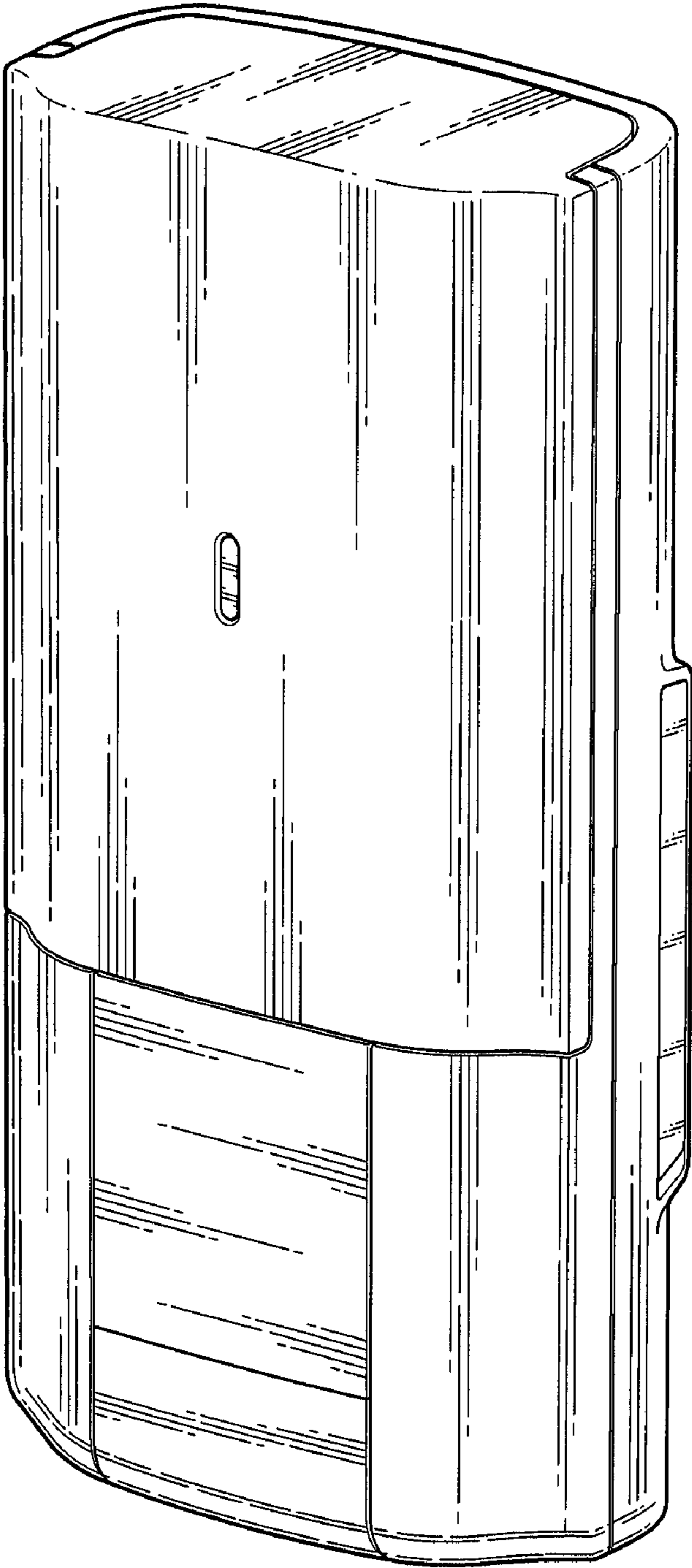

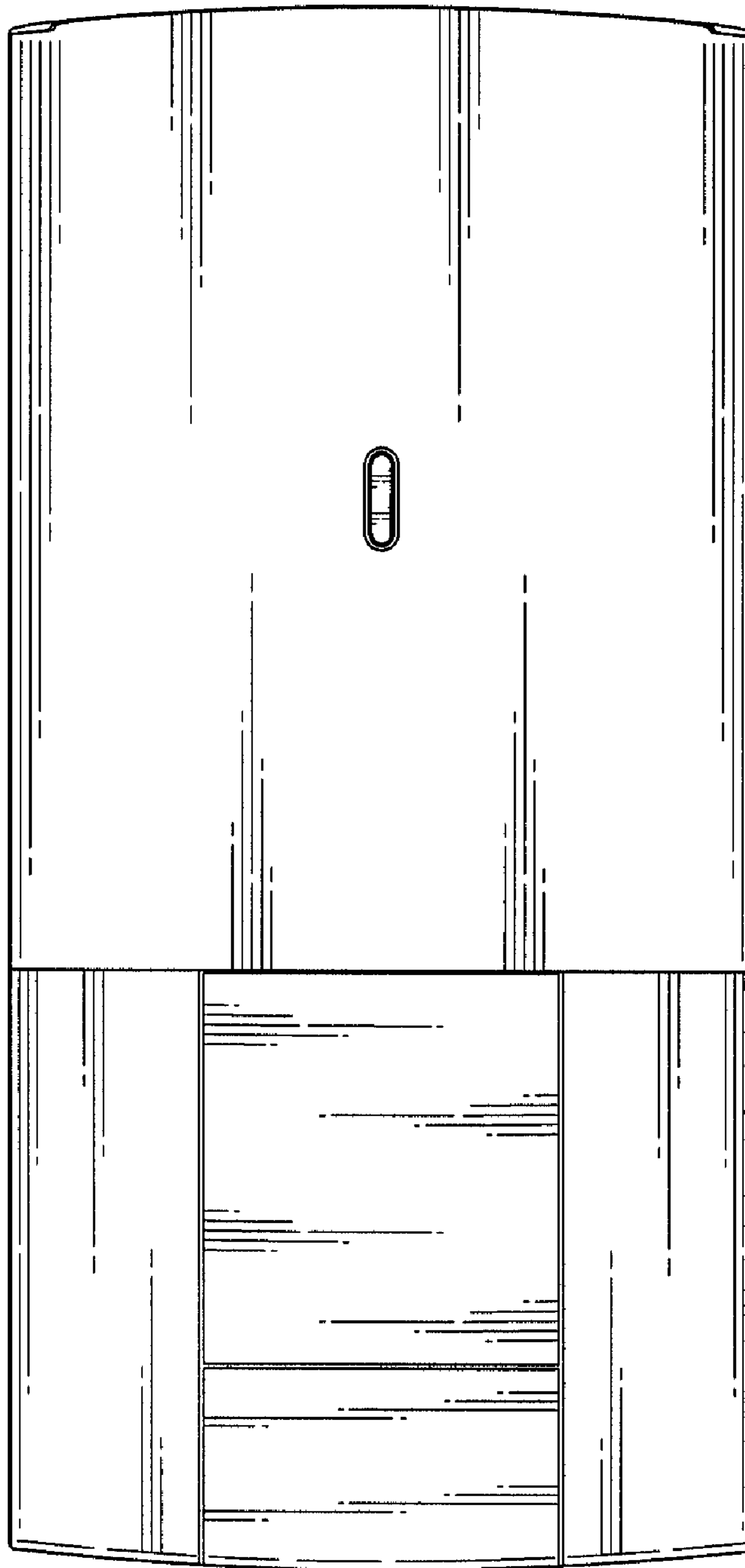

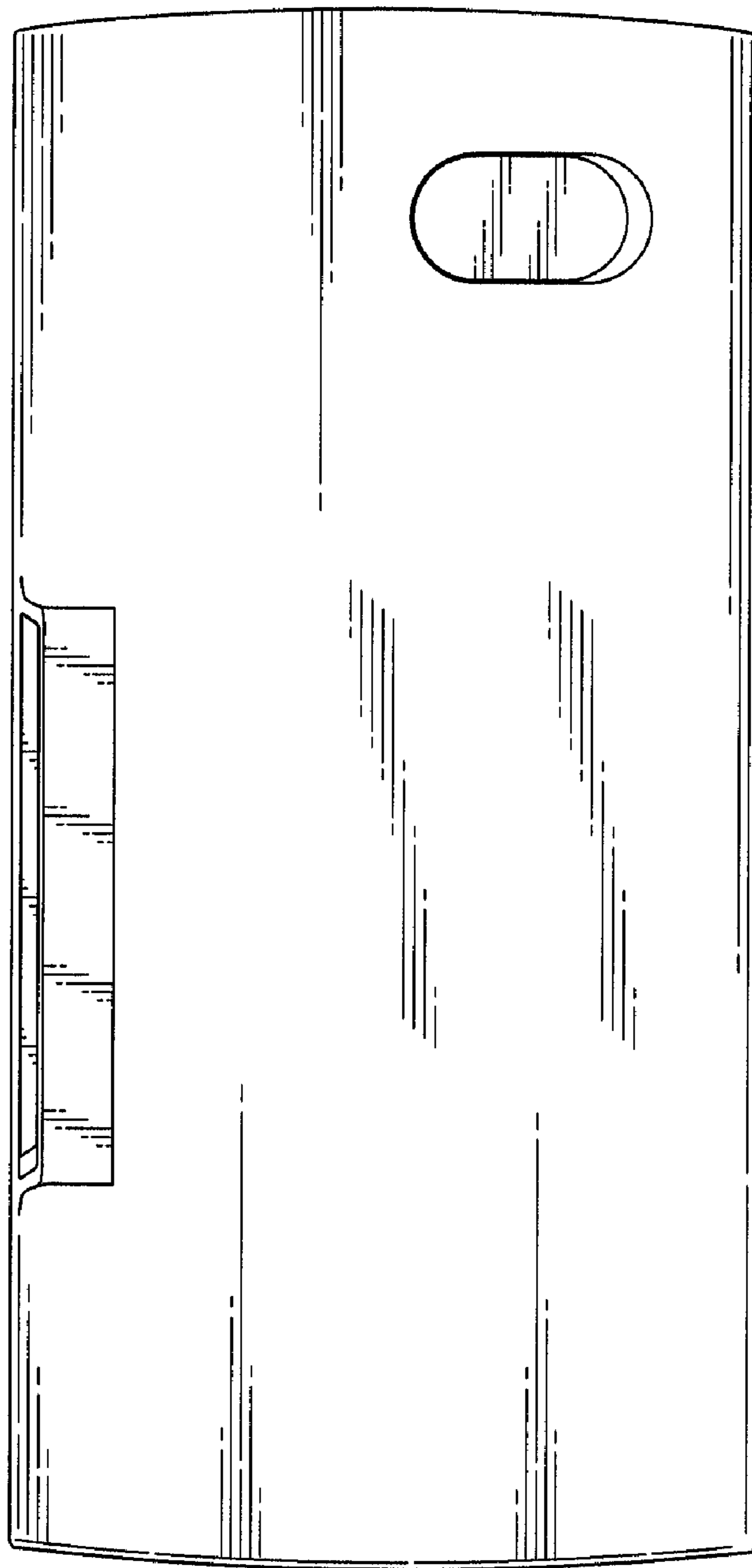

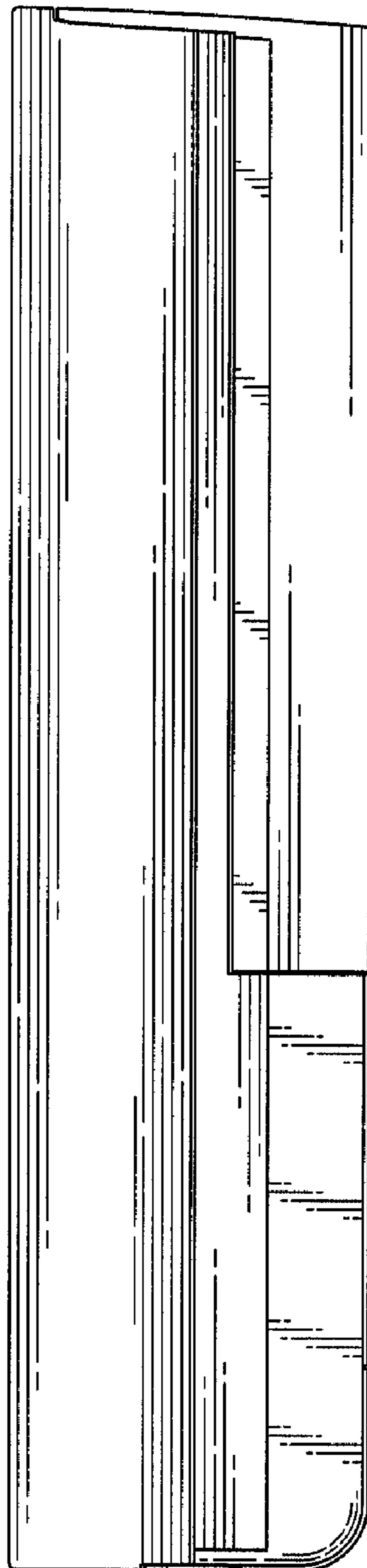
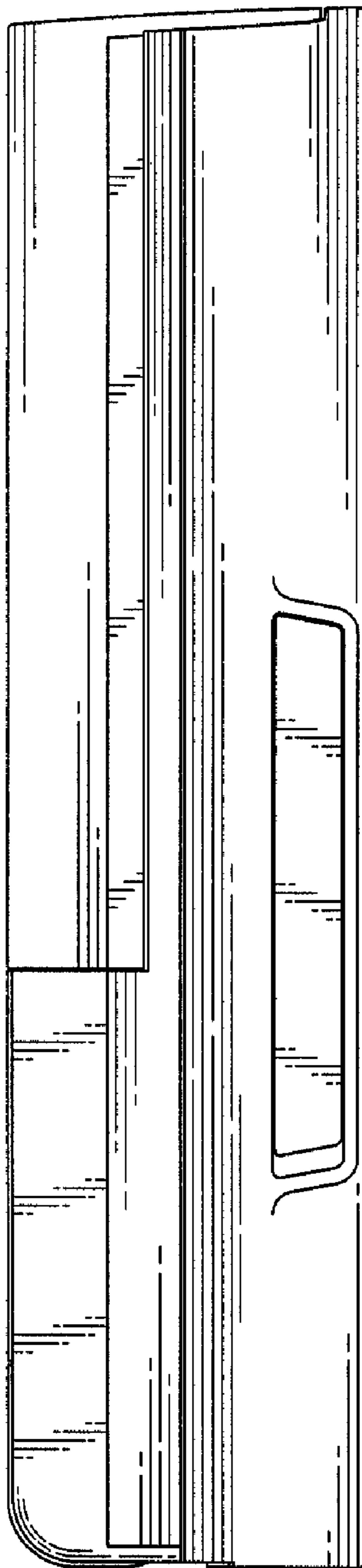
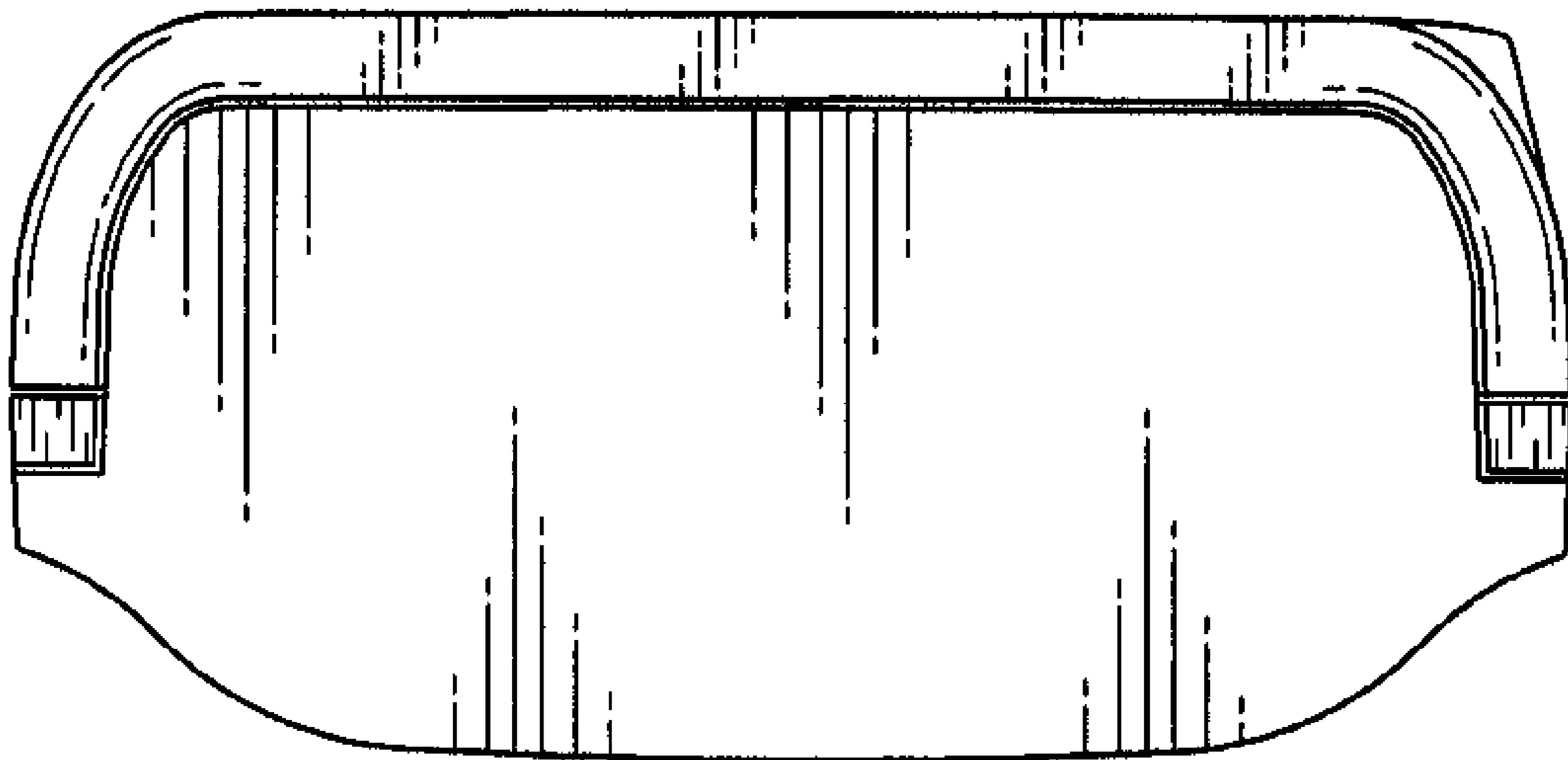

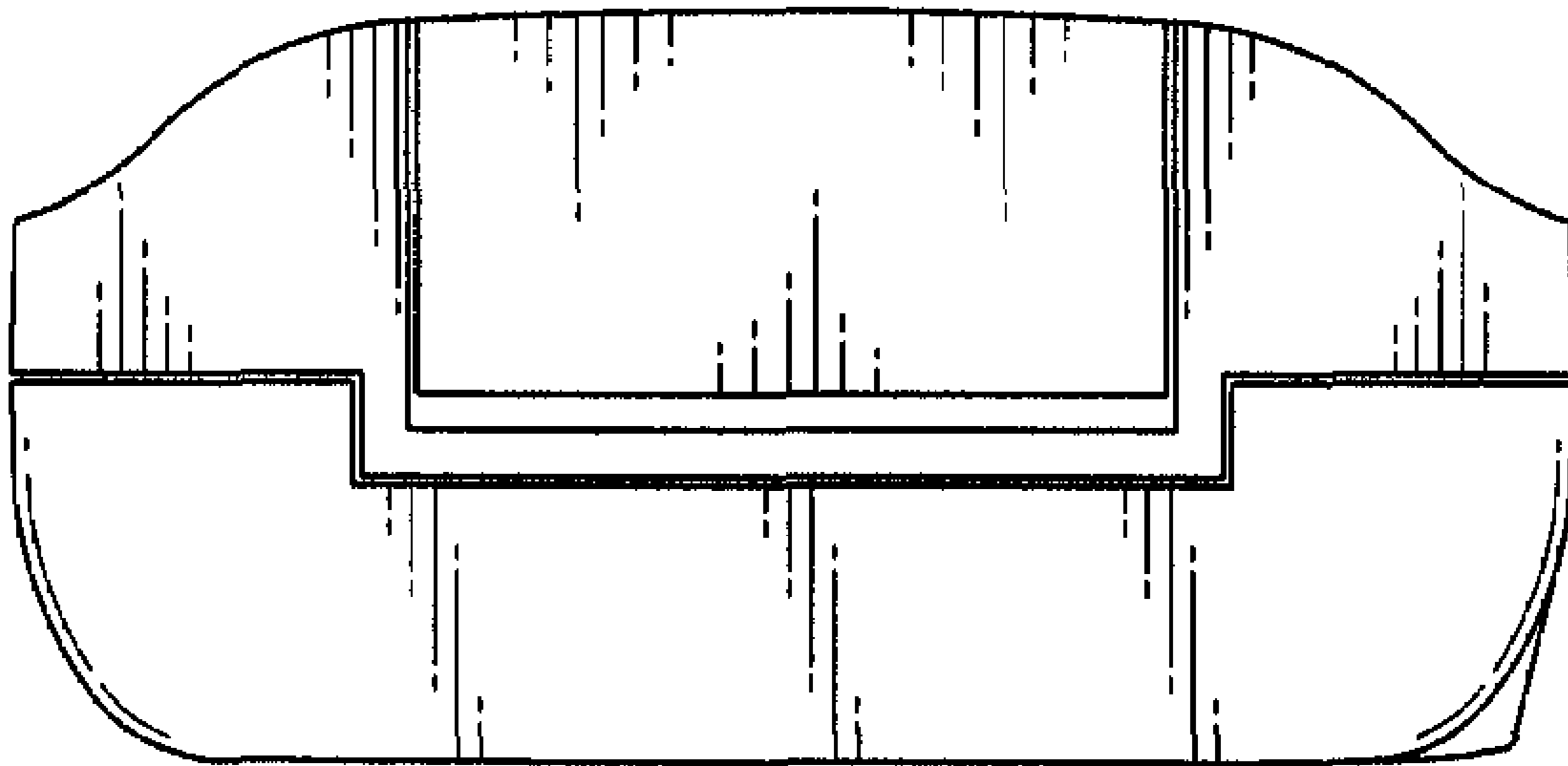
