(57) **CLAIM**

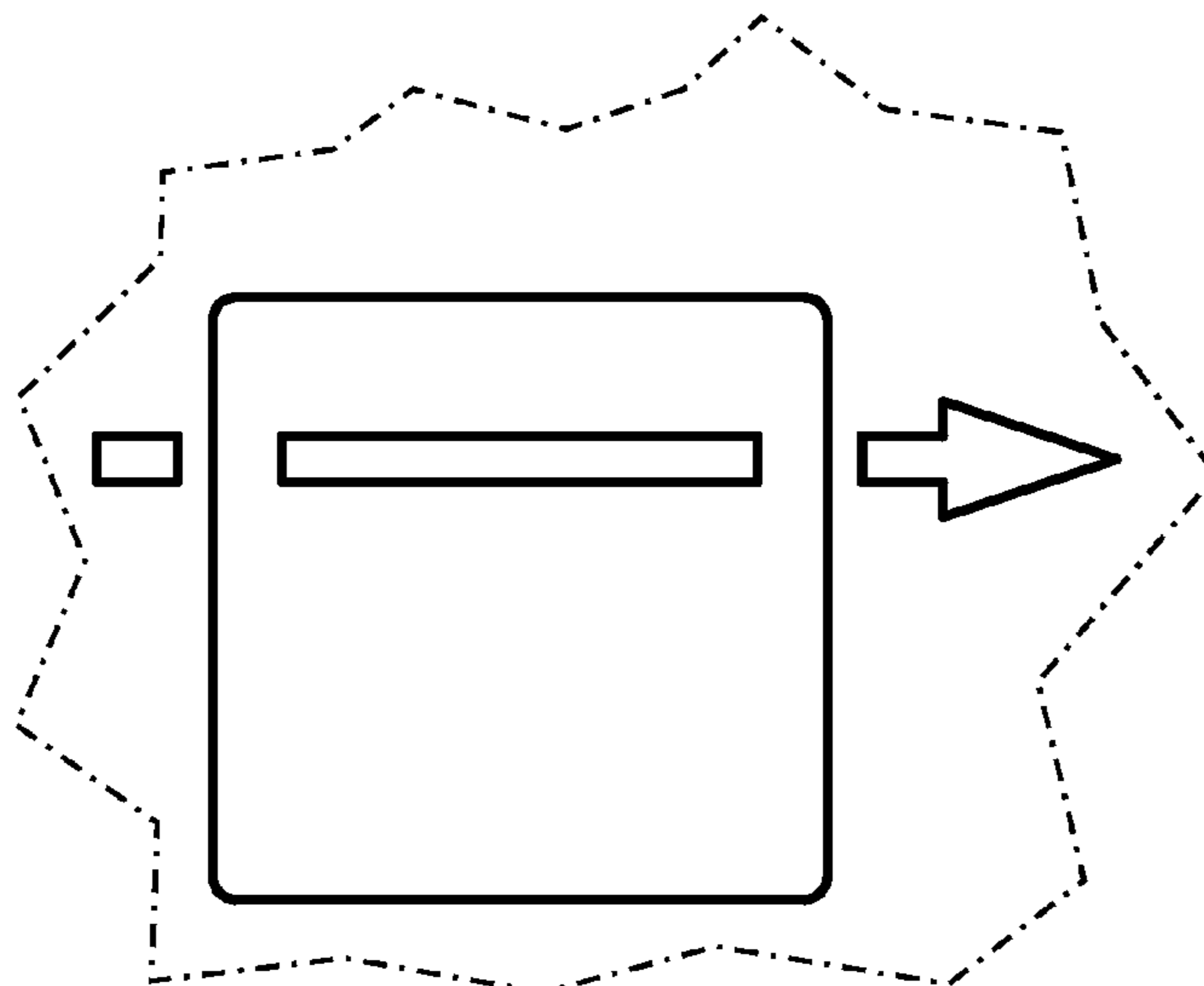
The ornamental design for a word free icon for a document finishing device of a printer, as shown and described.
