FIG. 1 is a left front perspective view of a printing unit configuration showing my new design;

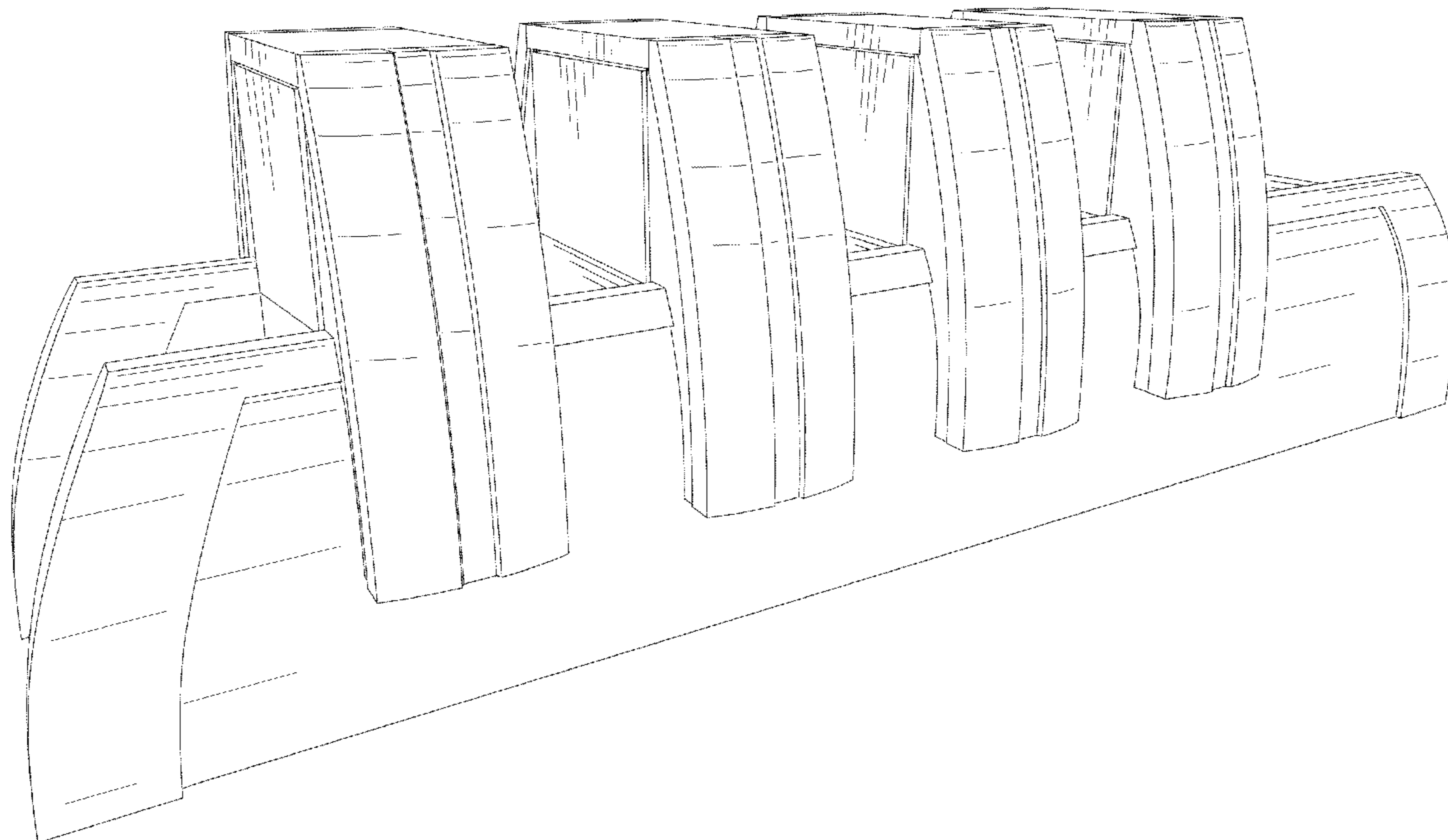
FIG. 2 is a front perspective view thereof;

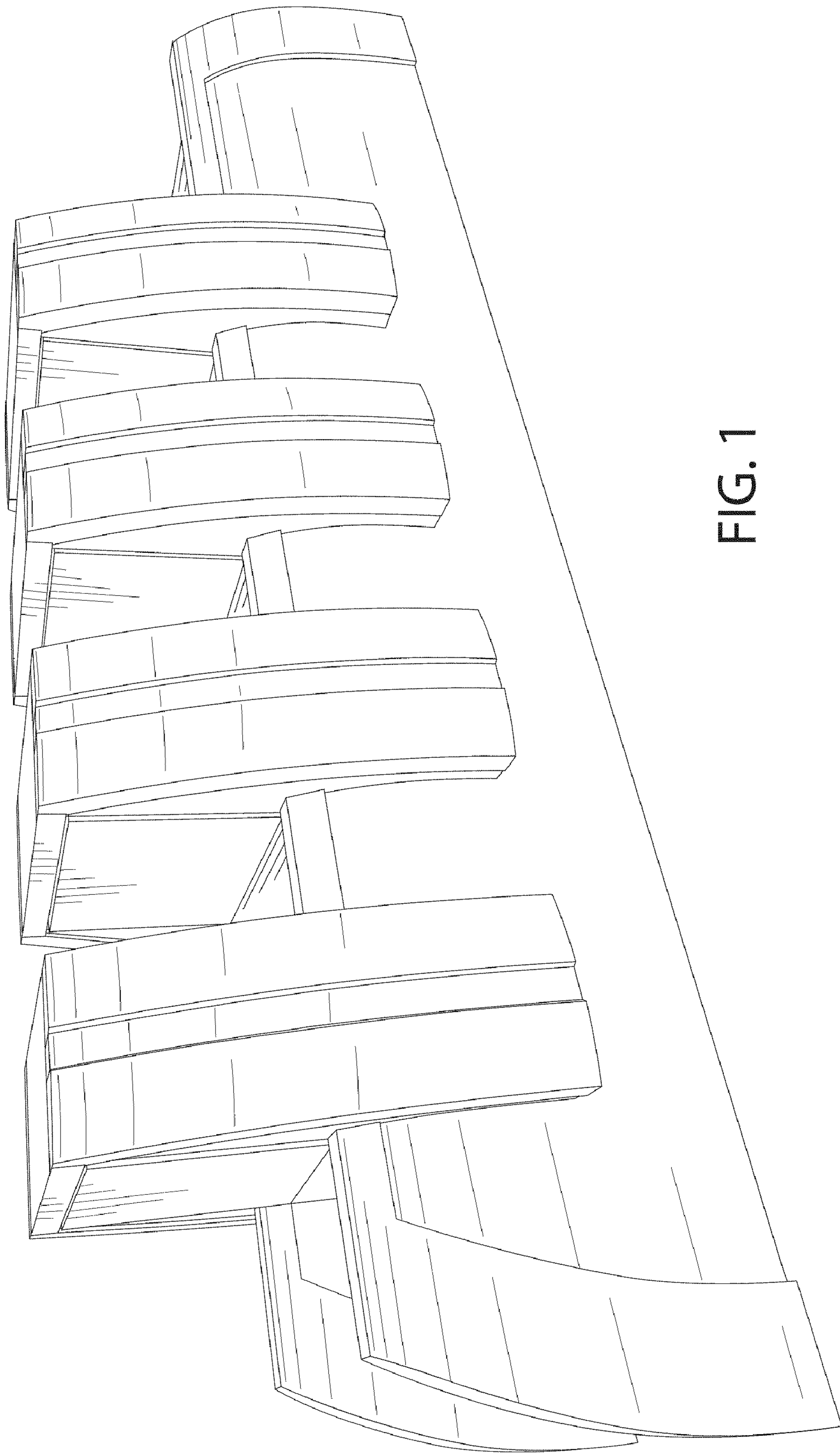

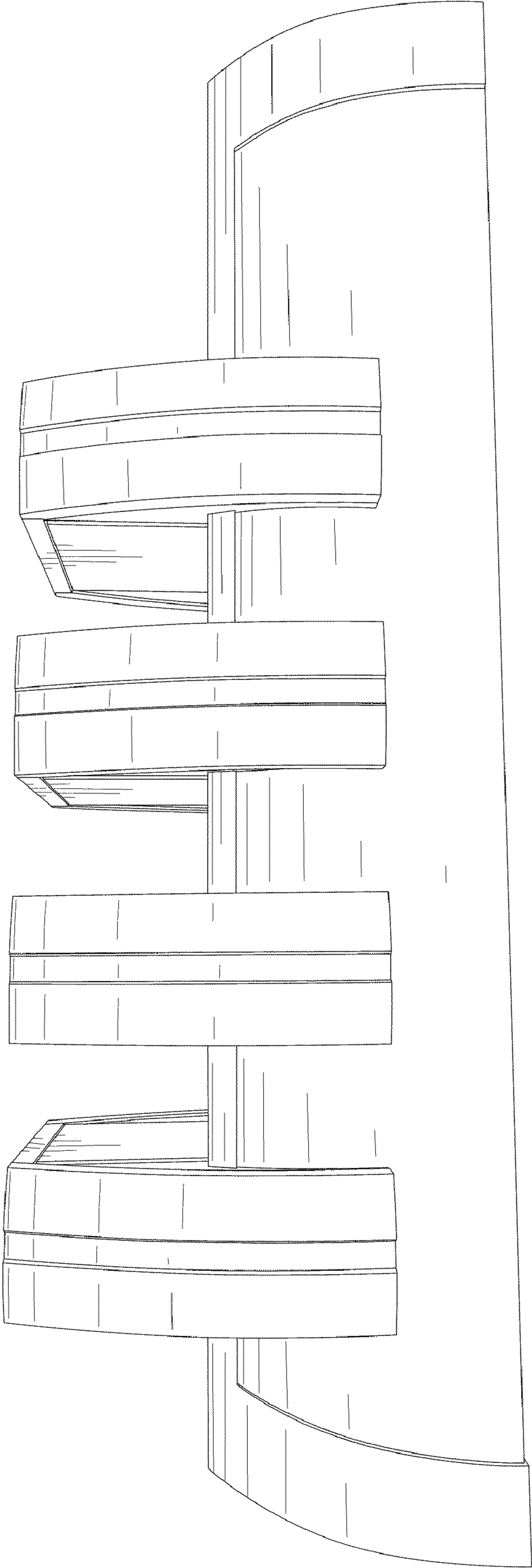

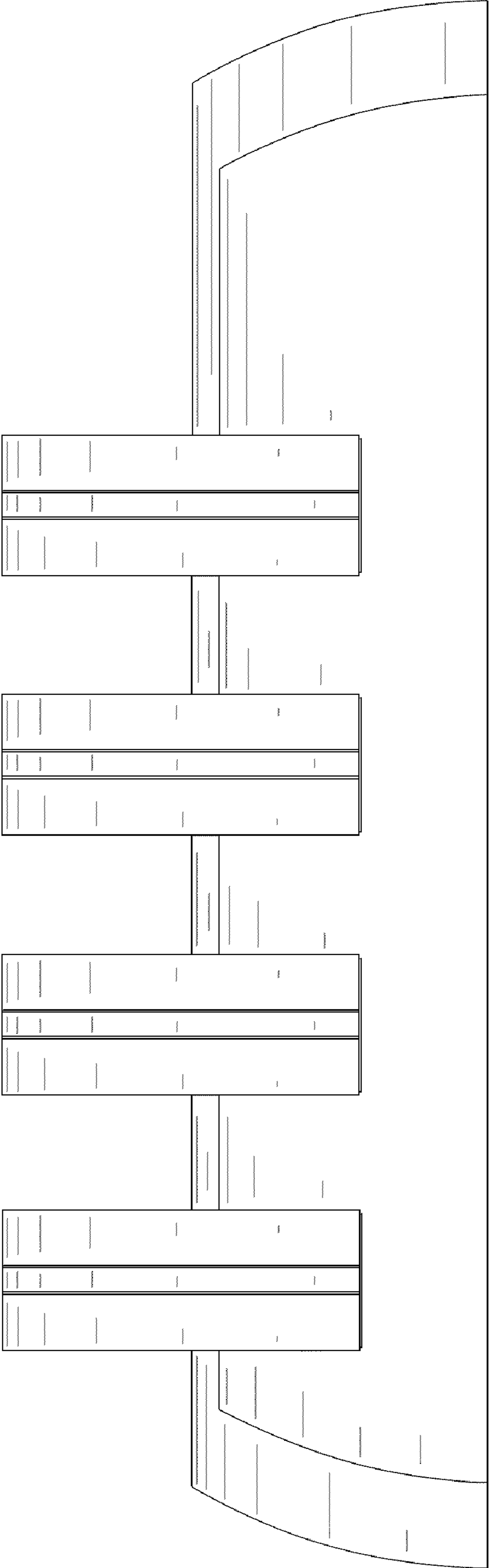

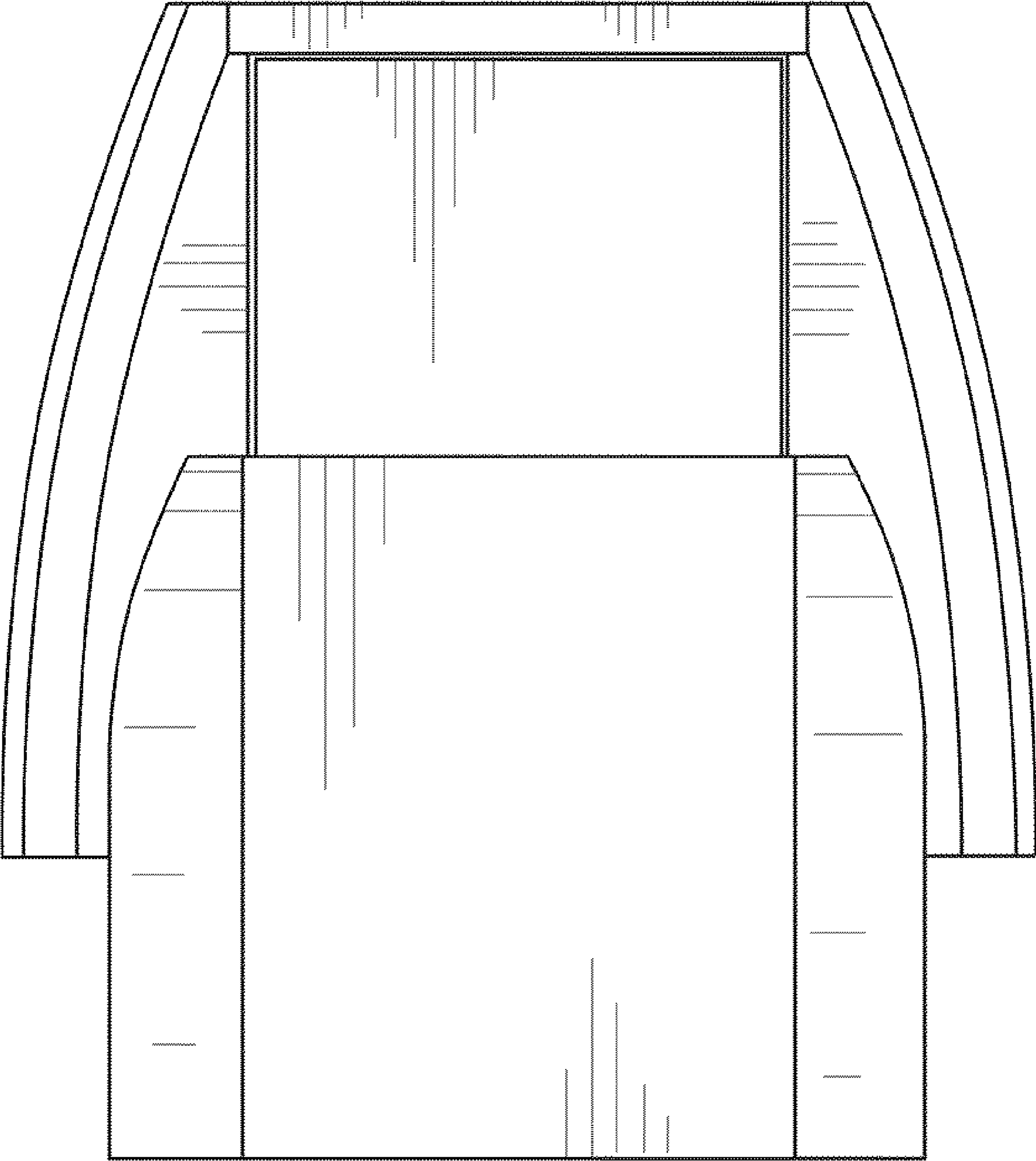

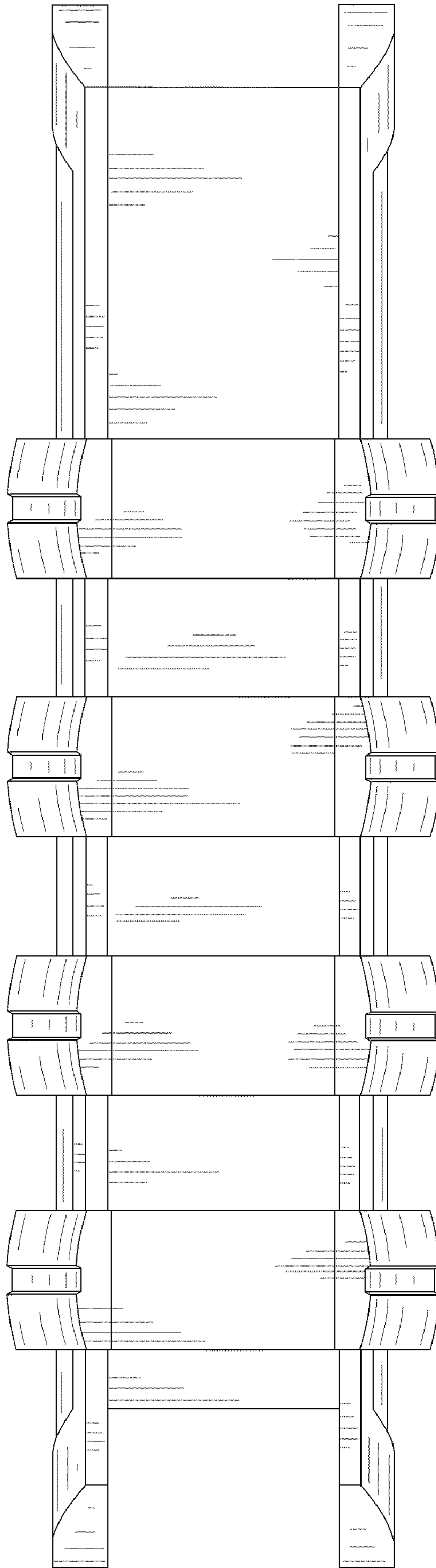
