**DESCRIPTION**

FIG. 1 is the front view of an ink tank for printer showing our new design;

FIG. 4 is a bottom plan view thereof;

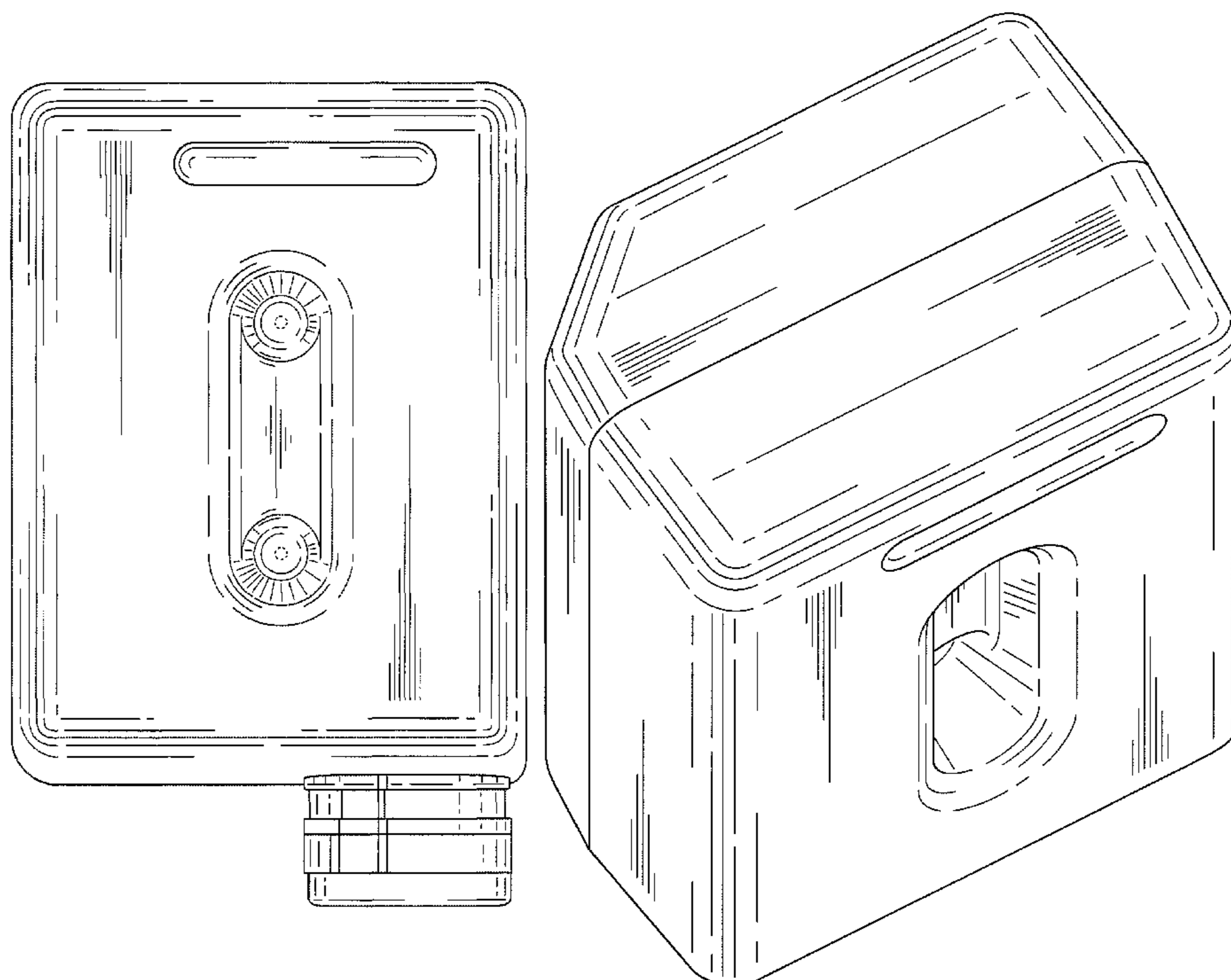
FIG. 5 is a left side view thereof;

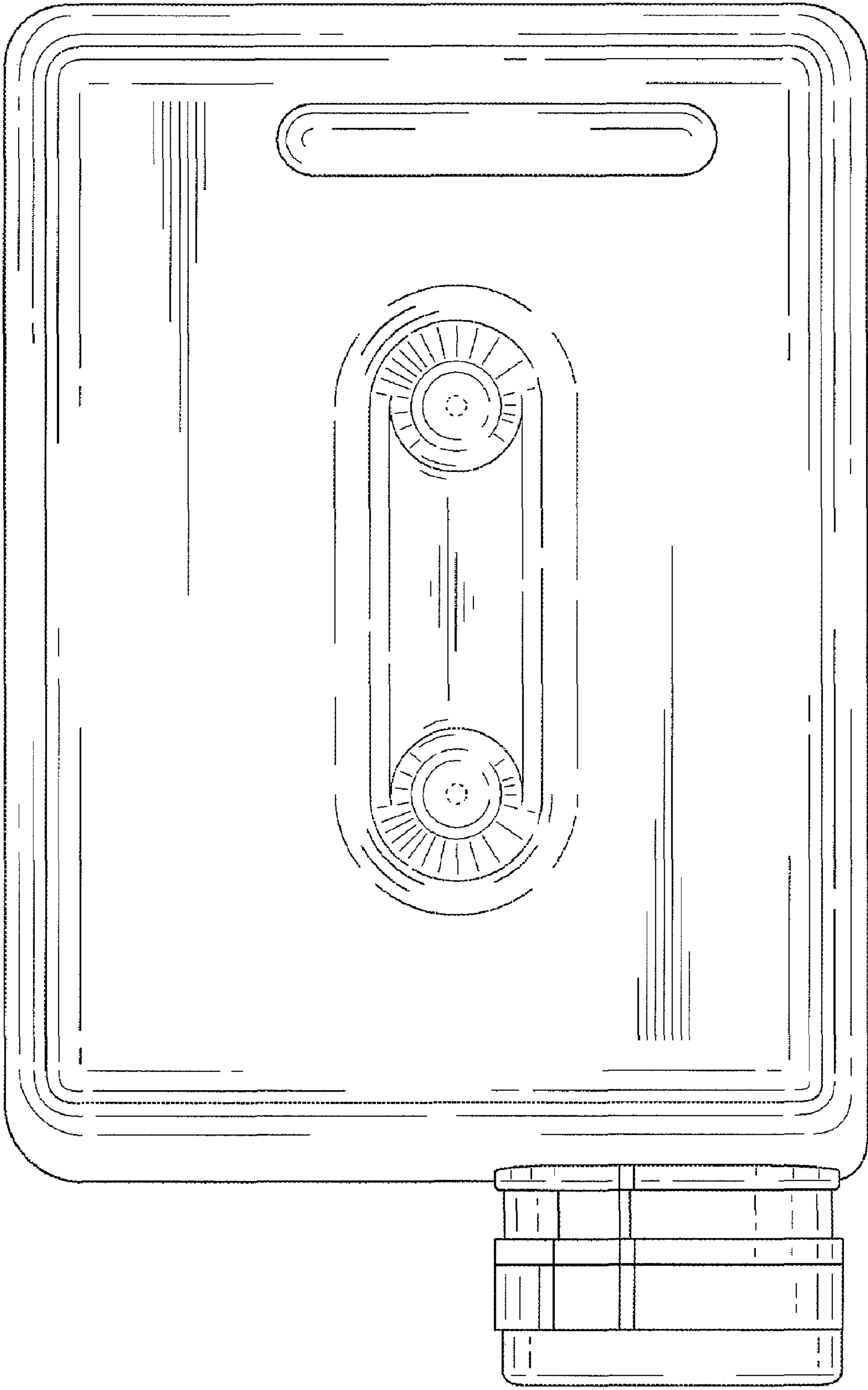
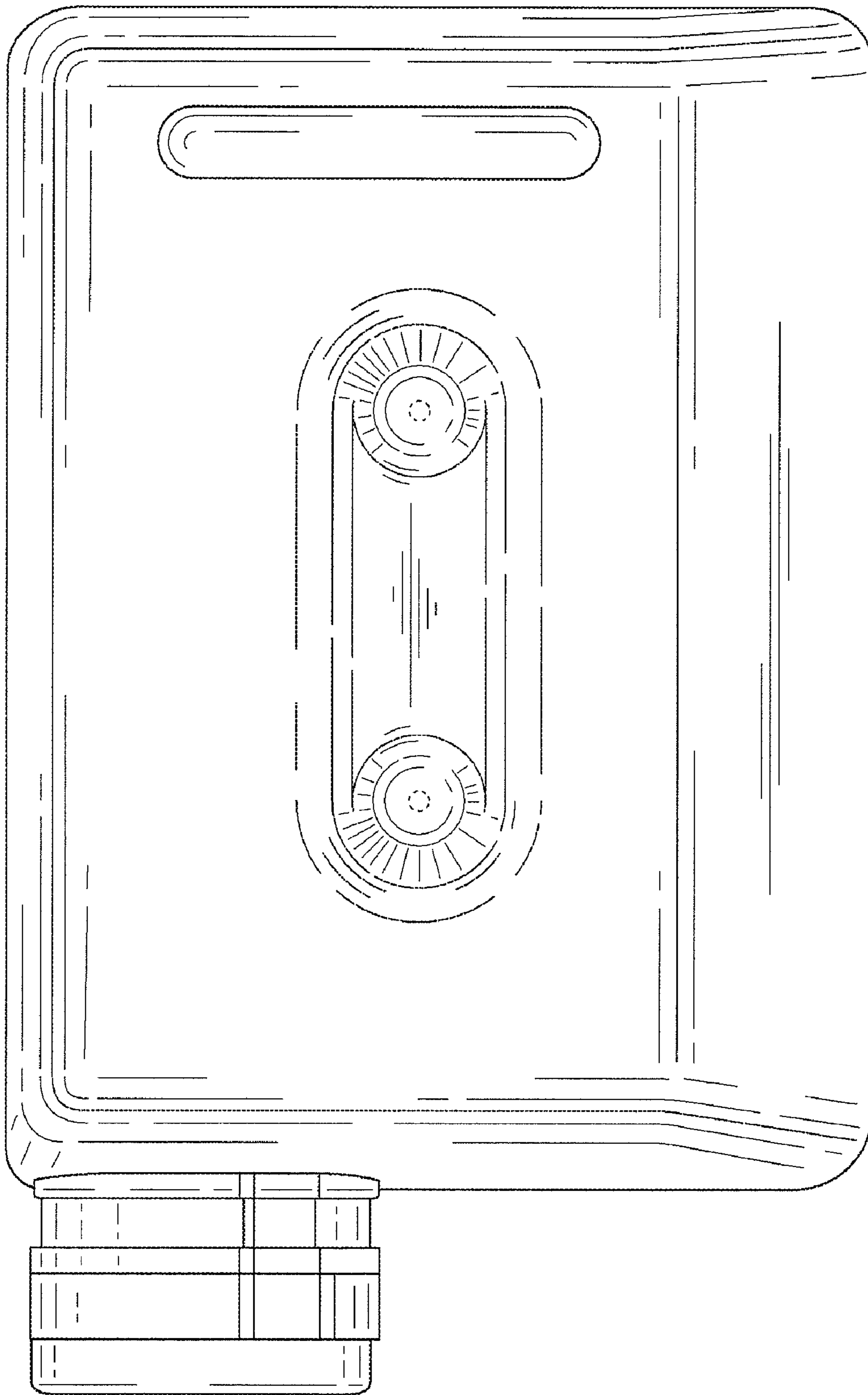

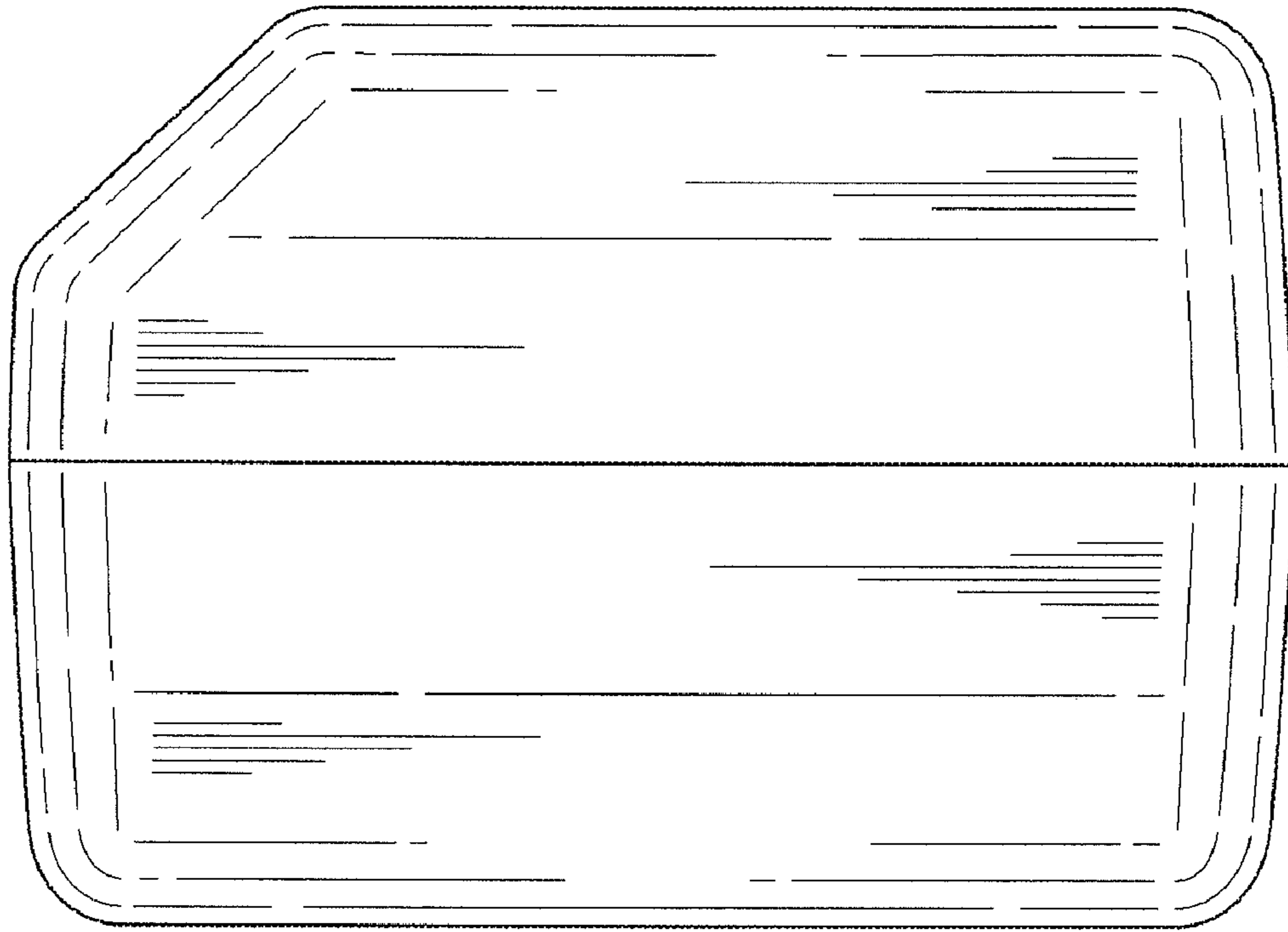

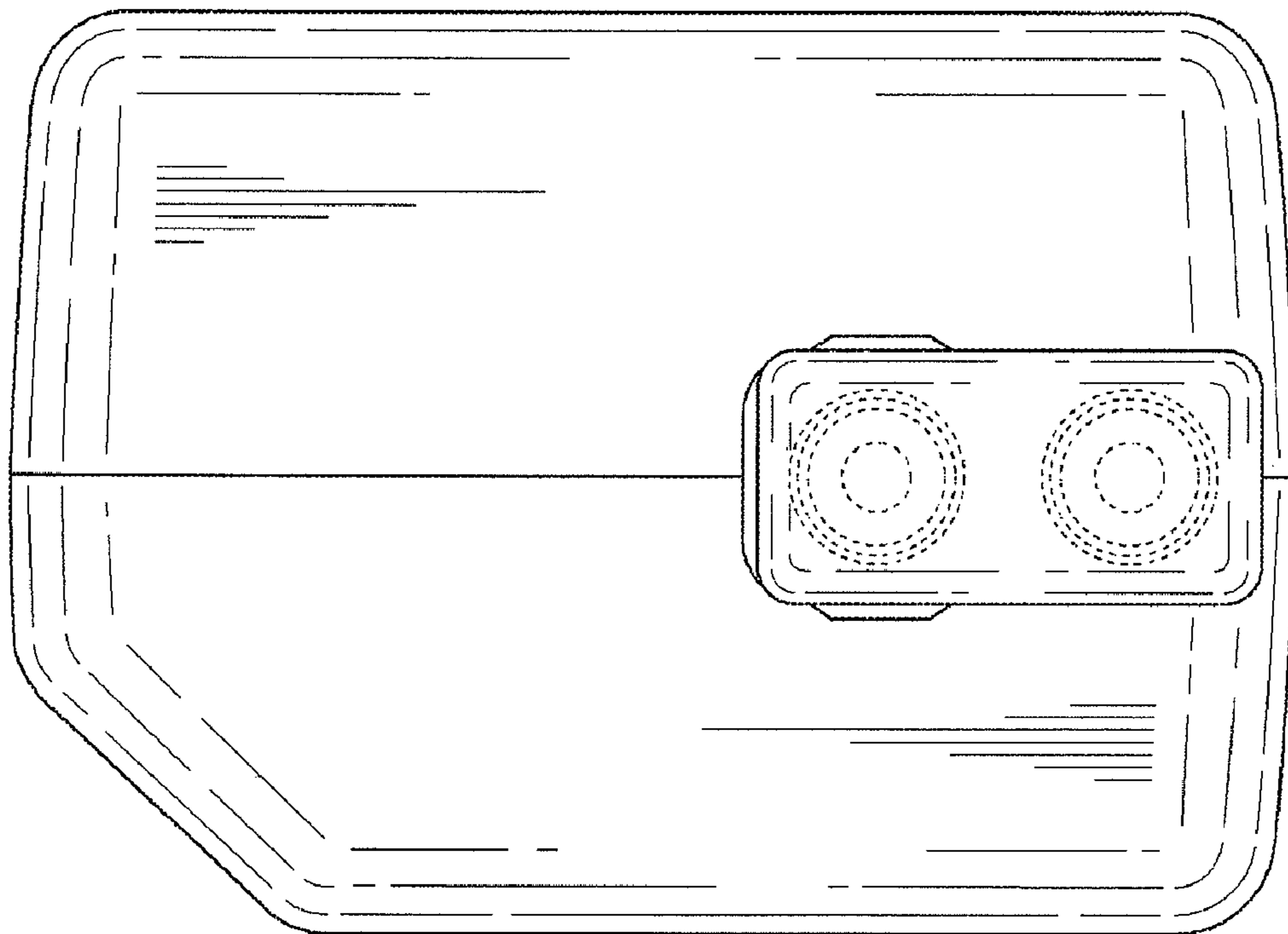

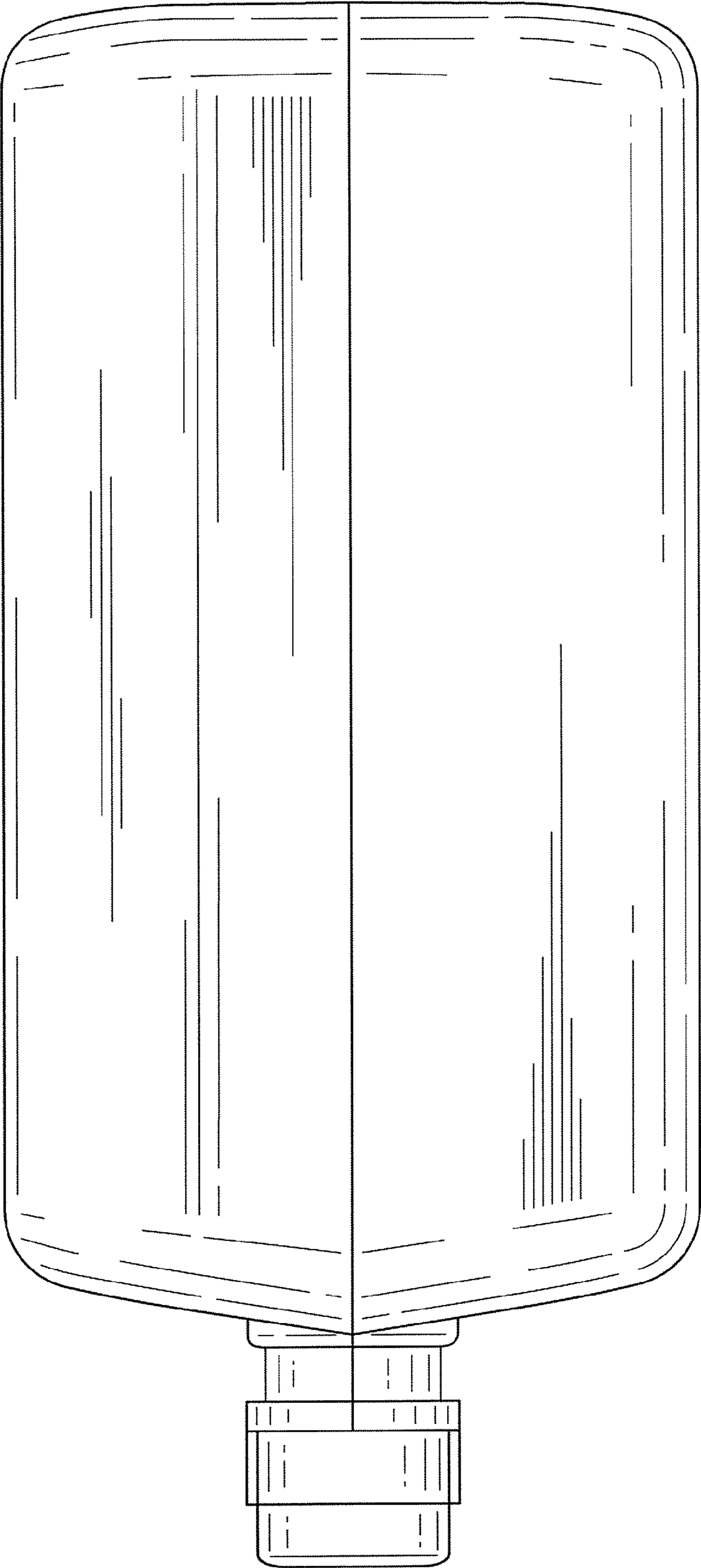
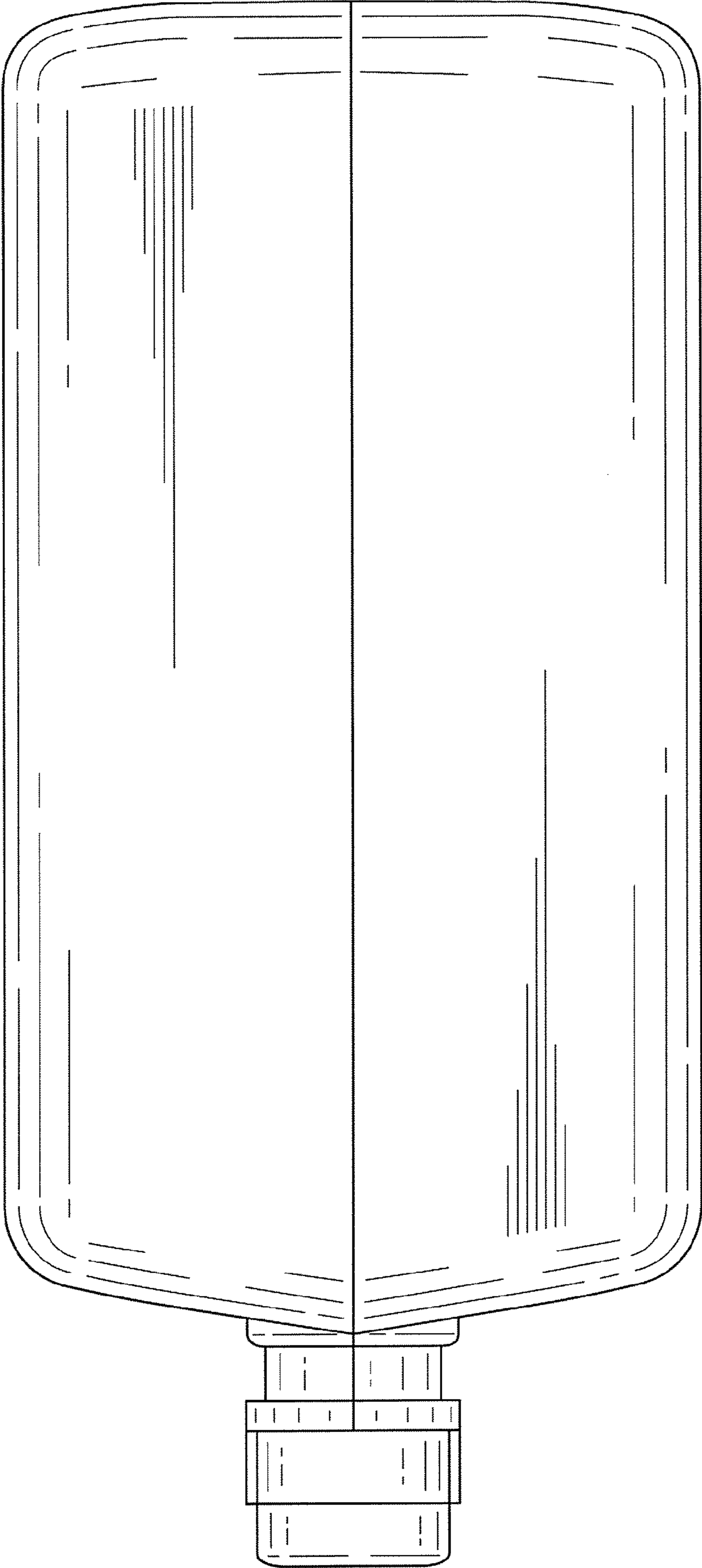
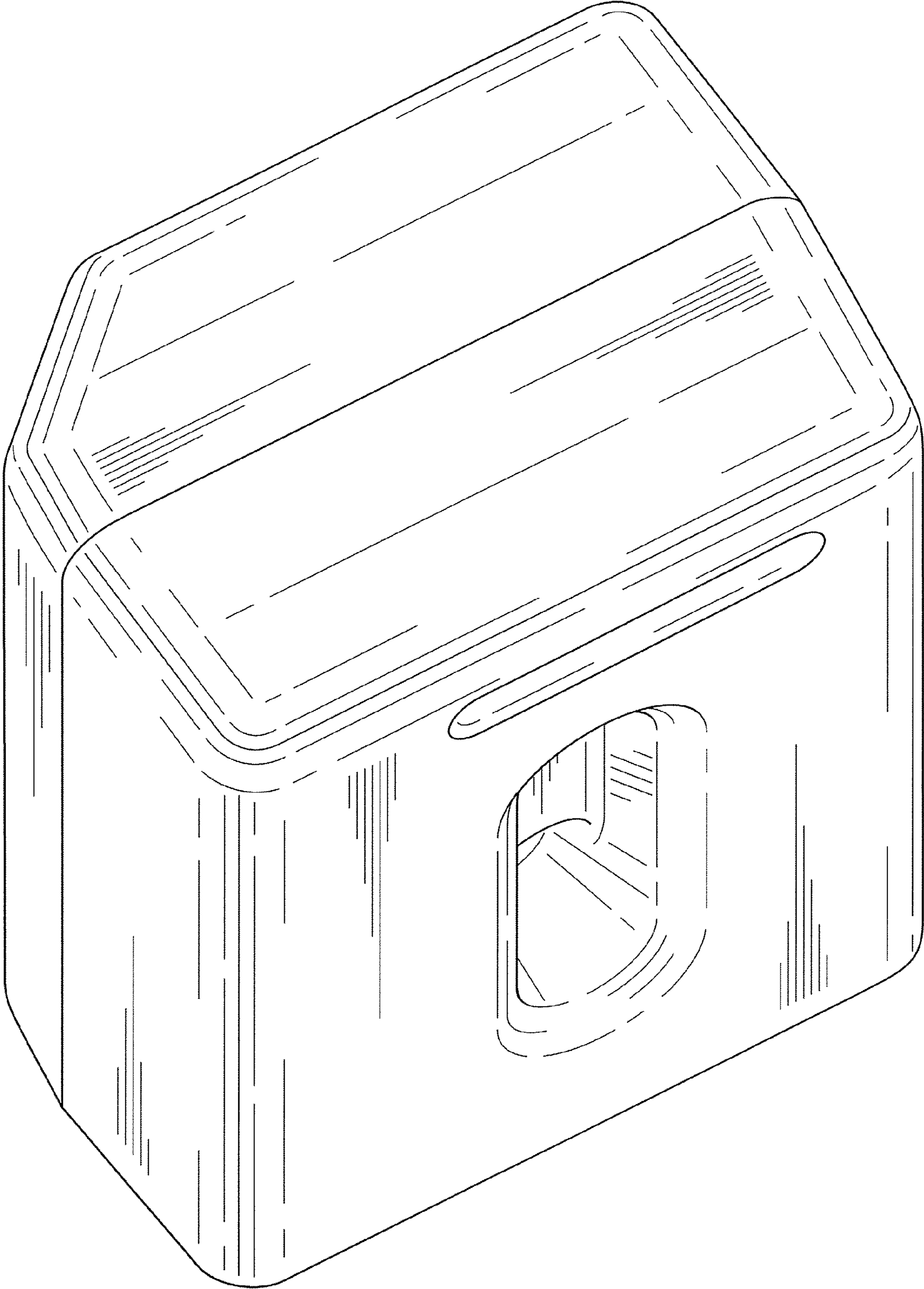
