(57) **CLAIM**

The ornamental design for the double ended tag for bag, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the double ended tag for bag of this invention, shown in use;

FIG. 2 is an isometric view of the tag for bag;

FIG. 3 is a front view, the back view being a mirror image thereof;

FIG. 4 is a side view, the opposite side view being a mirror thereof;

FIG. 5 is a top view, the bottom view being a mirror image thereof;

FIG. 6 is a perspective view of a modified double ended tag for bag;

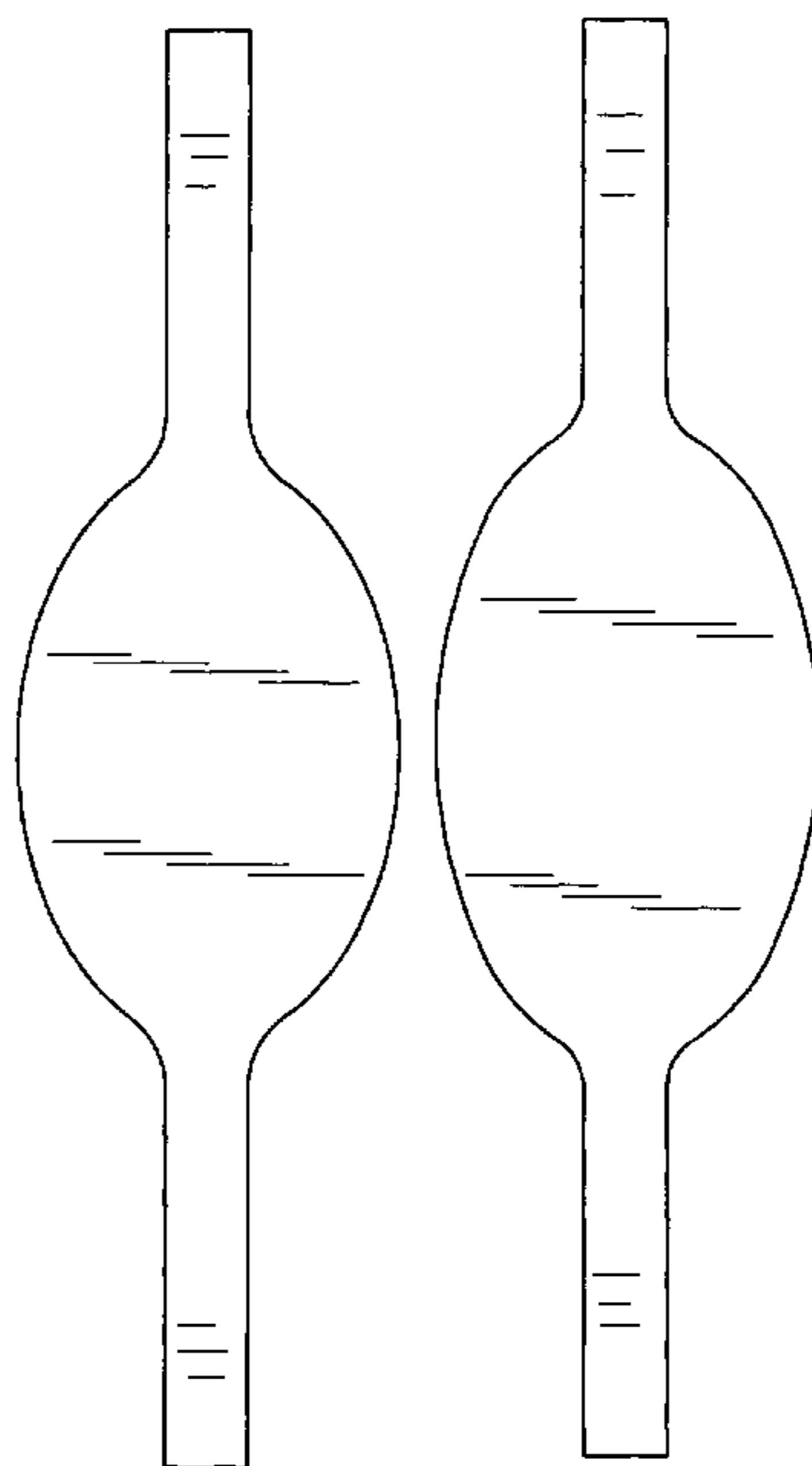
FIG. 7 is a front view, the back view being a mirror image thereof;

FIG. 8 is a side view, the opposite side view being a mirror image thereof; and,

FIG. 9 is a top view, the bottom view being a mirror image thereof.

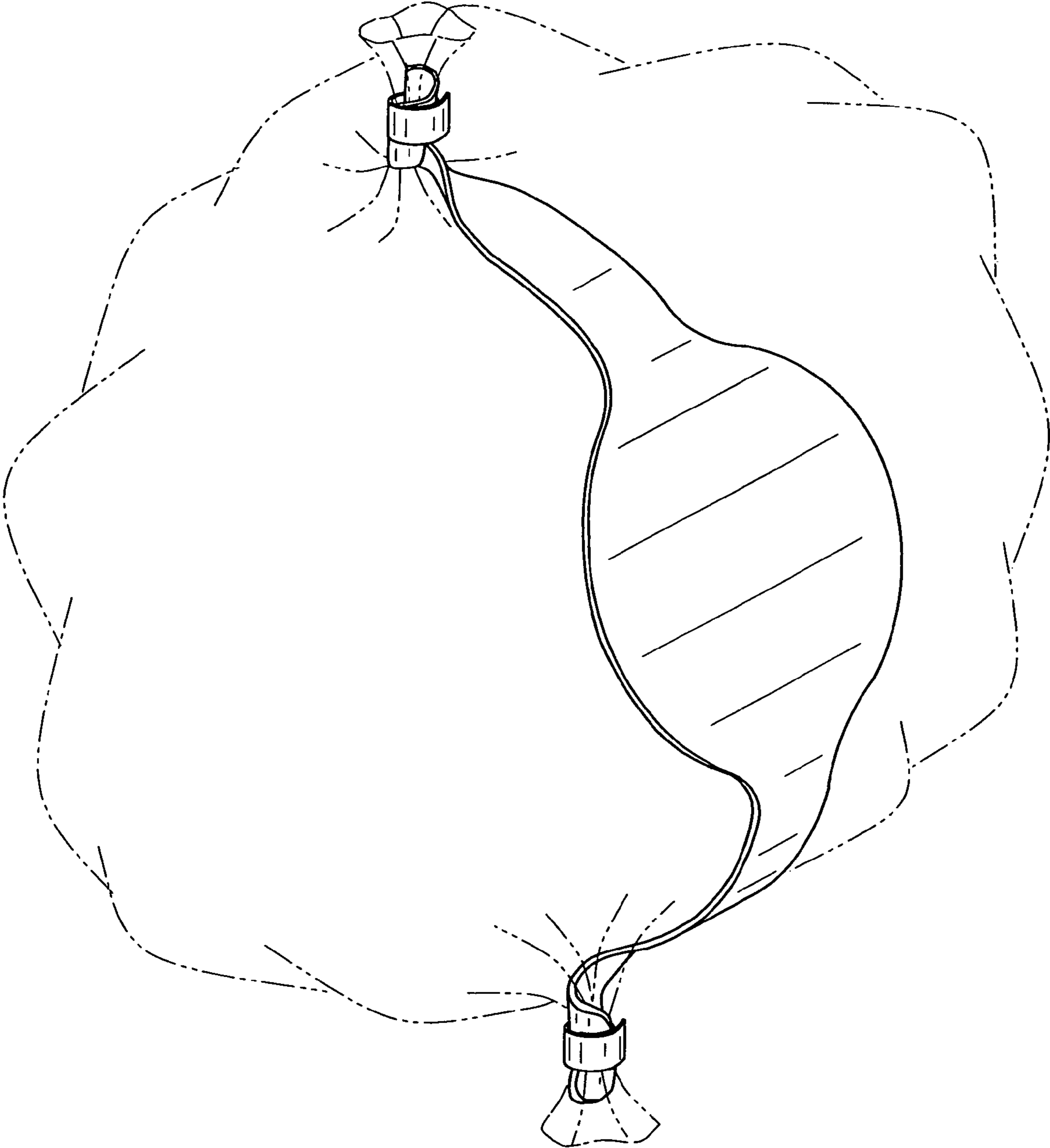

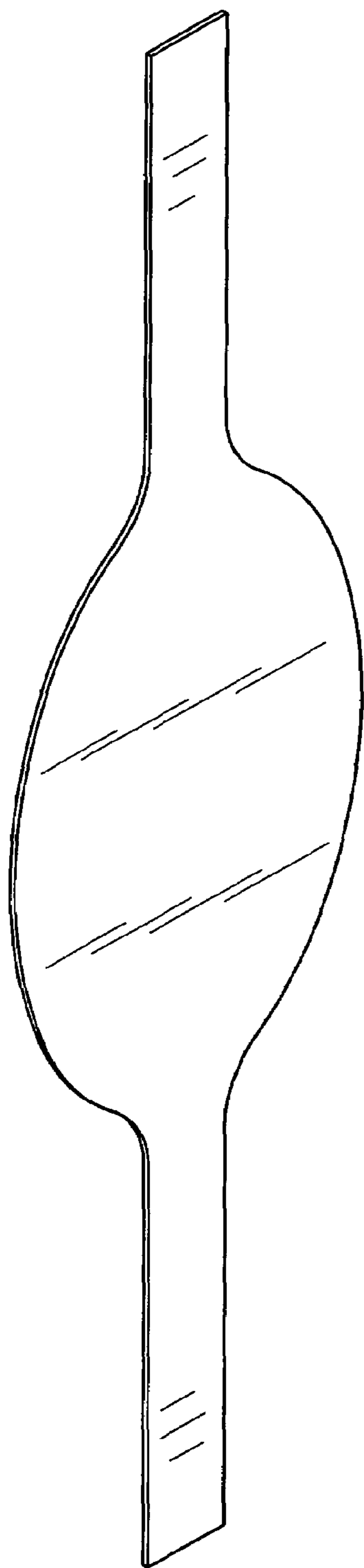

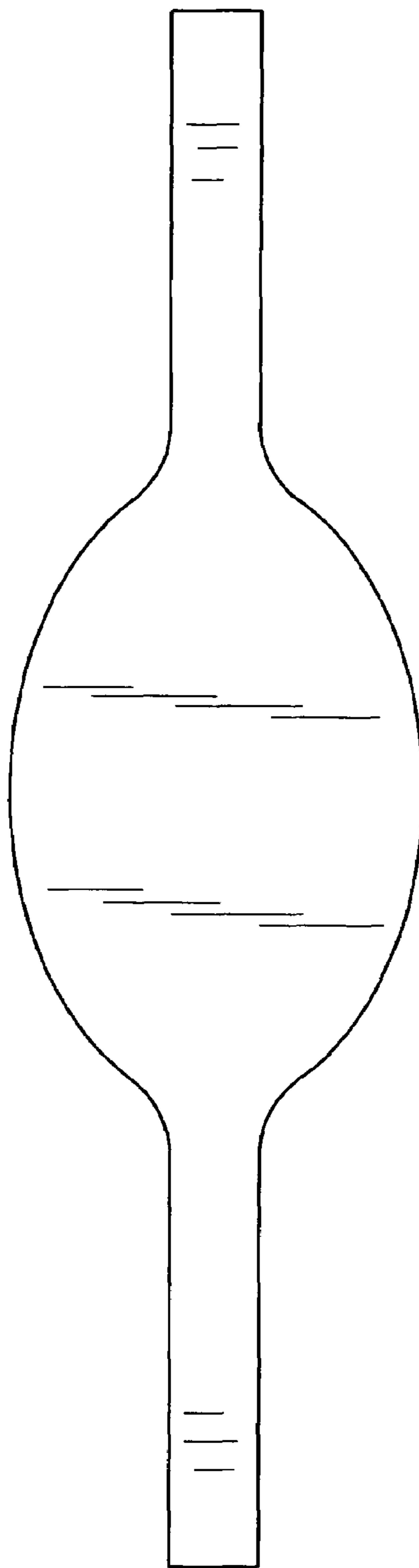

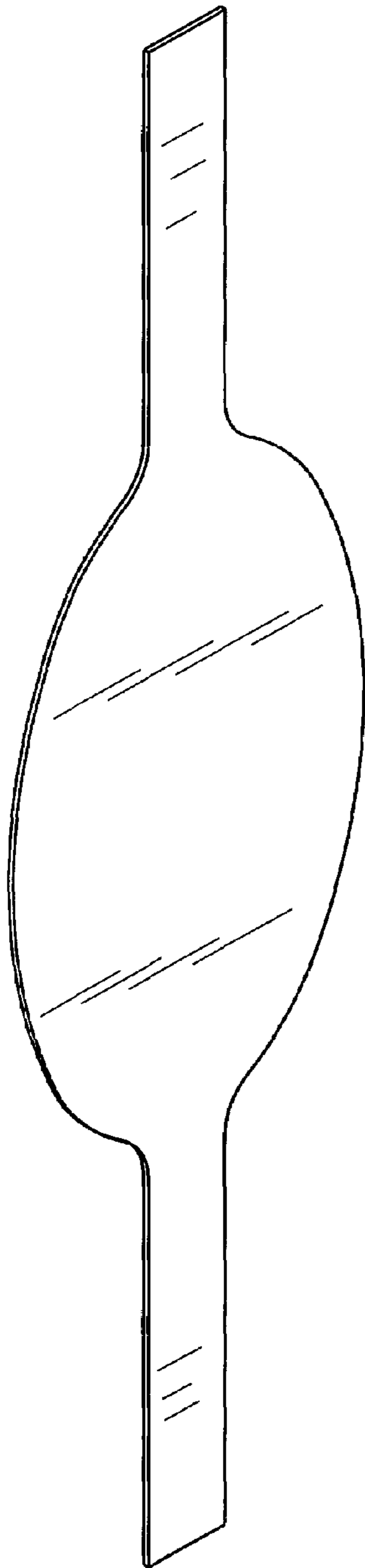

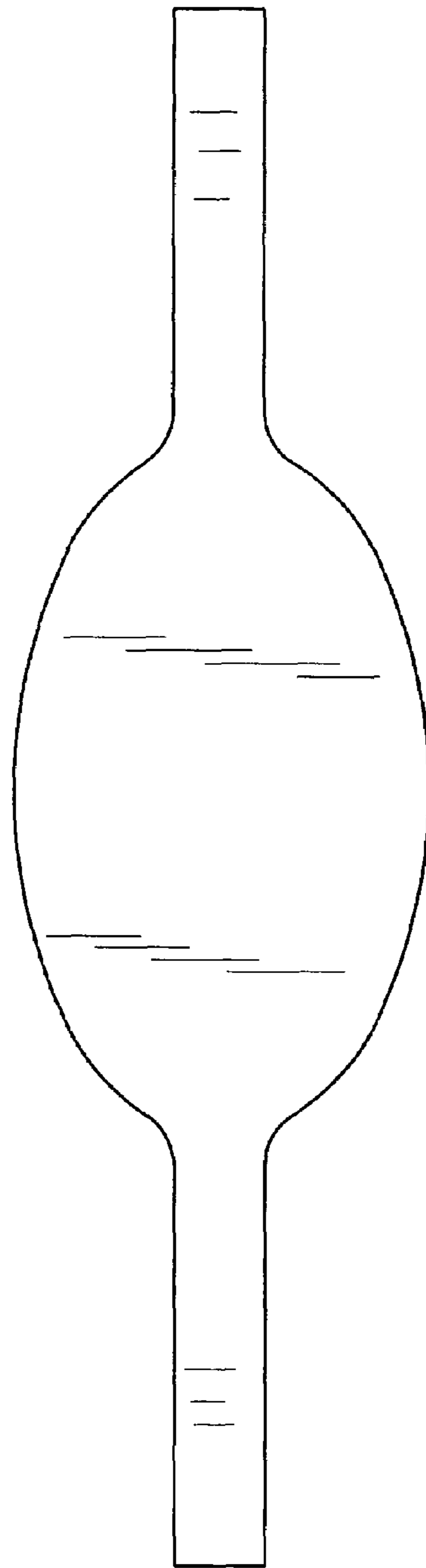
