The ornamental design for a display unit for game machine, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a display unit for a game machine showing our new design;

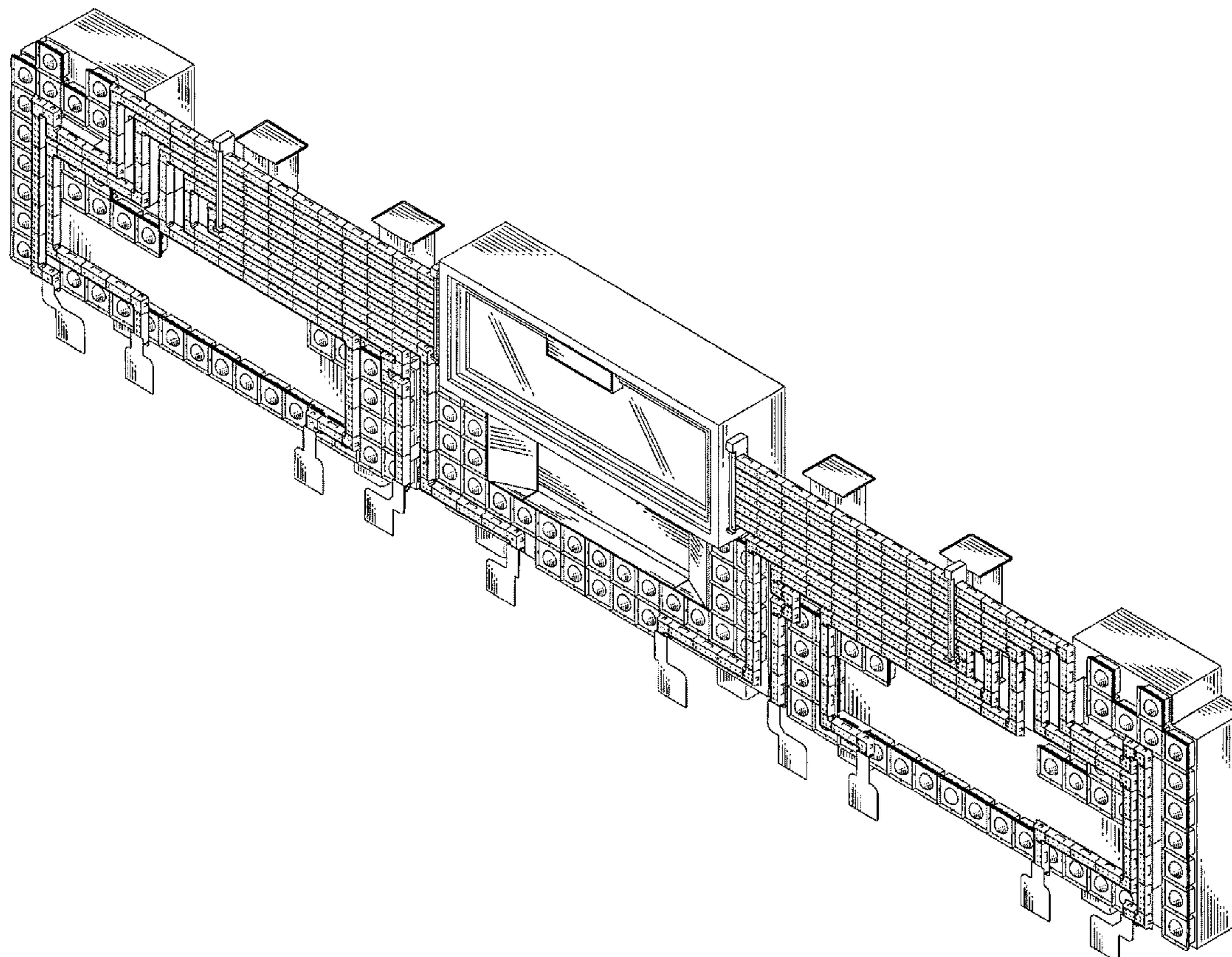

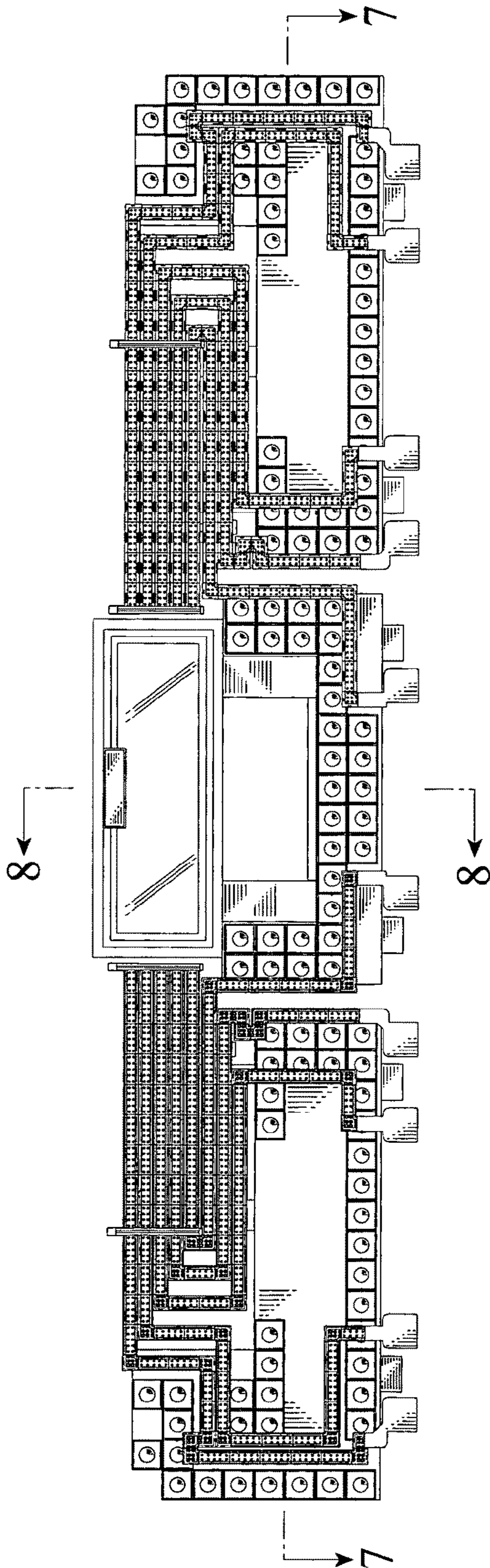
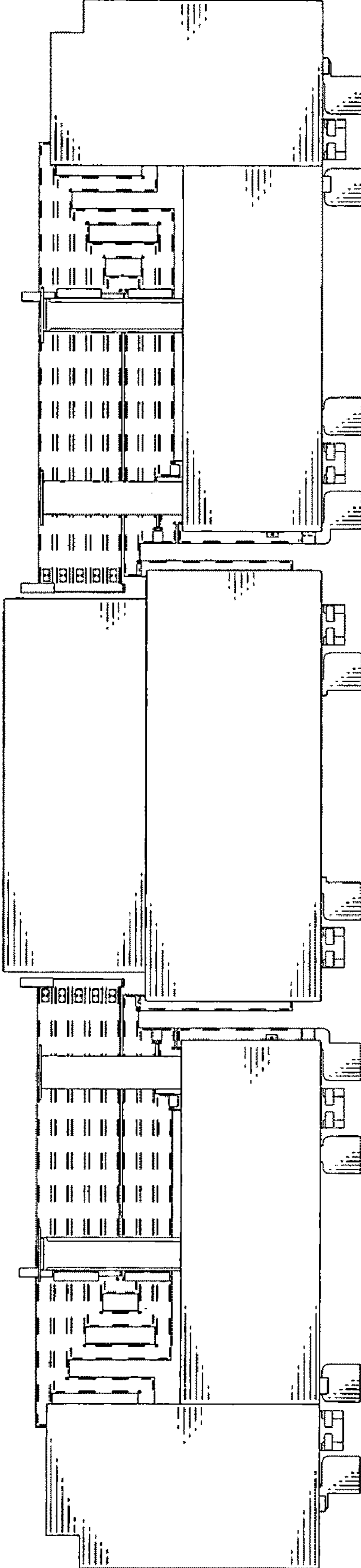
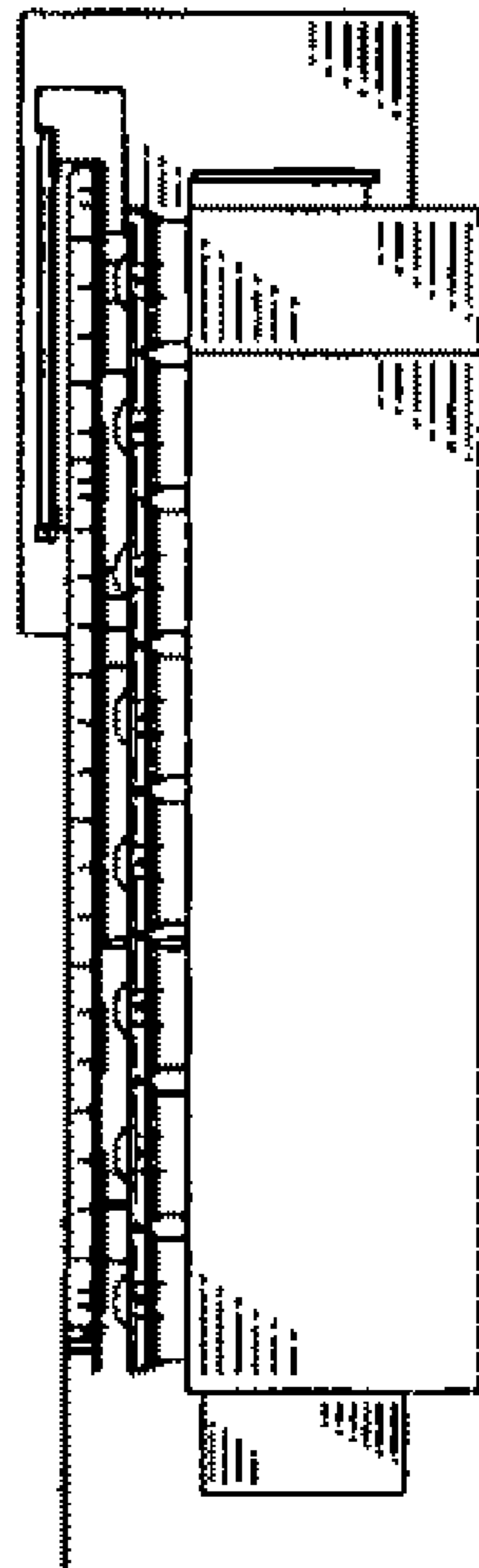

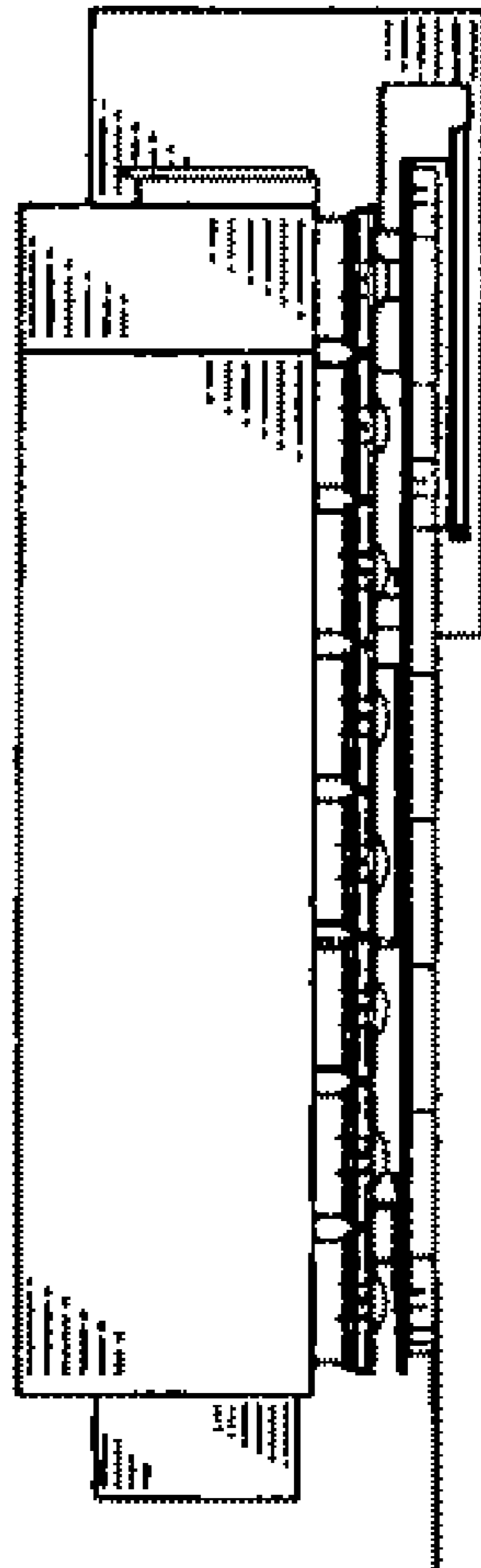

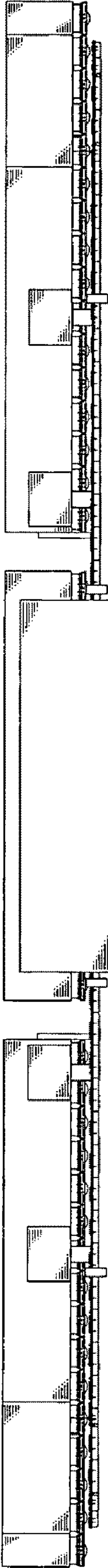

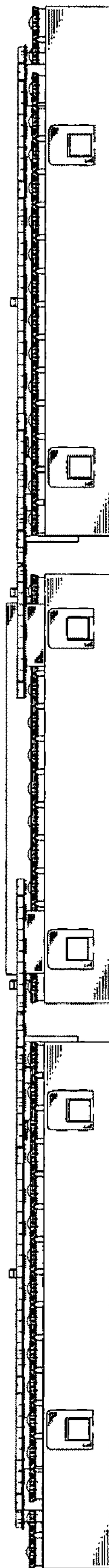
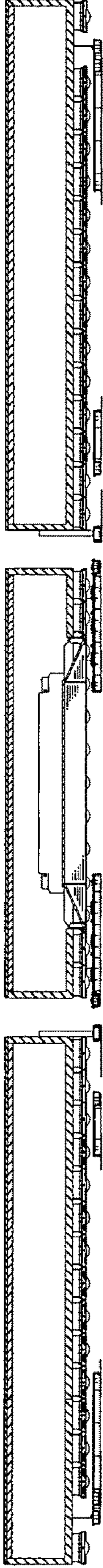

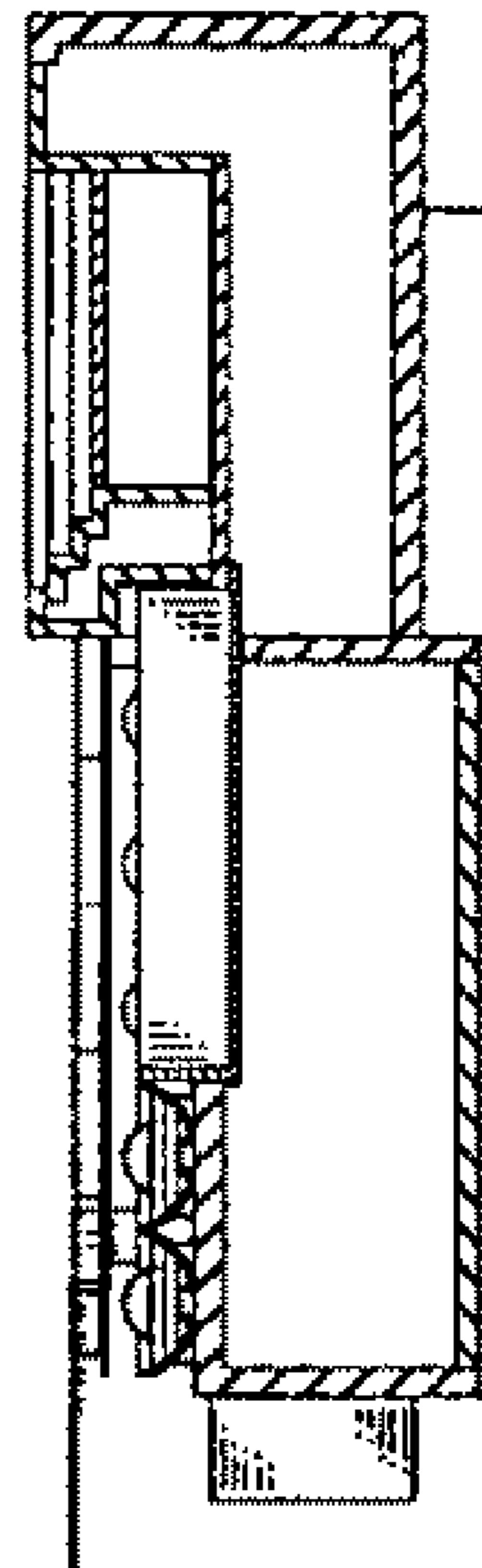
