FIG. 5 is a heel end perspective view thereof;

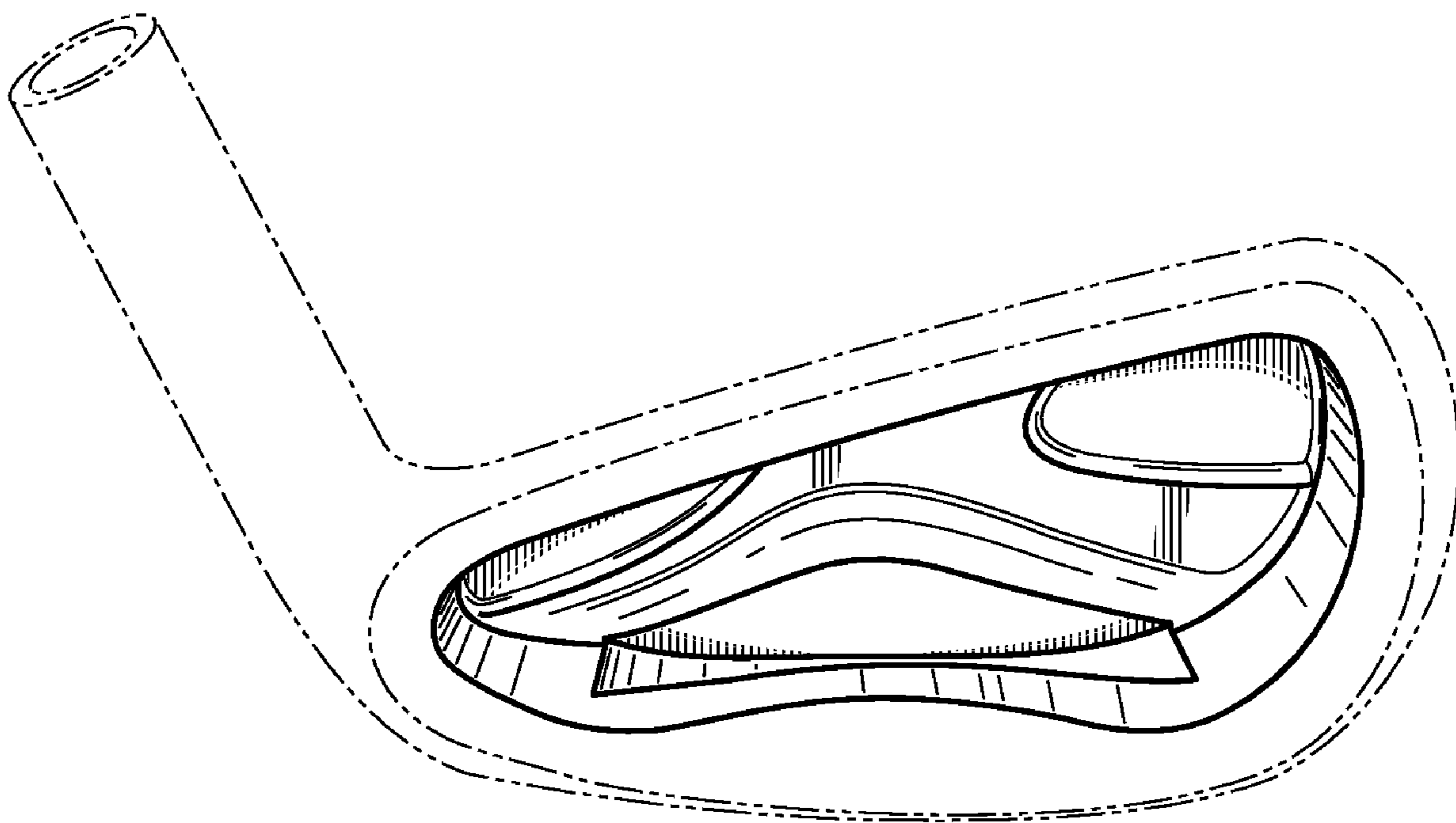
FIG. 6 is a toe end perspective view;

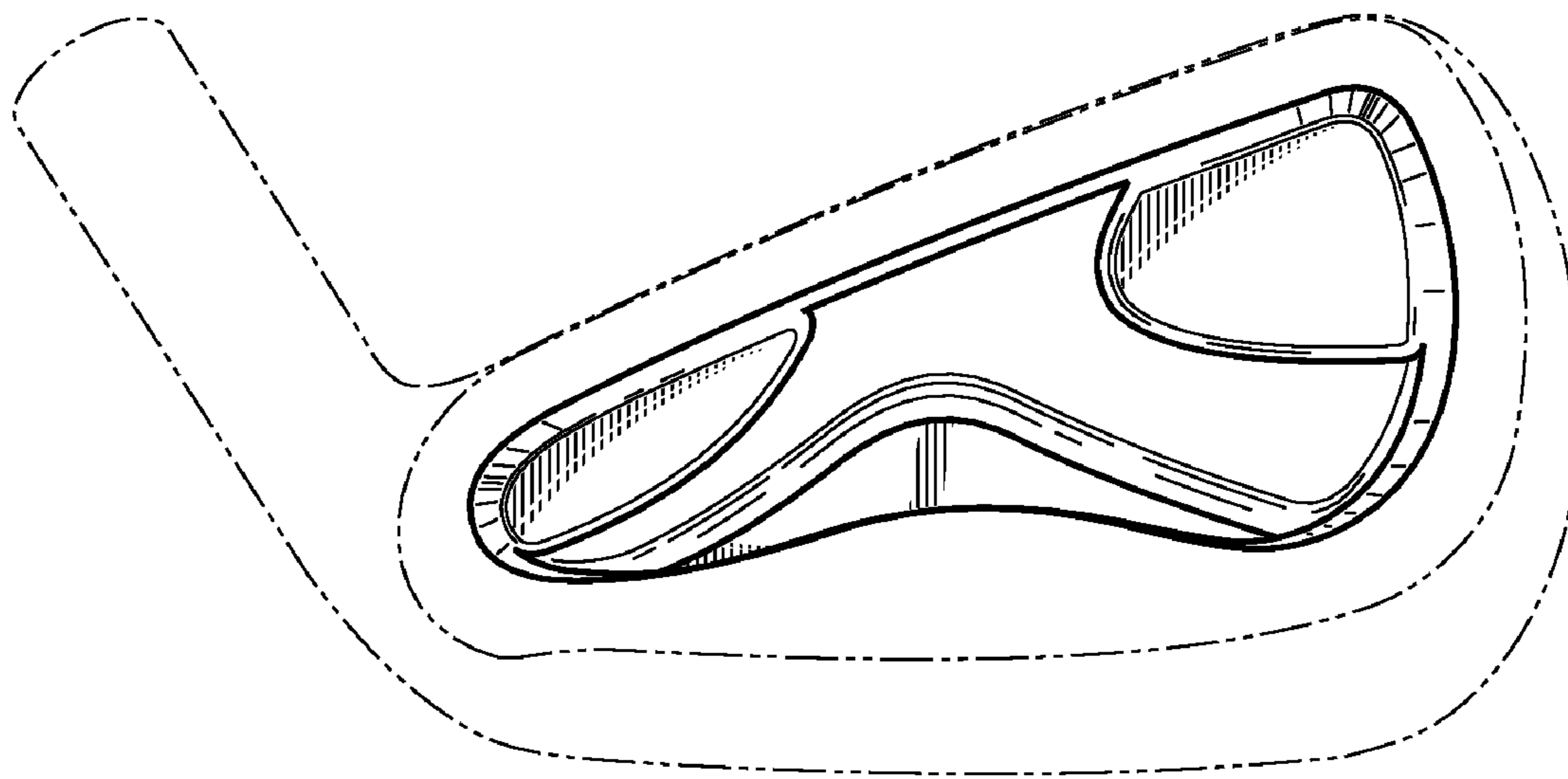
FIG. 7 is an inverted perspective view; and,

FIG. 8 is a perspective view.

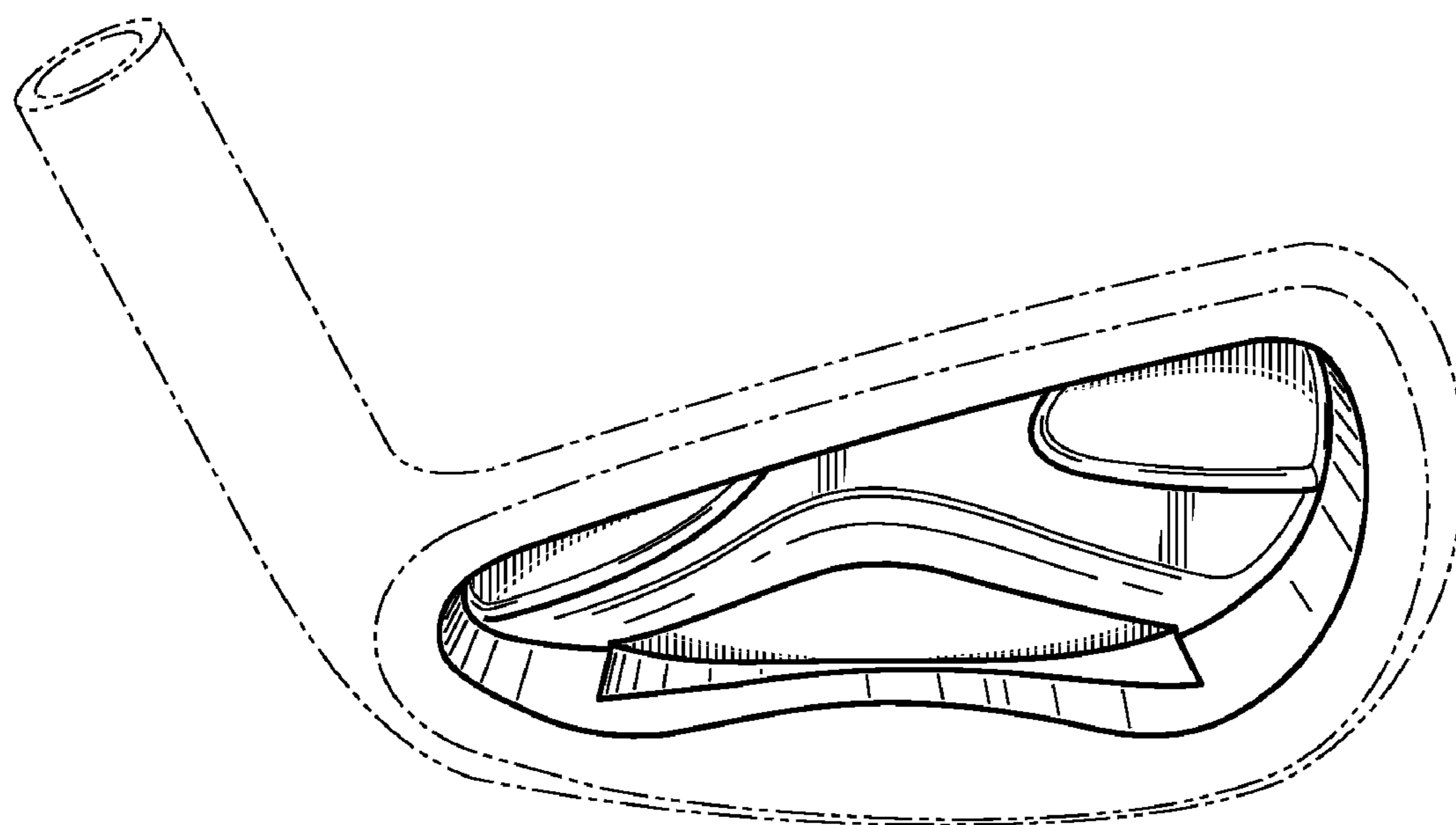

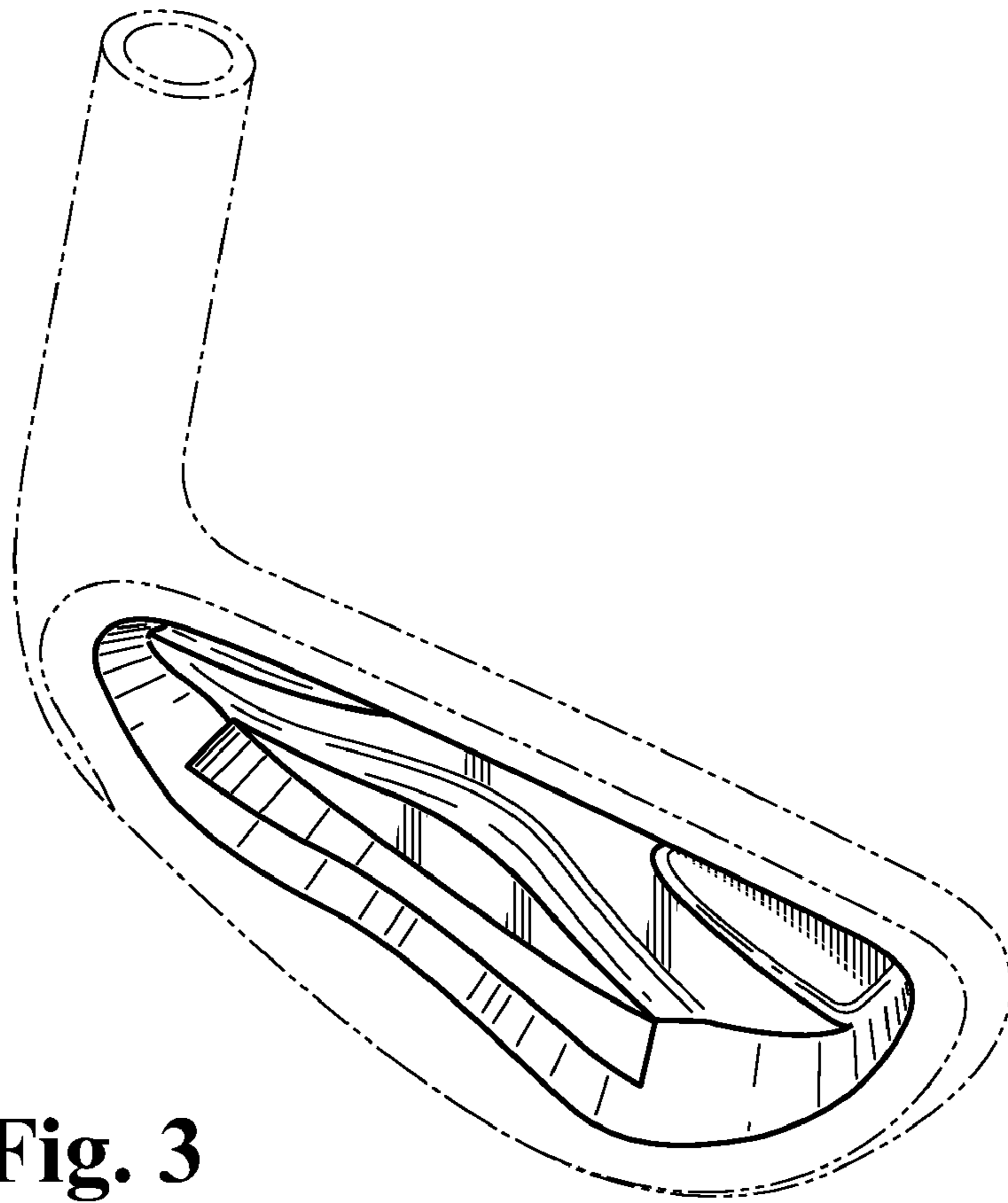




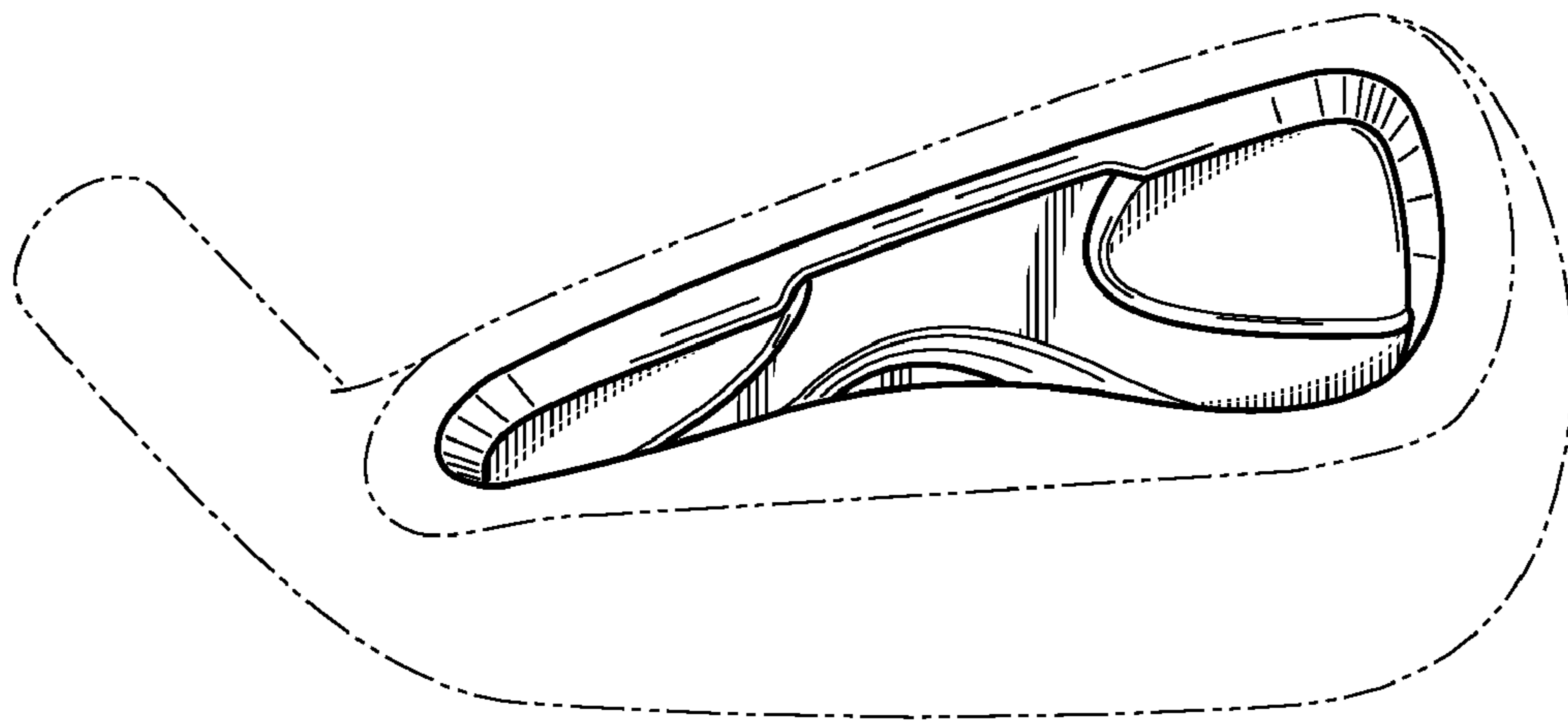

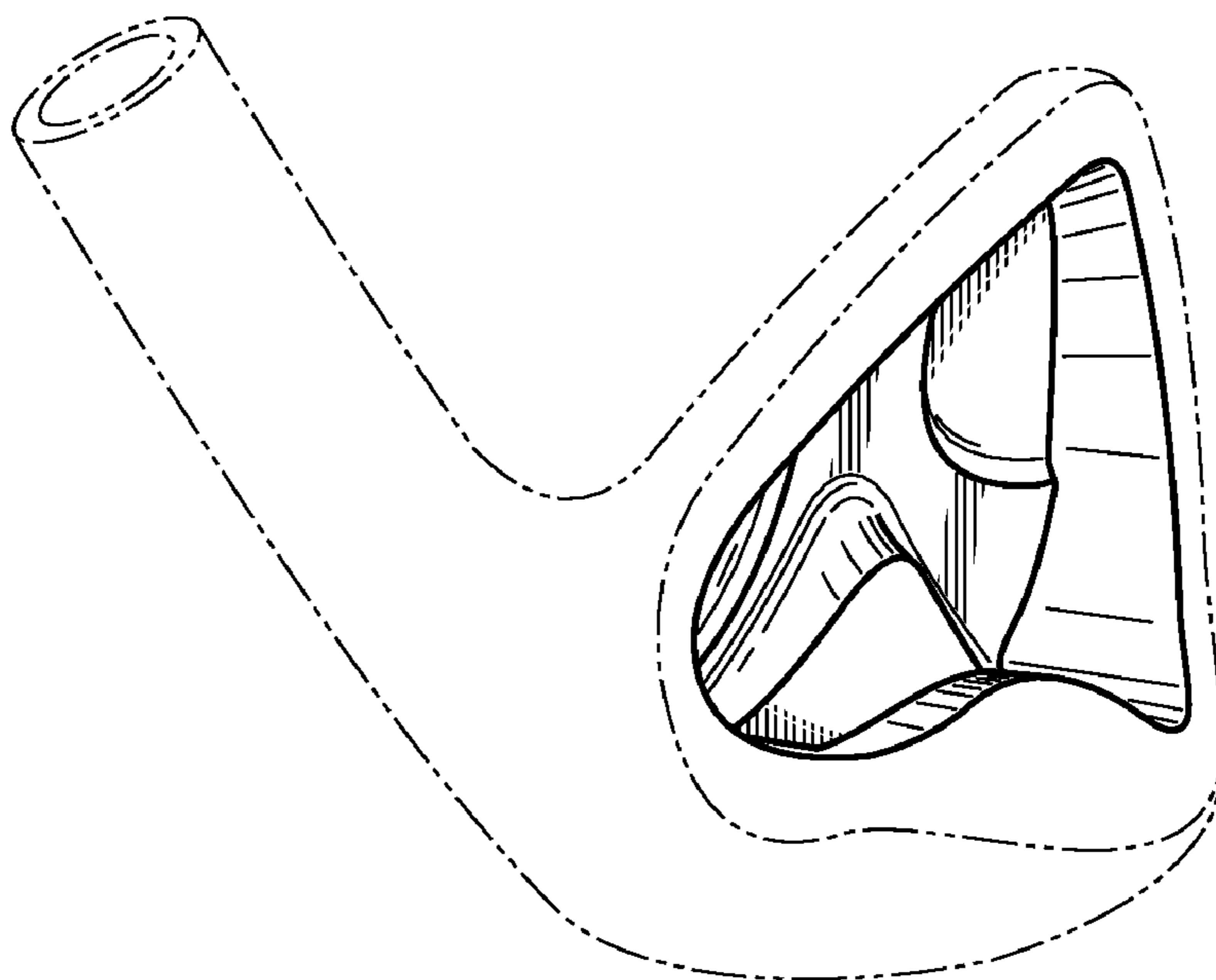

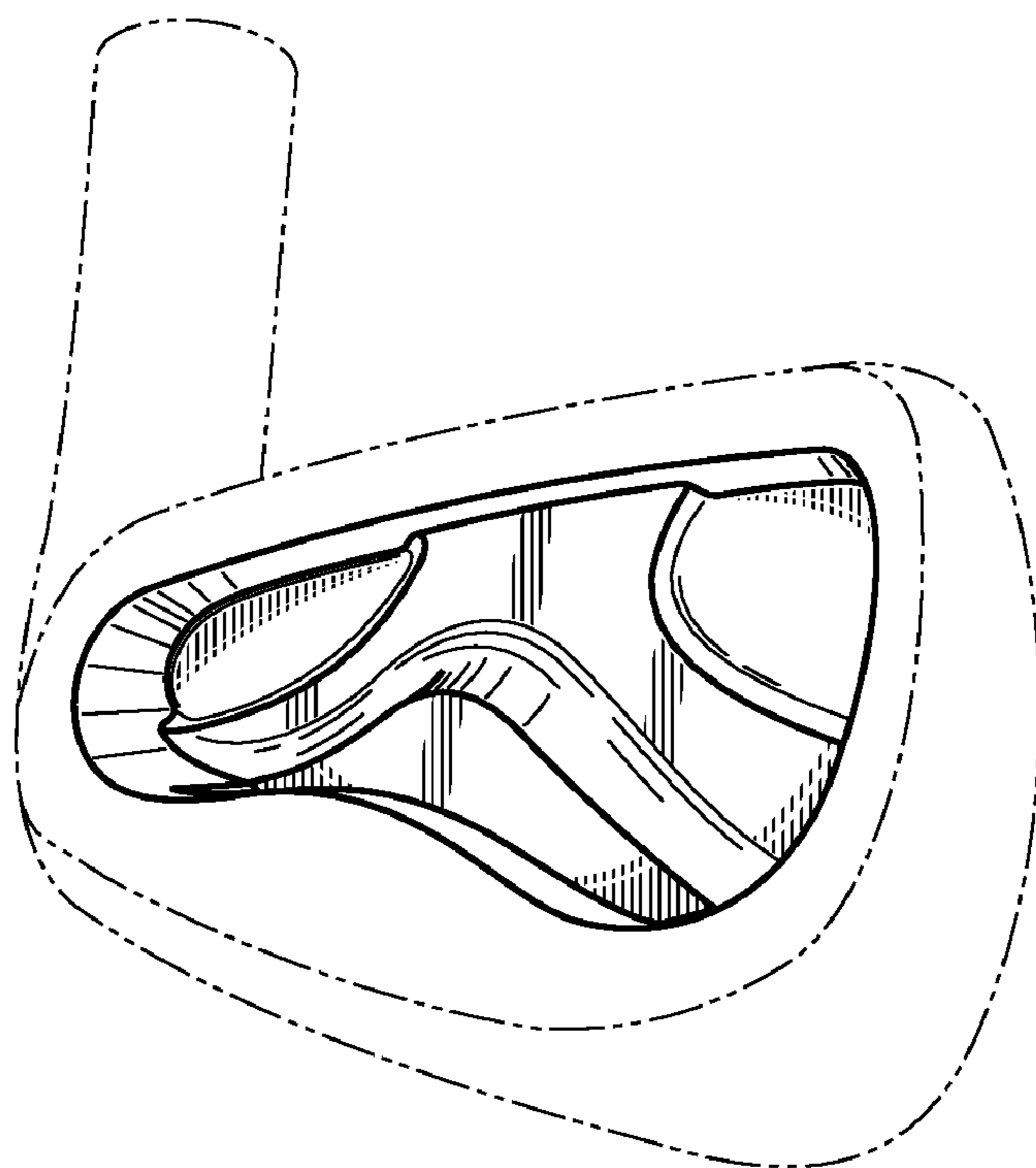

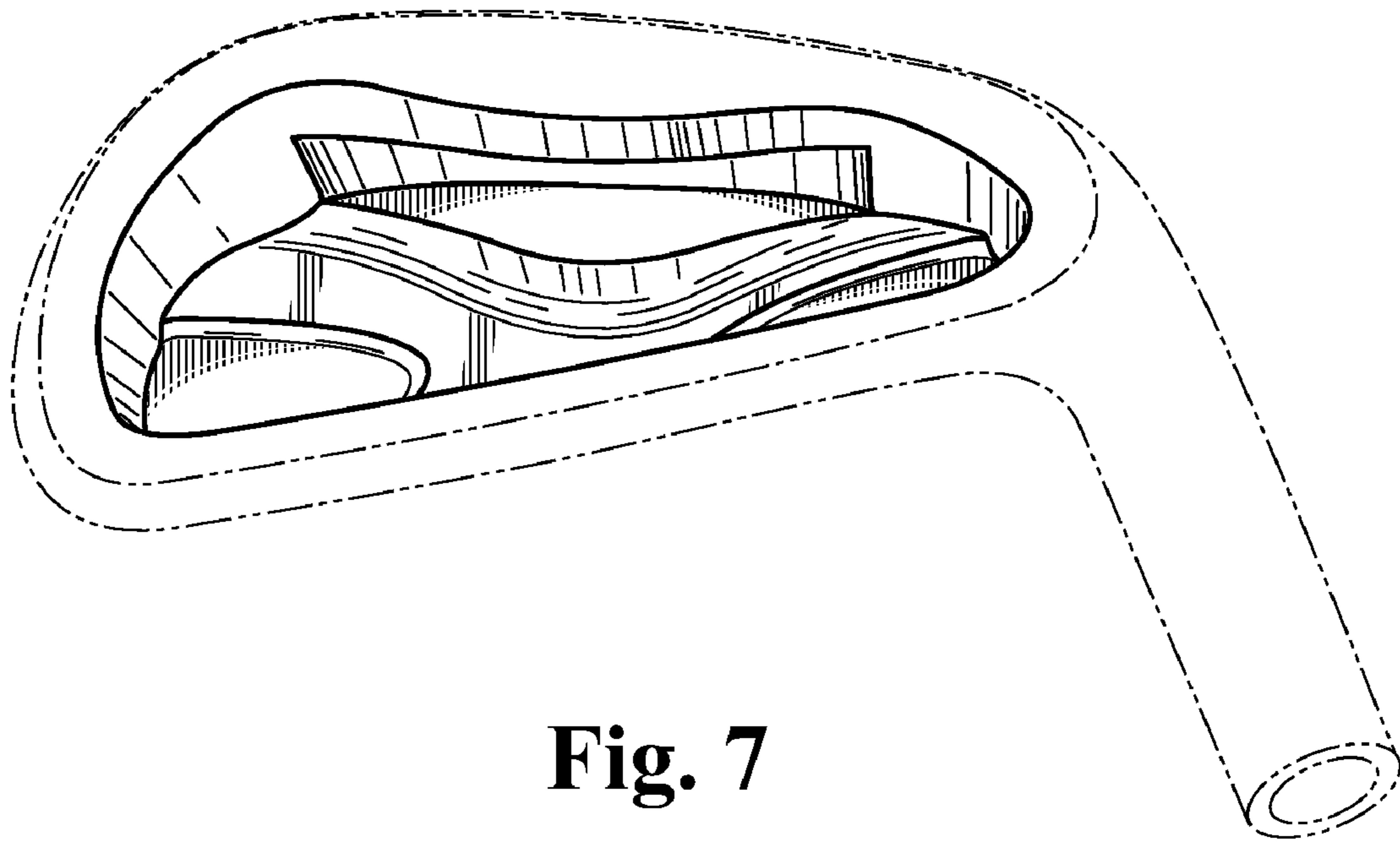

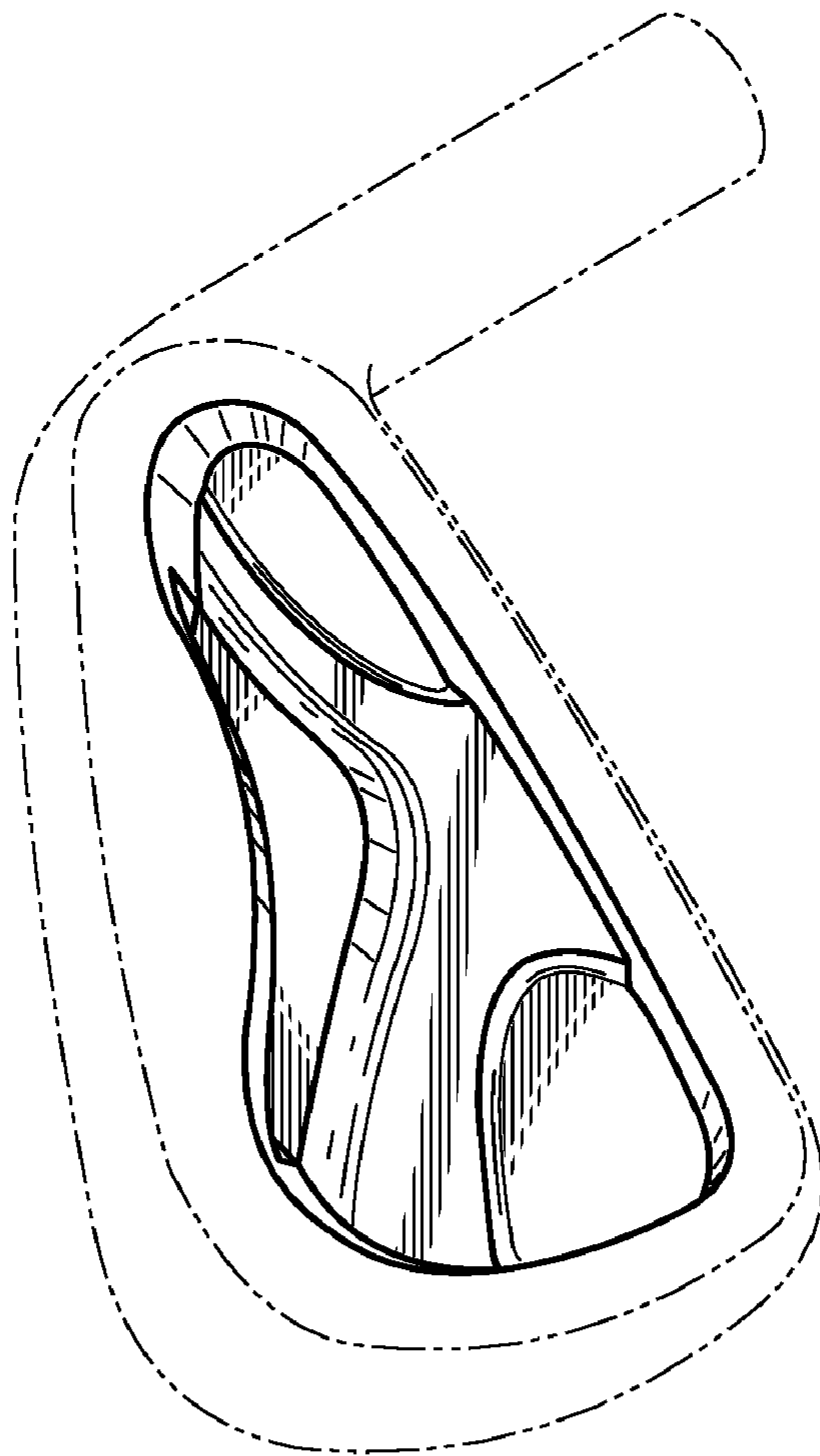
