**DESCRIPTION**

FIG. 5 is a bottom plan view thereof;

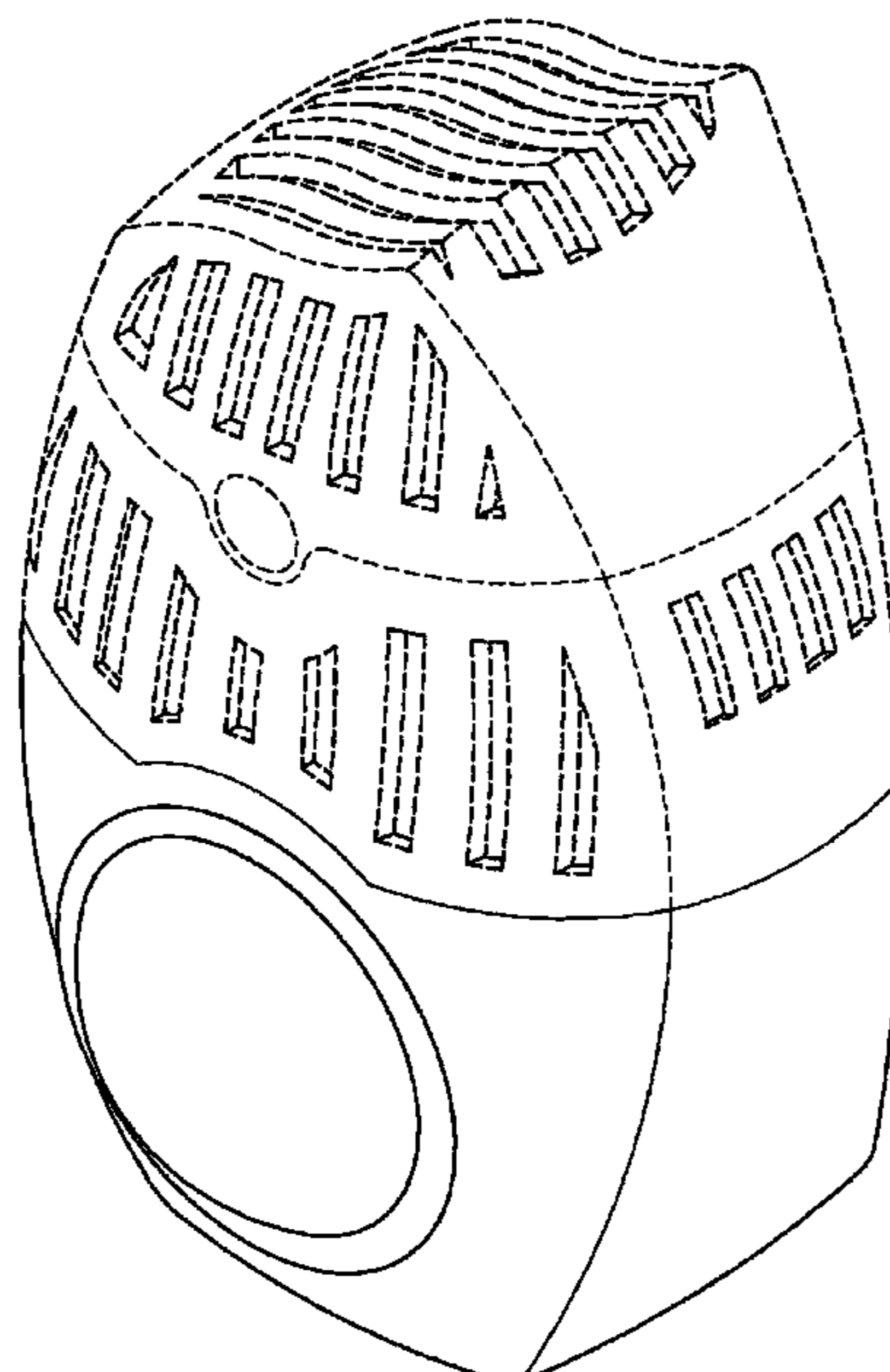
FIG. 6 is a cross sectional view of A—A of FIG. 4 thereof;

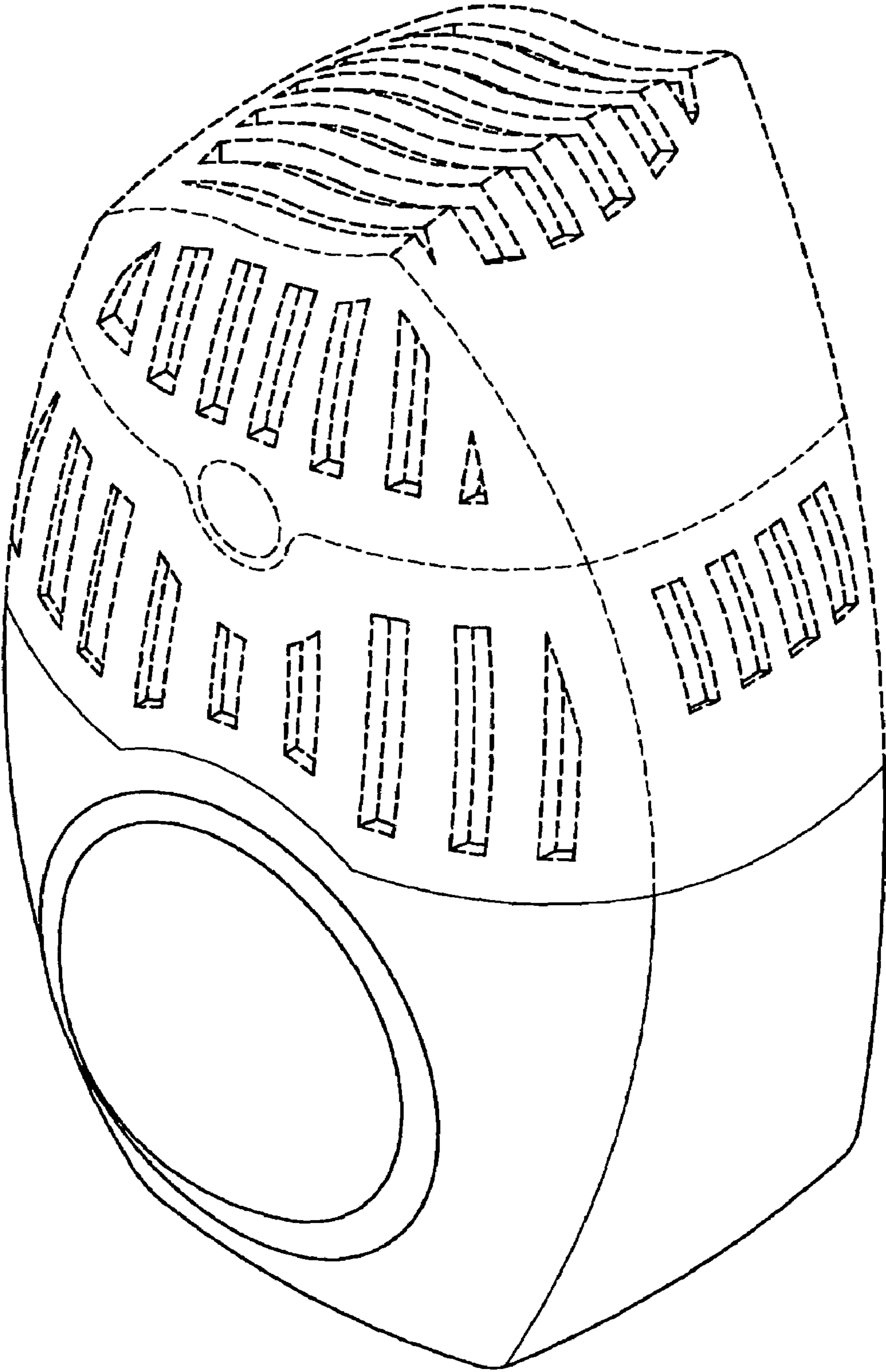
FIG. 7 is a front plan view thereof; and,

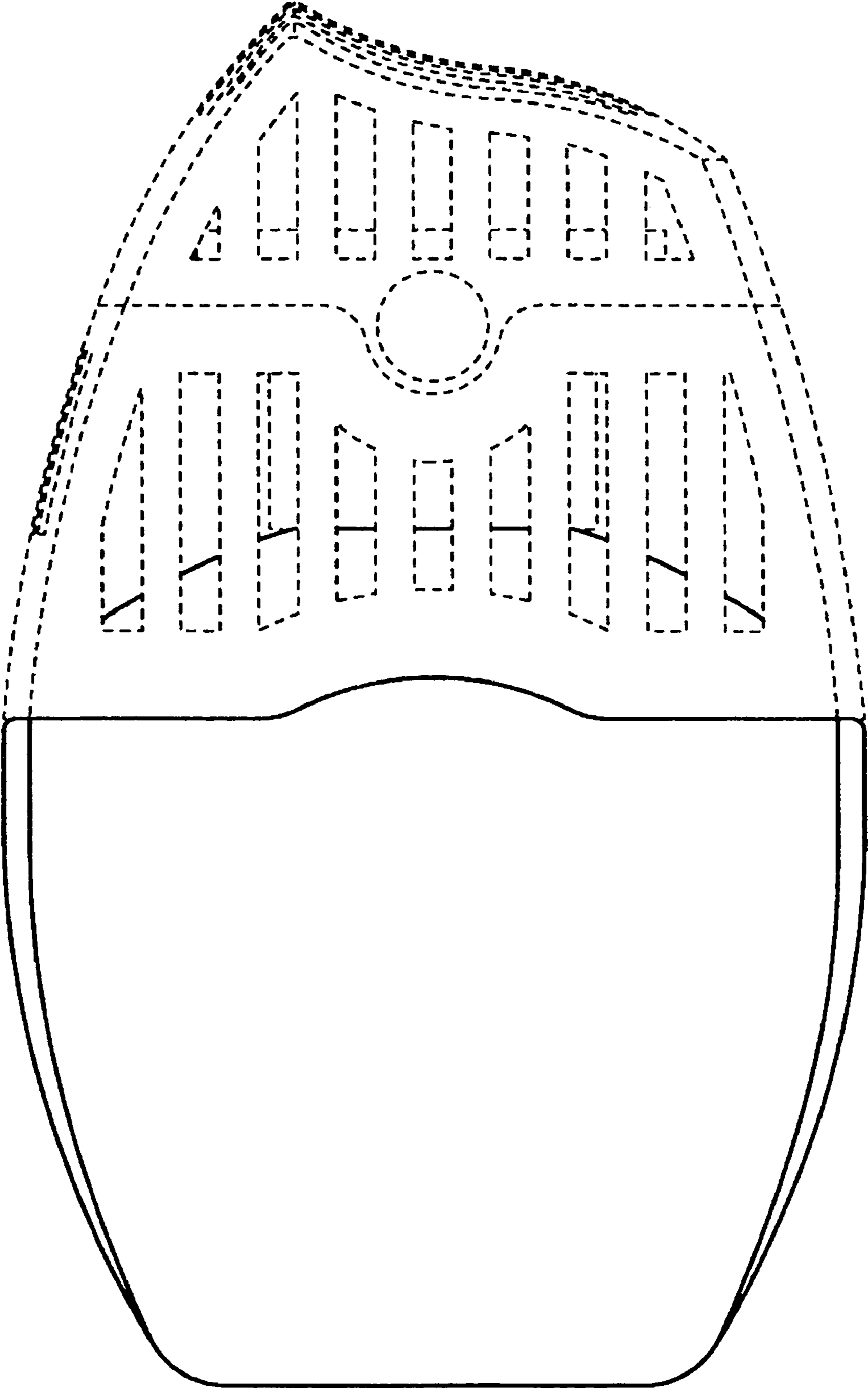

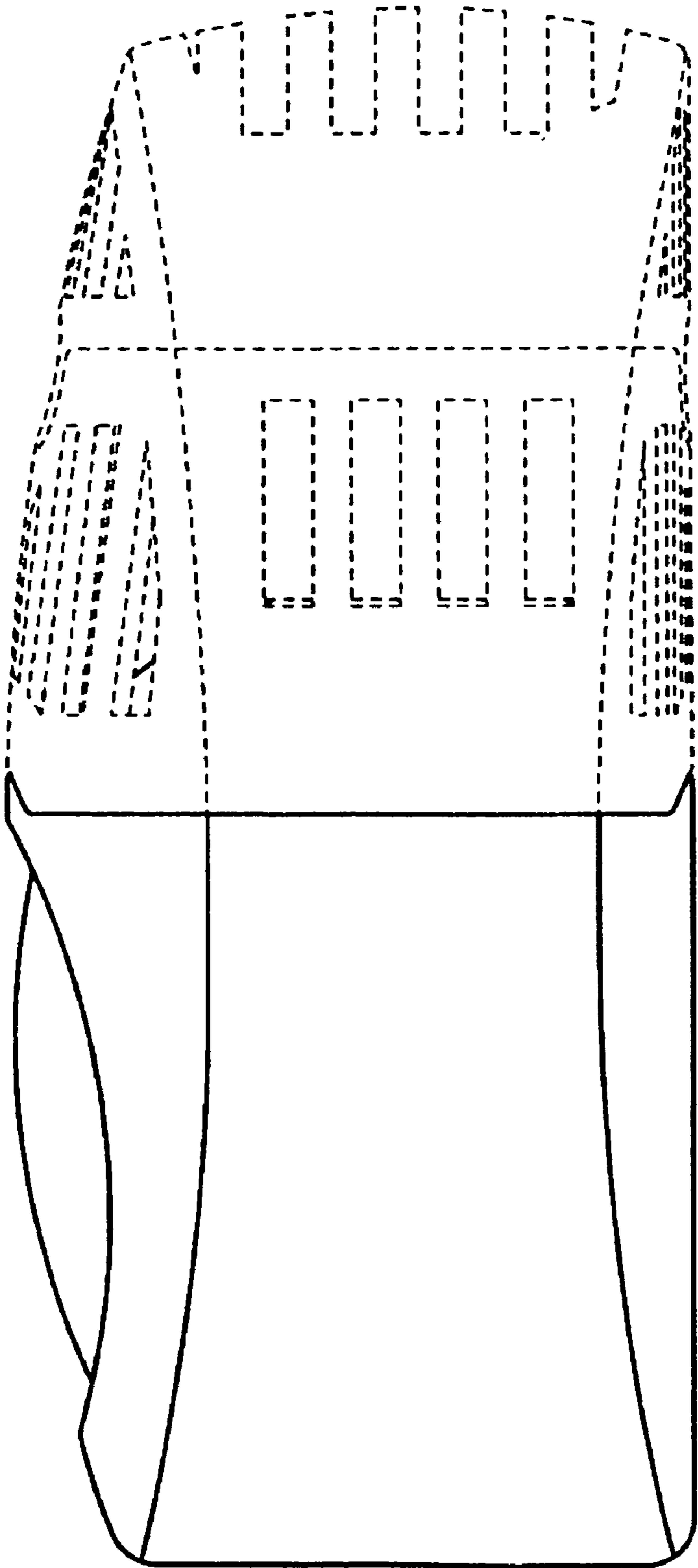

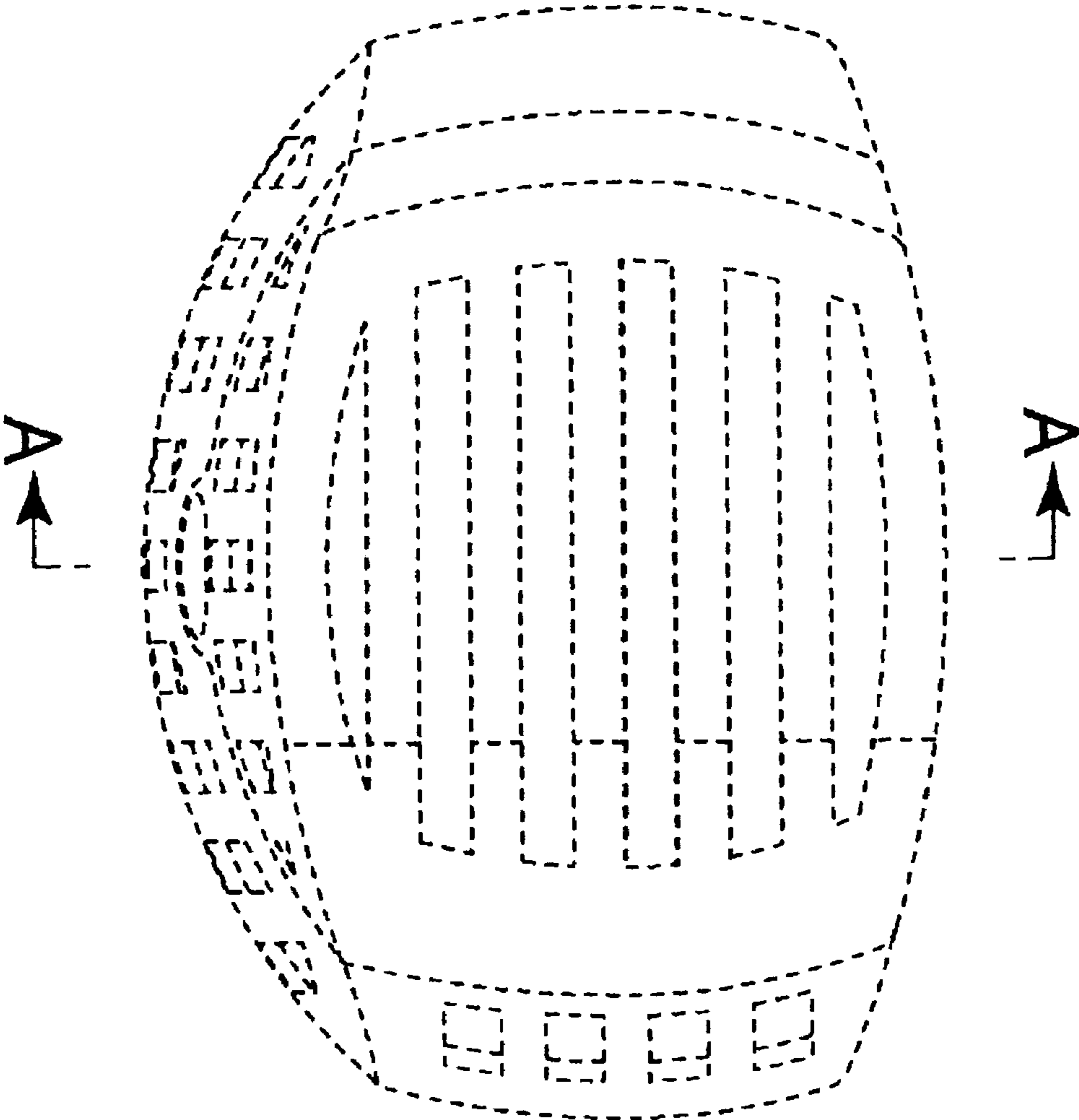
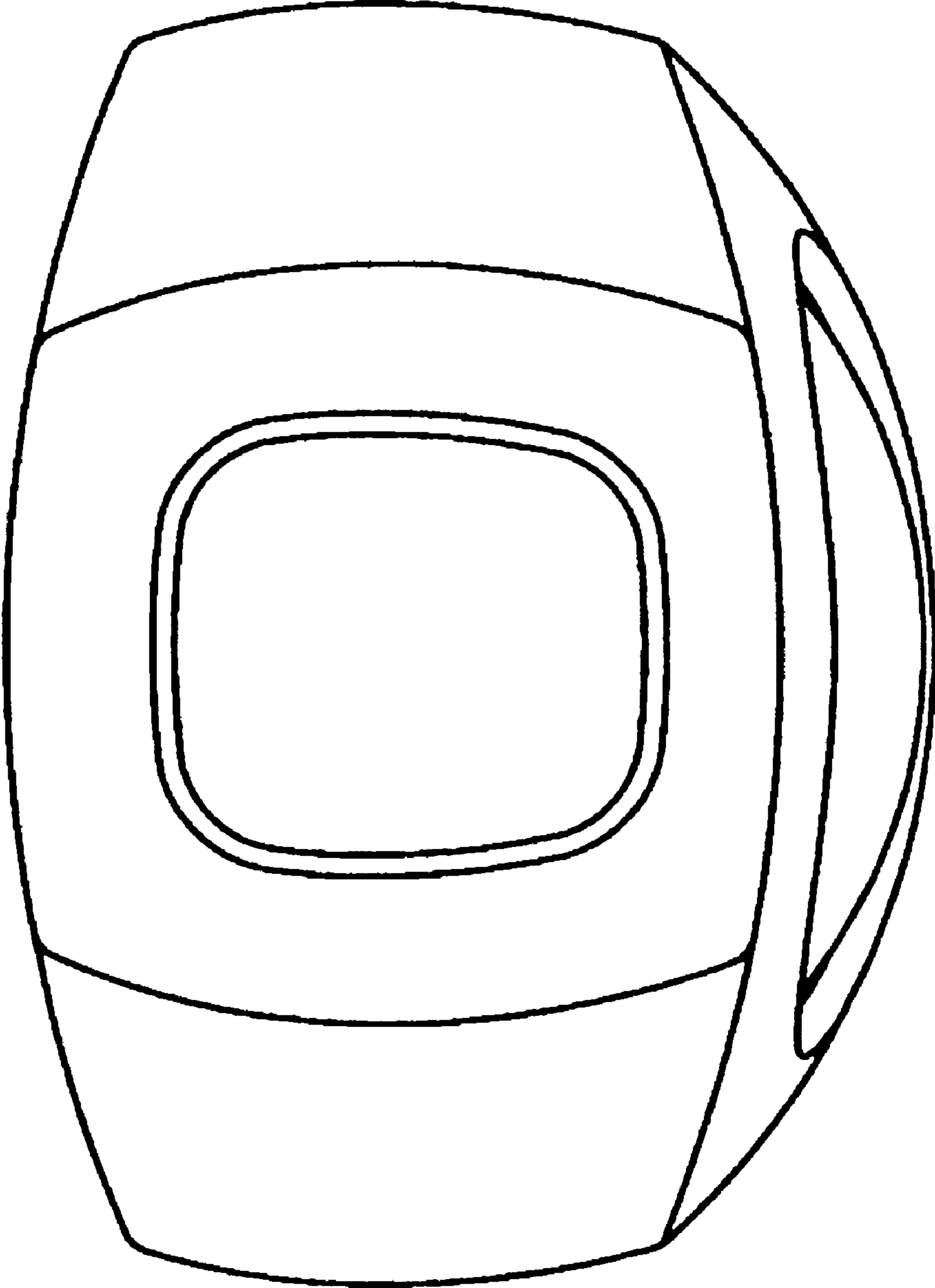

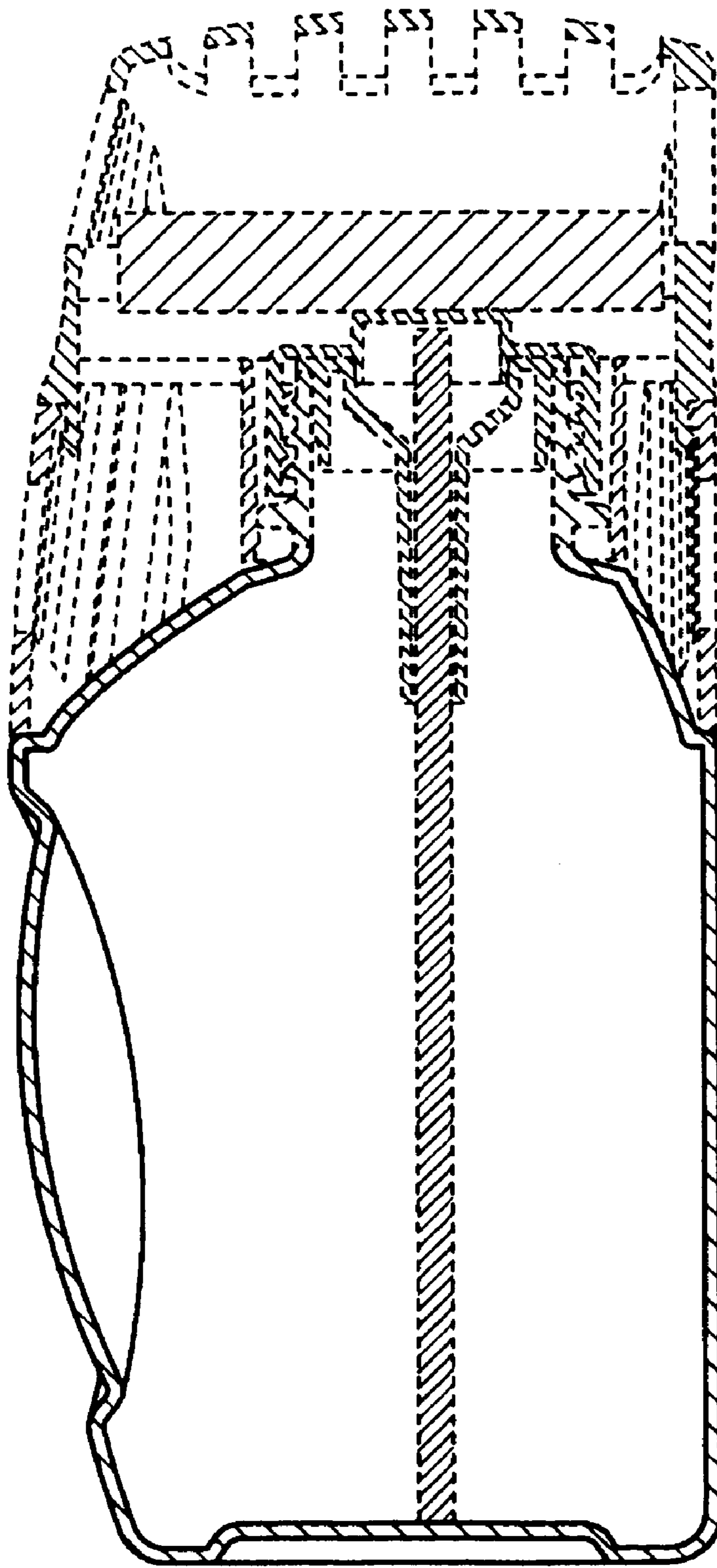

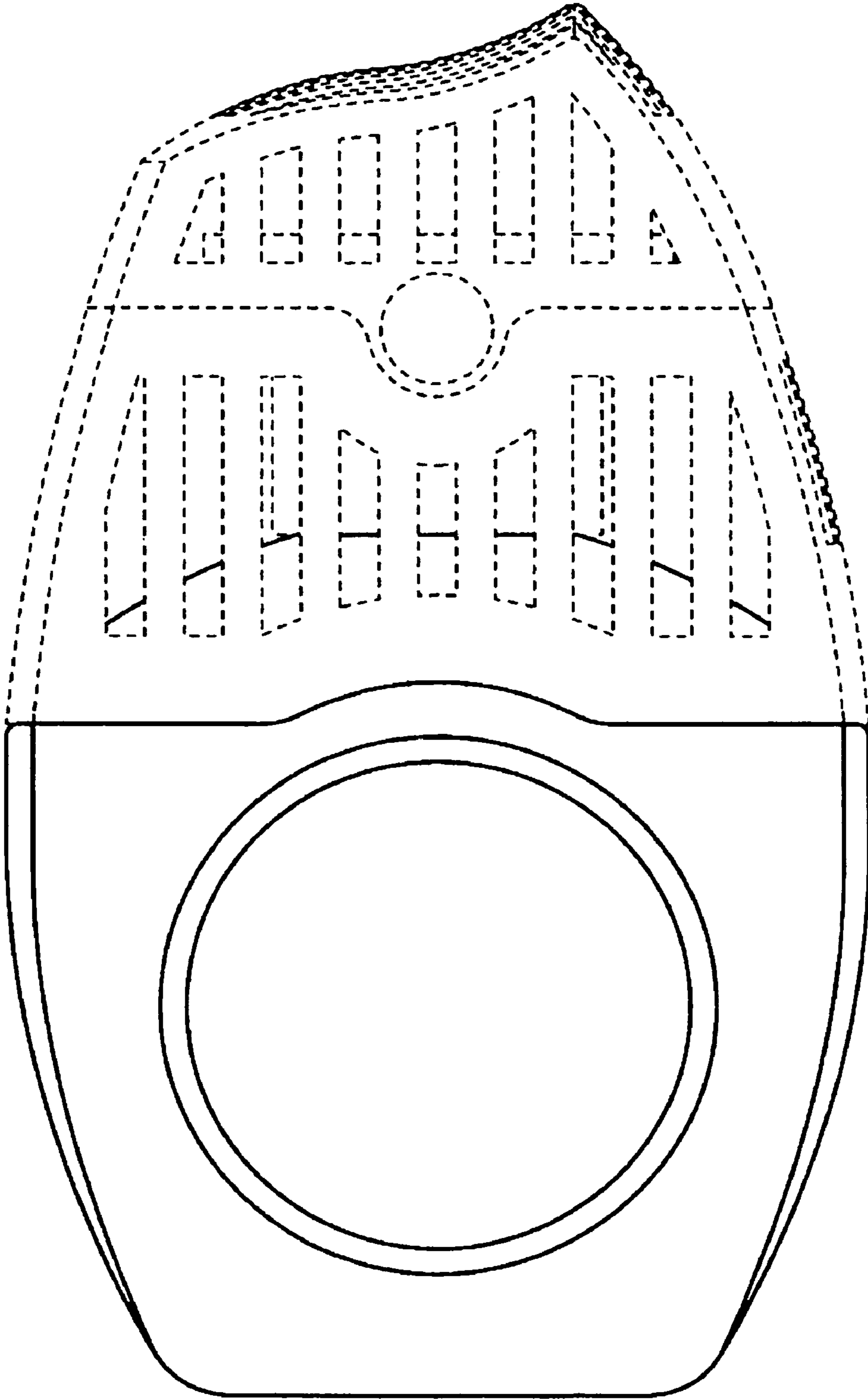

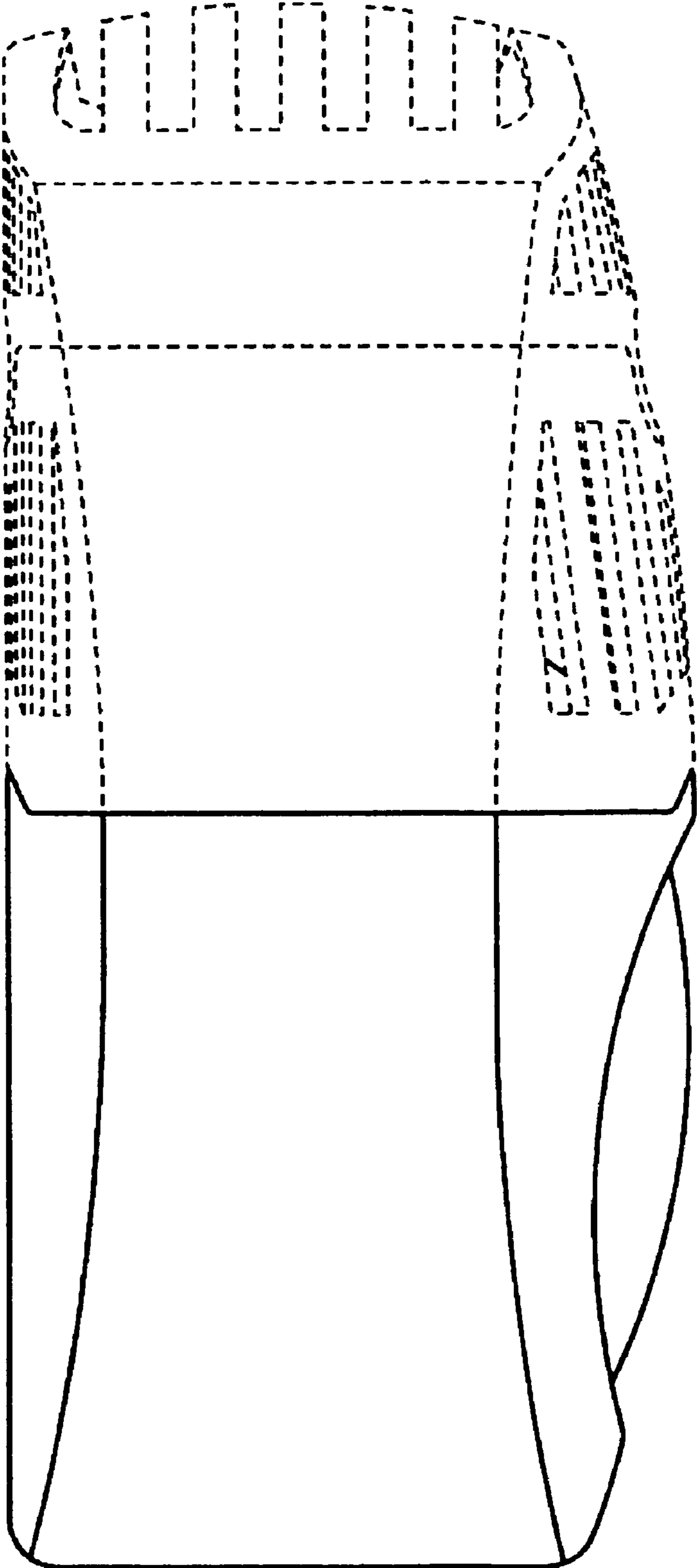
