FIG. 4 is a rear view of the appliance thereof;

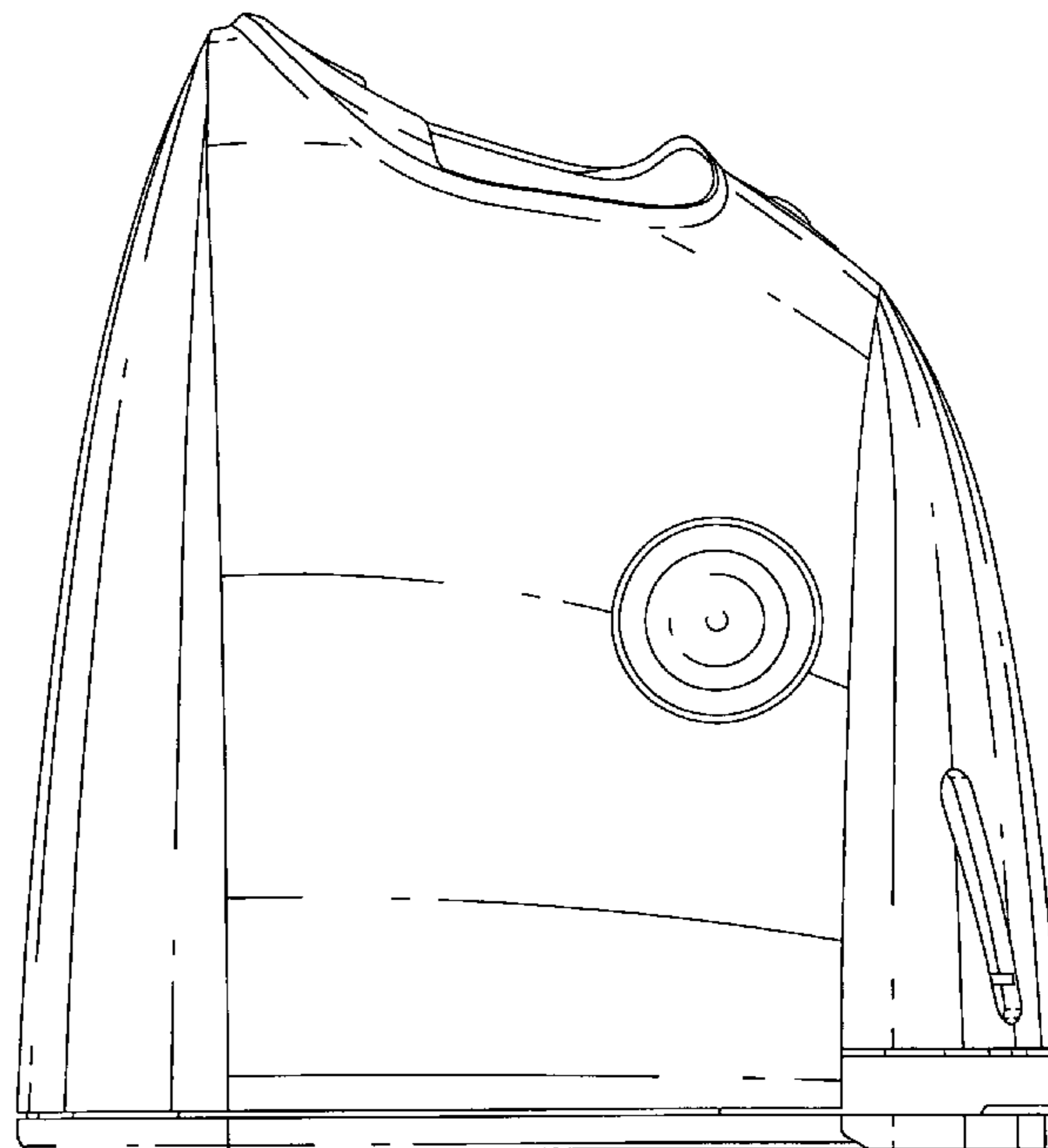
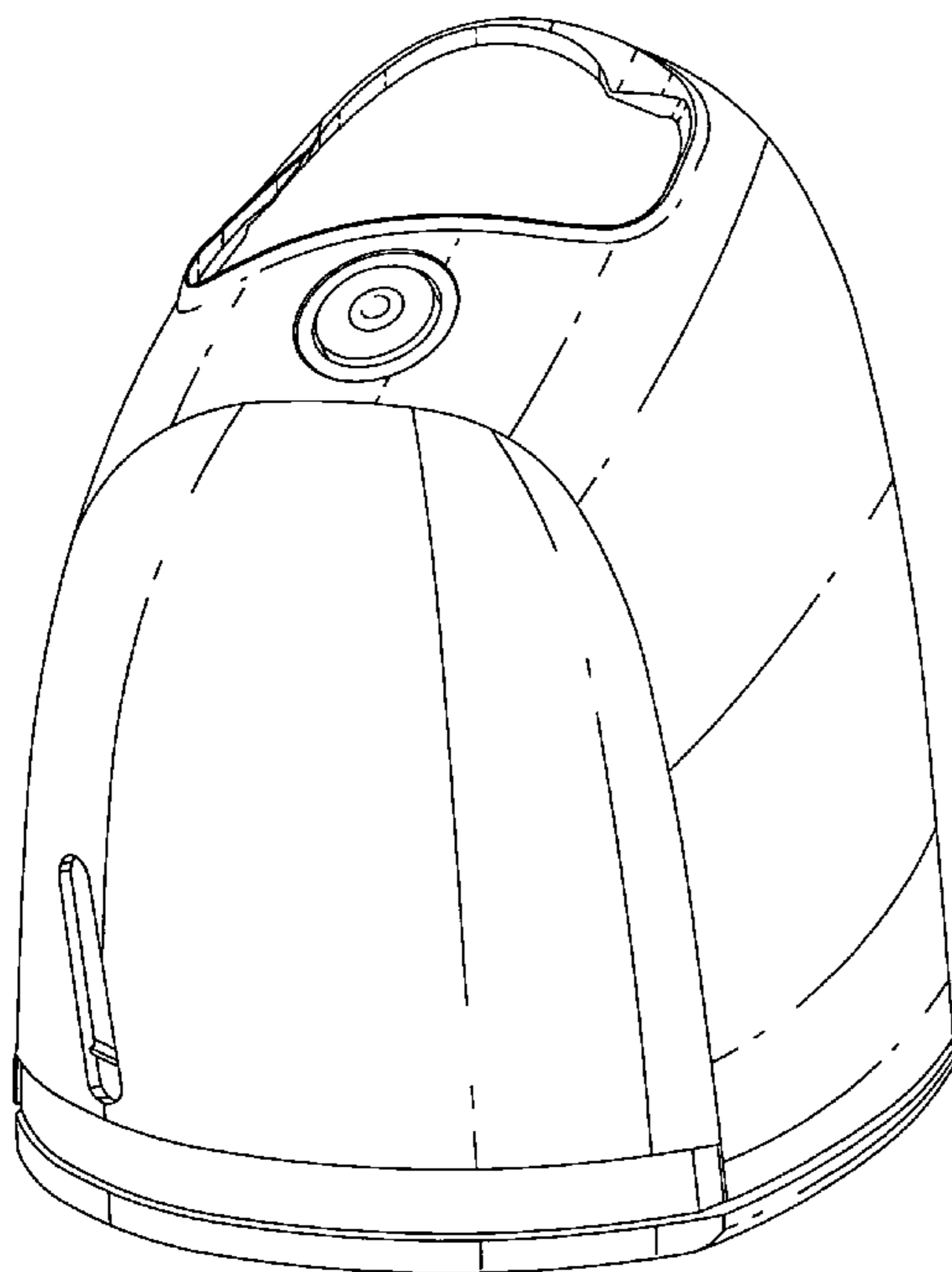
FIG. 5 is a side view of the appliance thereof;

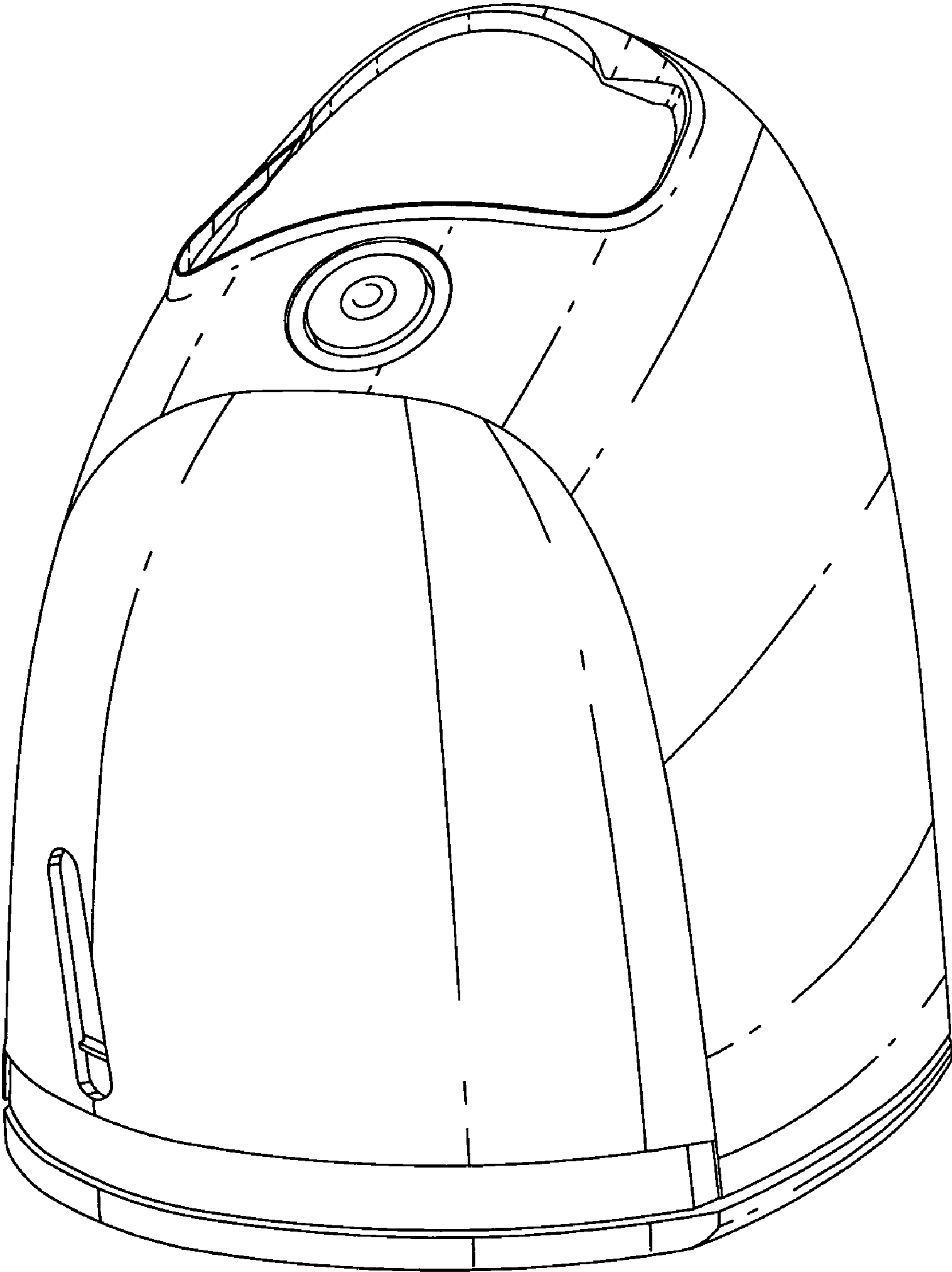

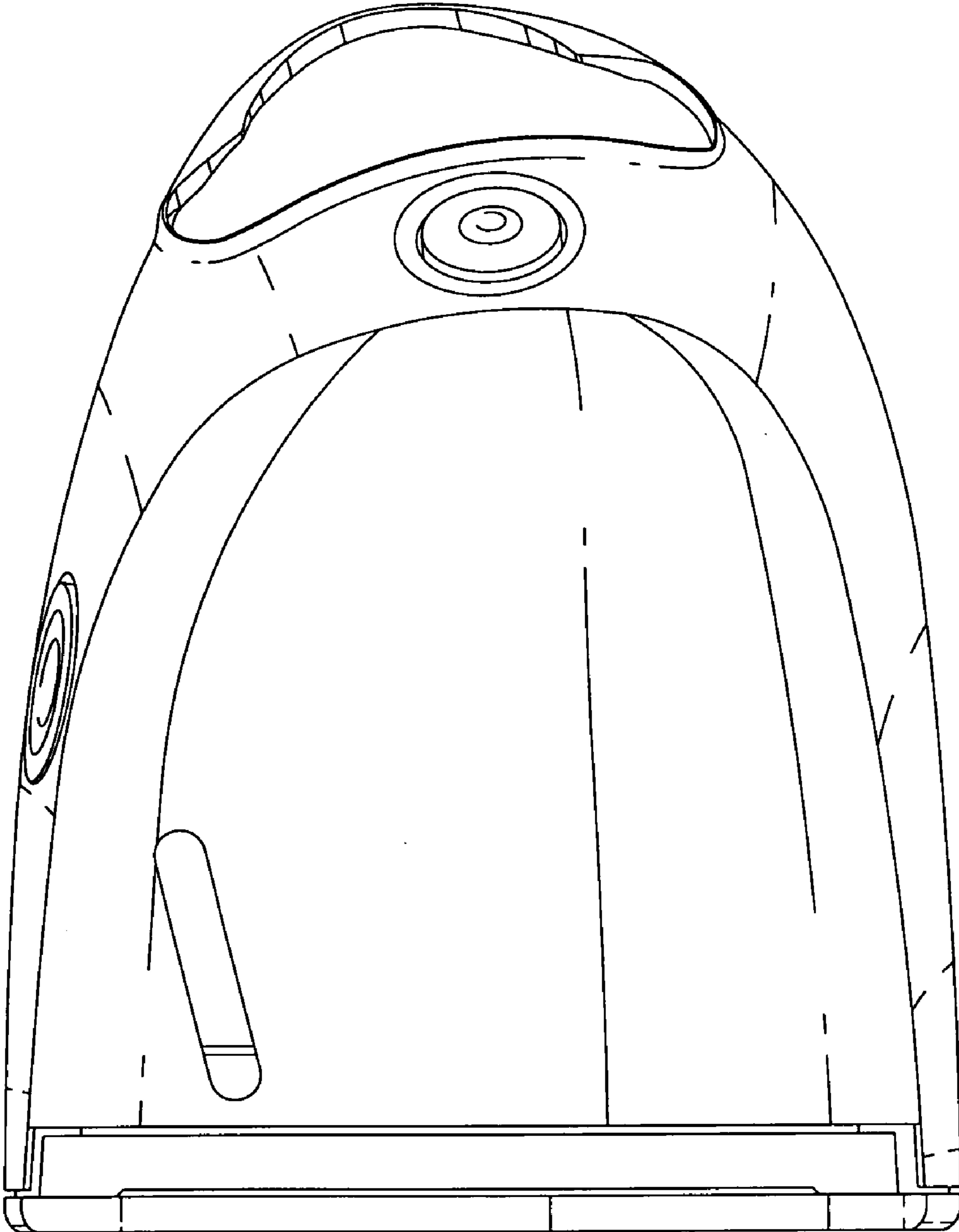

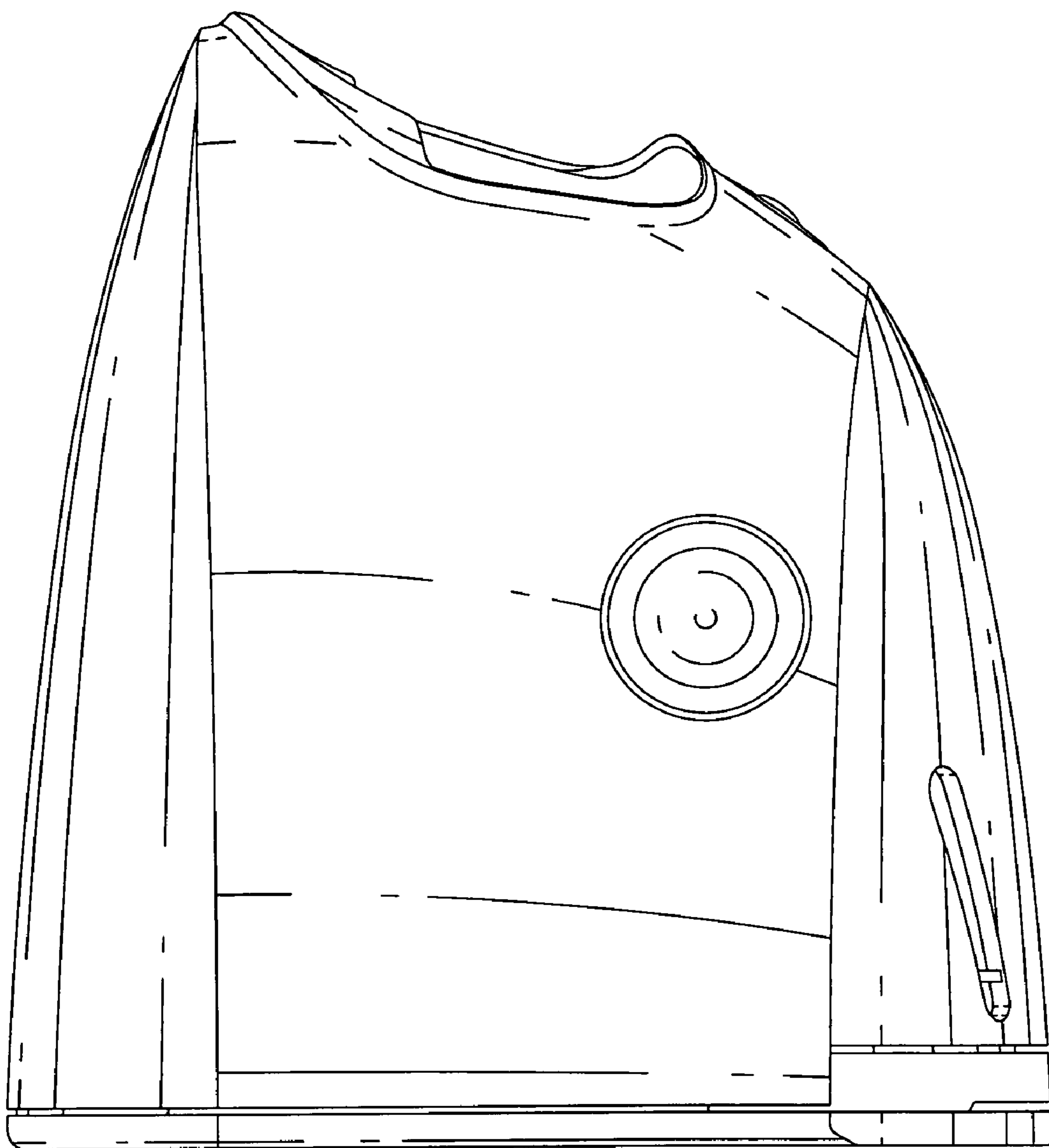

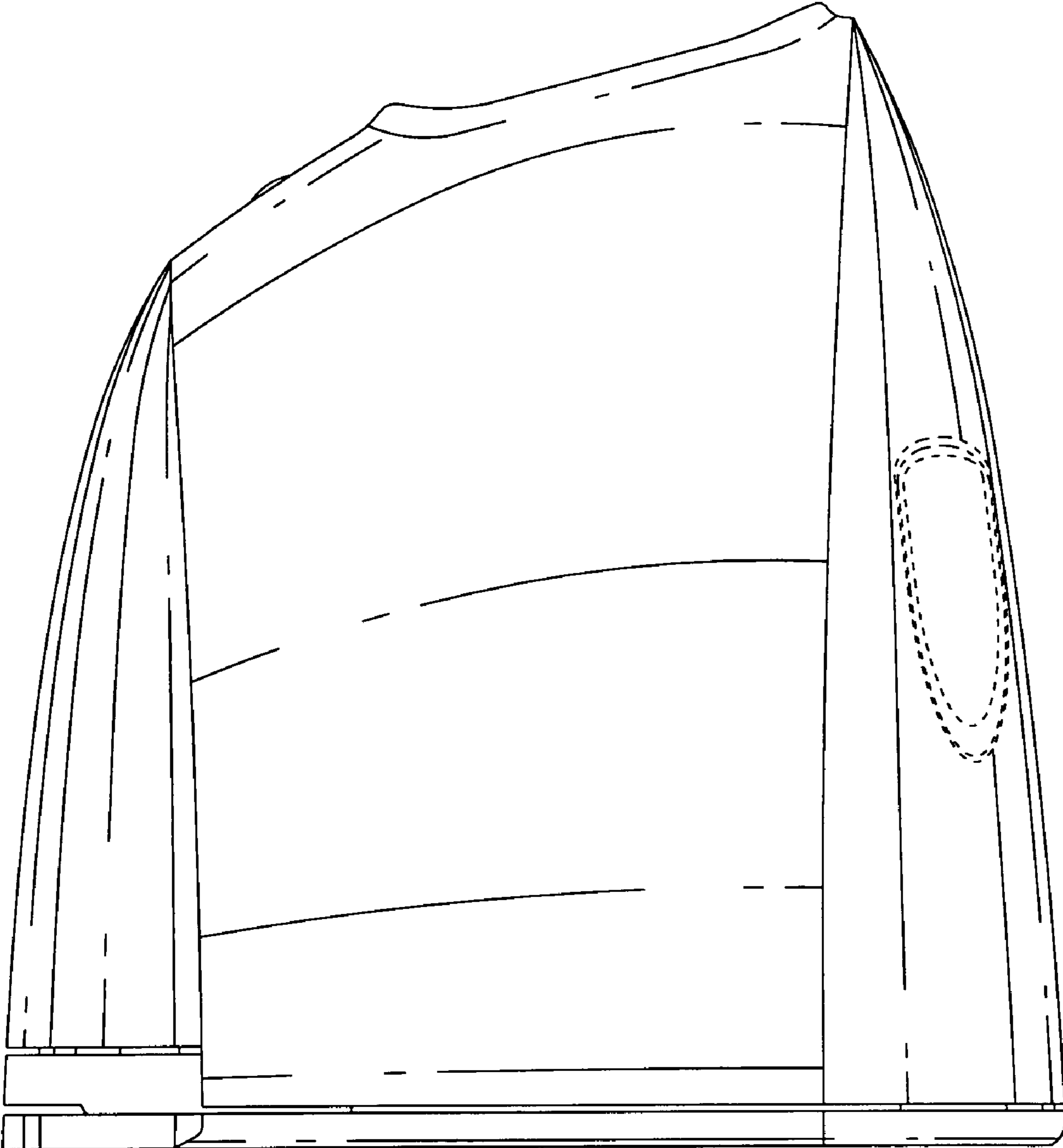

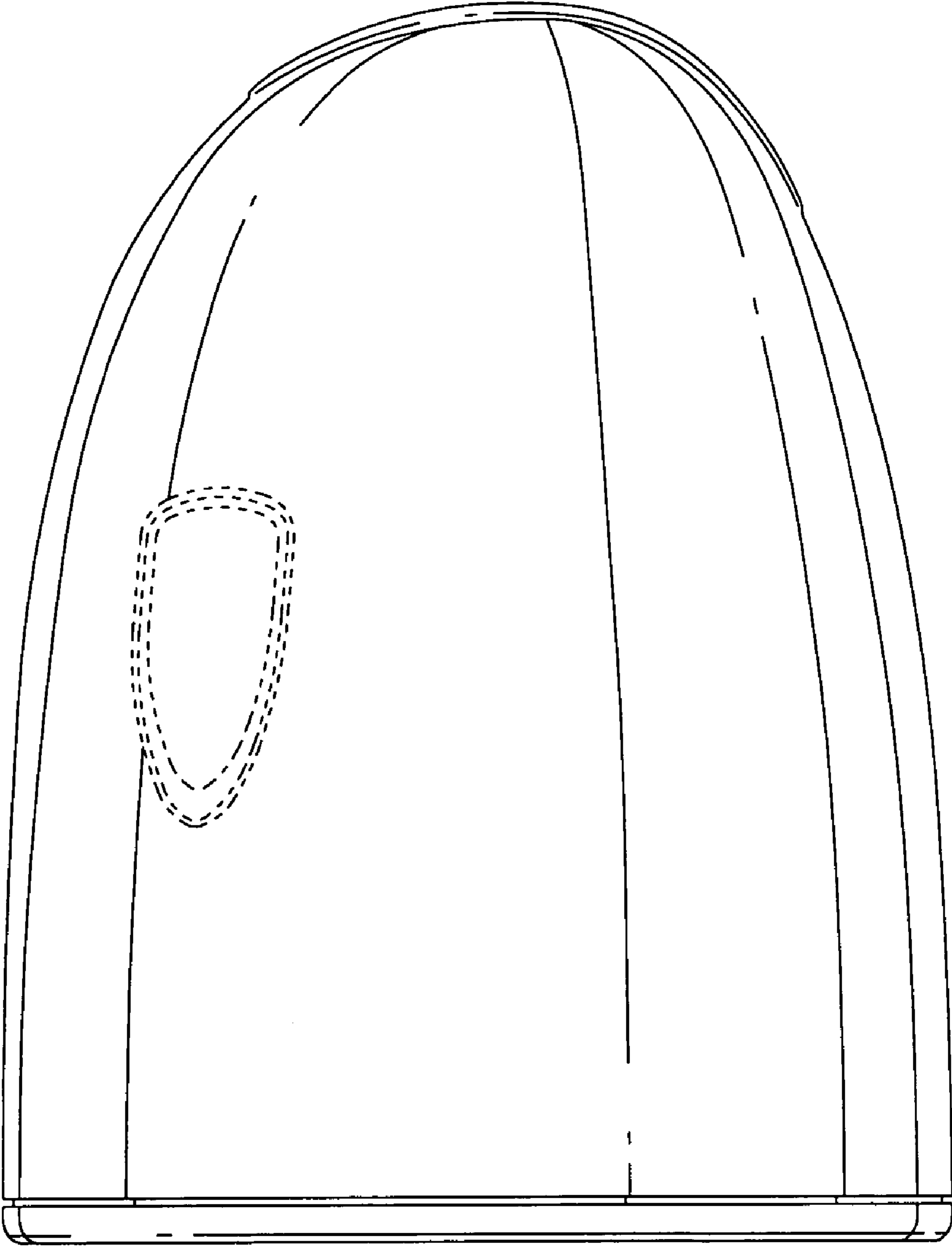

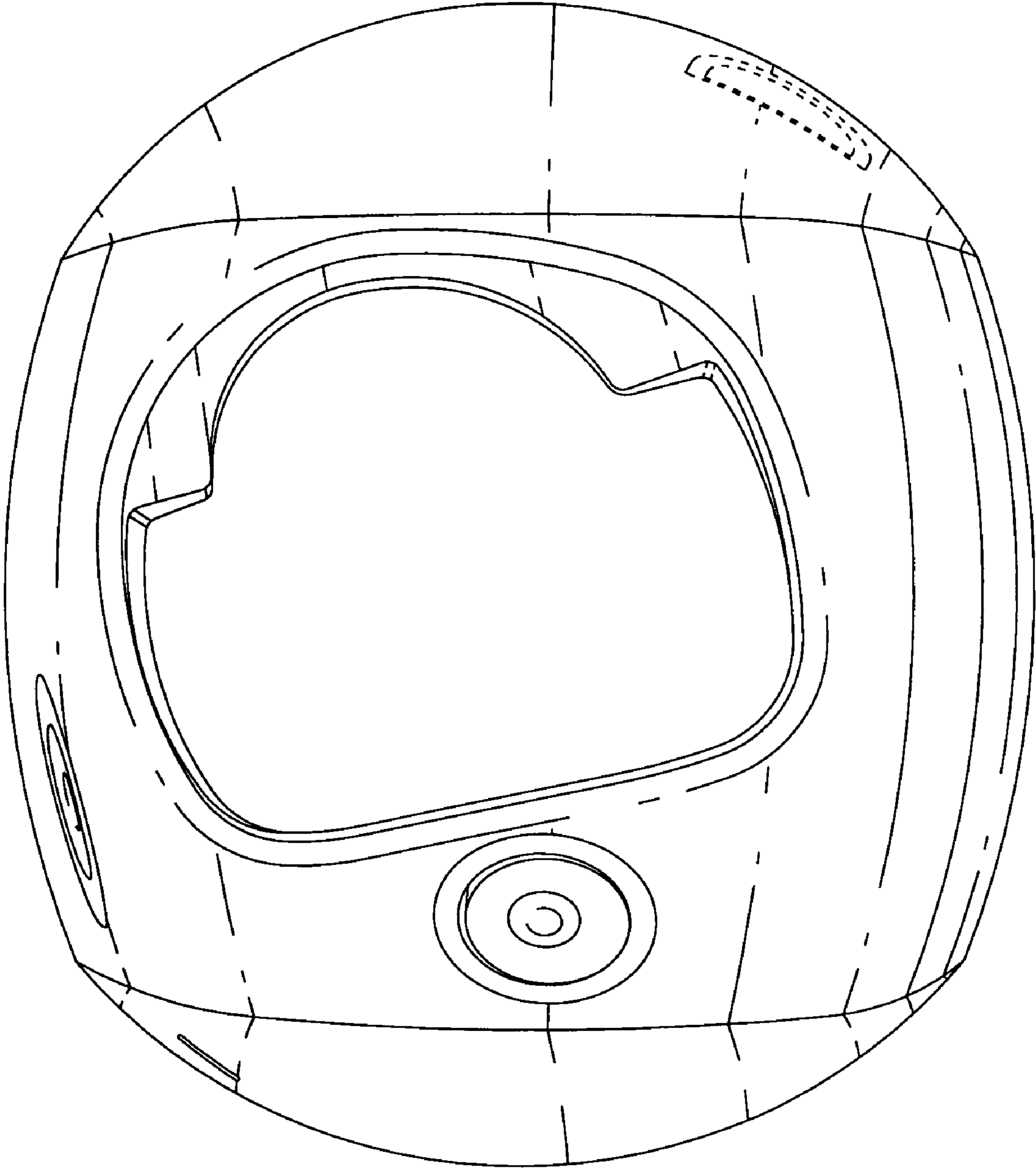

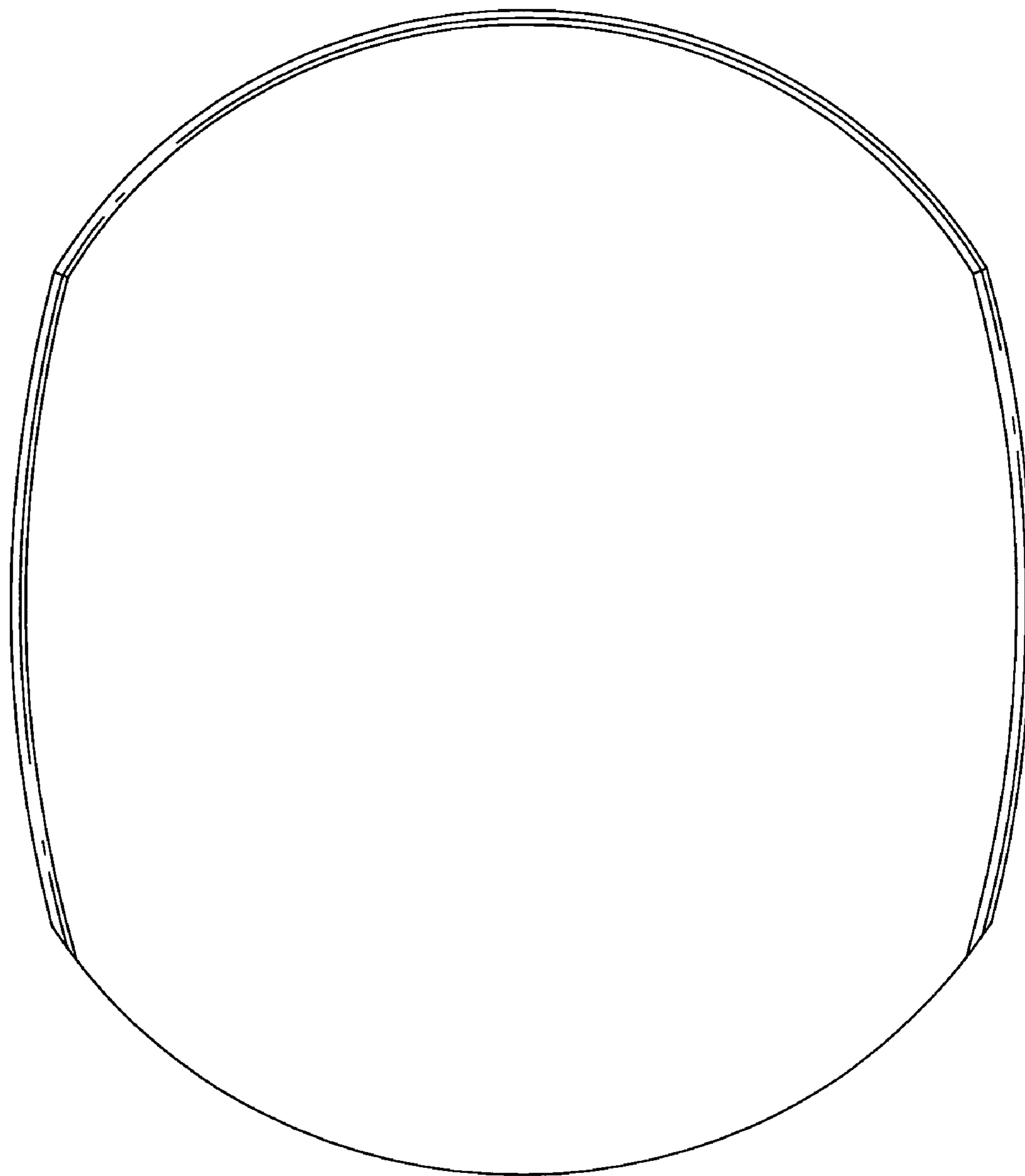
