(57) **CLAIM**

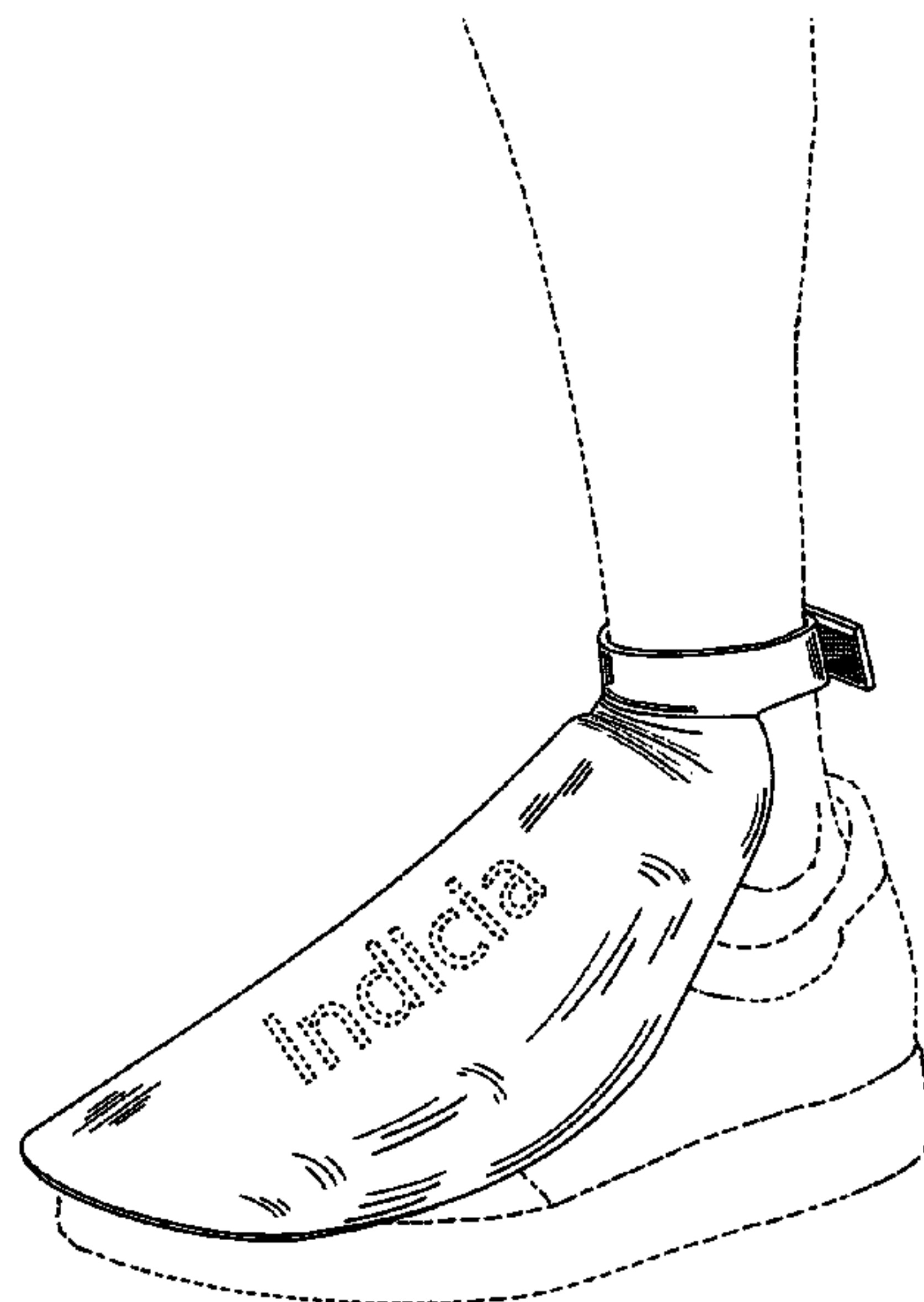
The ornamental design for an attachable cover for footwear, as shown and described.

**DESCRIPTION**

FIG. 1 is an isometric view of an attachable cover for footwear, showing my new design;  
FIG. 2 is an enlarged front view thereof;  
FIG. 3 is an enlarged rear view thereof;  
FIG. 4 is an enlarged right side view with a left side view being the mirror image thereof;  
FIG. 5 is a top view thereof; and,  
FIG. 6 is a bottom view thereof.

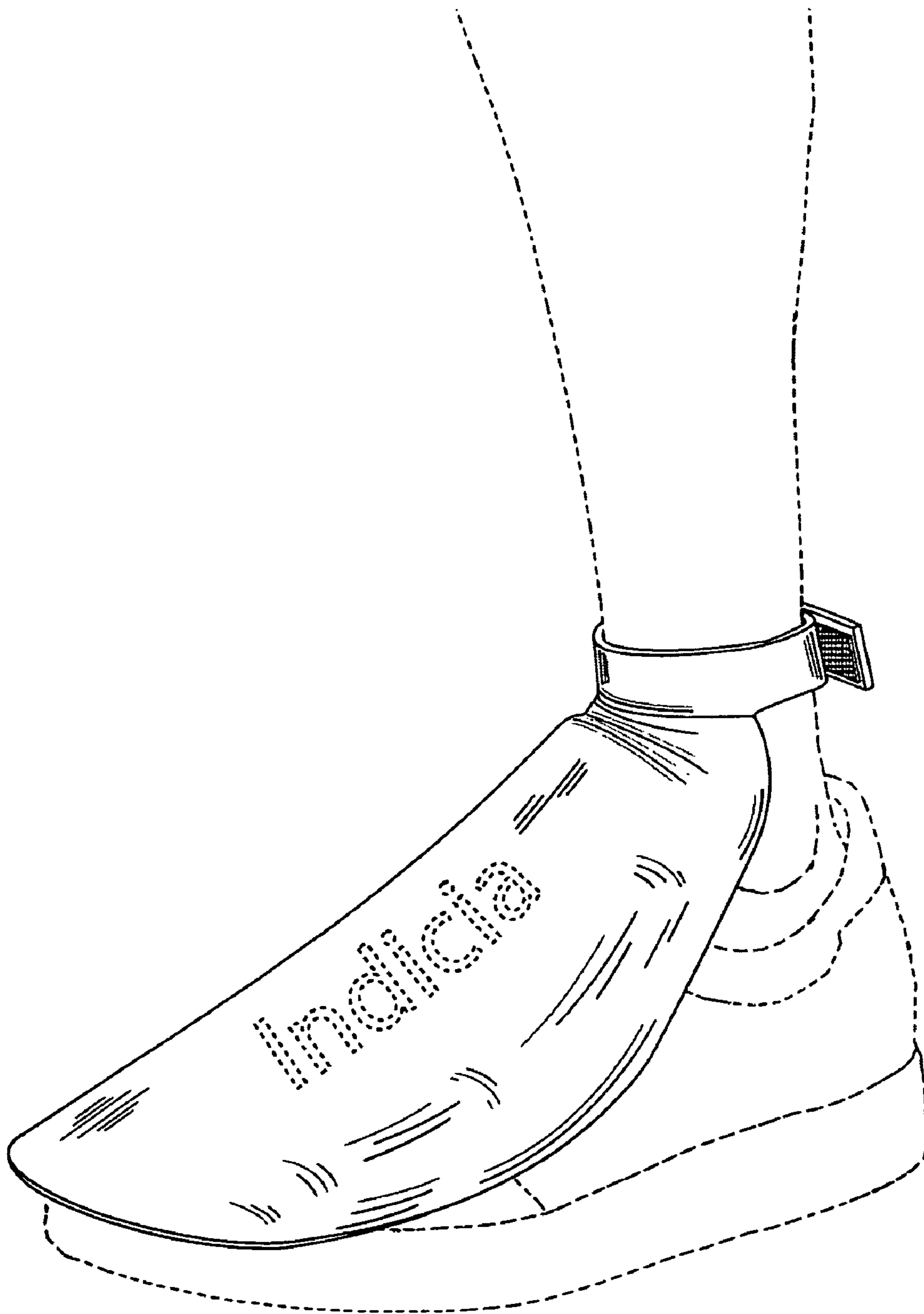

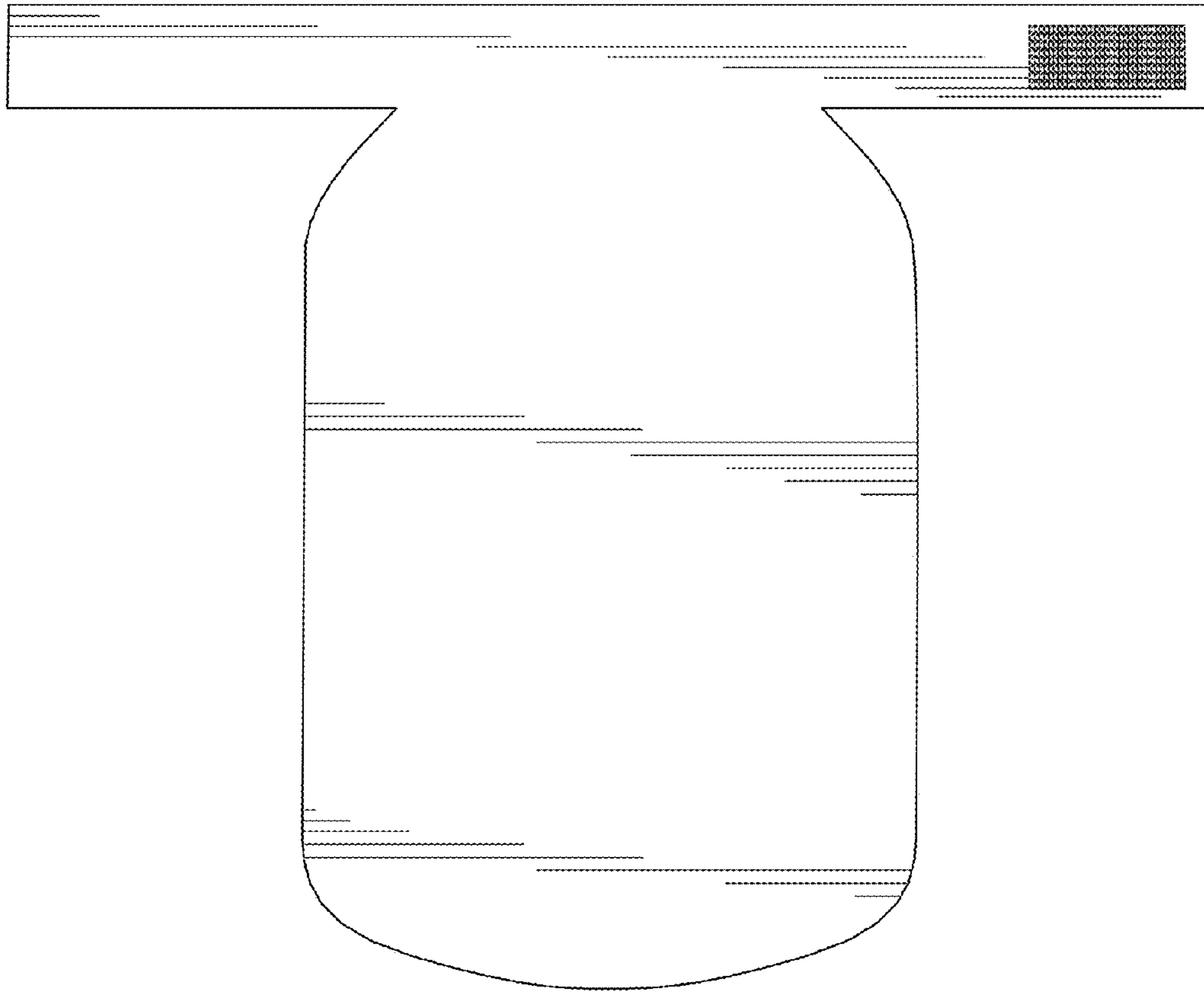

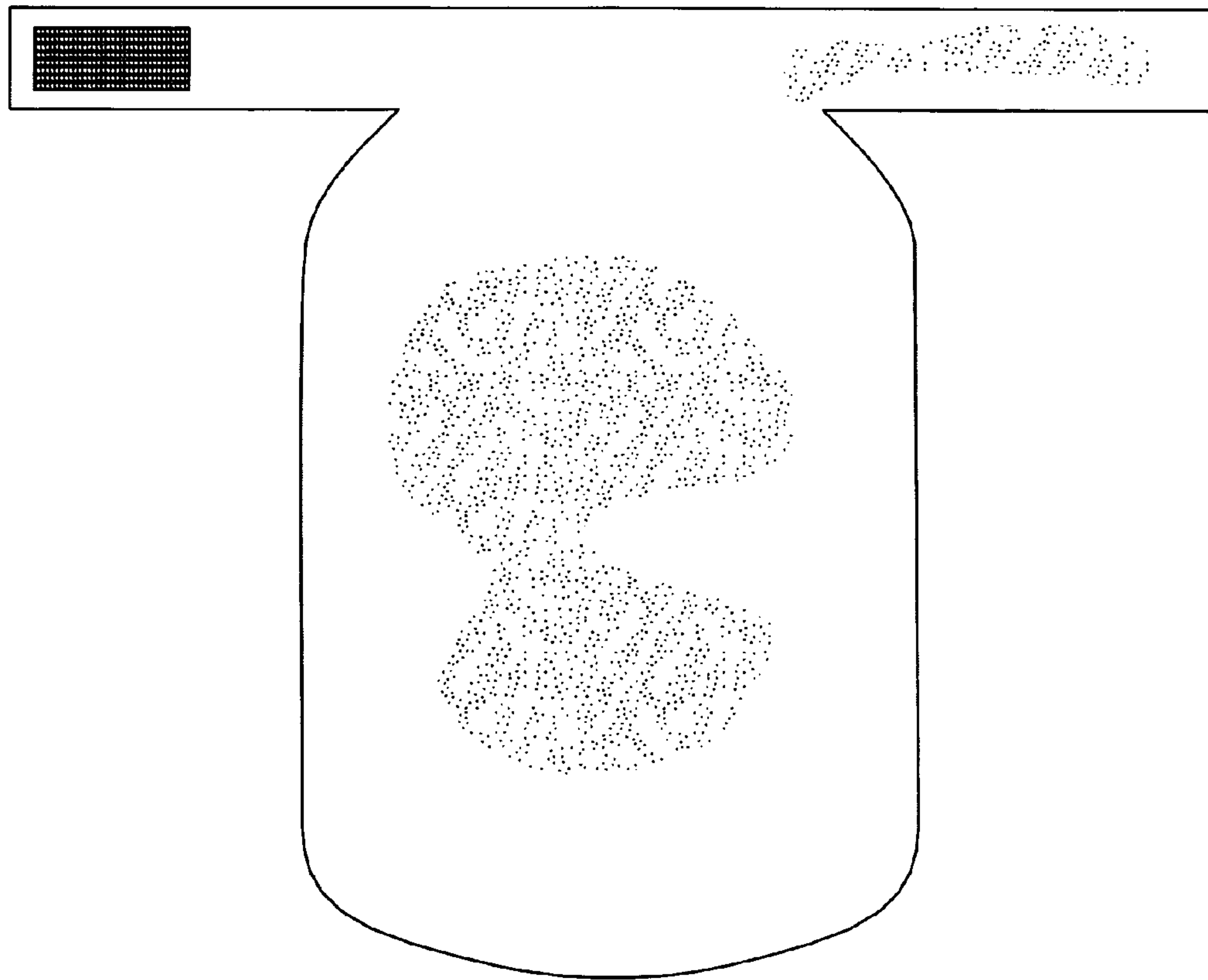
