The ornamental design for a large cosmetic bag with integrated compartments, as shown and described.

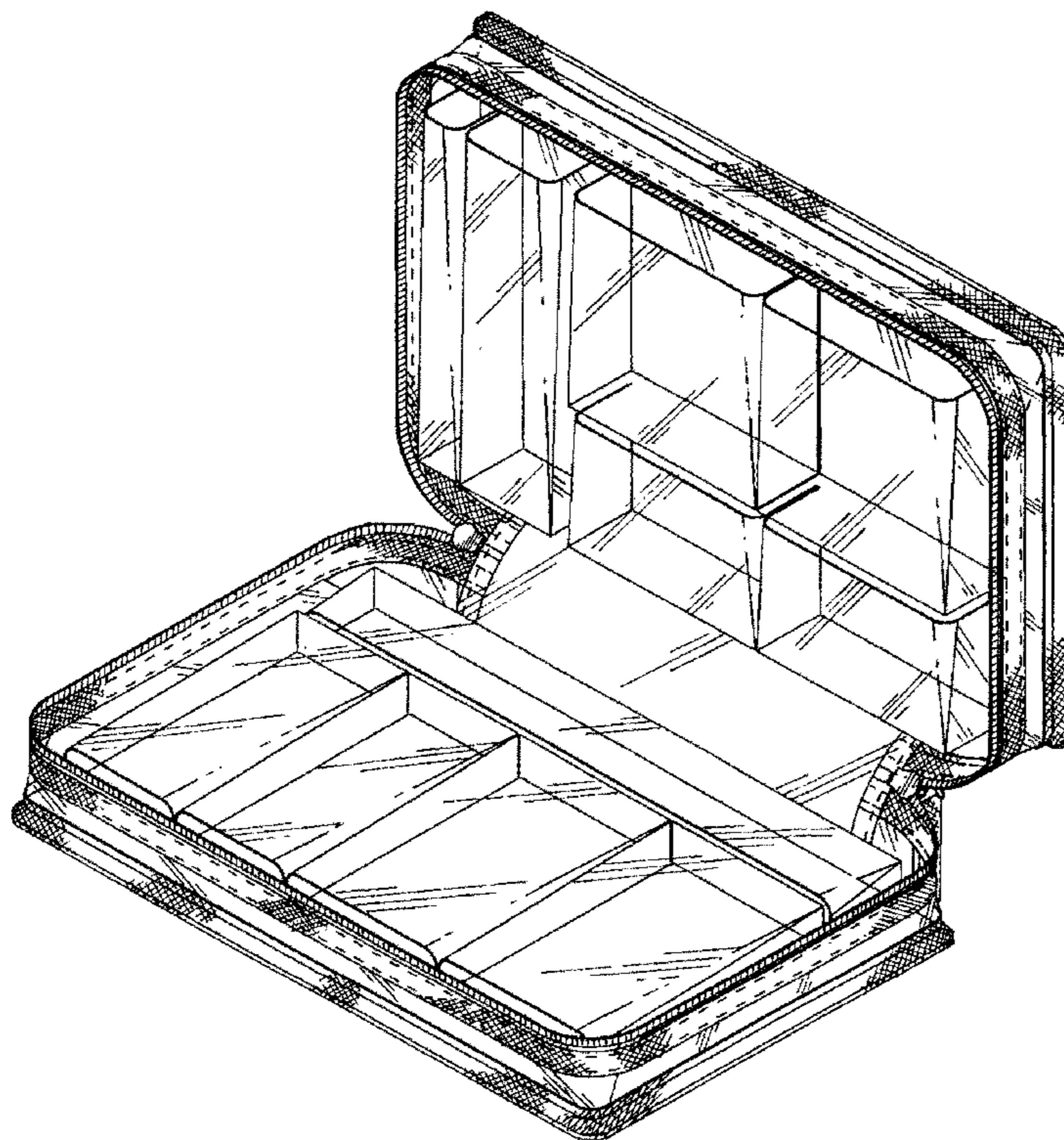
**DESCRIPTION**

FIG. 1 is a front view of a large cosmetic bag with integrated compartments of the present invention;  
FIG. 2 is a rear view thereof;  
FIG. 3 is a top view thereof;  
FIG. 4 is a bottom view thereof;  
FIG. 5 is a left side view thereof;  
FIG. 6 is a right side view thereof; and,  
FIG. 7 is an open perspective view thereof showing the integrated compartments in the interior.

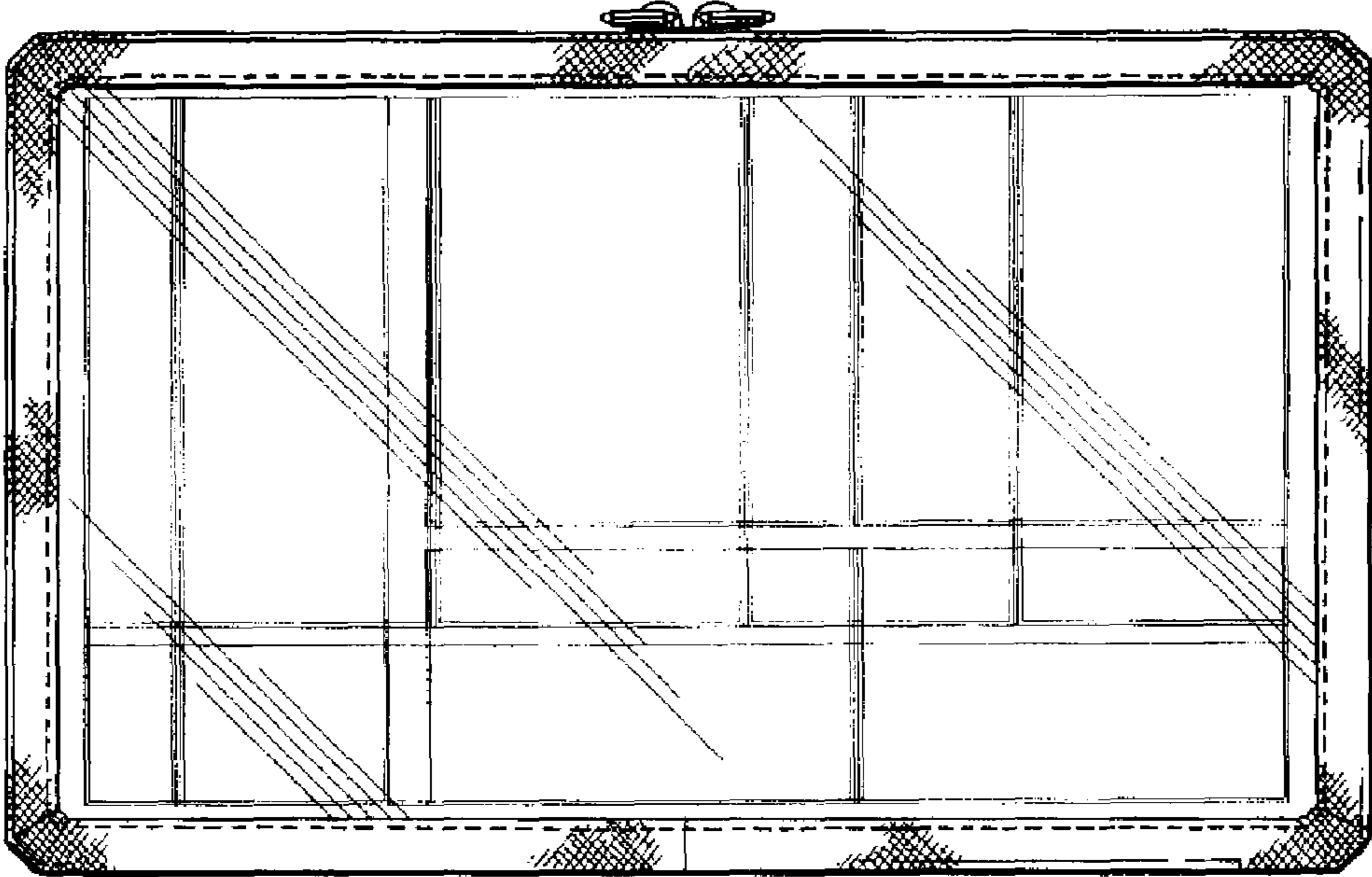

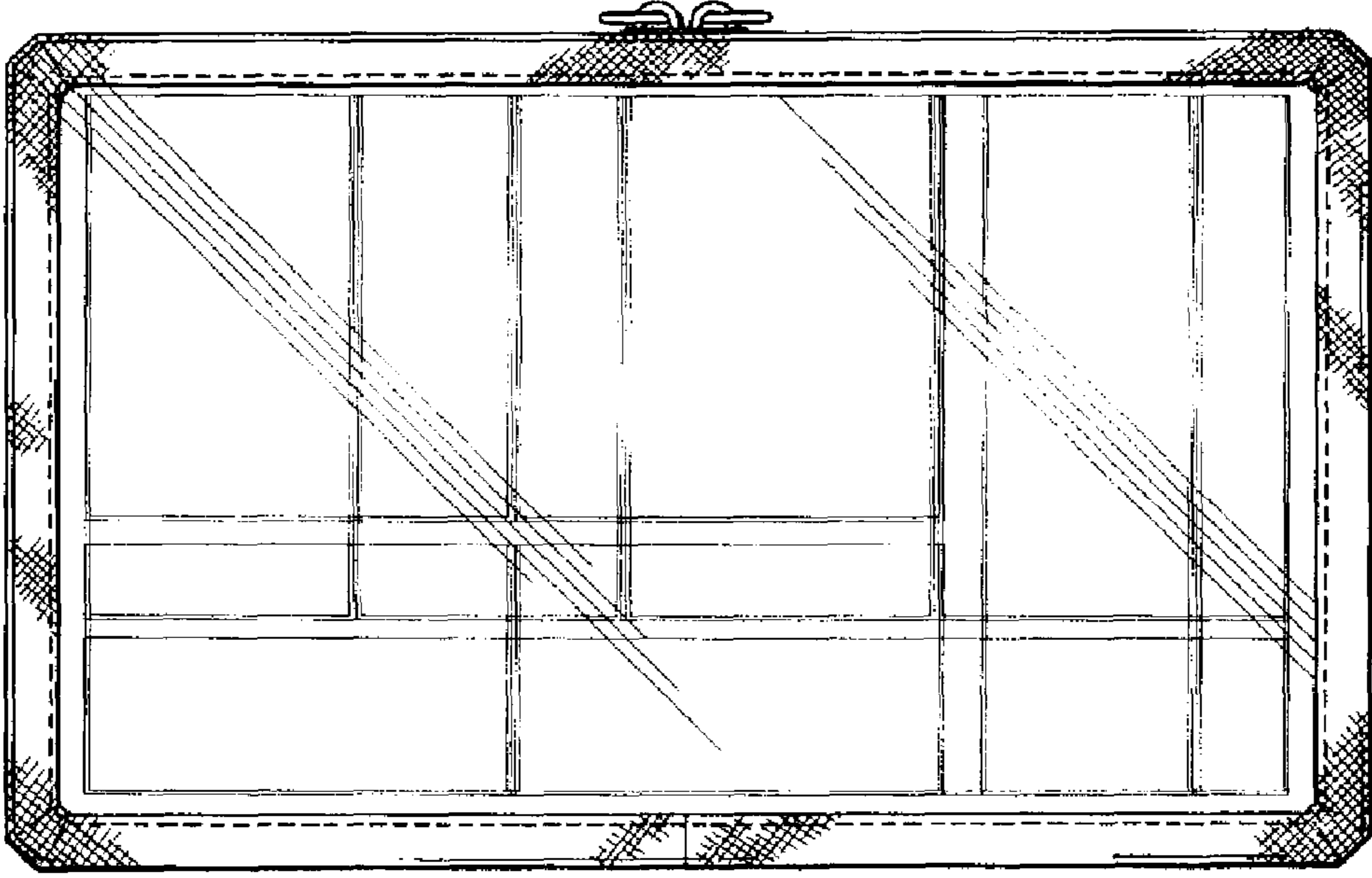

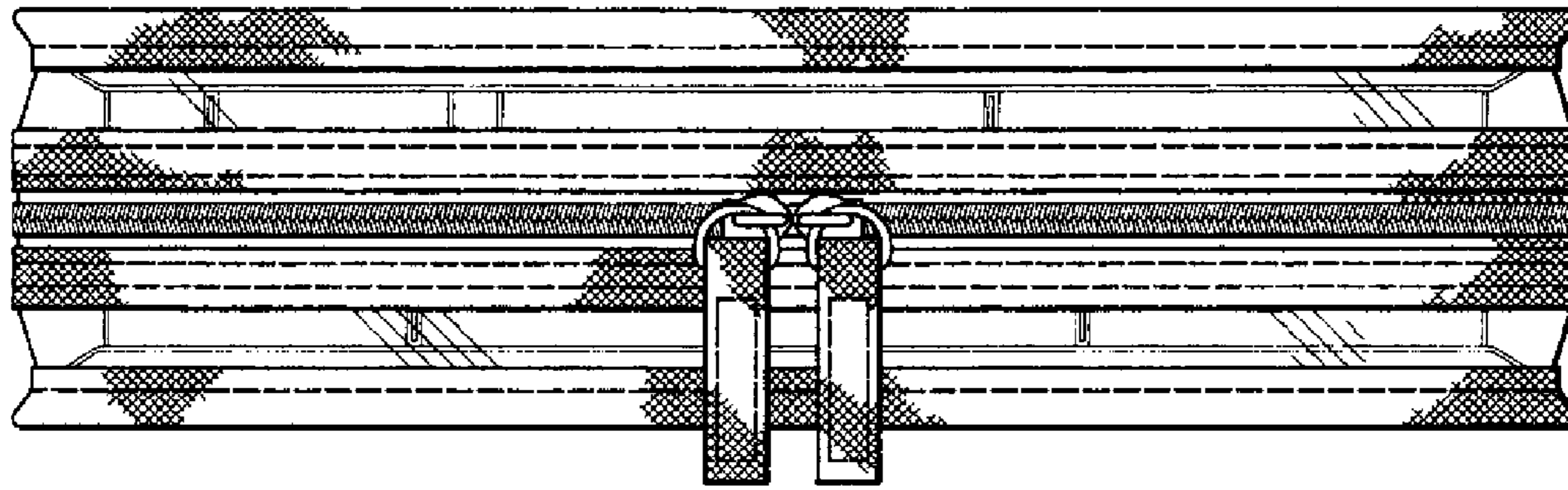

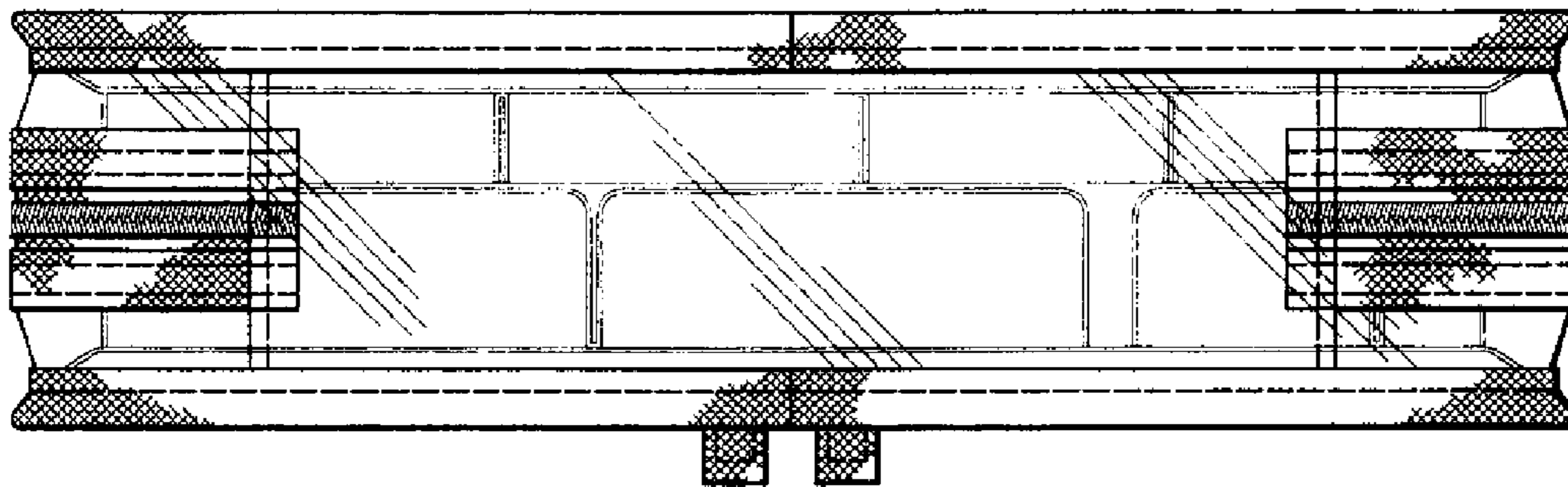

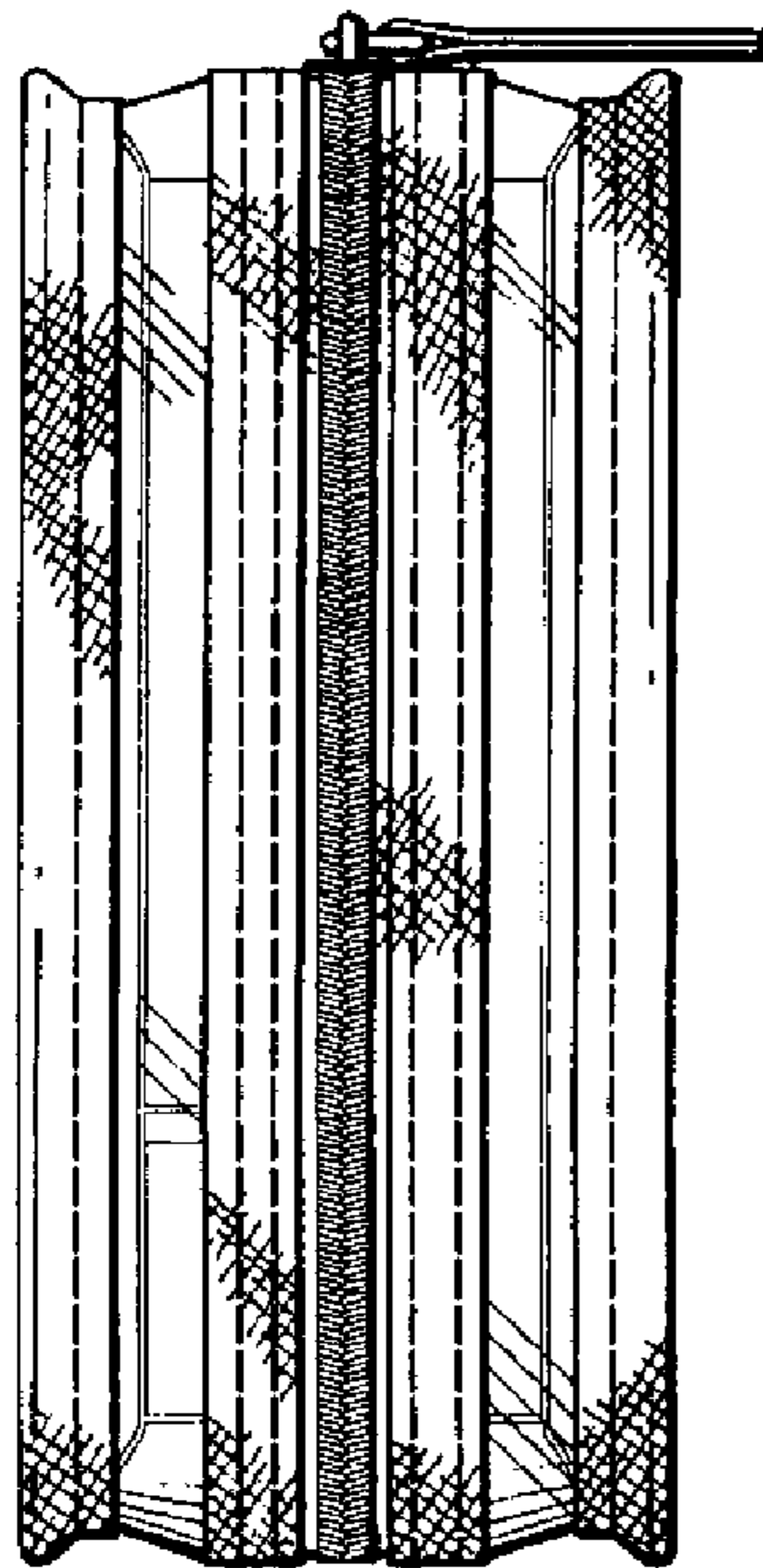

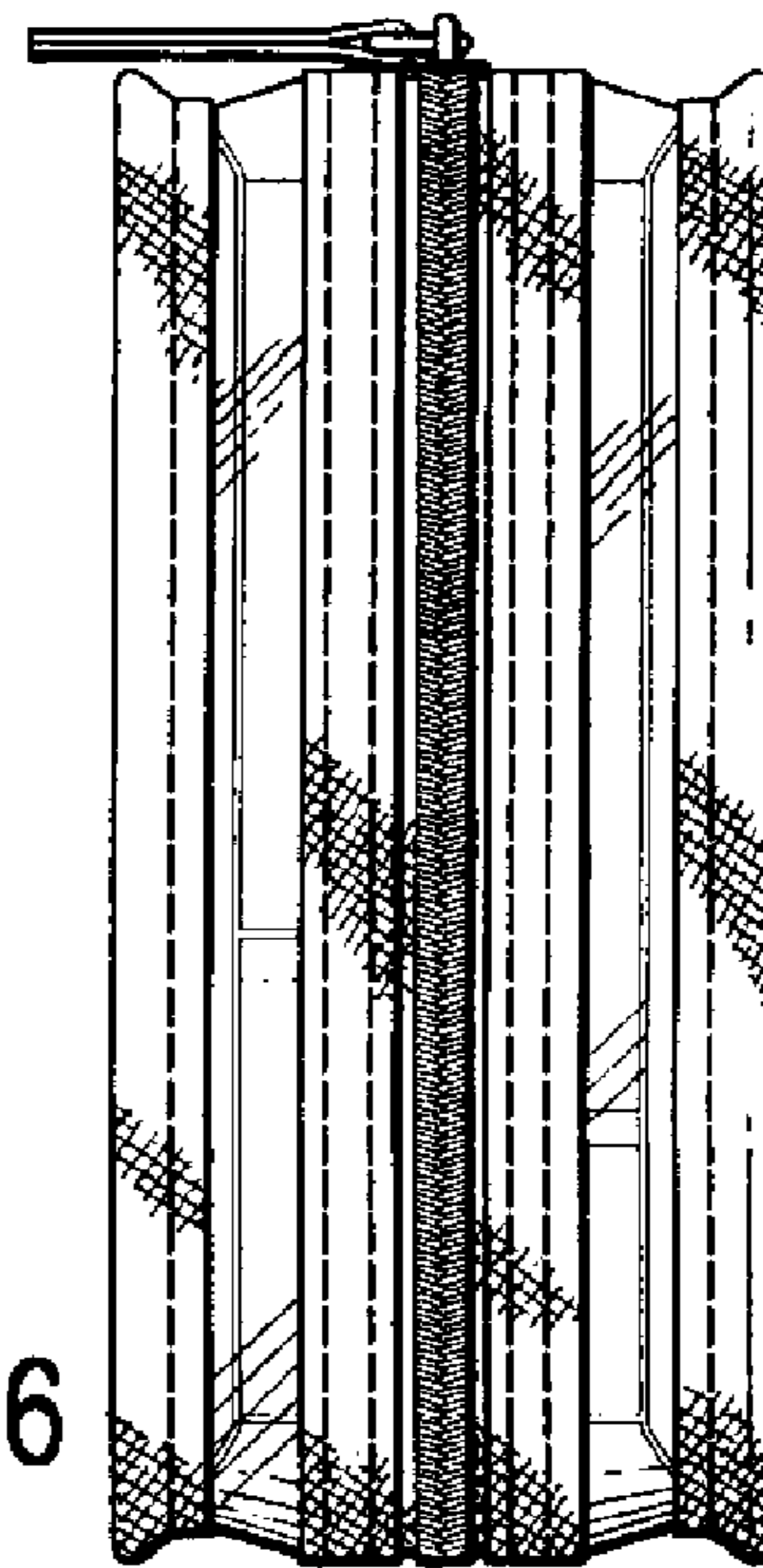
