(57) **CLAIM**

The ornamental design for infant carrier, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an infant carrier of the present design;

FIG. 2 is a left side view of the infant carrier;

FIG. 3 is a right side view of the infant carrier;

FIG. 4 is a front elevational view of the infant carrier;

FIG. 5 is a rear elevational view of the infant carrier;

FIG. 6 is a top view of the infant carrier, without straps and laid flat;

FIG. 7 is a bottom view of the infant carrier, without straps and laid flat;

FIG. 8 is a plan view of the straps of the infant carrier laid flat;

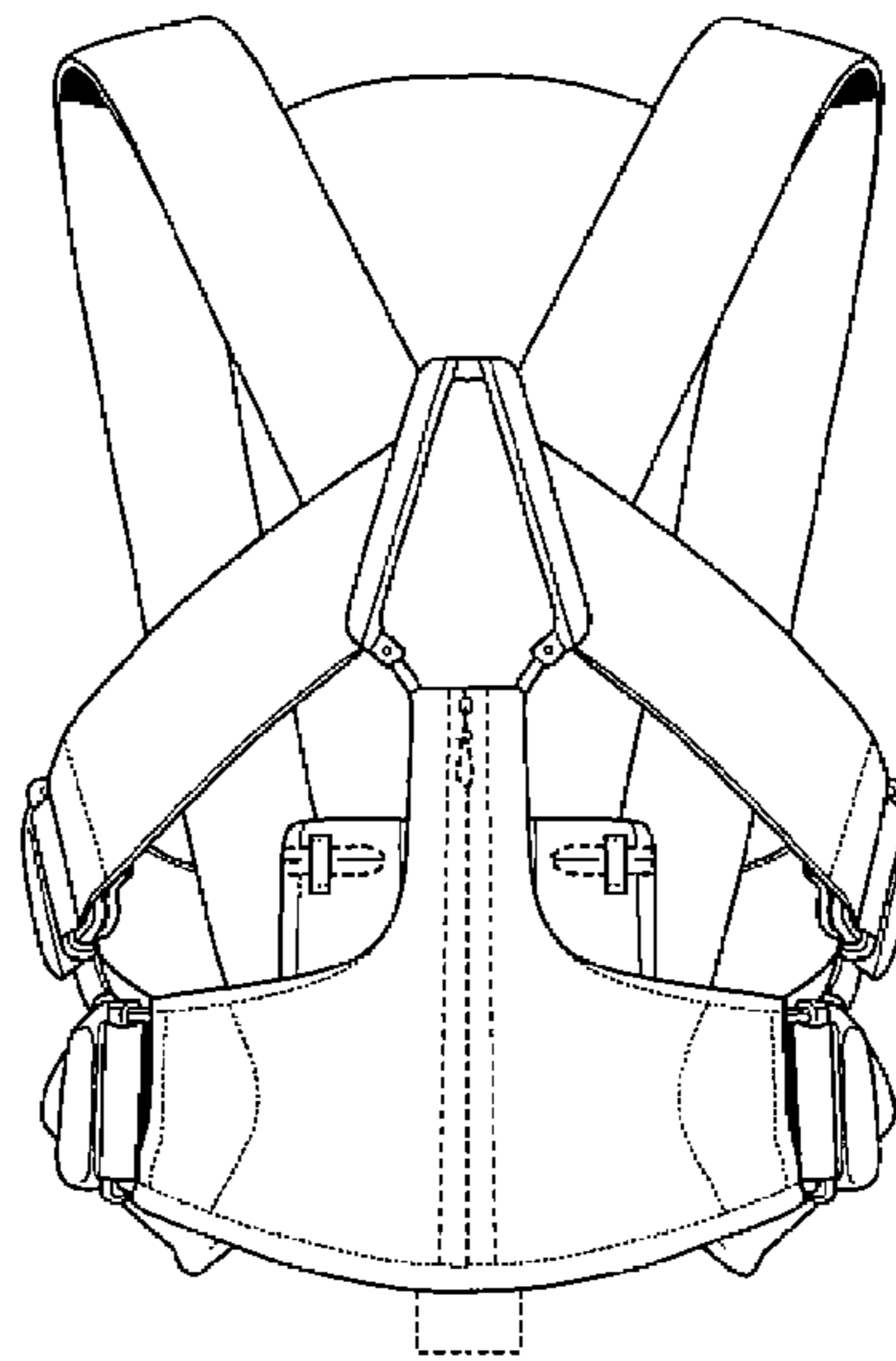
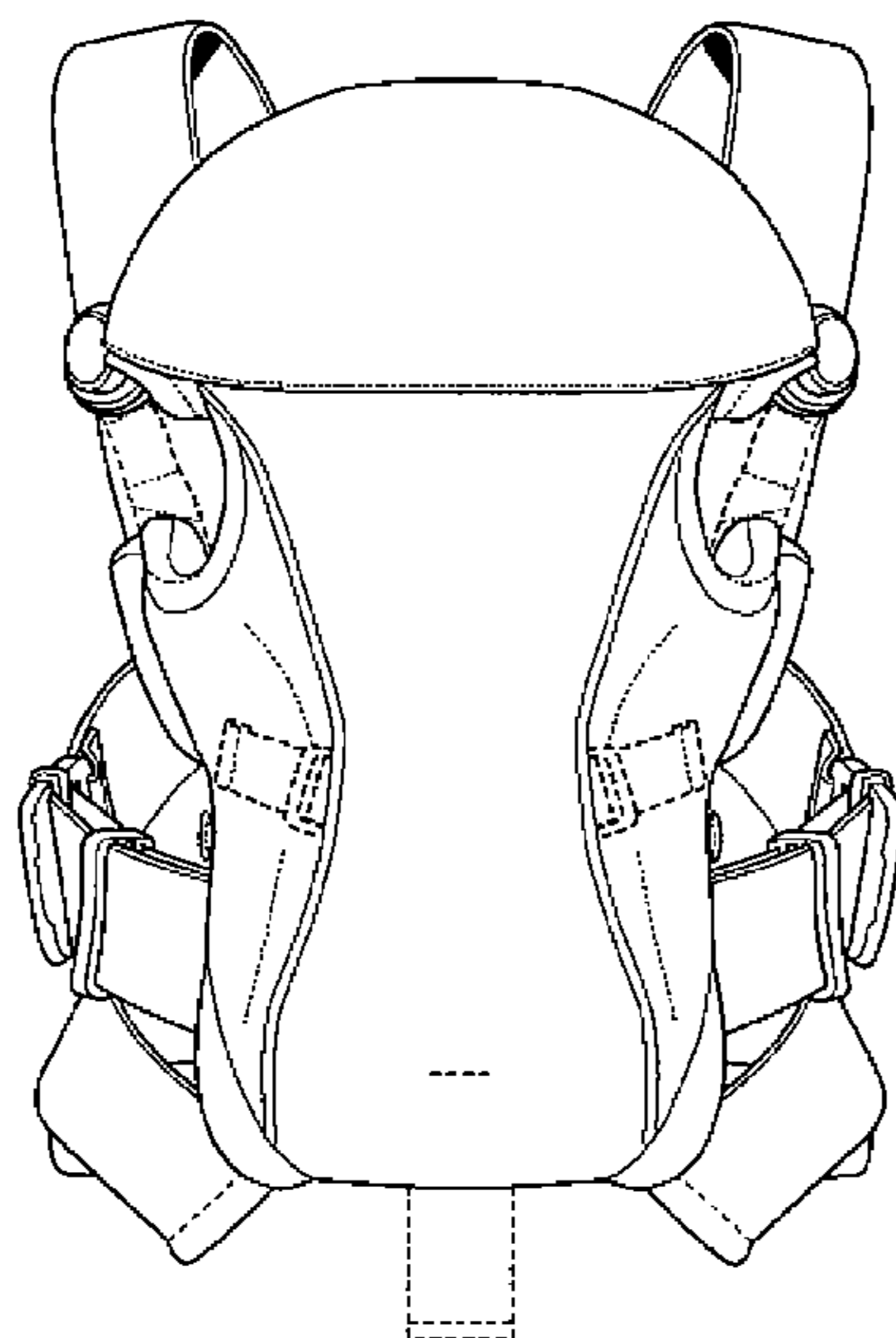
FIG. 9 is an inside view of a front piece of the infant carrier laid flat; and,

FIG. 10 is an outside view of the front piece of the infant carrier laid flat.

The fine dotted lines shown on the surface of the carrier along with the parallel broken lines along the slide fastener represent stitching. The tabs, hardware and slide fastener shown in broken lines throughout the views represent the portions of the article that form no part of the claim.

The claim consists of the infant carrier in its entirety. FIGS. 8-10 are included so that details of the design which are ordinarily partially visible would be more fully appreciated.

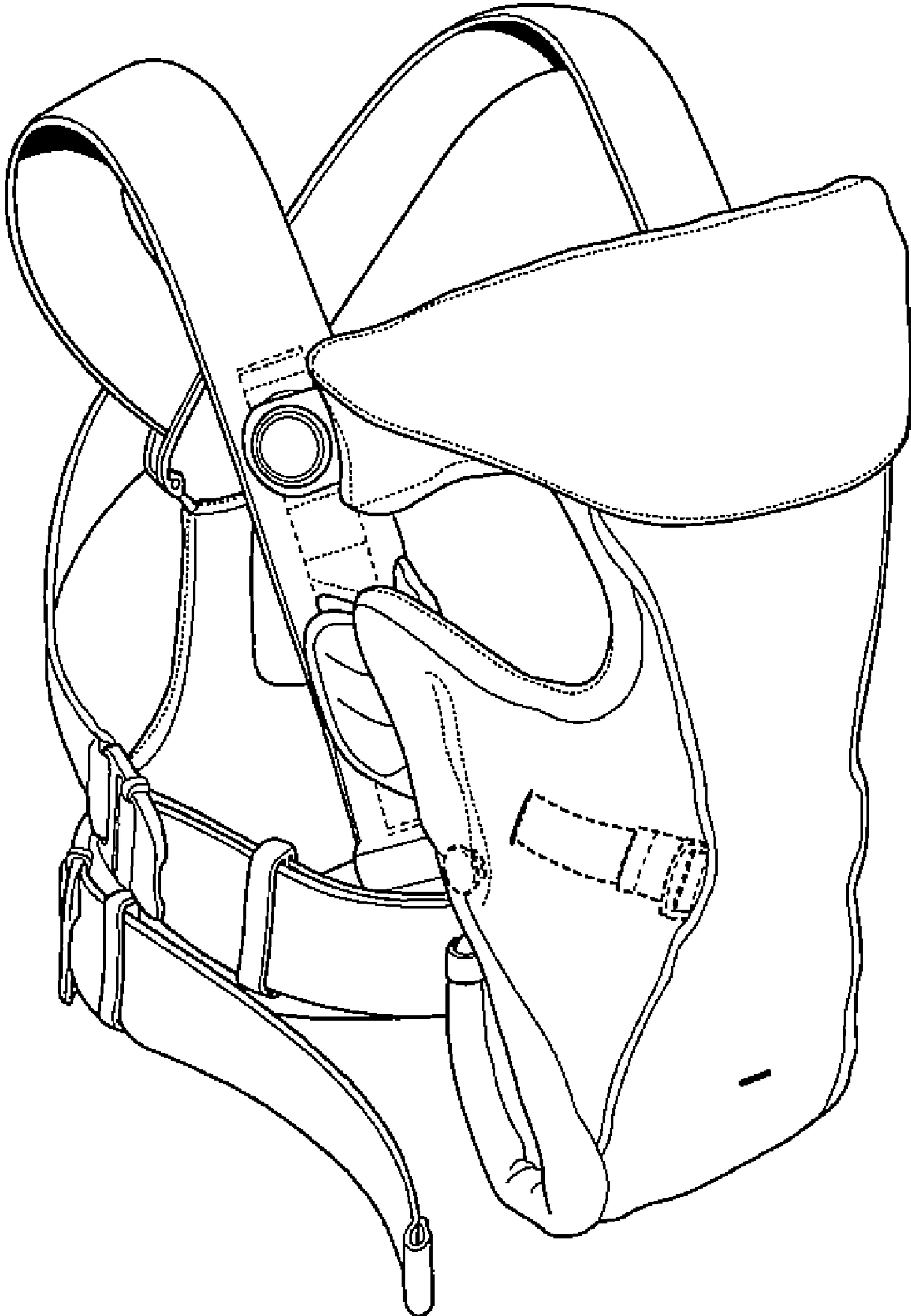

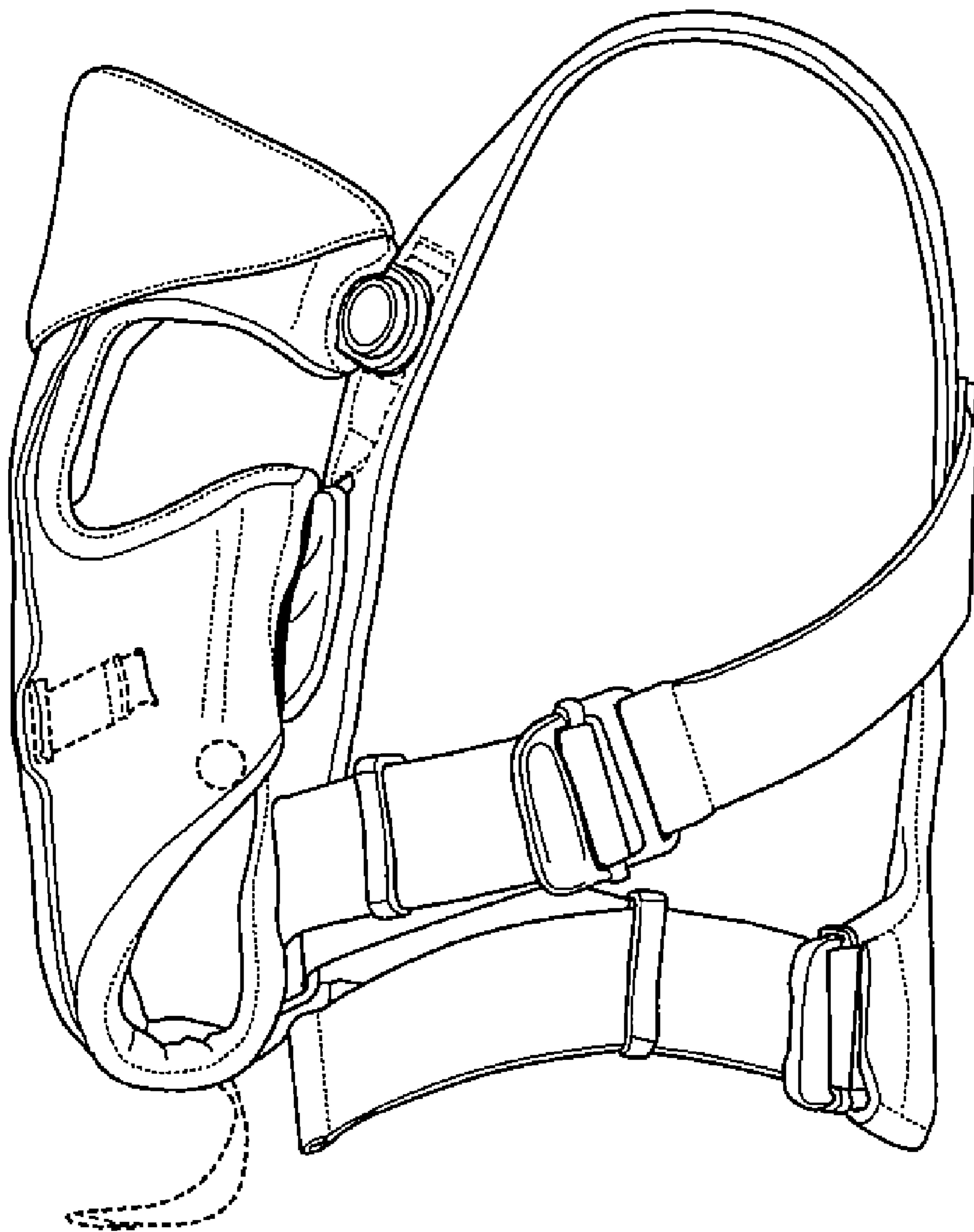

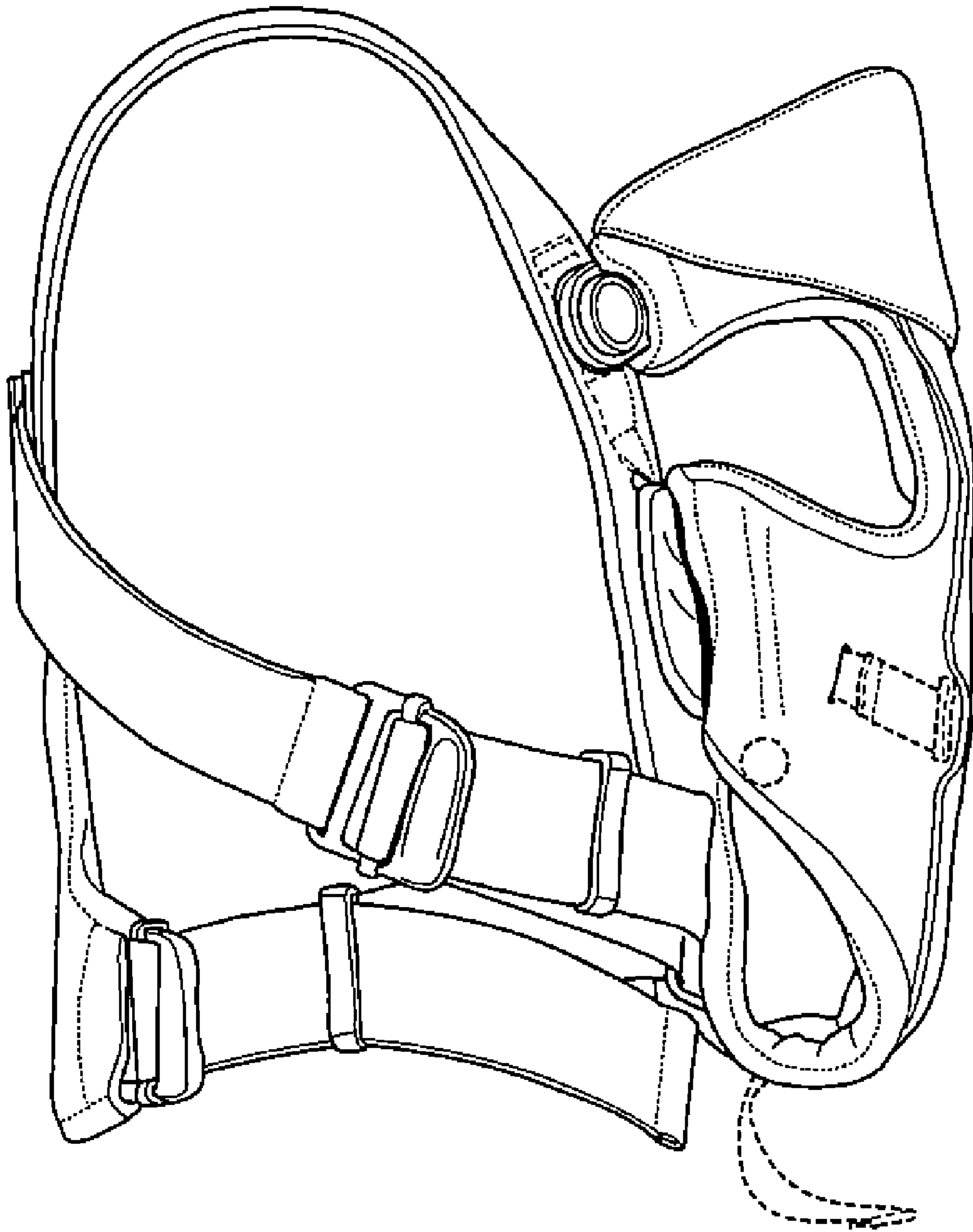

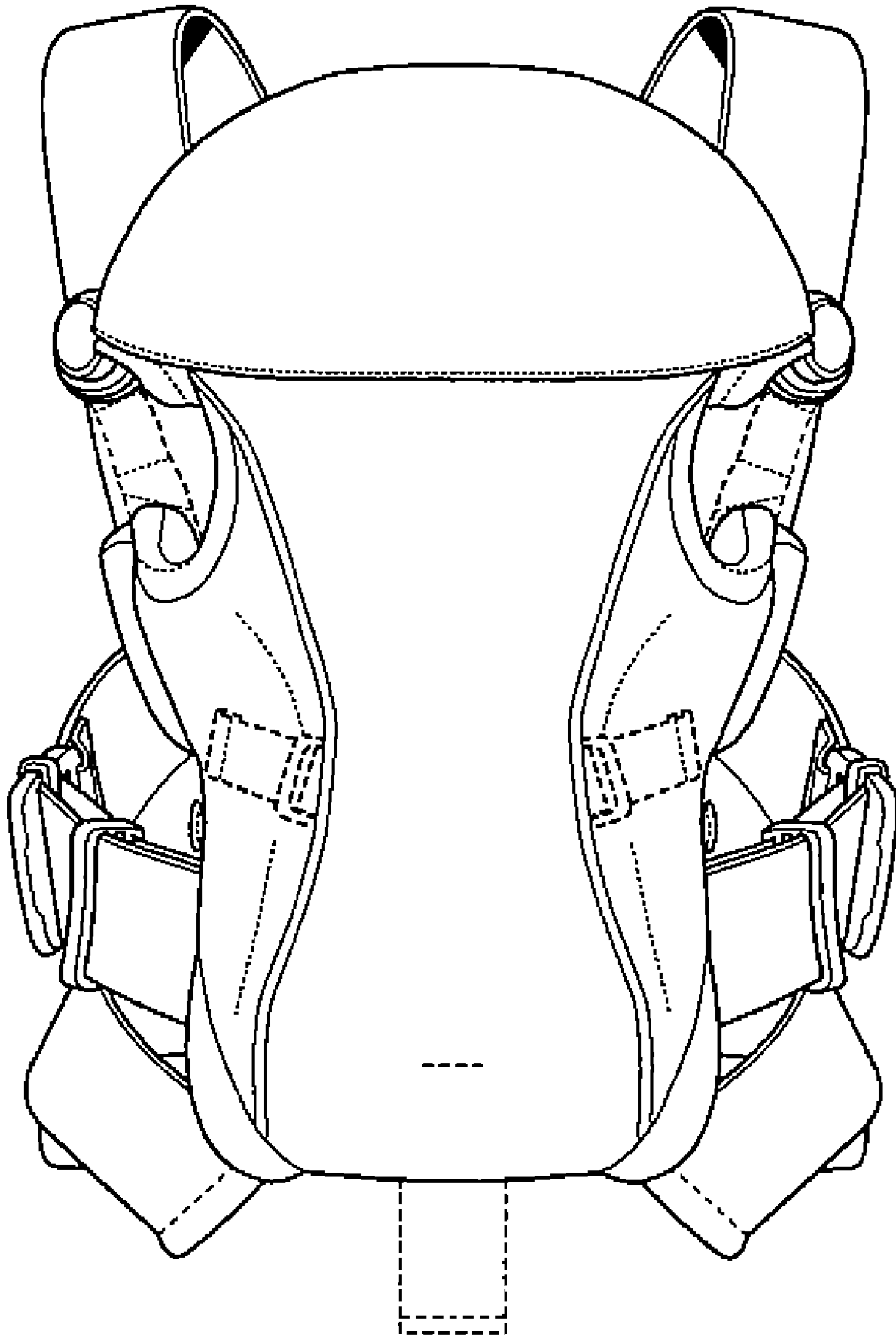

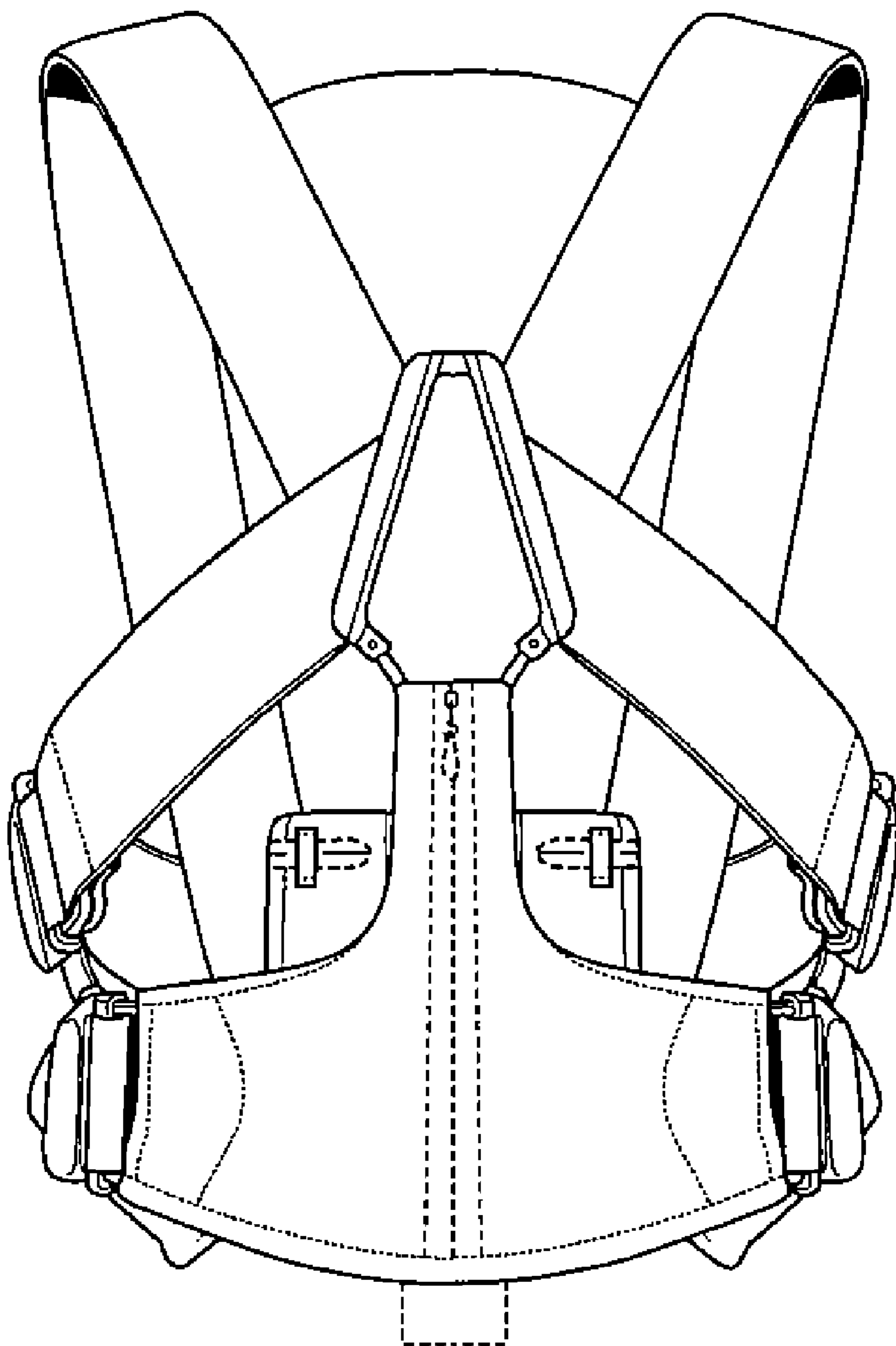

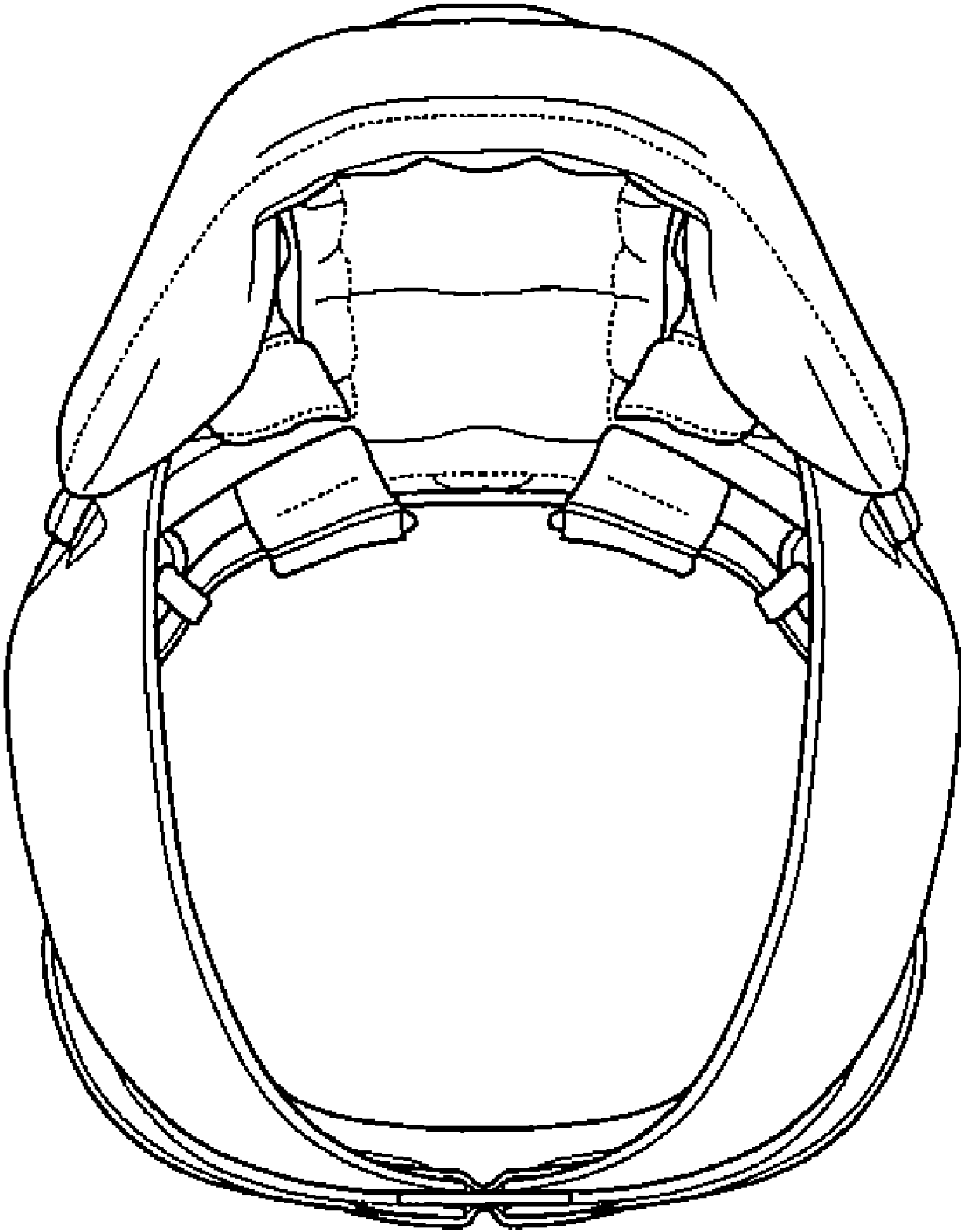

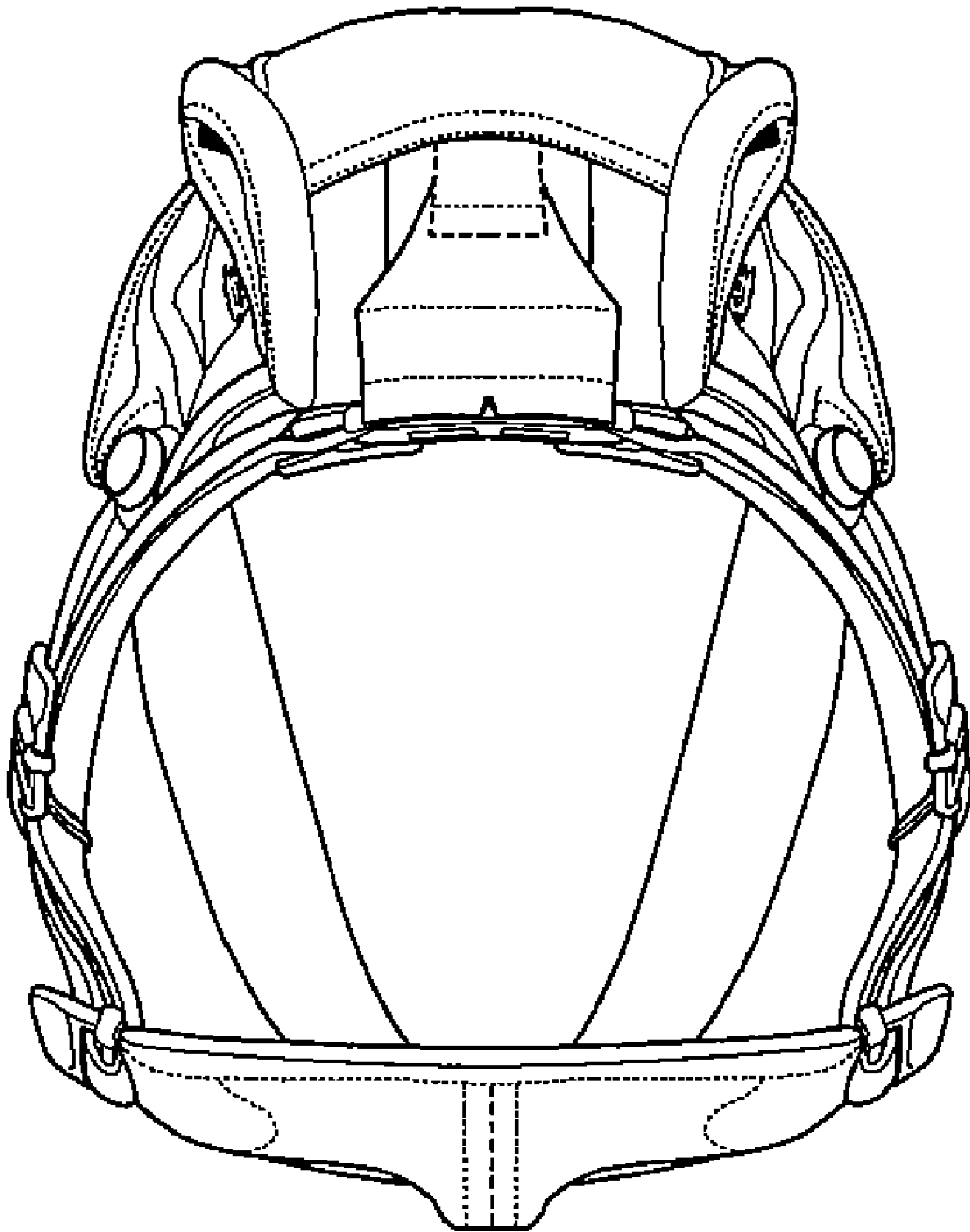

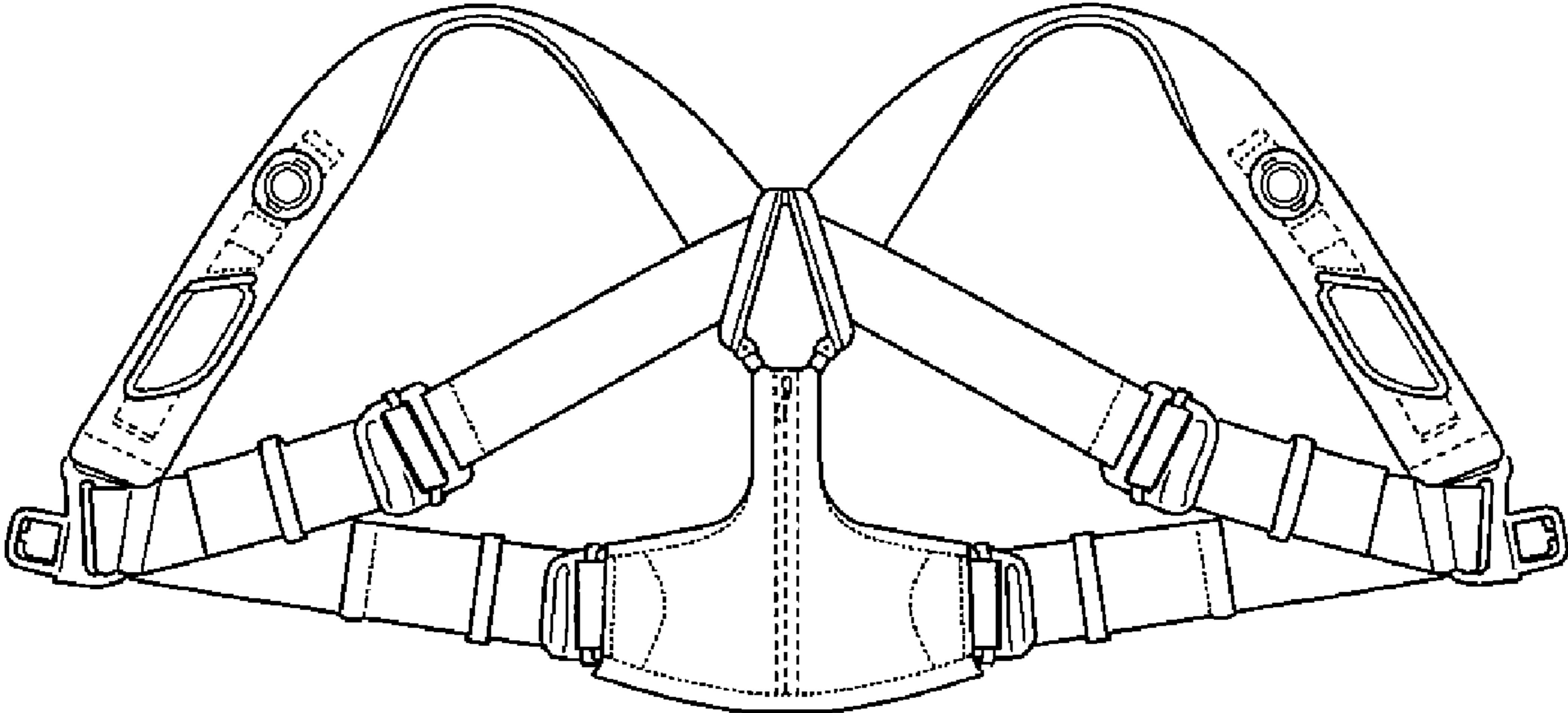

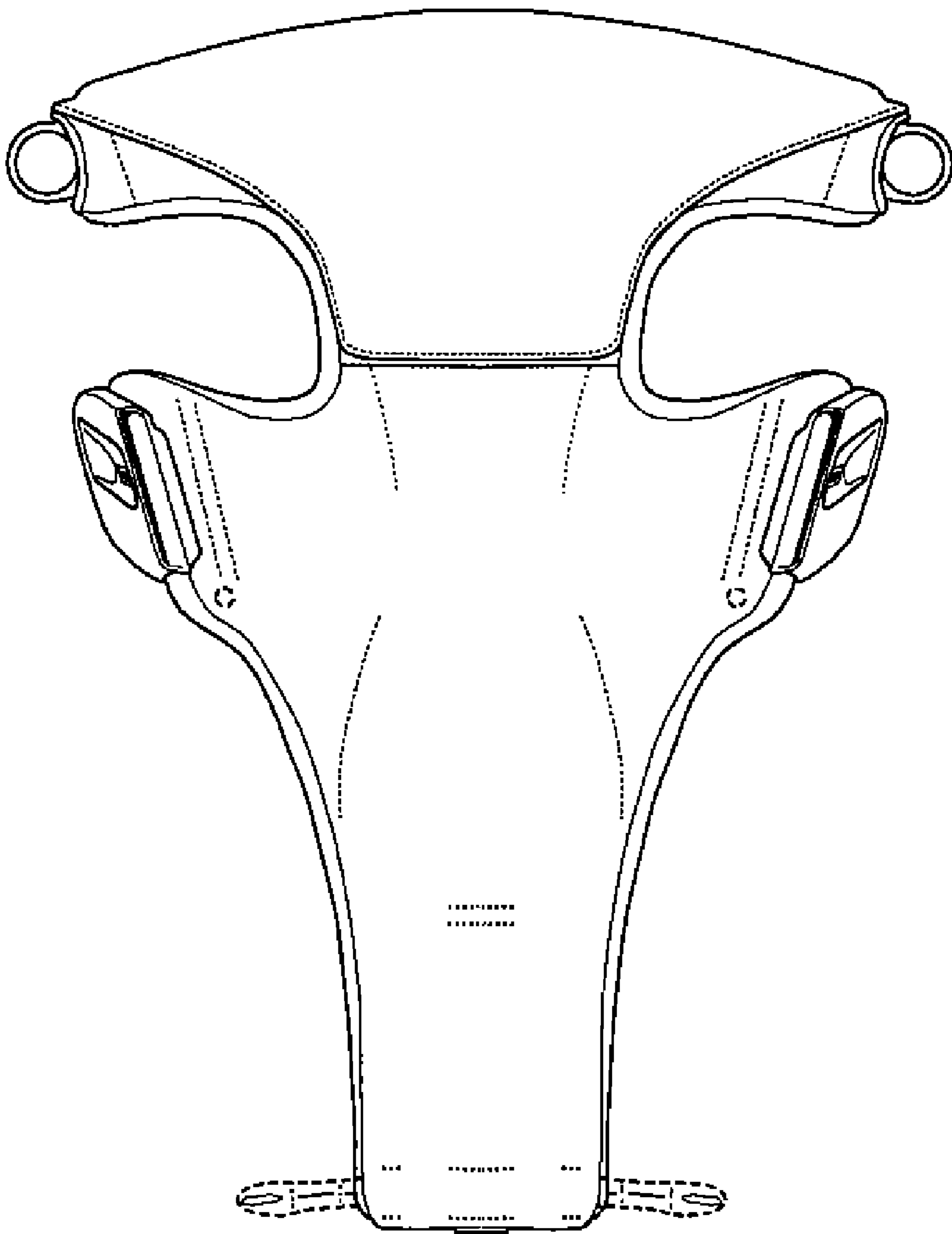

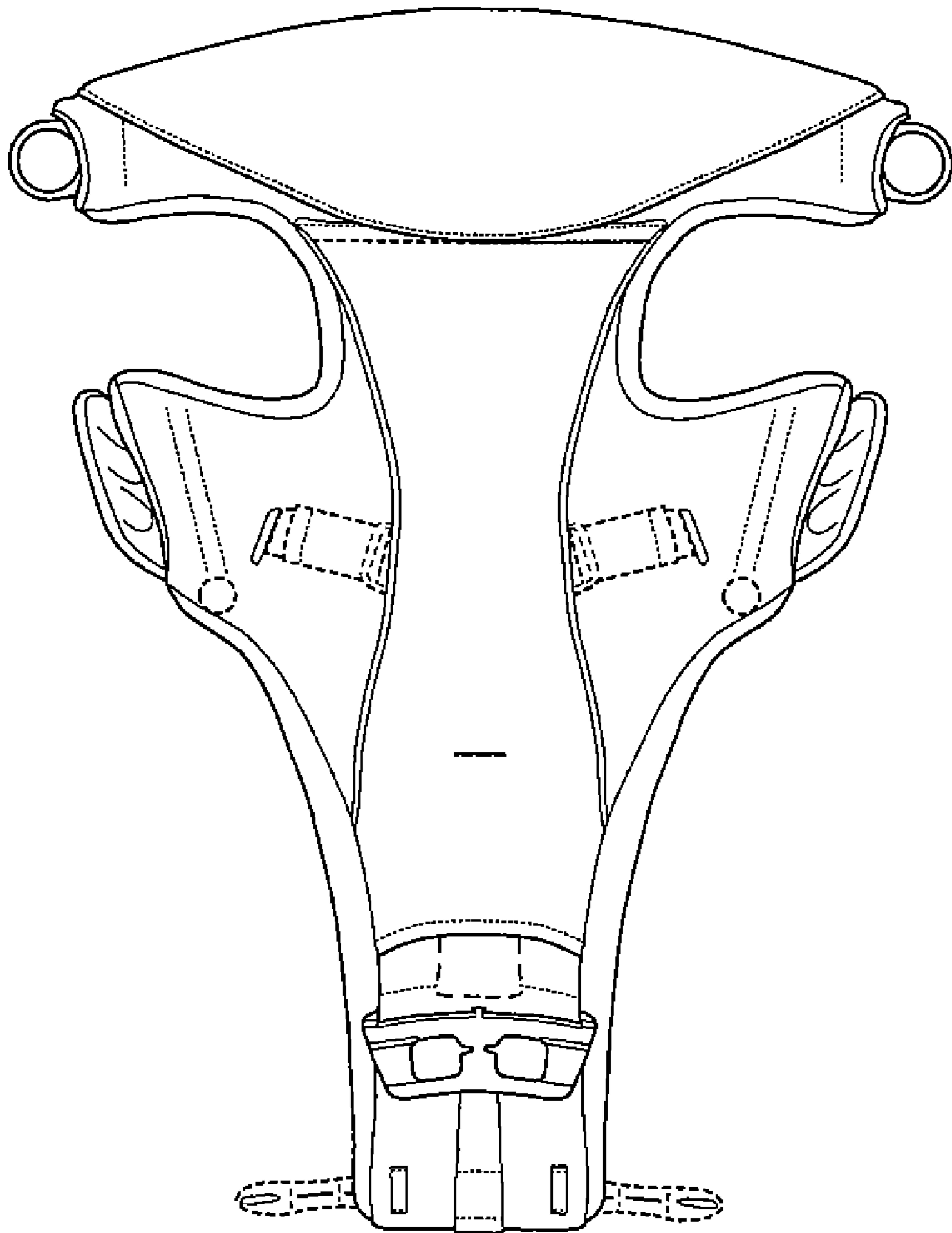
