side, and right side views being identical; and,

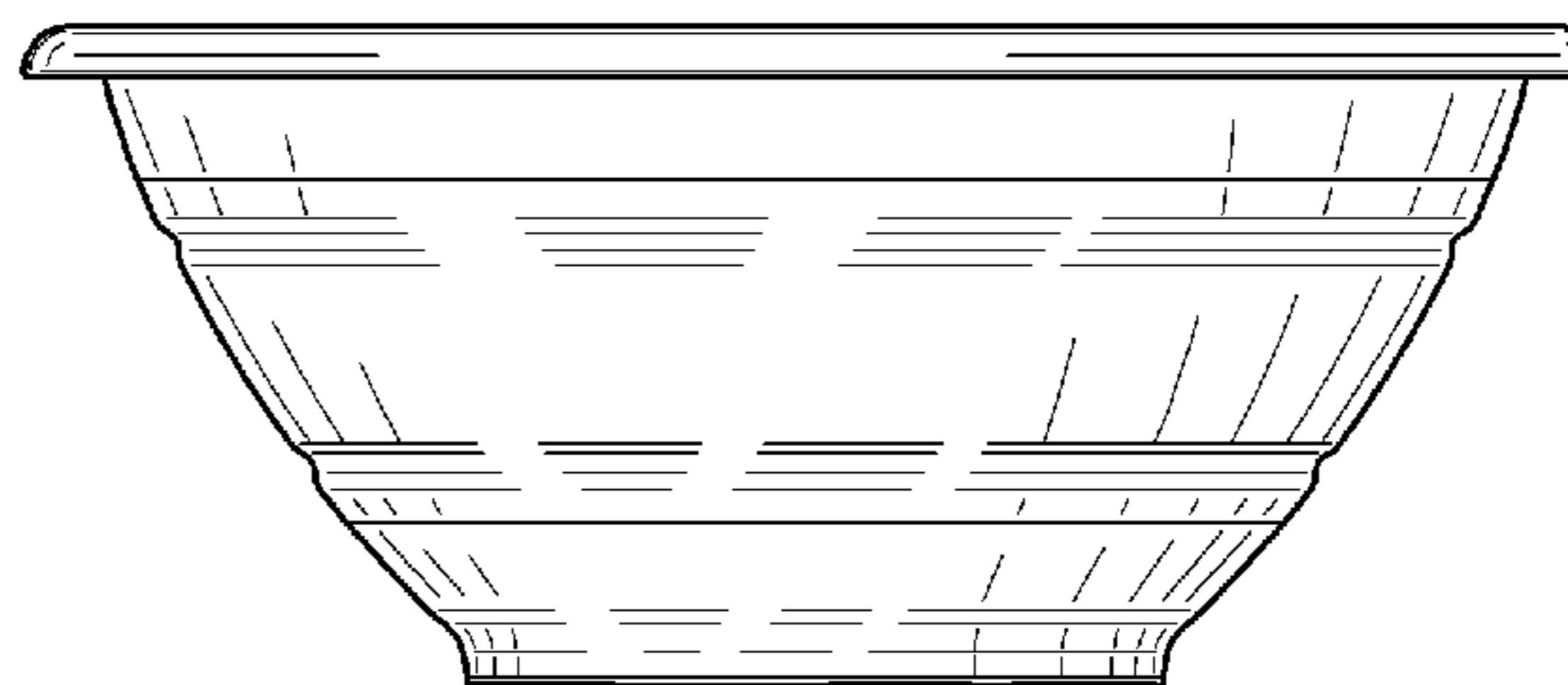
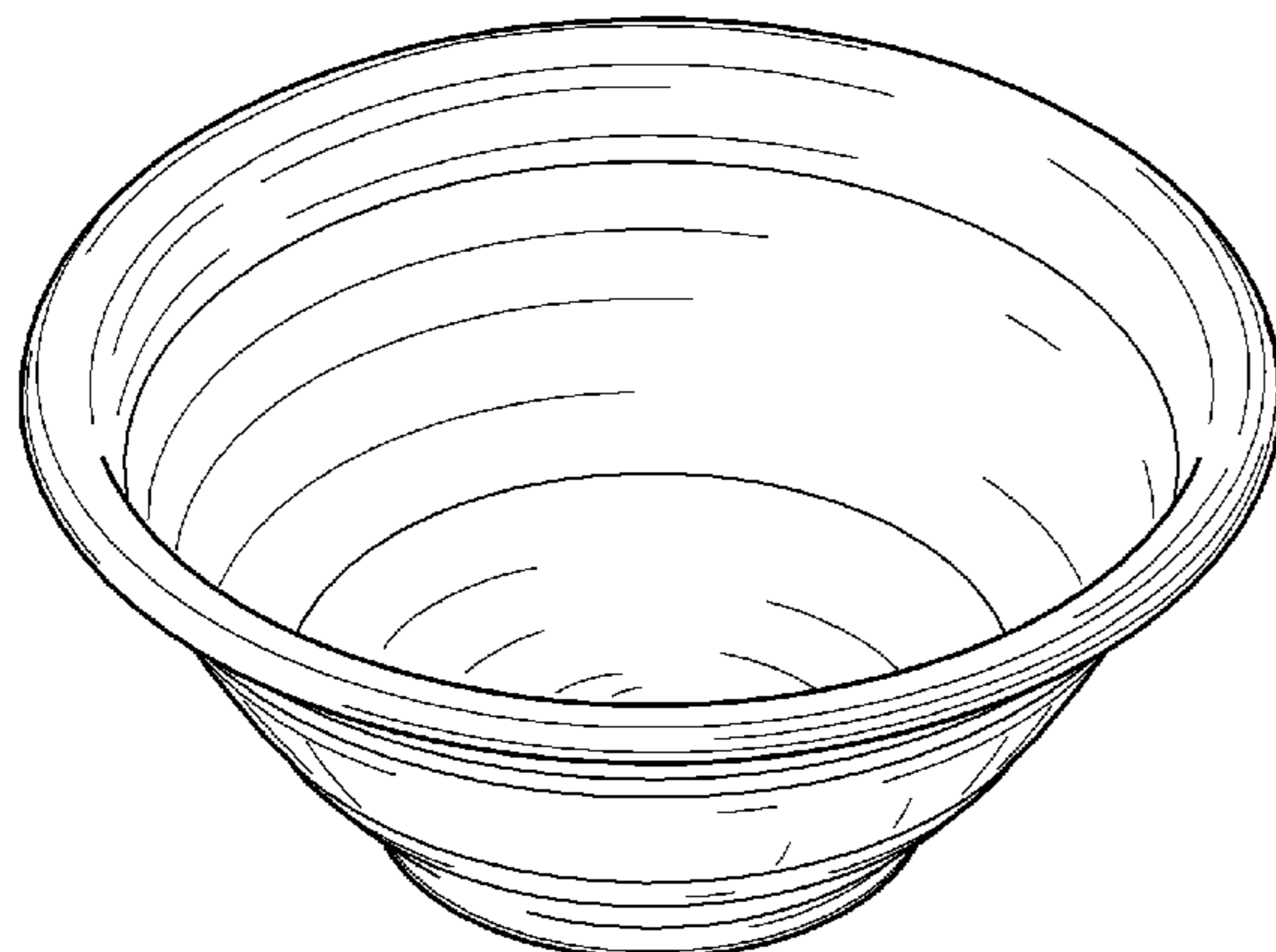
FIG. 4 is a bottom view of the collapsible bowl.

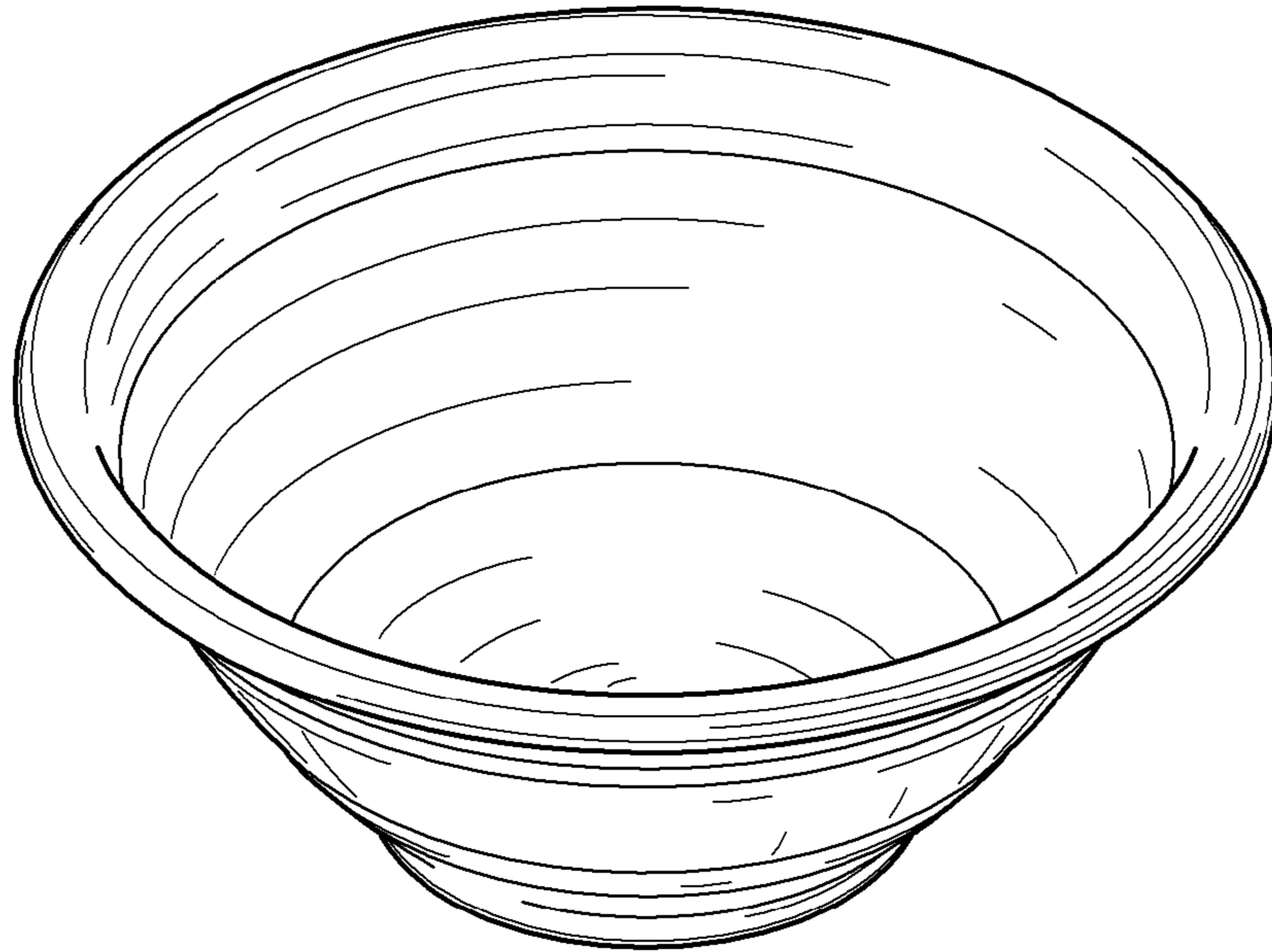

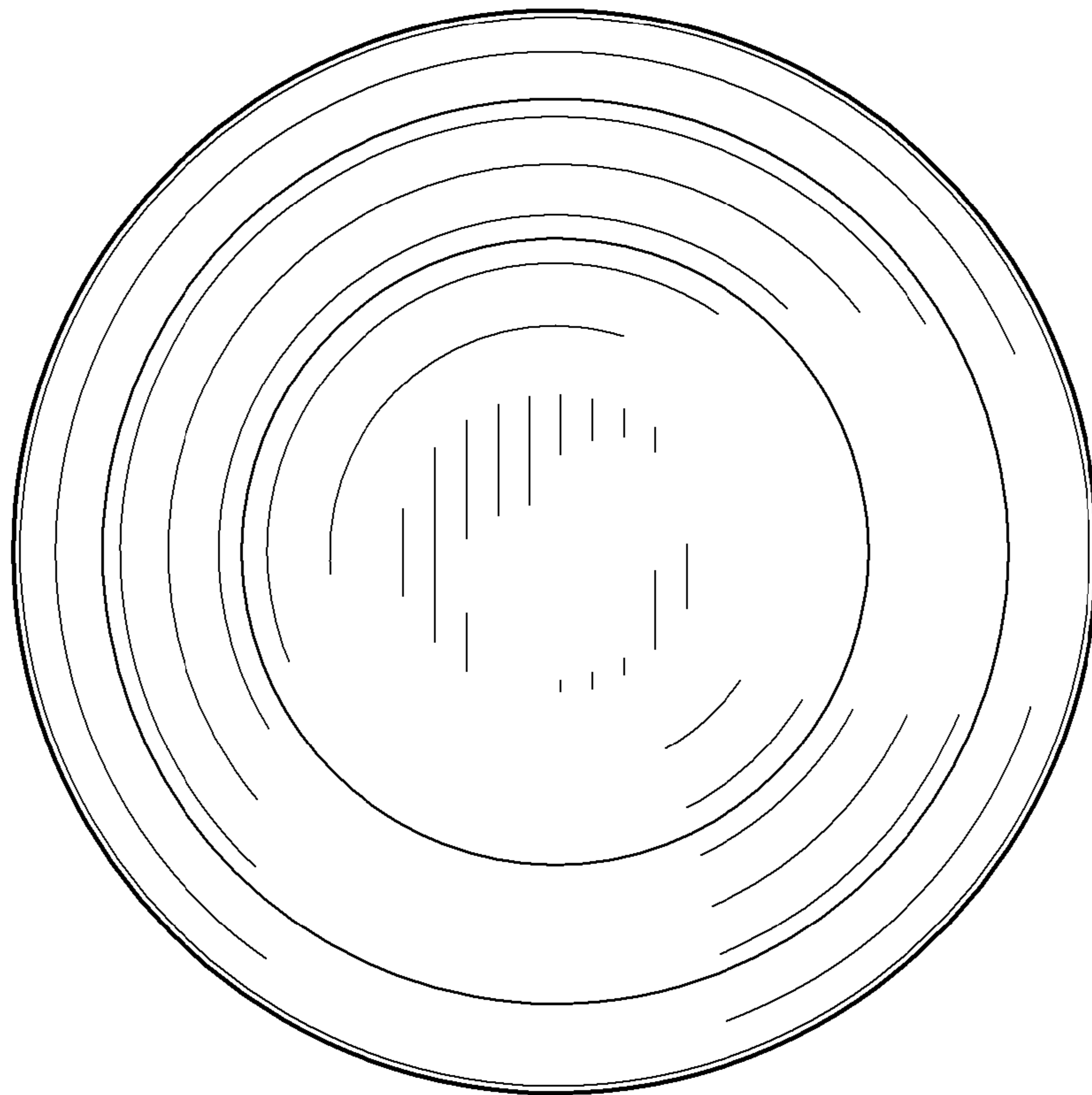

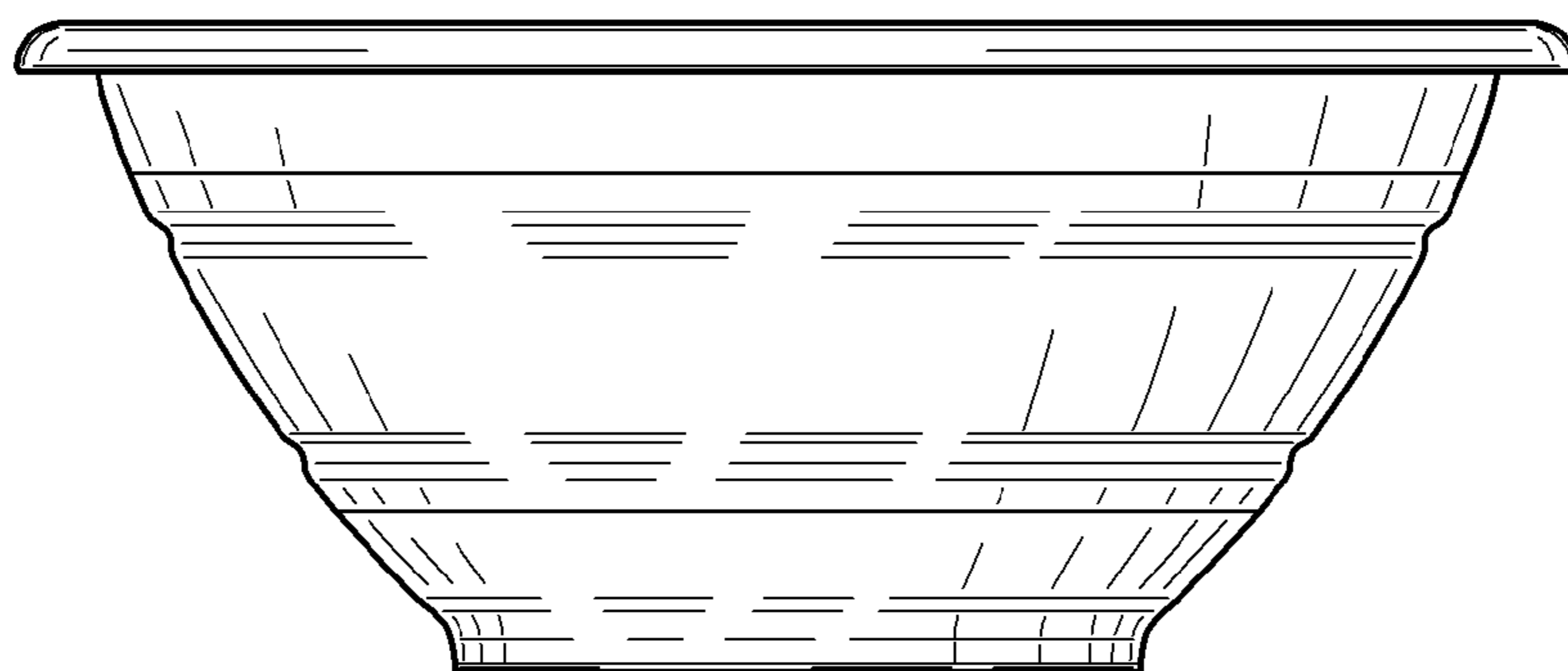

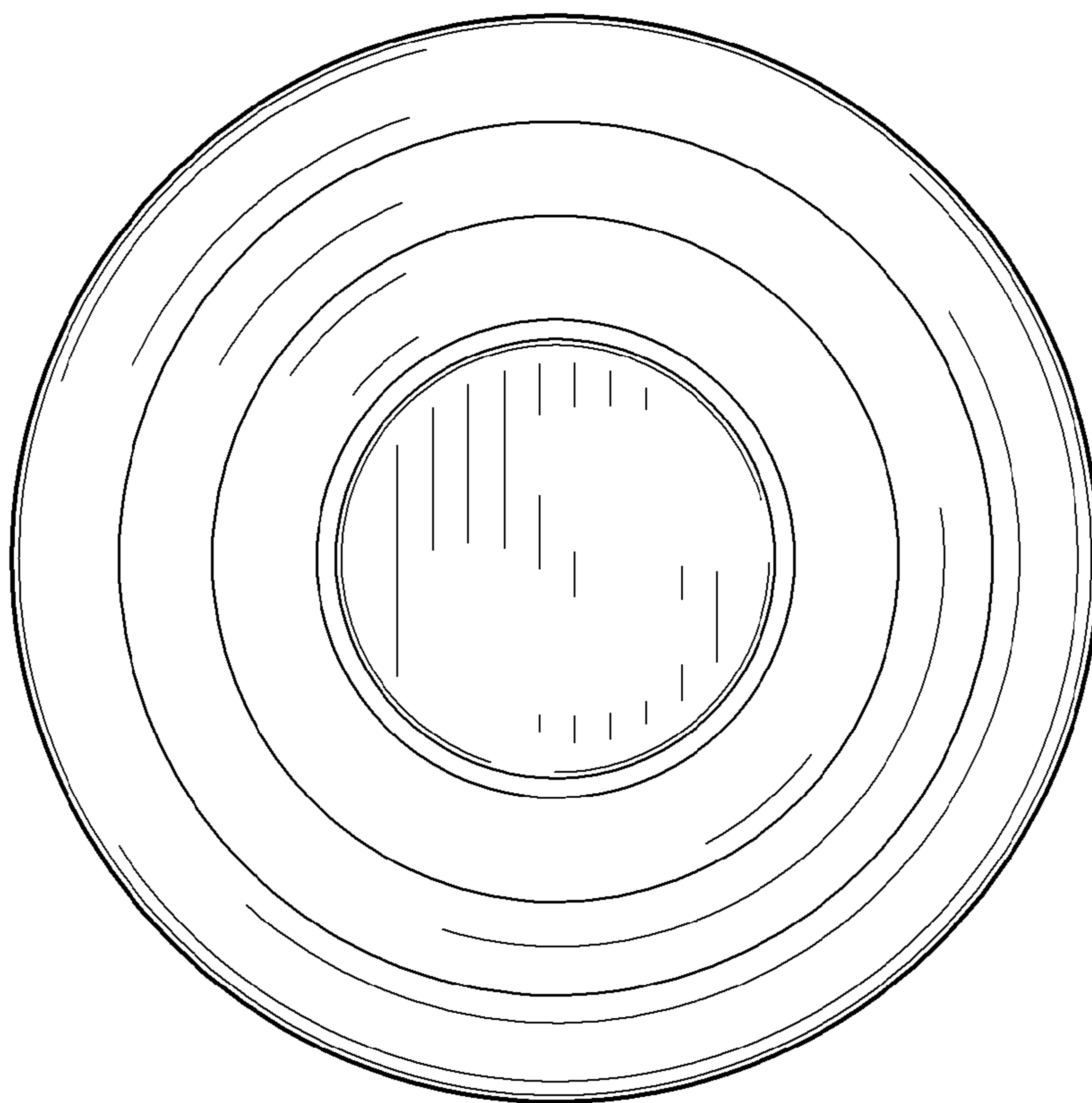
