(57) **CLAIM**

I claim the ornamental design for a pliers head, as shown and described.

DESCRIPTION

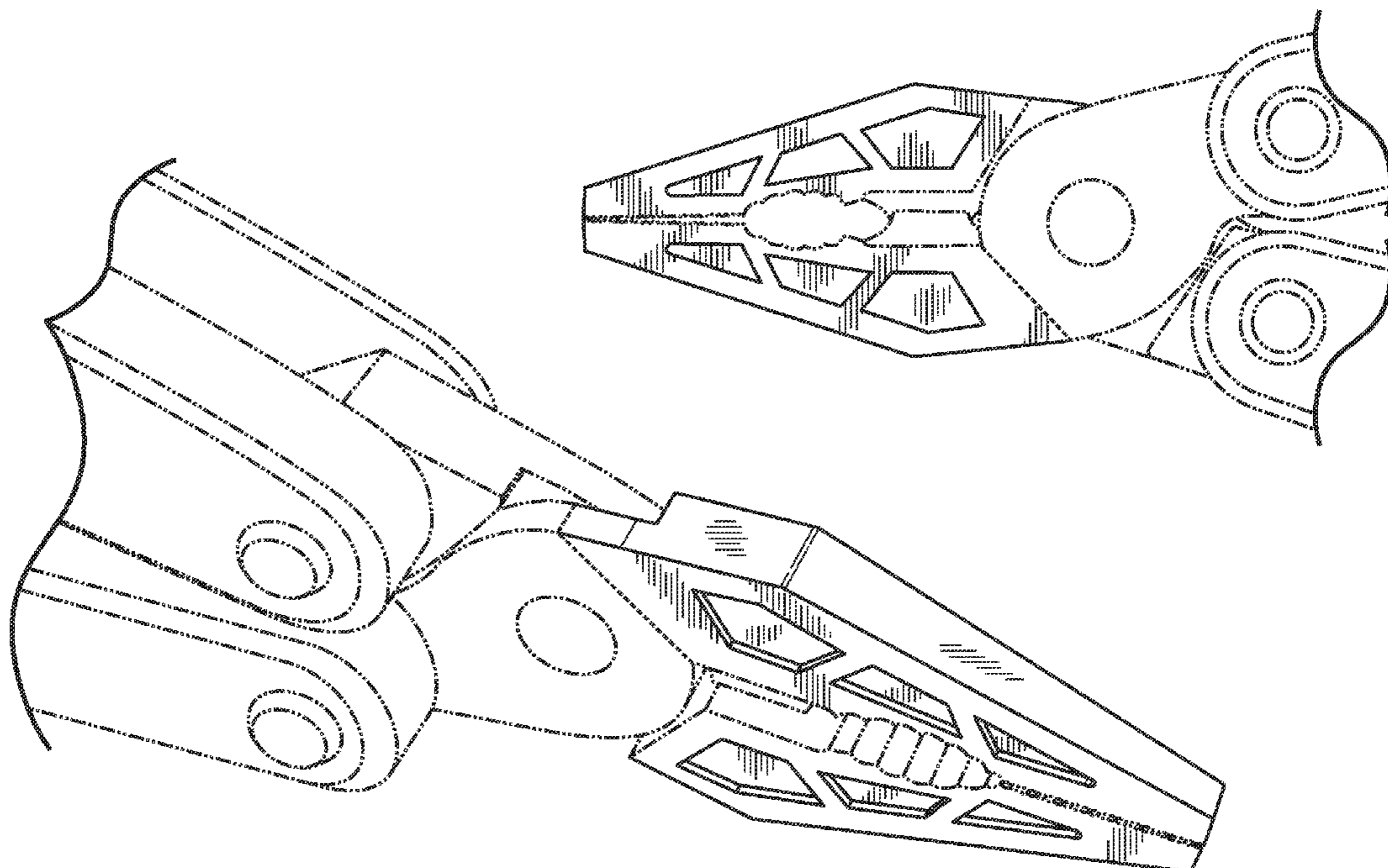
FIG. 1 is a perspective view of a pliers head, showing the front and left side of the pliers head; and,

FIG. 2 is a front elevation view of the pliers head of FIG. 1.

The evenly-spaced broken lines illustrate the bounds of the claimed design and form no part thereof. The unevenly-spaced broken lines illustrate unclaimed portions of the pliers head and form no part of the claimed design.

The shading lines shown in the drawings represent the approximate three-dimensional contour of the design, and are not intended to indicate surface decoration.

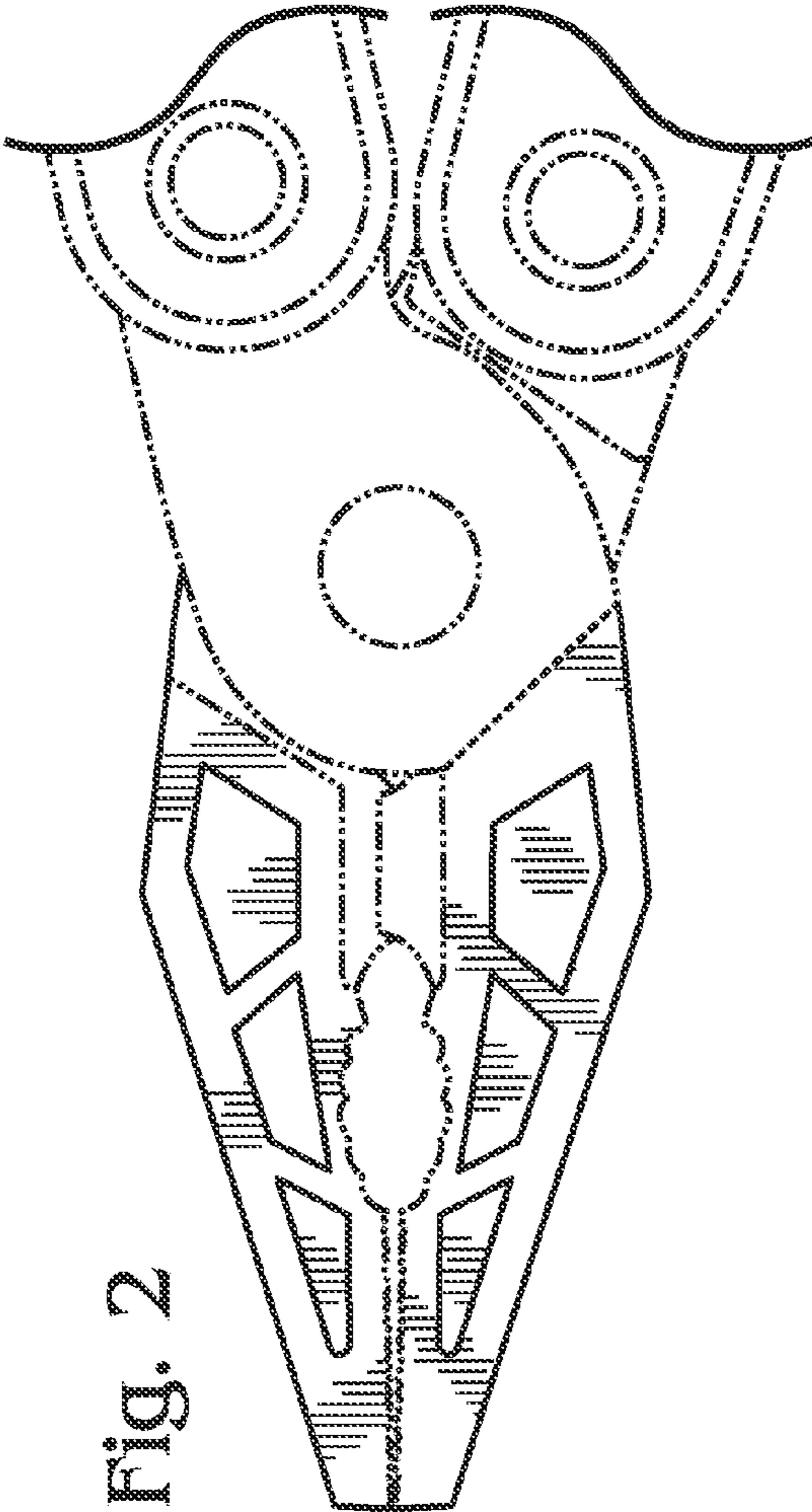

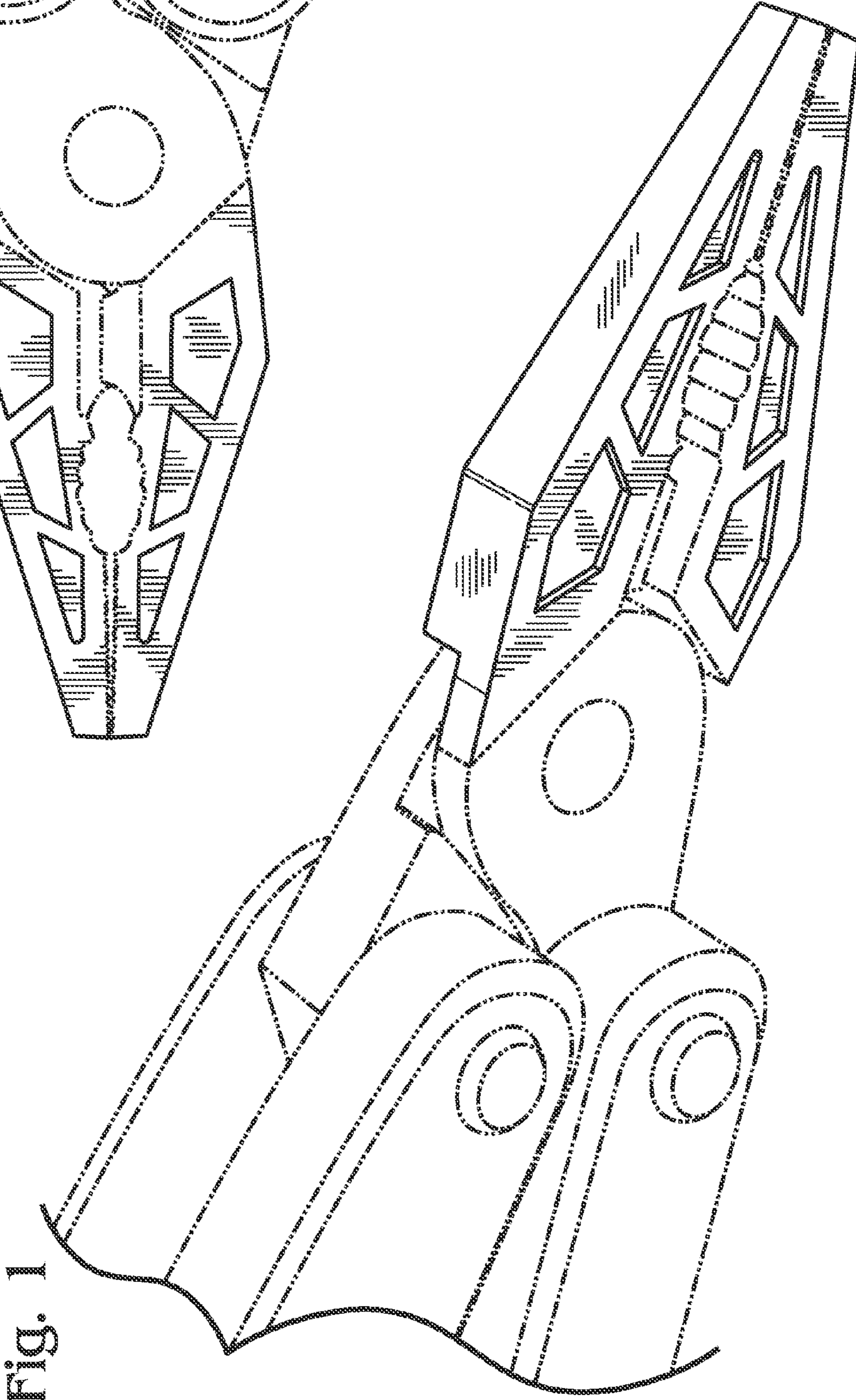
