FIG. 1 is a bottom perspective view of a plastic bottle showing our new design;

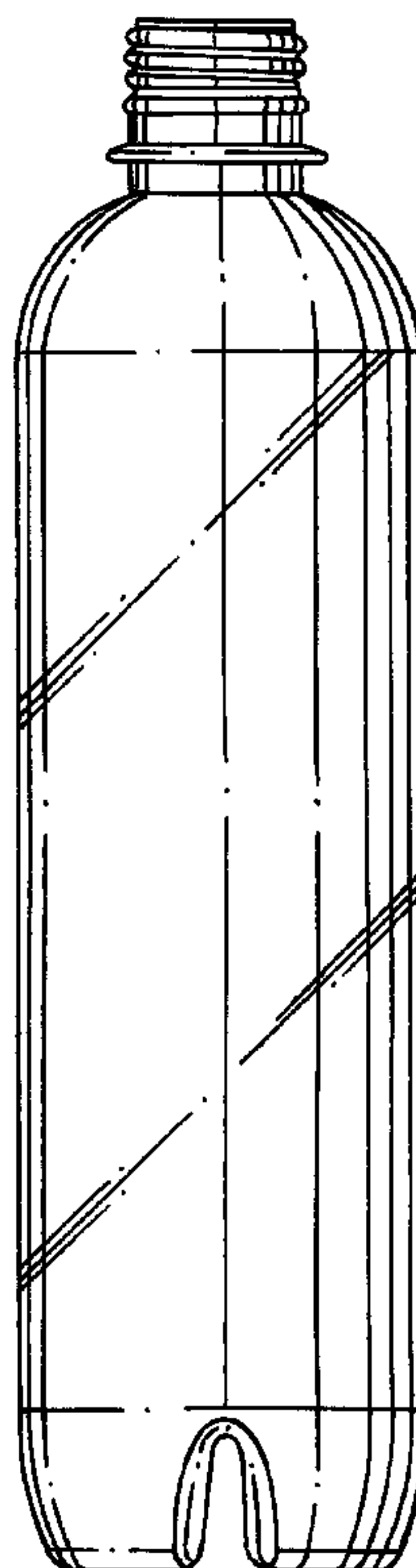
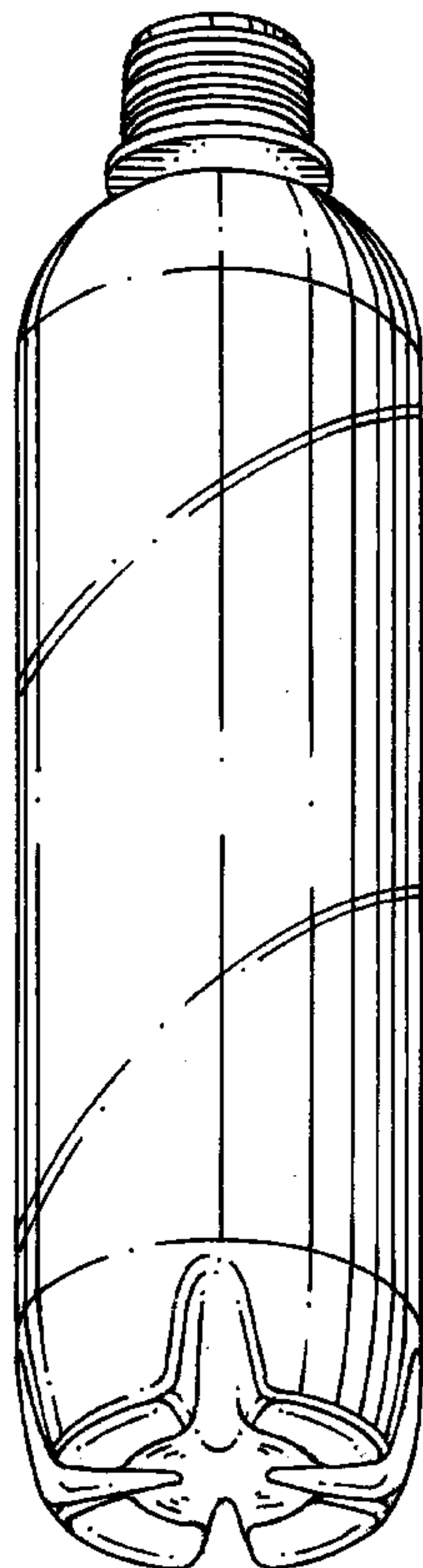
FIG. 2 is a top plan view thereof;

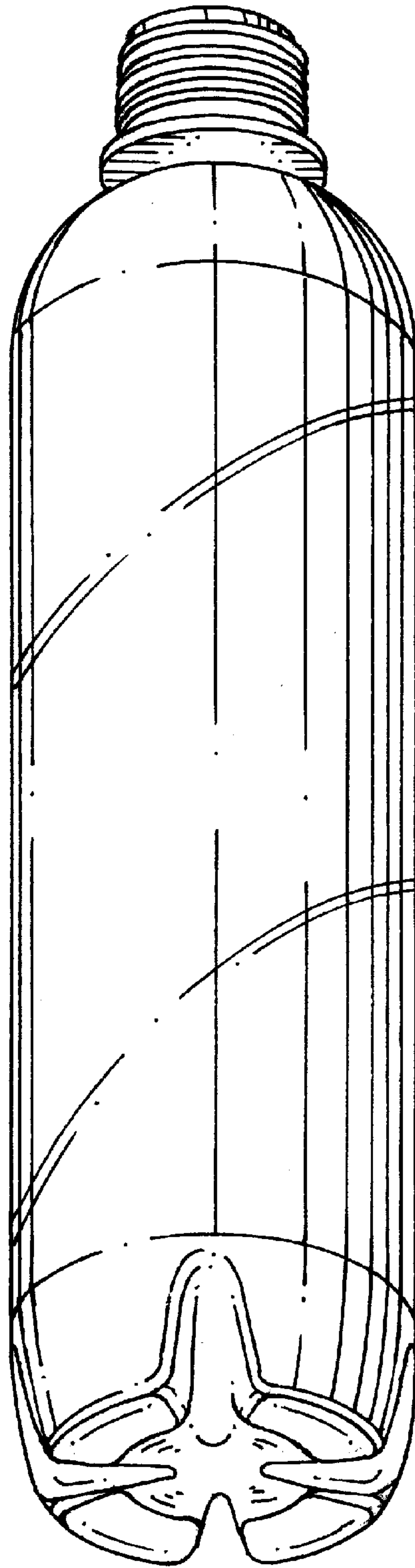

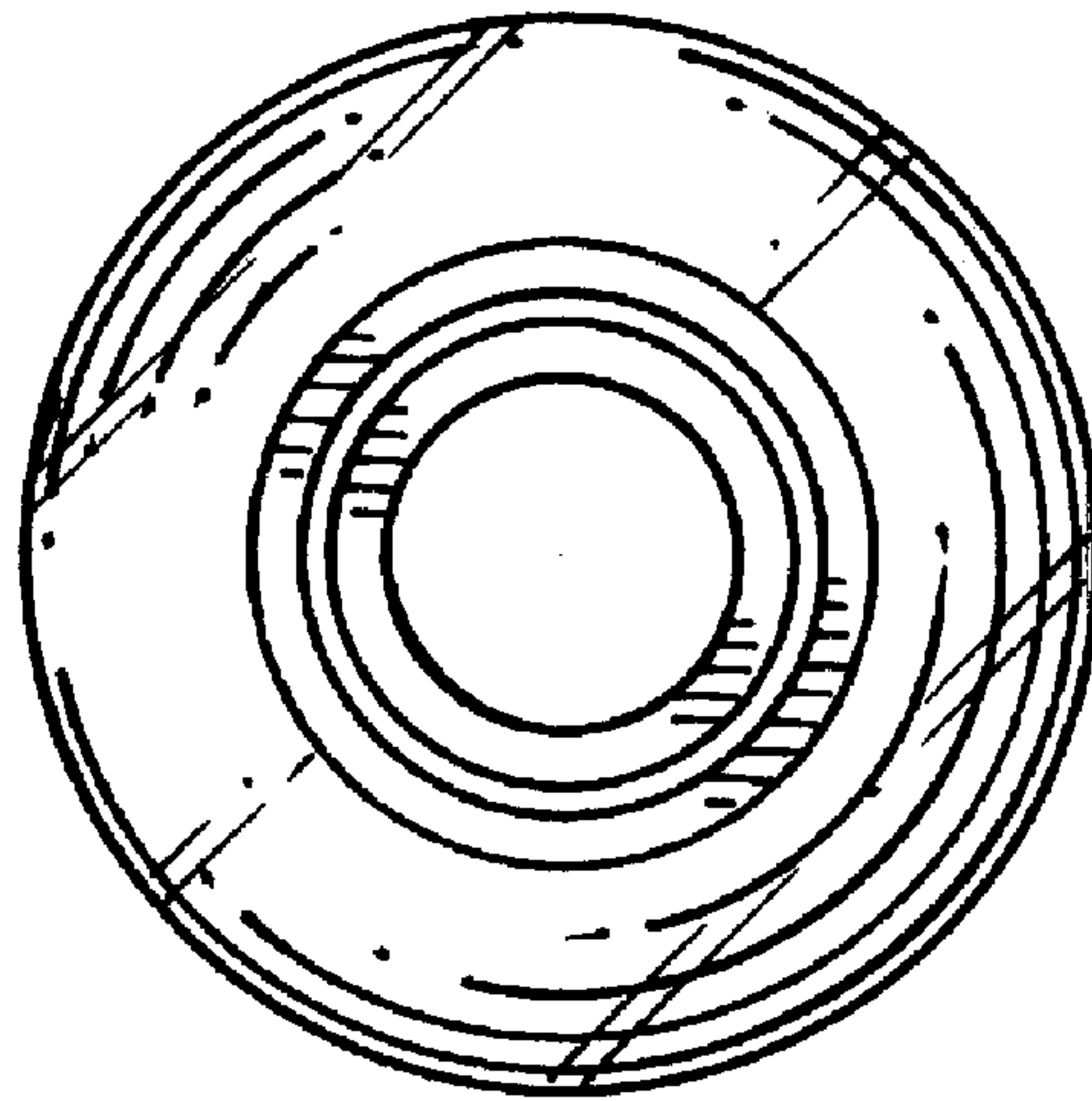
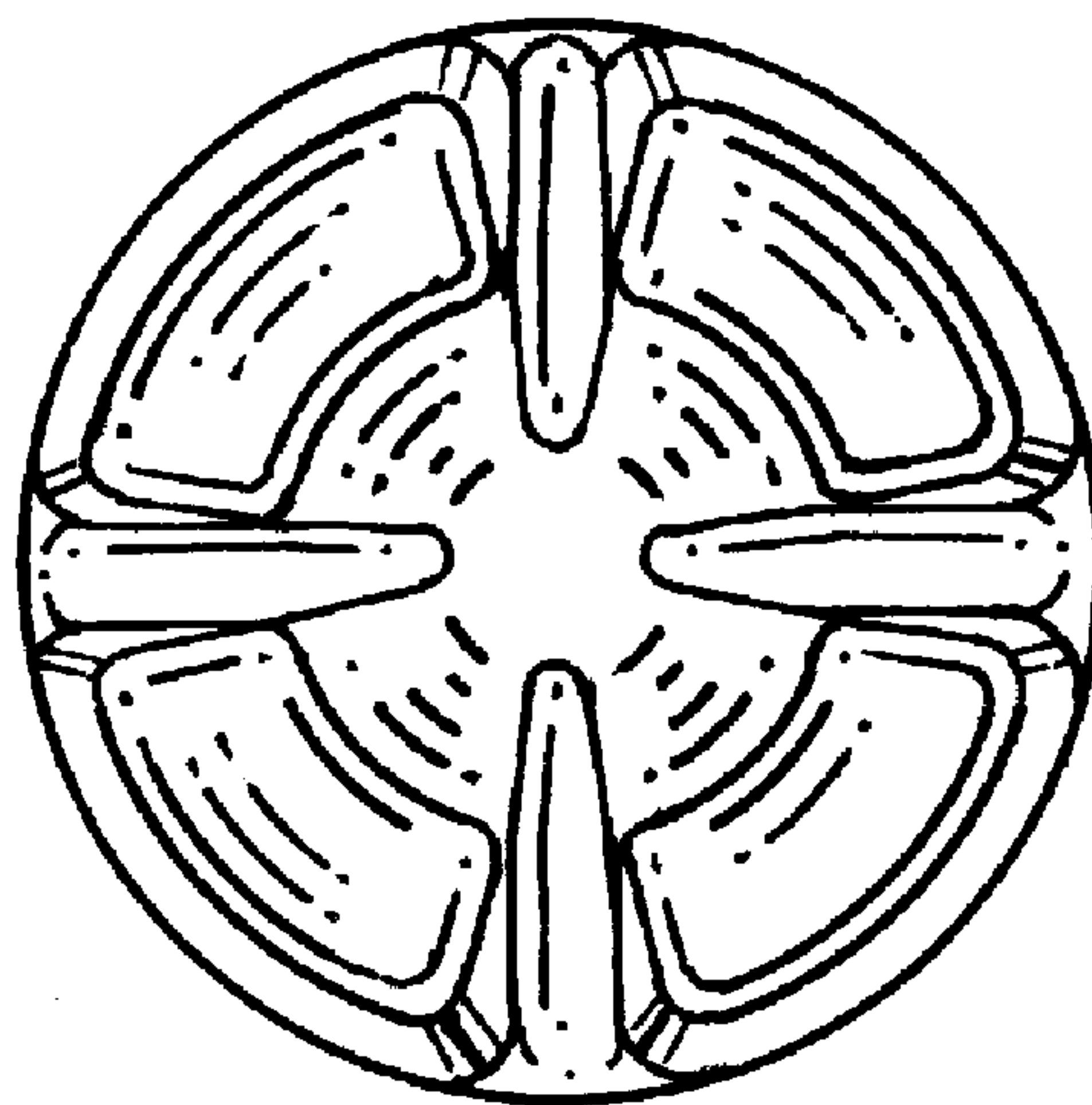

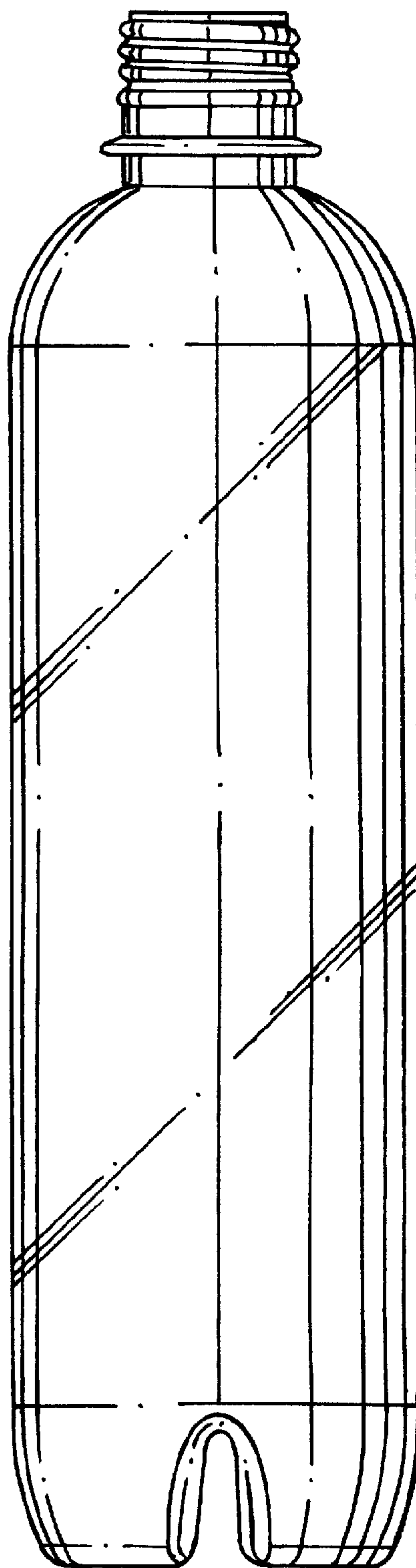
