FIG. 4 is a rear view of the gemstone setting;

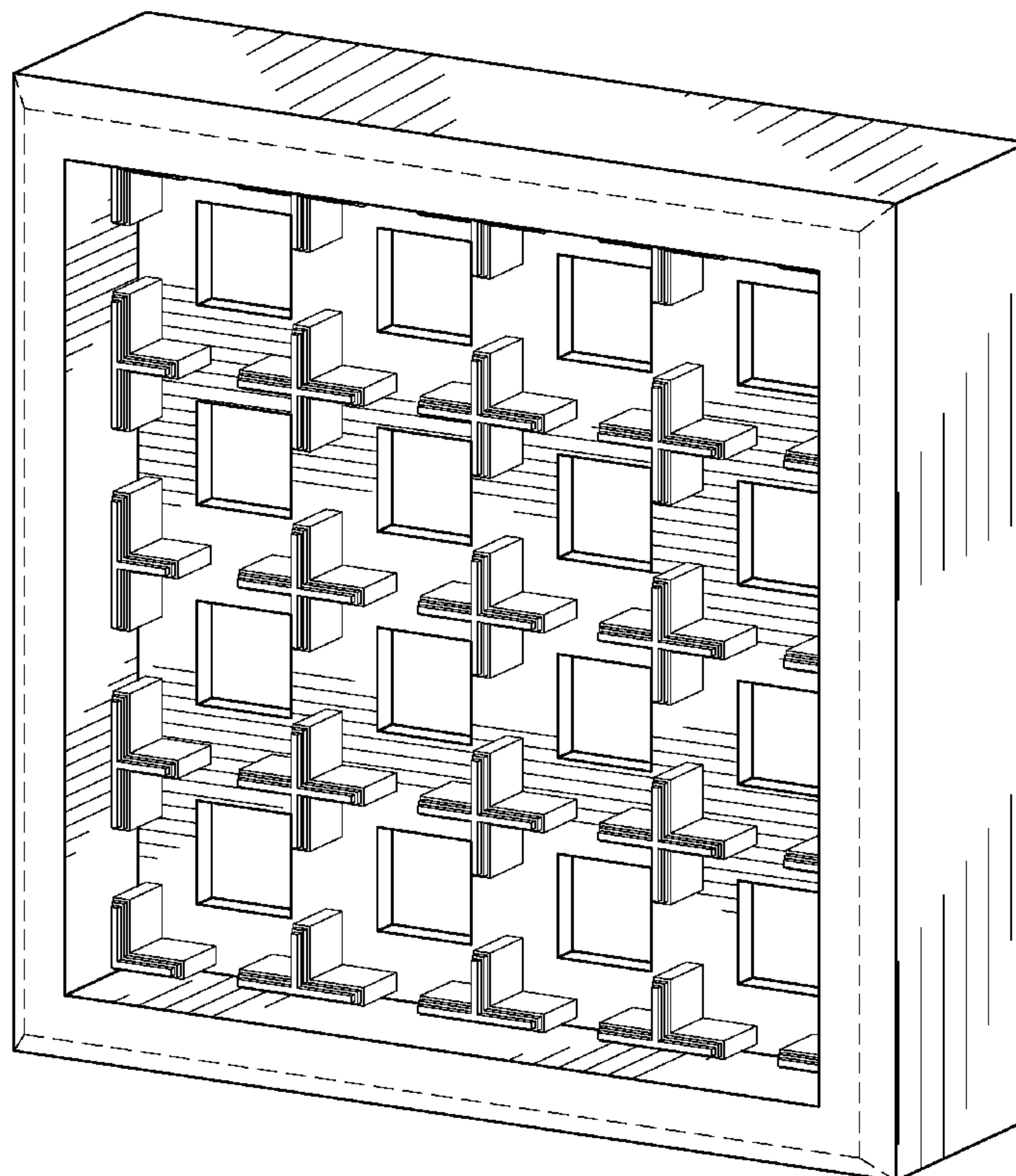
FIG. 5 is a top view of the gemstone setting;

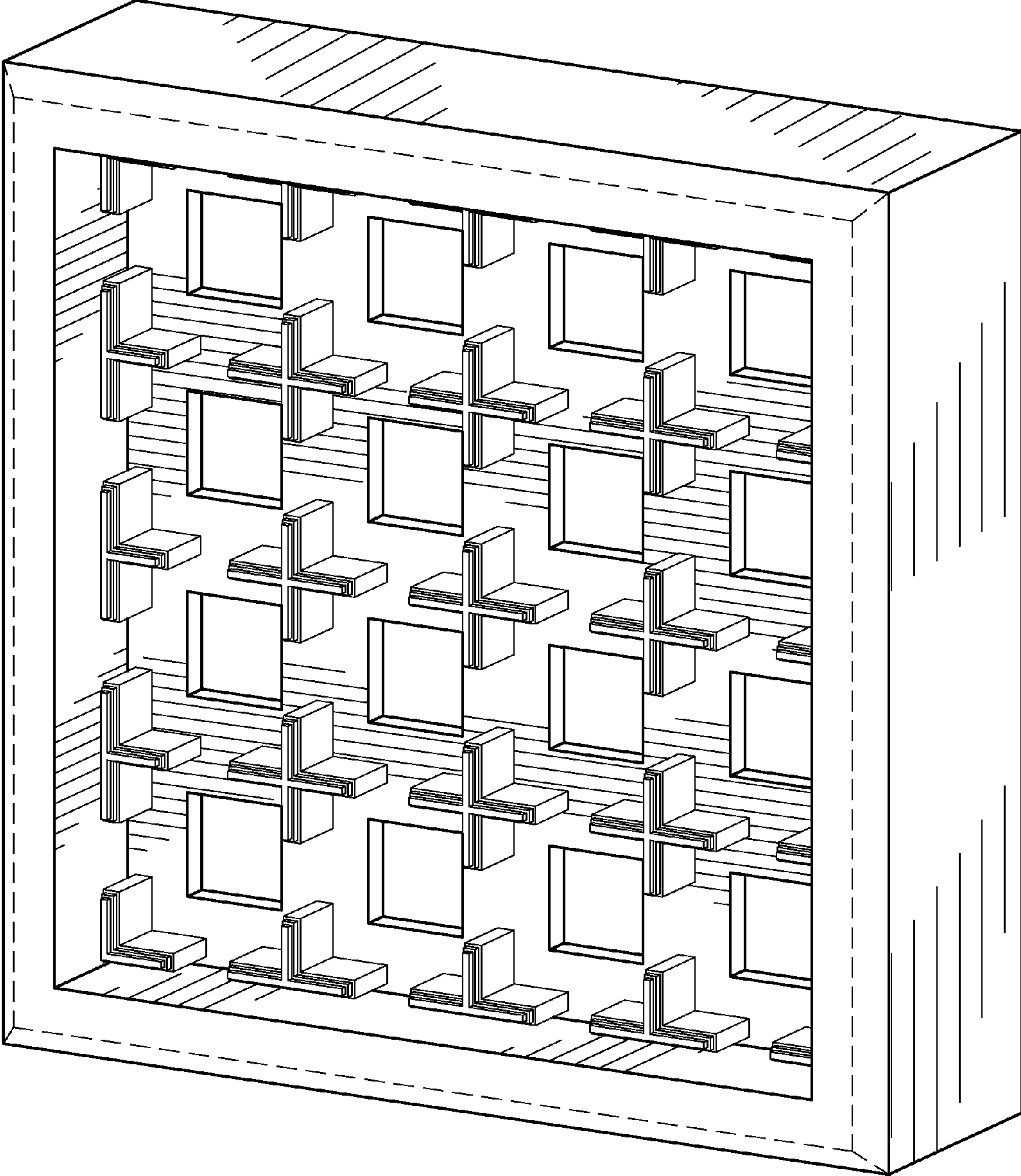

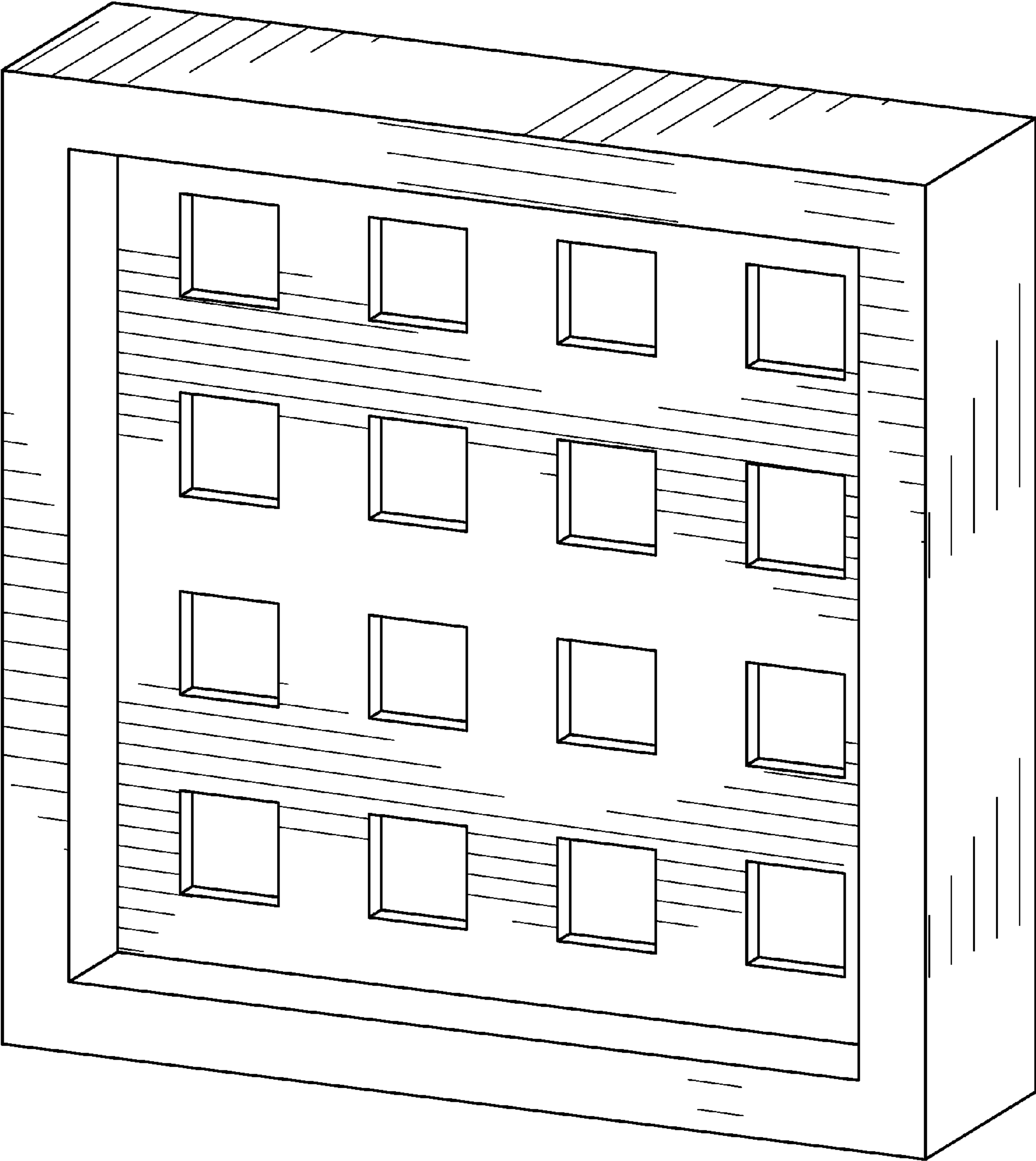

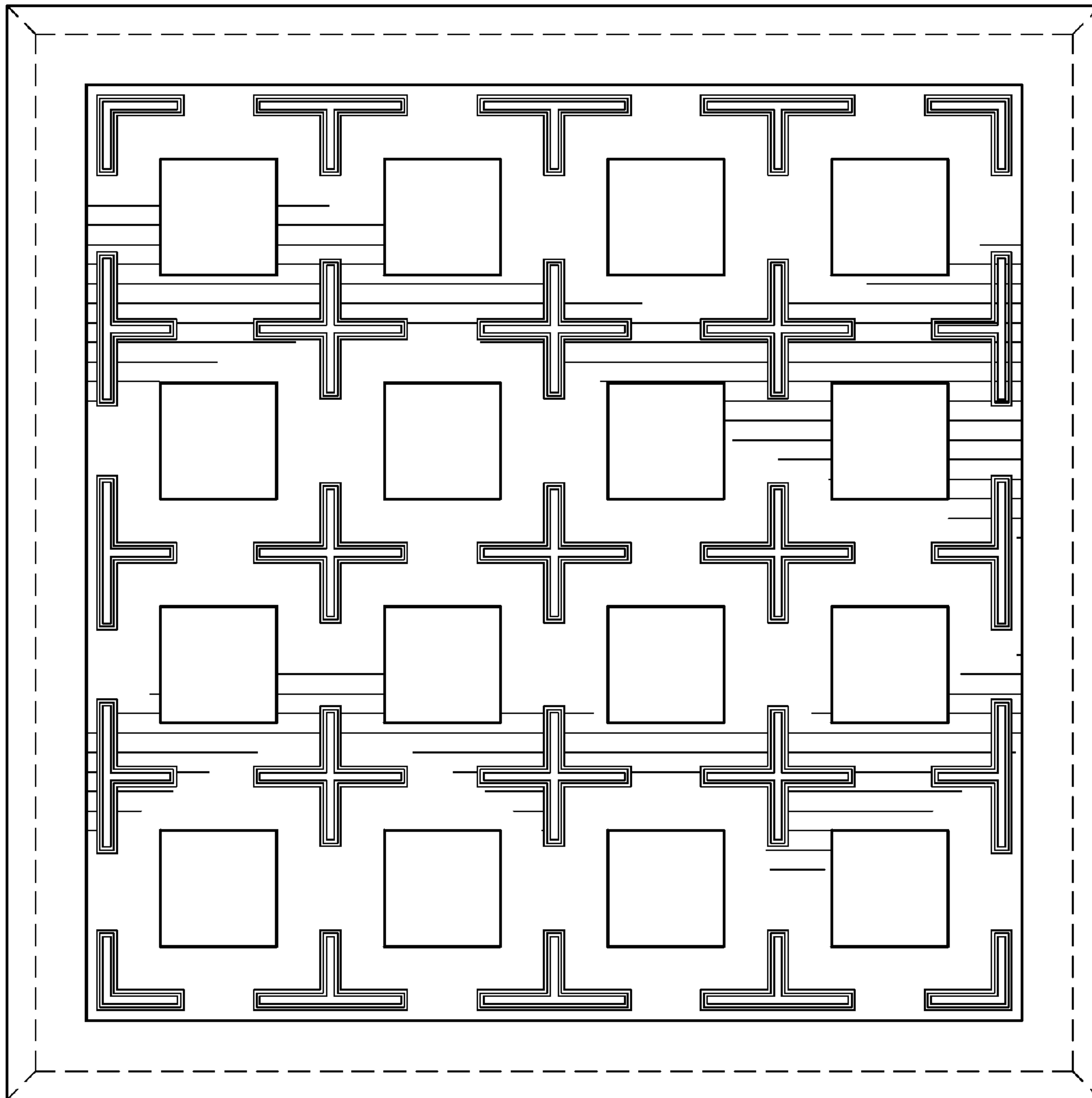

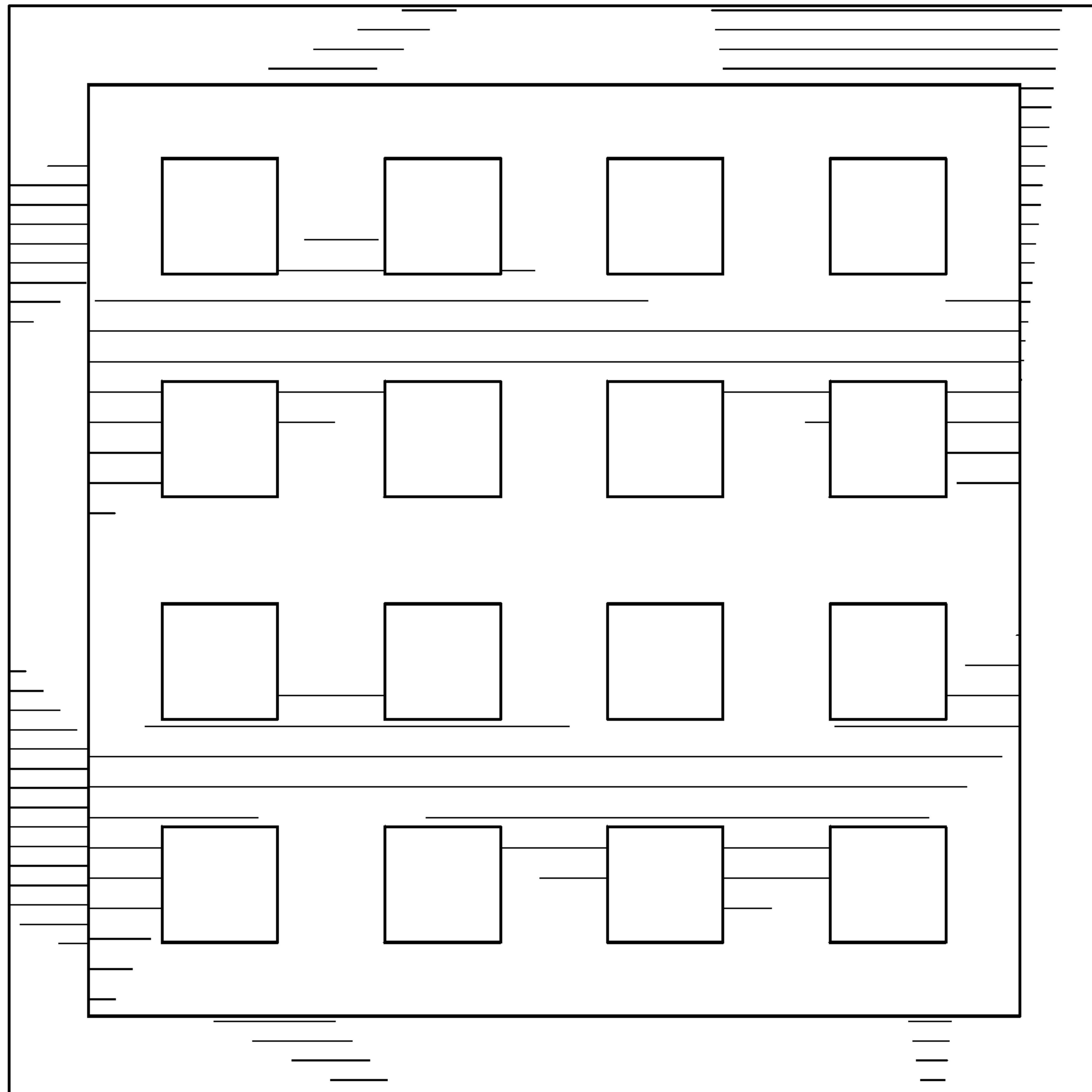

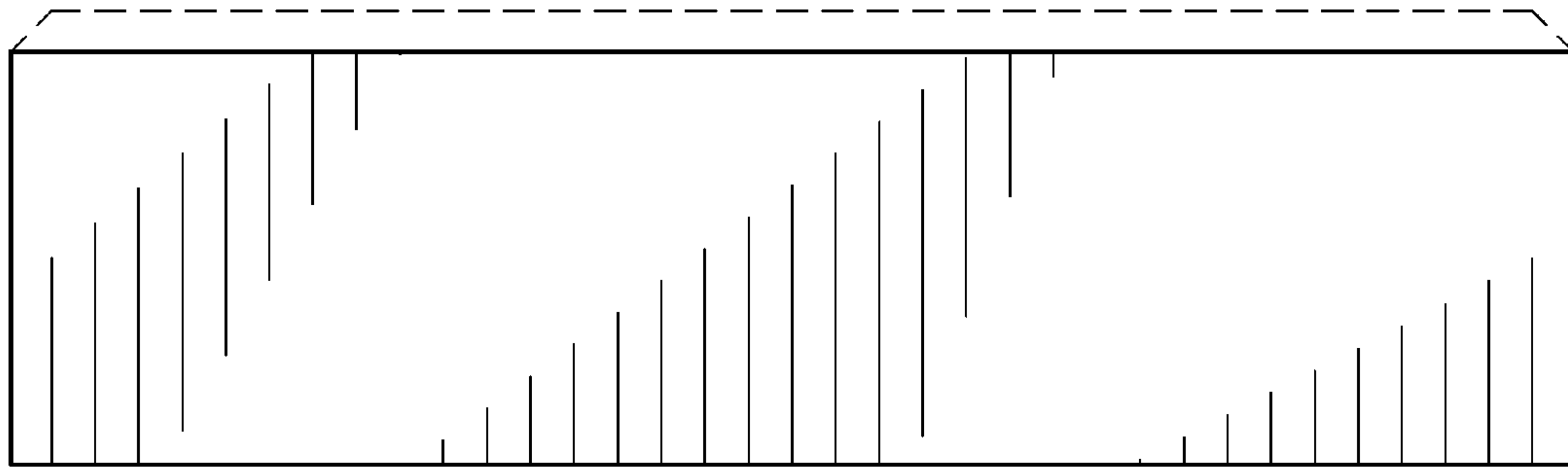

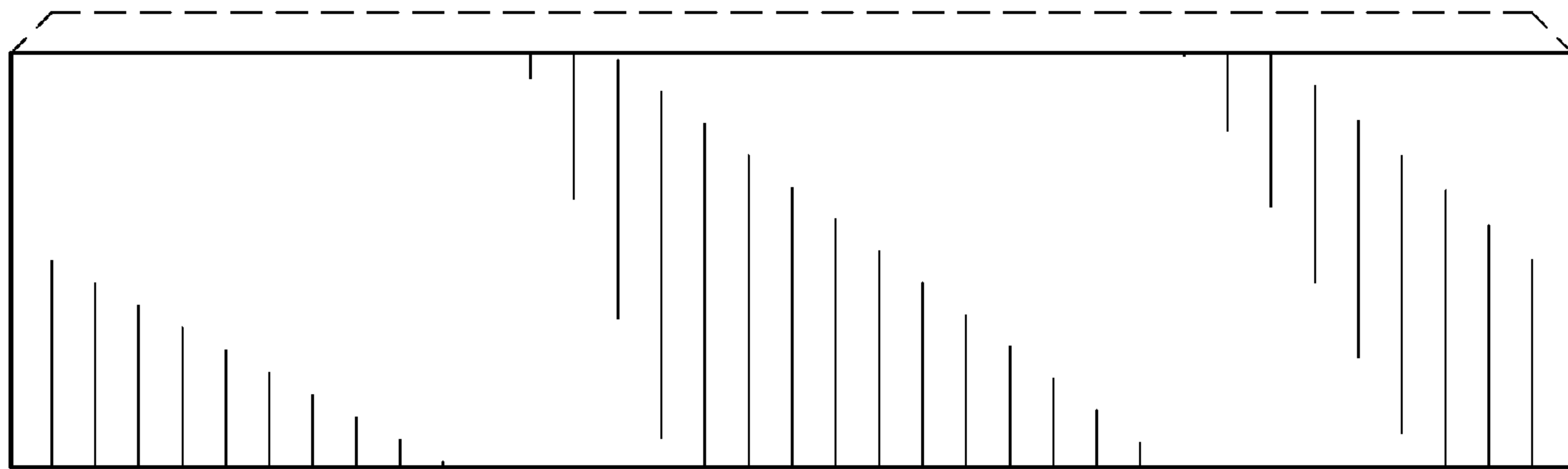

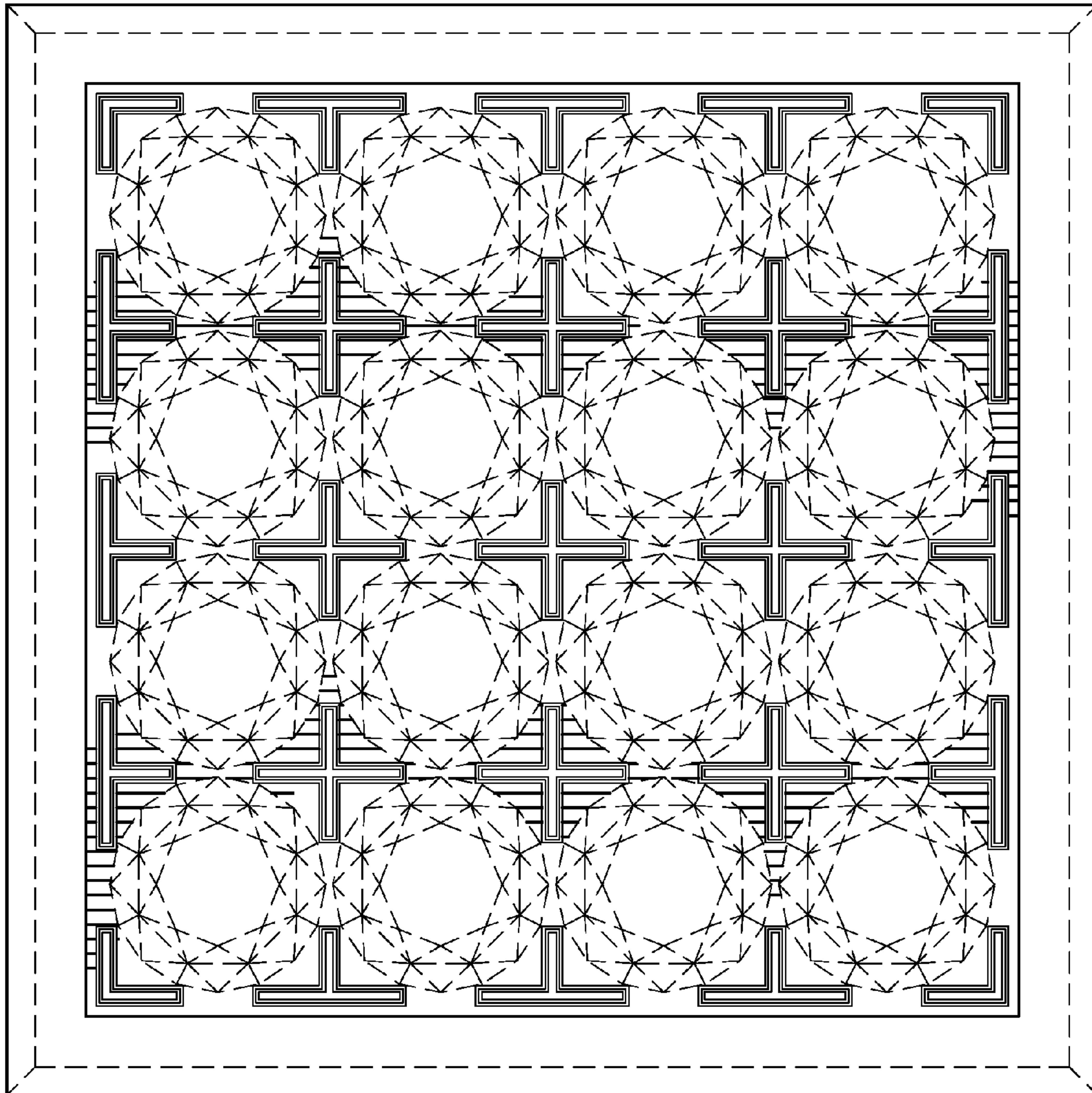

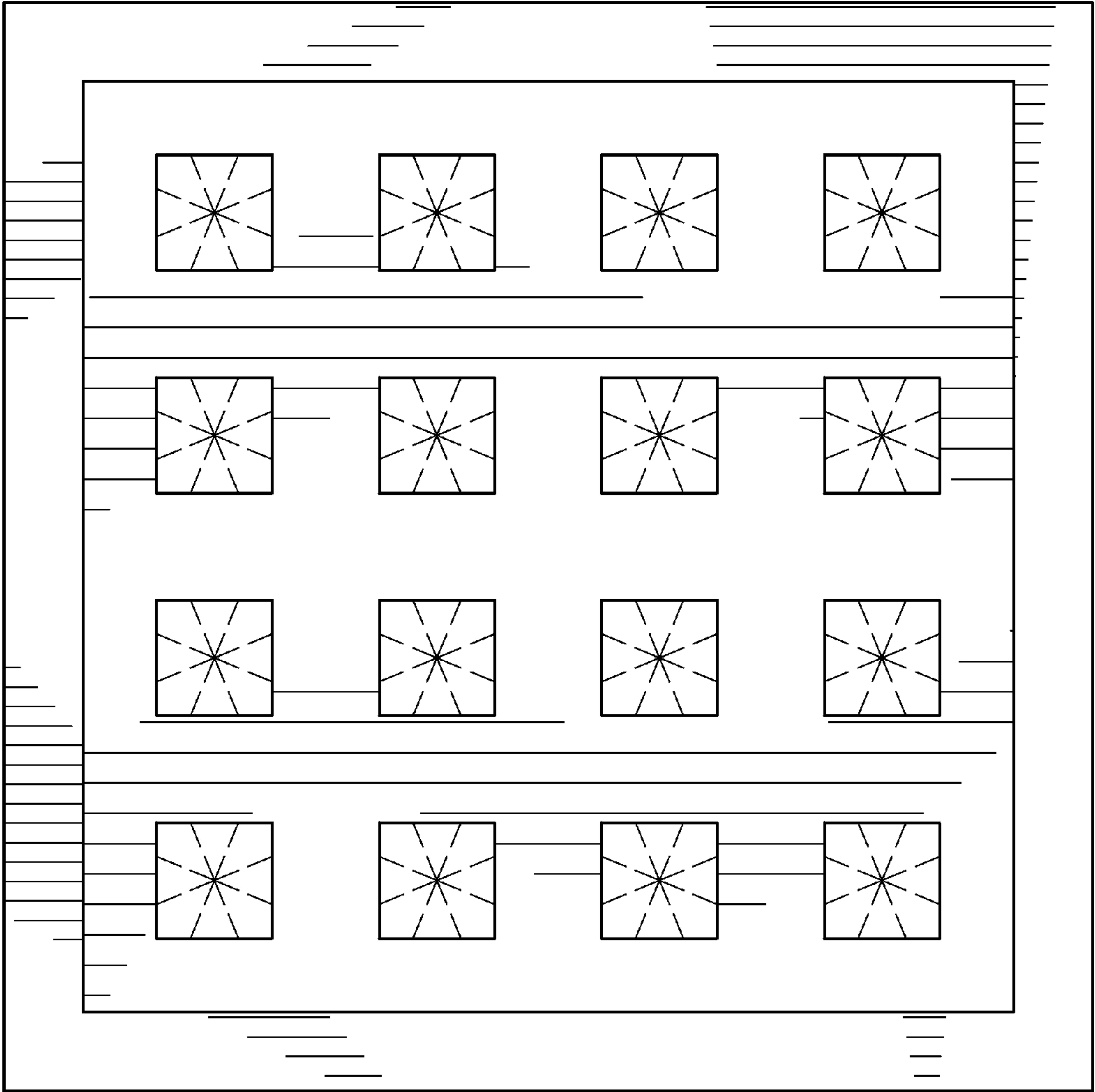
