The ornamental design for a graphical user interface providing annotated alerts on dynamically generated charts for a display screen, as shown and described.

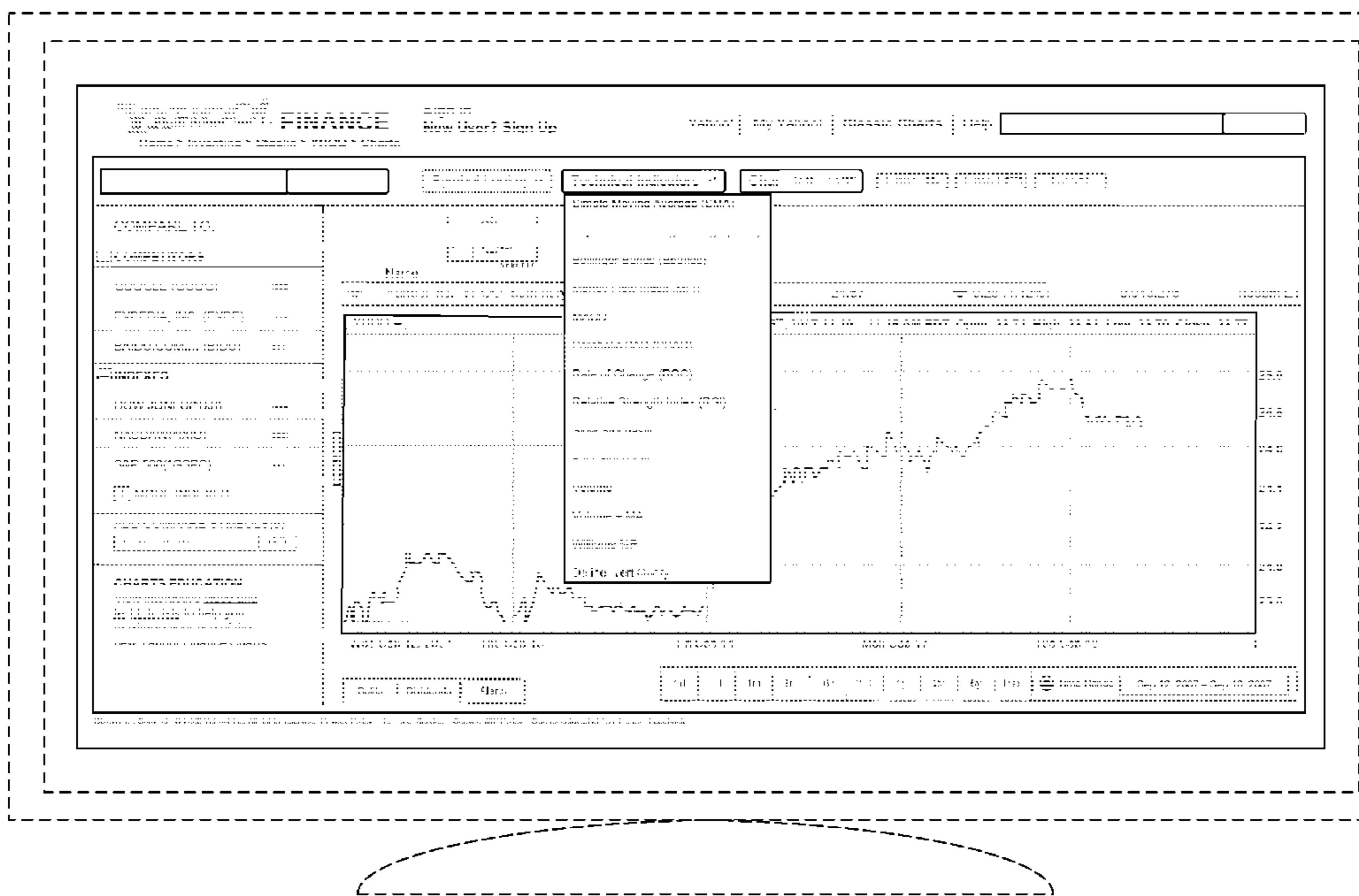
DESCRIPTION

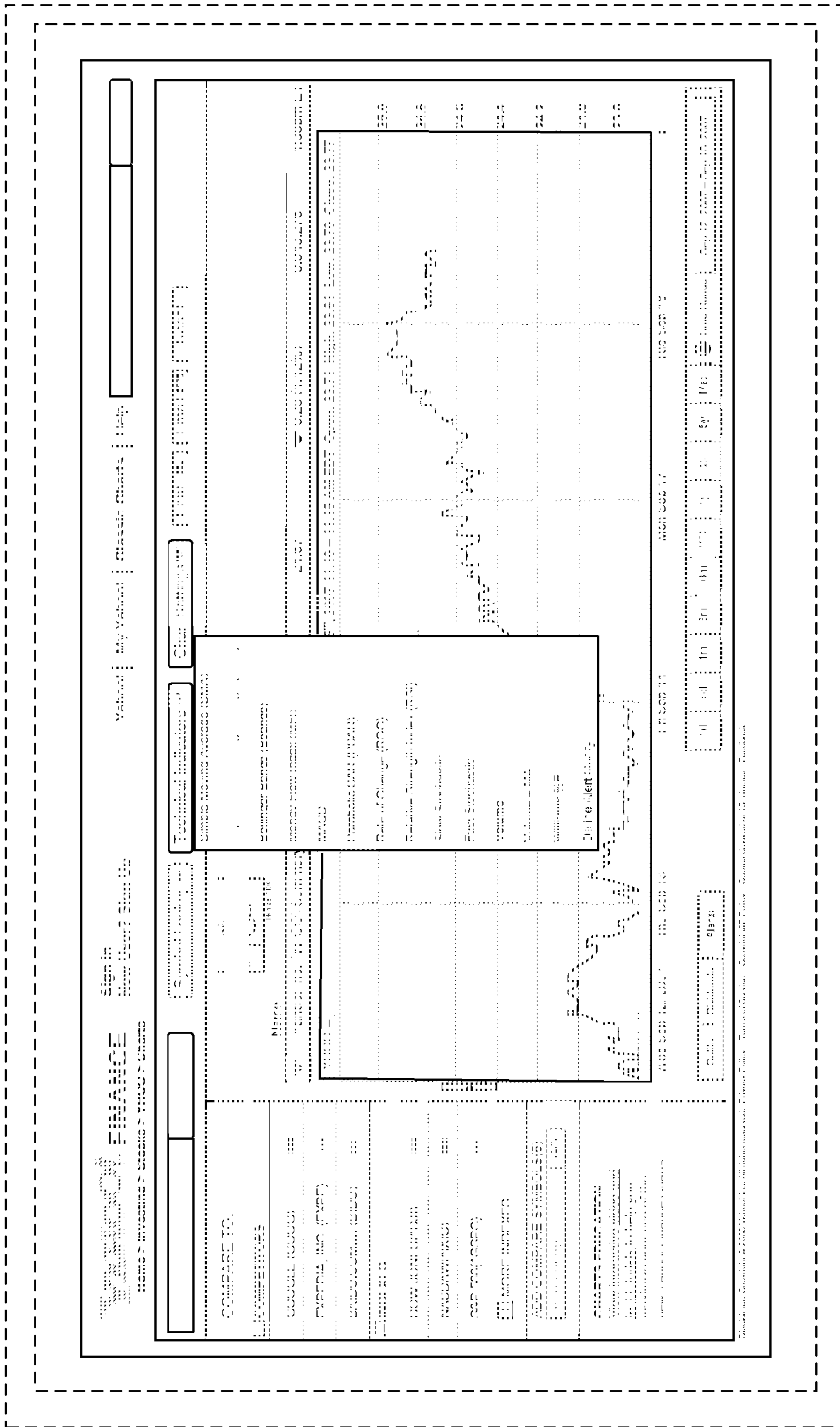
