(57) **CLAIM**

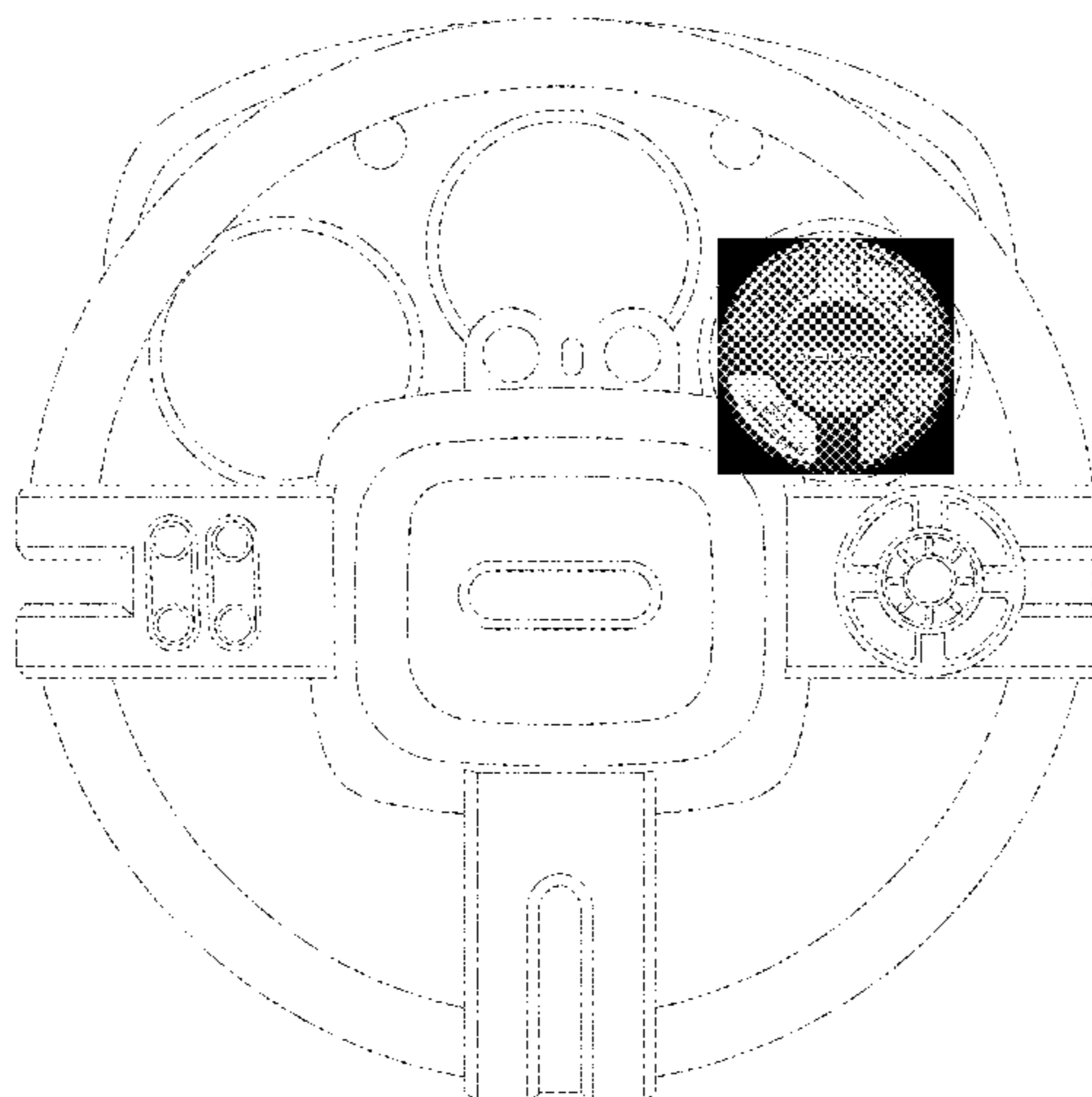
An ornamental design for a display panel with a computer icon of an instrument gauge of a vehicle, as shown and described.

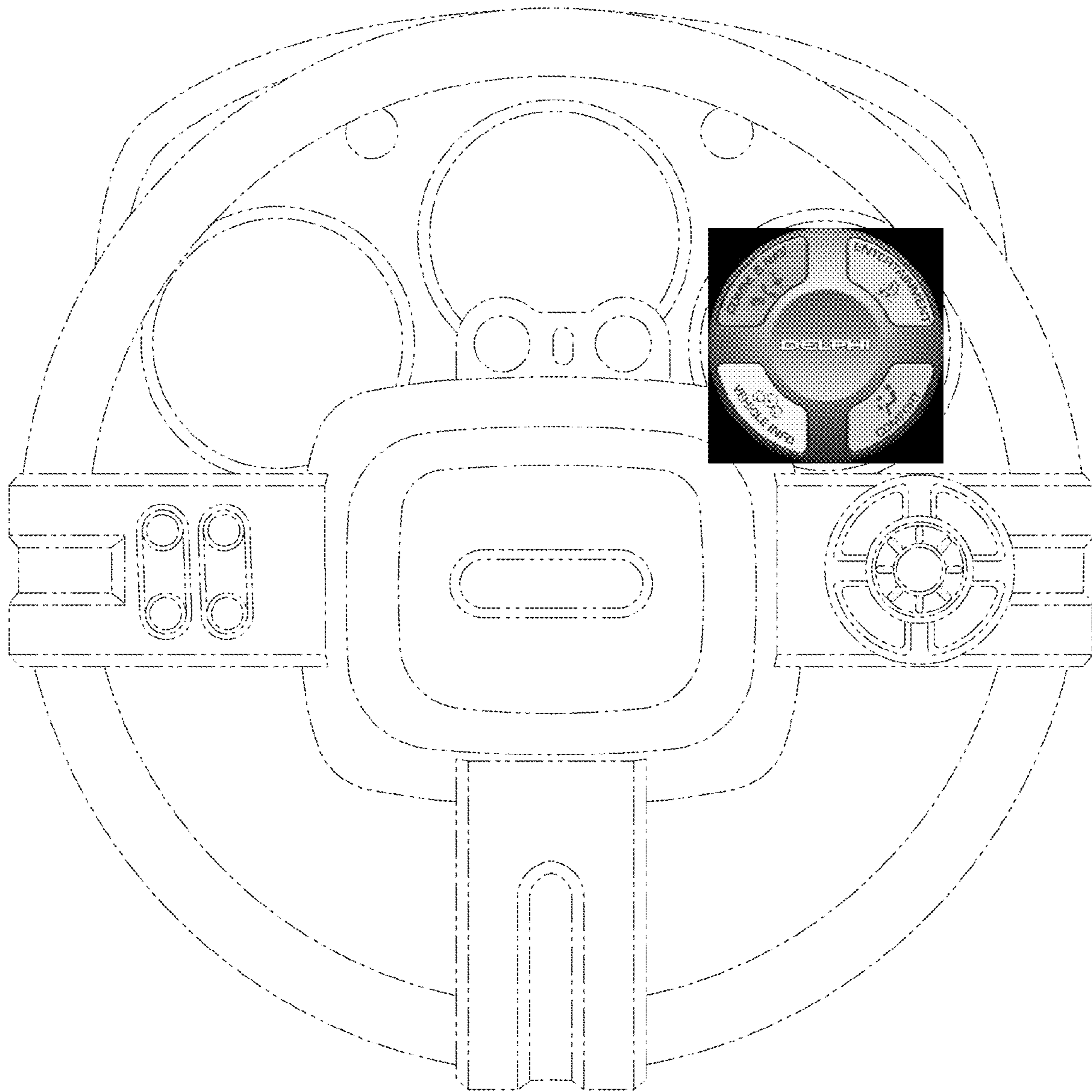

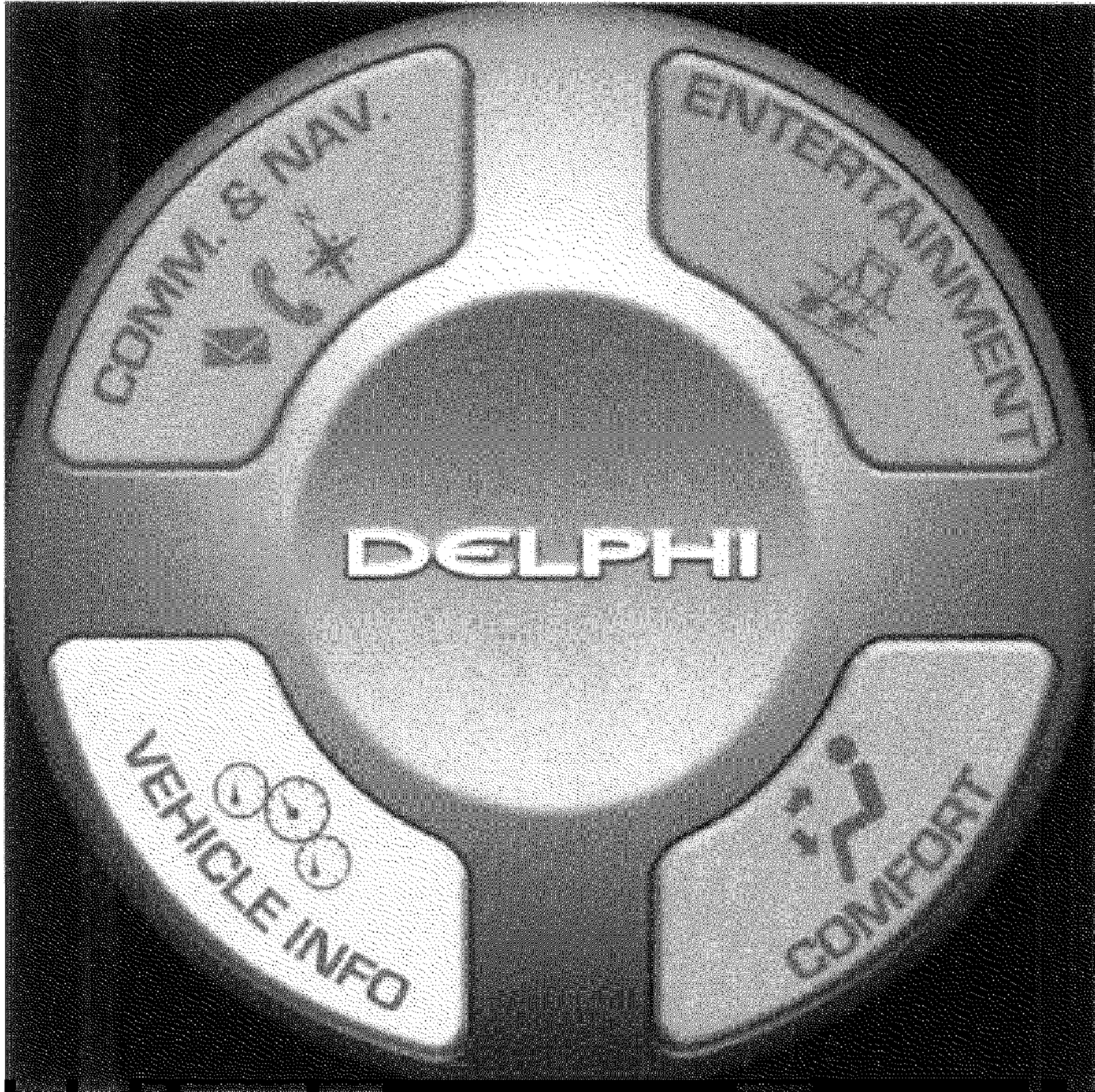
