FIG. 6 is a top view of the design;

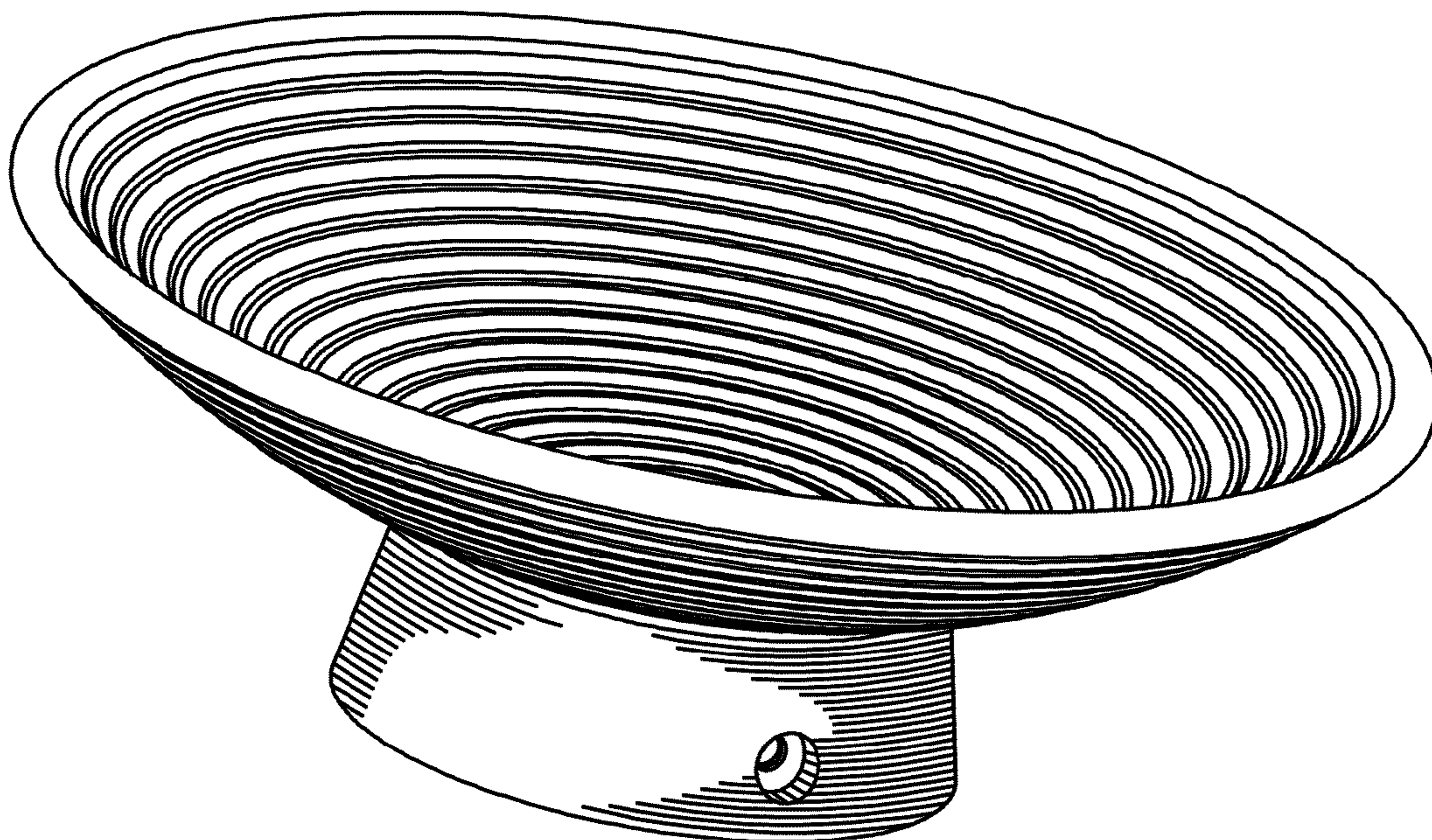
FIG. 7 is a bottom view of the design;

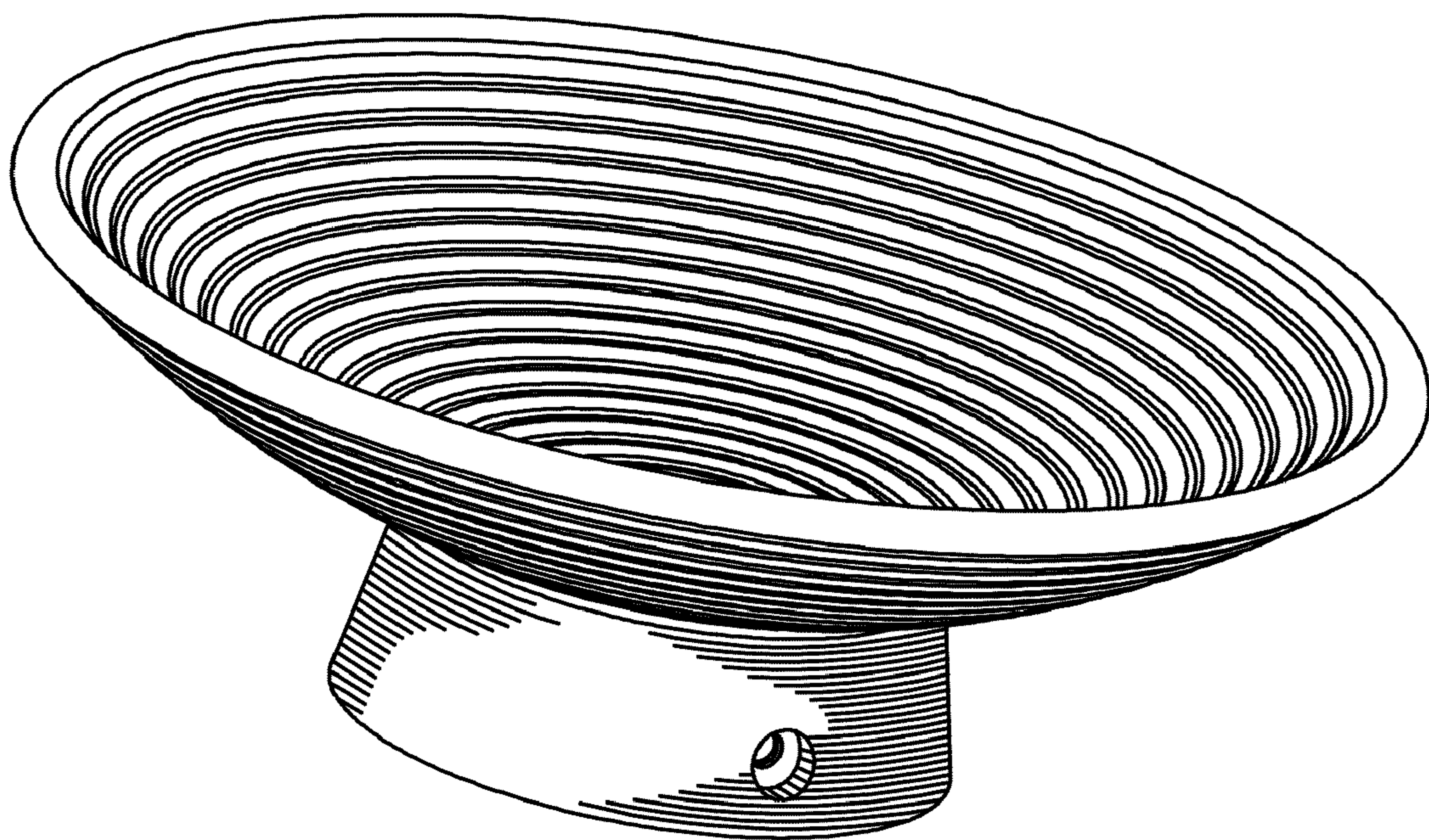

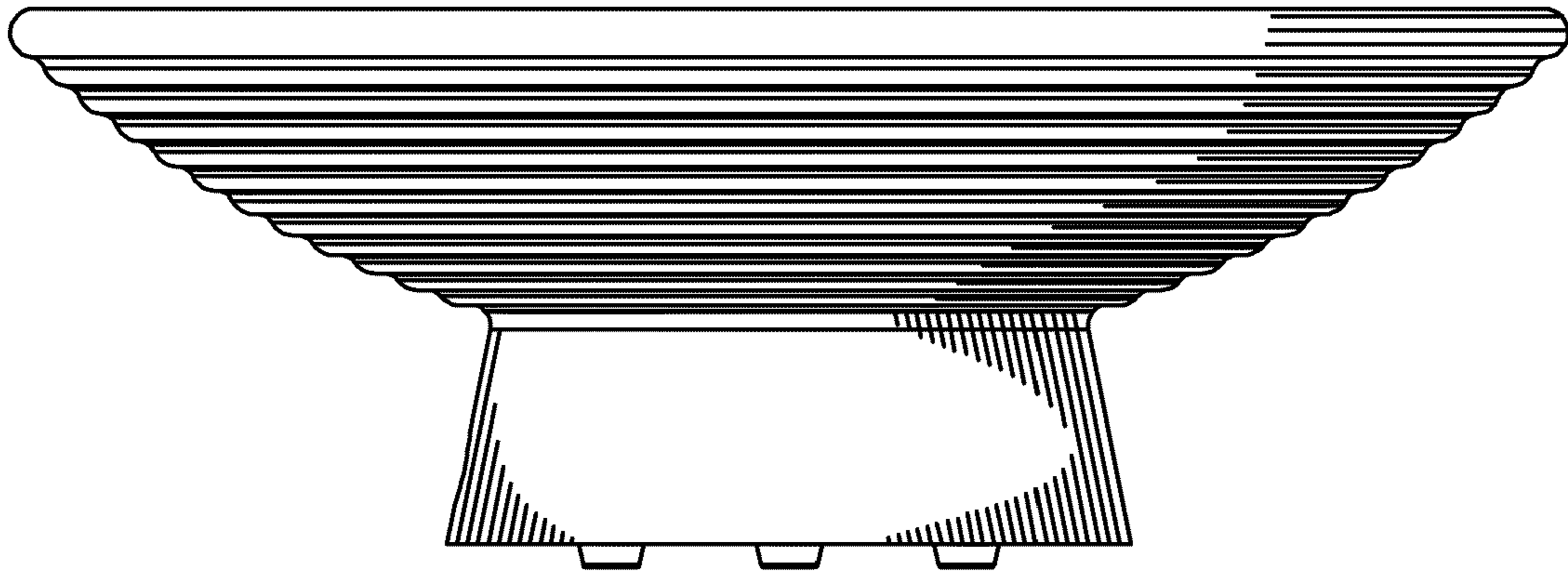

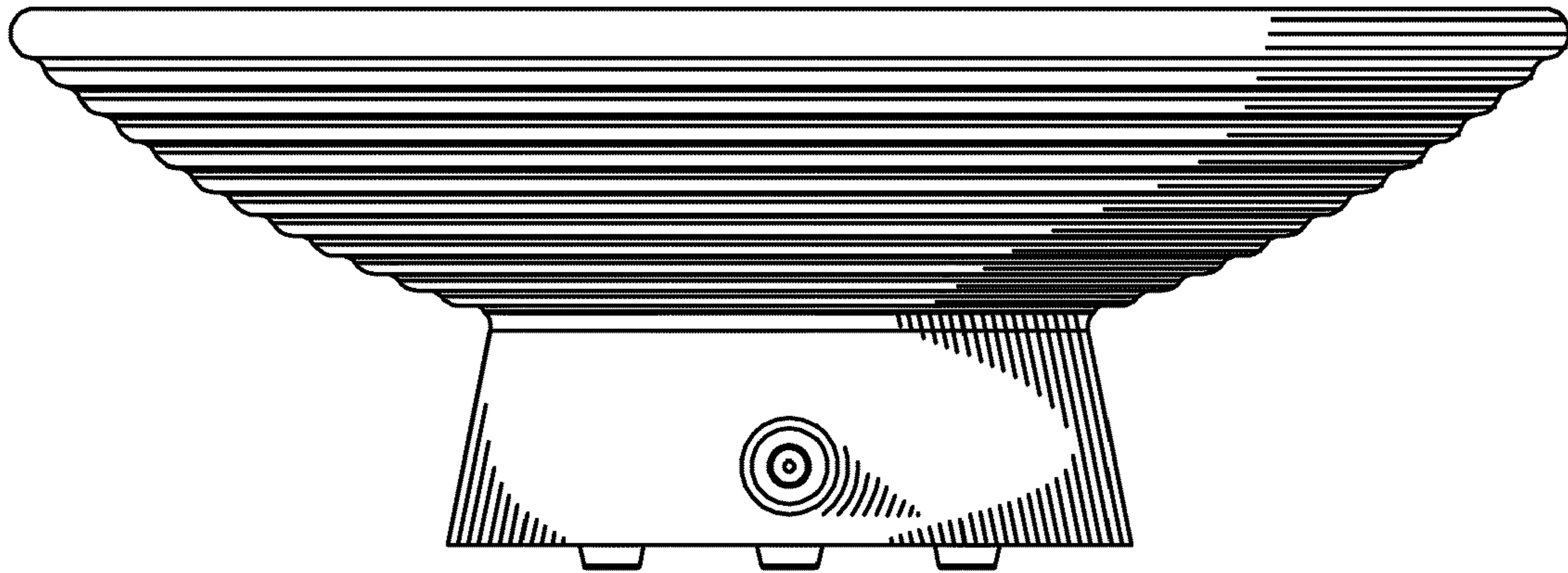

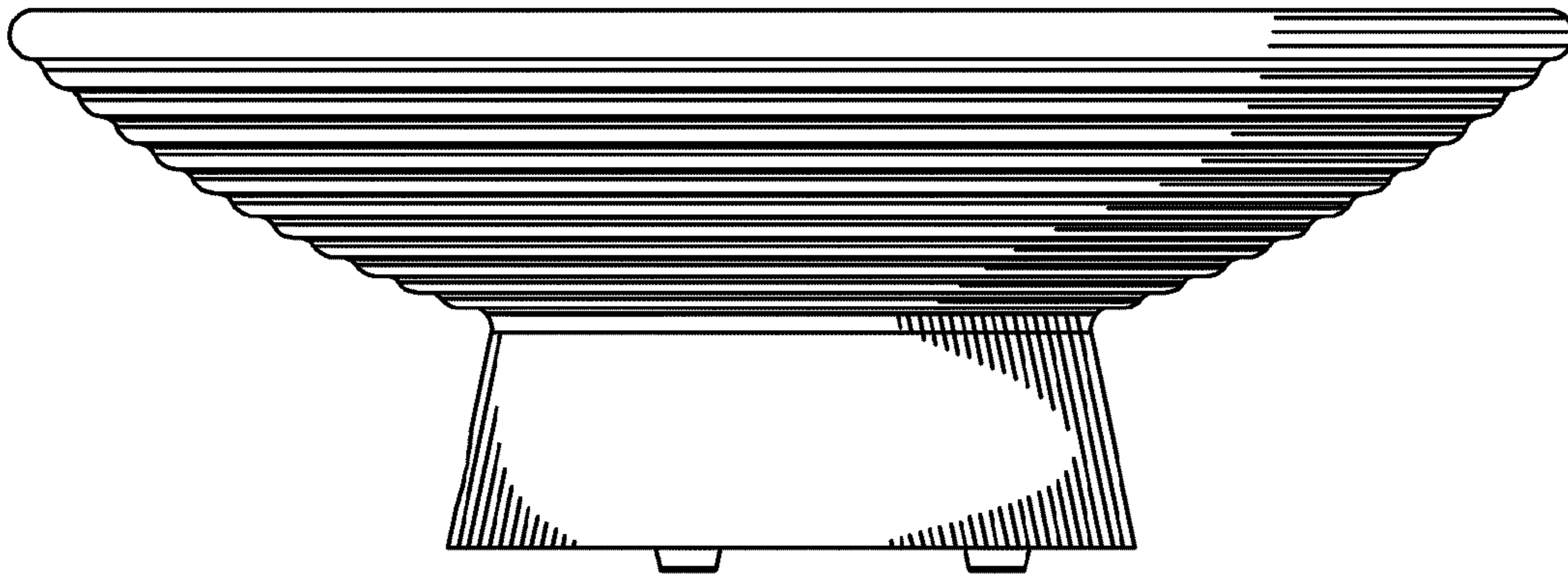

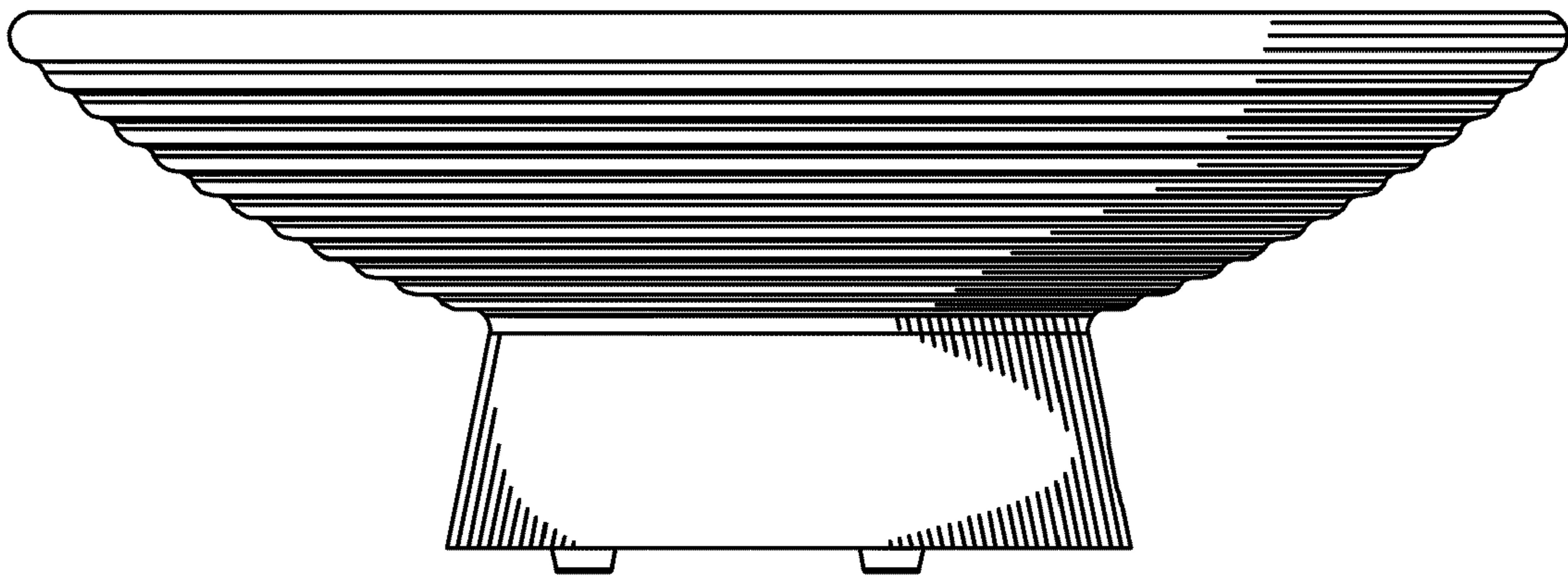

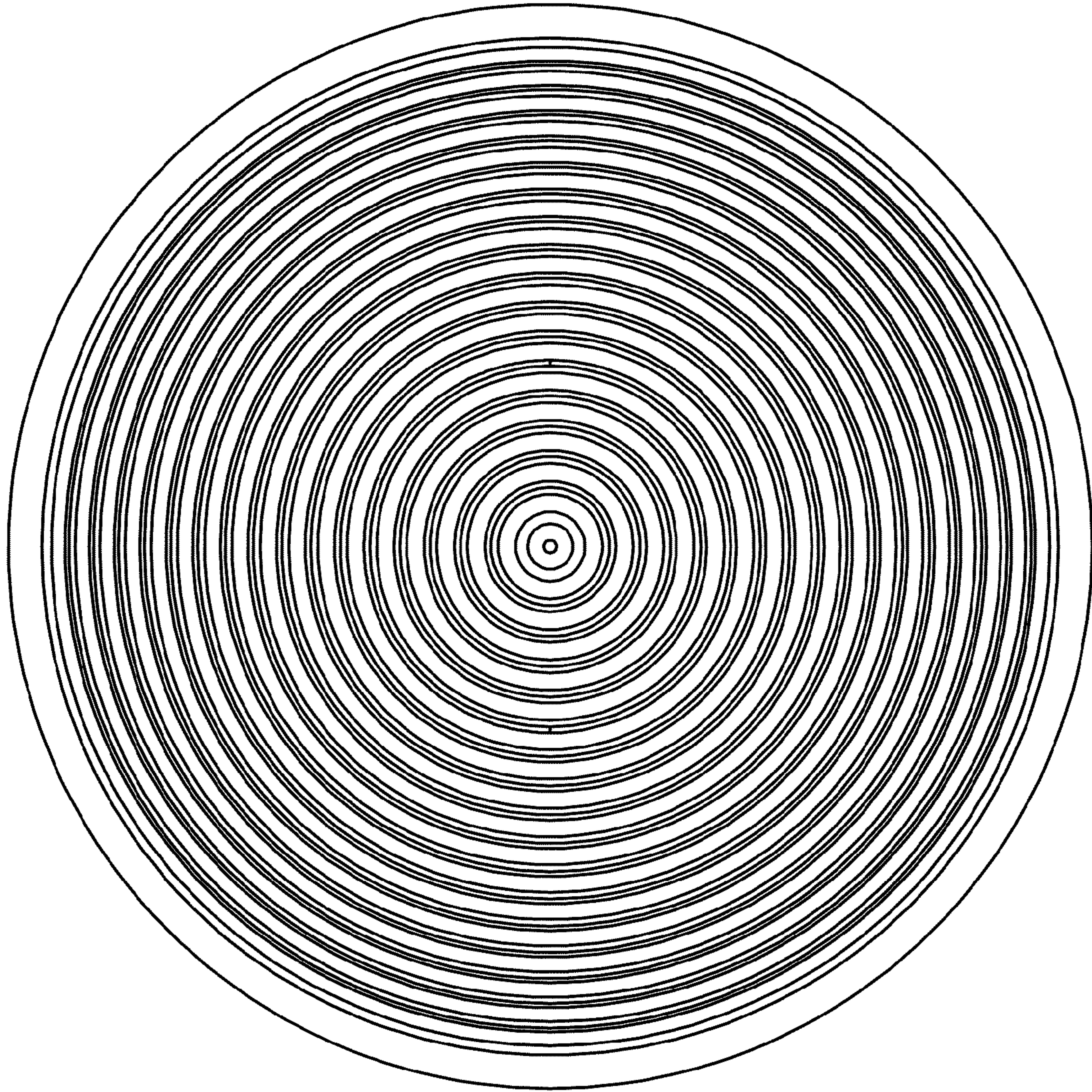

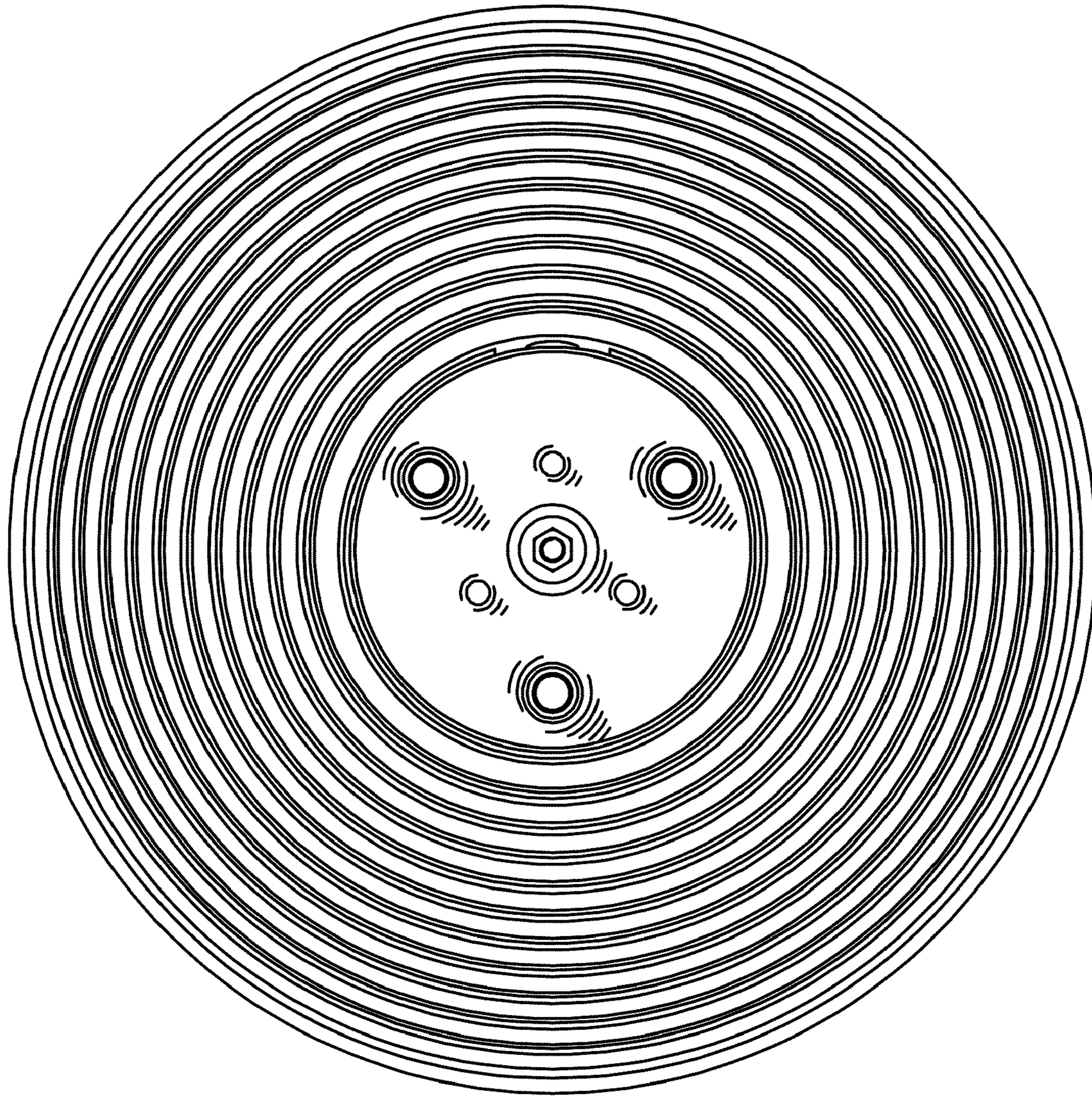

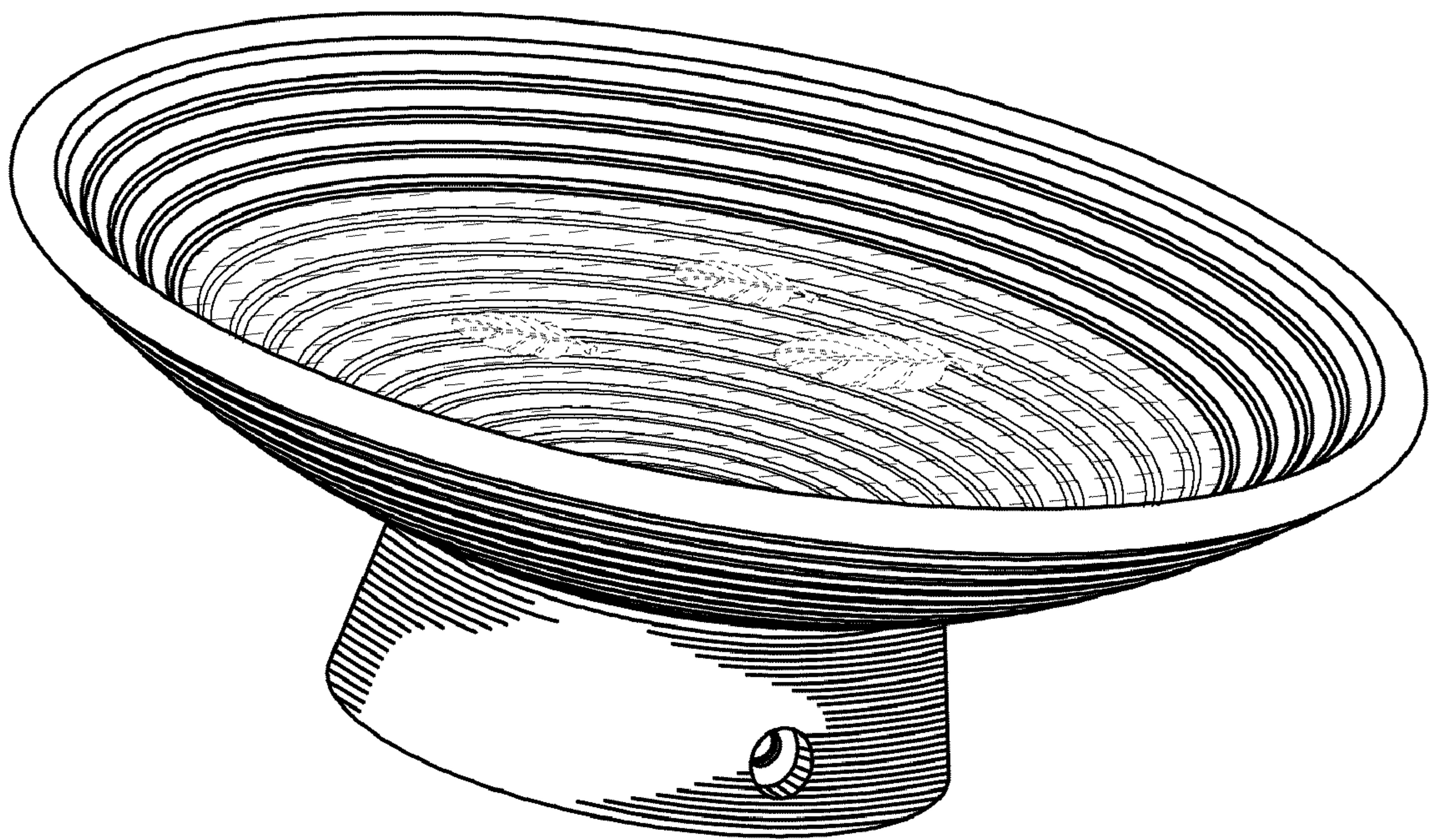

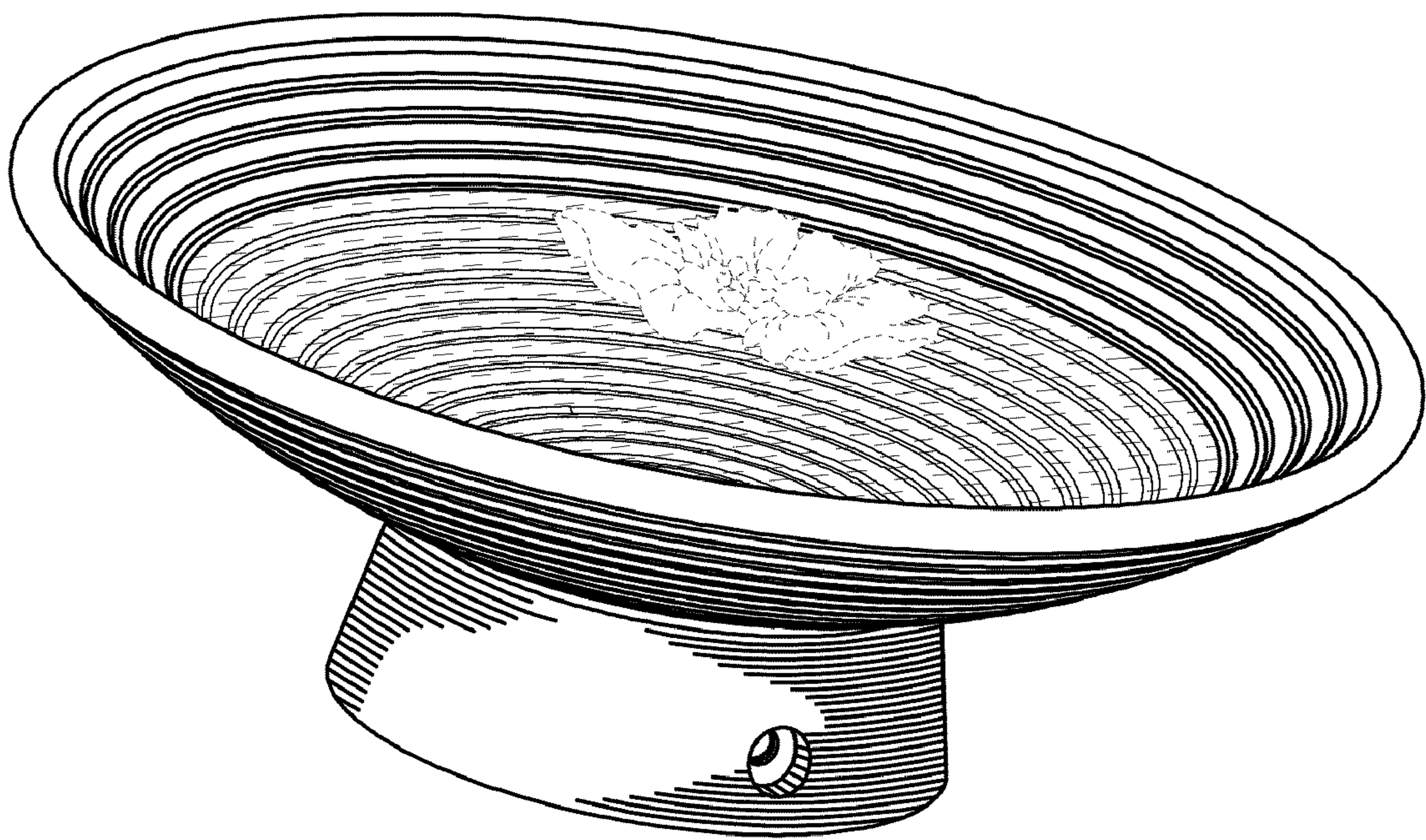
