FIG. 1 is a front elevational view of the therapy suit;

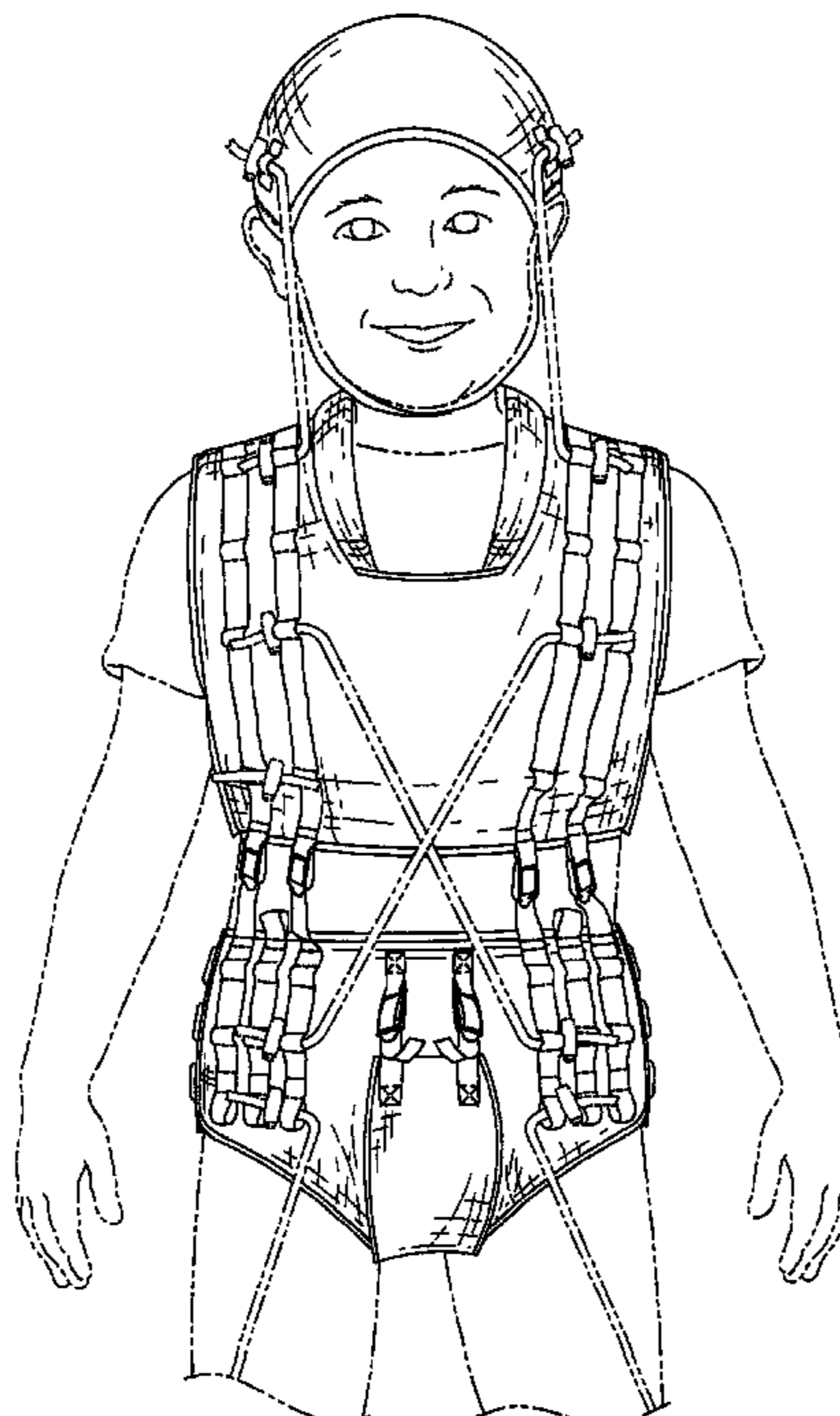
FIG. 2 is a rear elevational view thereof;

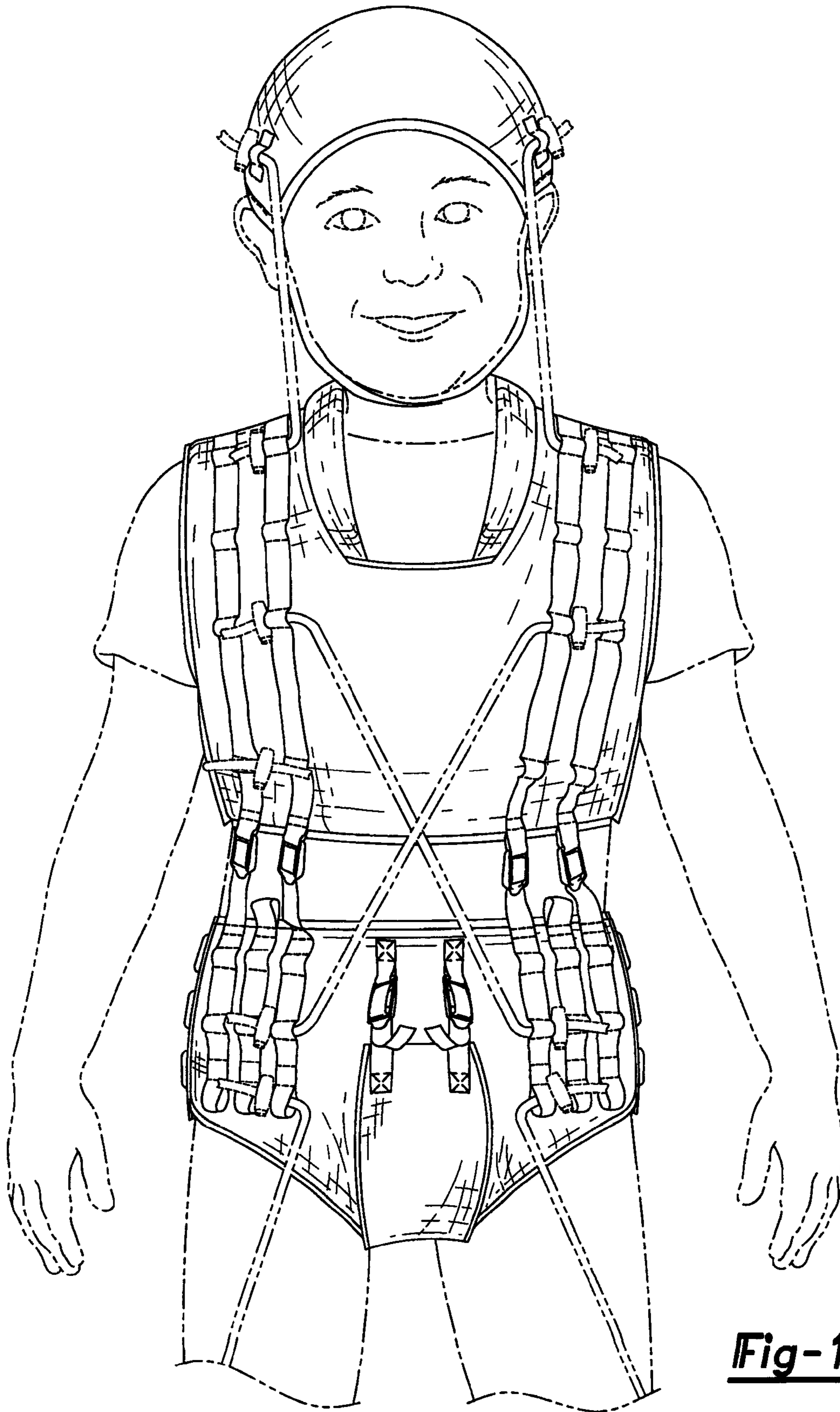

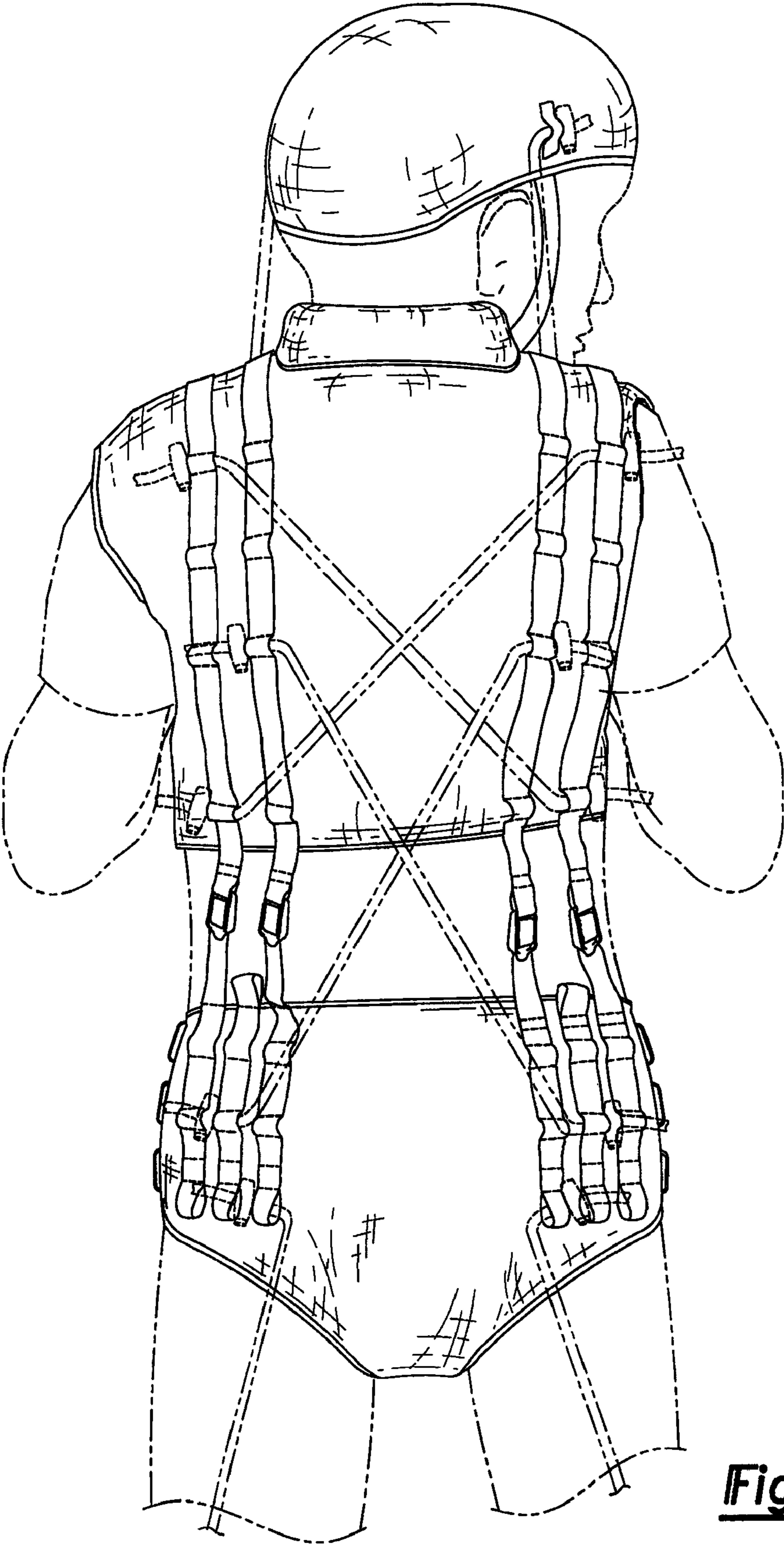

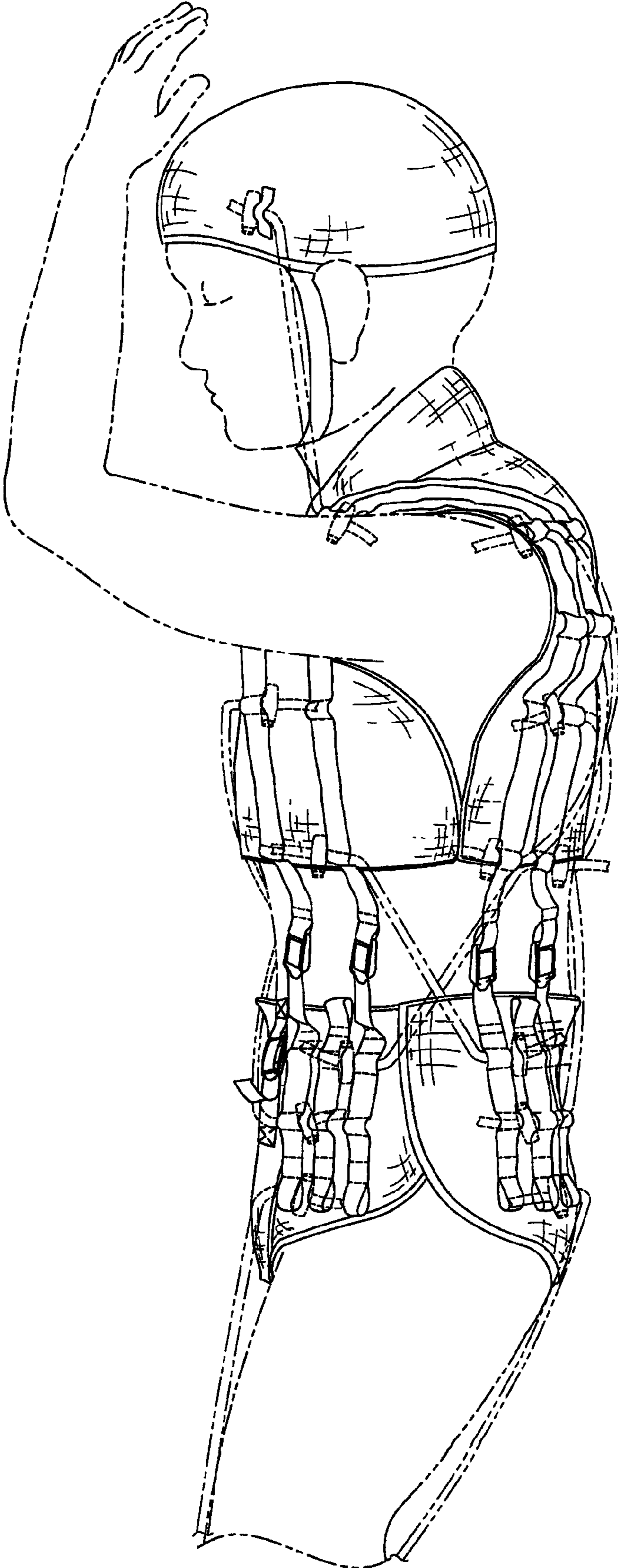

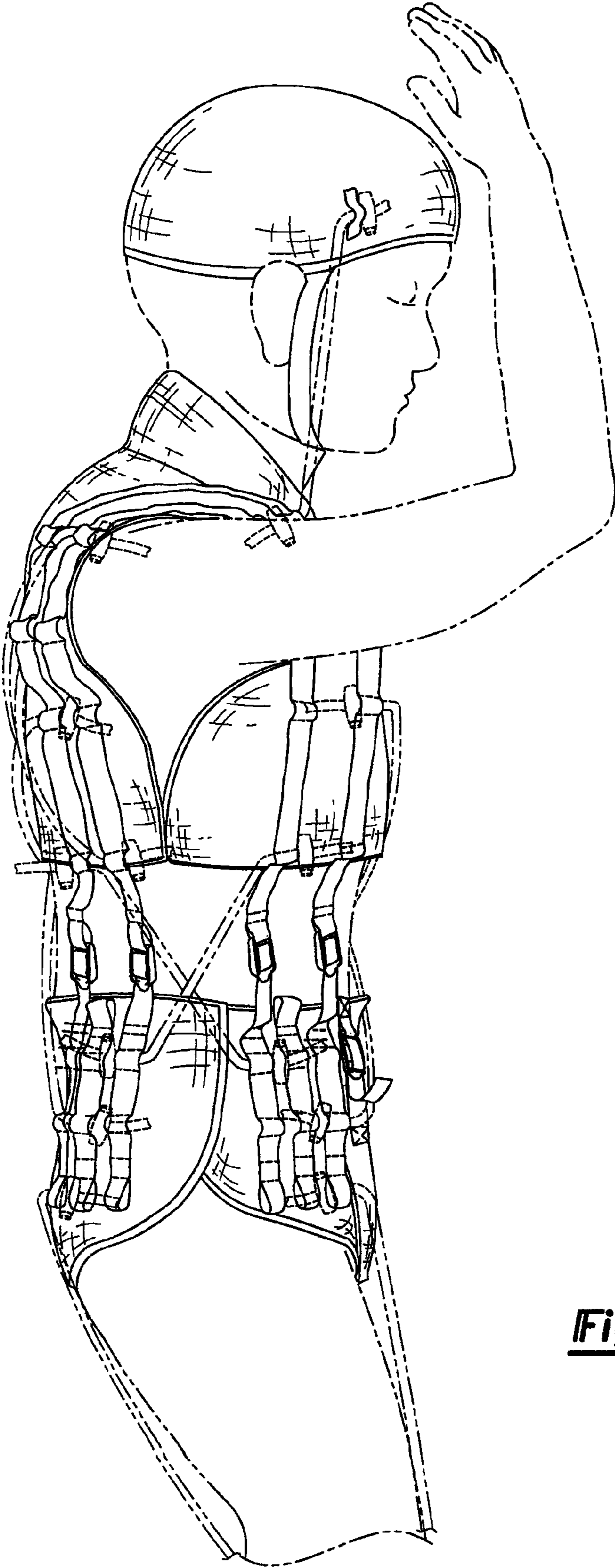
