(57) **CLAIM**

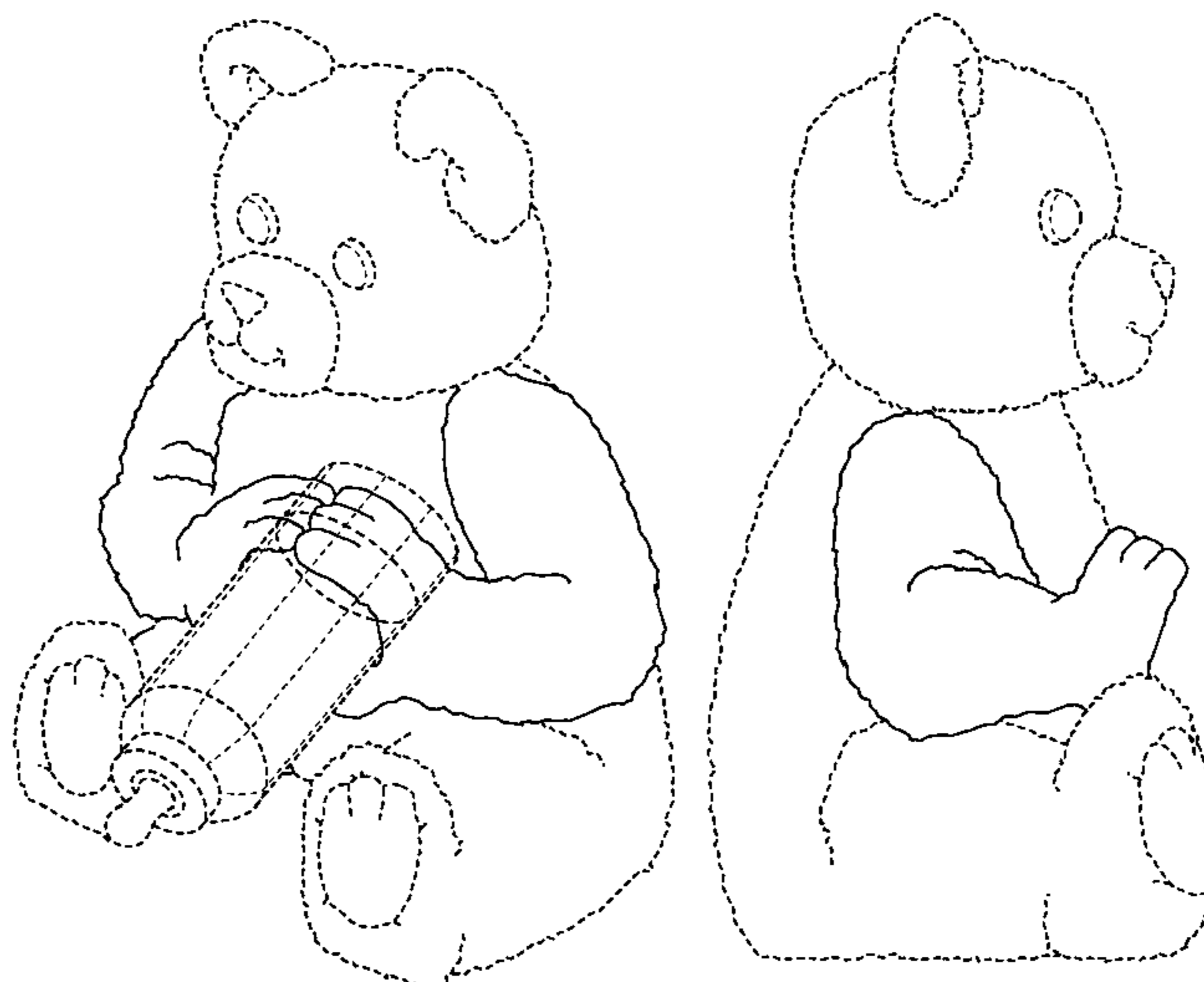
The ornamental design for a baby bottle holder, as shown and described.

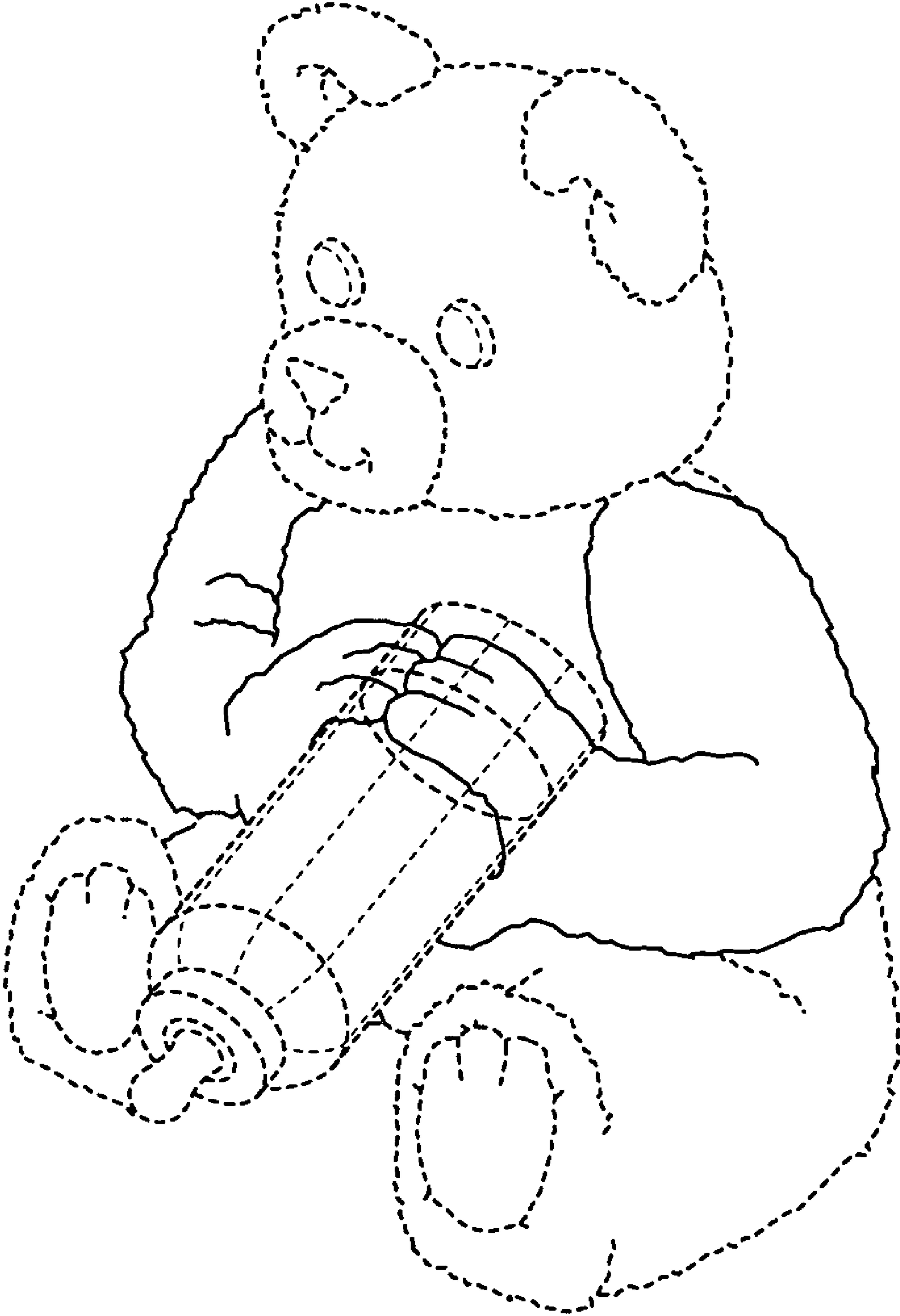
**DESCRIPTION**

FIG. 1 is an isometric view of a baby bottle holder incorporating my new design, as viewed from the front and right side; FIG. 2 is a front elevational view thereof; FIG. 3 is a back elevational view thereof; FIG. 4 is a right side elevational view thereof; FIG. 5 is a left side elevational view thereof; FIG. 6 is a top plan view thereof; and, FIG. 7 is a bottom plan view thereof.

The broken lines illustrate portions of the baby bottle holder which form no part of the claimed design.

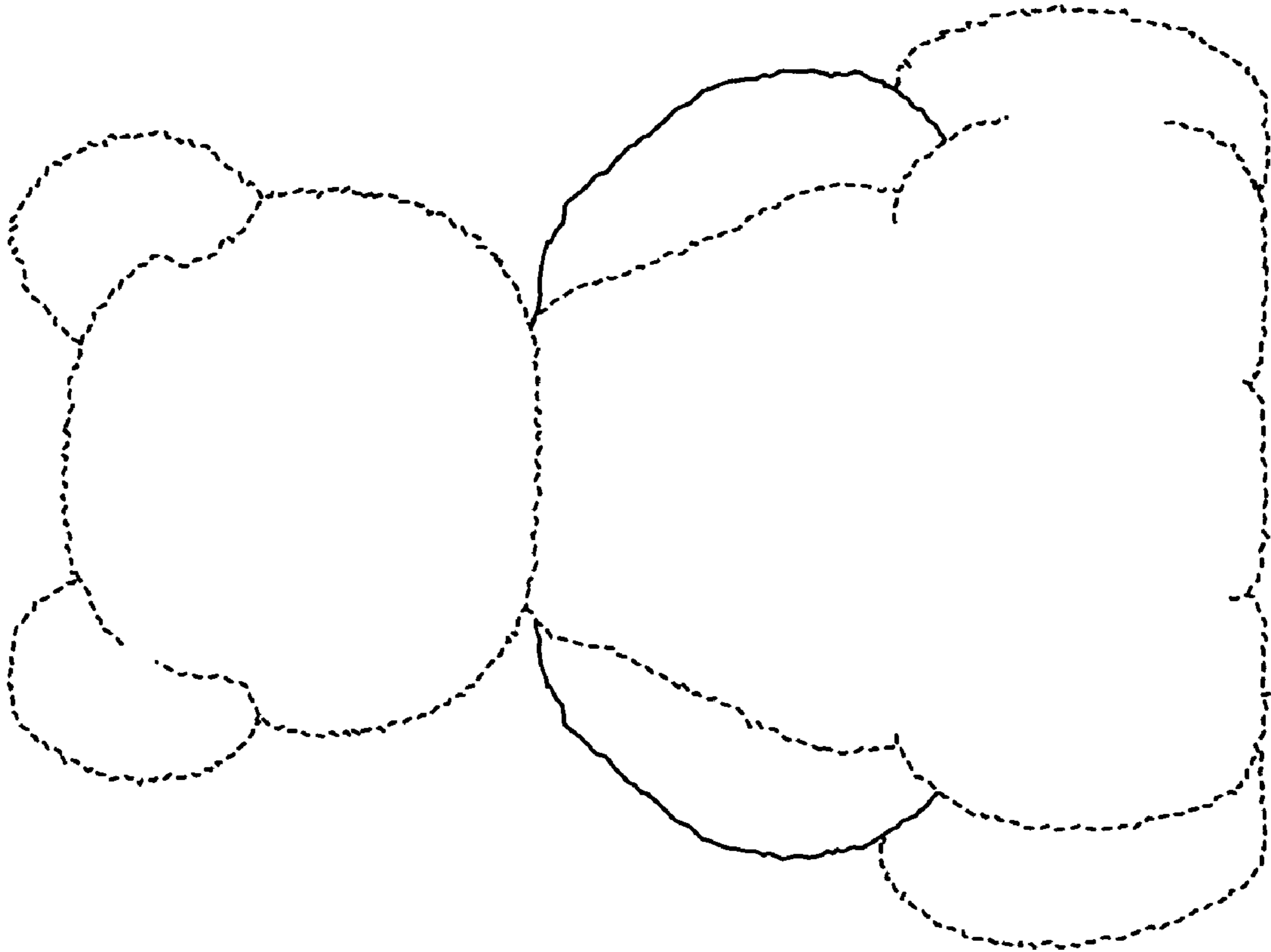

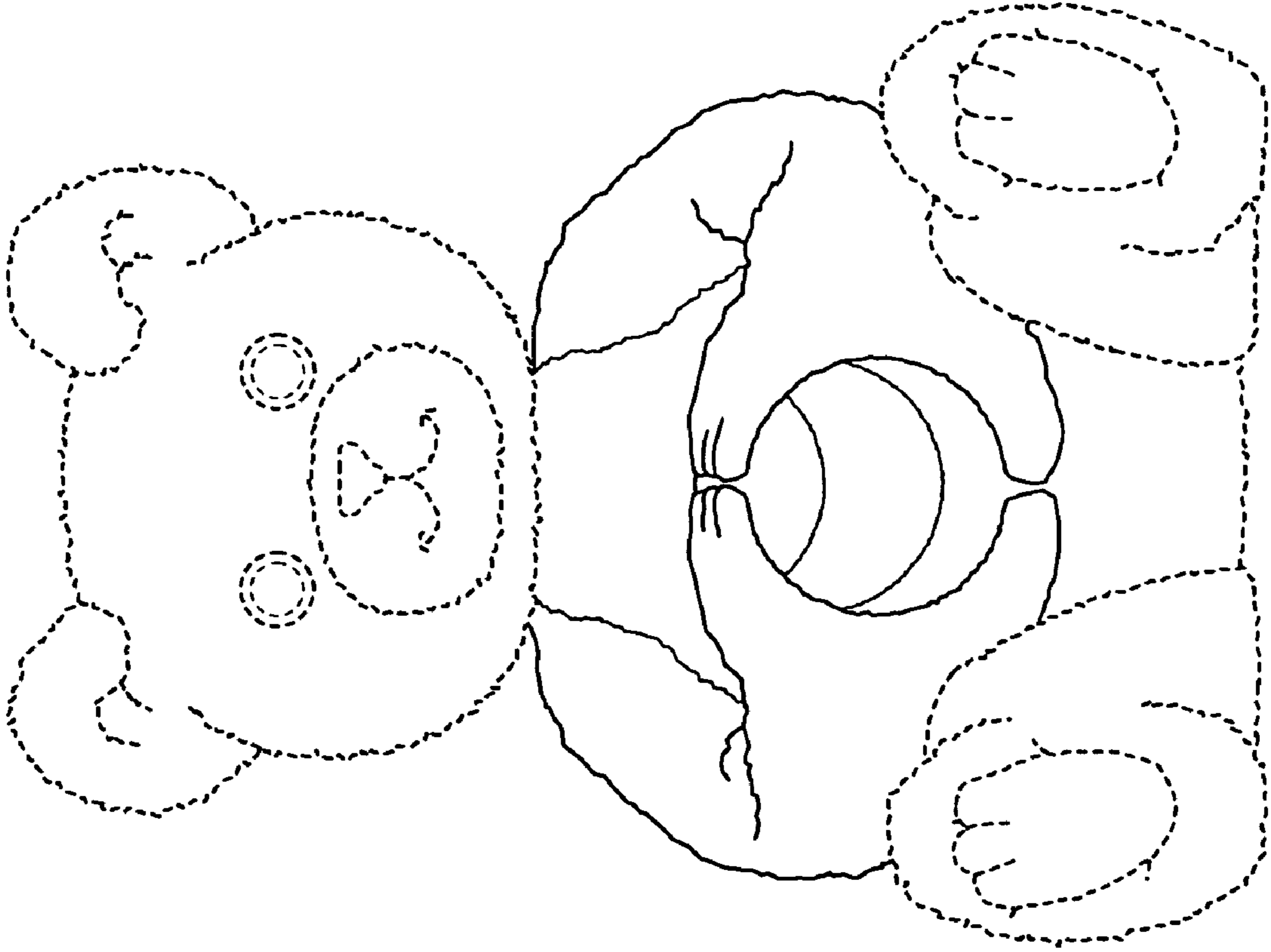

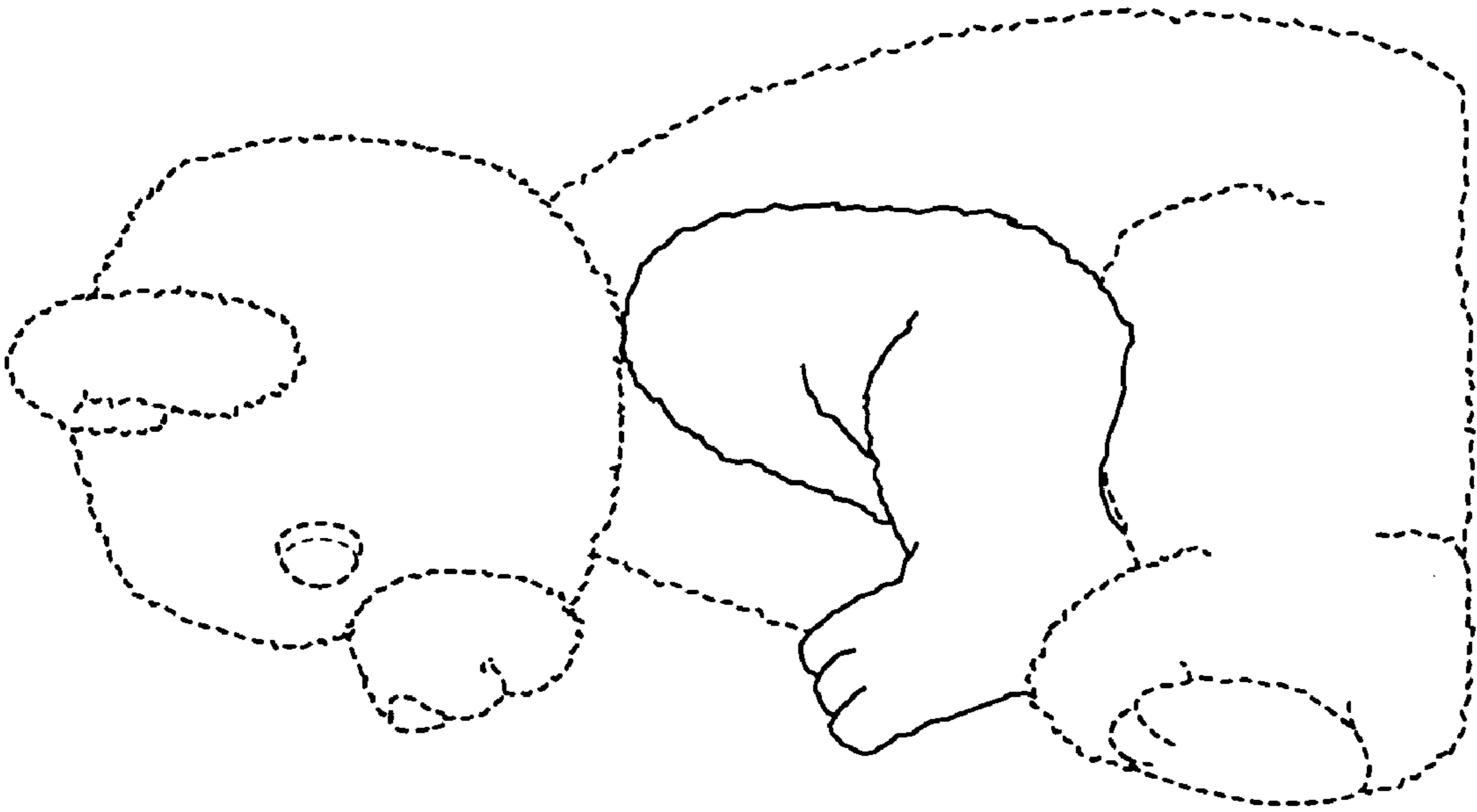

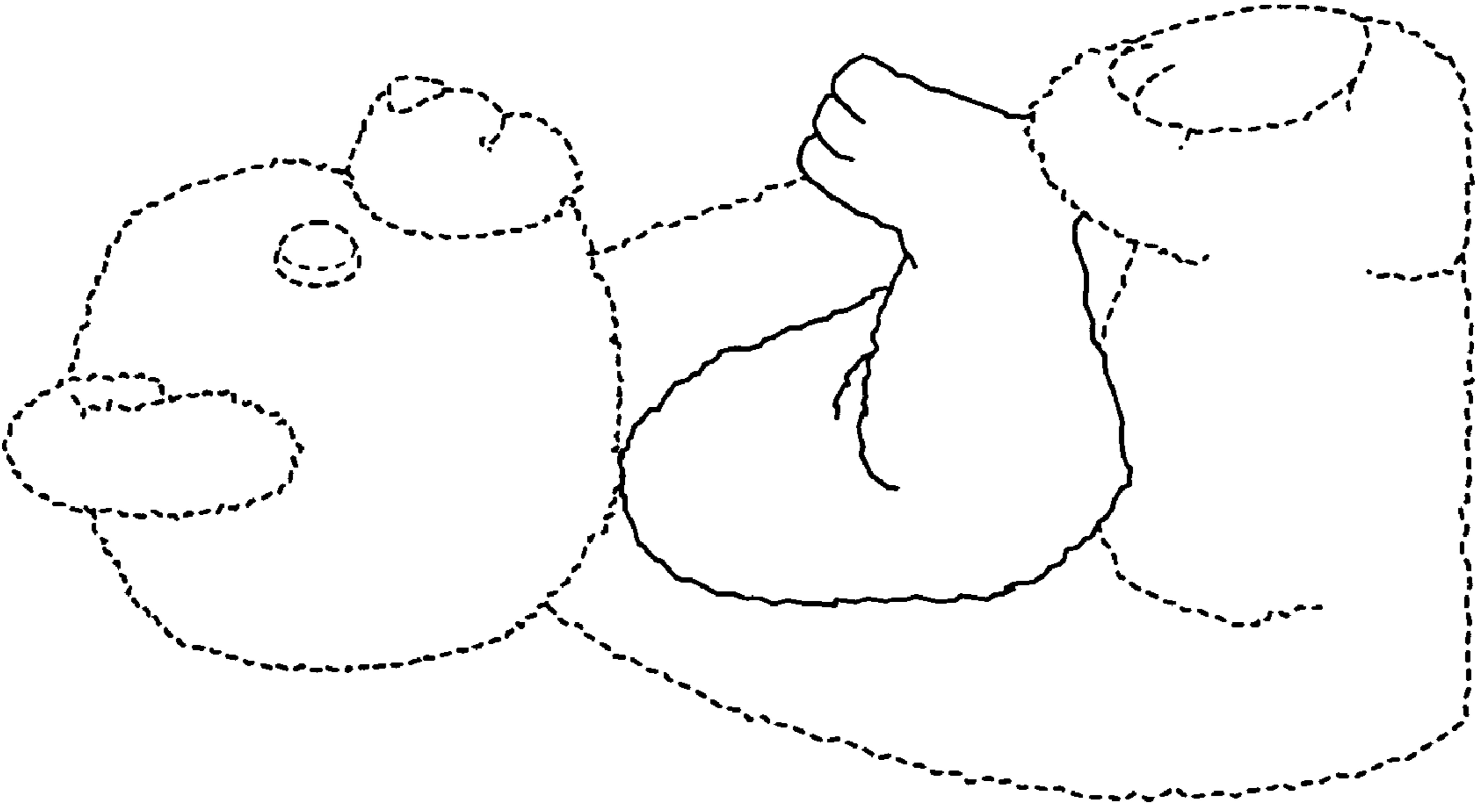

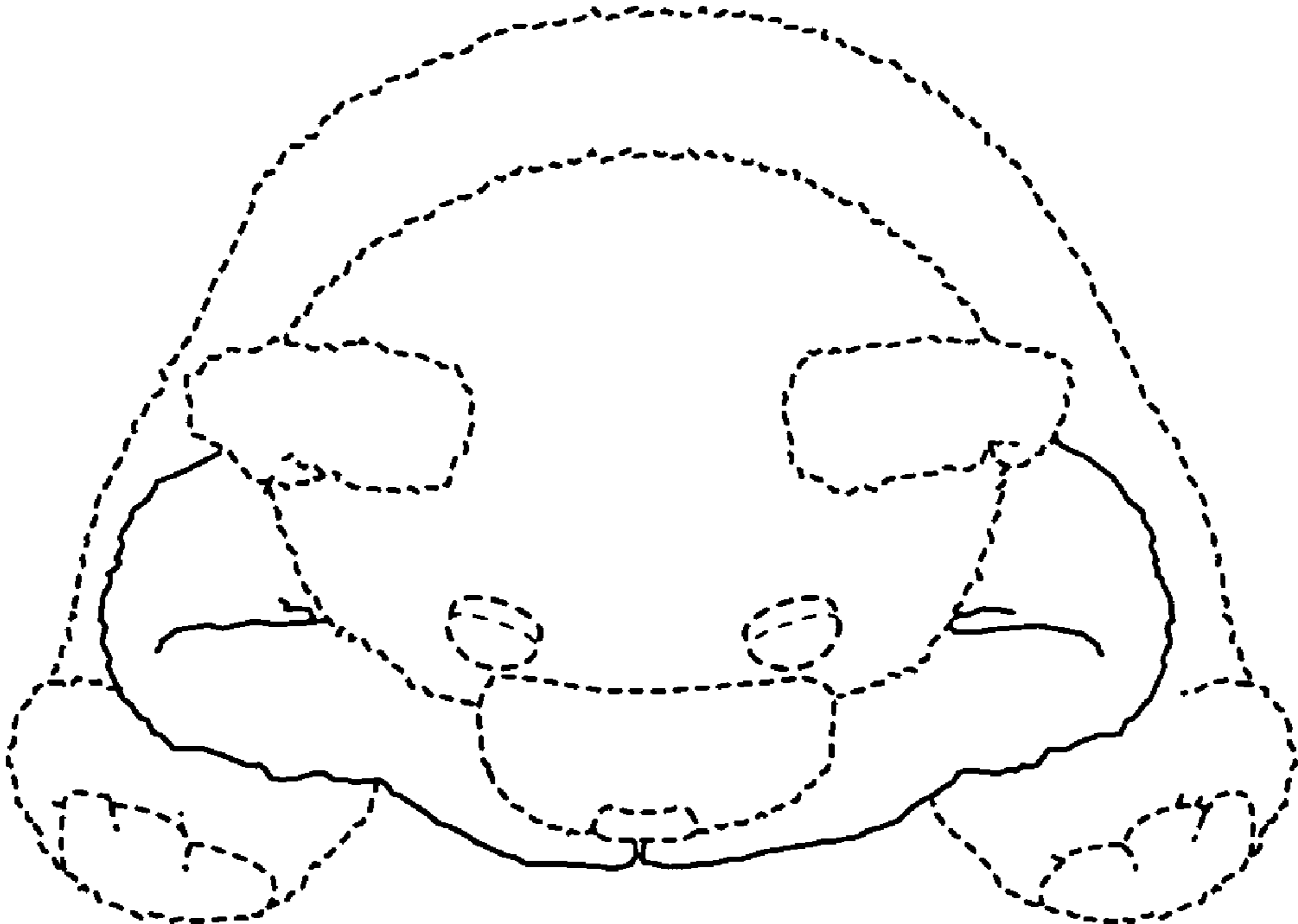

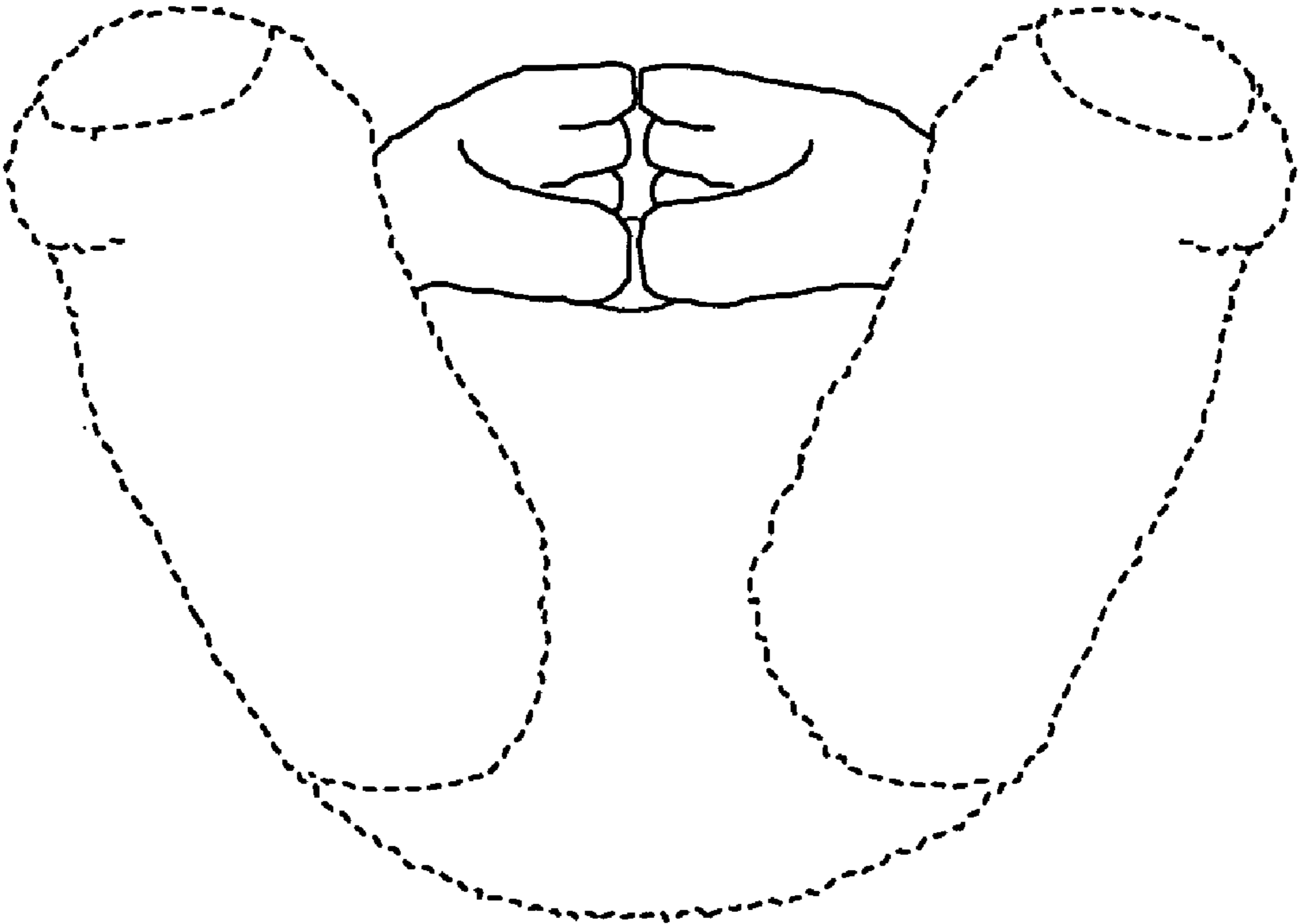
