FIG. 2 is a top view of a decorative squirrel proof birdhouse

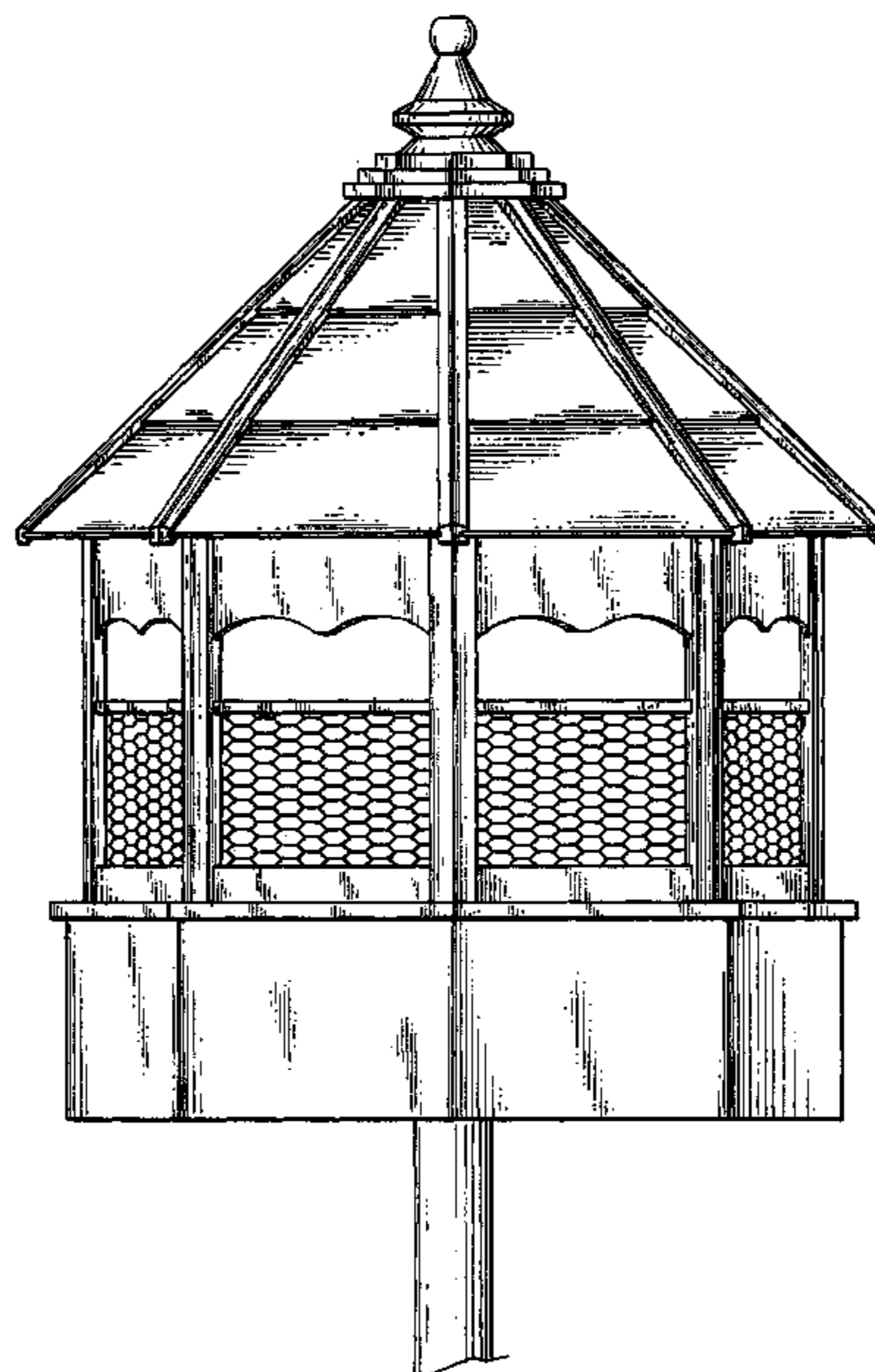
FIG. 3 is a bottom view of a decorative squirrel proof birdhouse

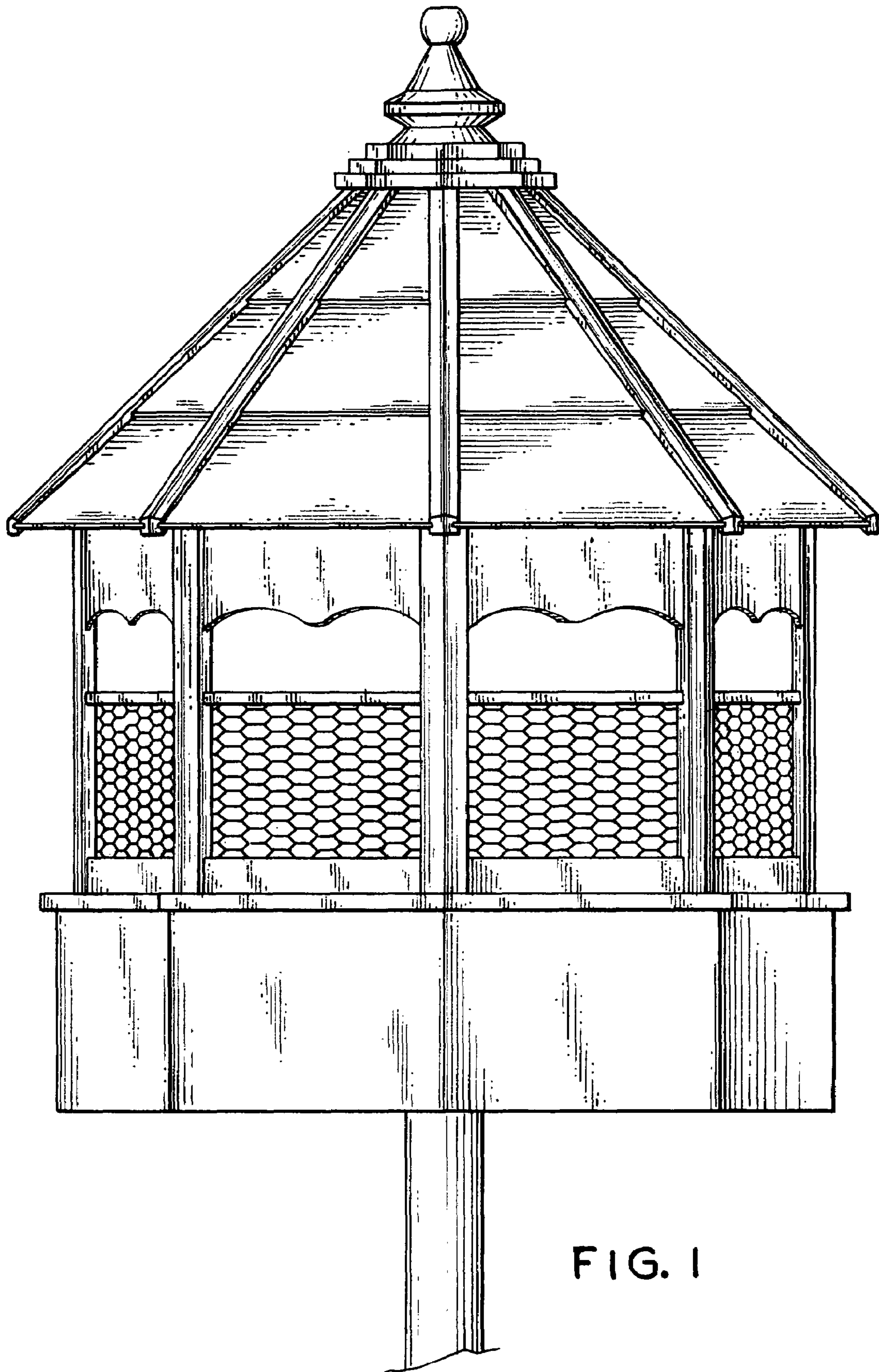

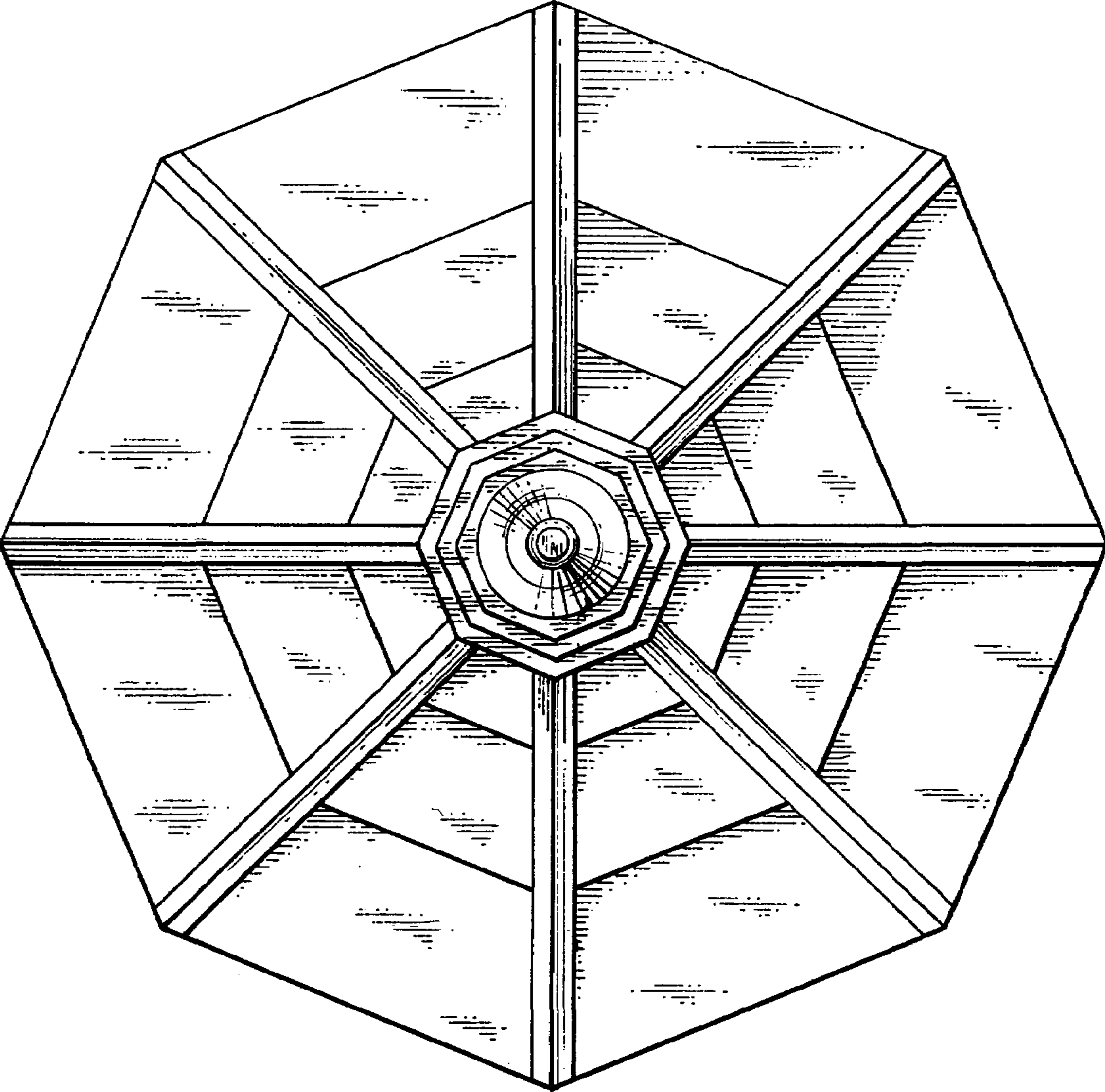

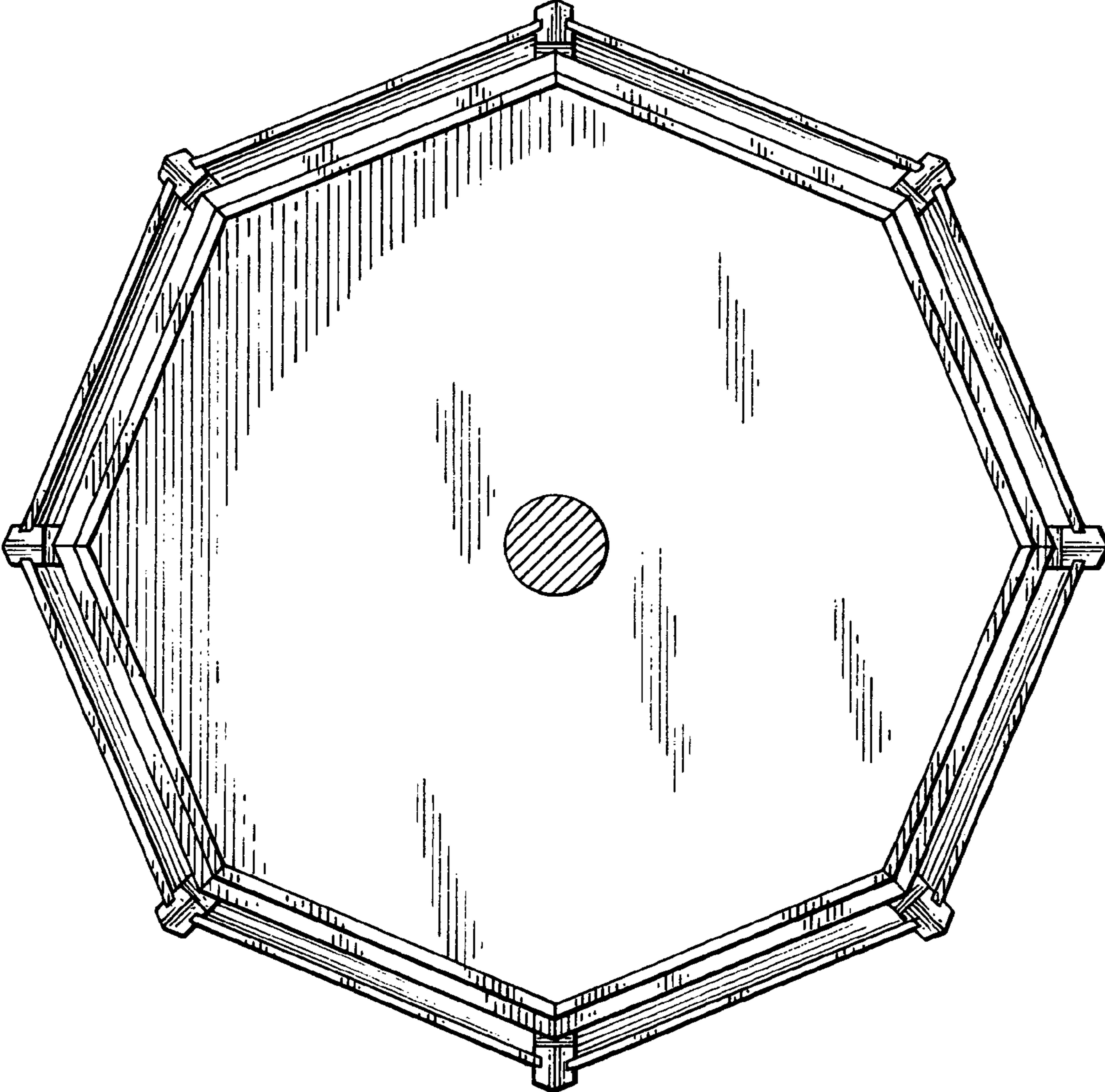

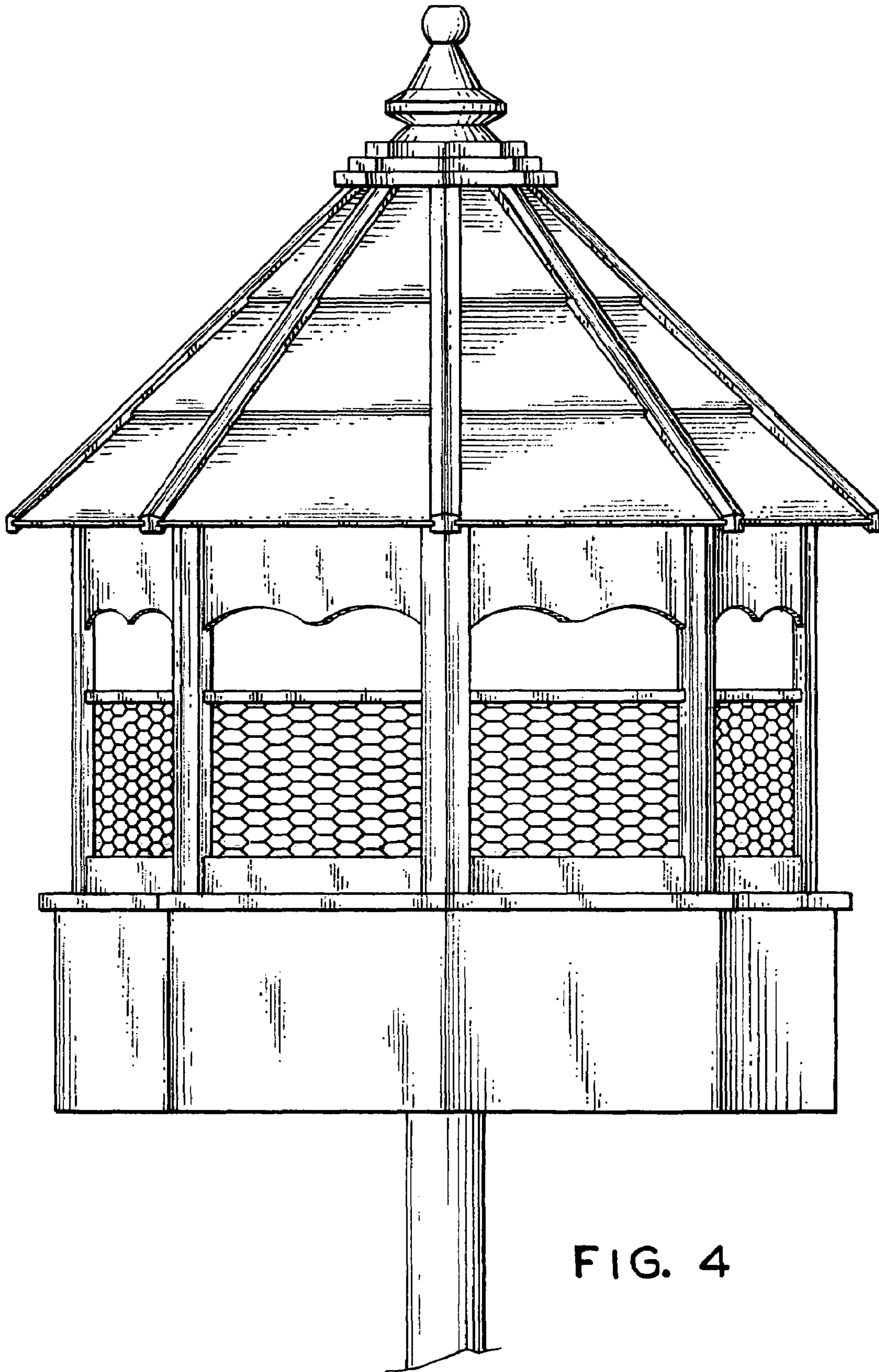

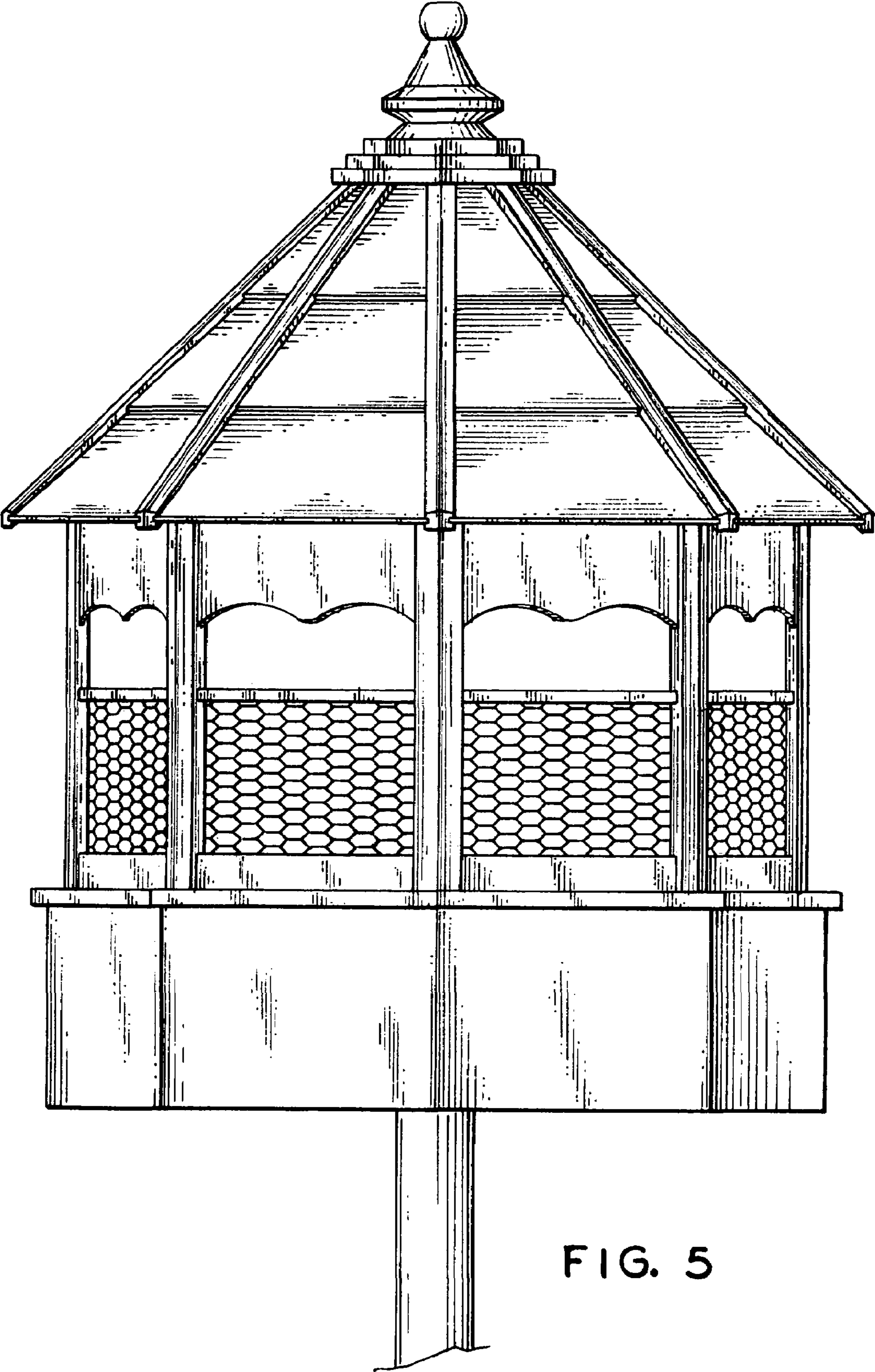

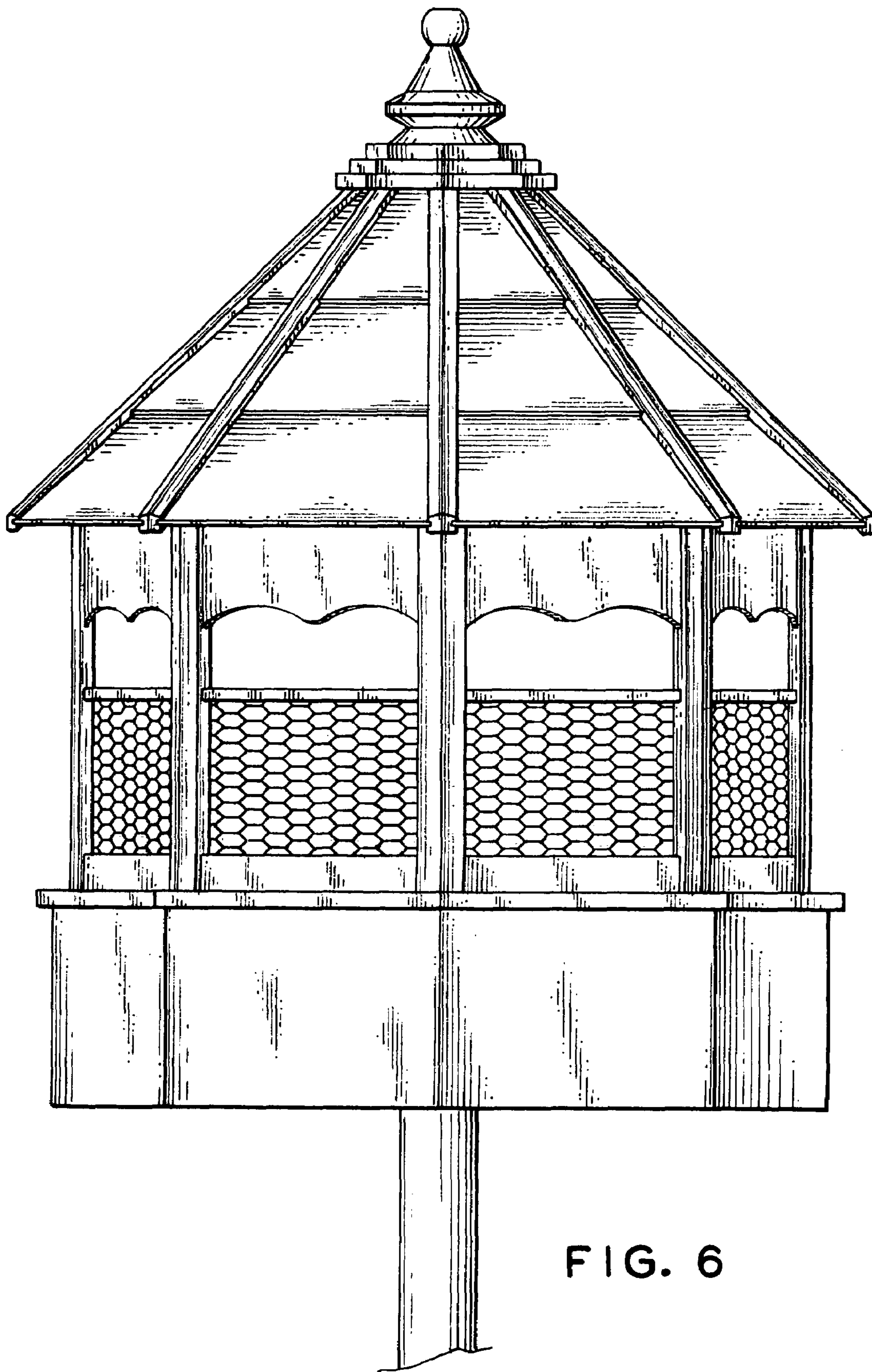
