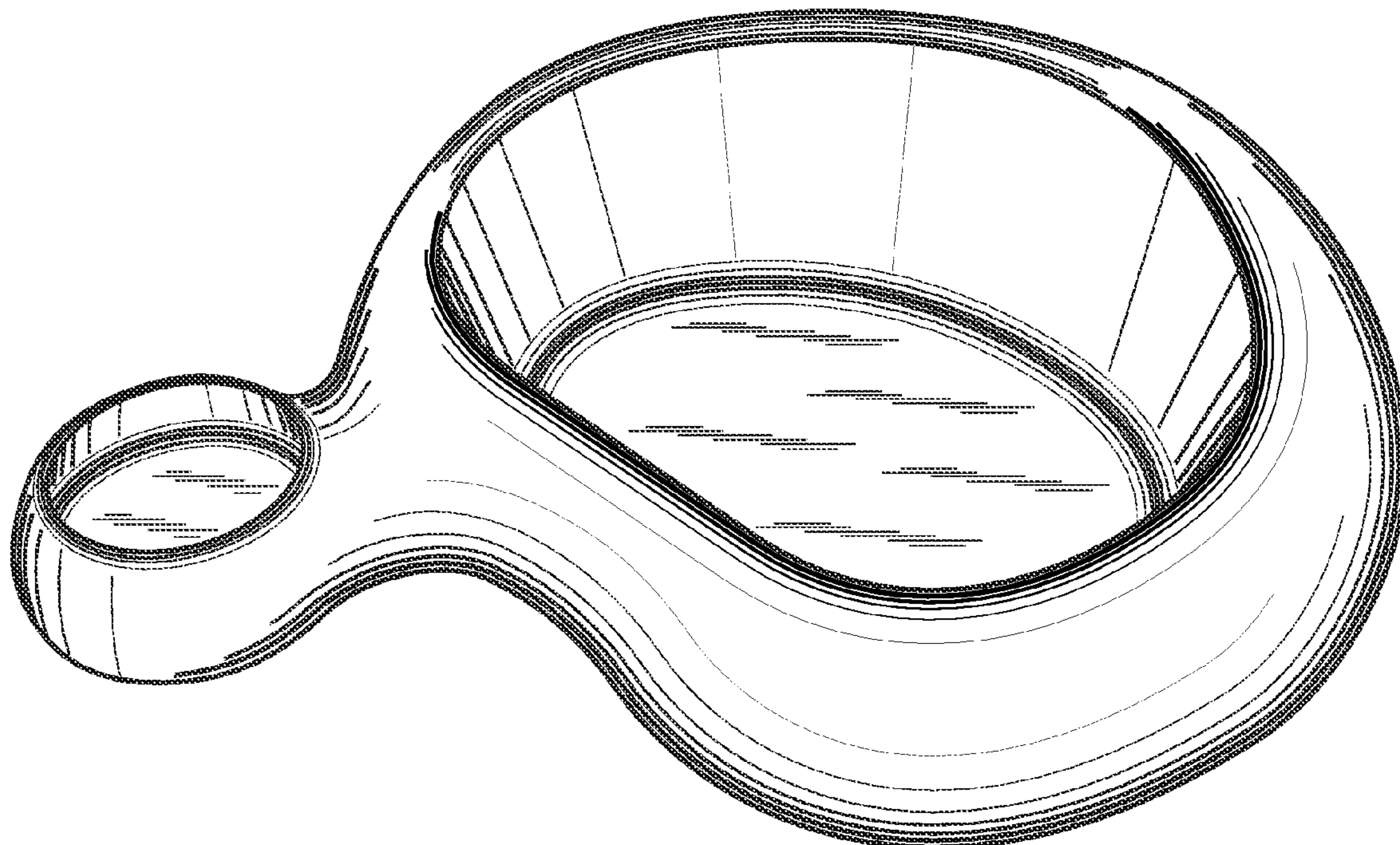

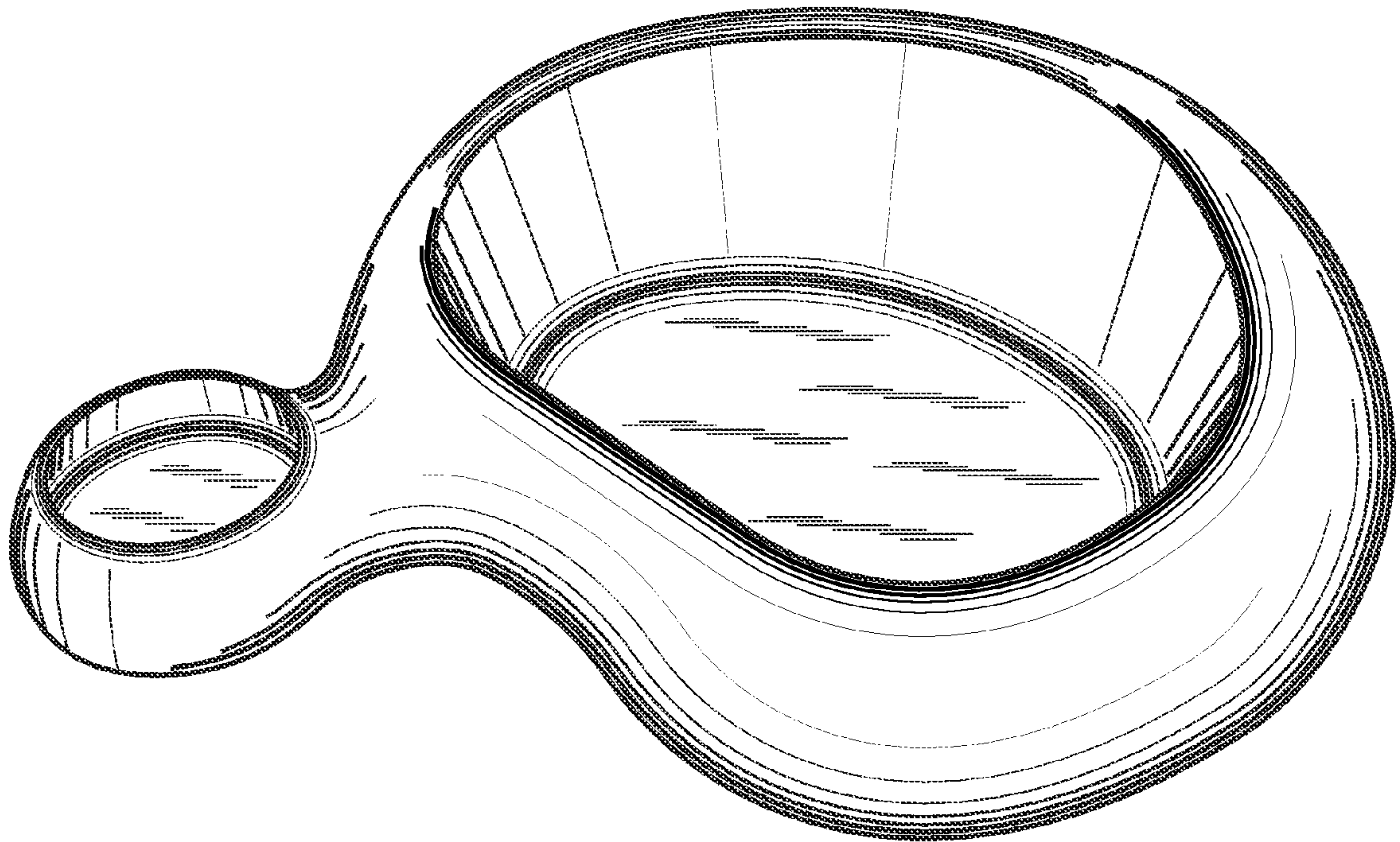
The ornamental design for a pet bed with extension, as shown and described.

DESCRIPTION

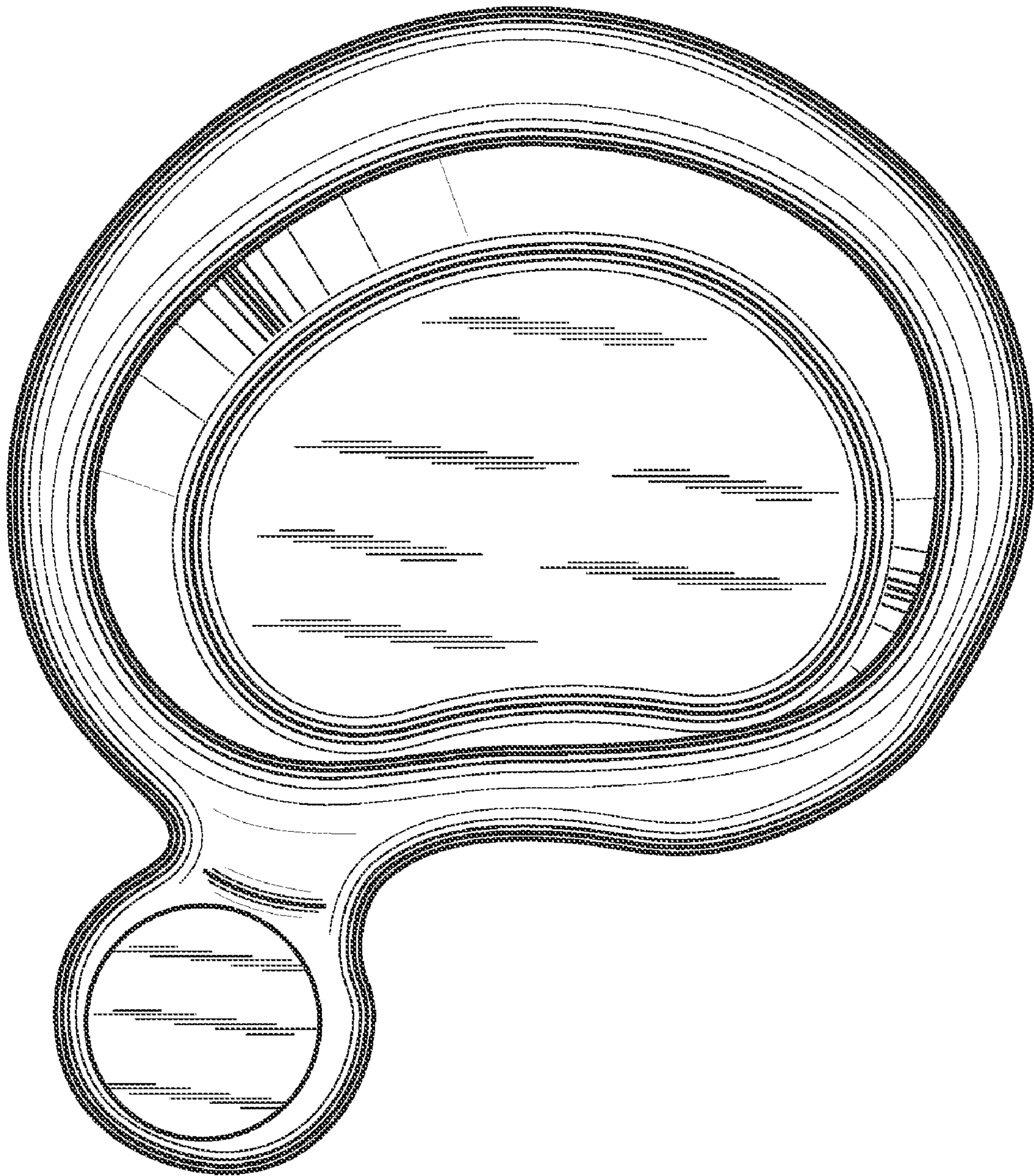
FIG. 1 is a perspective view of a pet bed, showing my new design;

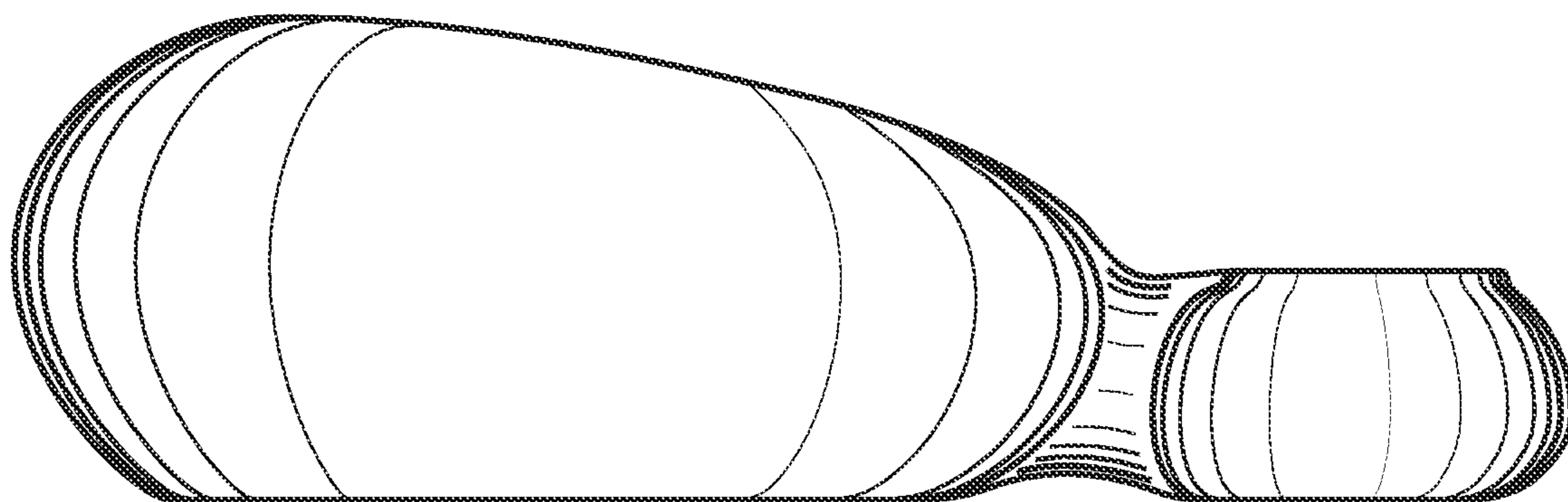

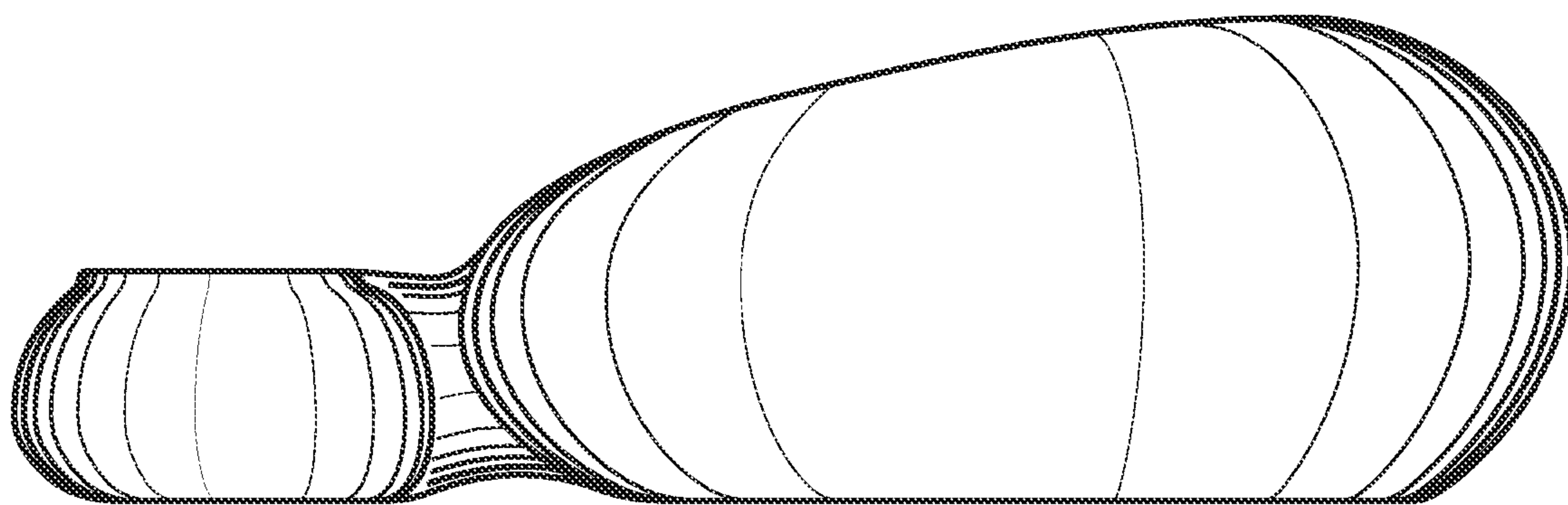
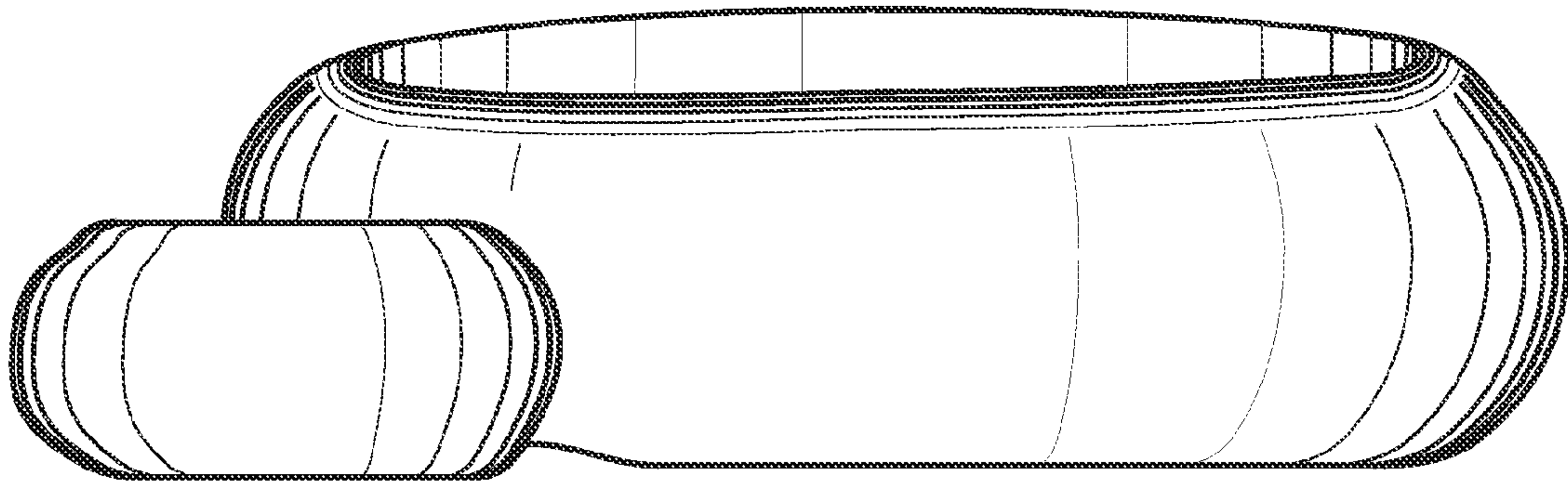
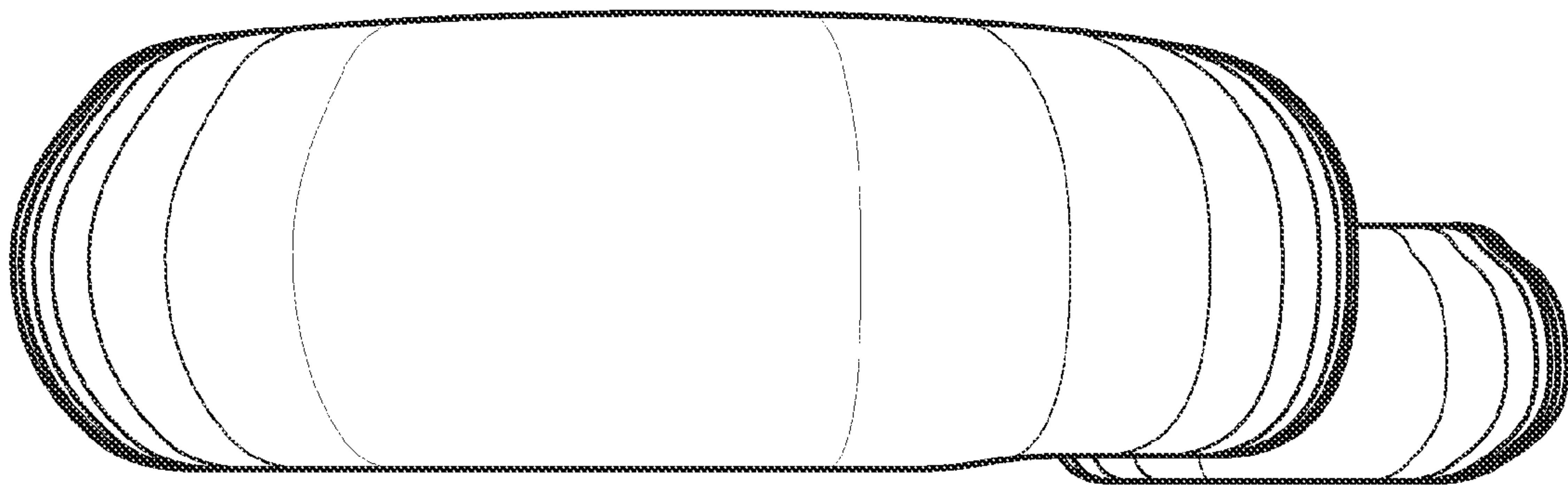
