**DESCRIPTION**

FIG. 1 is a front perspective view of an article of footwear, showing my new design;

FIG. 2 is a view of a first side thereof;

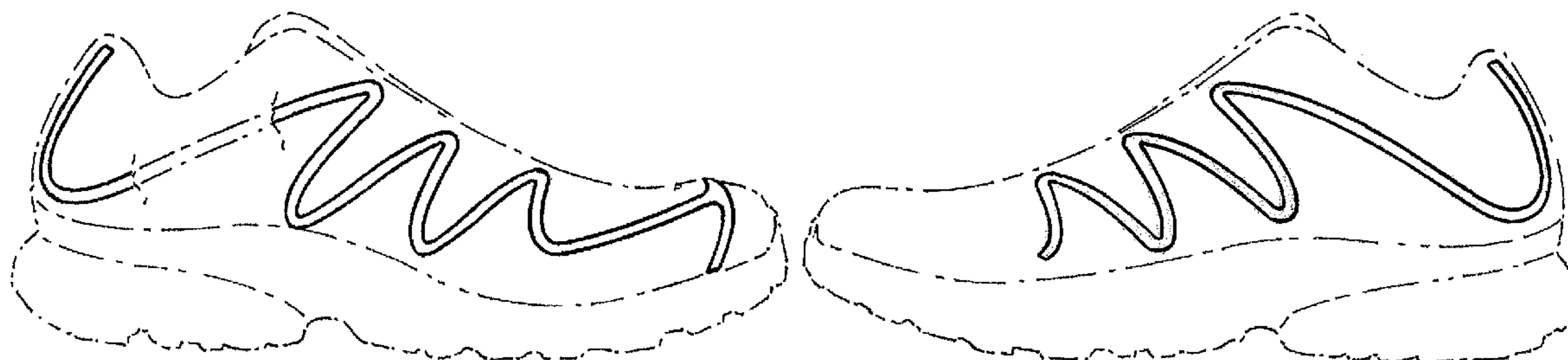
FIG. 3 is a rear perspective thereof; and,

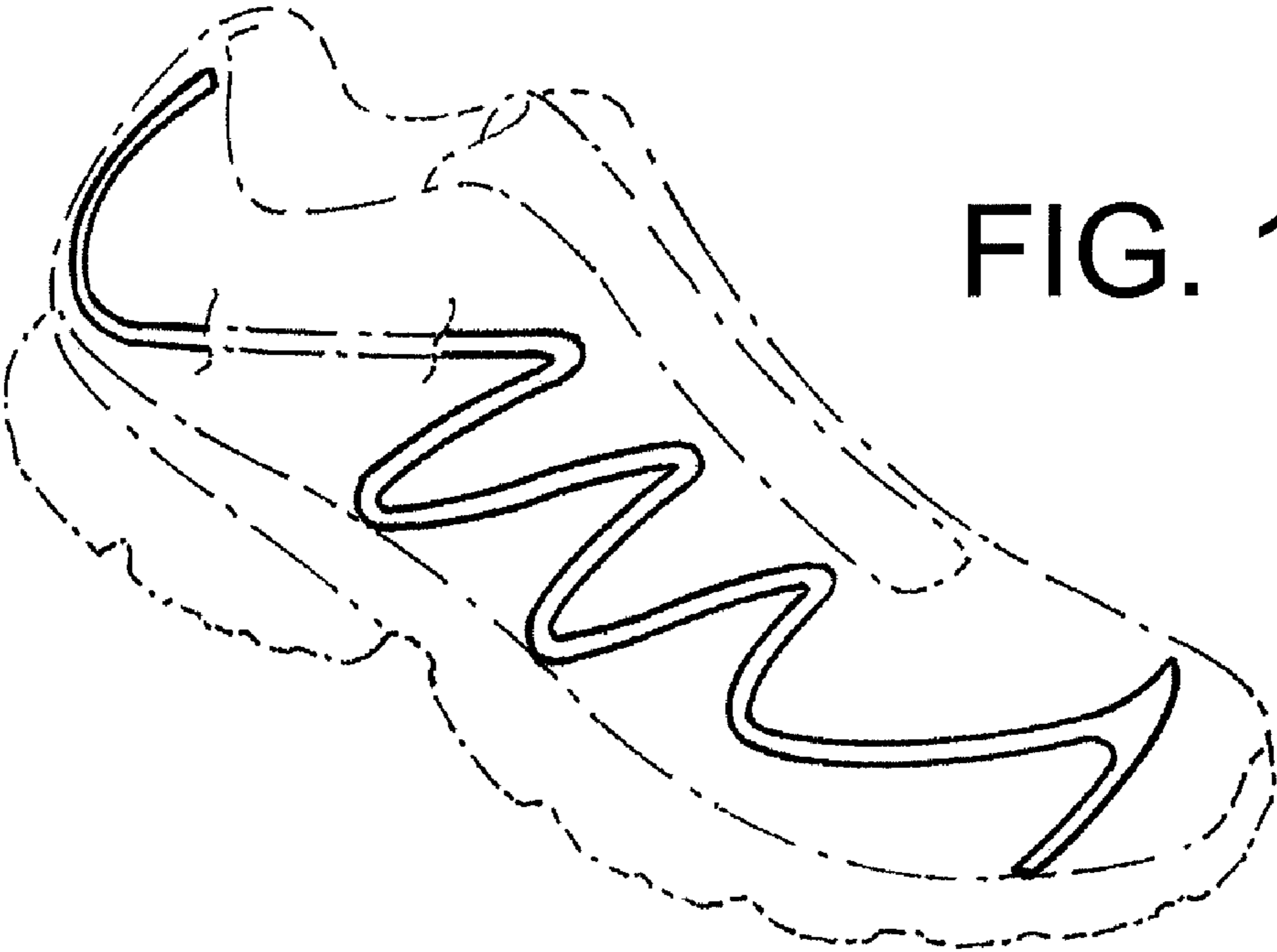

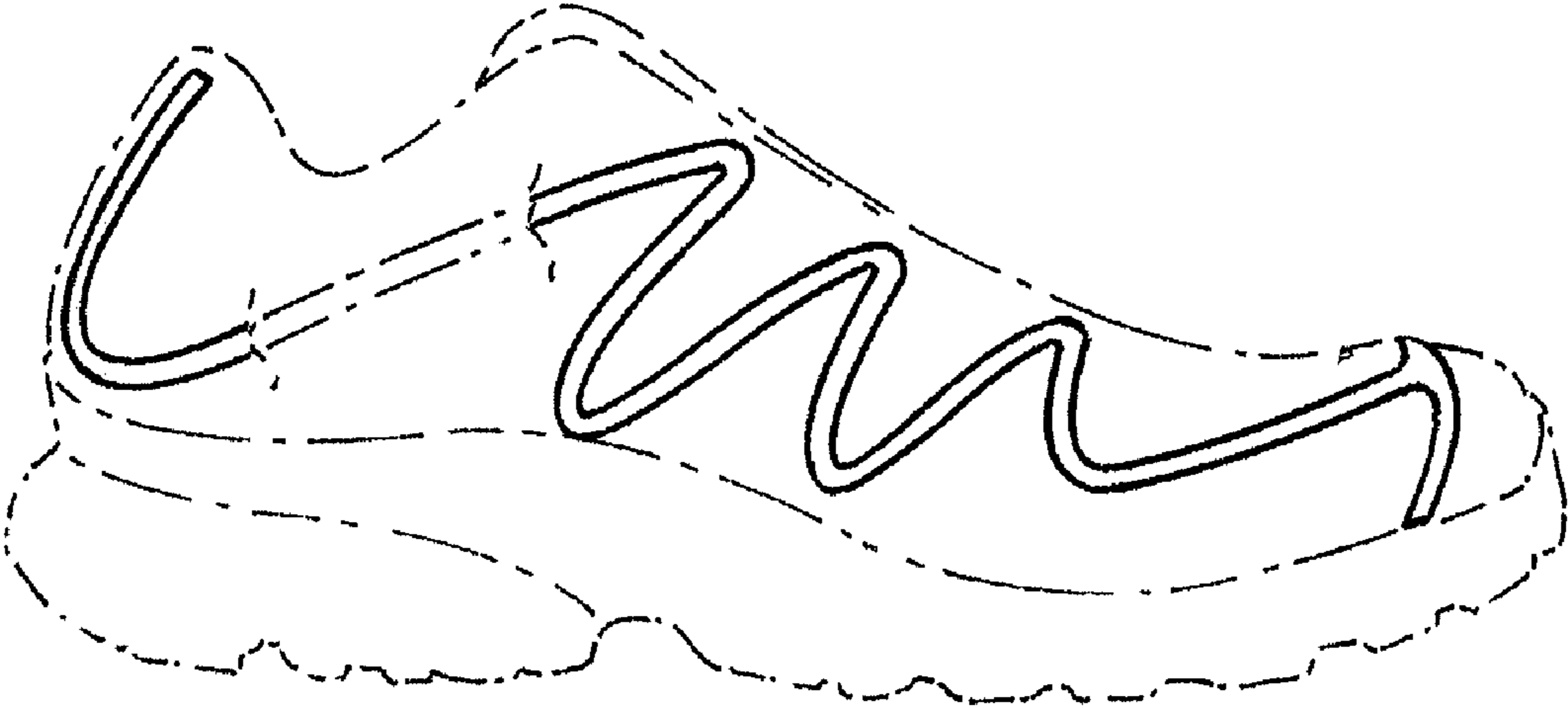

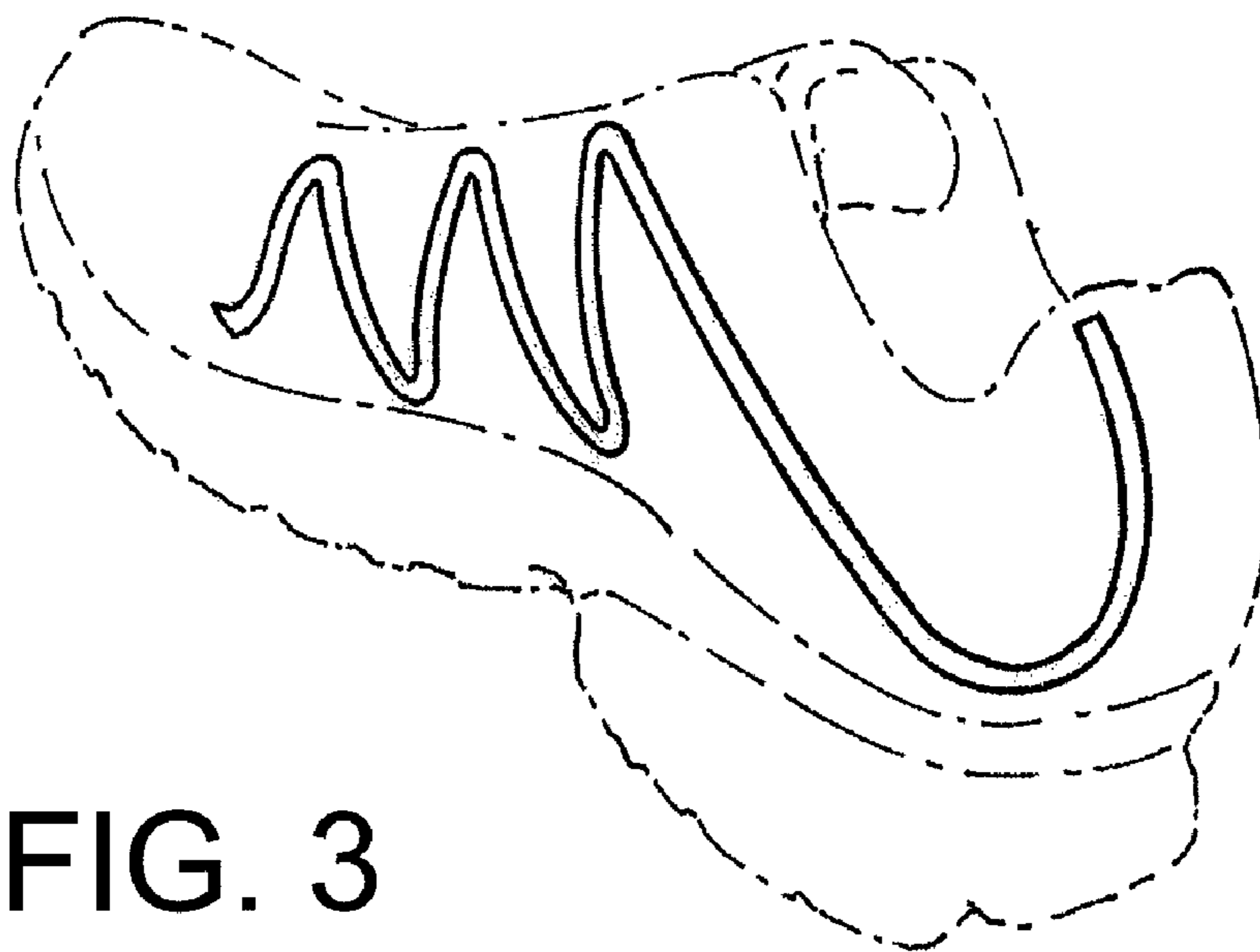
