FIG. 1 is a perspective view of an article of footwear, showing my new design; and,

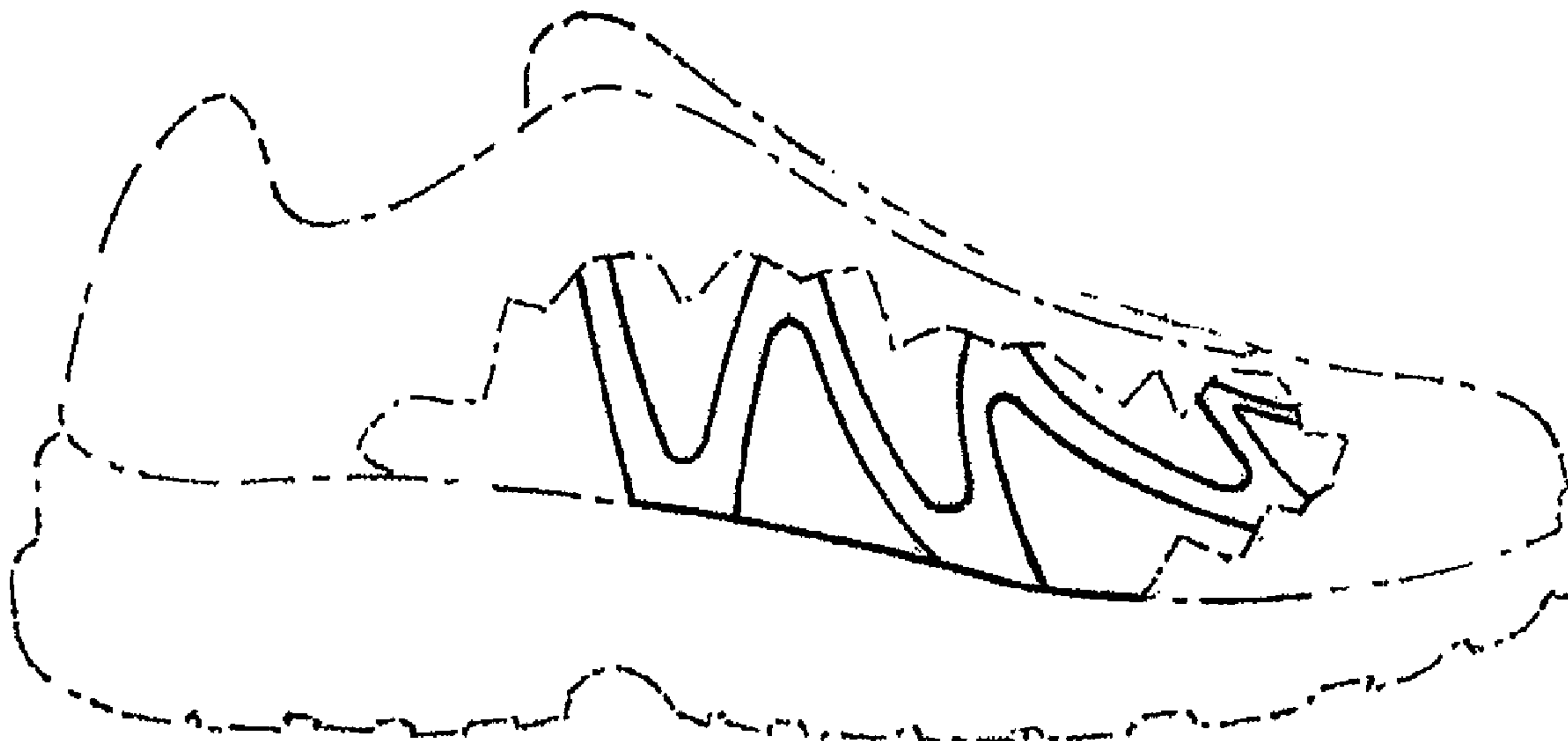
FIG. 2 is a side view thereof.

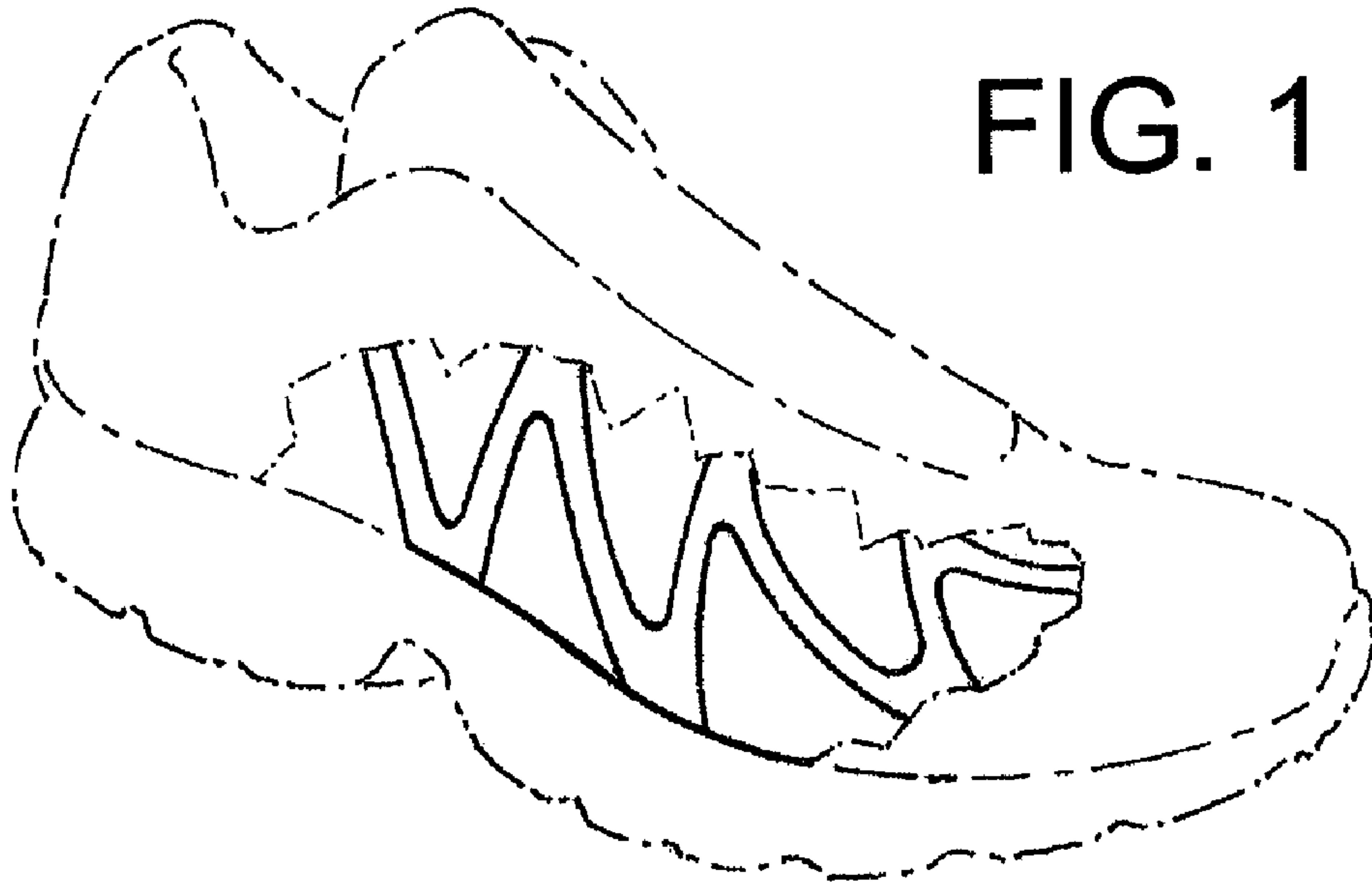

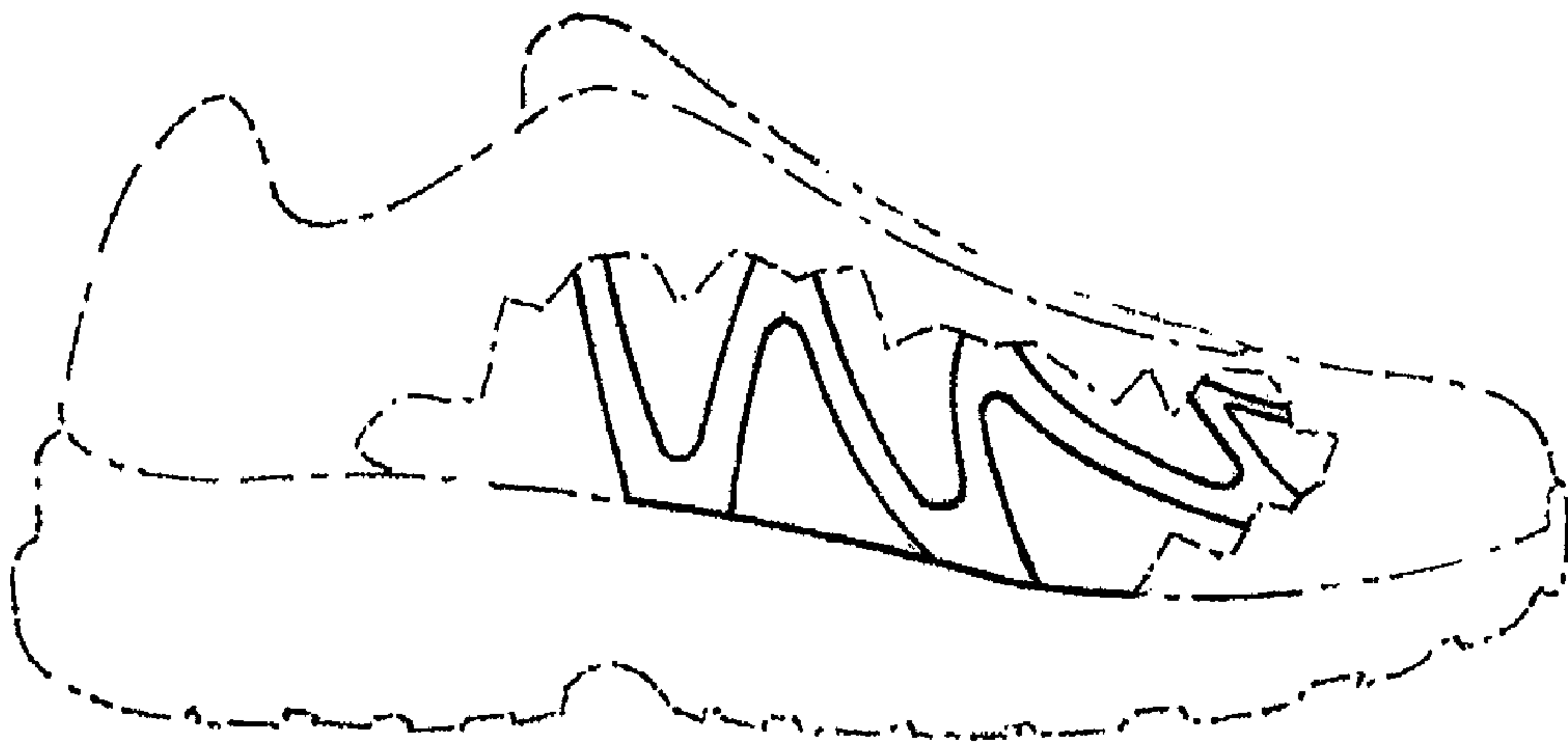
