The ornamental design for a container, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of a container according to the invention;

FIG. 2 is a bottom plan view of the container of FIG. 1;

FIG. 3 is a side plan view of the container of FIG. 1;

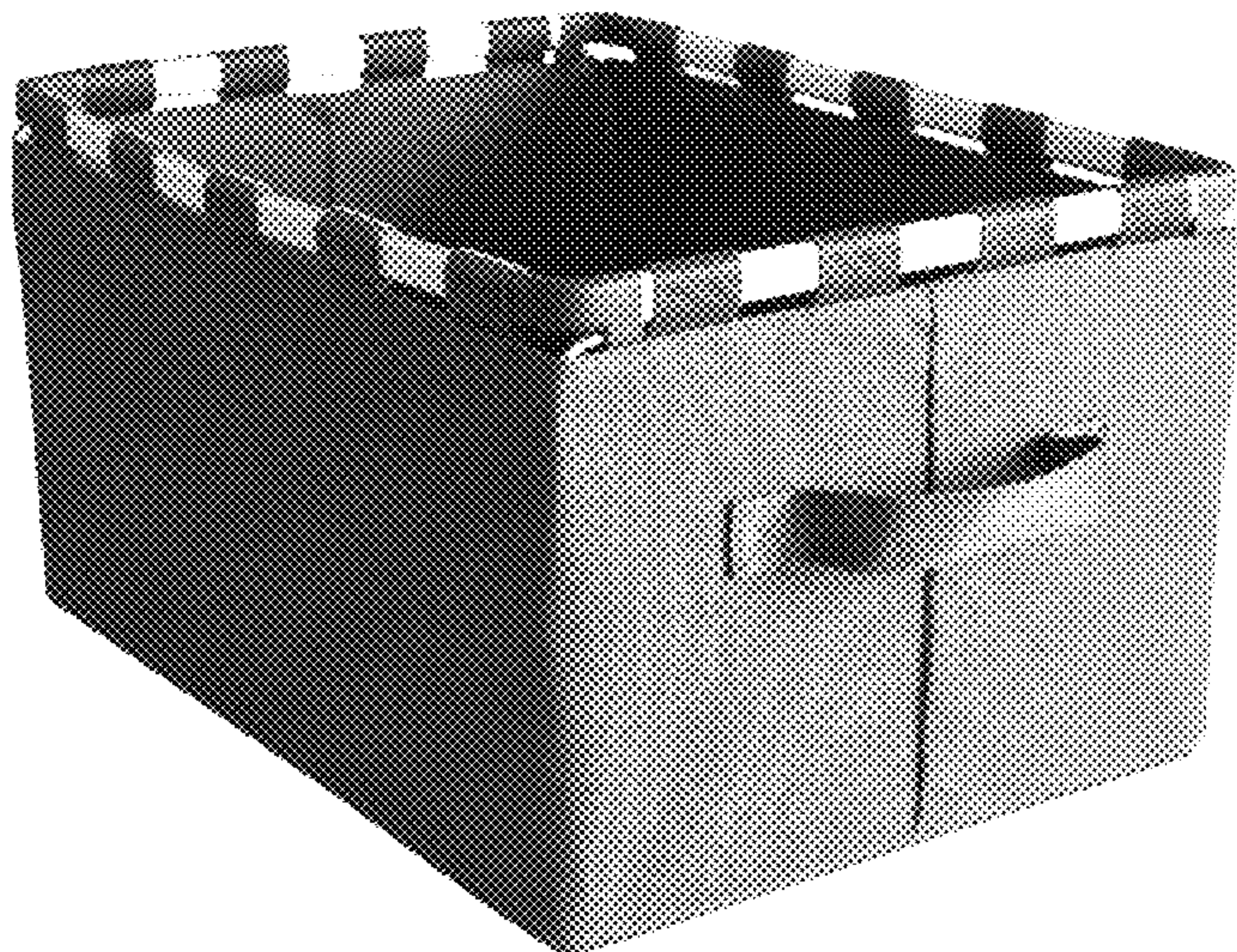
FIG. 4 is a front plan view of the container of FIG. 1;

FIG. 5 is a perspective view of the container of FIG. 1 from an upper corner thereof;

FIG. 6 is a perspective view of the container of FIG. 1 from above a front side thereof in an alternative configuration of the container; and,

FIG. 7 is a perspective view of the container of FIG. 1 from above a corner thereof in another alternative configuration of the container, the figures of the Drawings herein are directed to the cumulative appearance of all configurations illustrated.

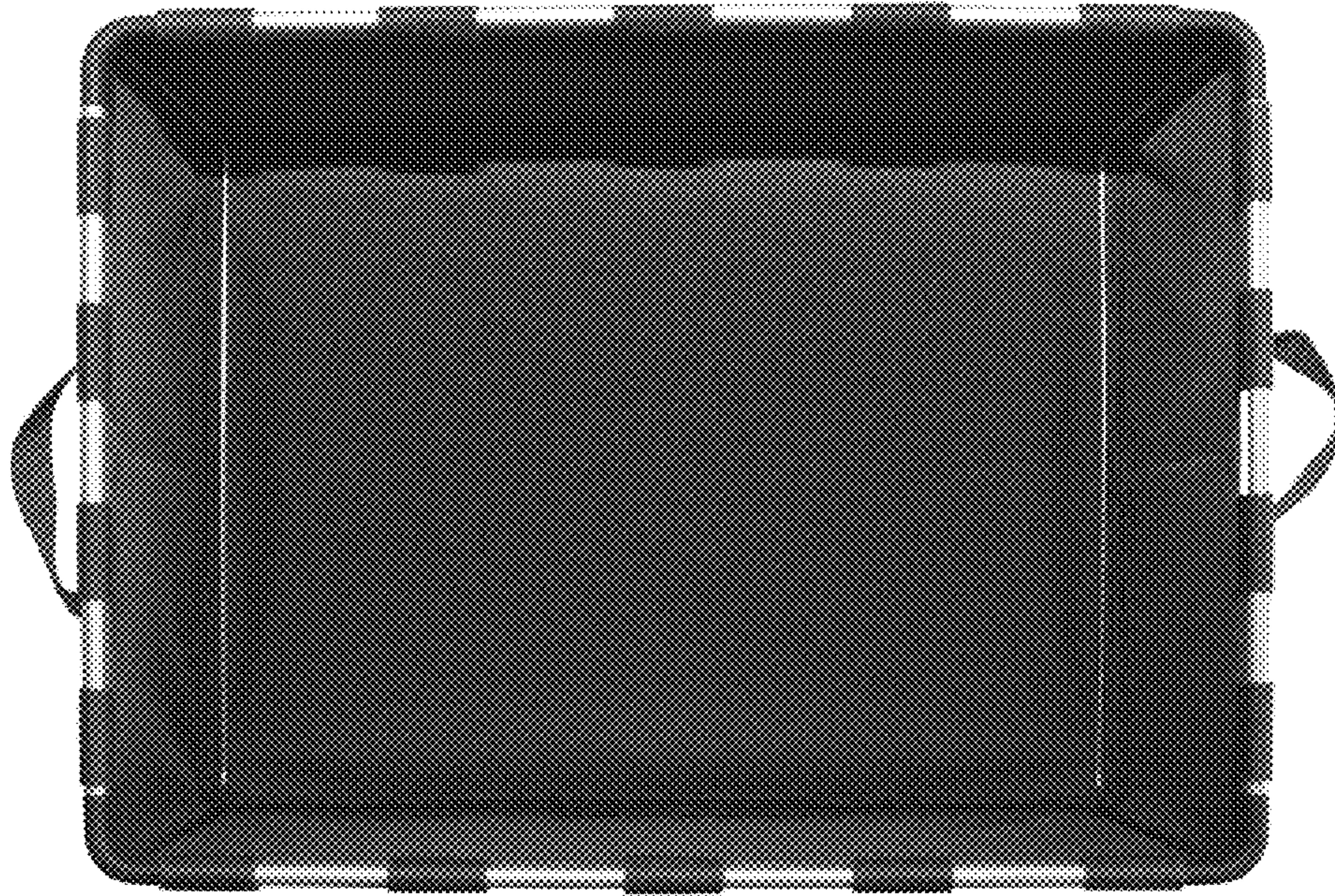

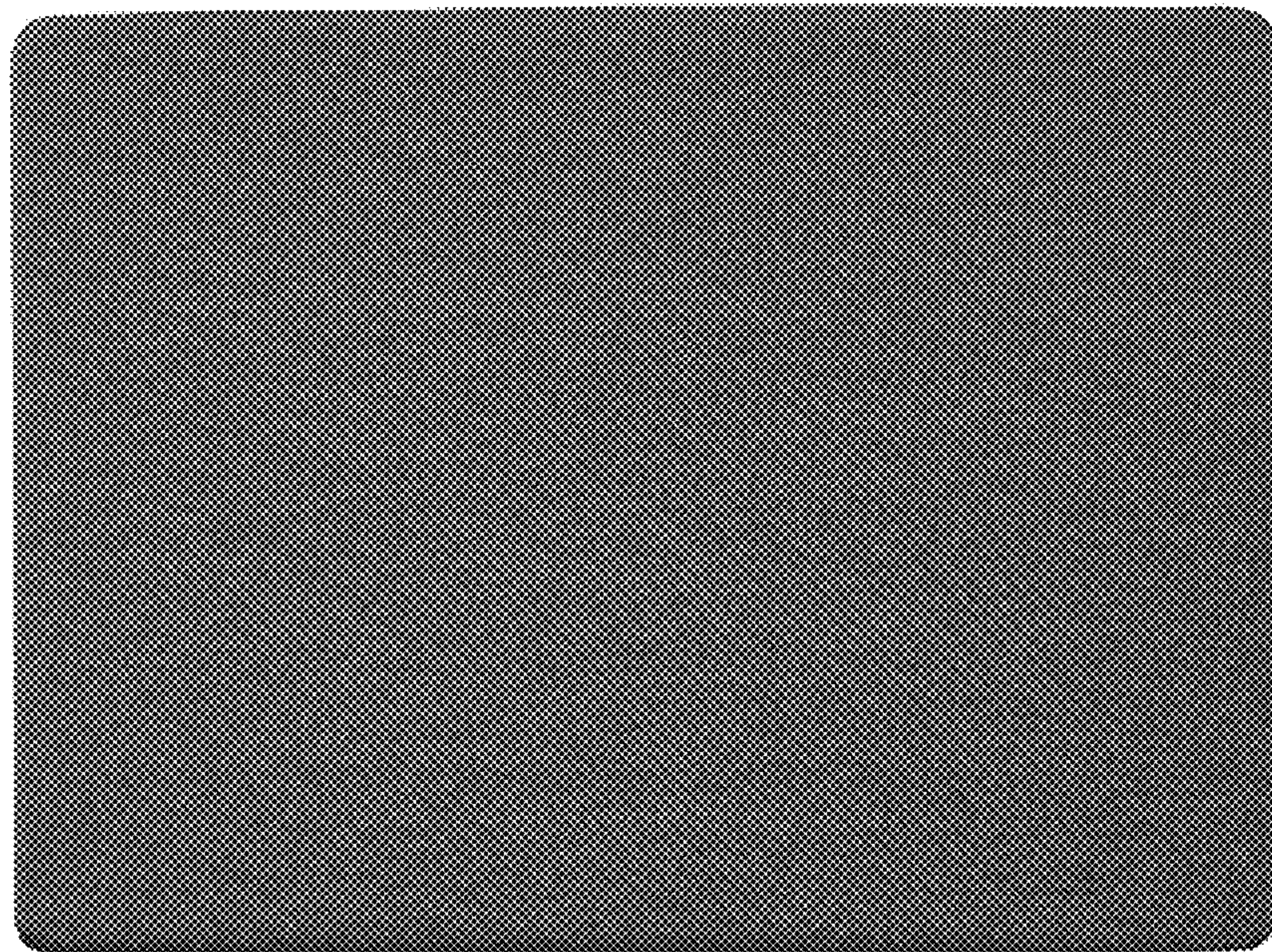

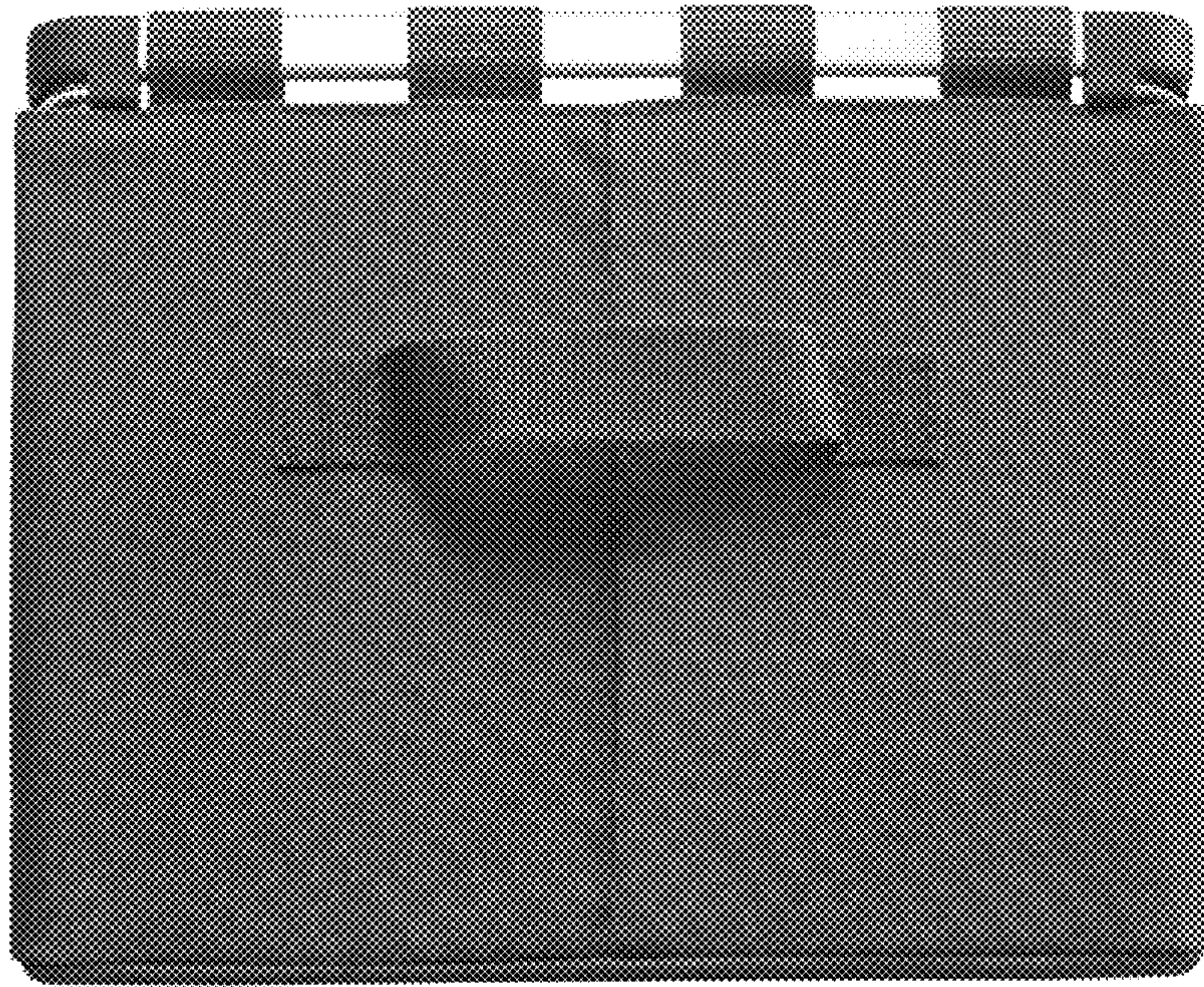

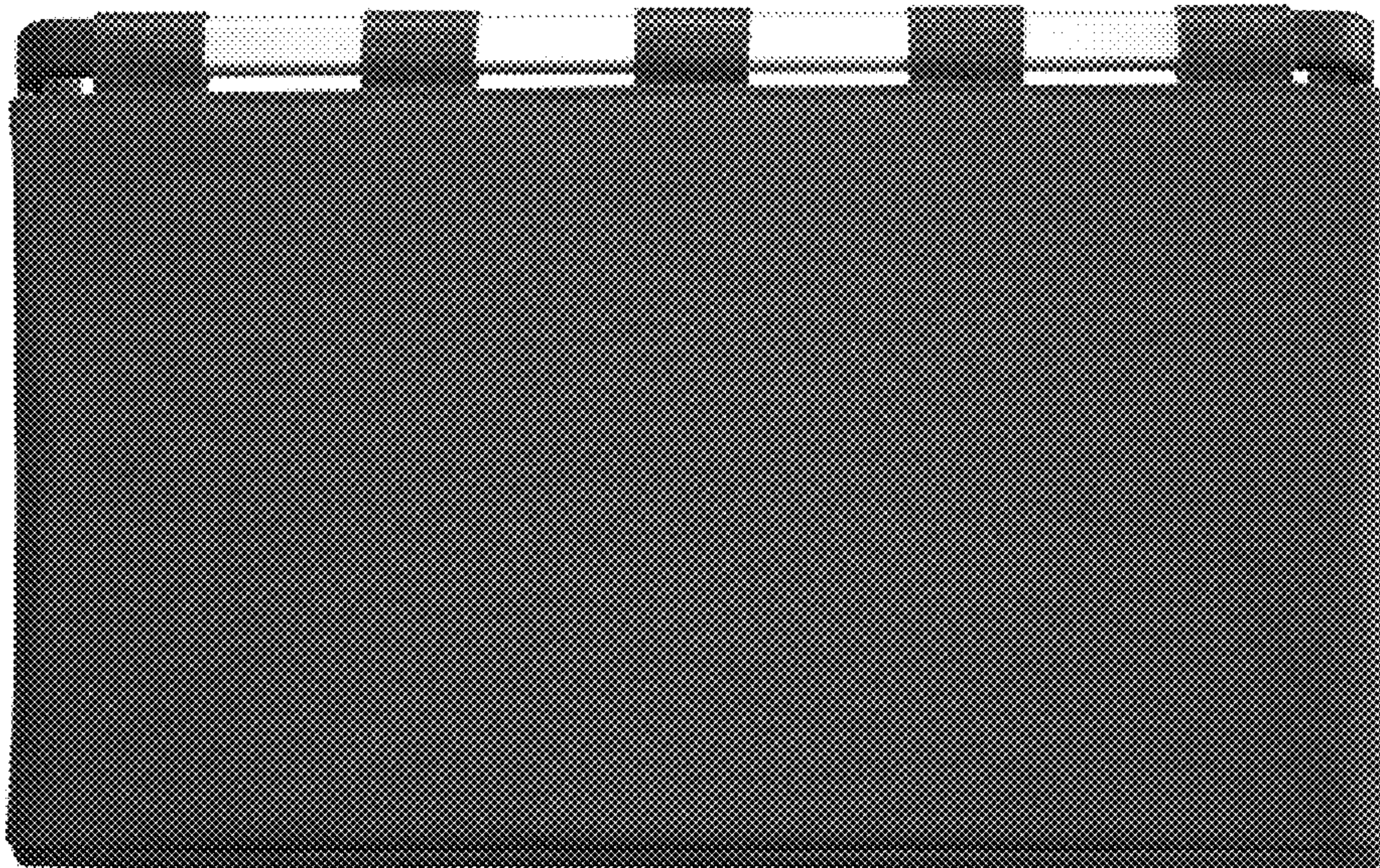

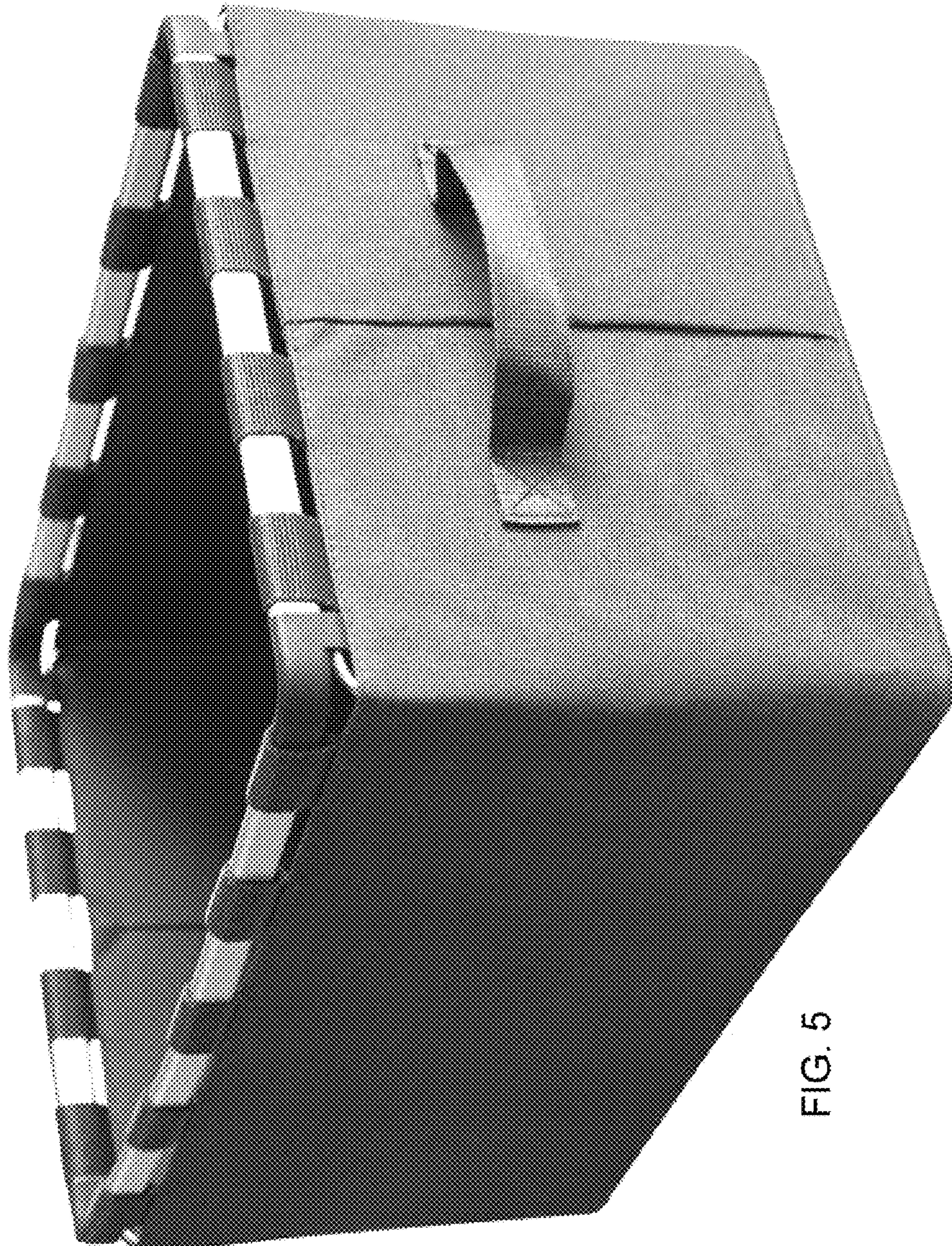

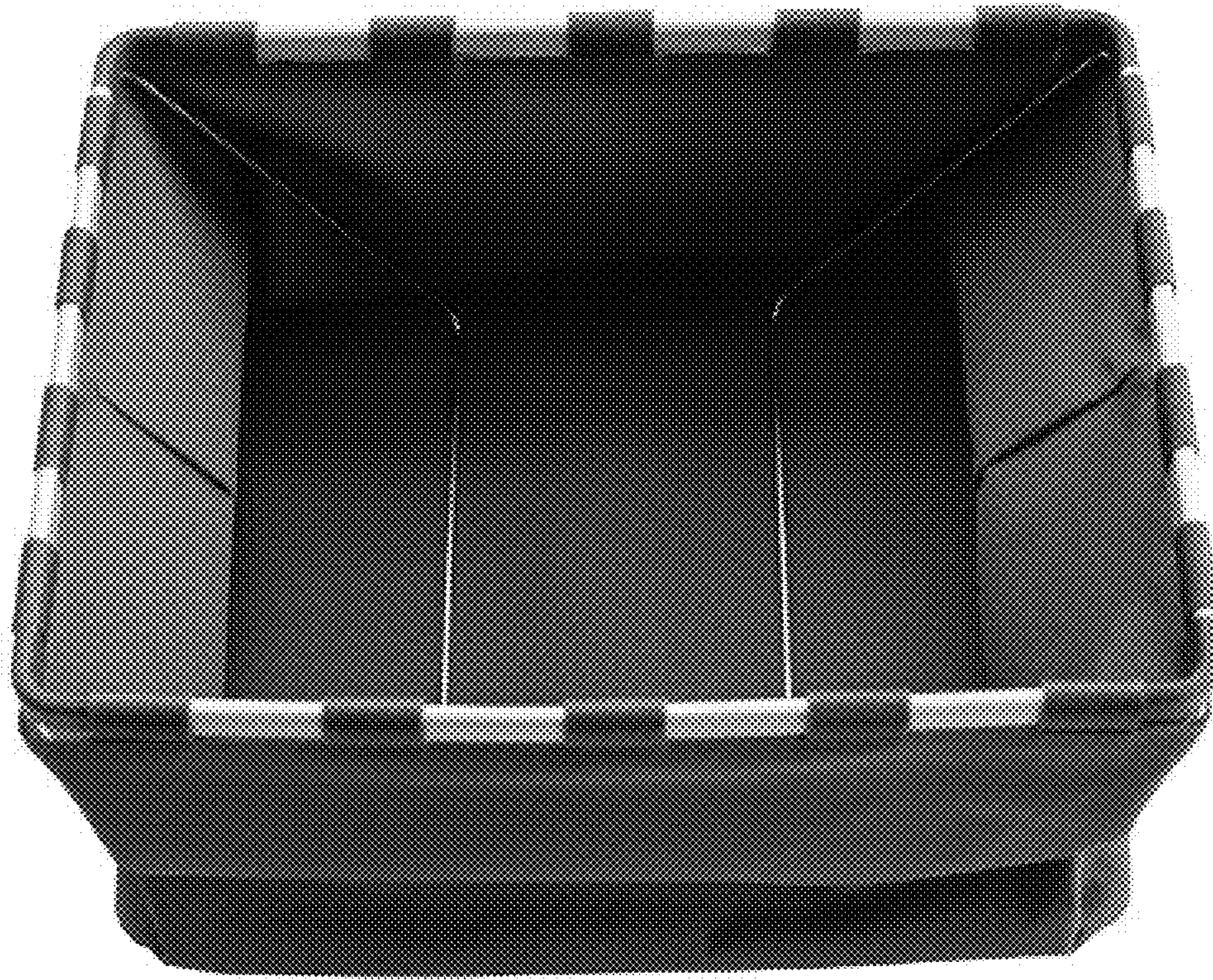
