(57) **CLAIM**

The ornamental design for a lid for travel mug, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of the lid for travel mug showing the valve in the open position;

FIG. 2 is a top view of the lid for travel mug;

FIG. 3 is a bottom view of the lid for travel mug;

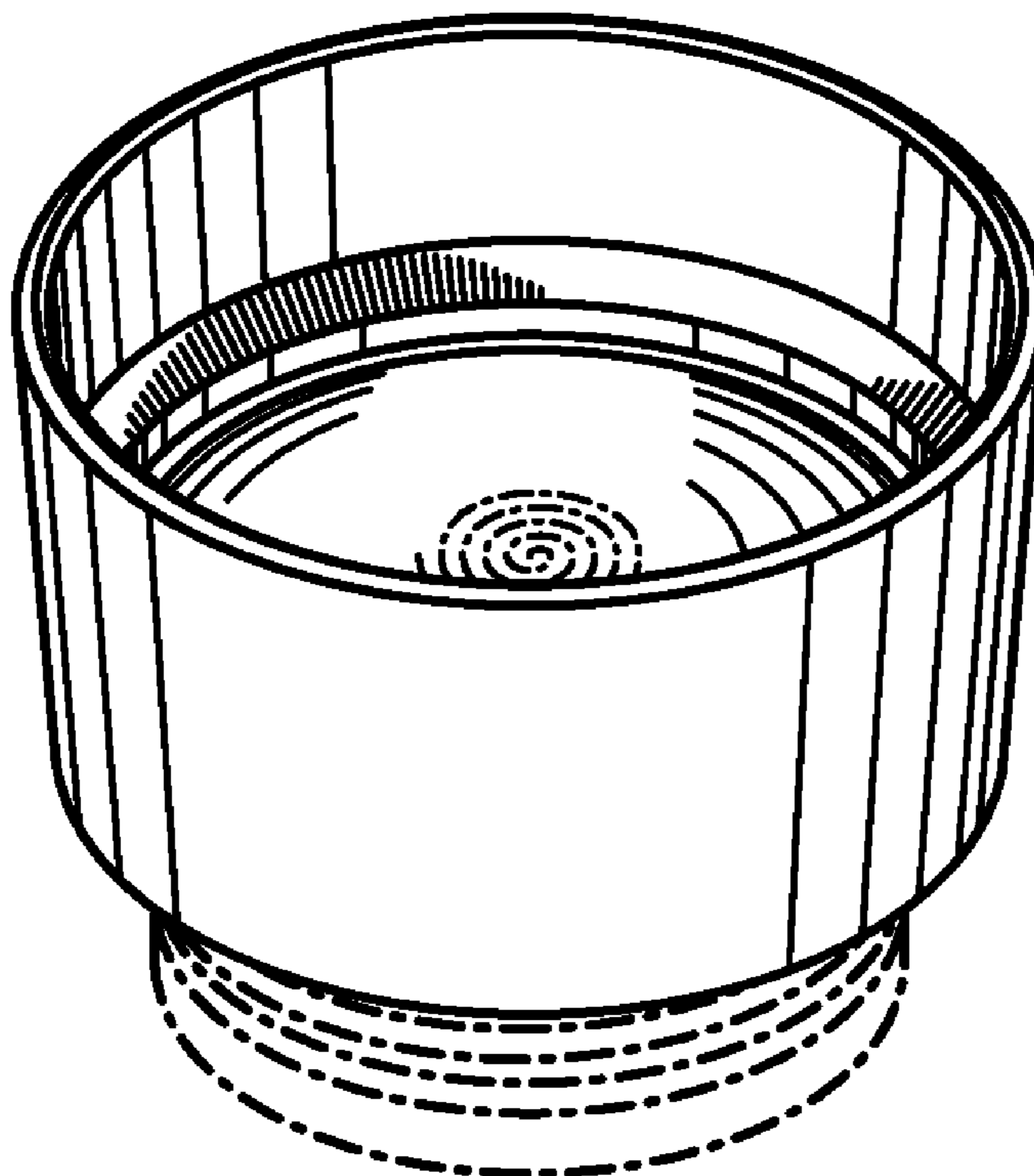
FIG. 4 is a side view of the lid for travel mug;

FIG. 5 is a front perspective view of the lid for travel mug showing the valve in the closed position; and,

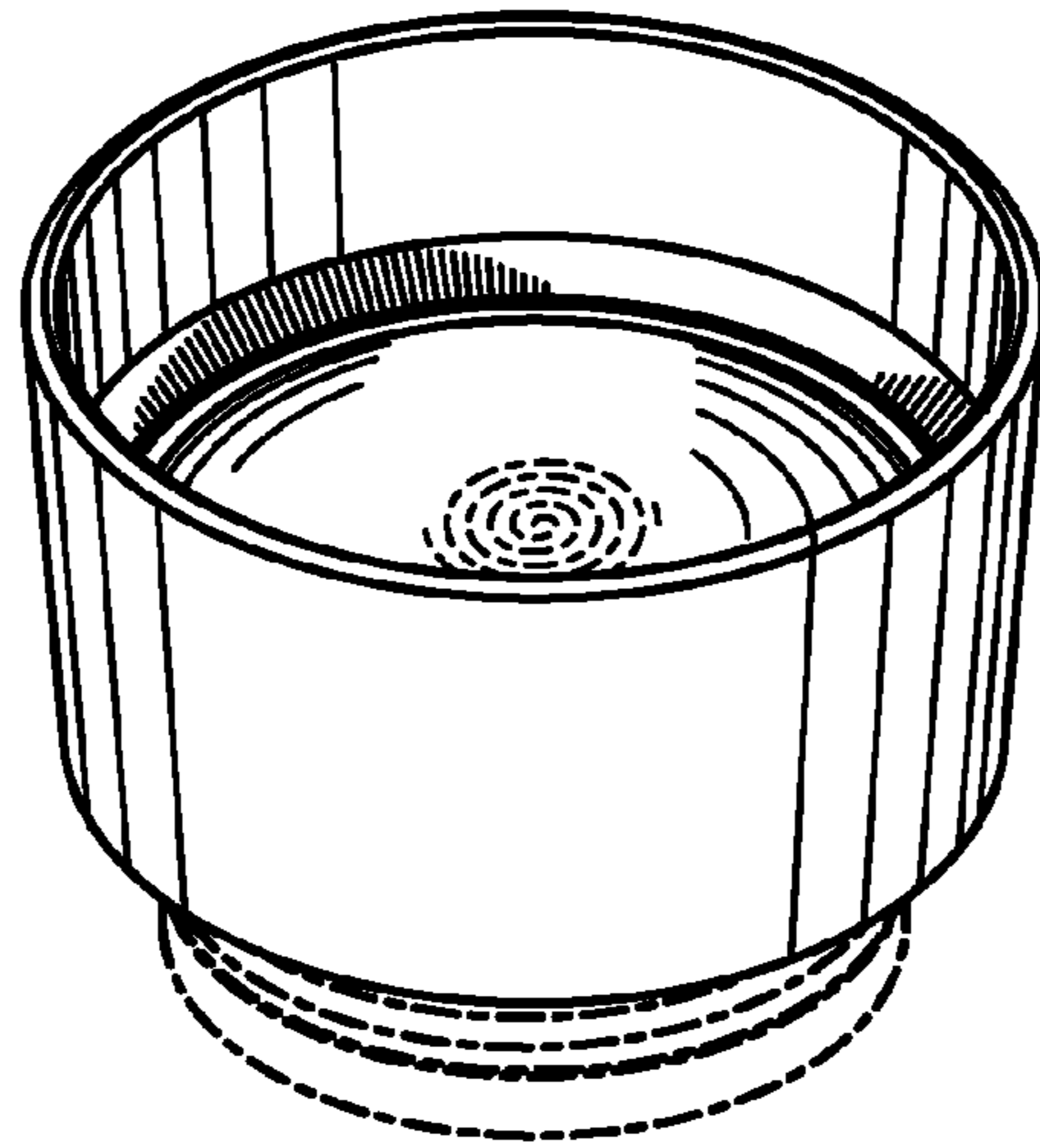

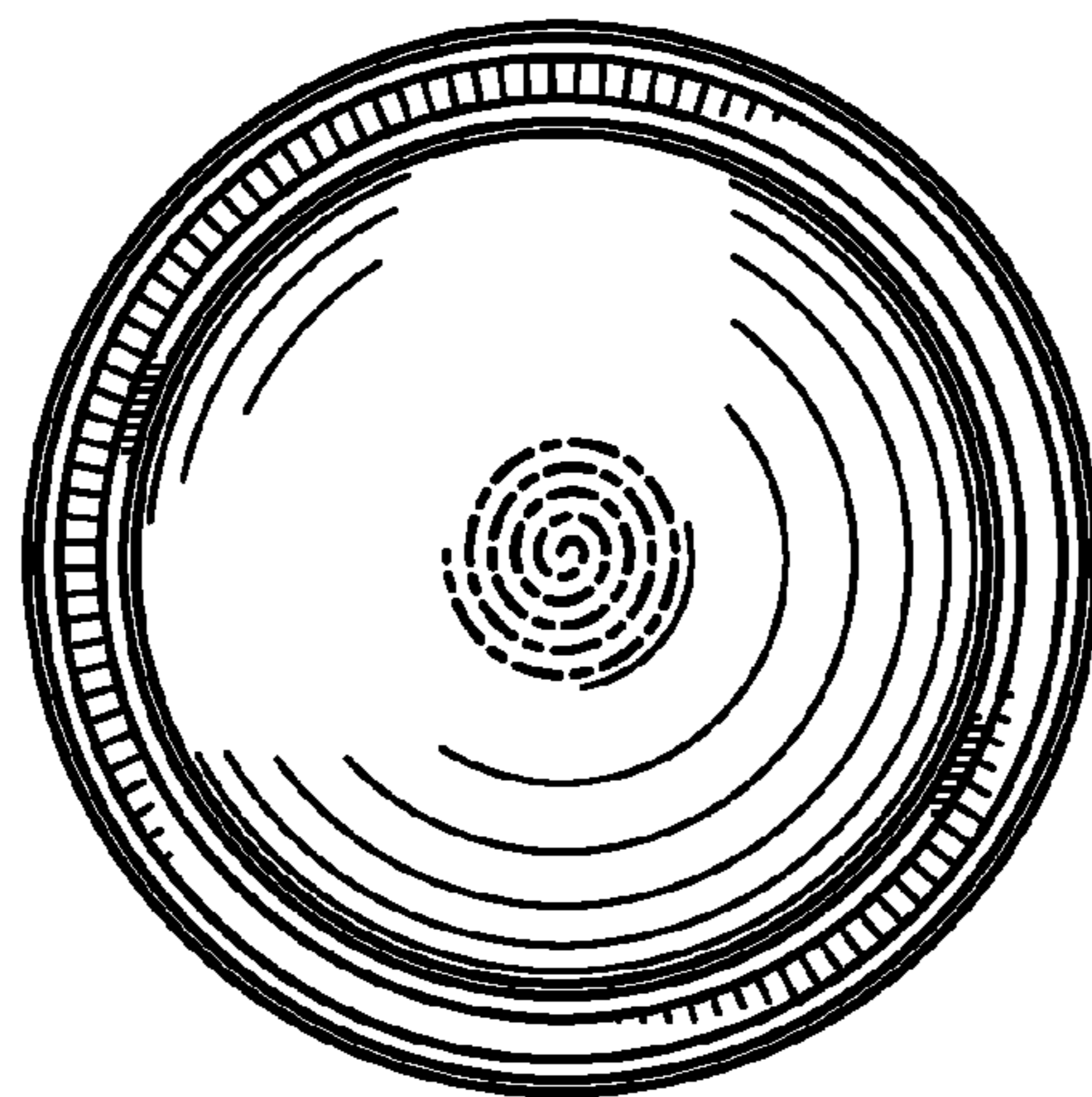

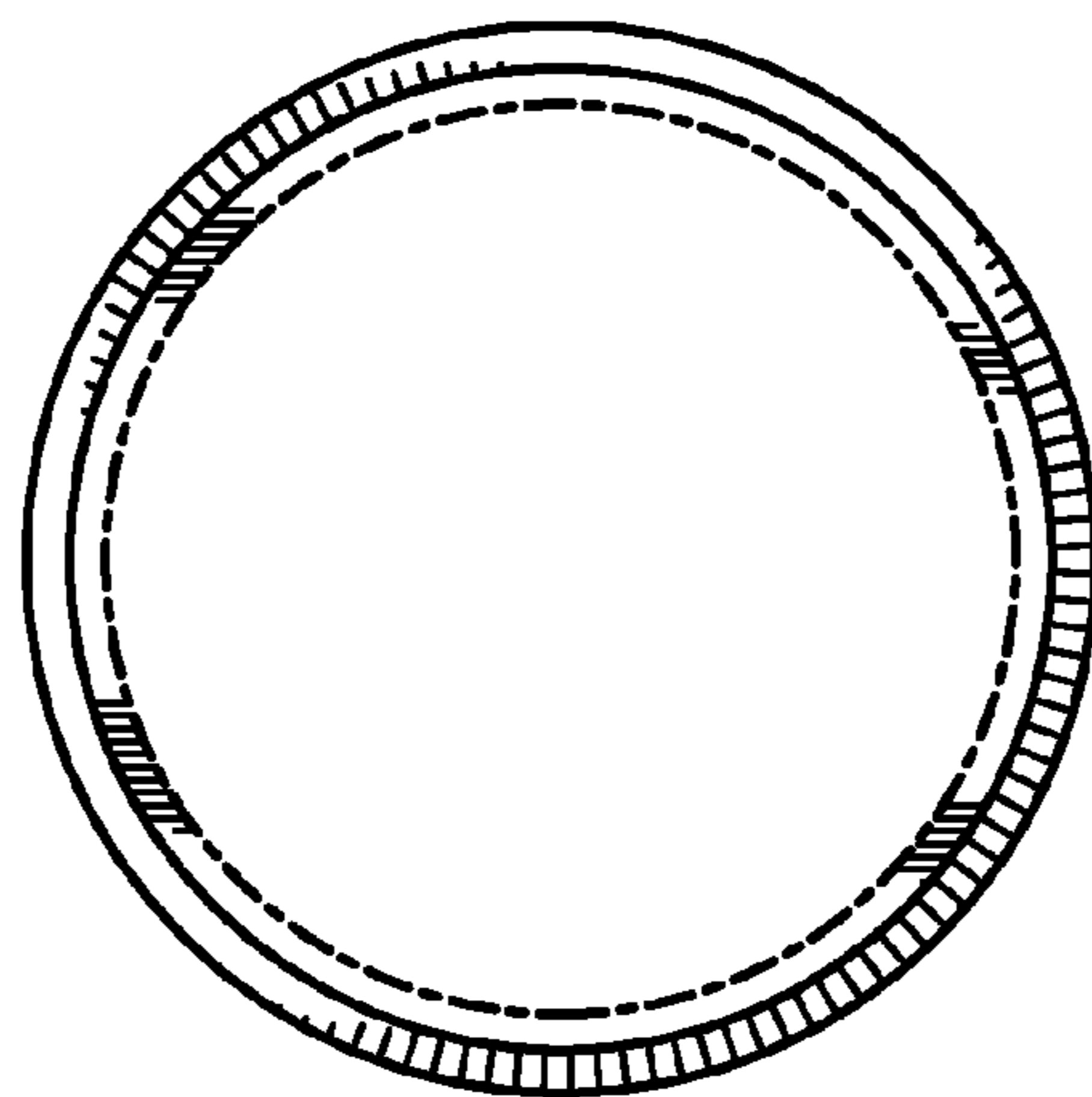

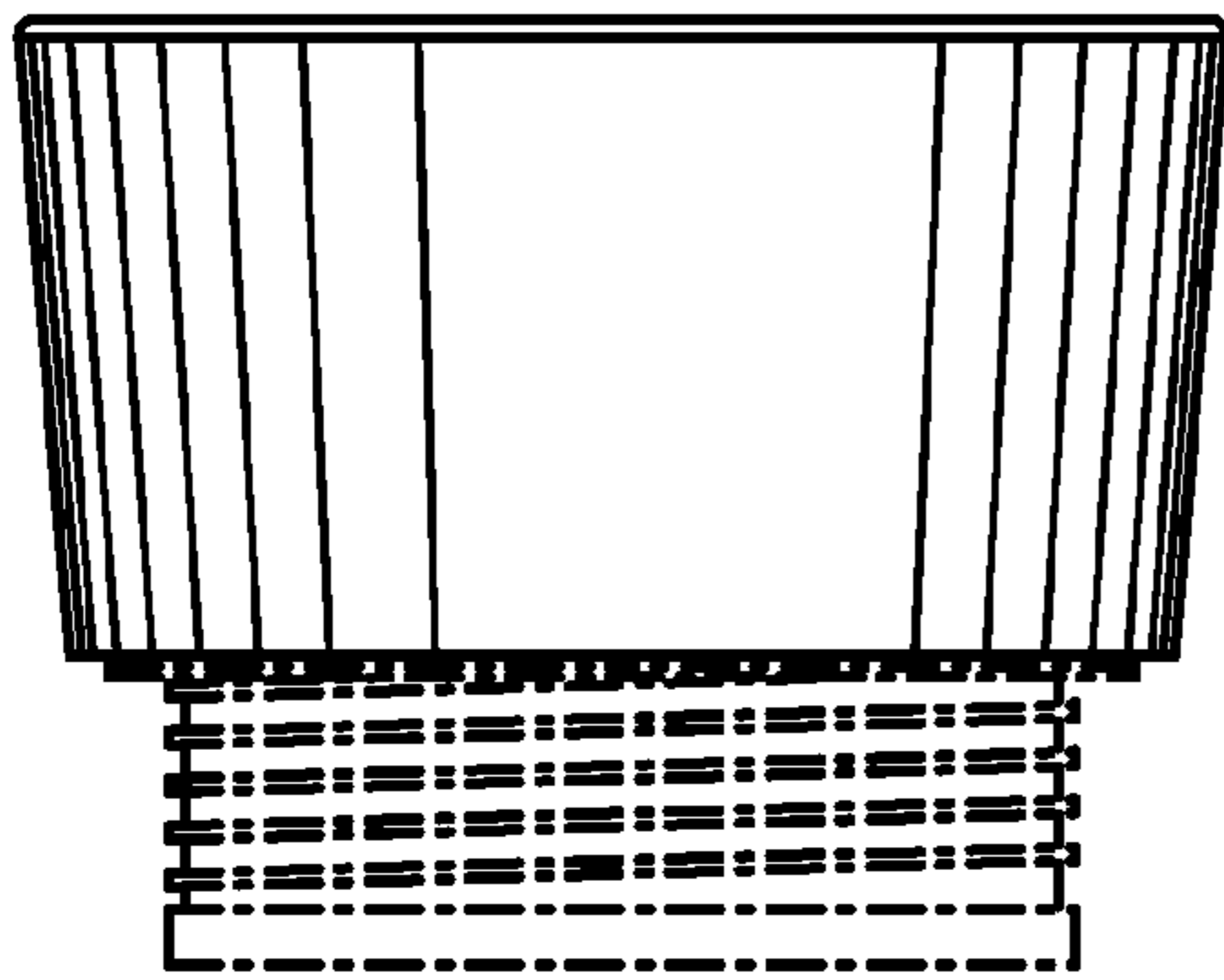

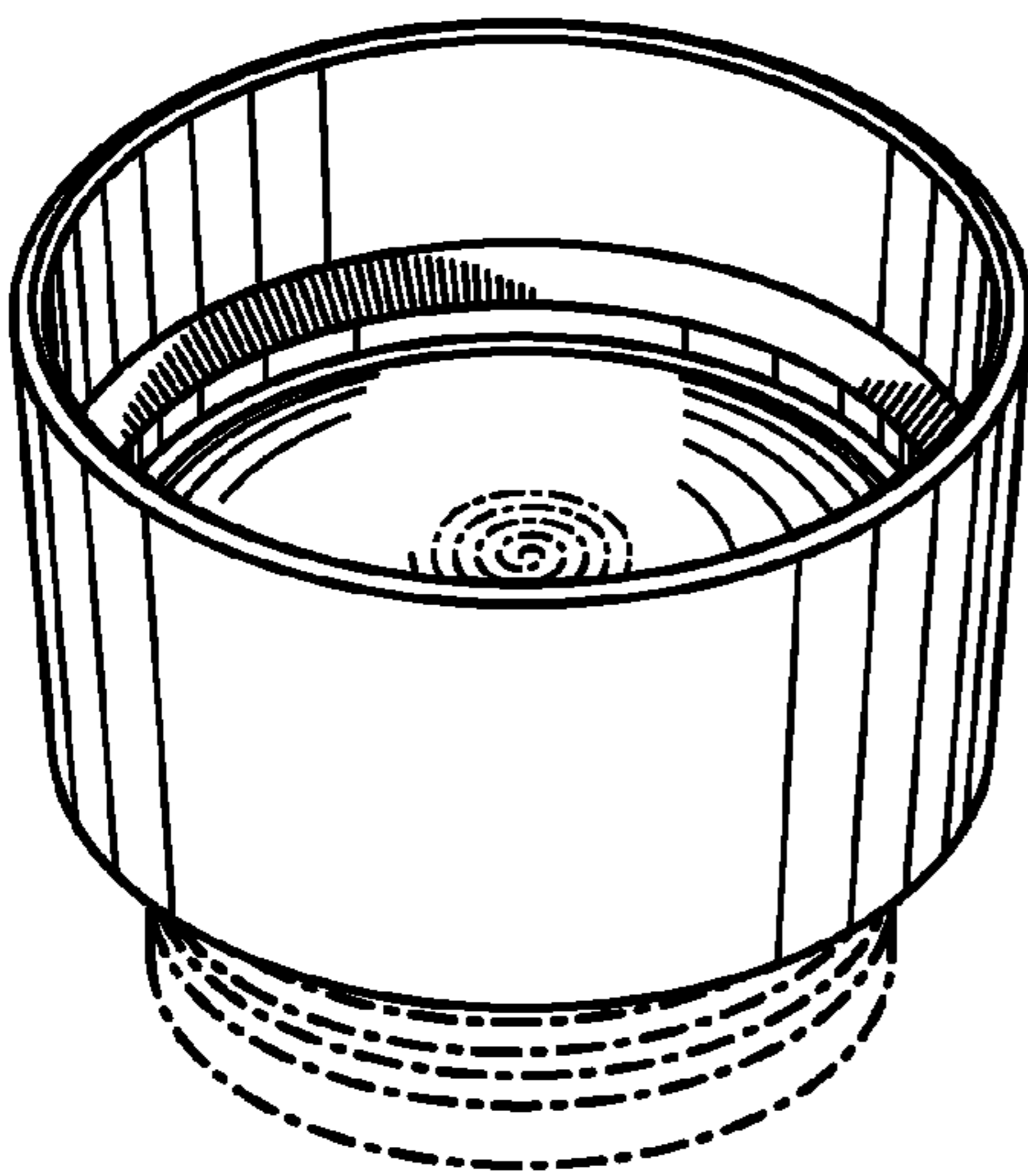

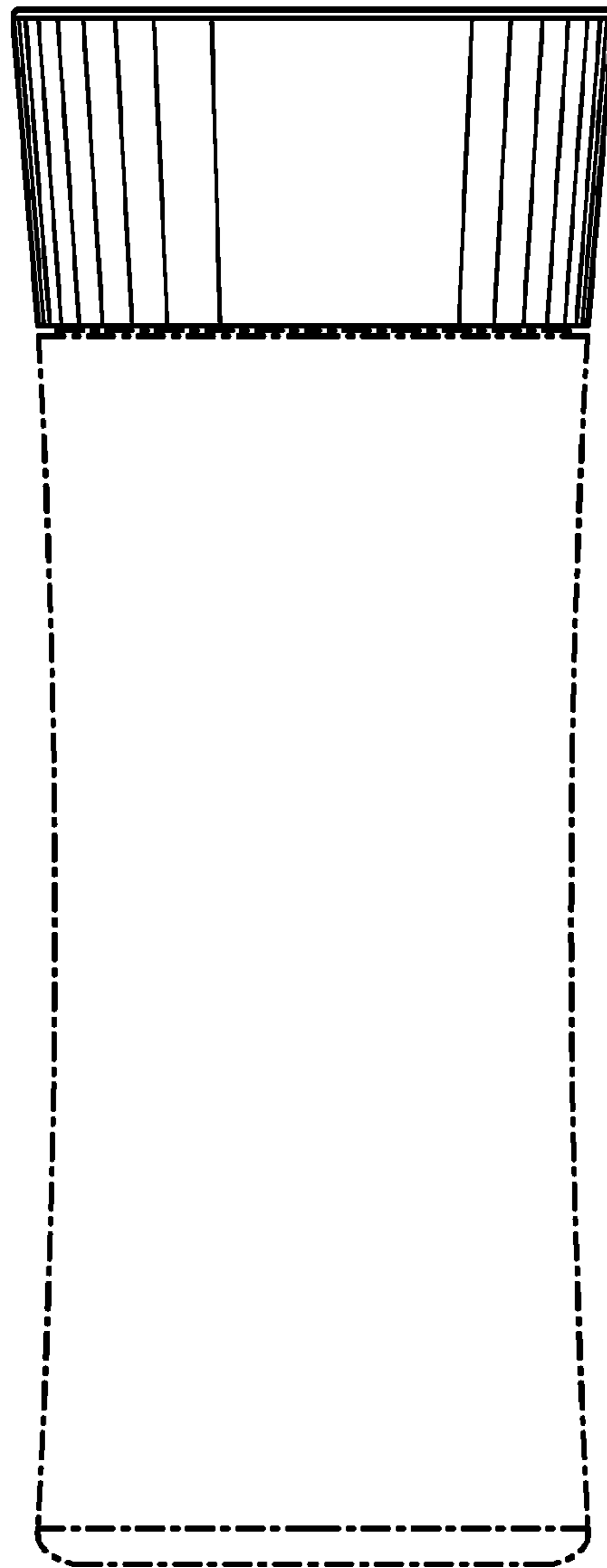
