DESCRIPTION

FIG. 1 is a perspective view of a bottle showing my new design;

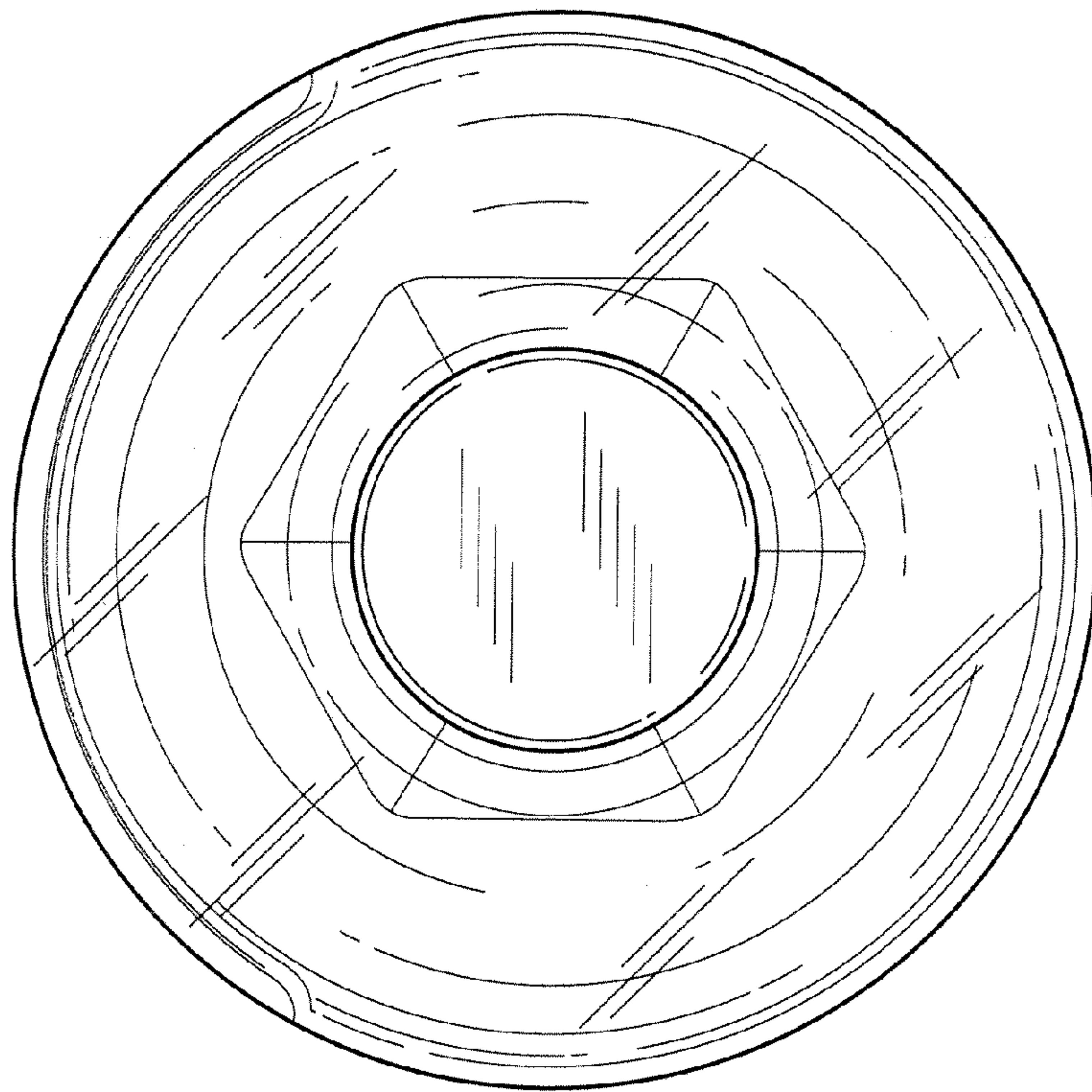

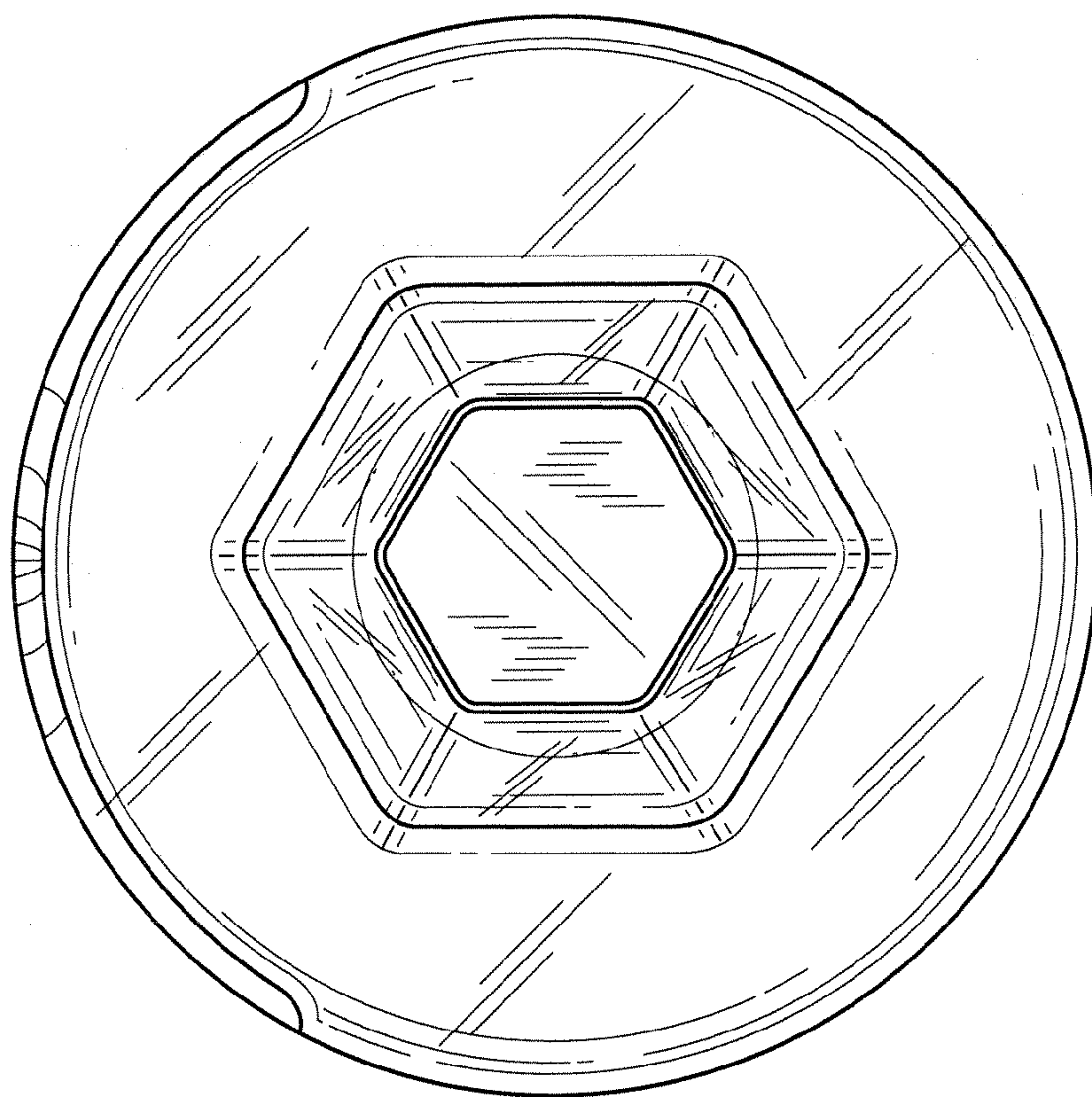

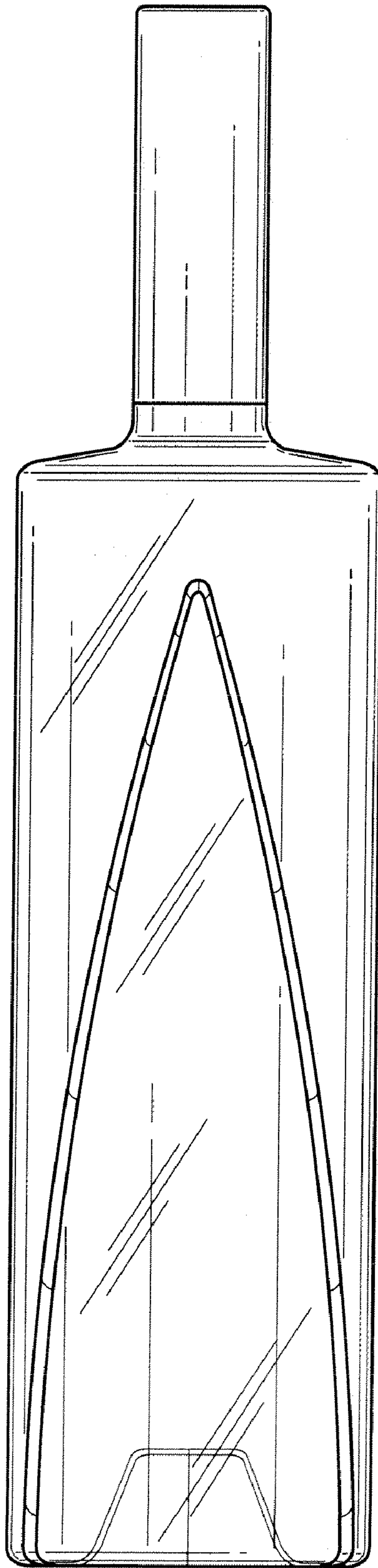

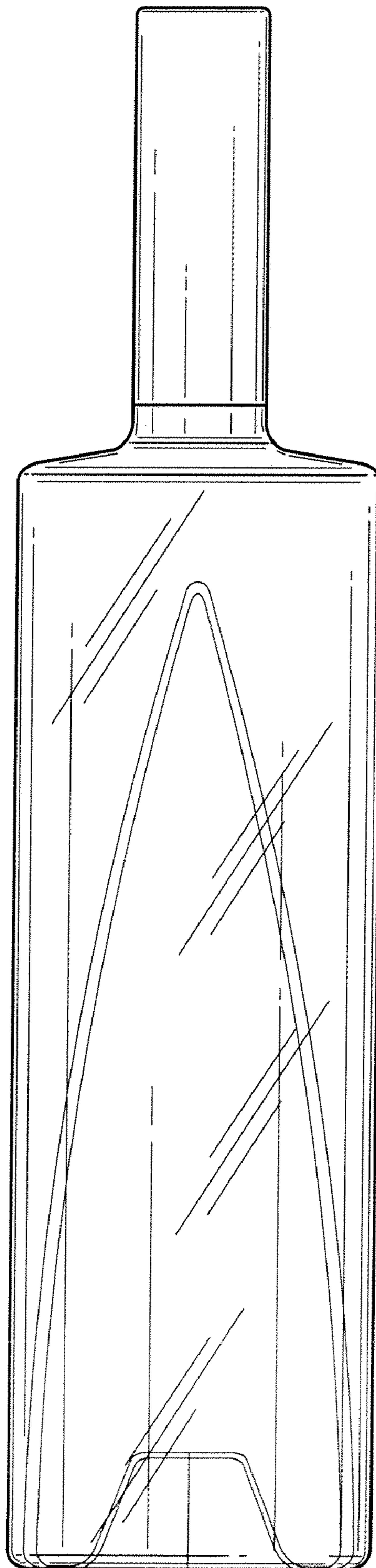

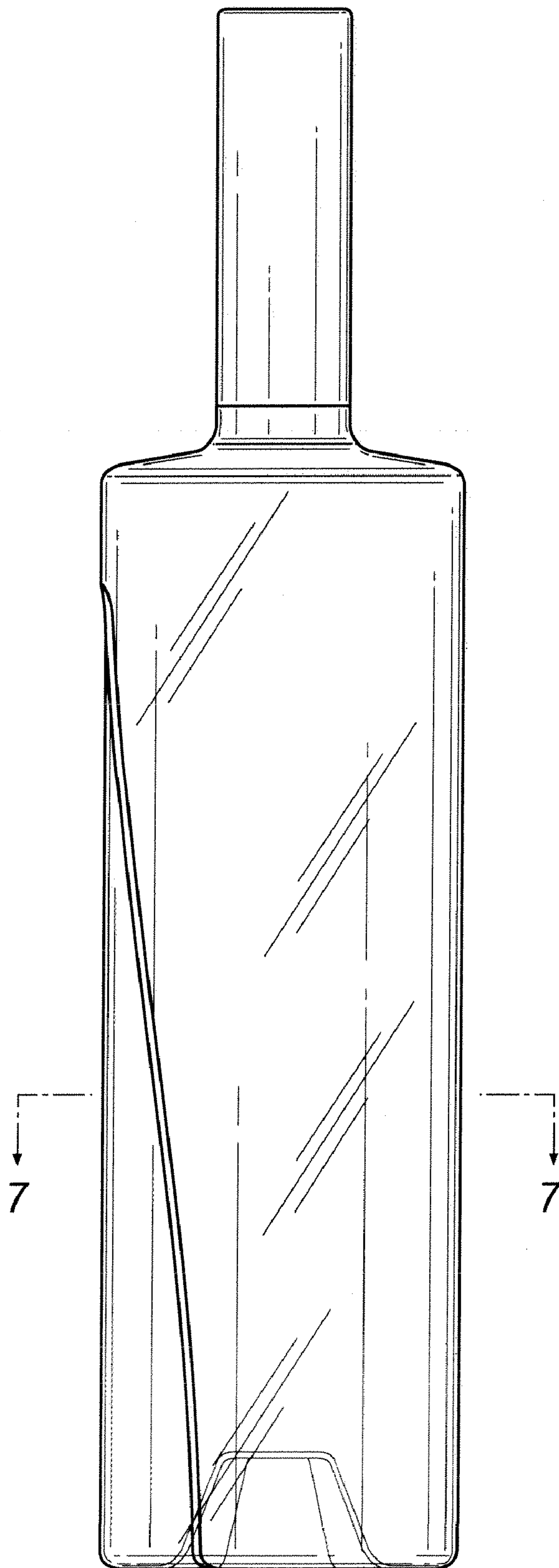

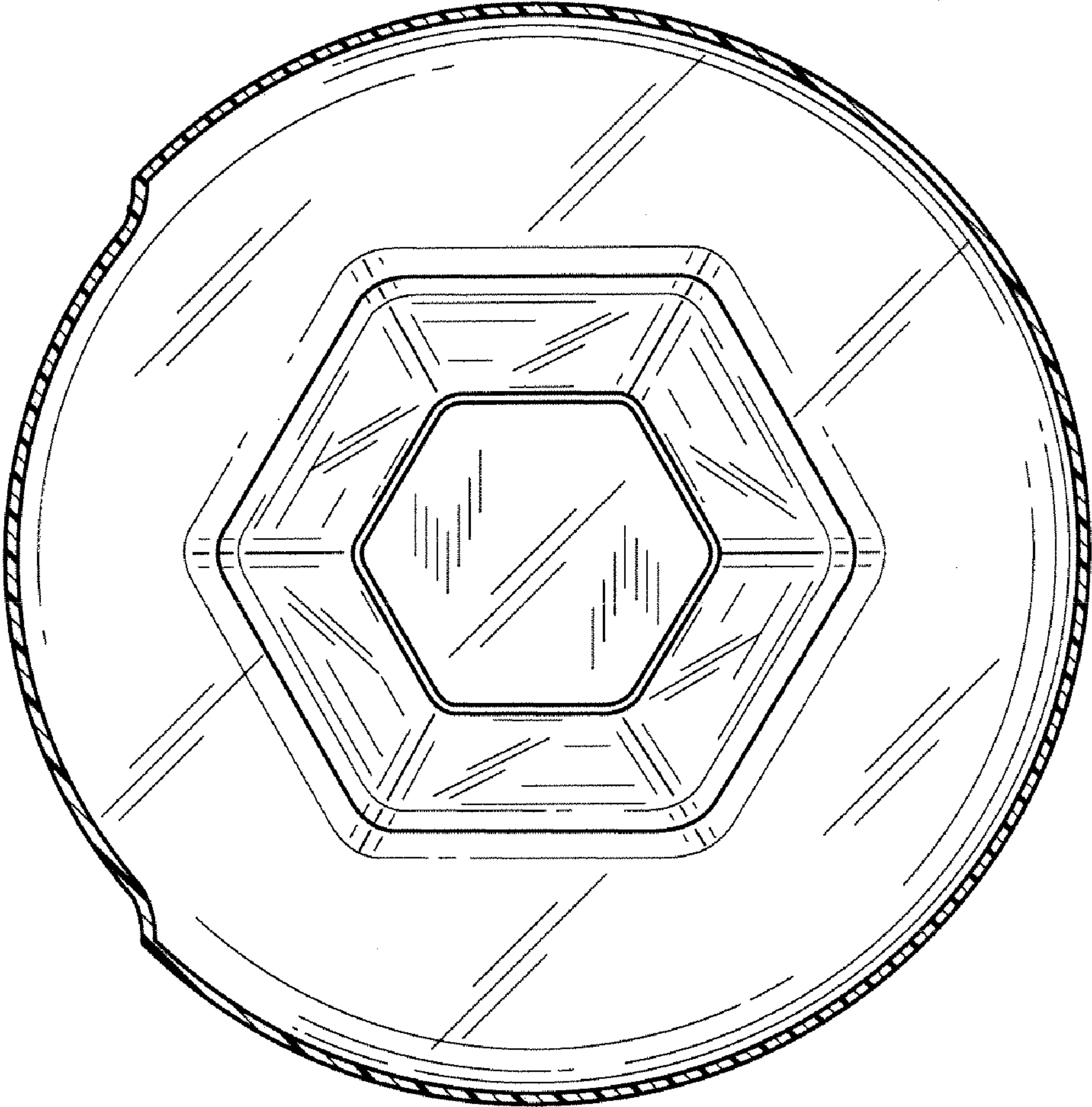
