FIG. 1 is a bottom plan view of a combined bottle and cap, embodying my new design;

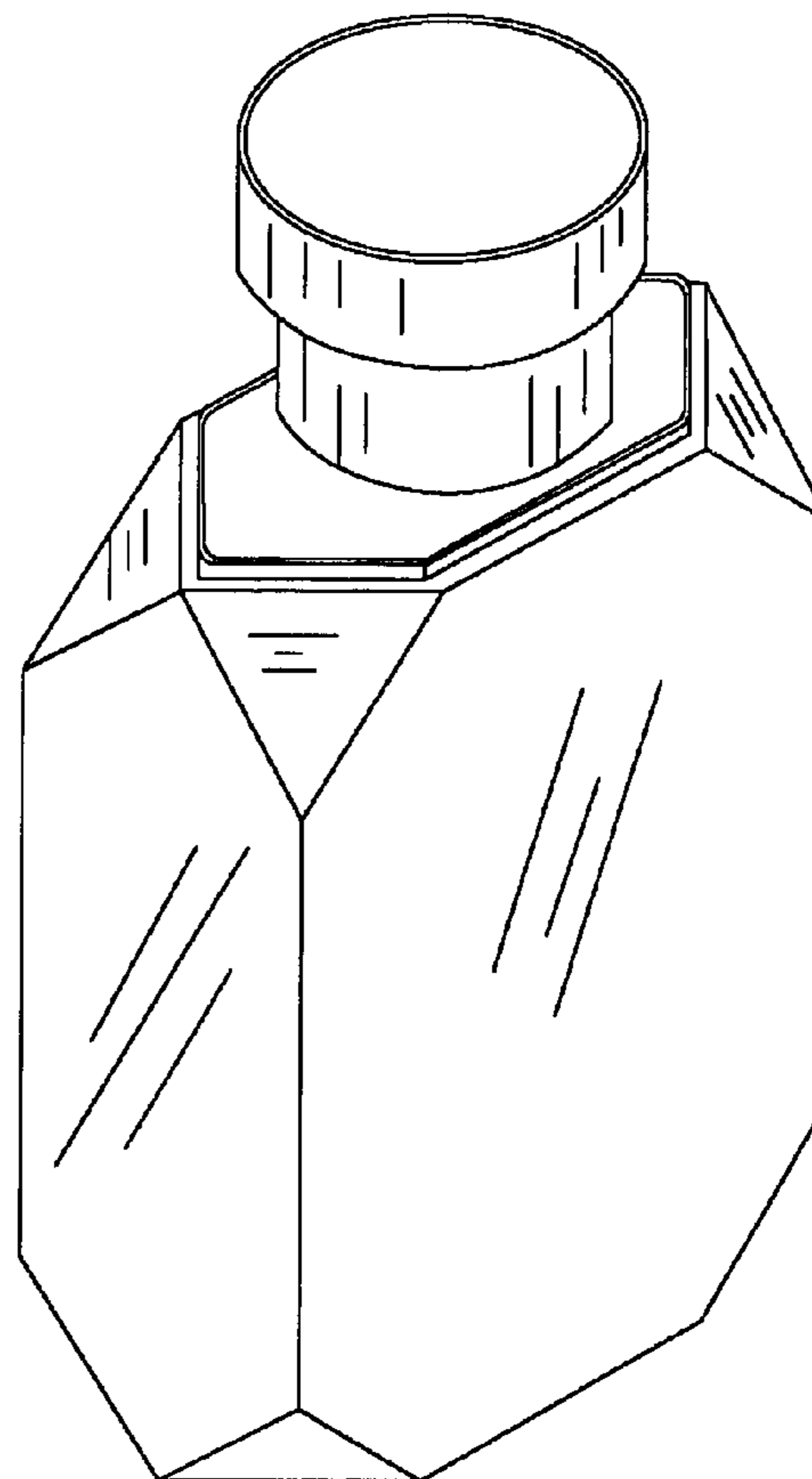
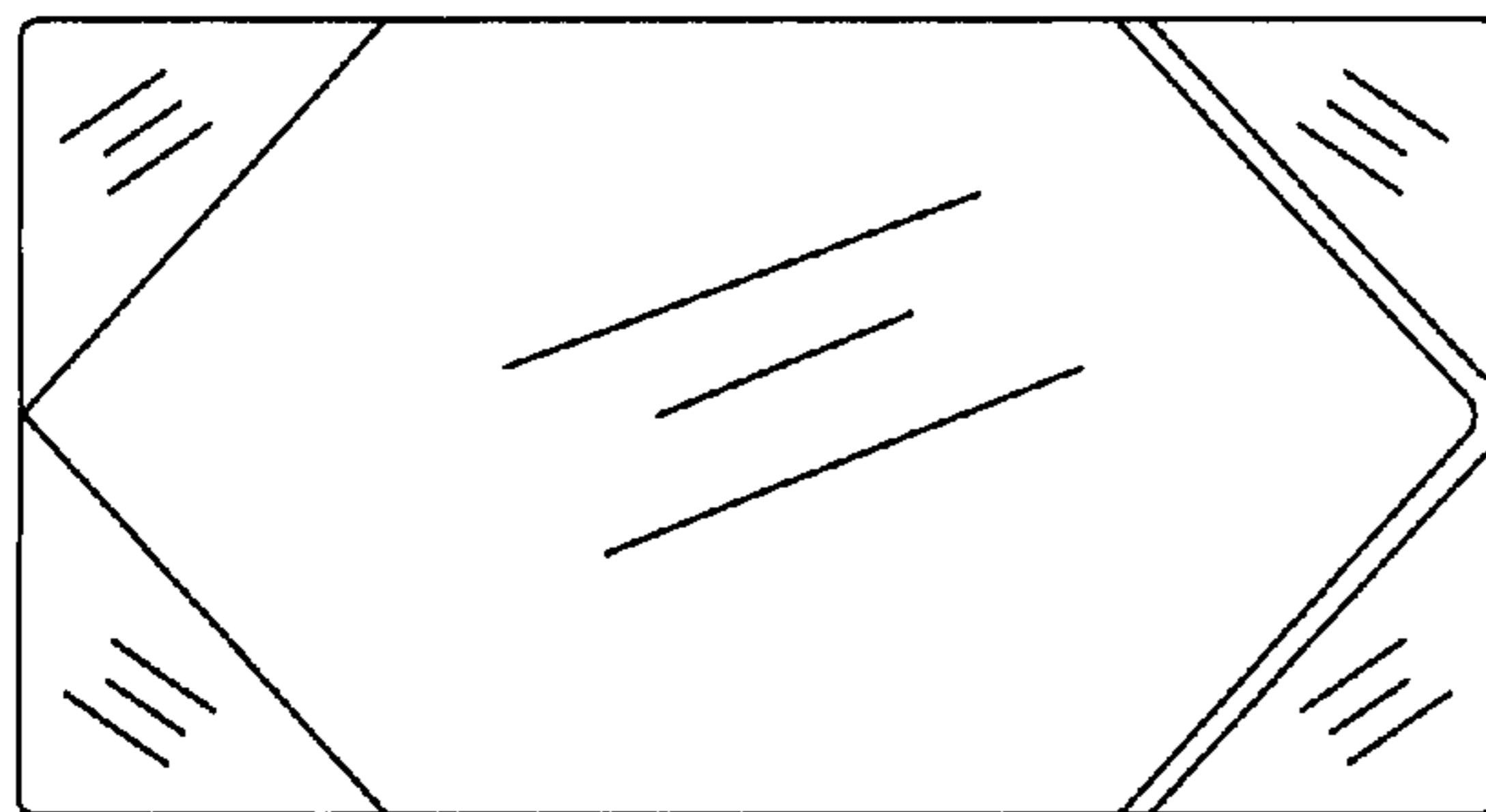
FIG. 2 is a front view thereof;

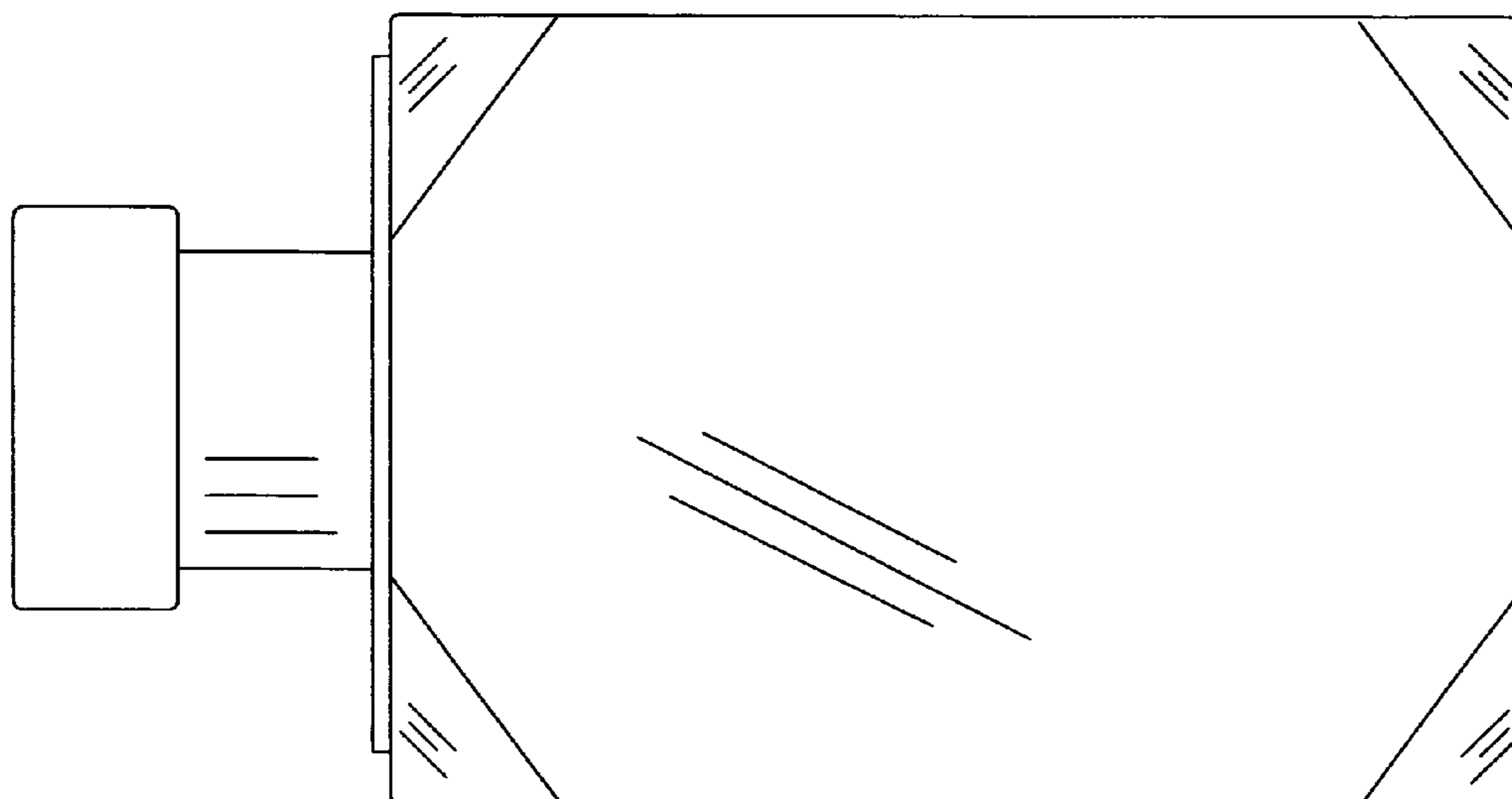

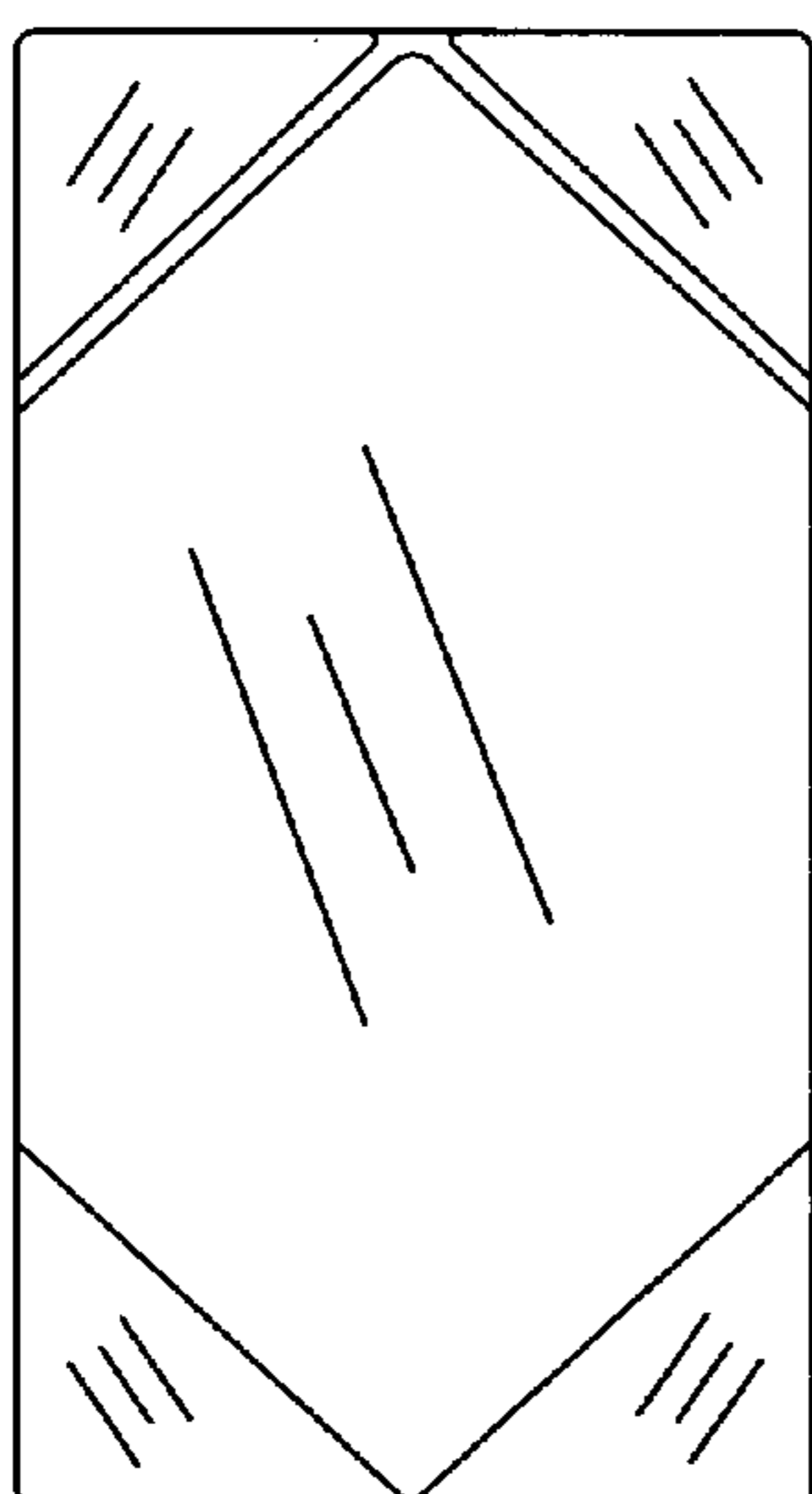

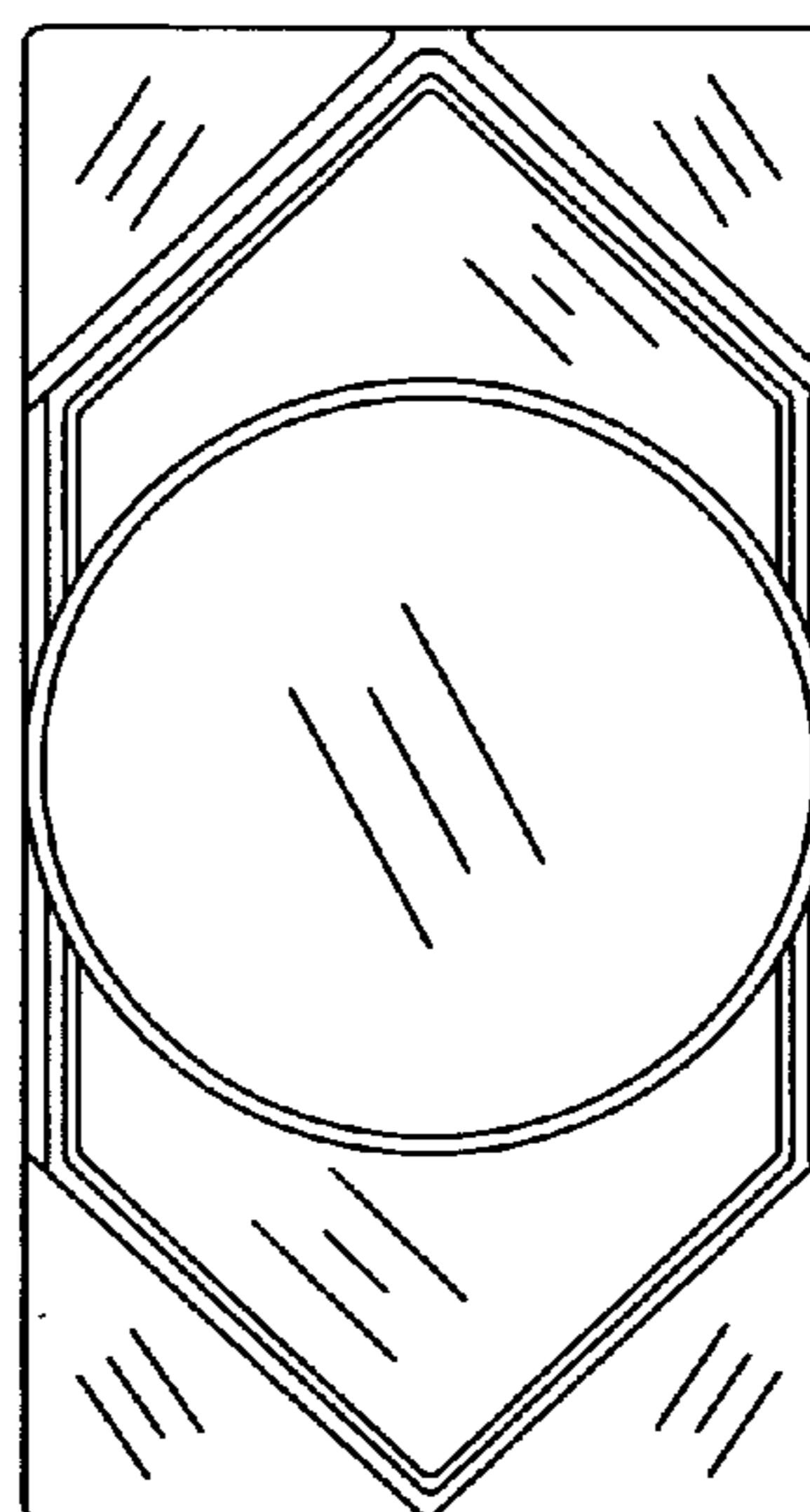

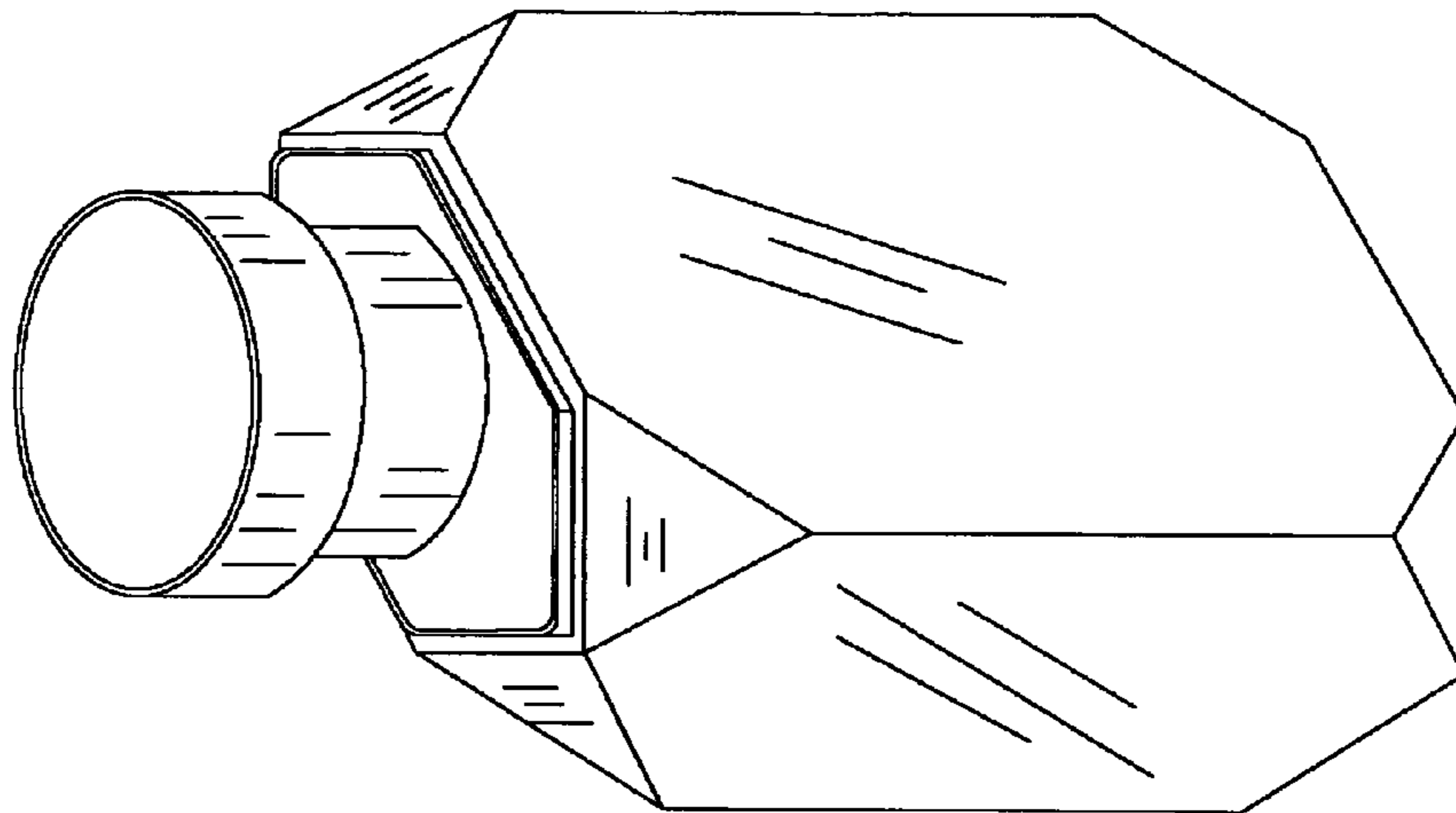

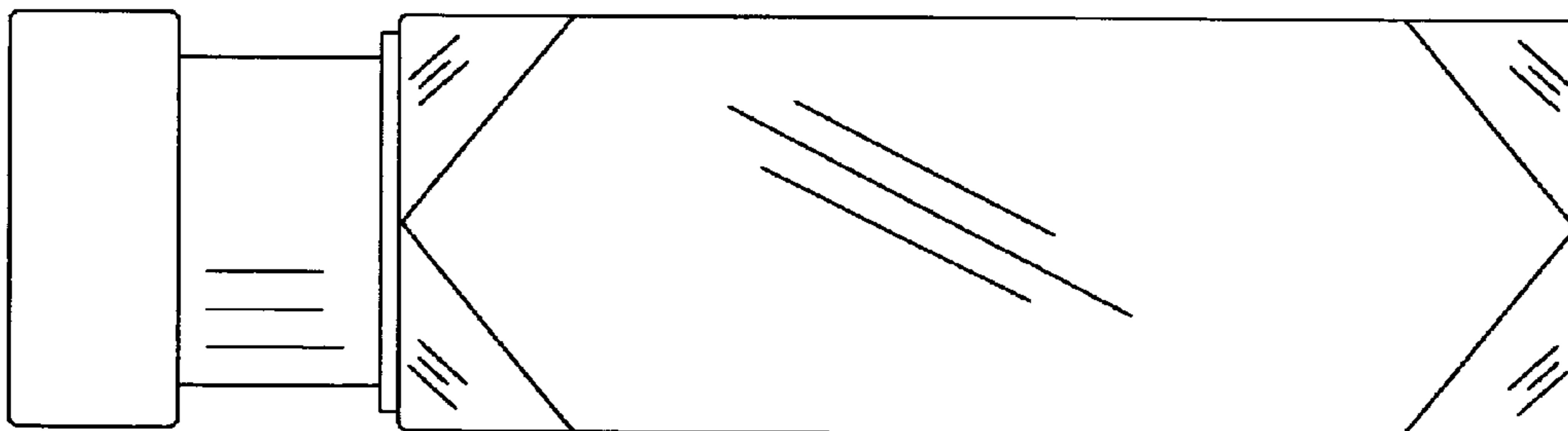
