FIG. 11 is a rear view of FIG. 8;

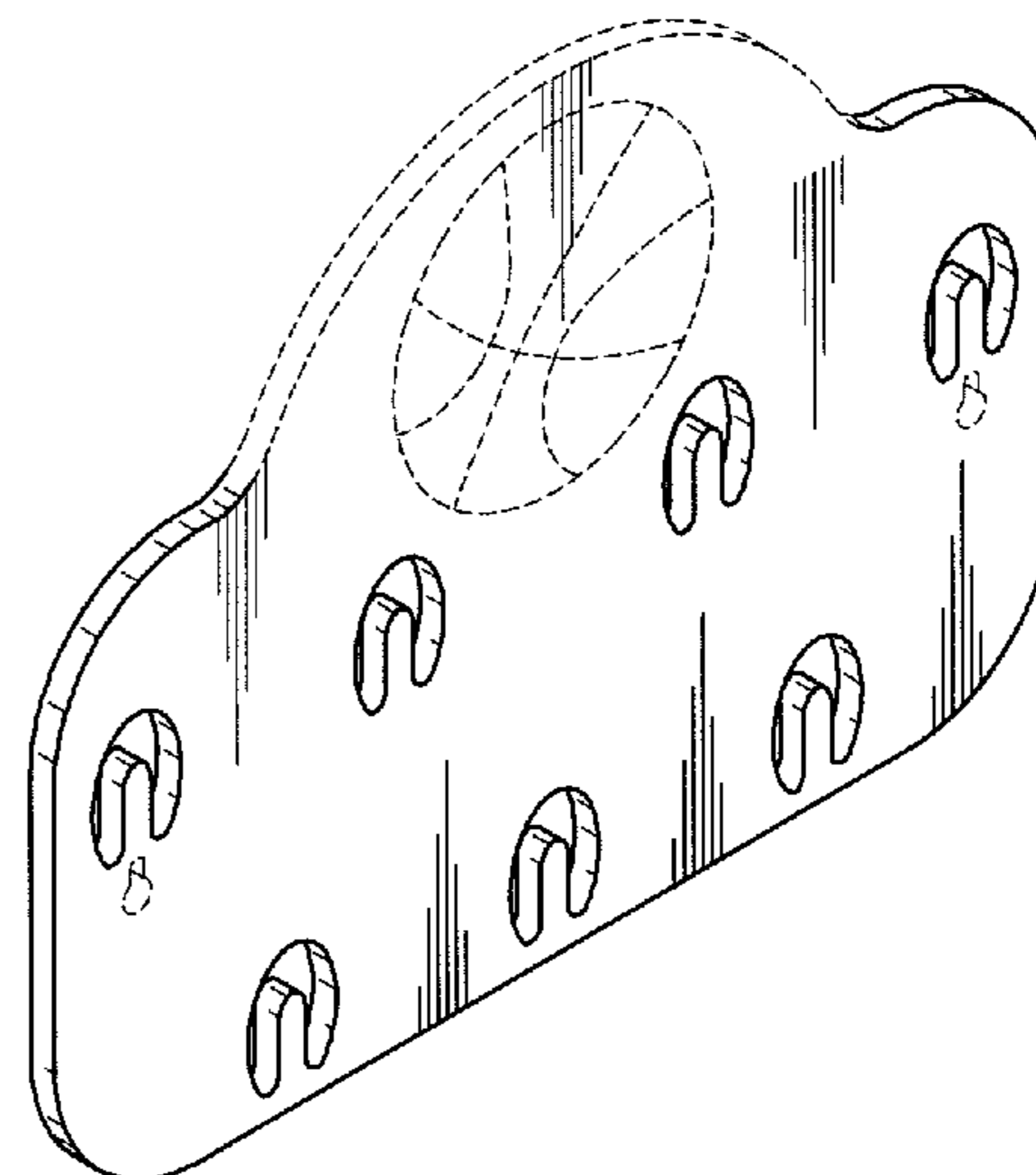
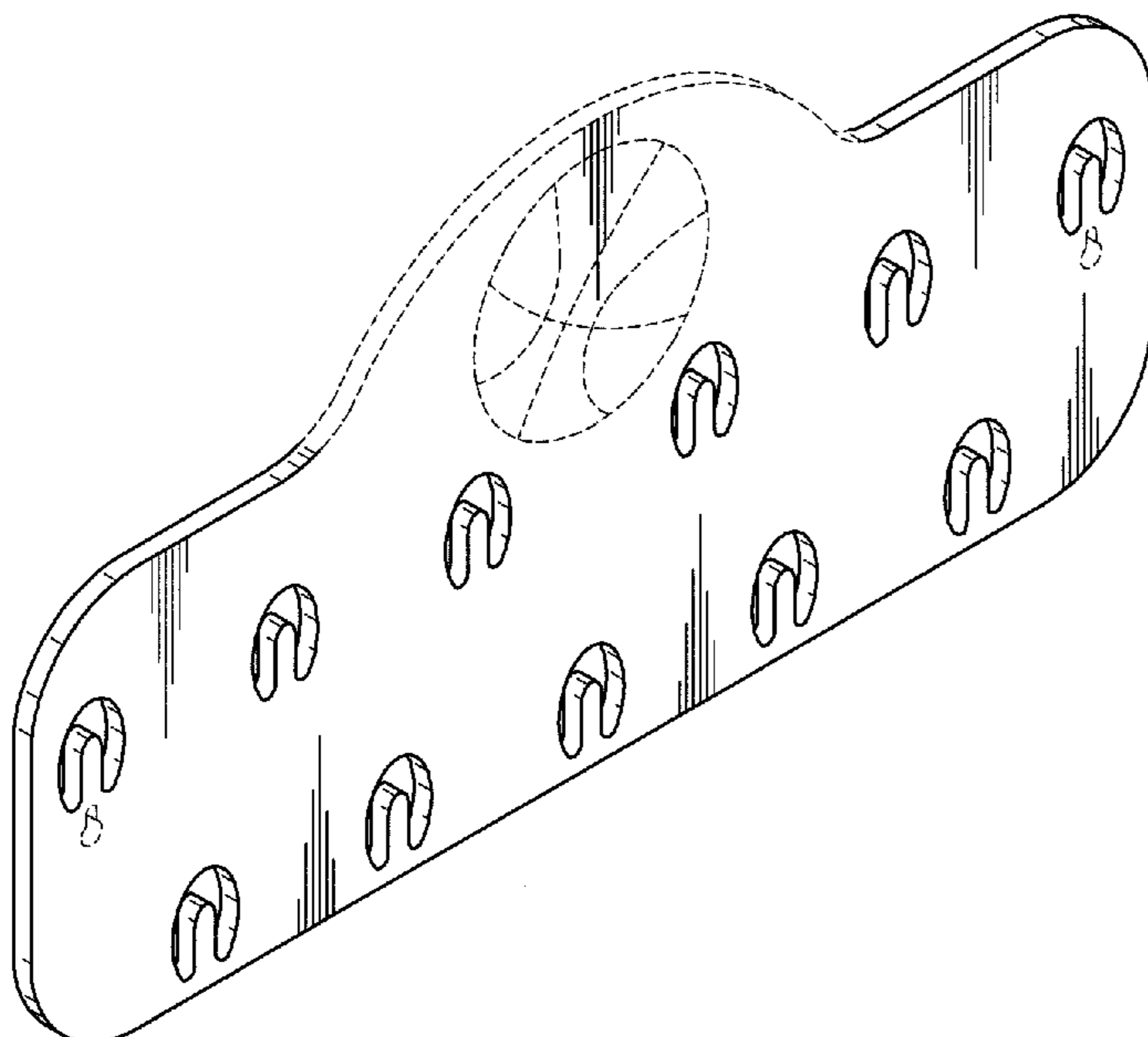
FIG. 12 is a bottom view of FIG. 8;

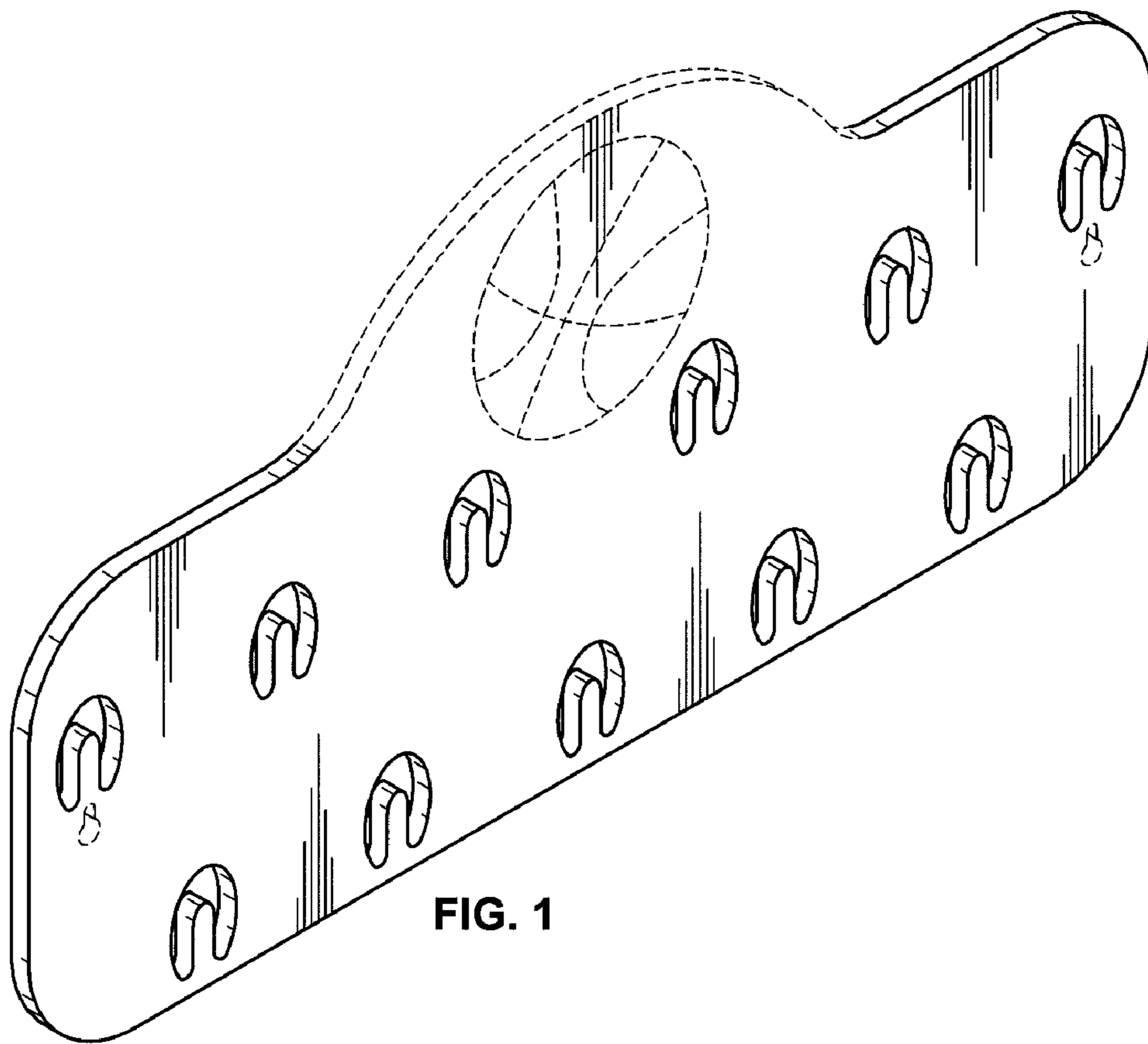

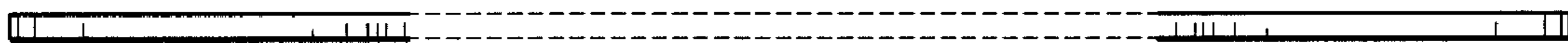

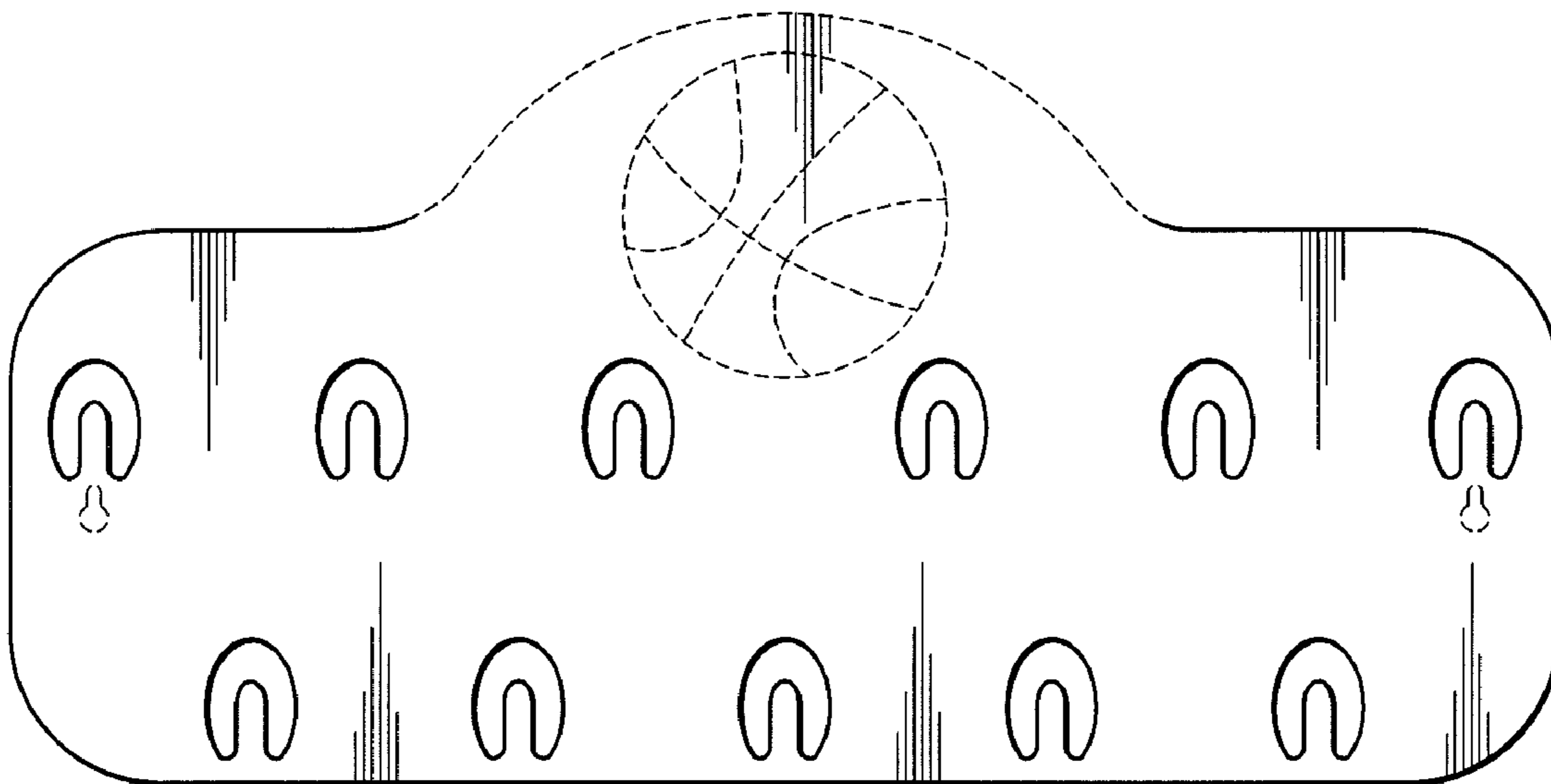

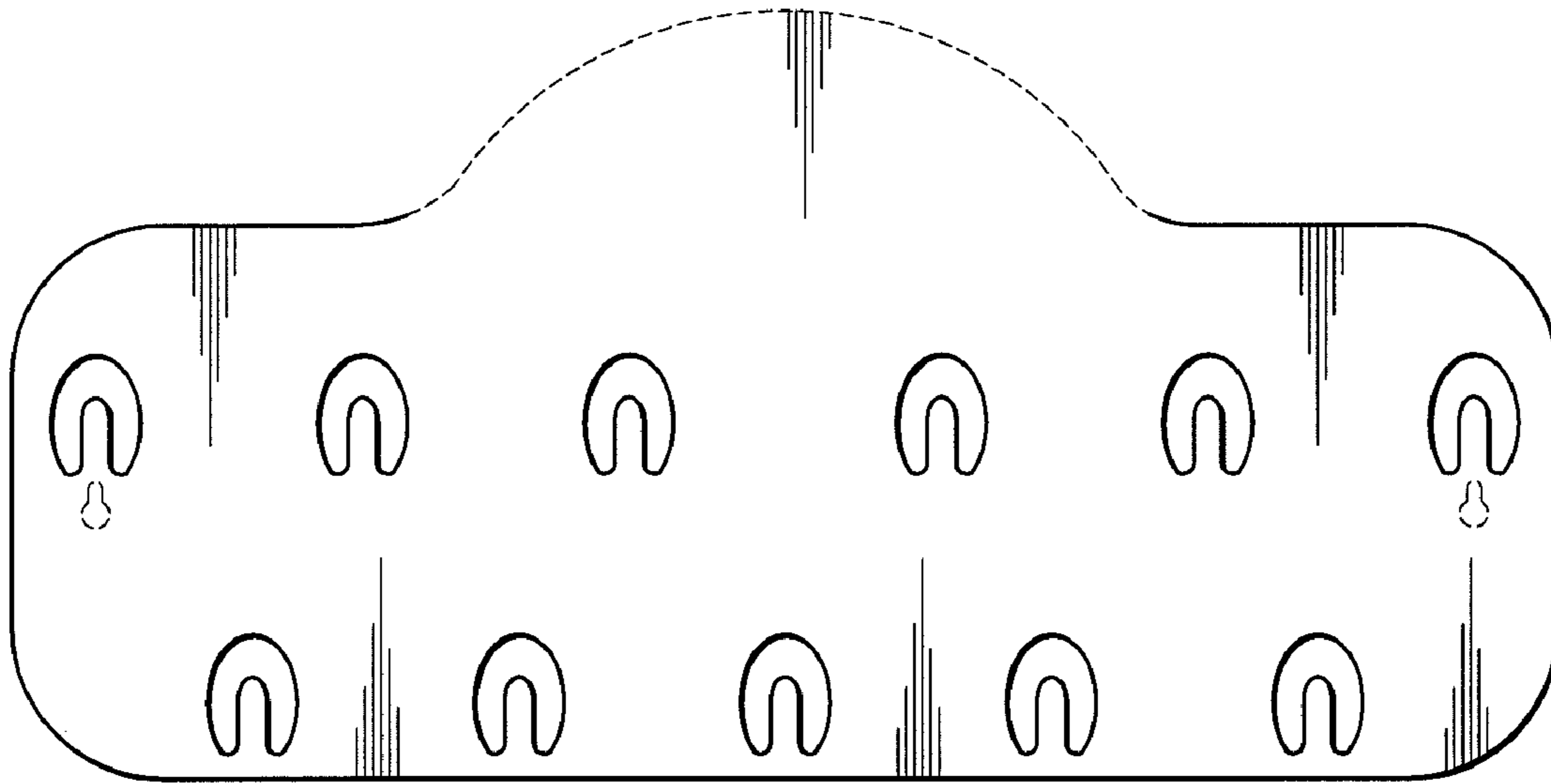

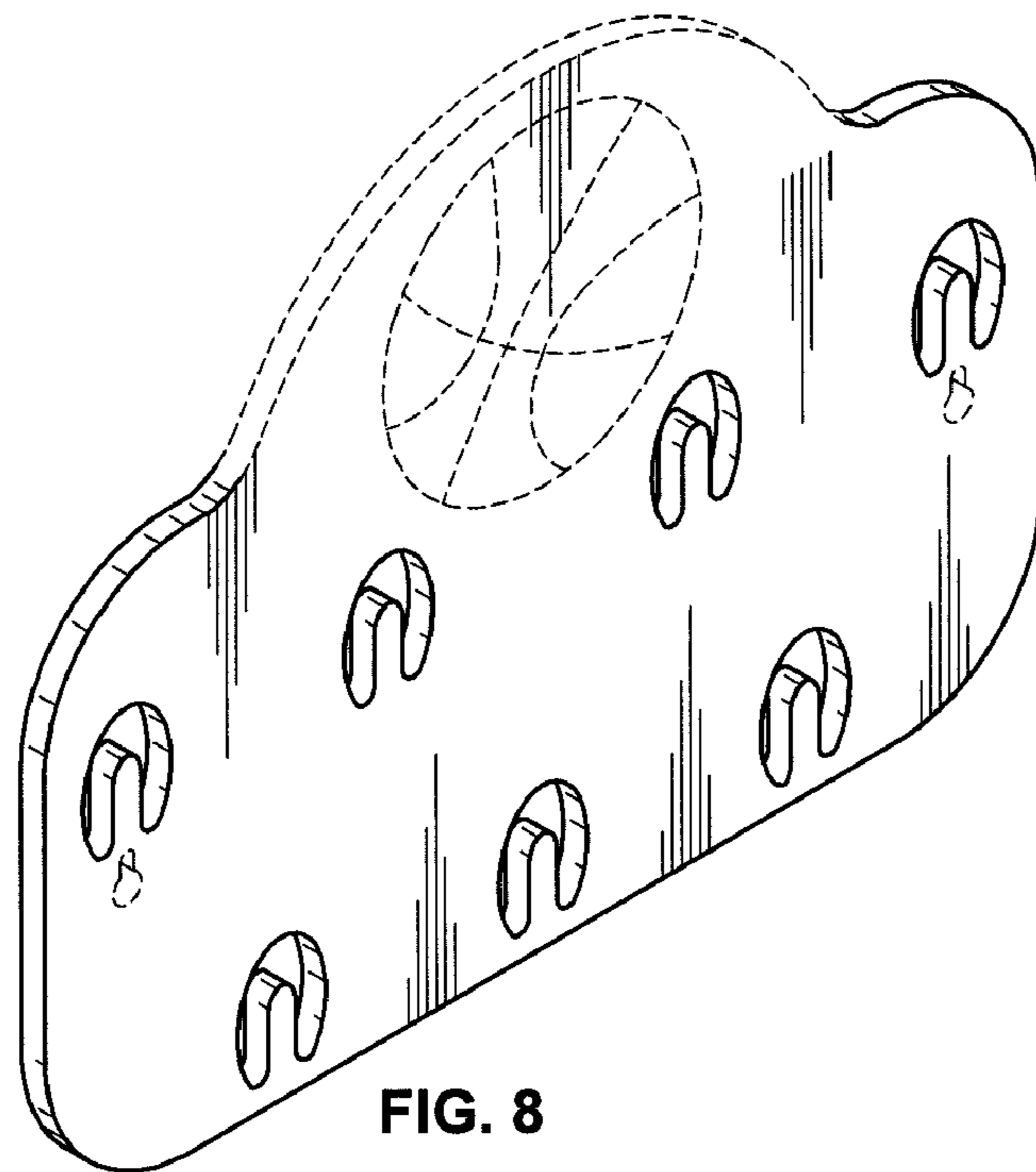

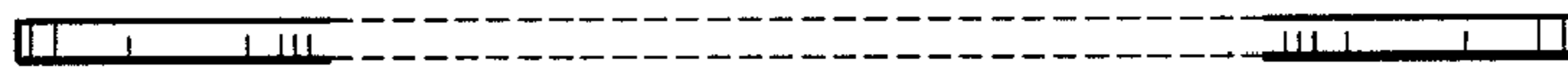

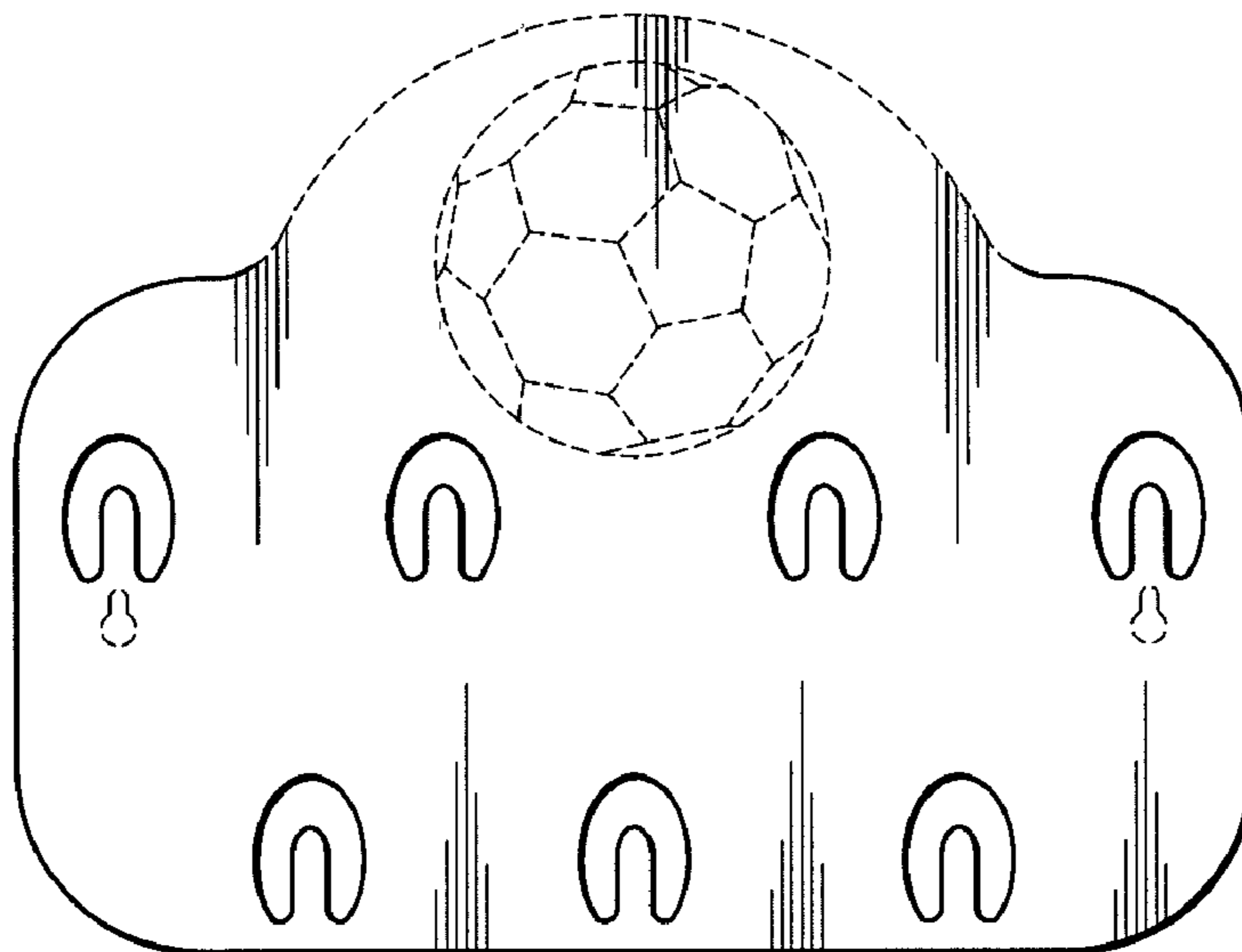

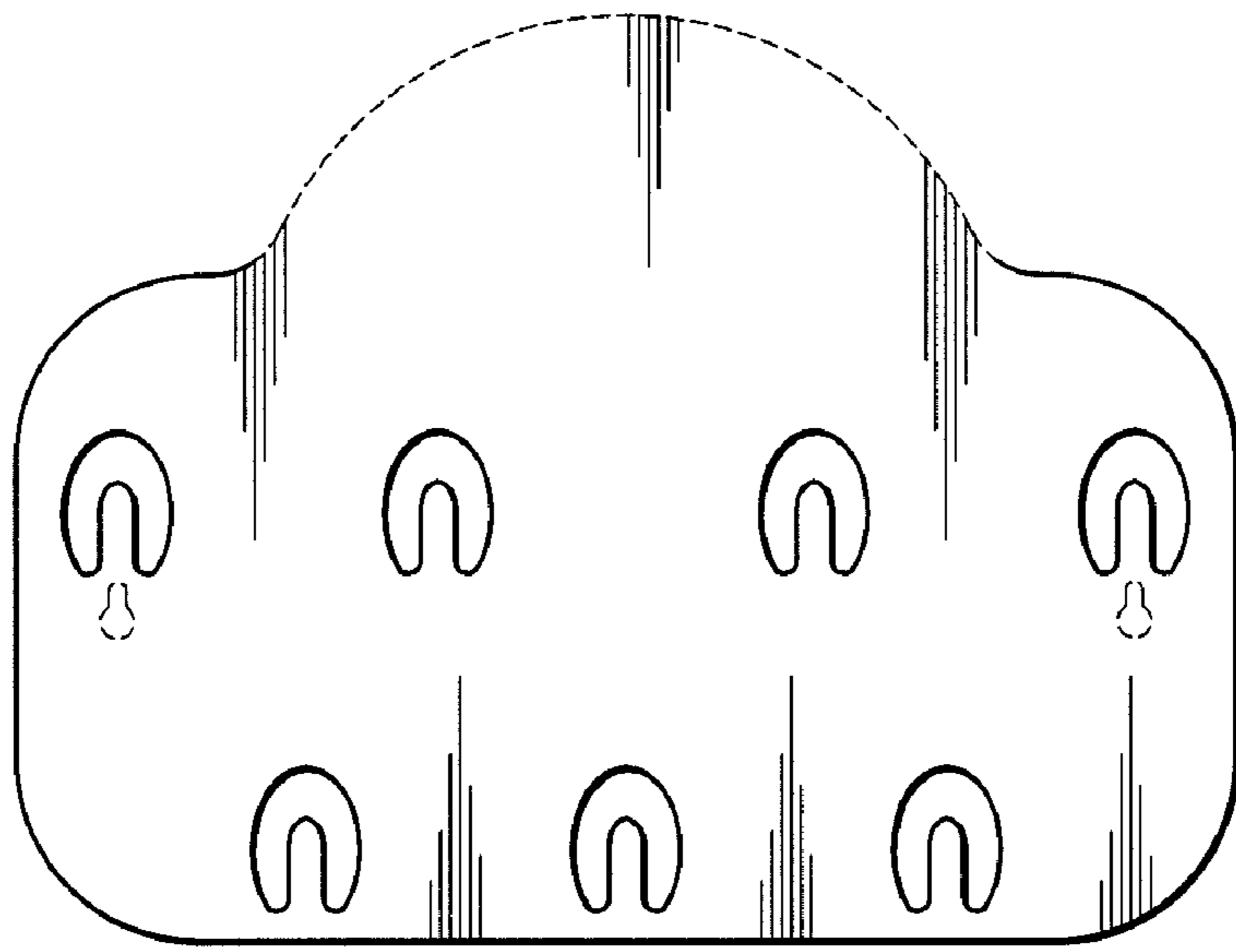
