(57) **CLAIM**

The ornamental design for a buckle decoration, as shown and described herein.

DESCRIPTION

FIG. 1 is a front elevational view of a buckle decoration showing our new design.

FIG. 2 is a rear elevational view thereof.

FIG. 3 is a right side elevational view thereof.

FIG. 4 is a left side elevational view thereof.

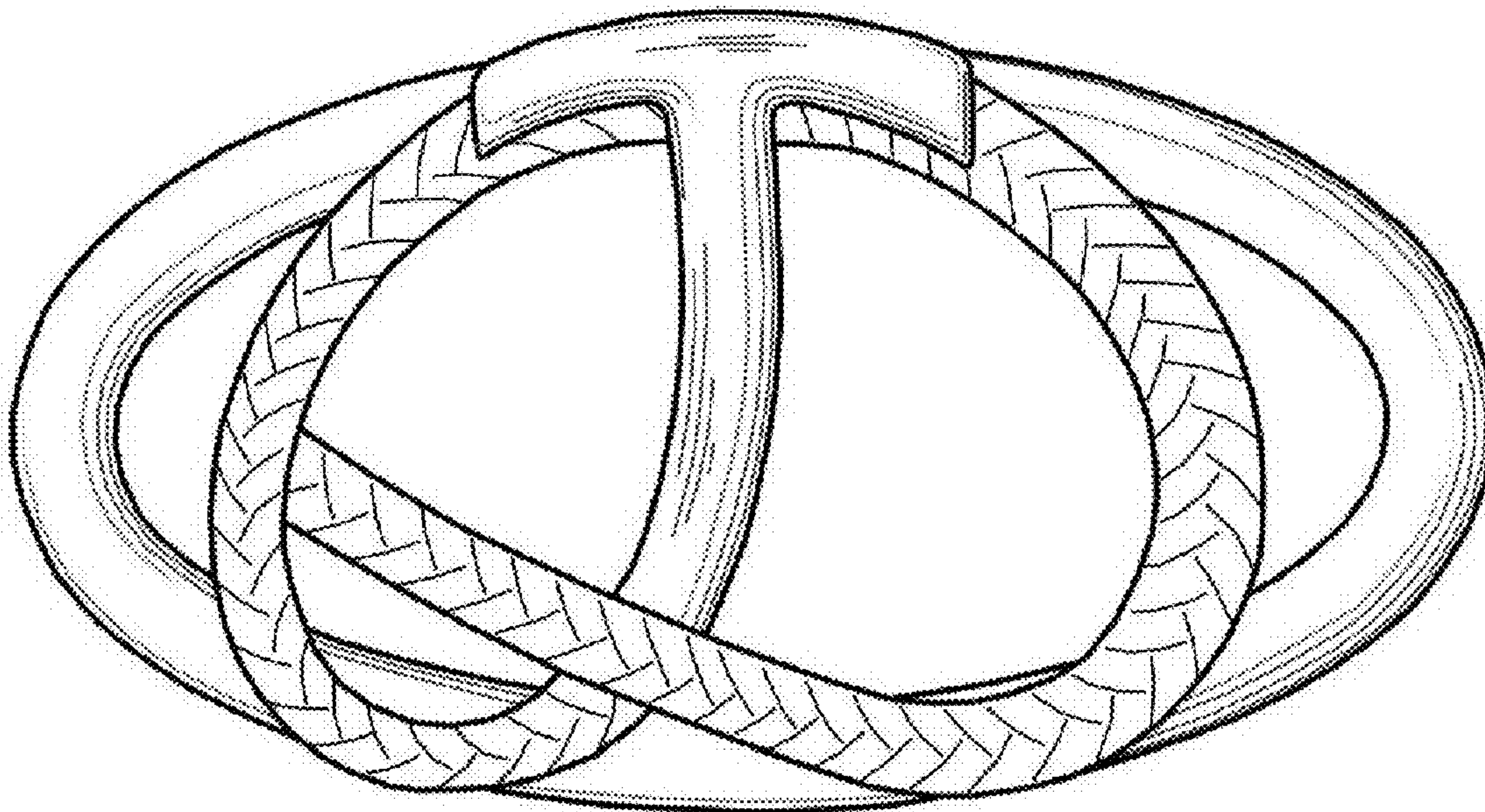
FIG. 5 is a top plan view thereof.

FIG. 6 is a bottom plan view thereof; and,

FIG. 7 is a perspective view thereof.

In some embodiments, a pair of decorations may be used on a pair of objects, such as on a pair of shoes. In such embodiments, or where a mirror image decoration may be used alone, respective views of a mirror image decoration showing our new design are mirror images of FIGS. 1-7.

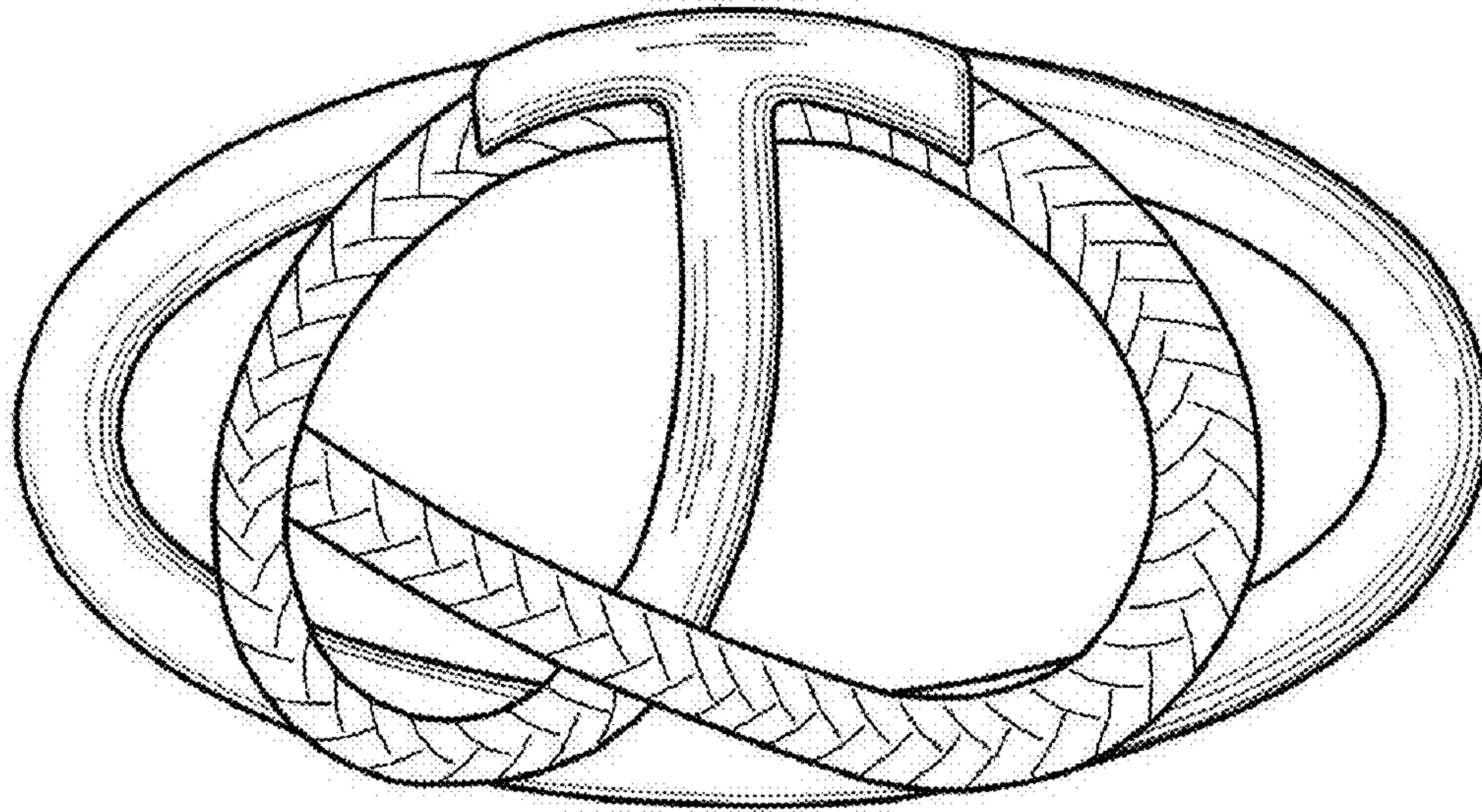

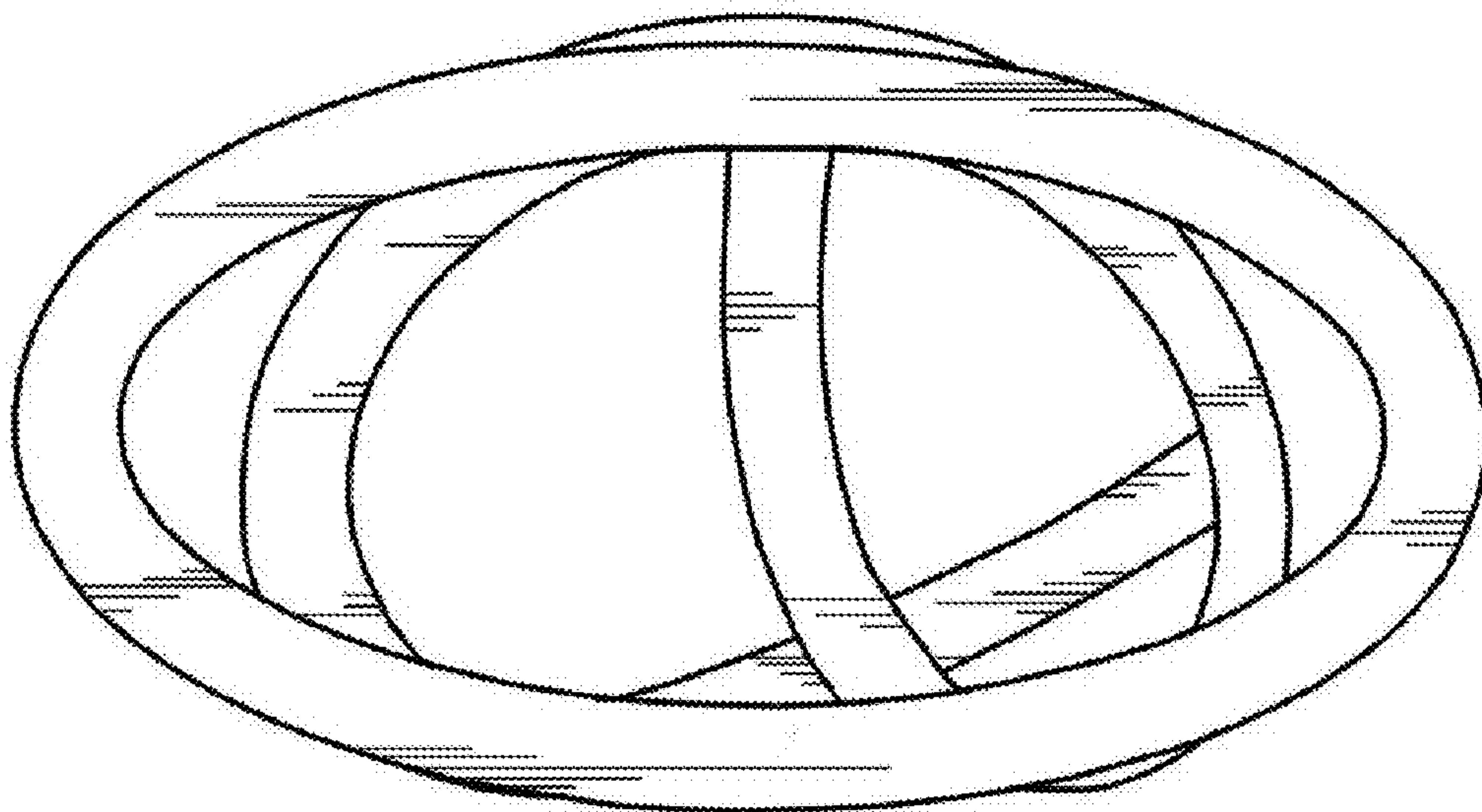

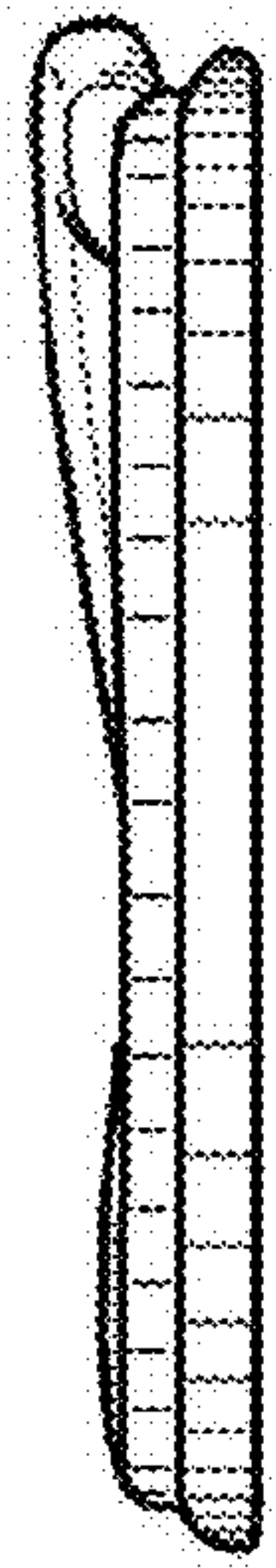

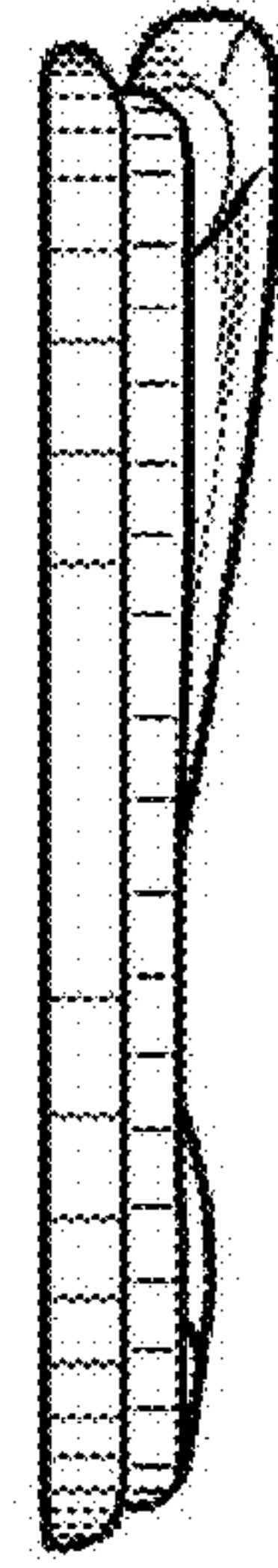

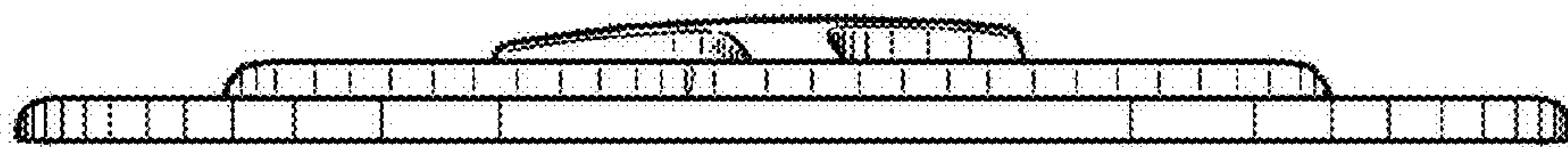

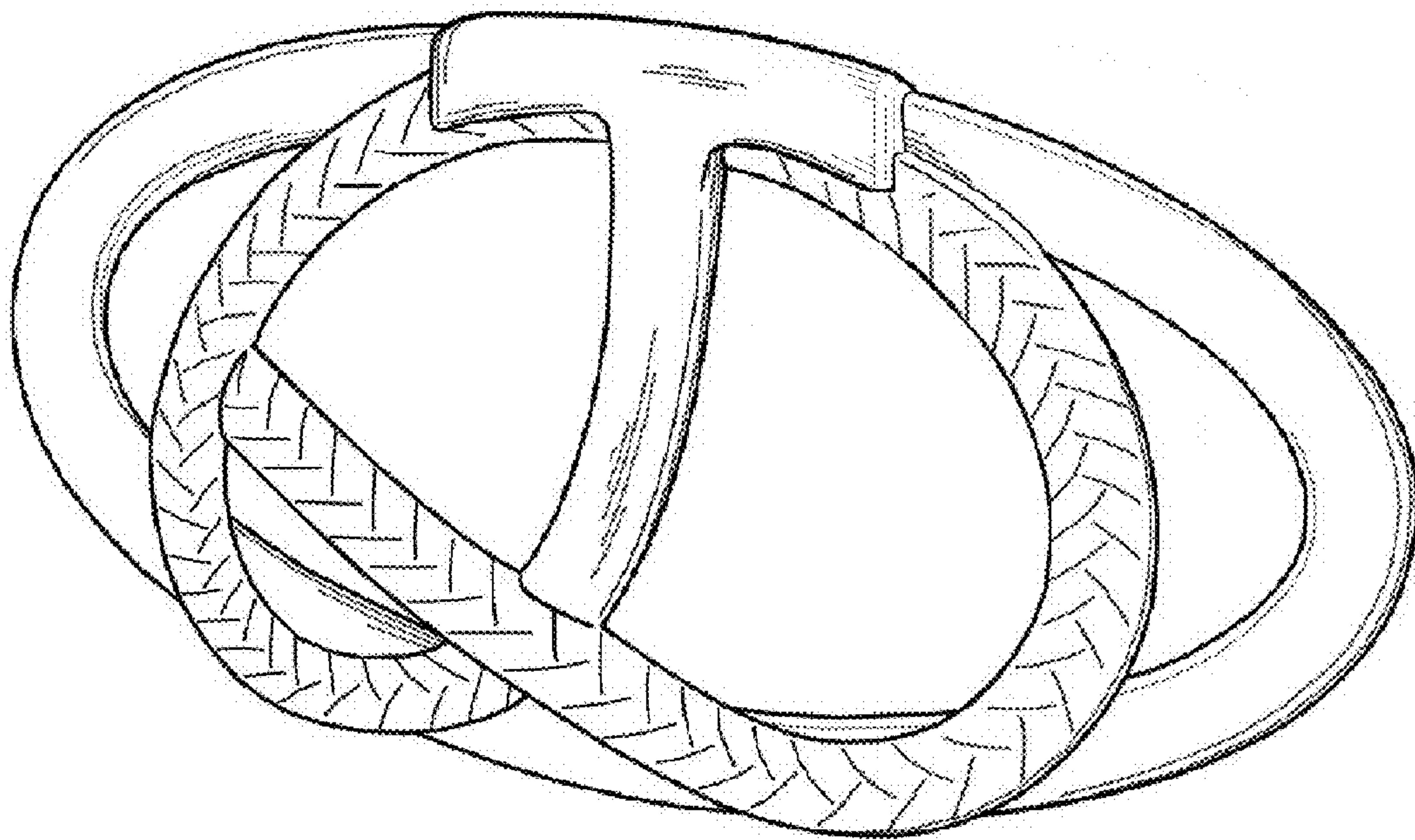
