FIG. 3 is a first side view of the ball mount.

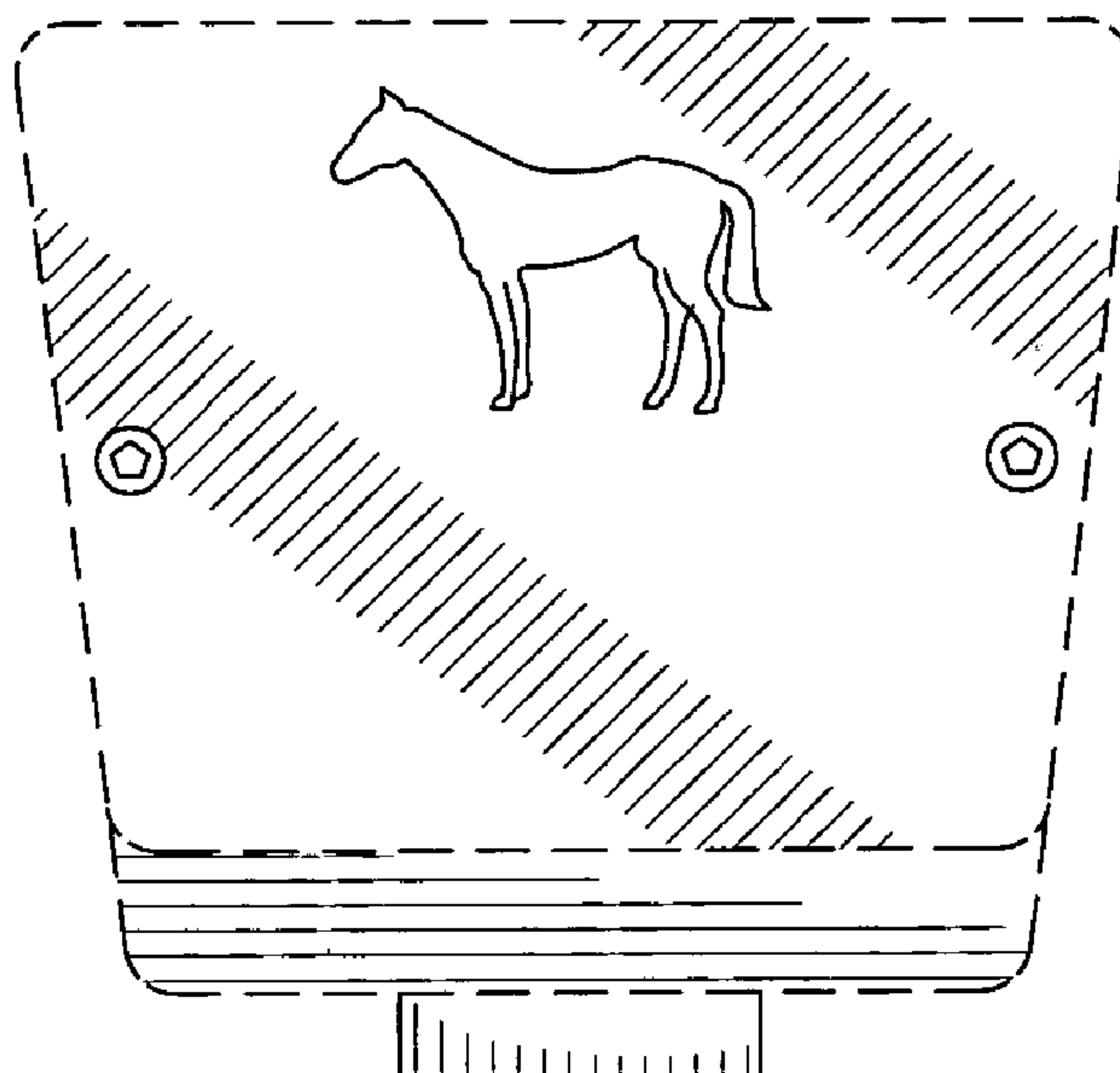
FIG. 4 is a second side view of the ball mount.

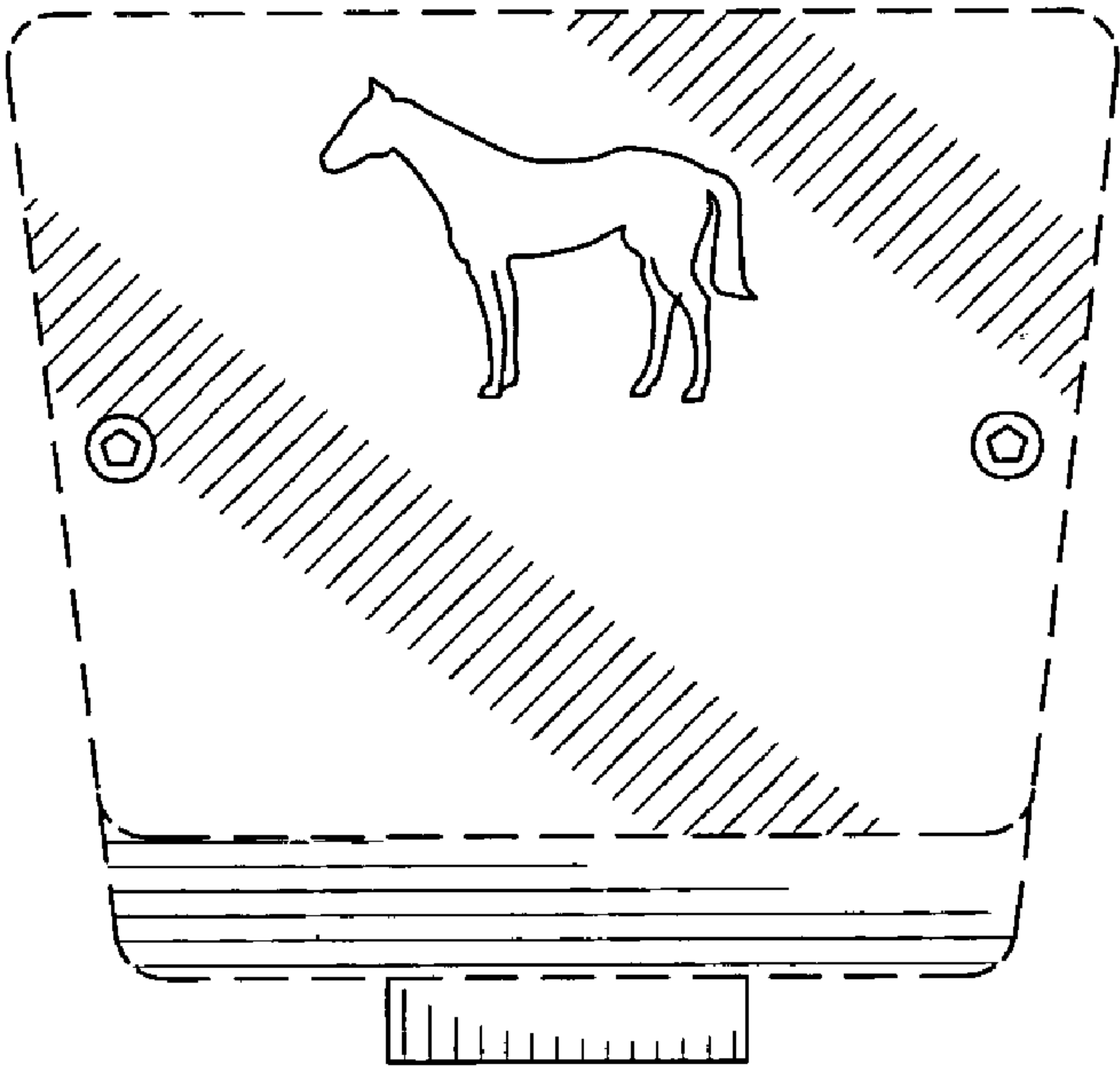

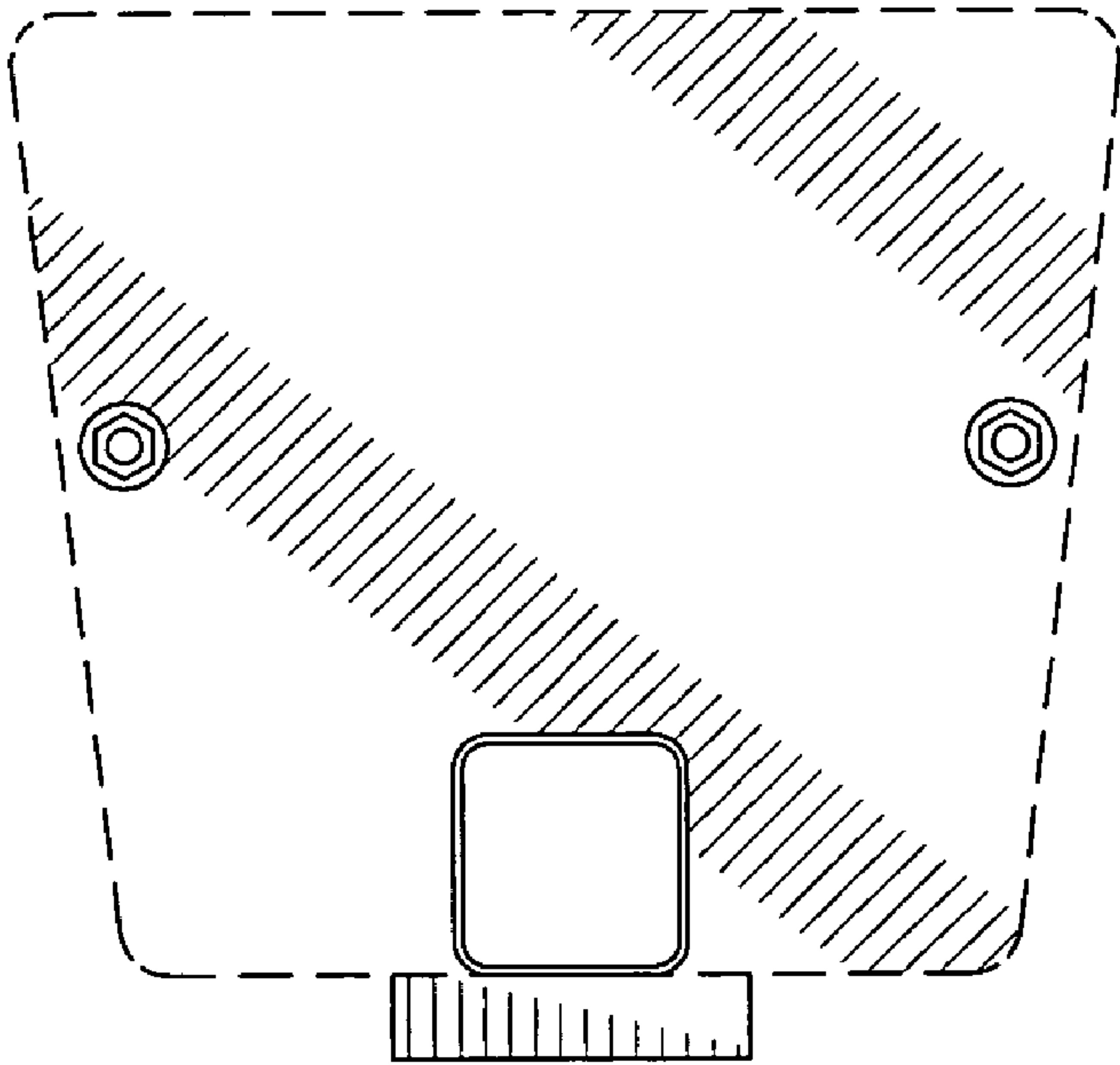

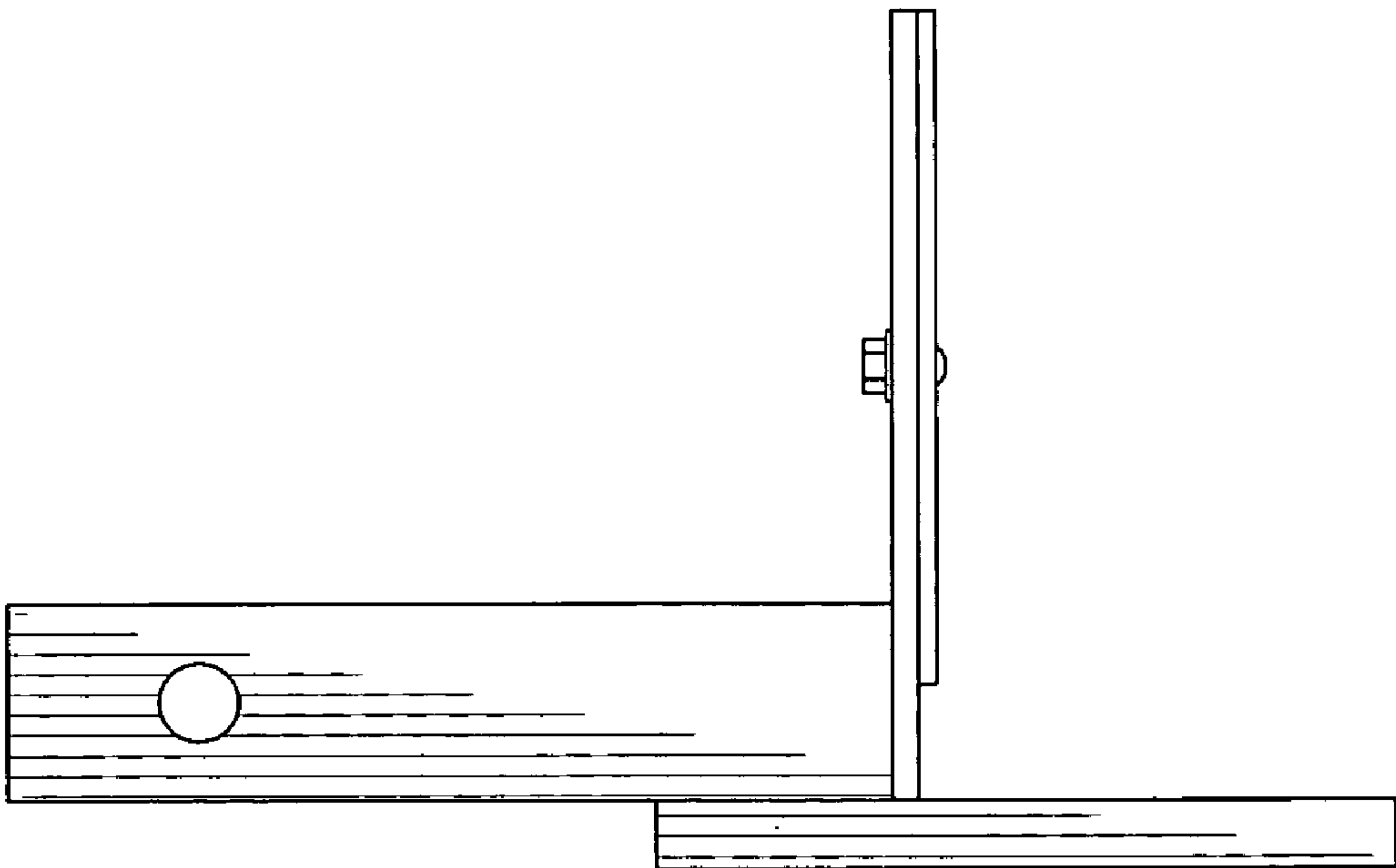

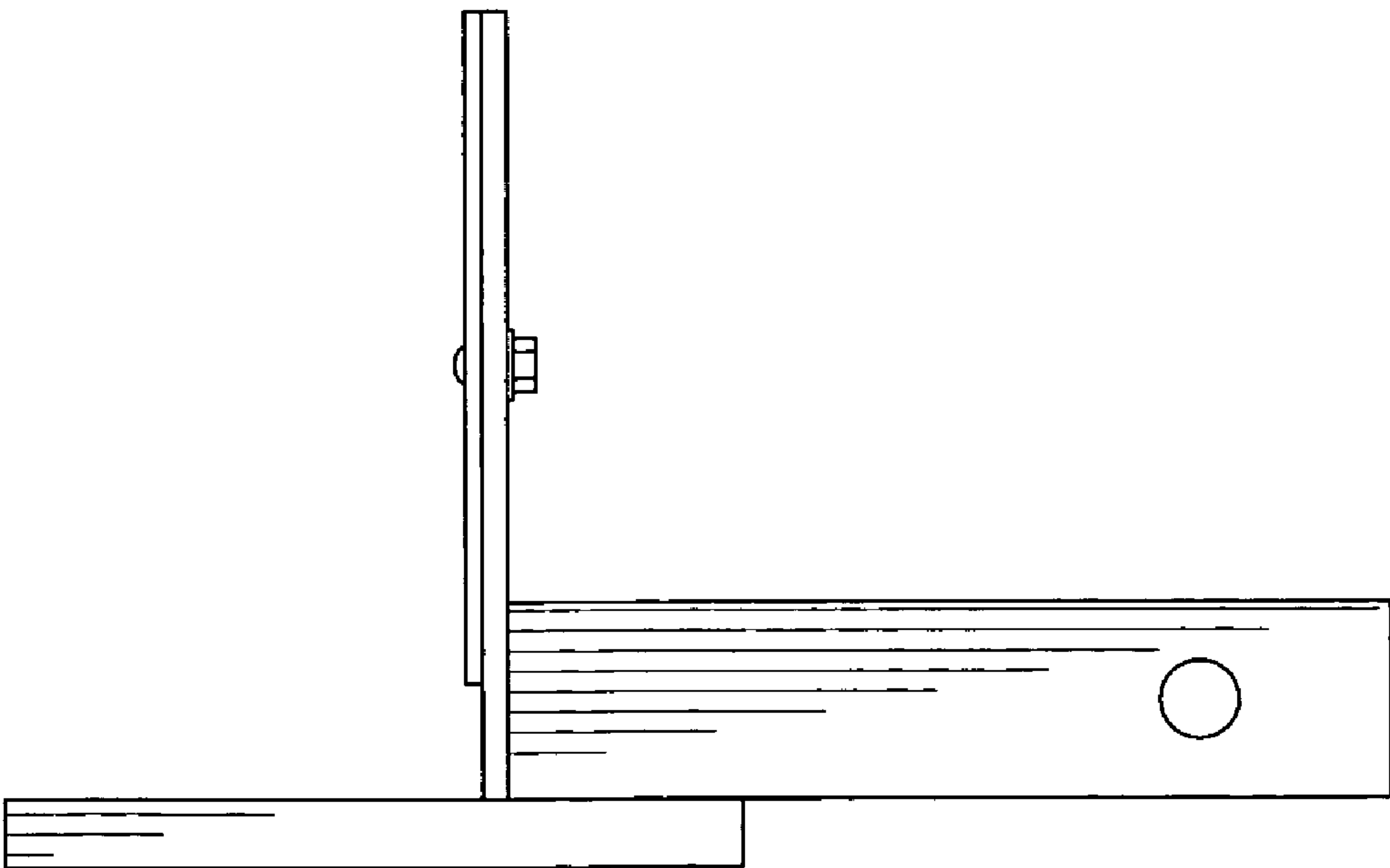

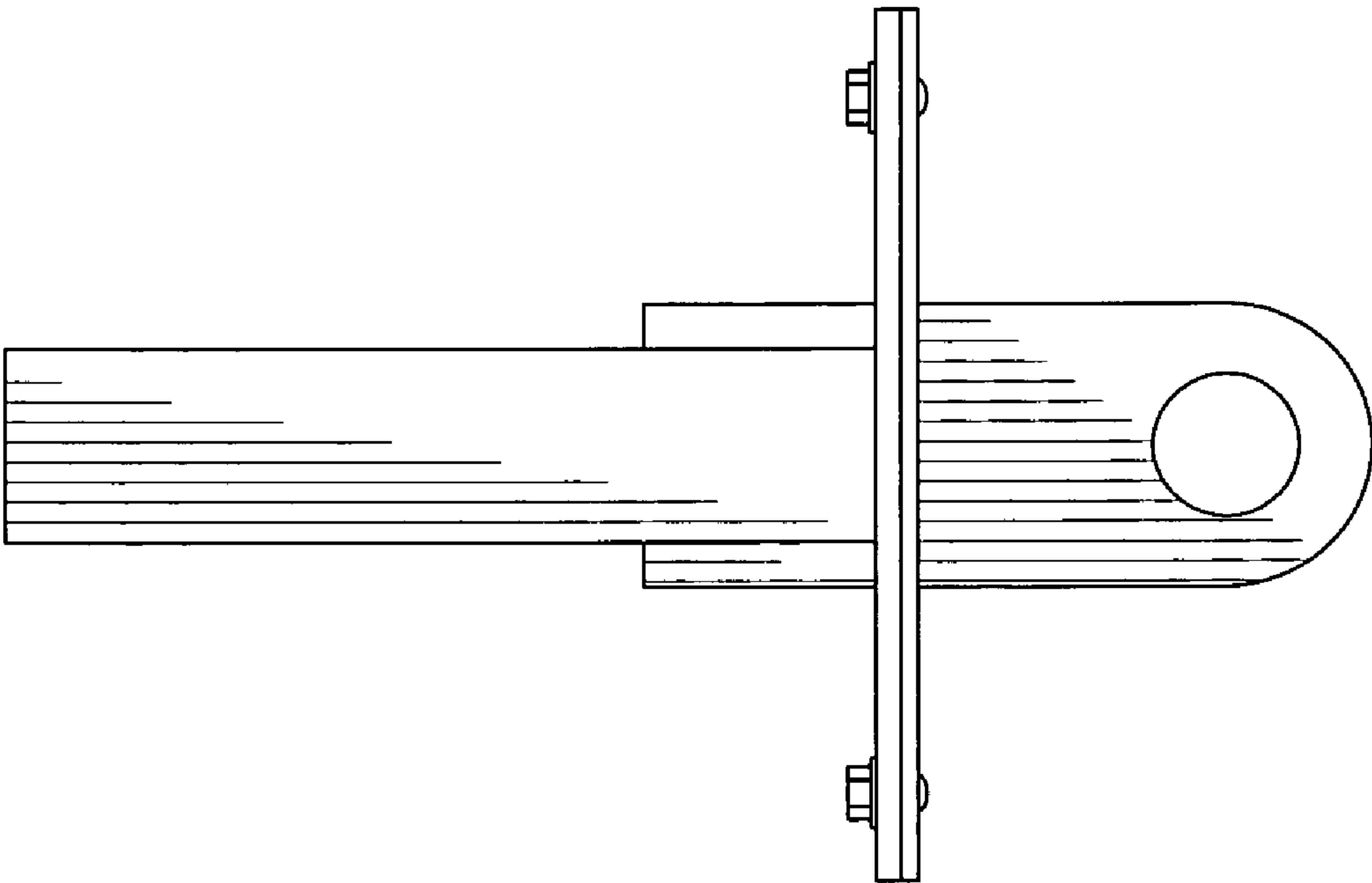

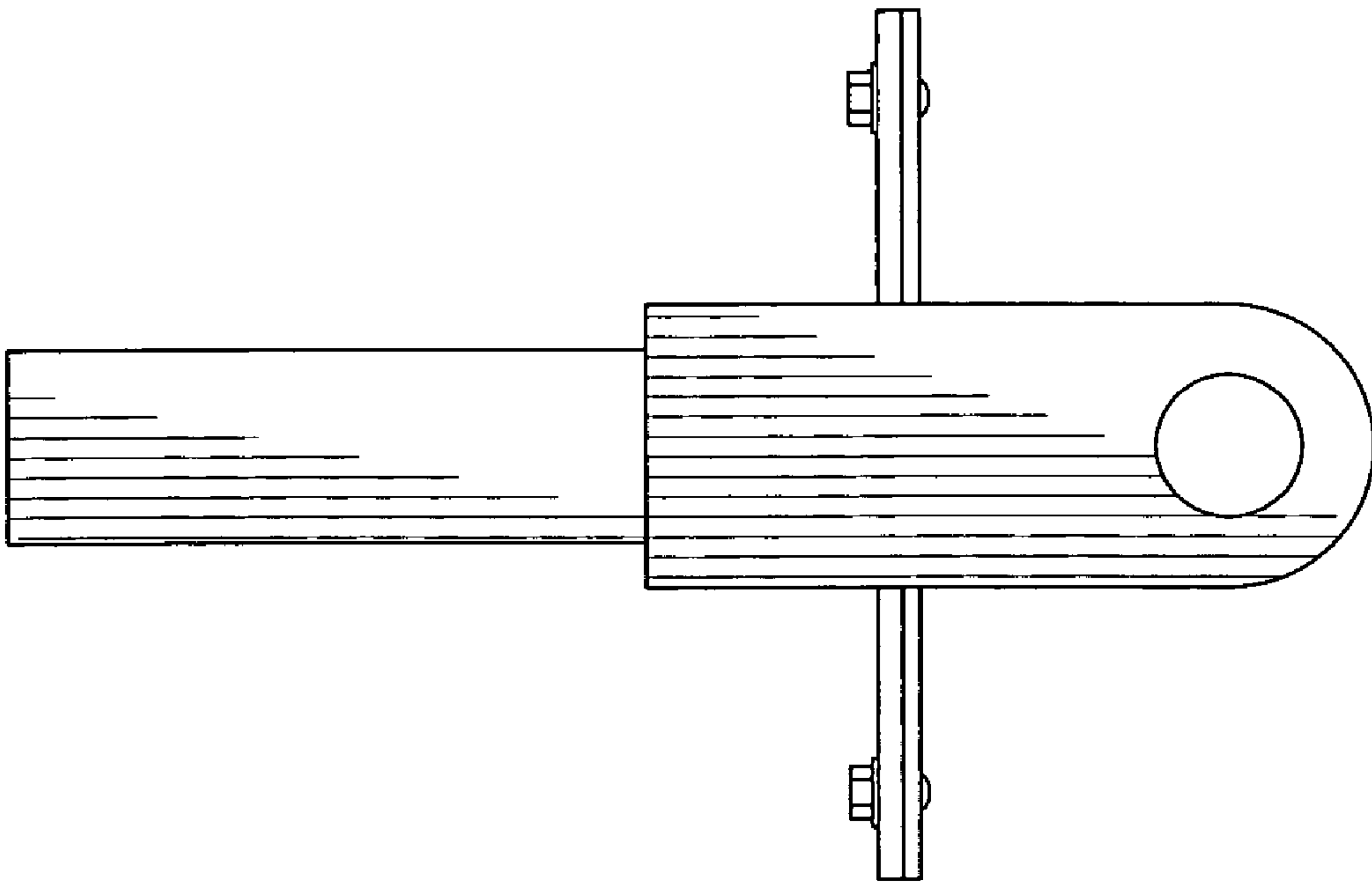
