**DESCRIPTION**

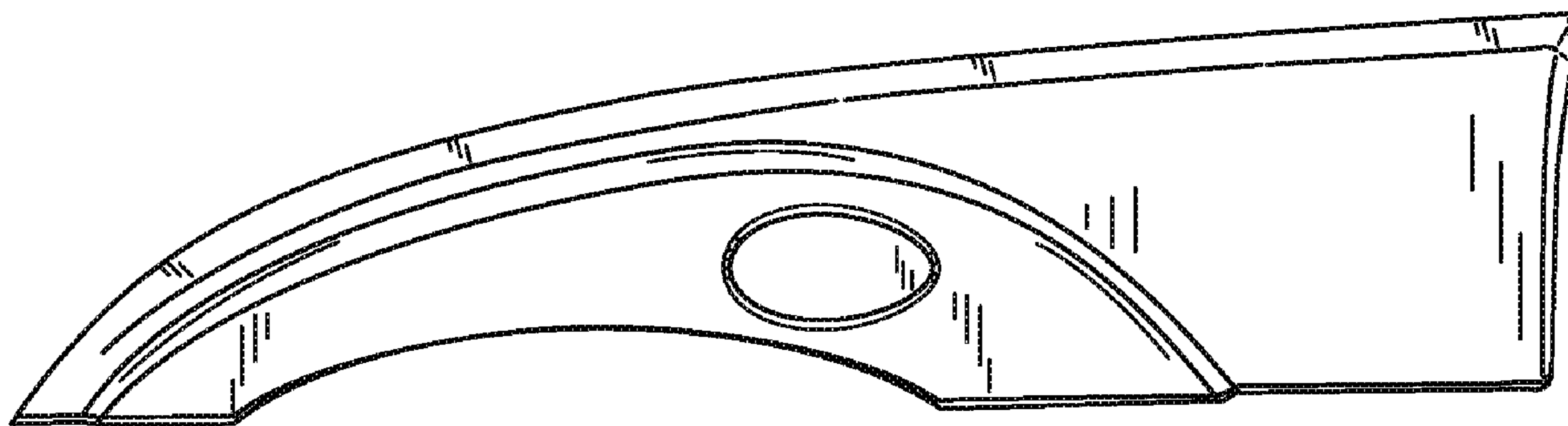
FIG. 1 is a right, front perspective view of a fender of a truck

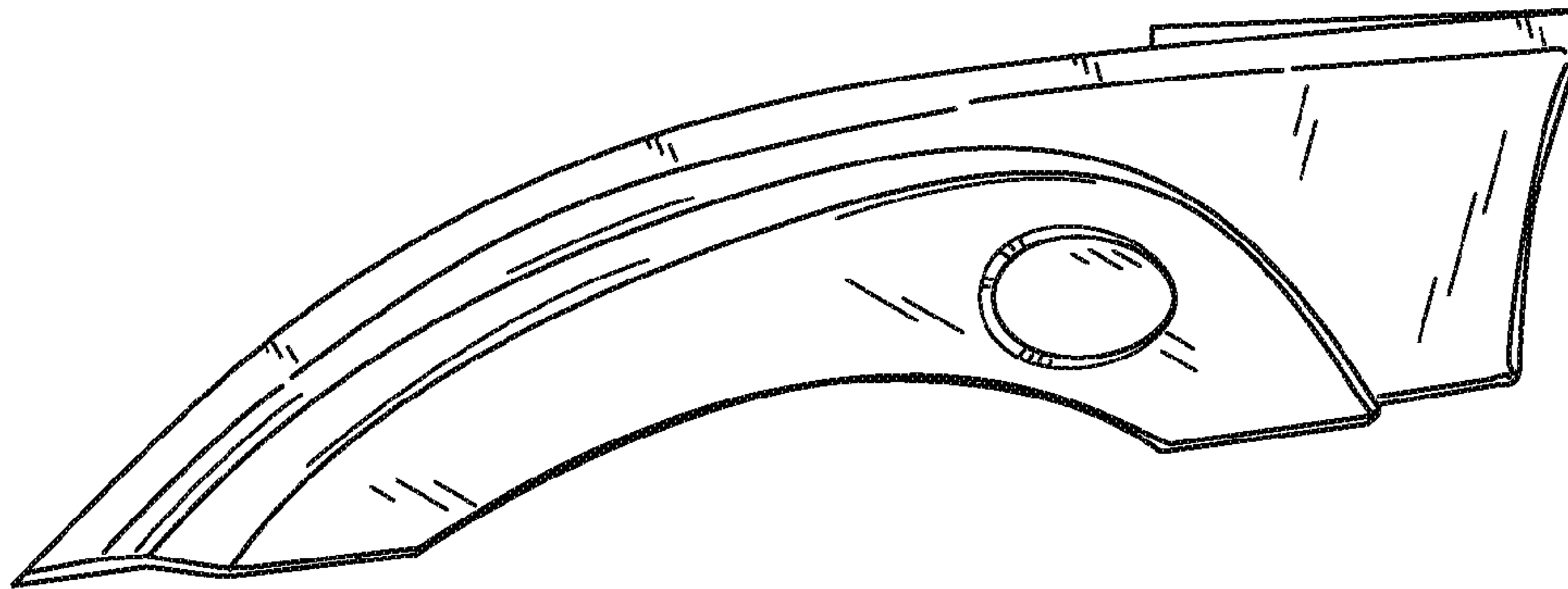

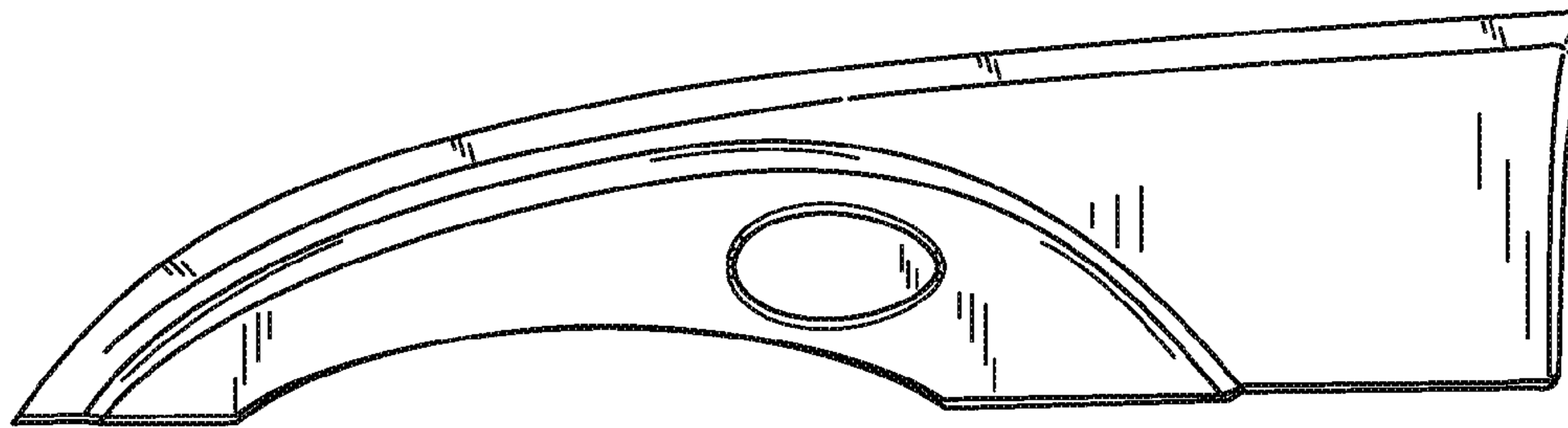

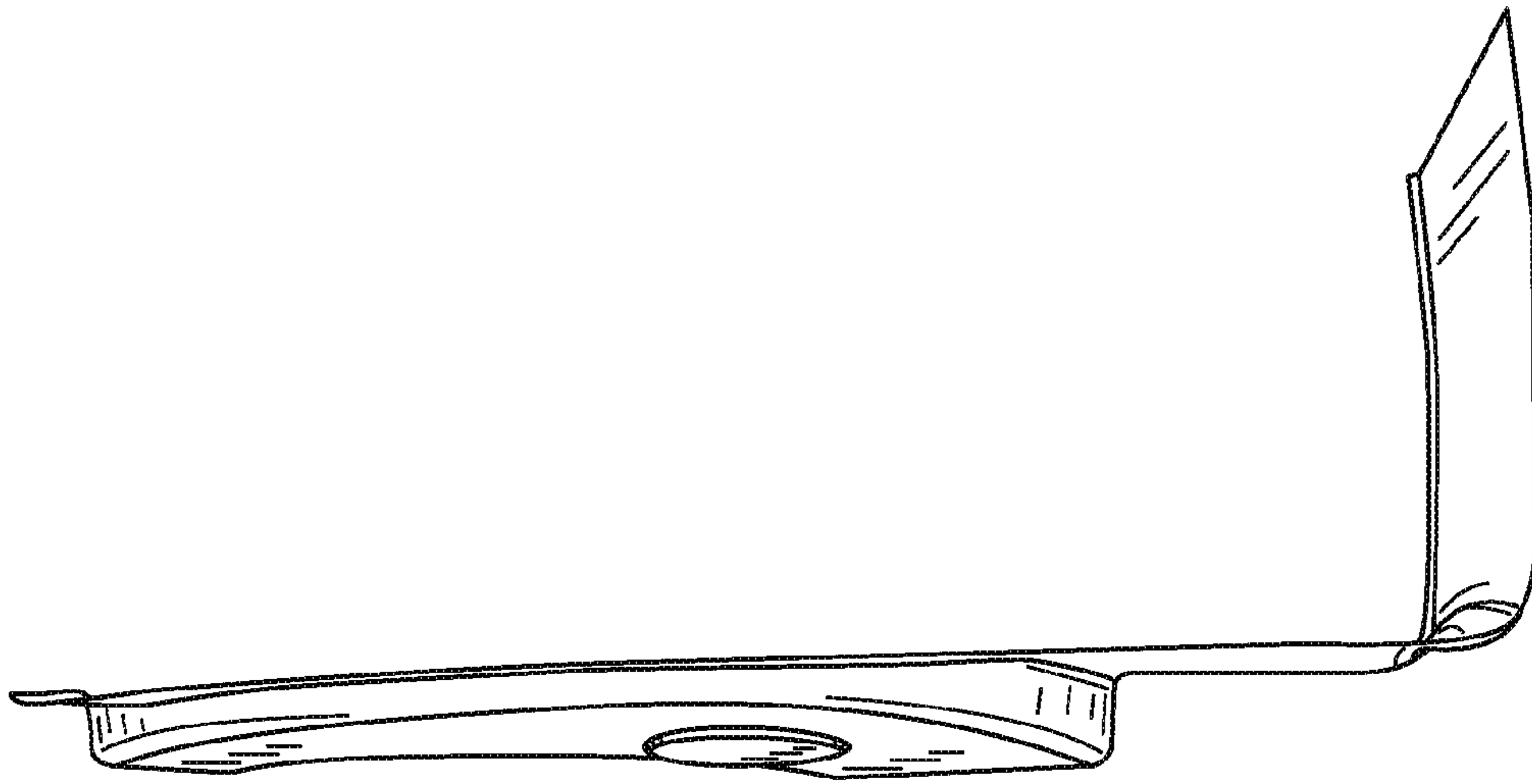

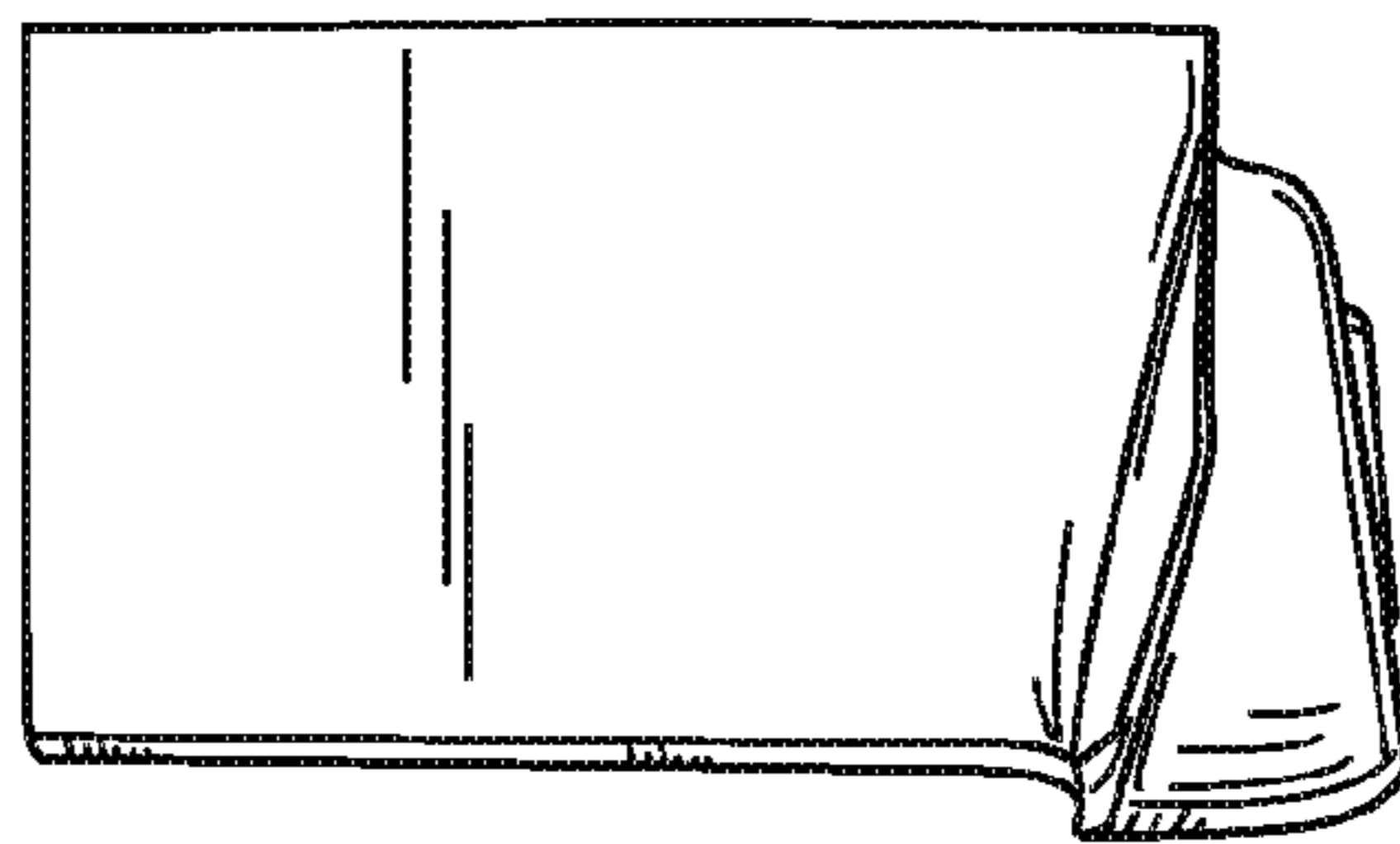
