The ornamental design for a side mirror for a vehicle, as shown and described.

DESCRIPTION

FIG. 1 is a left side perspective view of a first embodiment of a side mirror for a vehicle according to my design;

FIG. 4 is a rear view thereof;

FIG. 13 is a left side view thereof;

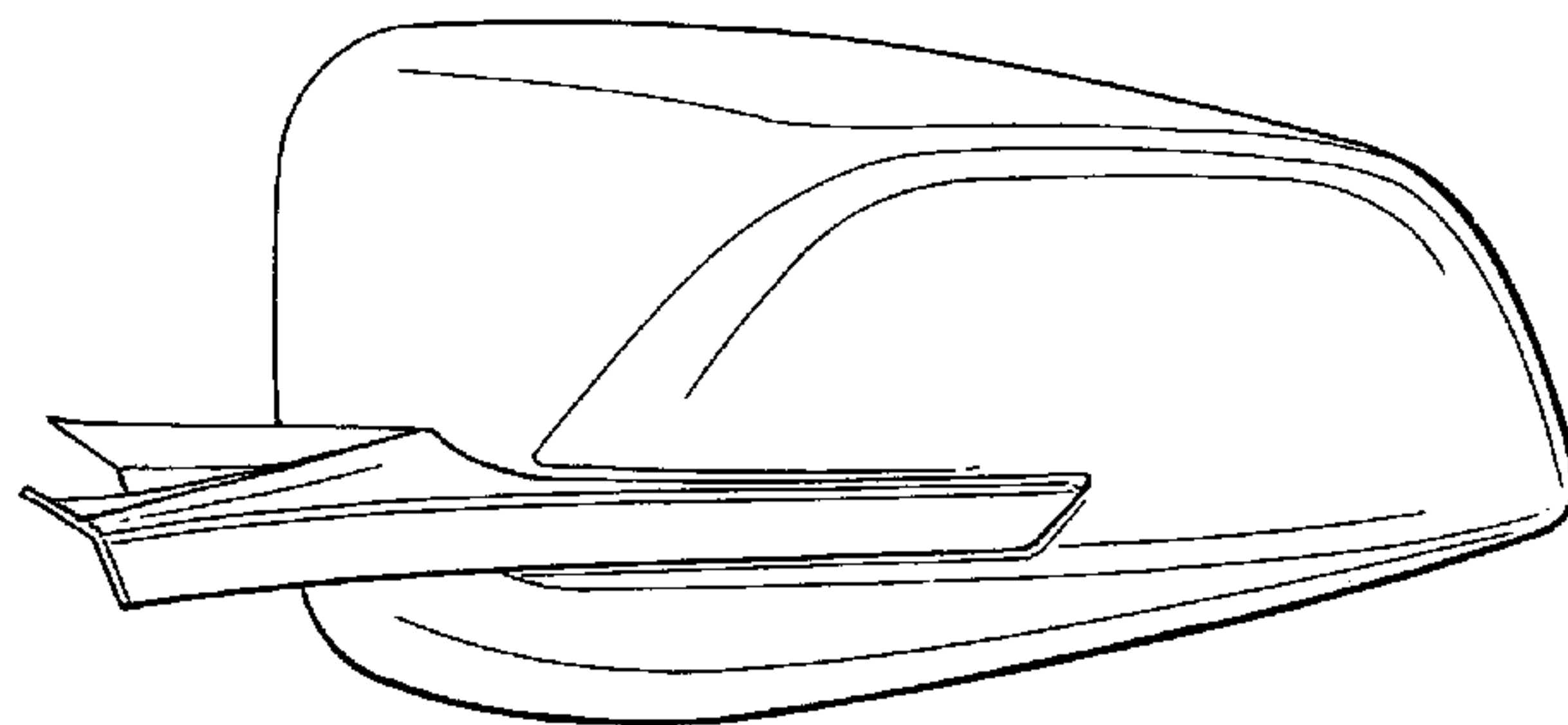
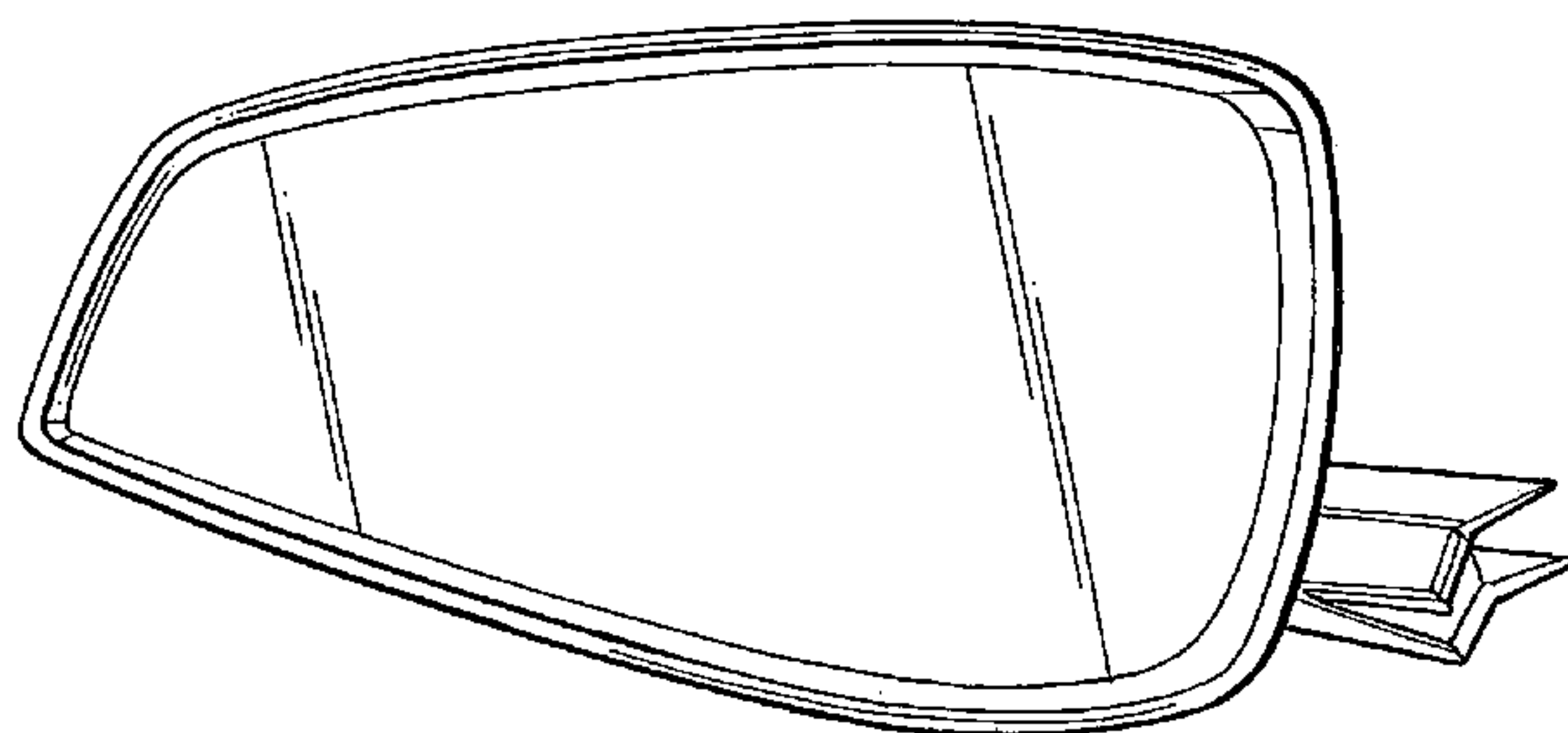
FIG. 14 is a right side view thereof;

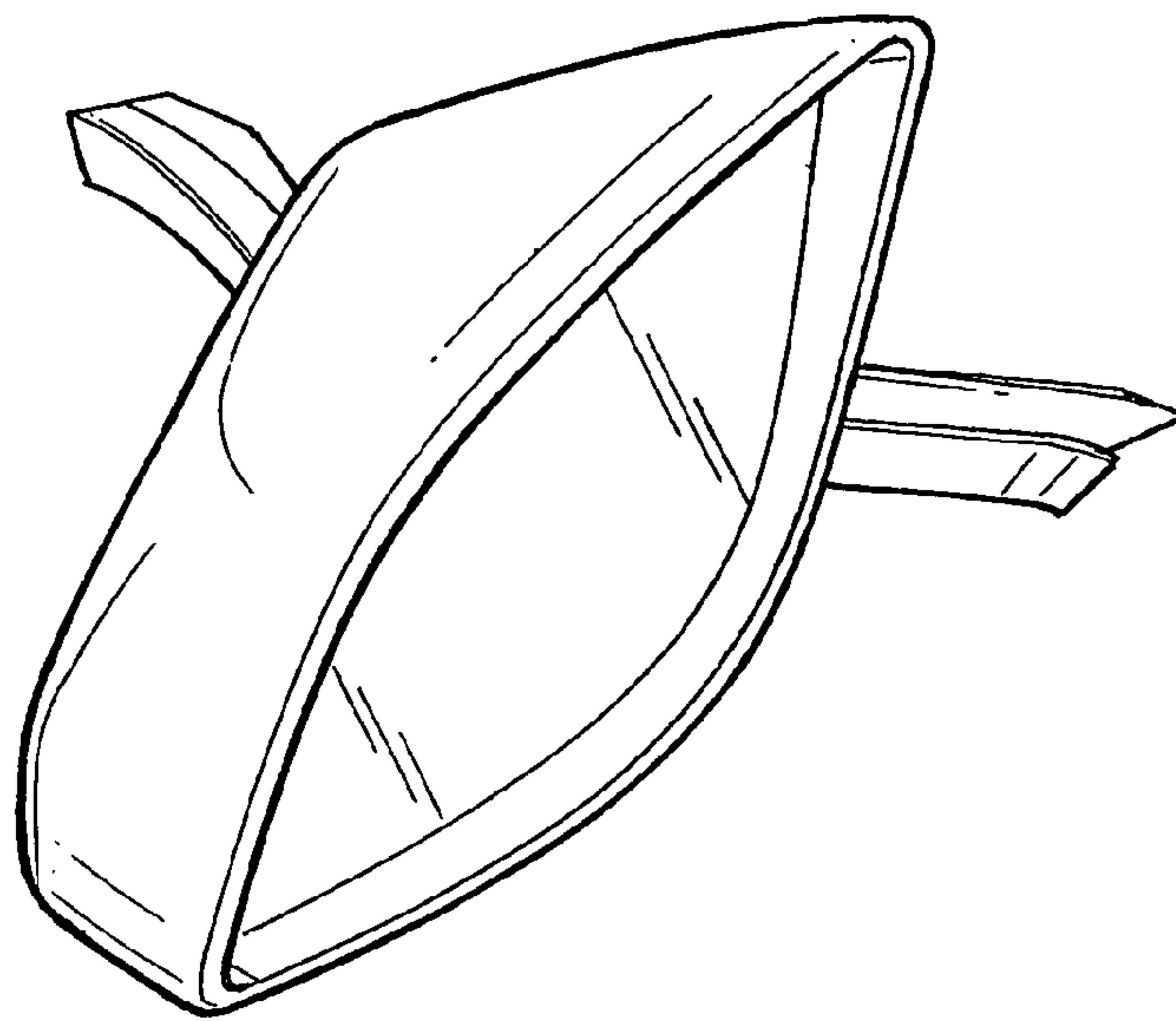

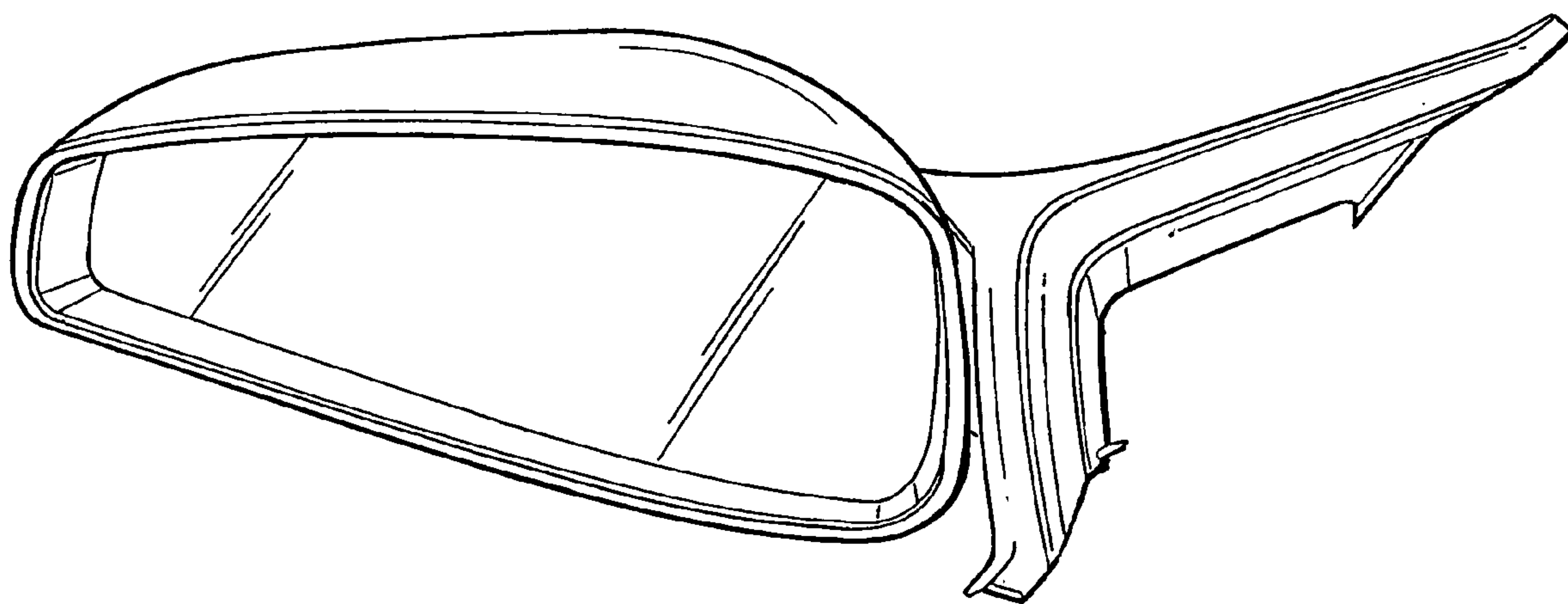

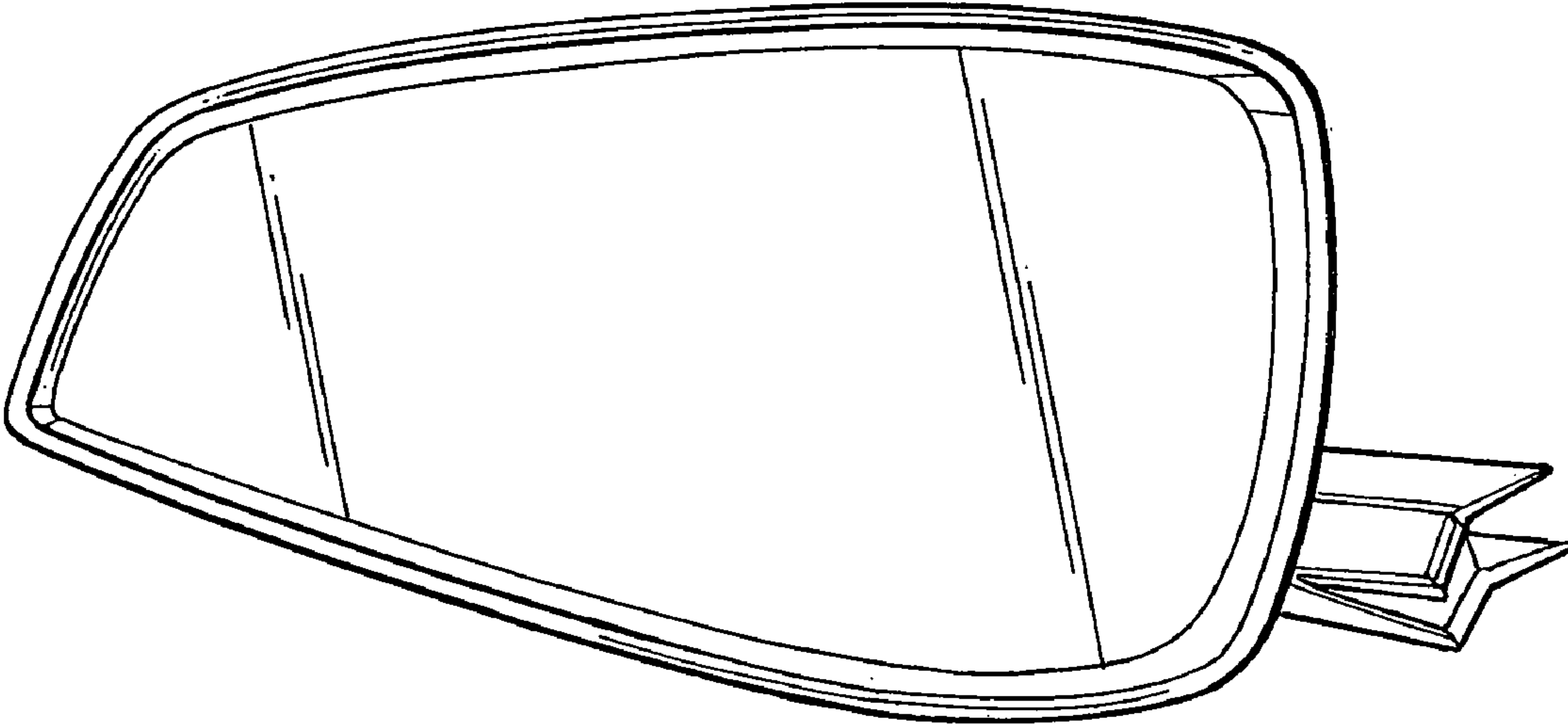

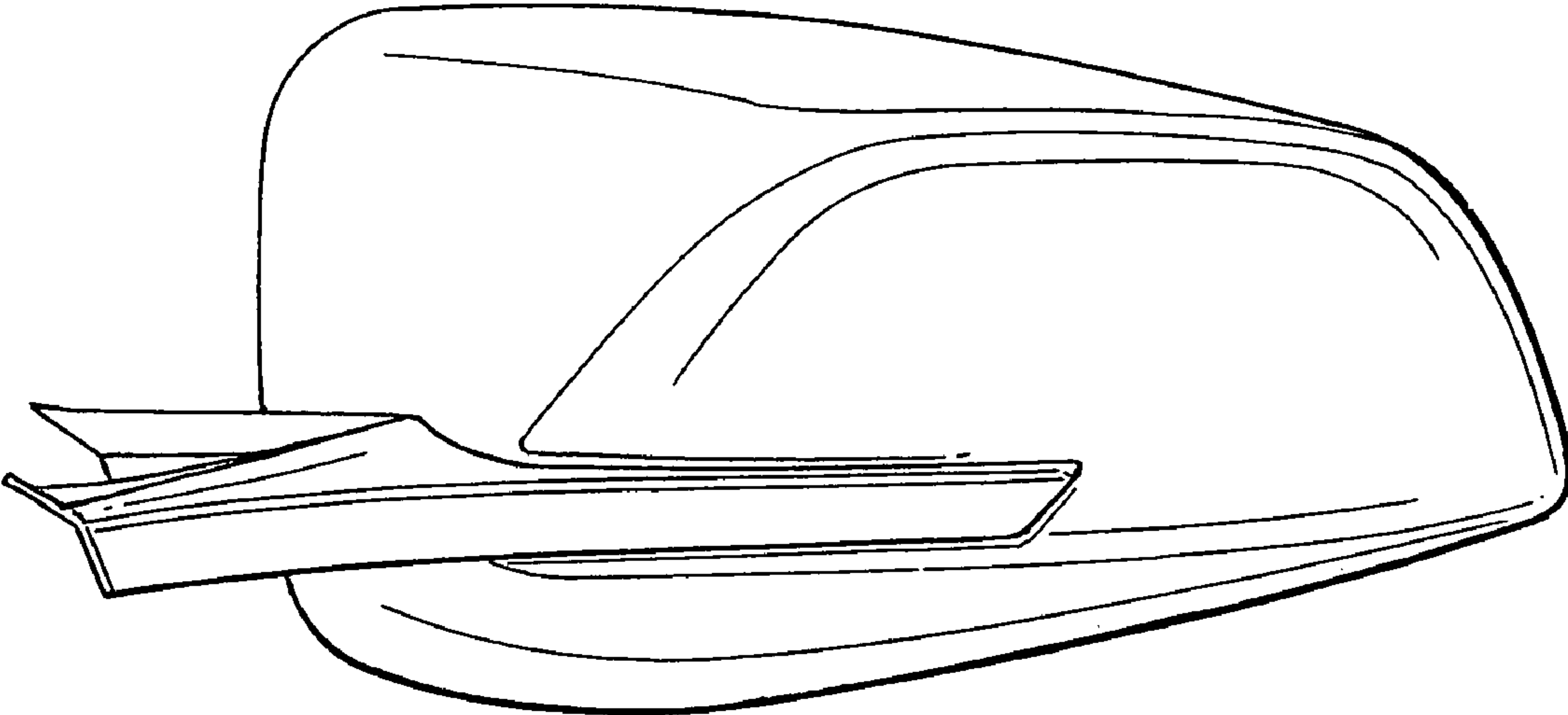

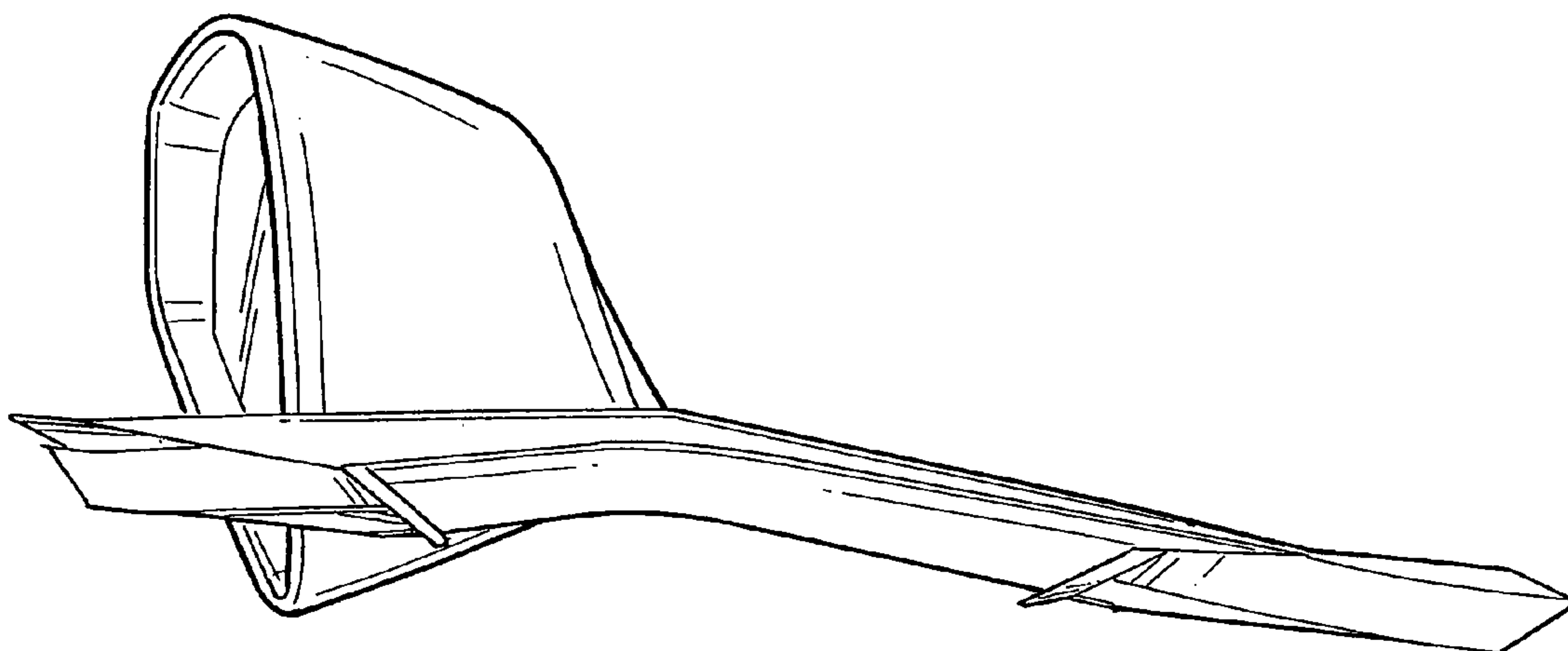

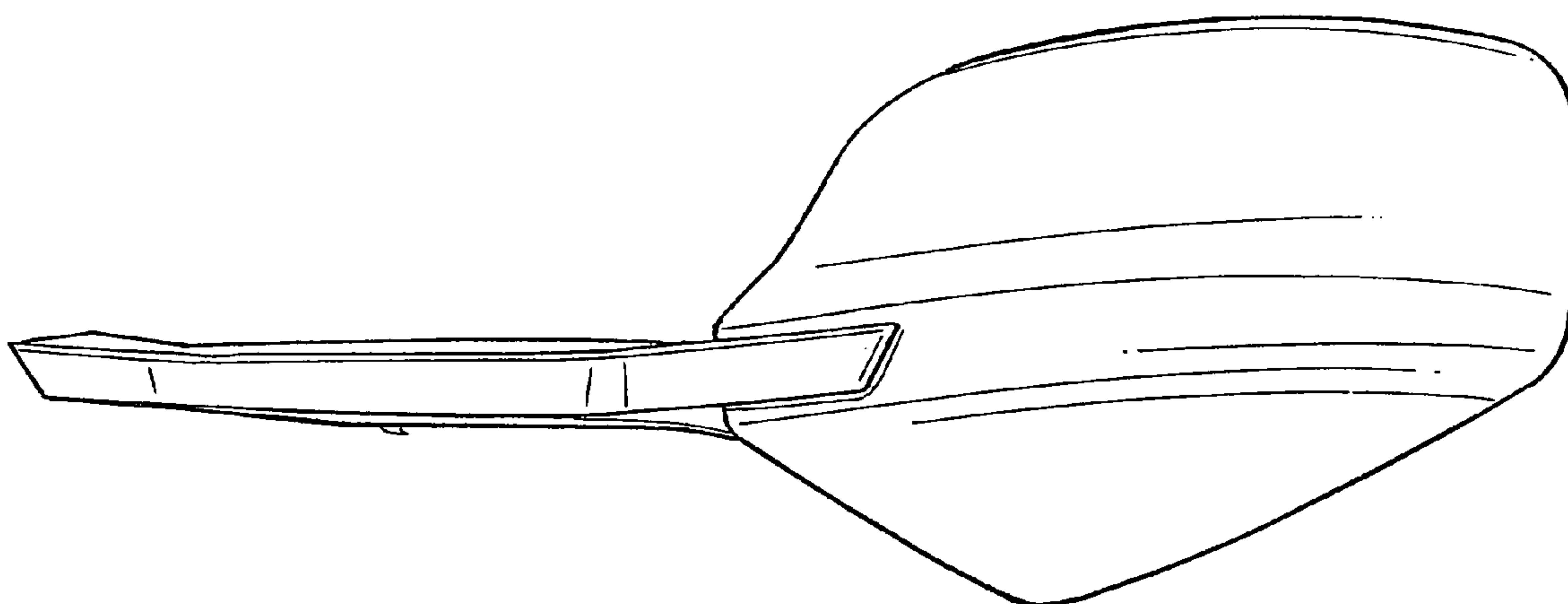

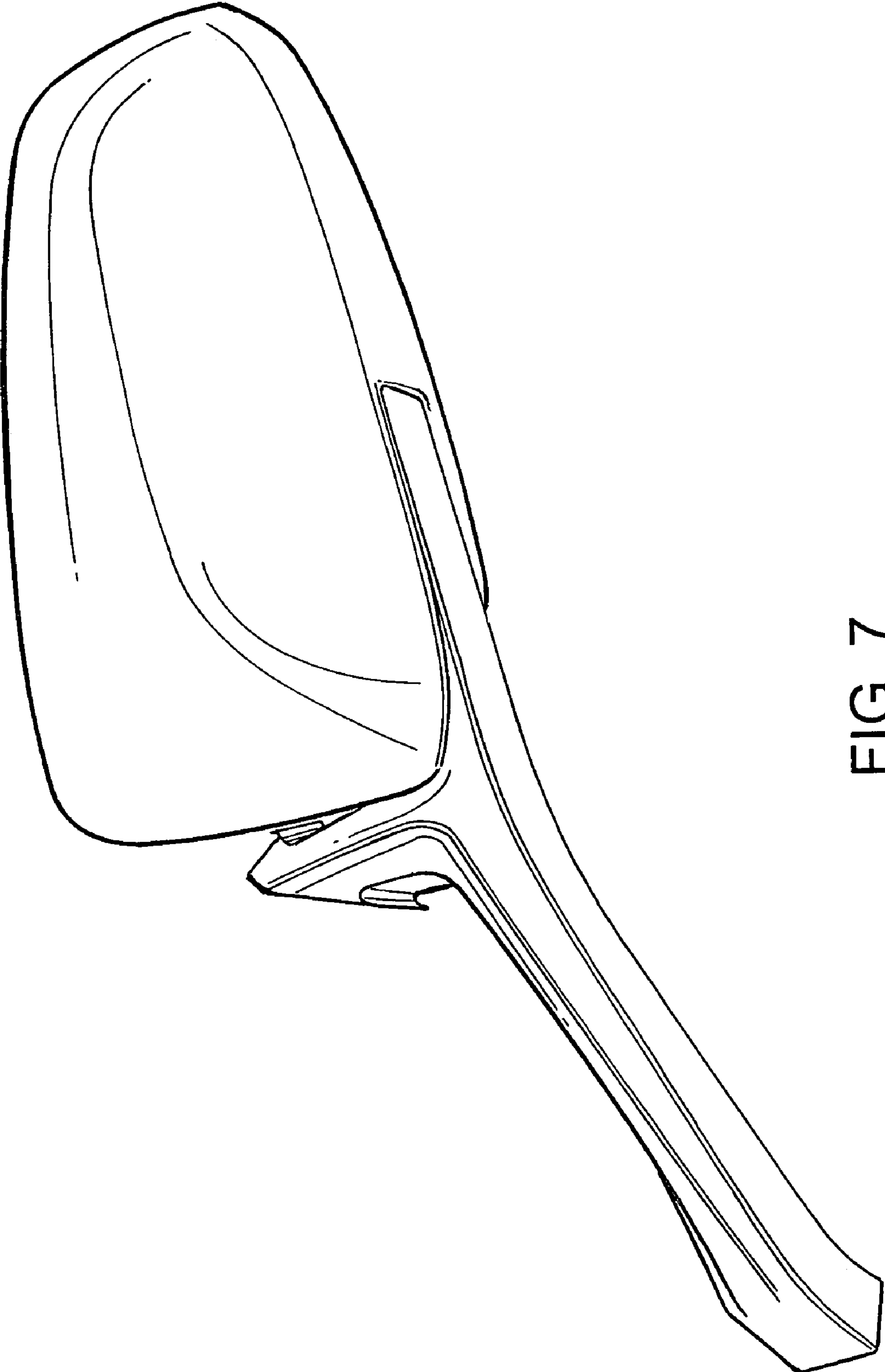

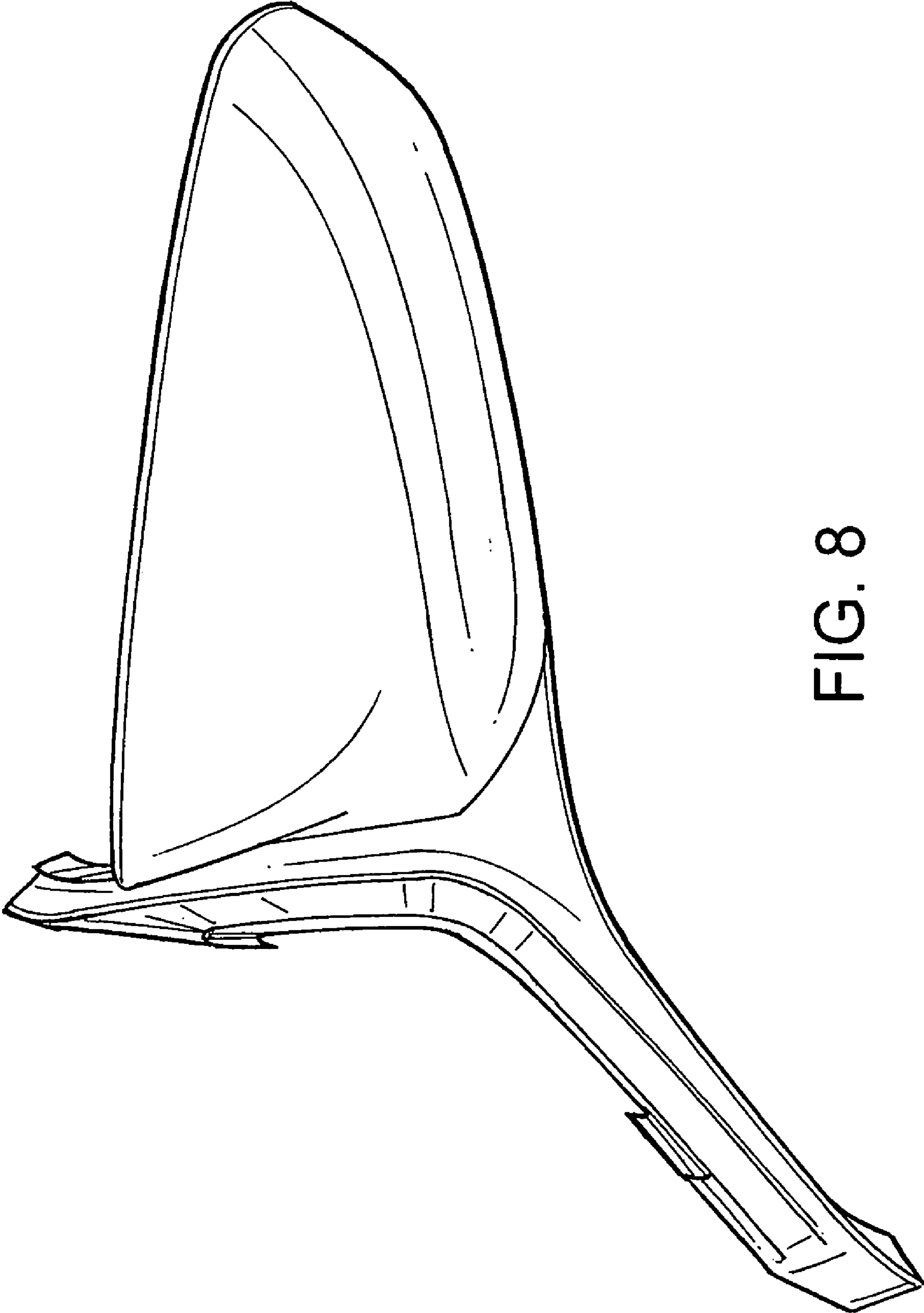

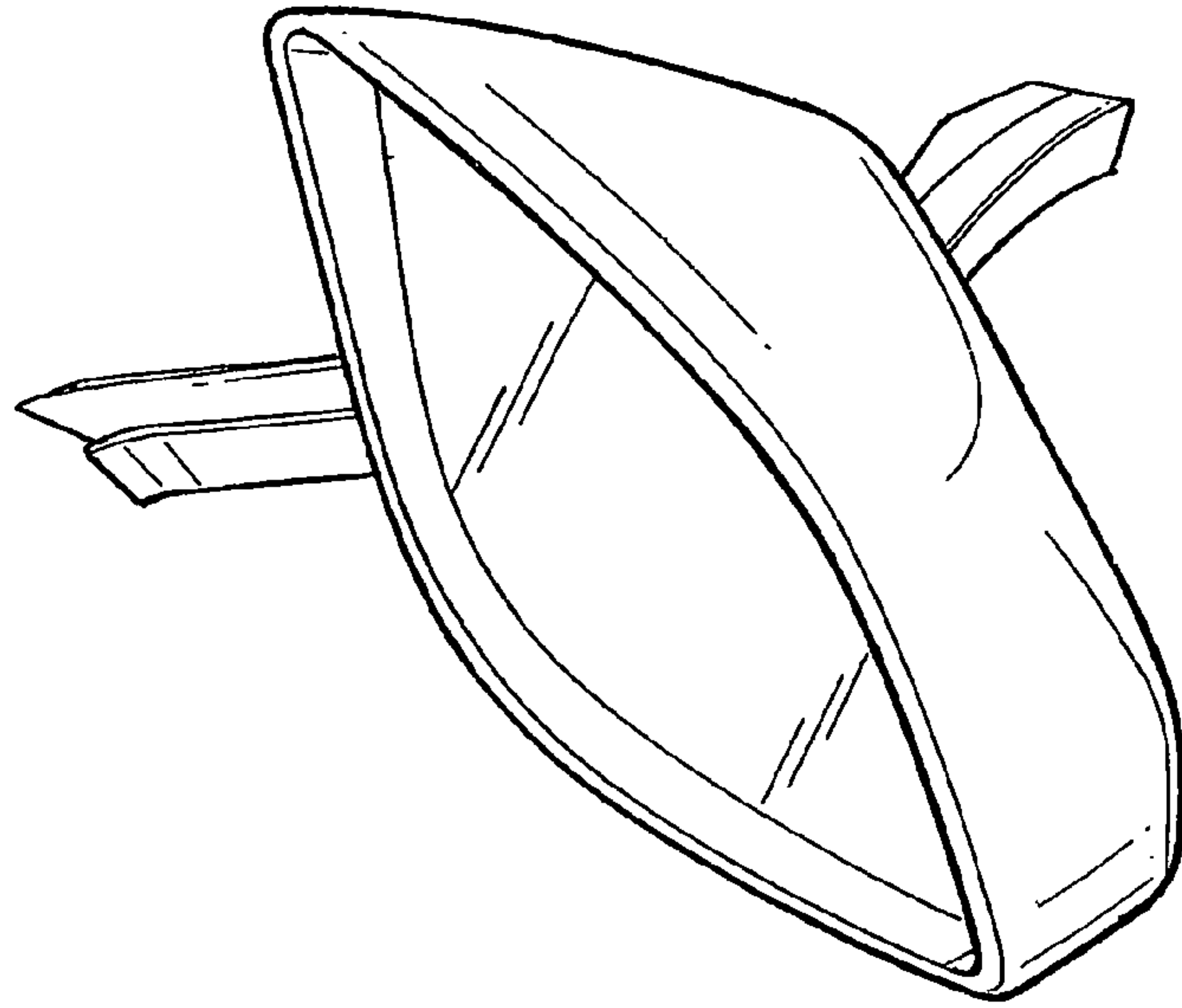

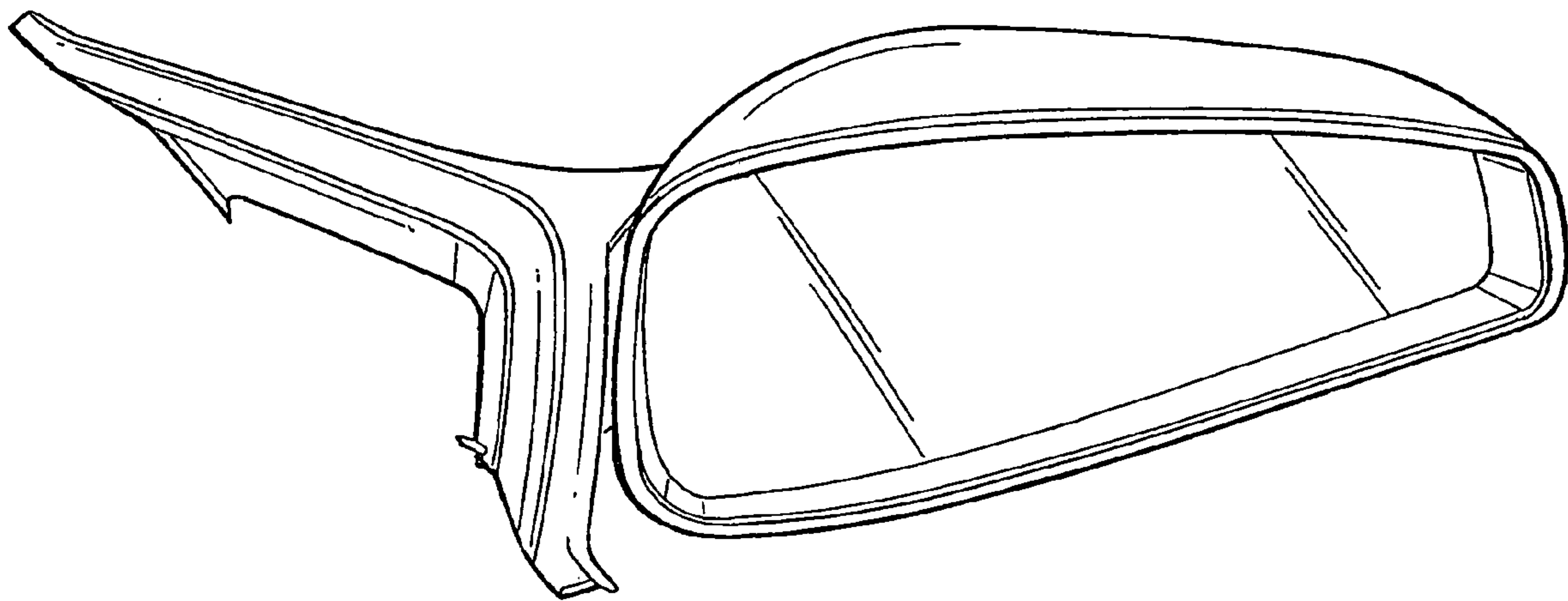

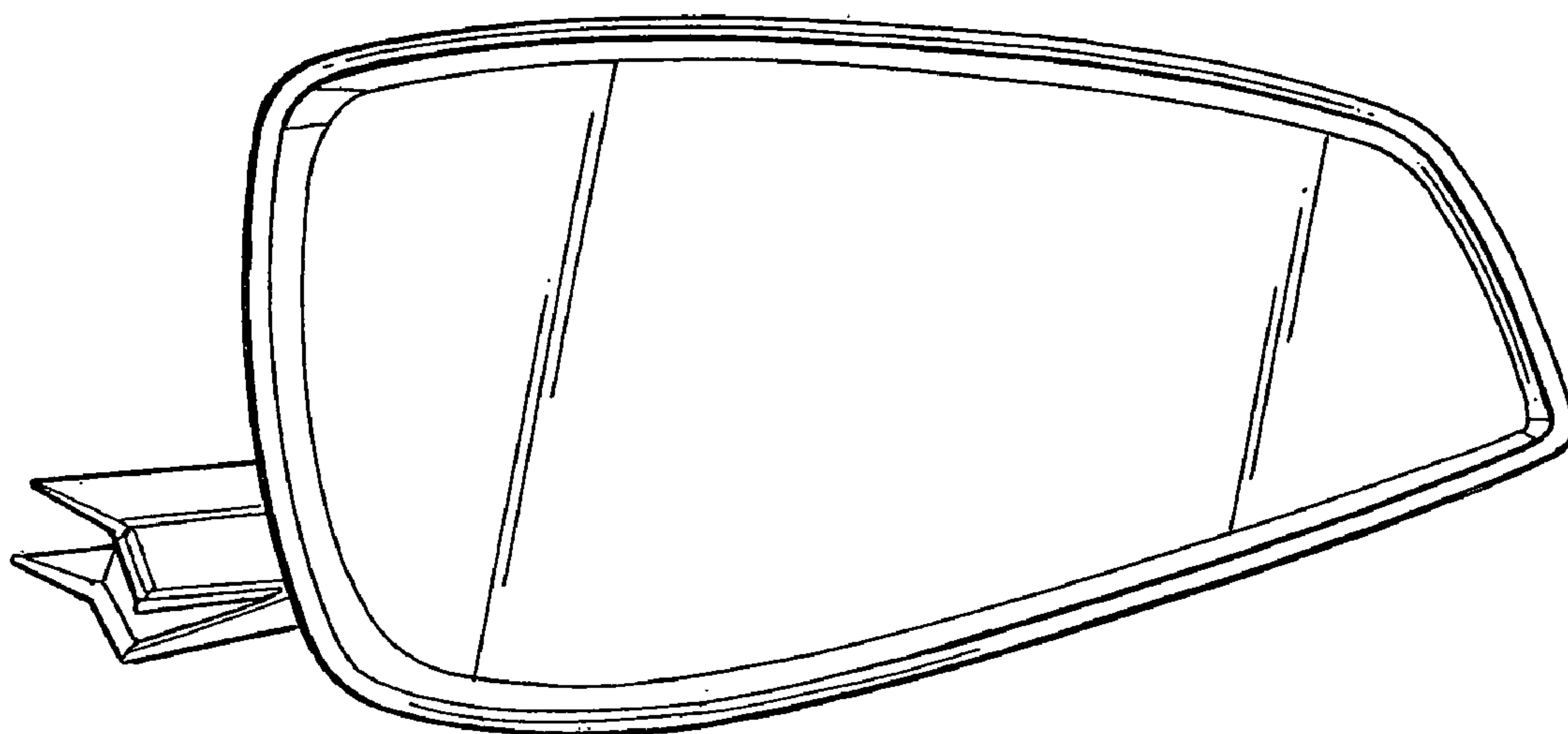

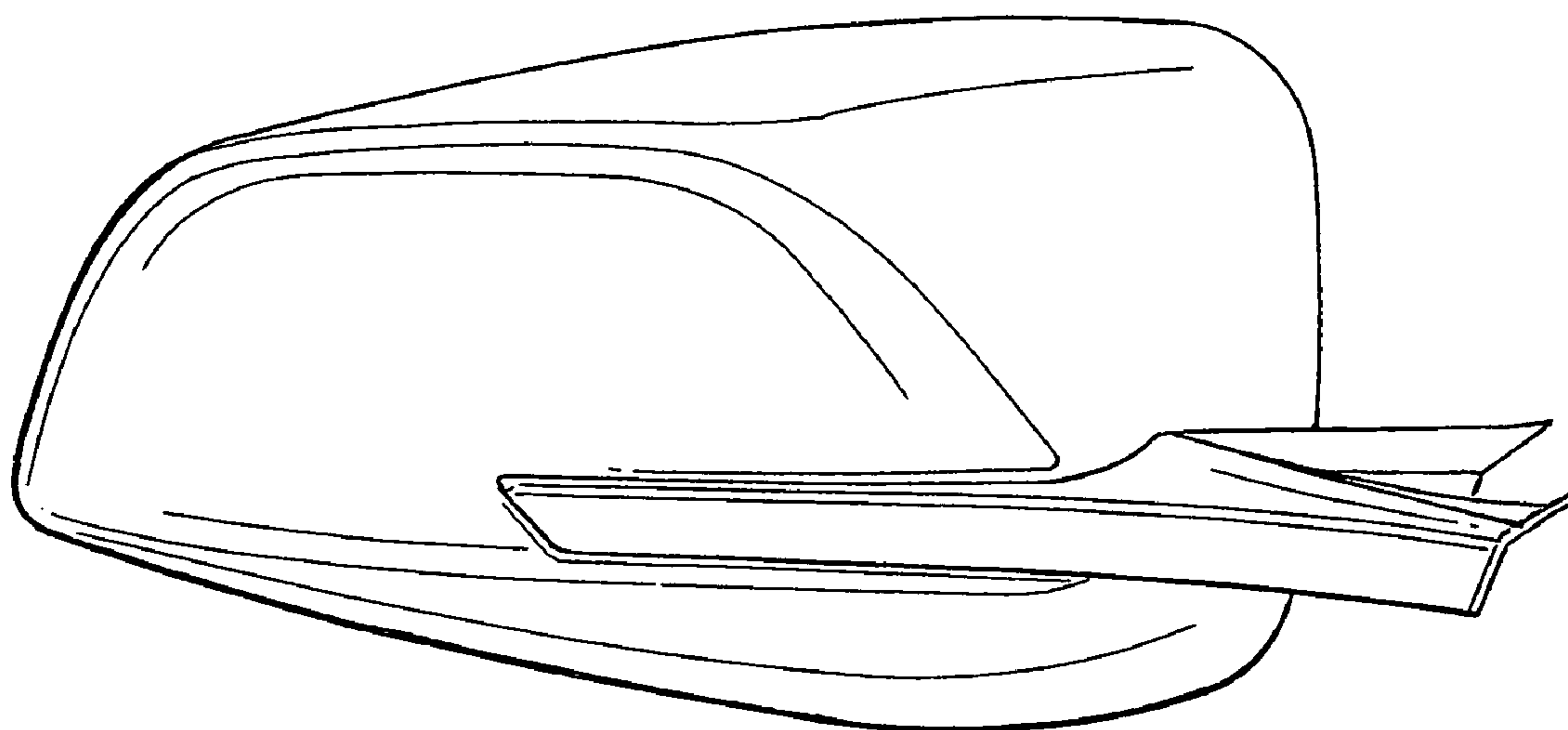

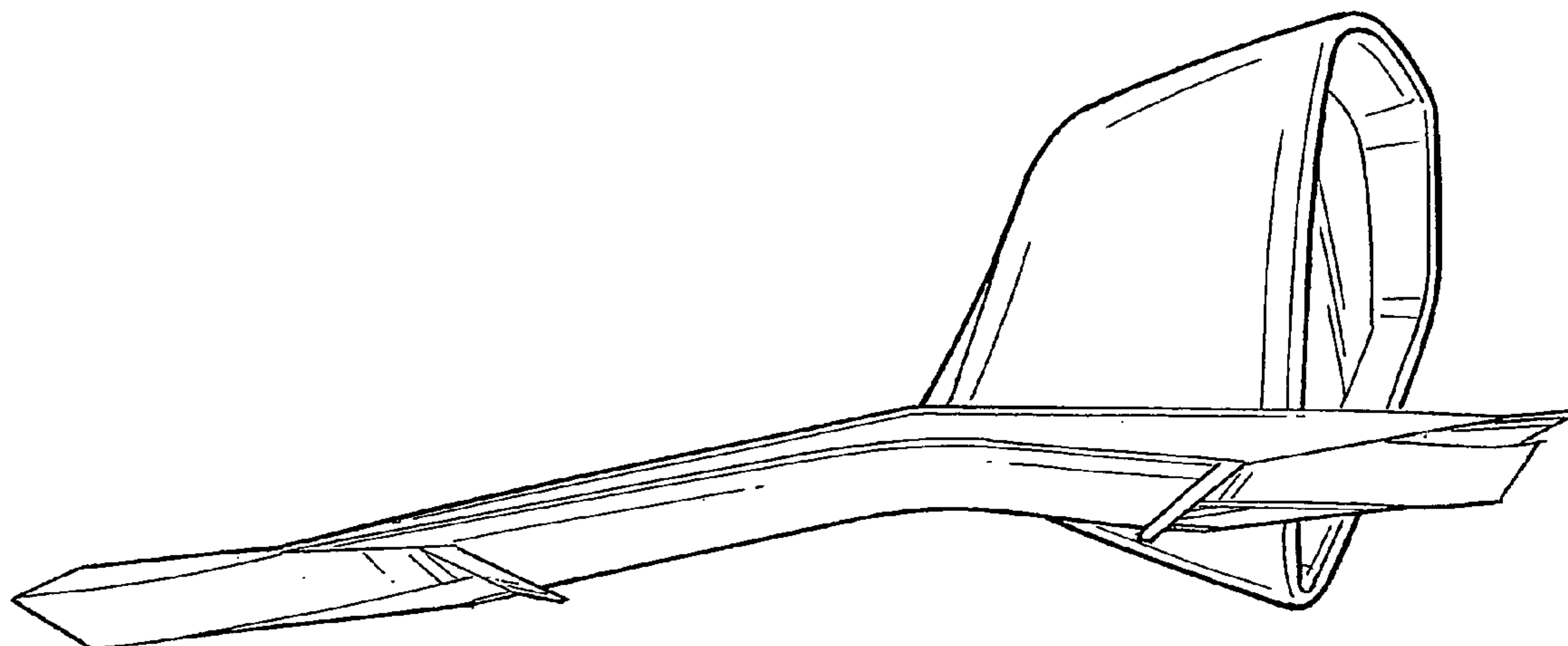

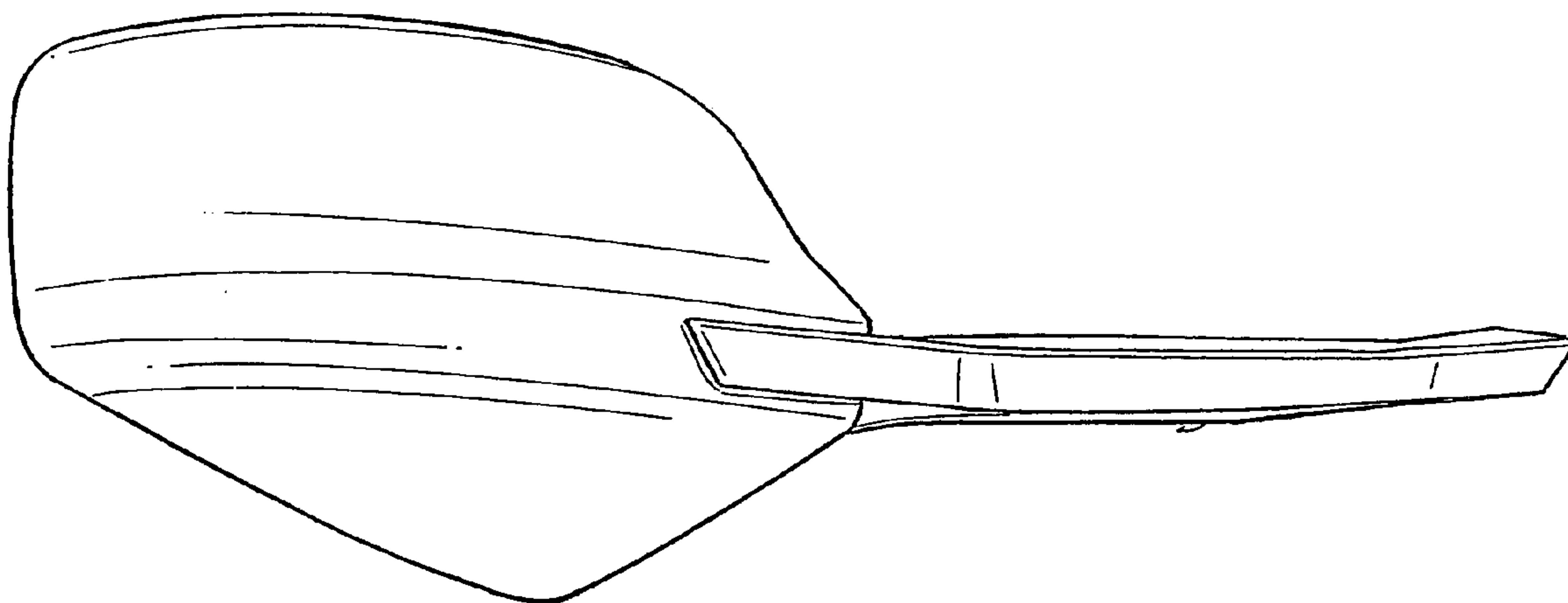

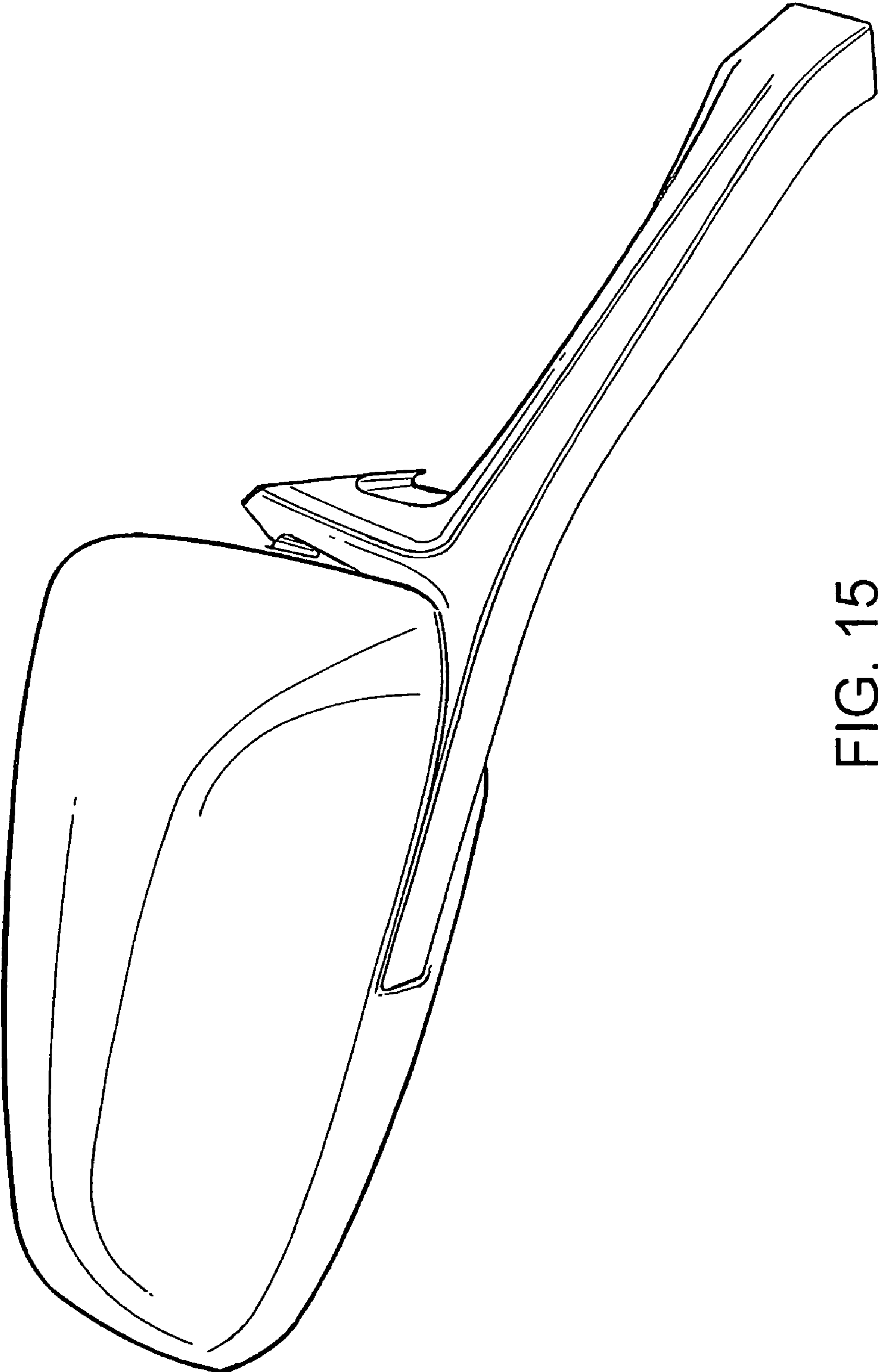

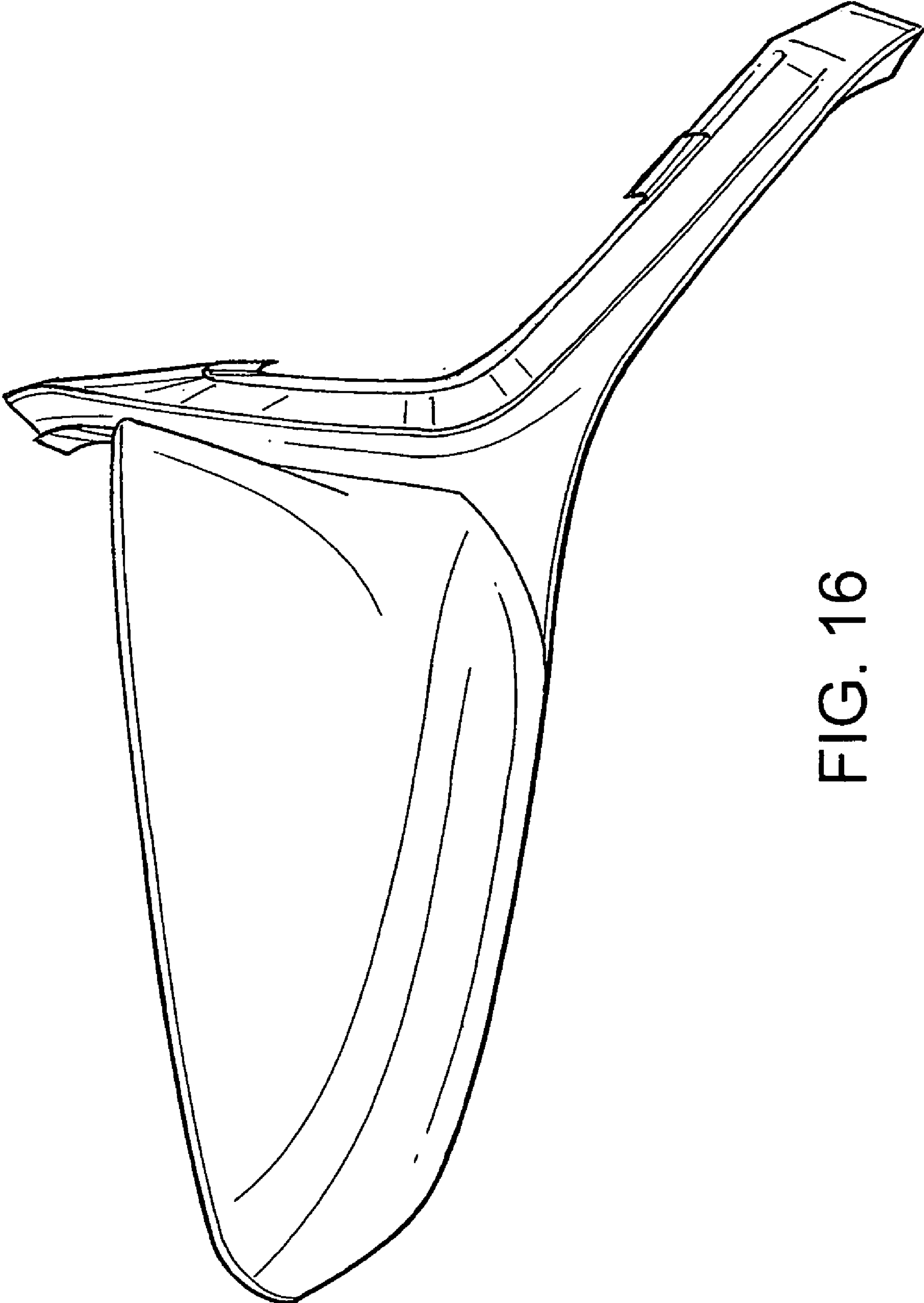
