FIG. 4 is a left side elevational view of the human interface module;

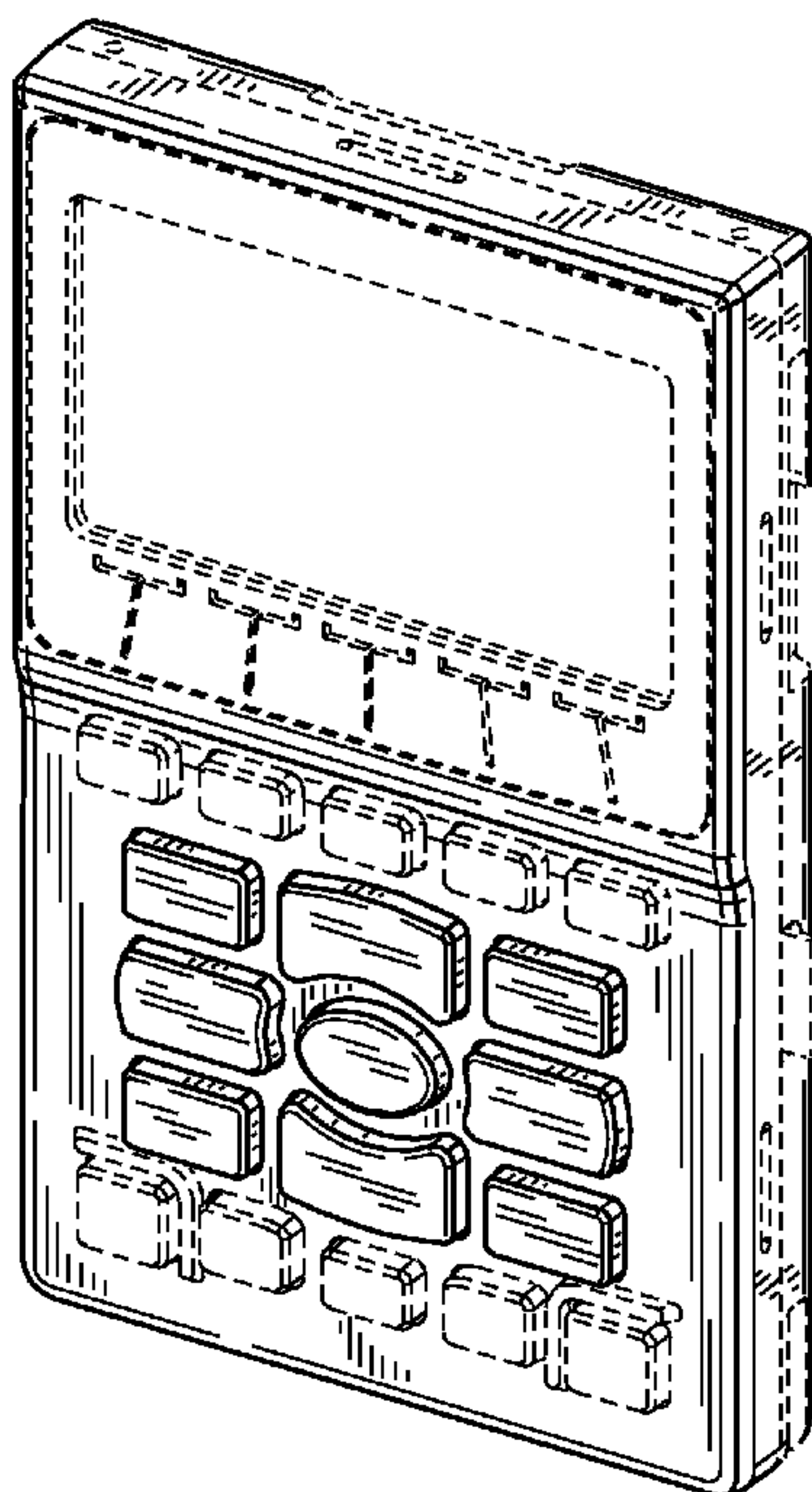
FIG. 5 is top plan view of the human interface module;

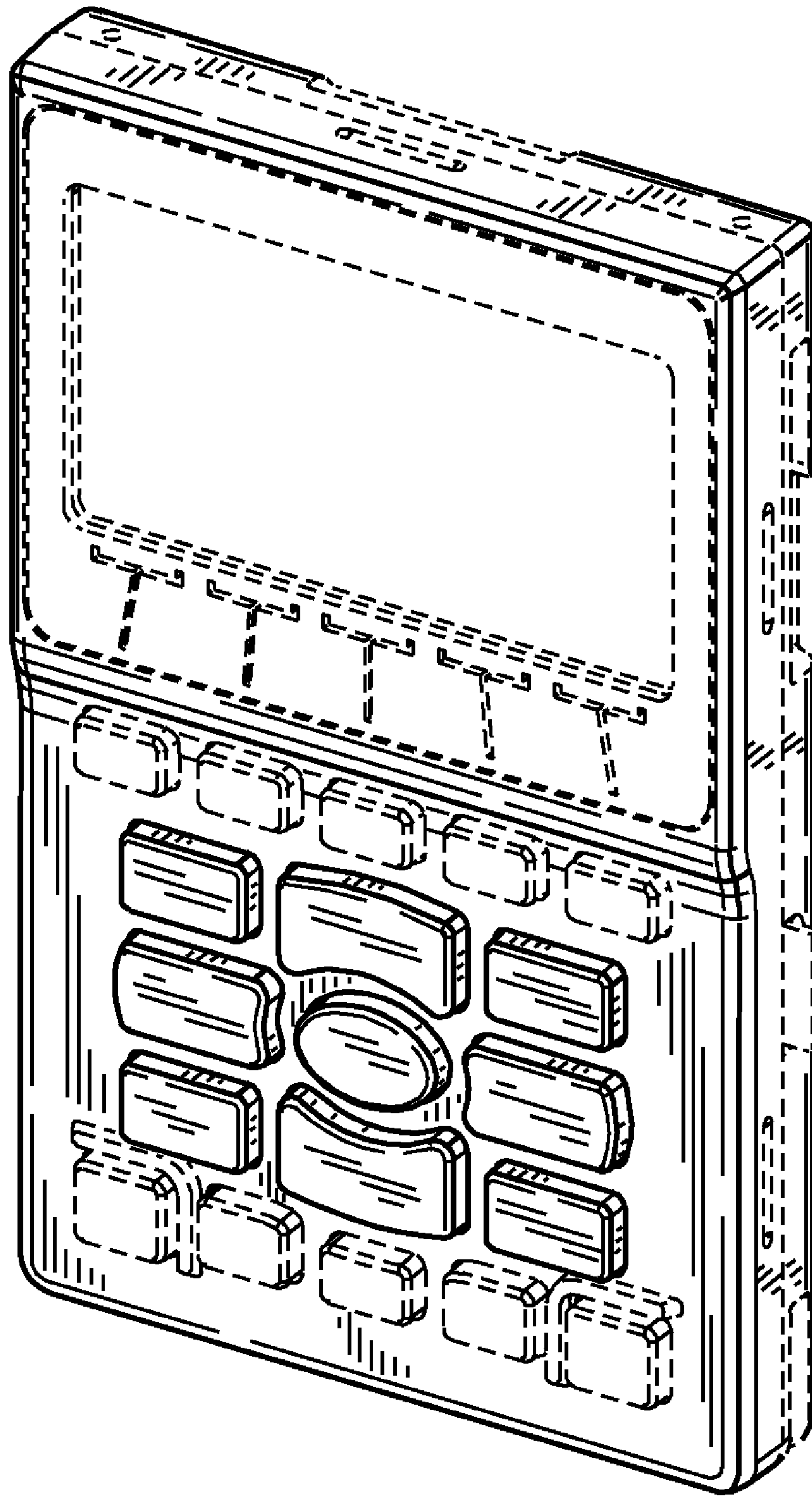

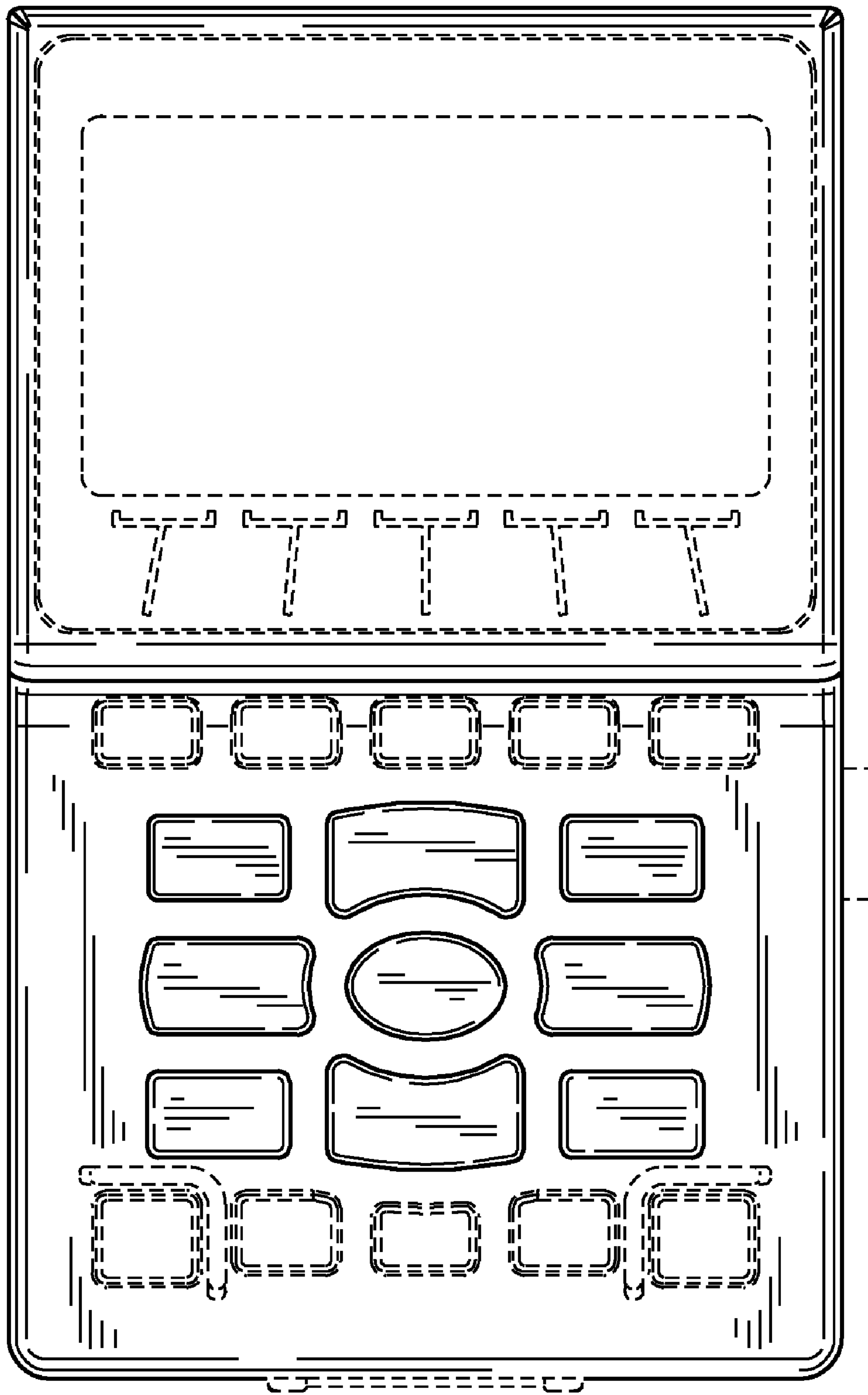

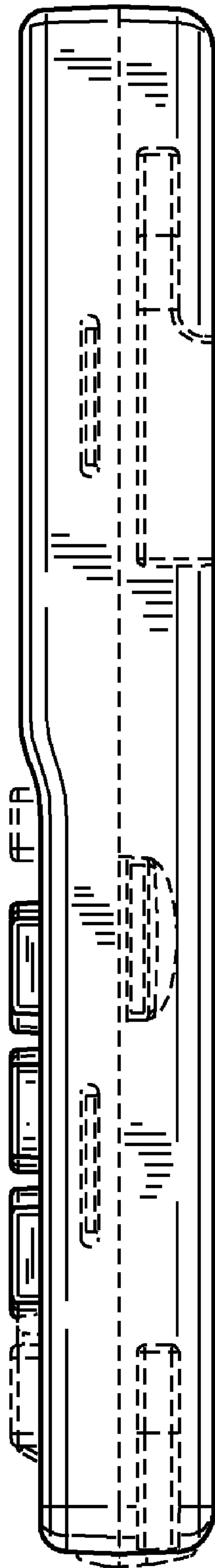

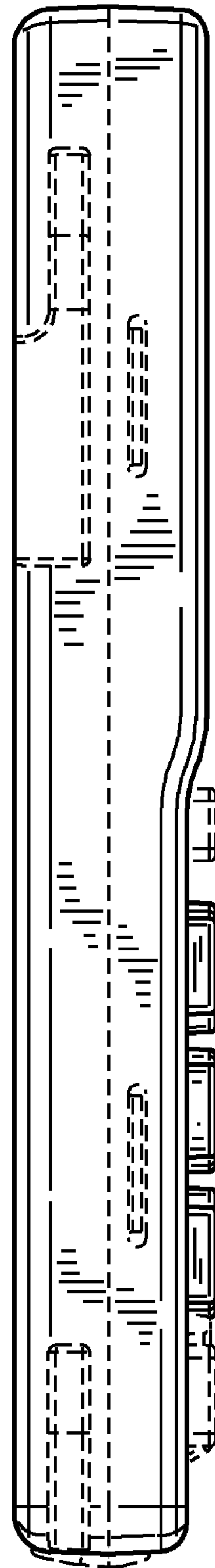

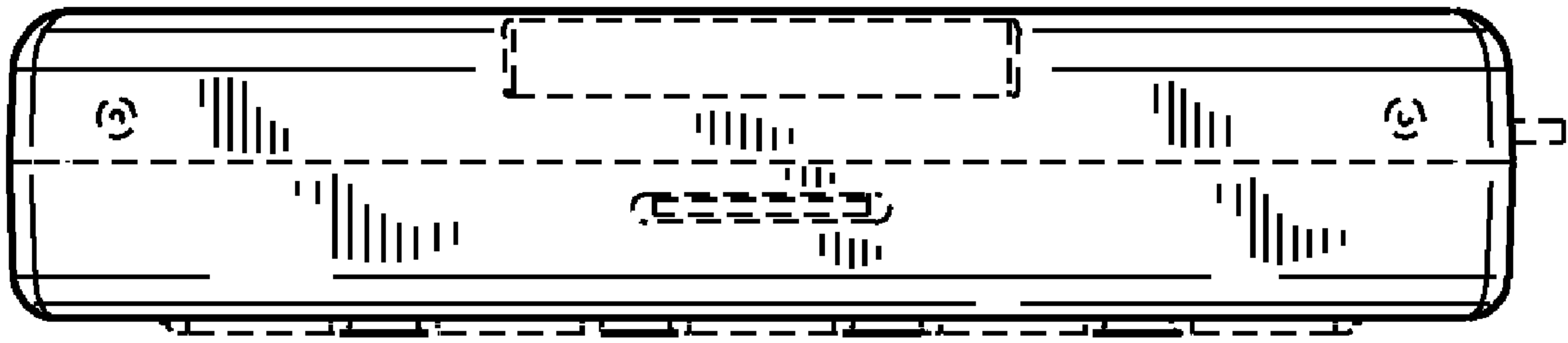

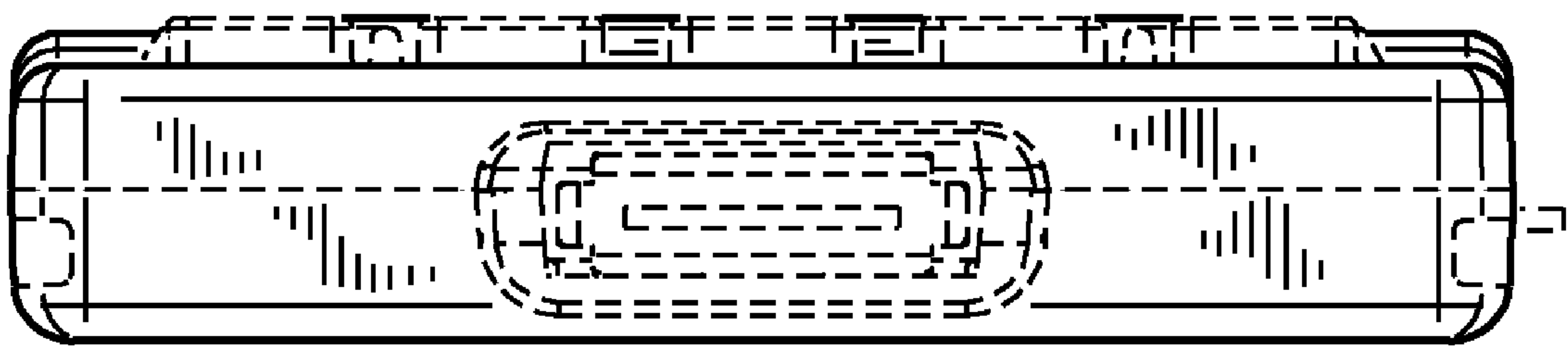

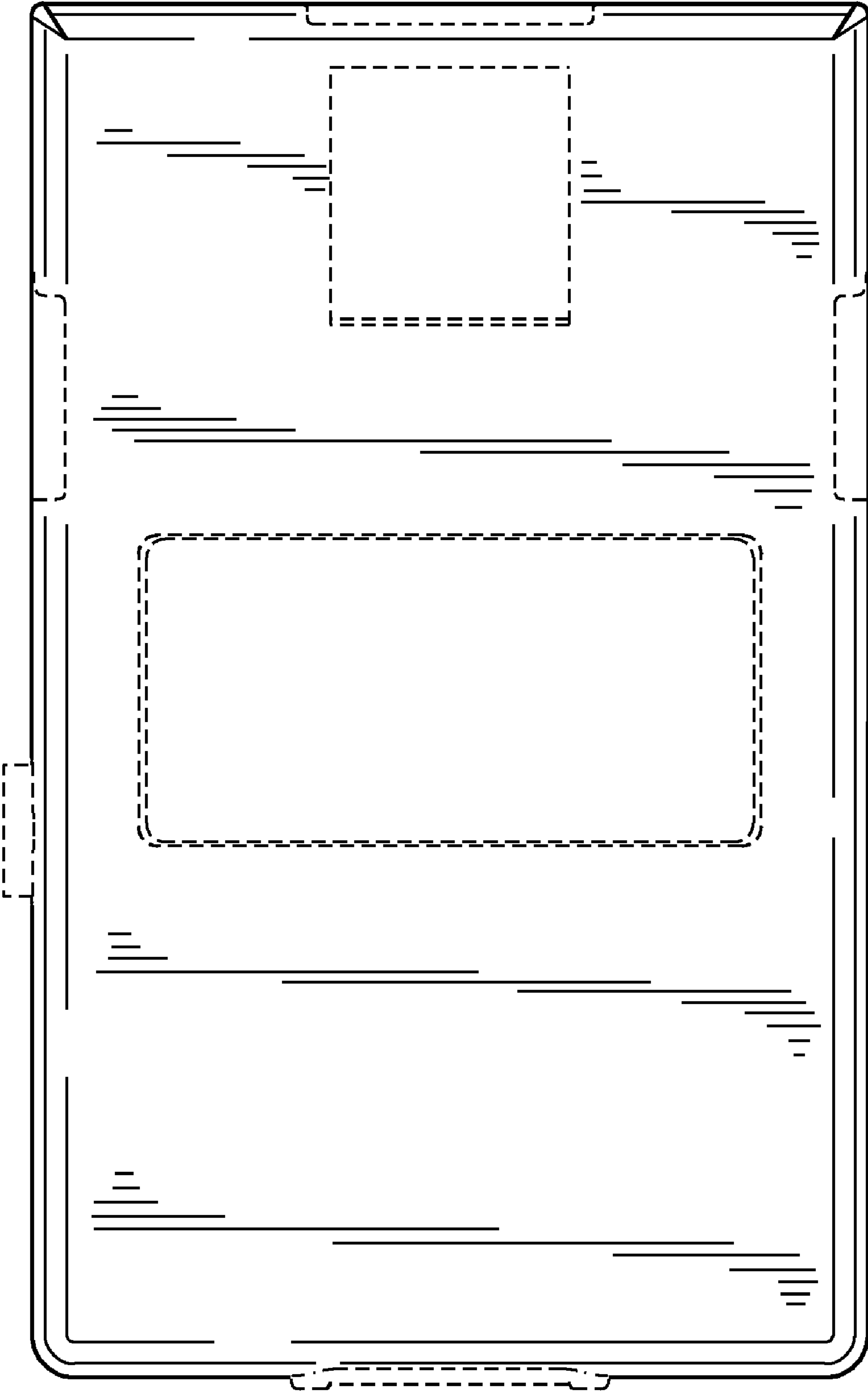
