(57) **CLAIM**

The ornamental design for a identification tag, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an identification tag of our new design;

FIG. 2 is a left side elevational view of the embodiment of FIG. 1 thereof, the right side being a mirror image thereof;

FIG. 3 is a front side elevational view of the embodiment of FIG. 1 thereof; and,

FIG. 4 is a rear side elevational view of FIG. 1 thereof.

The broken lines of the Figures are for the purpose of illustrating portions of the identification tag and form no part of the claimed design.

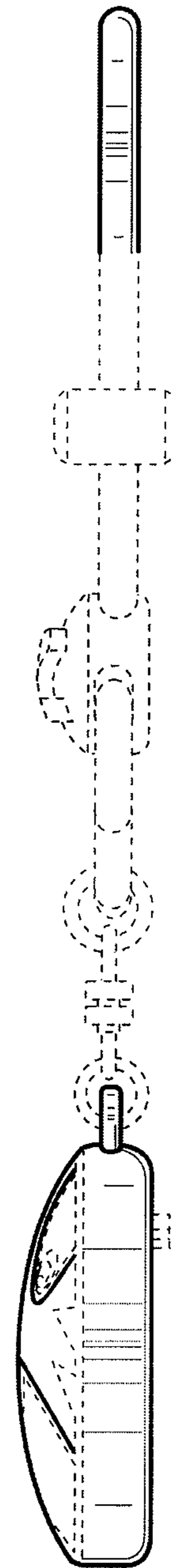

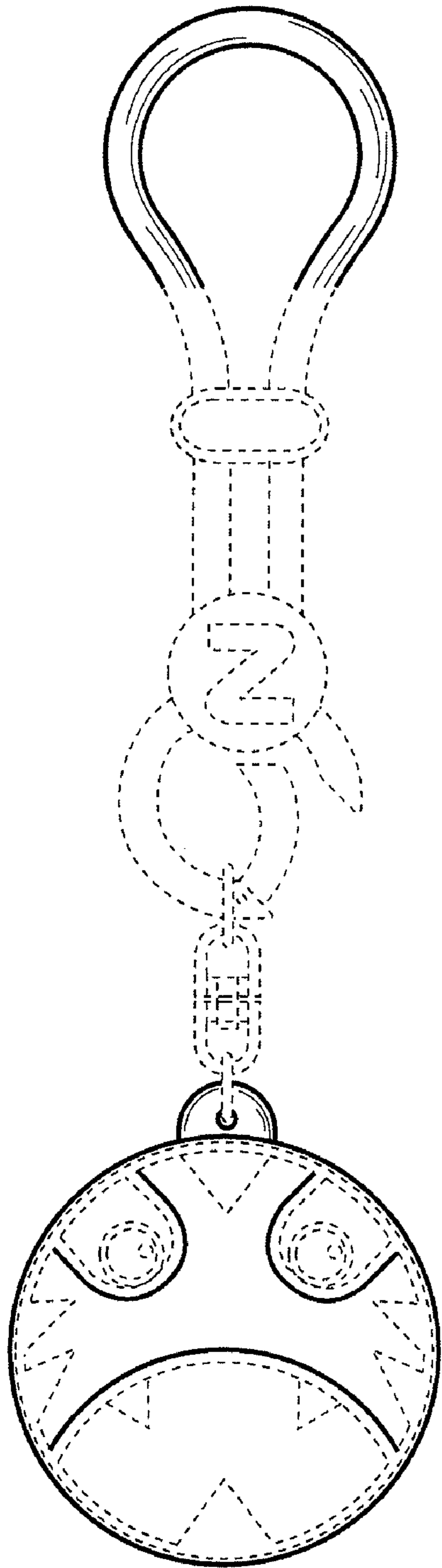

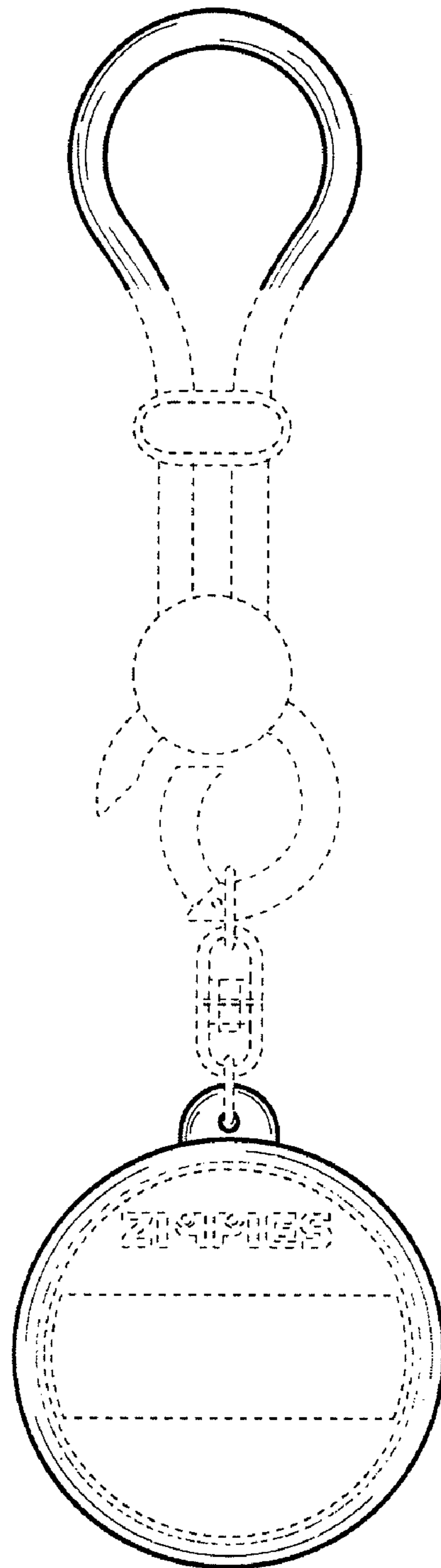
