(57) **CLAIM**

The ornamental design for a golf club head, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a golf club head with its face in the drawing plane, showing a detail 2 according to a first embodiment of the inventive design.

FIG. 2 is an enlarged view of the detail 2 shown in FIG. 1.

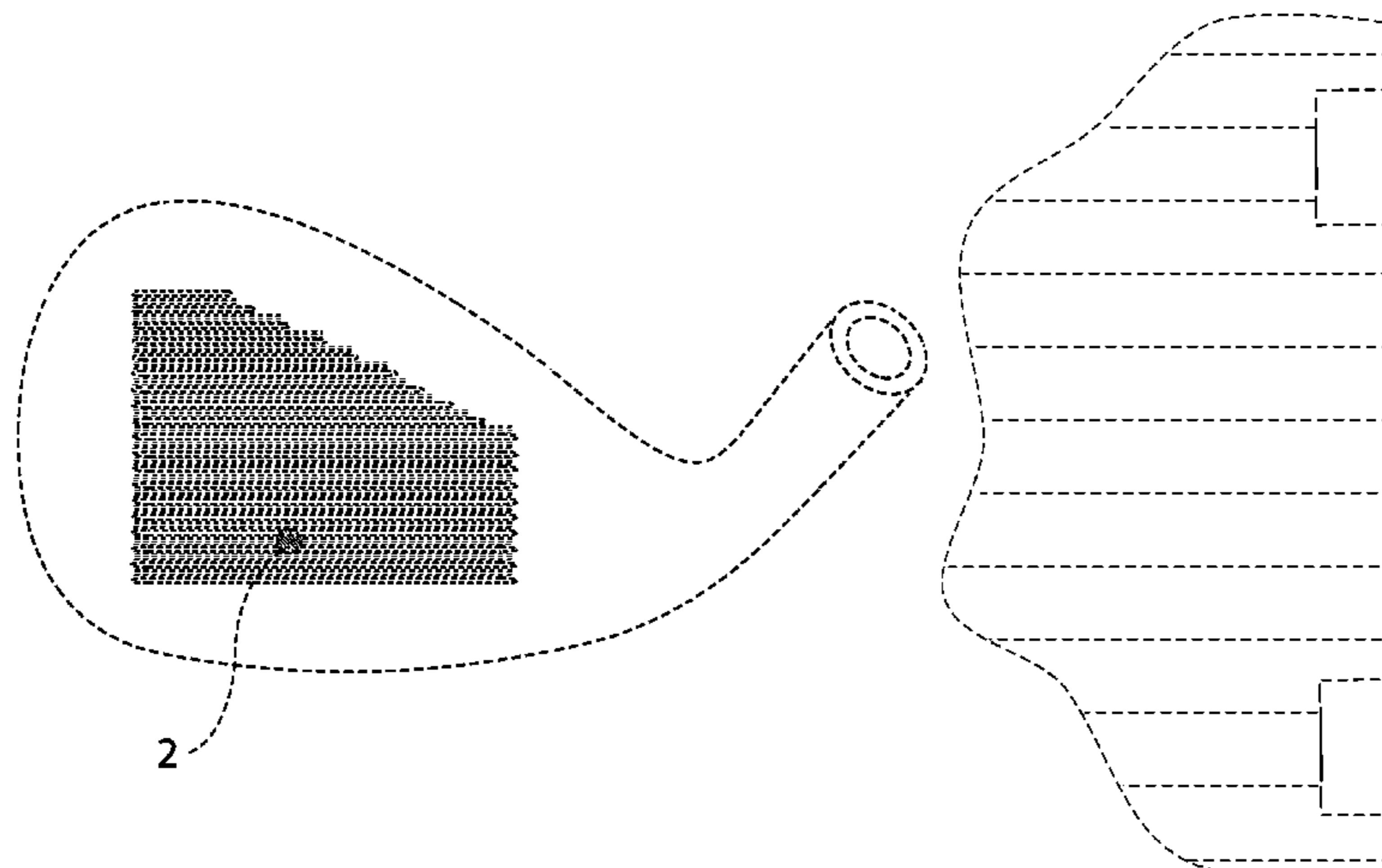


FIG. 3 is a partial cross-sectional view of the detail 2 observed in the direction of lines 3—3 of FIG. 2.

FIG. 4 is a perspective view of the detail 2 shown in FIG. 3.

FIG. 5 is a rear view of the golf club head shown in FIG. 1.

FIG. 6 is a top view of the golf club head shown in FIG. 1.

FIG. 7 is a bottom view the golf club head shown in FIG. 1.

FIG. 8 is a toe side view of the golf club head shown in FIG. 1.

FIG. 9 is a heel side view of the golf club head shown in FIG. 1.

FIG. 10 is a front view of a golf club head with its face in the drawing plane, showing a detail 11 according to a second embodiment of the inventive design.

FIG. 11 is an enlarged view of the detail 11 shown in FIG. 10.

FIG. 12 is a partial cross-sectional view of the detail 11 observed in the direction of lines 12—12 of FIG. 11.

FIG. 13 is a perspective view of the detail 11 shown in FIG. 12.

FIG. 14 is a rear view of the golf club head shown in FIG. 10.

FIG. 15 is a top view of the golf club head shown in FIG. 10.

FIG. 16 is a bottom view the golf club head shown in FIG. 10.

FIG. 17 is a toe side view of the golf club head shown in FIG. 10.

FIG. 18 is a heel side view of the golf club head shown in FIG. 10.

FIG. 19 is a front view of a golf club head with its face in the drawing plane, showing a detail 20 according to a third embodiment of the inventive design.

FIG. 20 is an enlarged view of the detail 20 shown in FIG. 19.

FIG. 21 is a partial cross-sectional view of the detail 20 observed in the direction of lines 21—21 of FIG. 20.

FIG. 22 is a perspective view of the detail 20 shown in FIG. 21.

FIG. 23 is a rear view of the golf club head shown in FIG. 19.

FIG. 24 is a top view of the golf club head shown in FIG. 19.

FIG. 25 is a bottom view the golf club head shown in FIG. 19.

FIG. 26 is a toe side view of the golf club head shown in FIG. 19; and,

FIG. 27 is a heel side view of the golf club head shown in FIG. 19.

The shading represents three different surface treatments. The broken lines immediately adjacent the shaded areas represent the bounds of the claimed design, while all other broken lines are directed to environment and are for illustrative purposes only; the broken lines form no part of the claimed design.

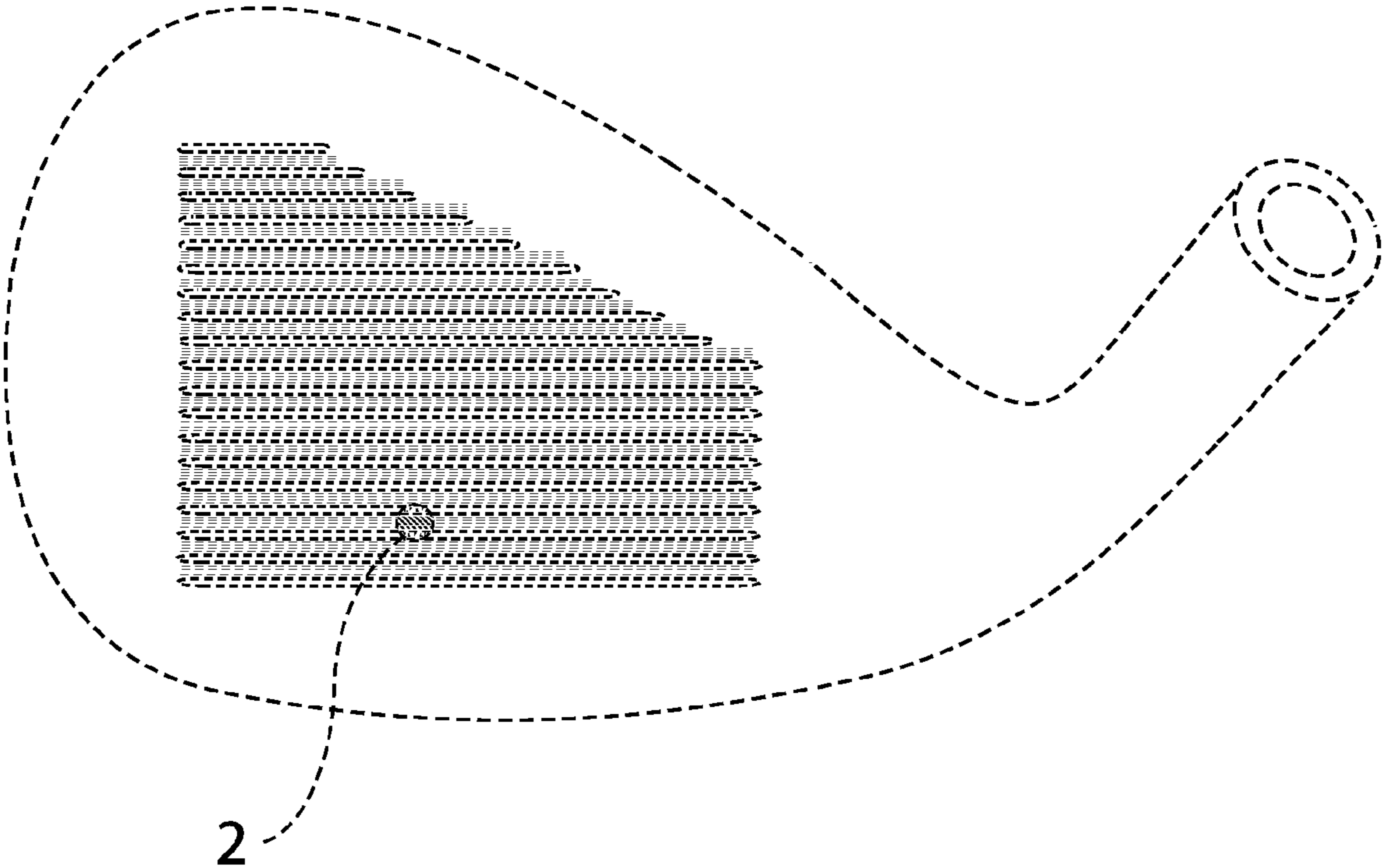

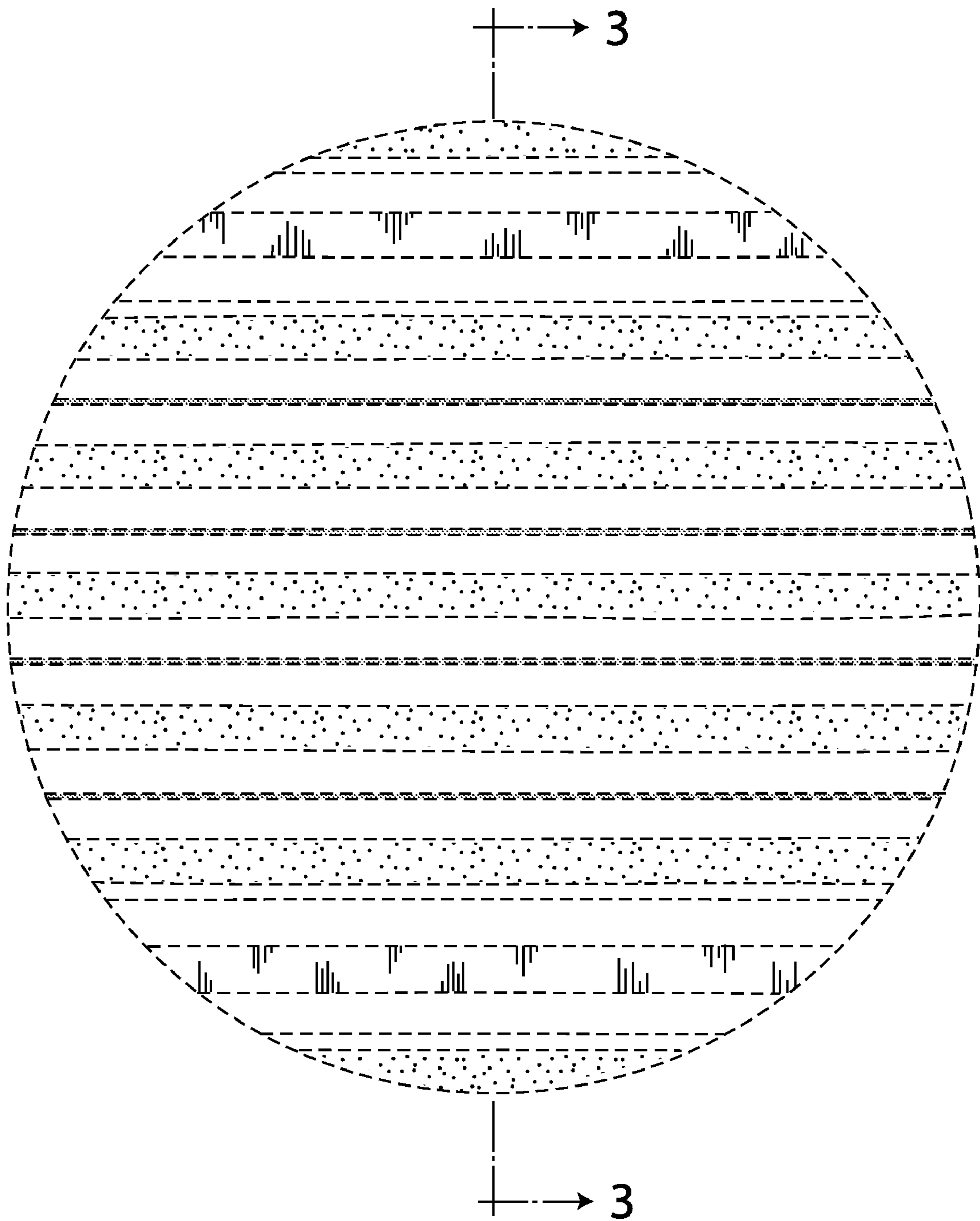

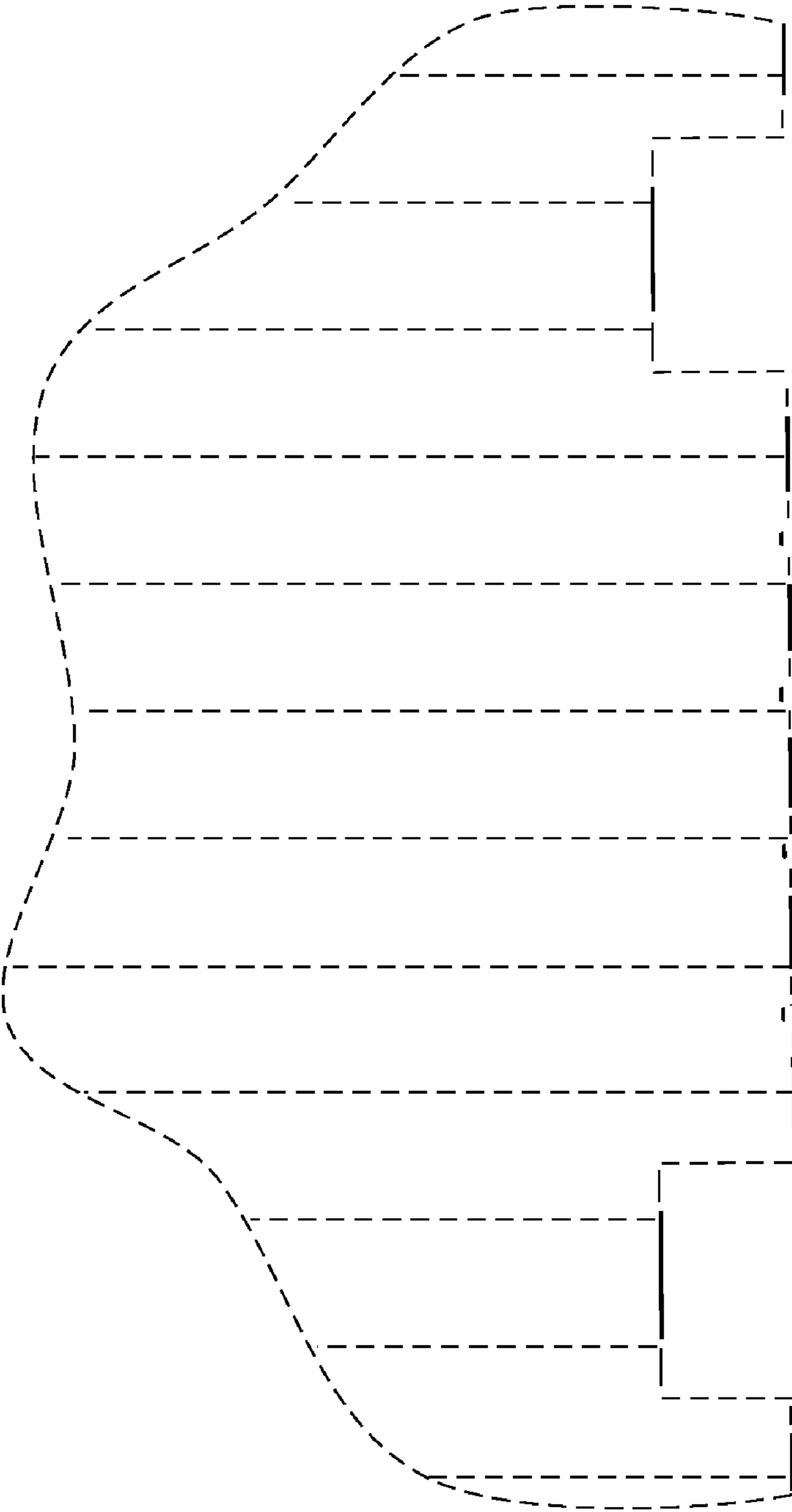

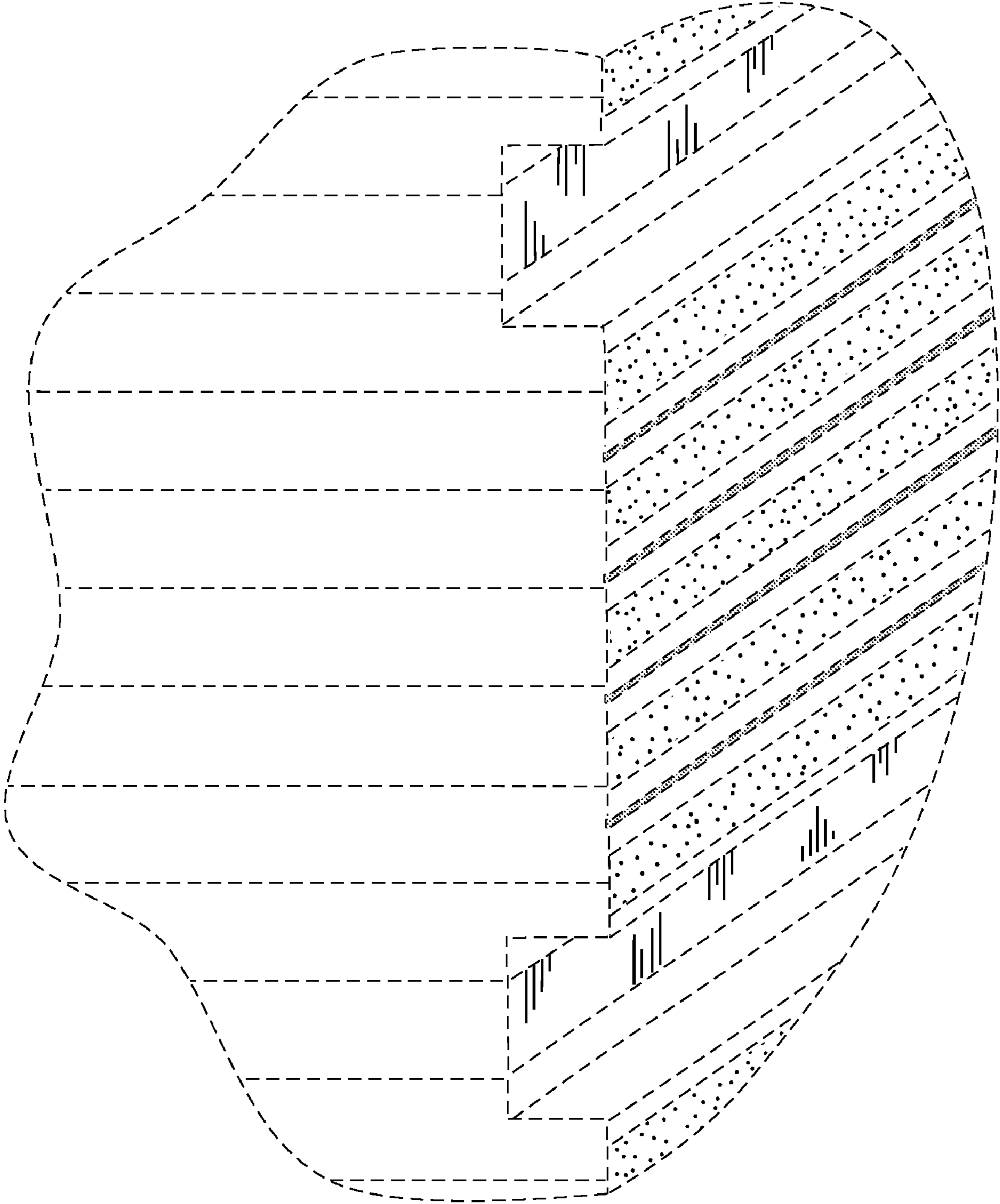

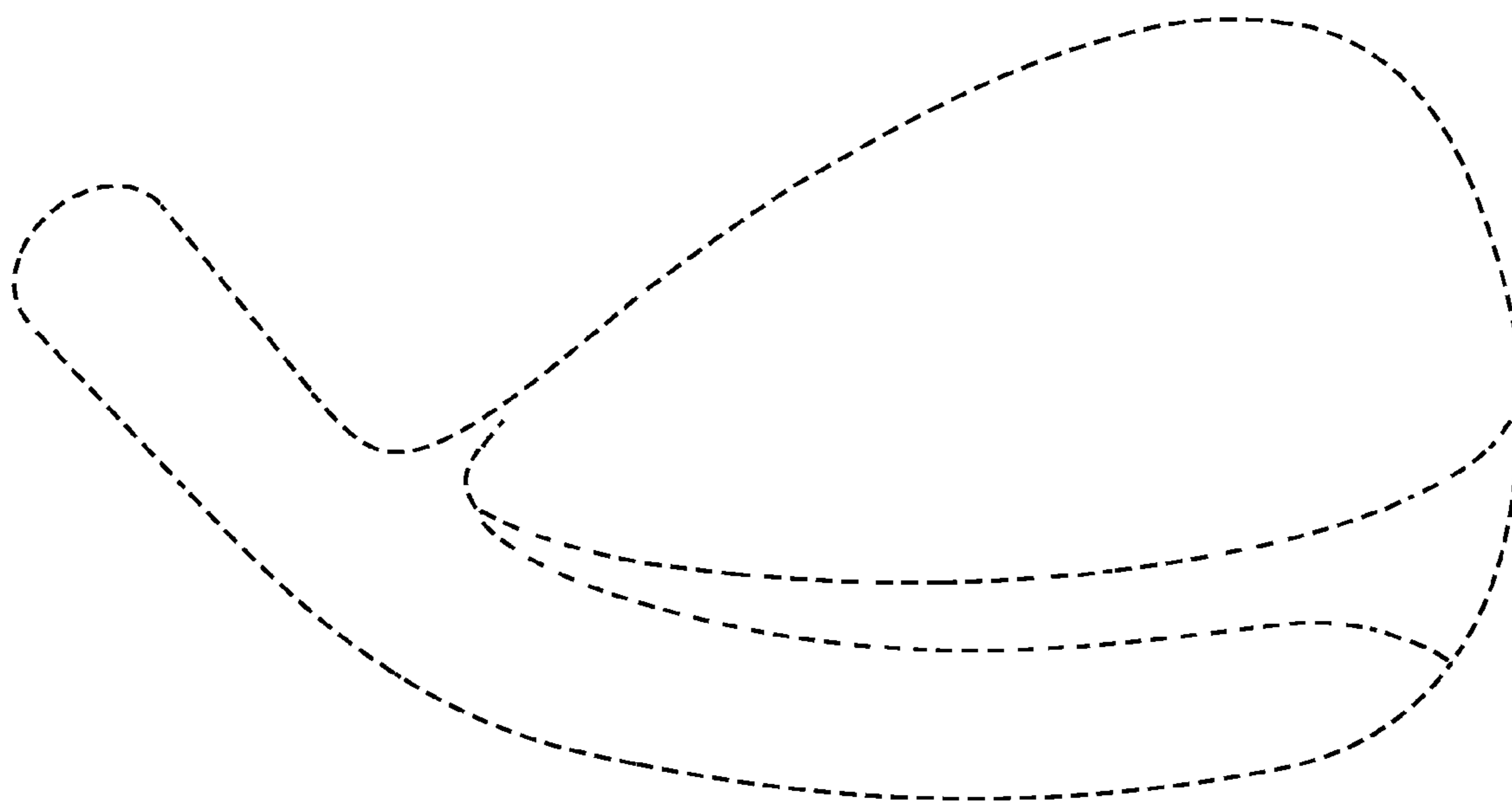

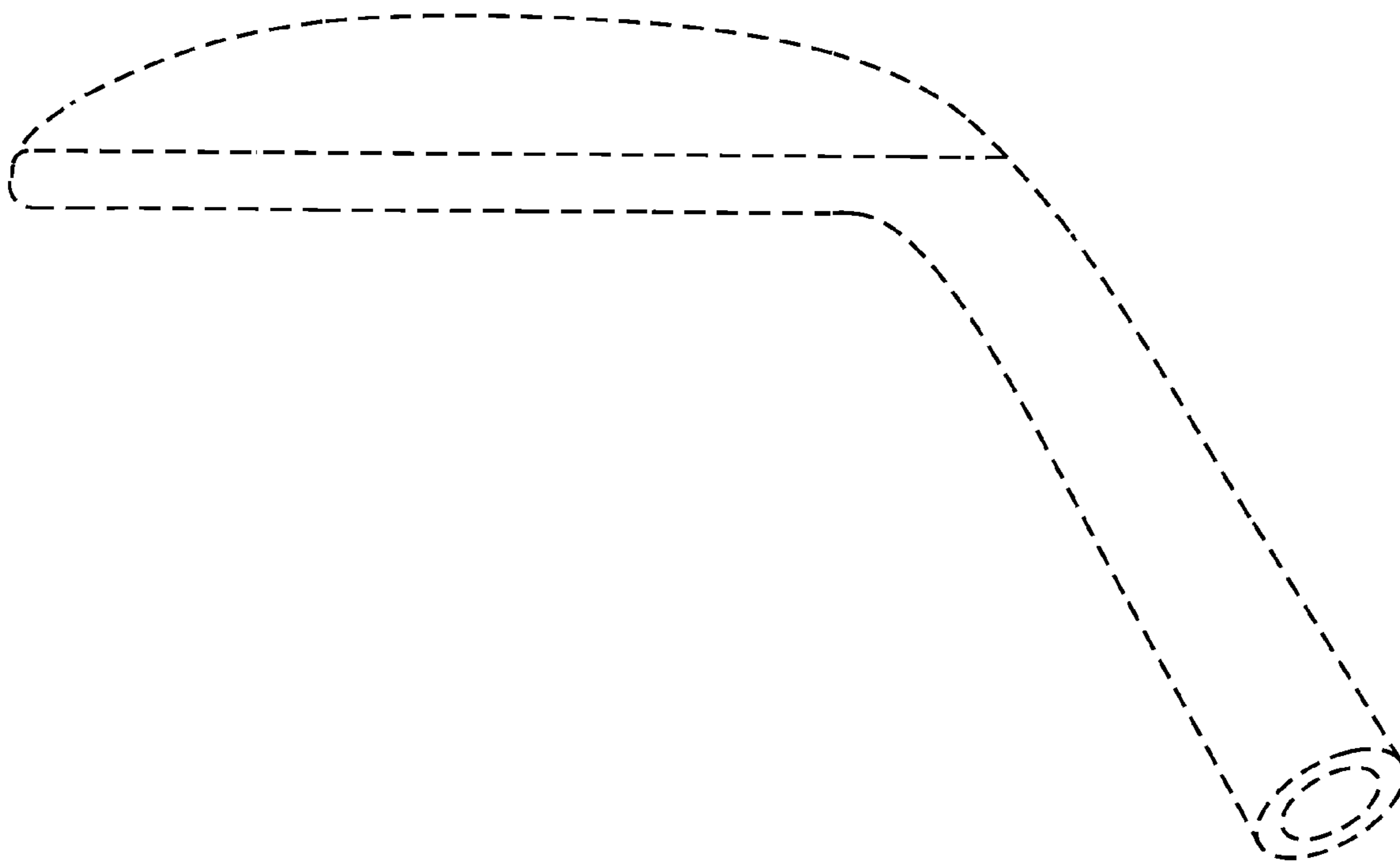

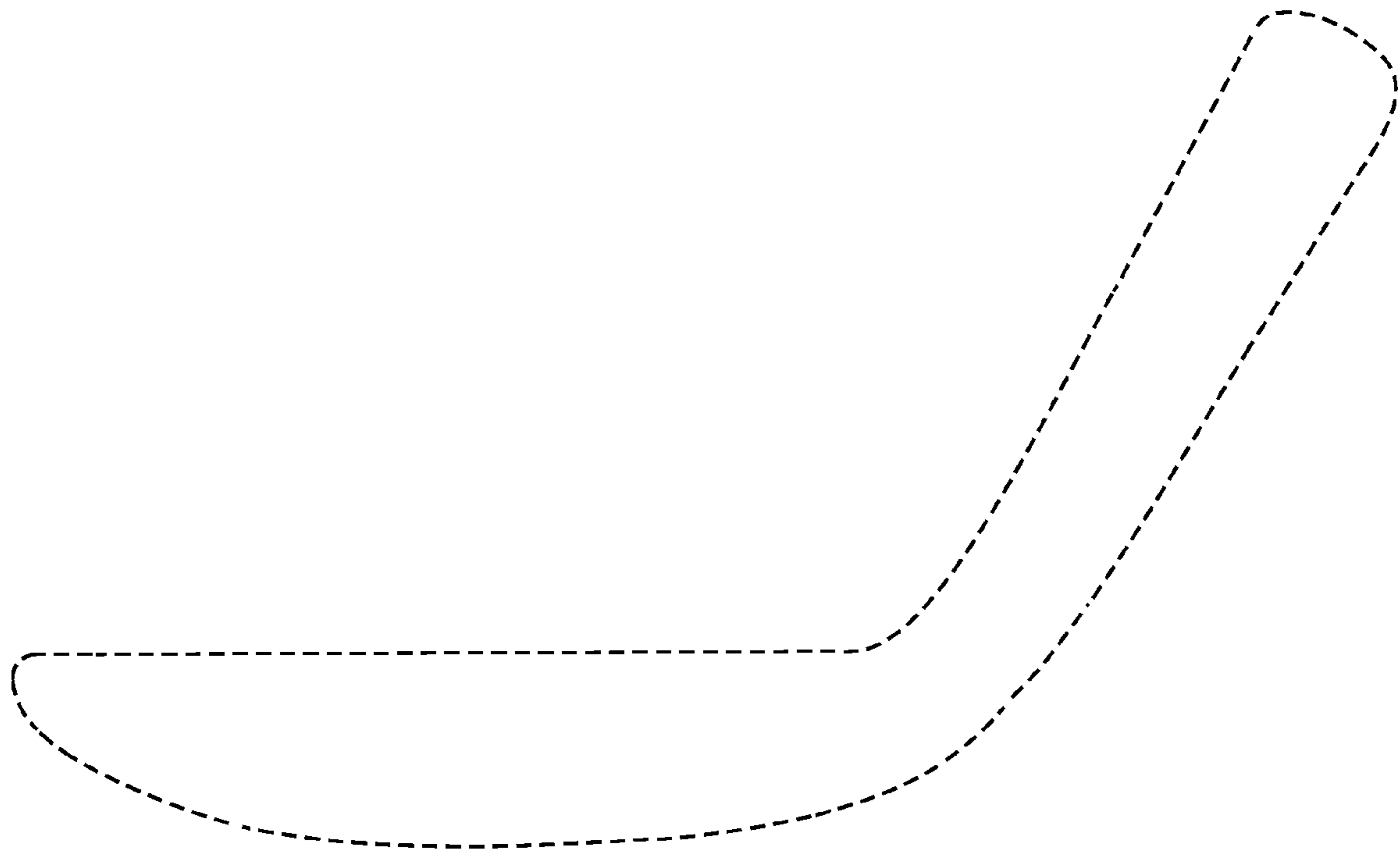

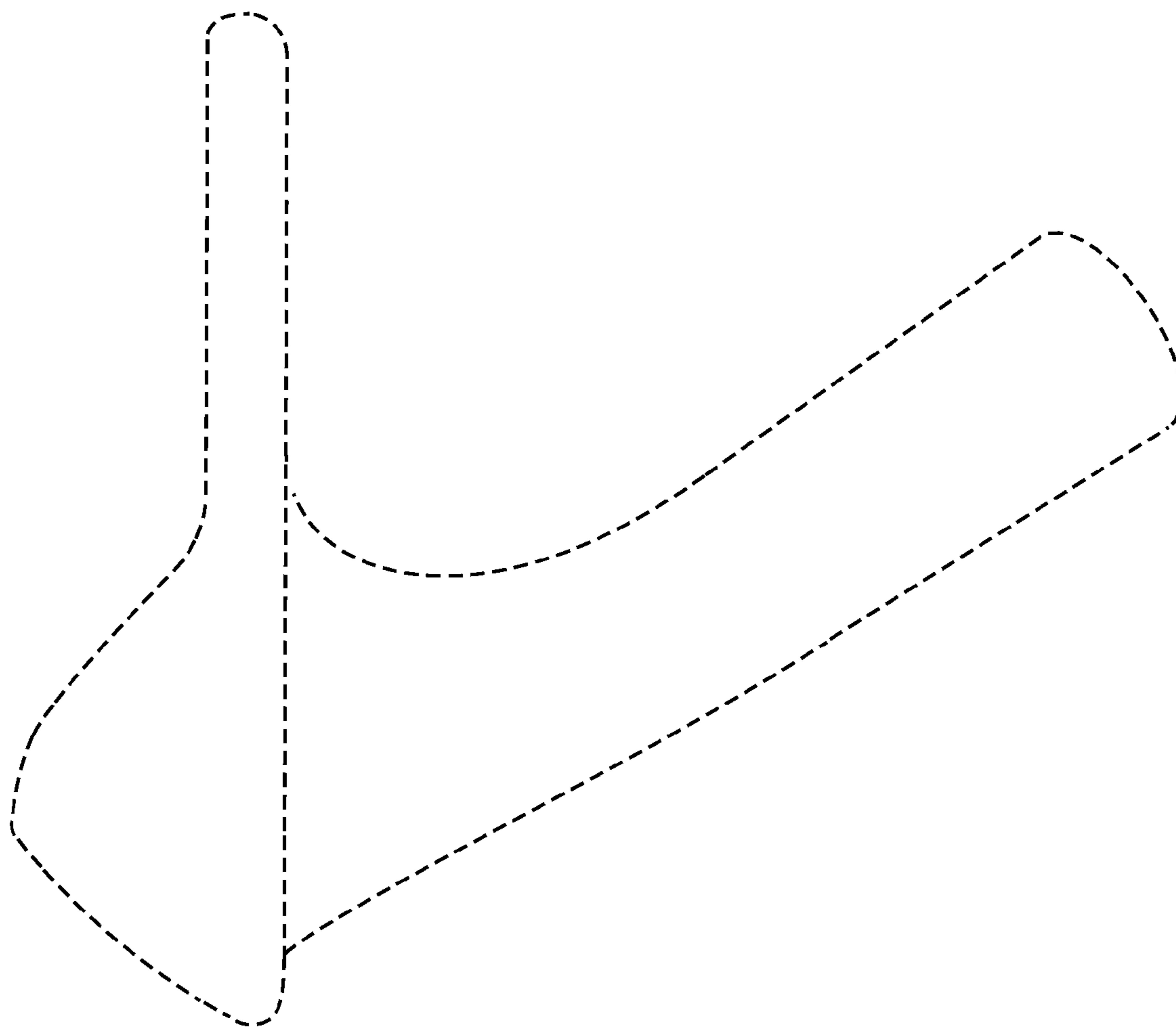

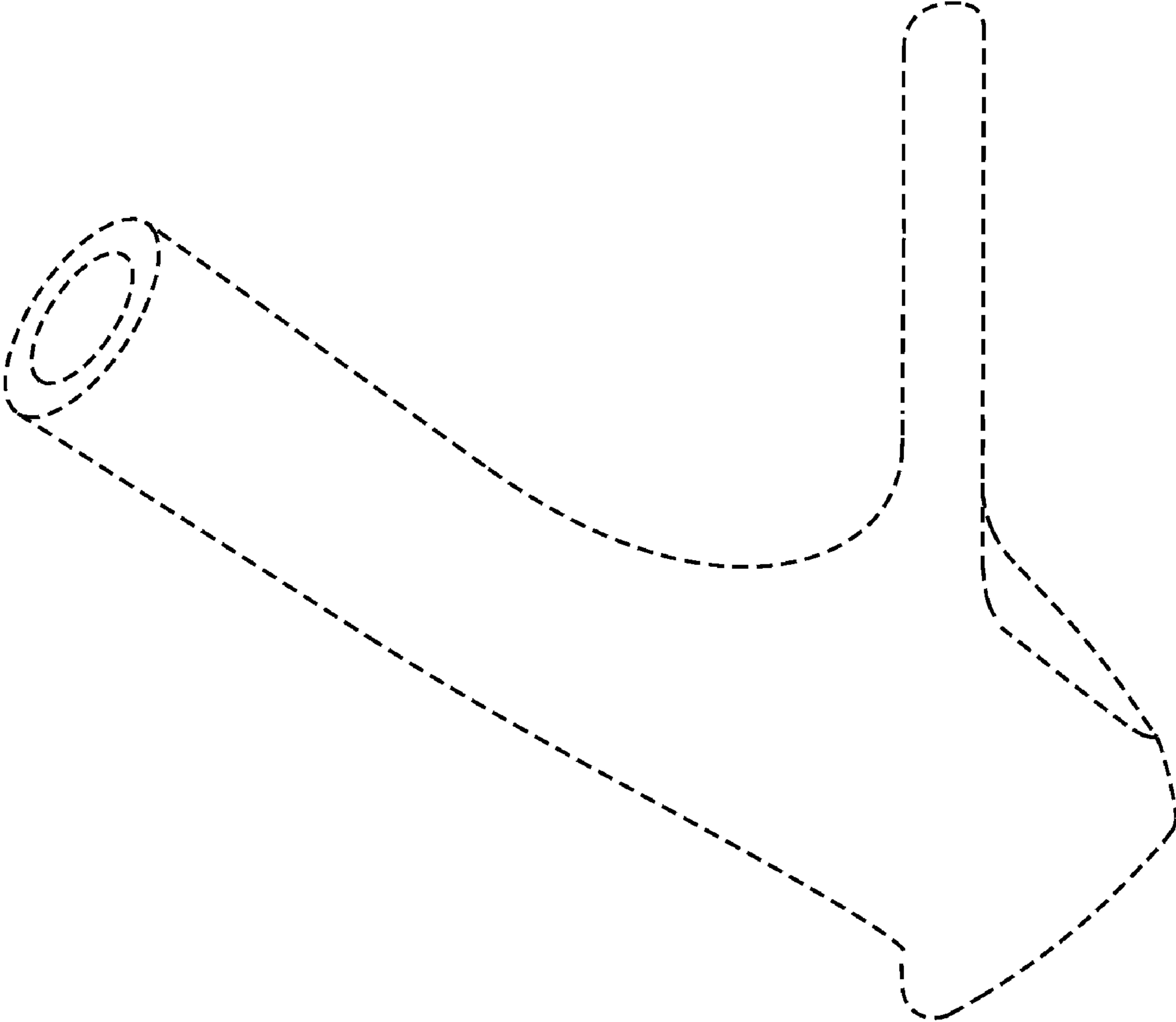

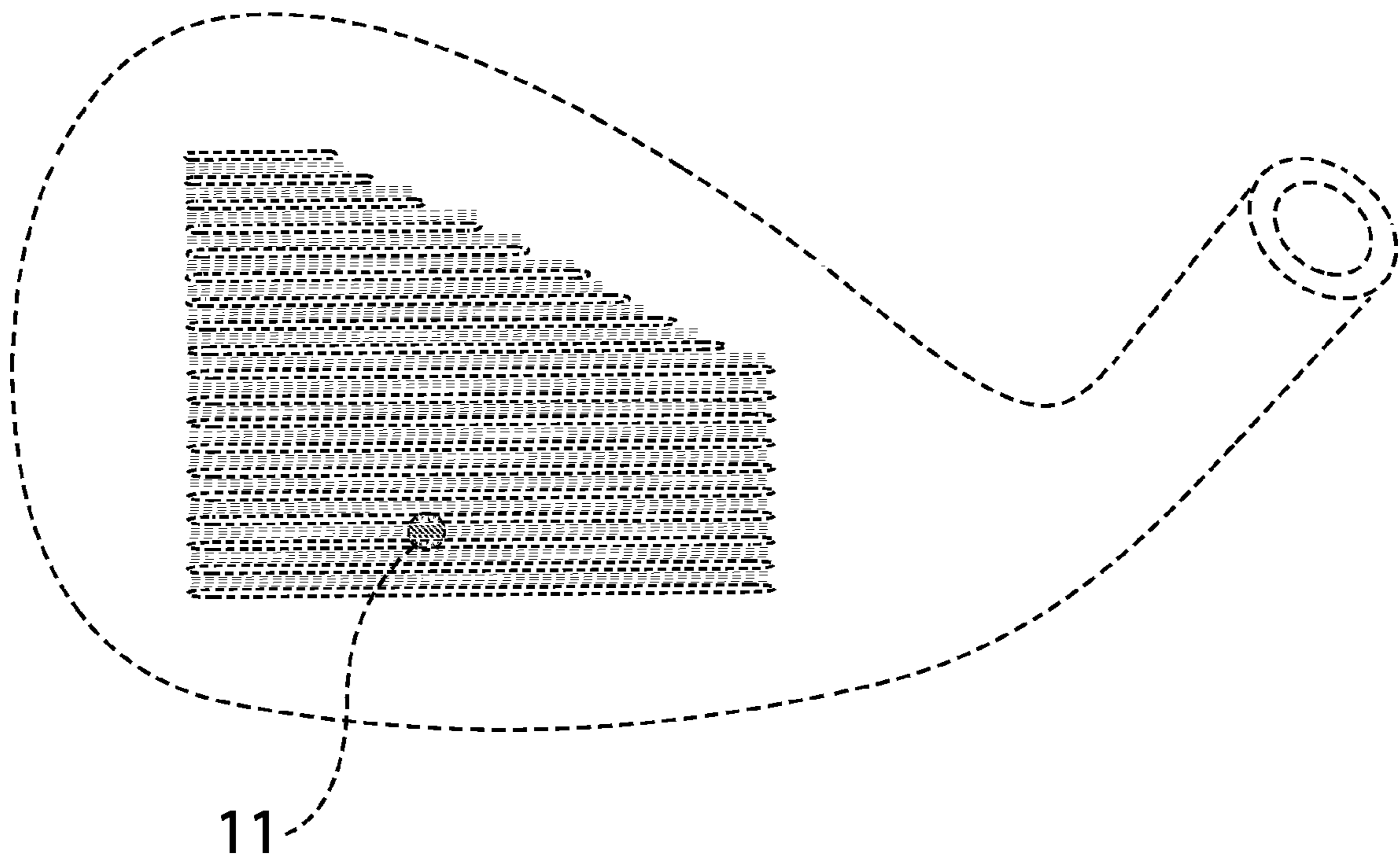

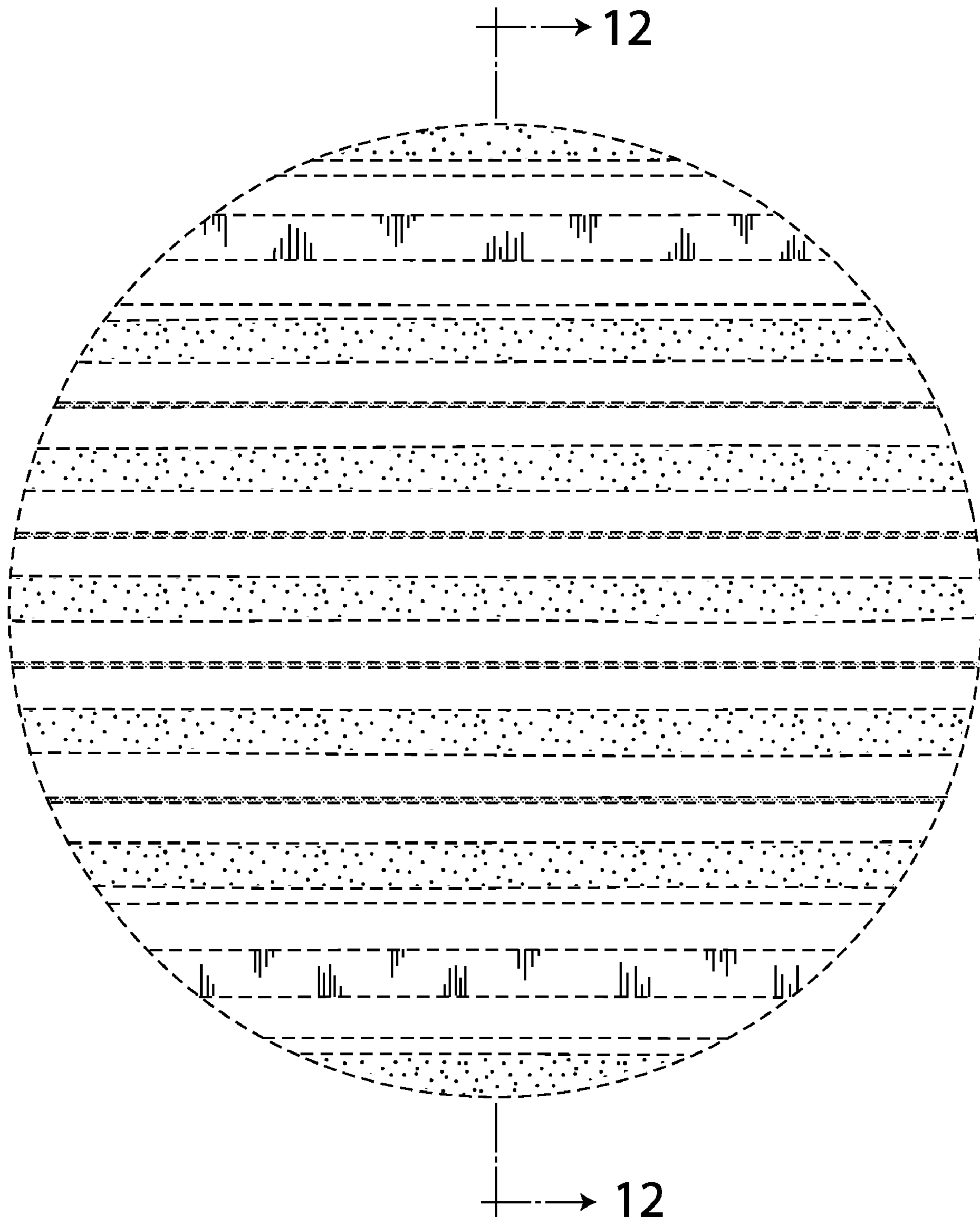

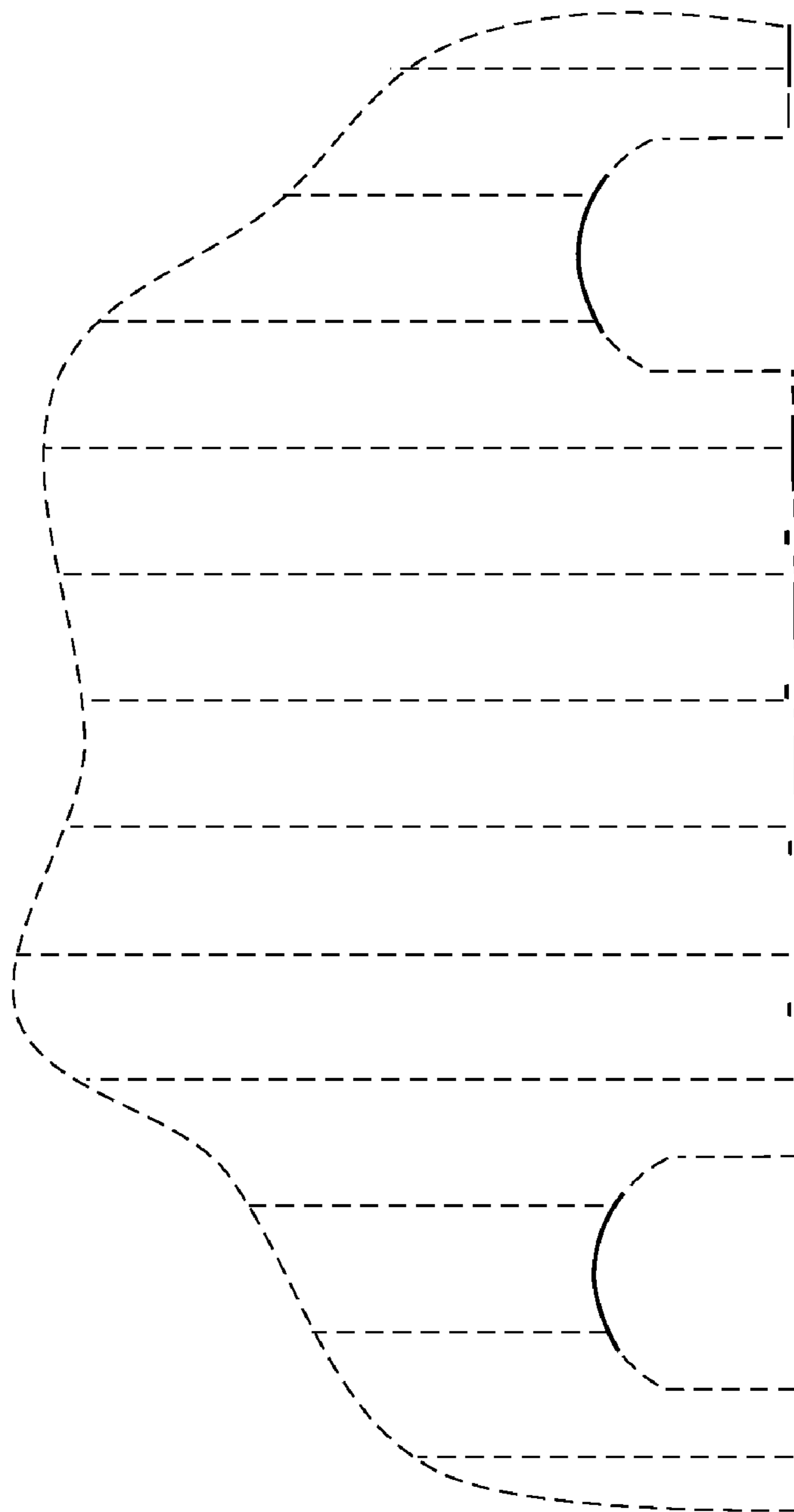

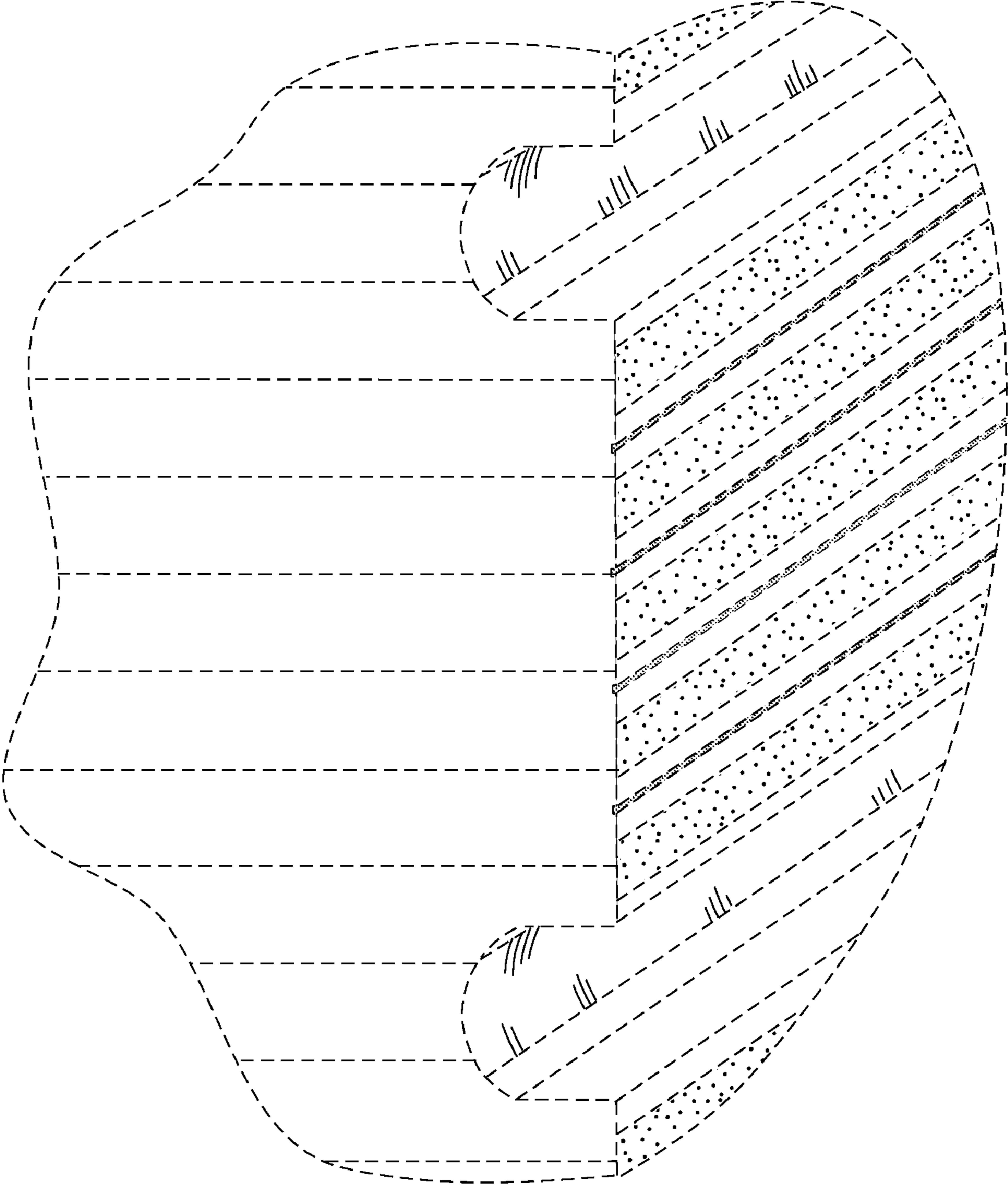

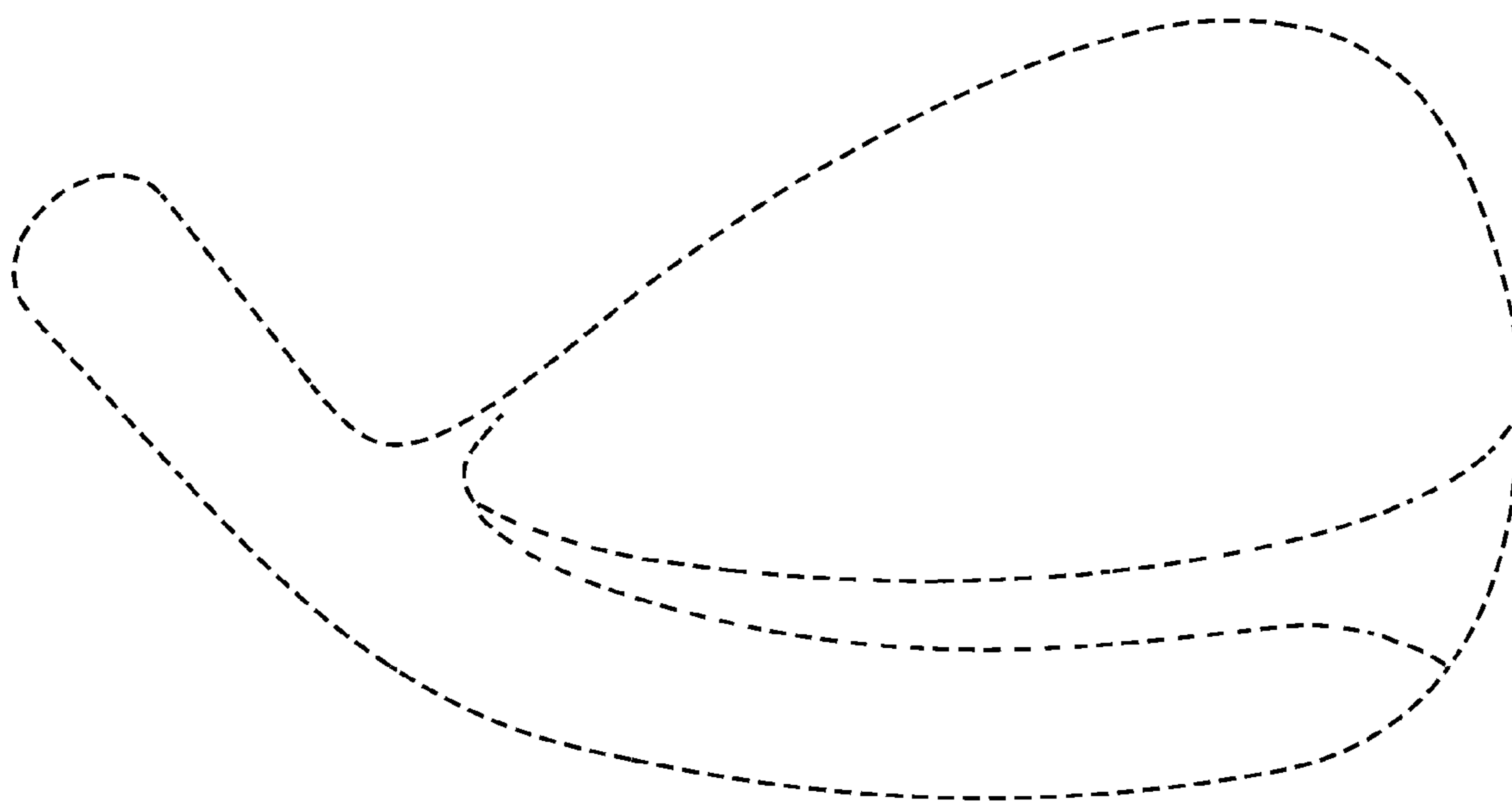

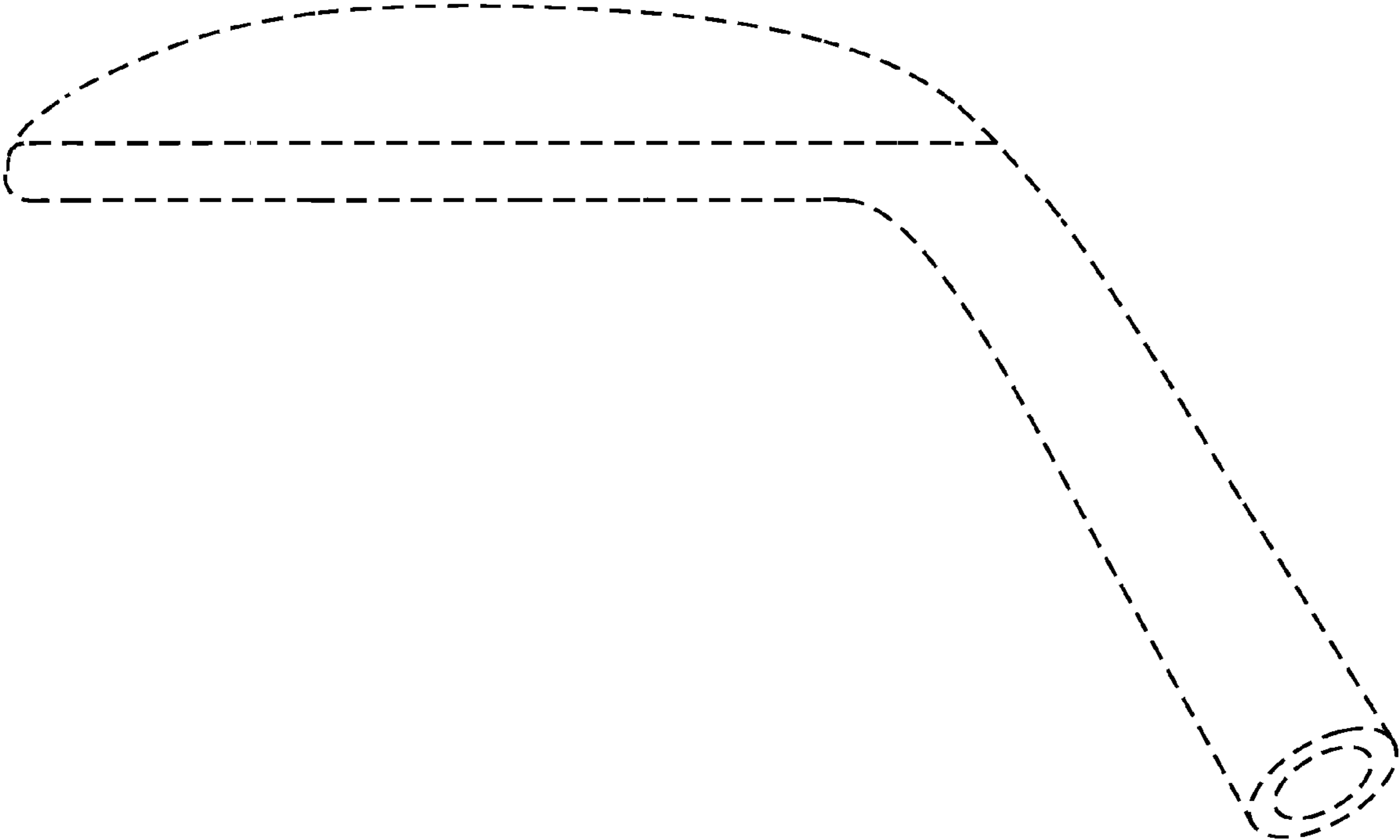

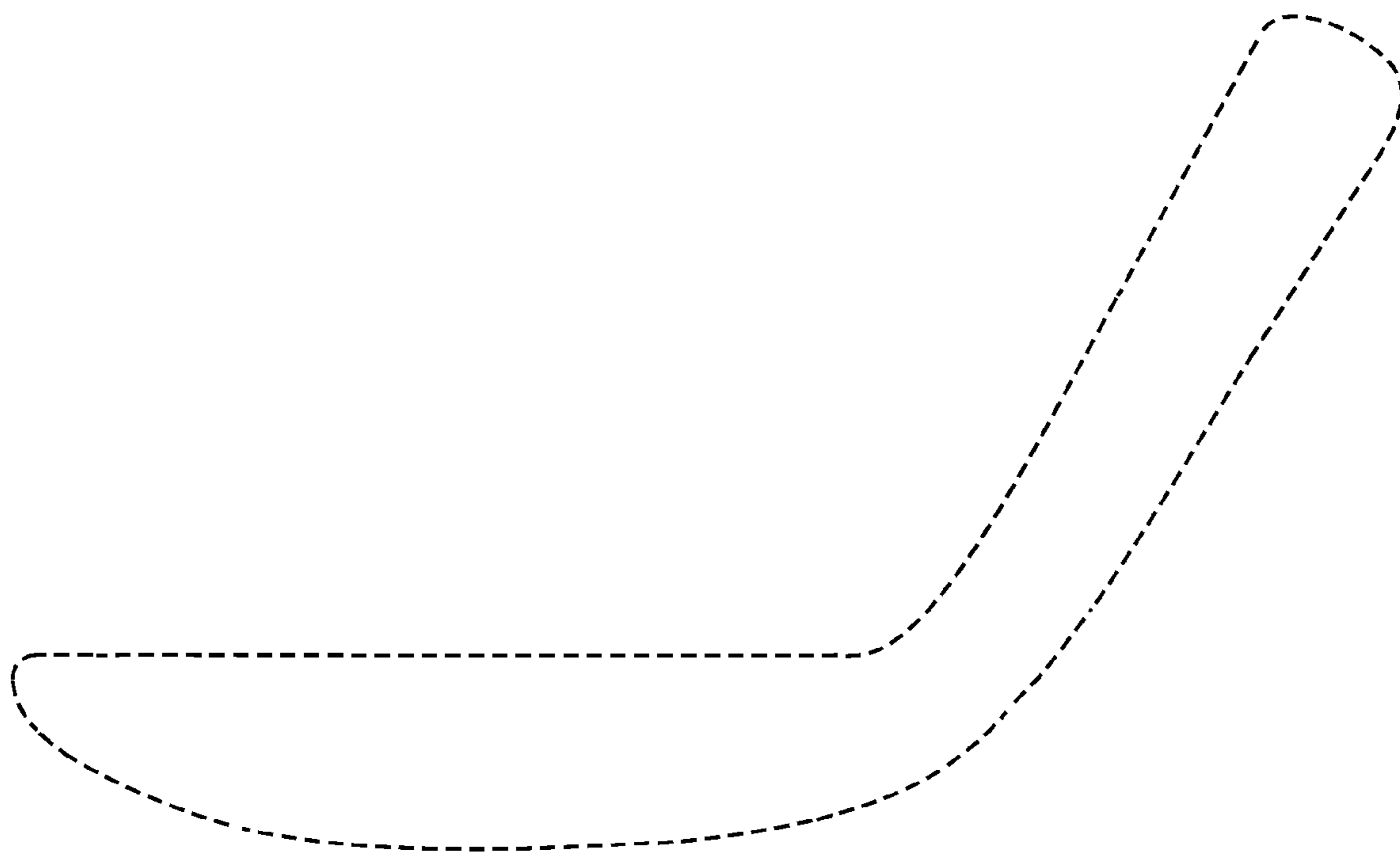

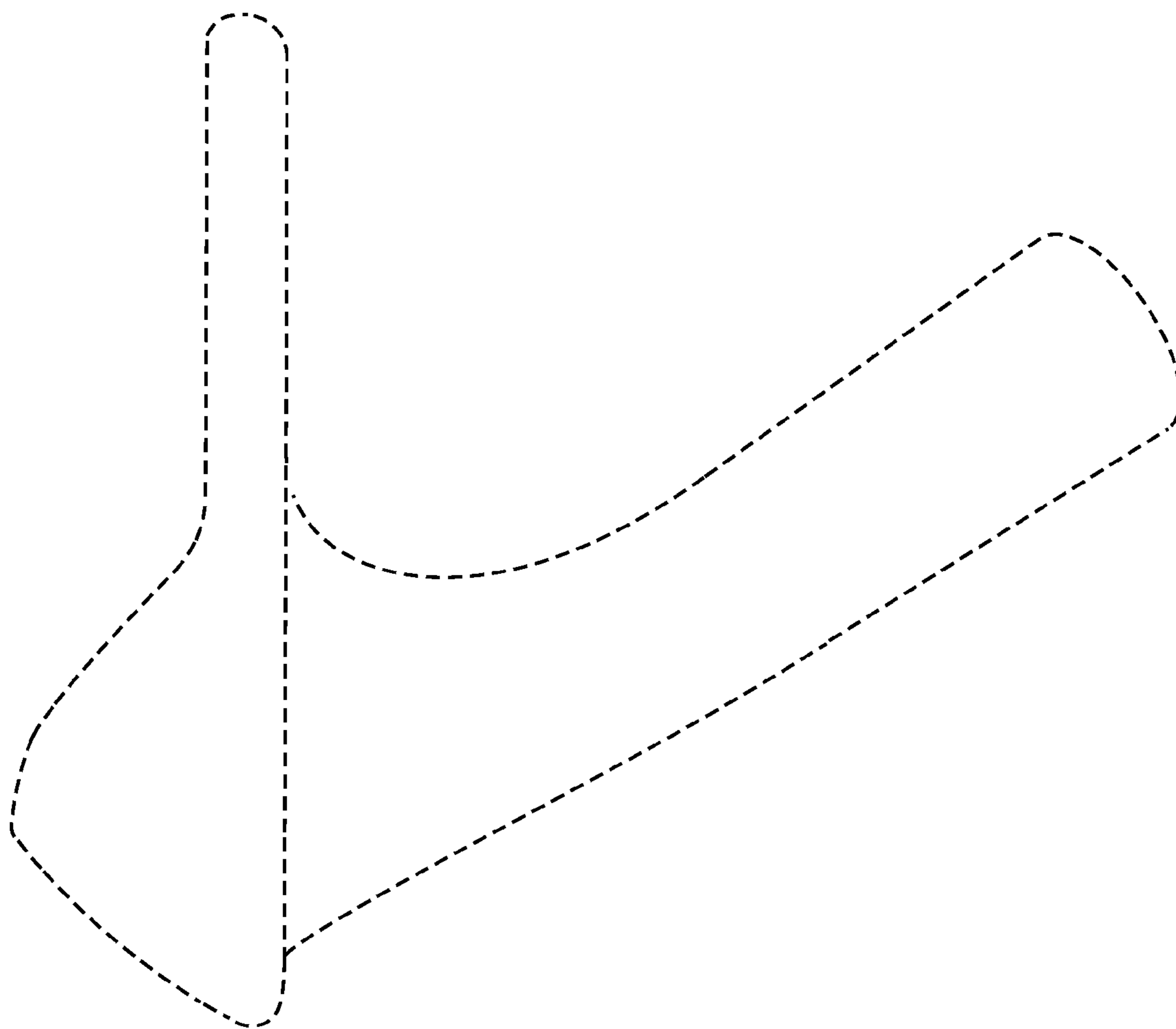

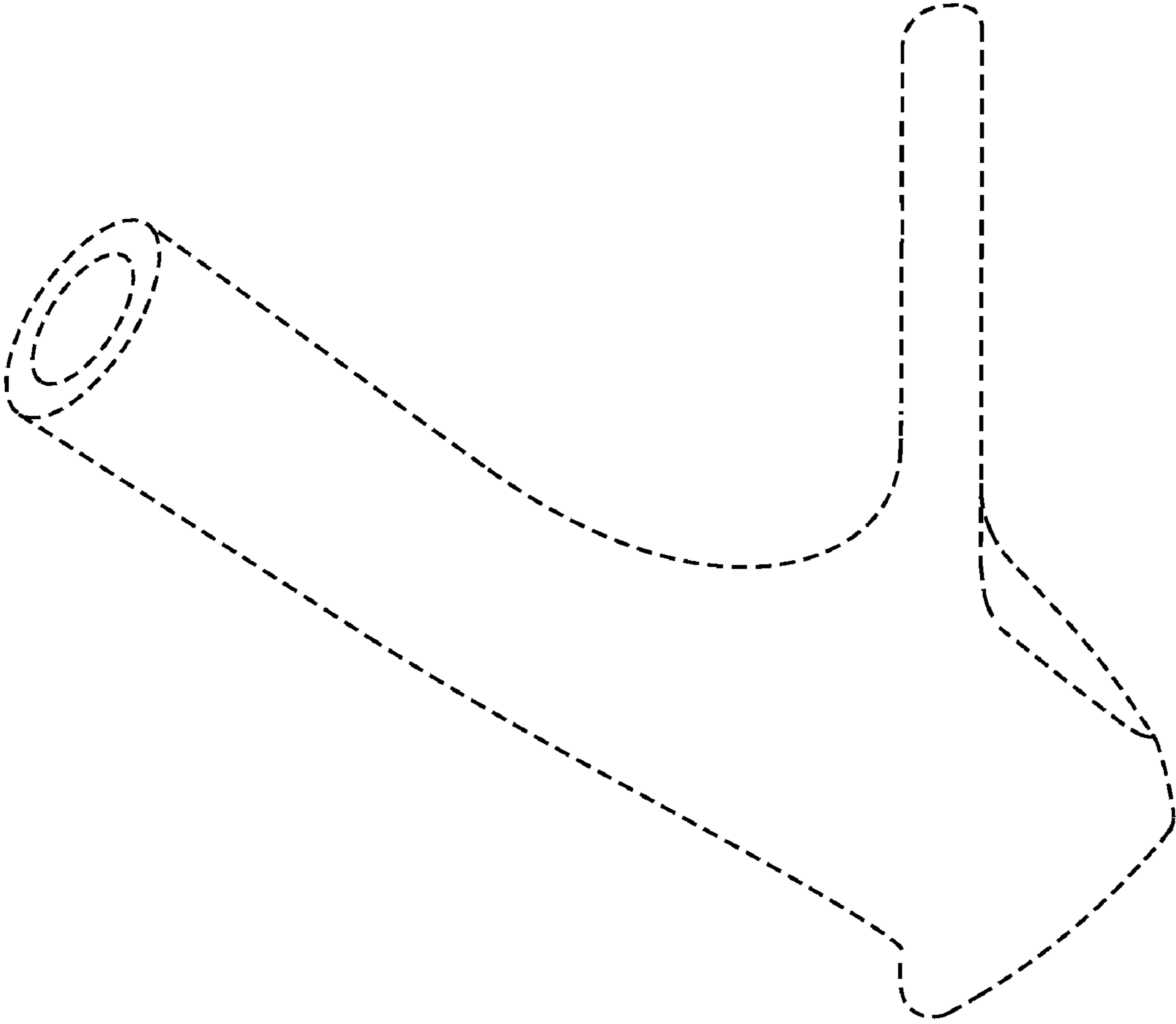

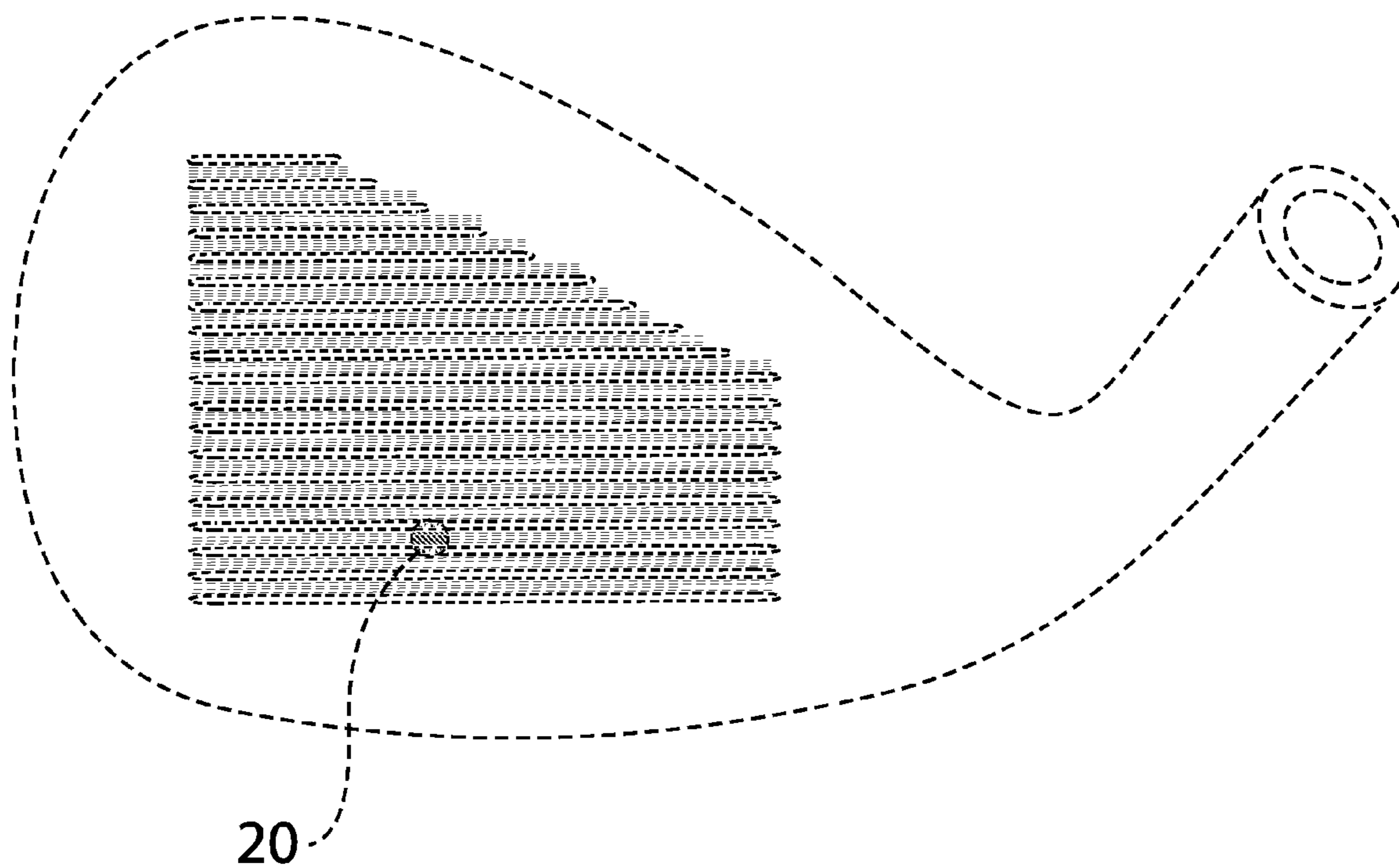

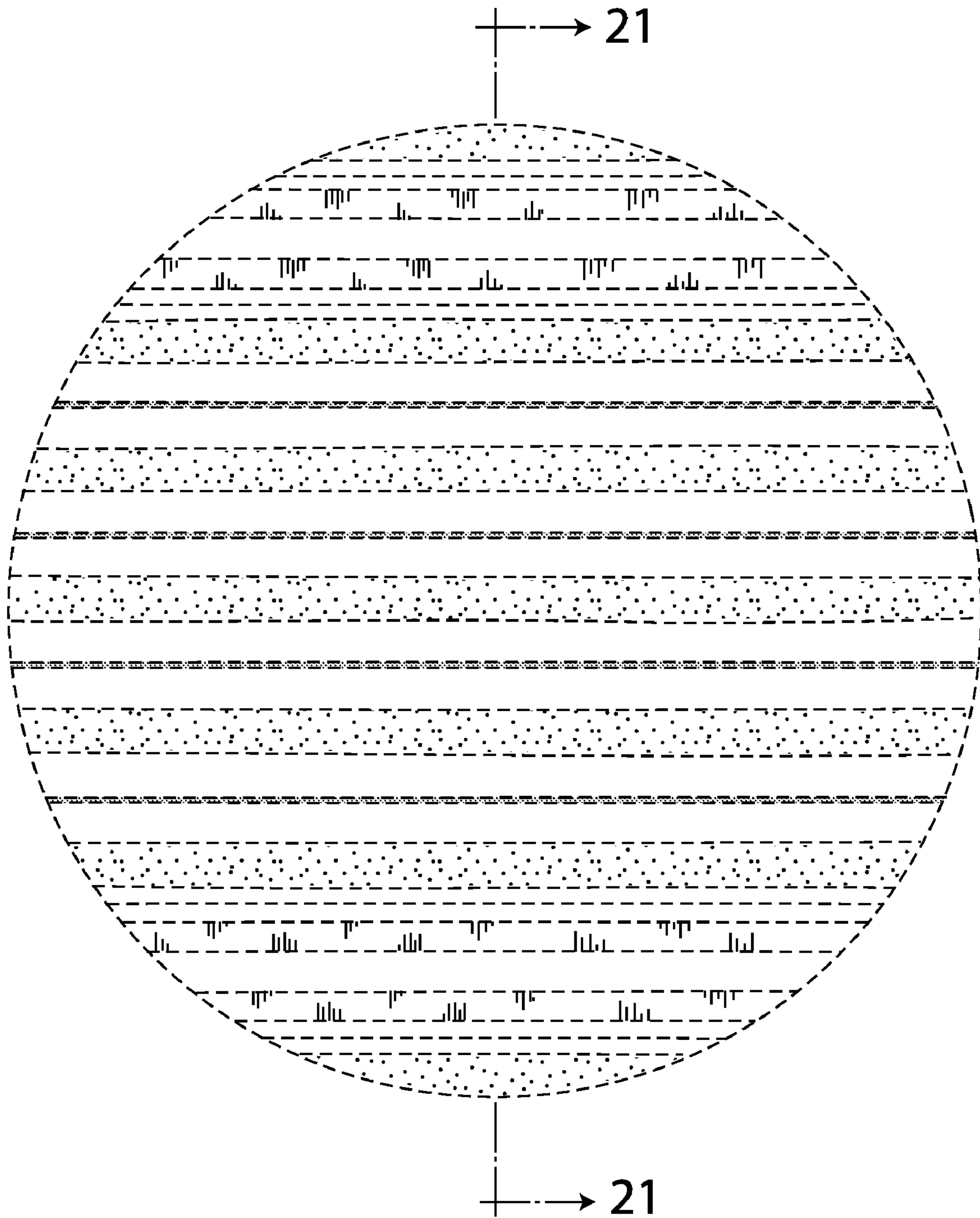

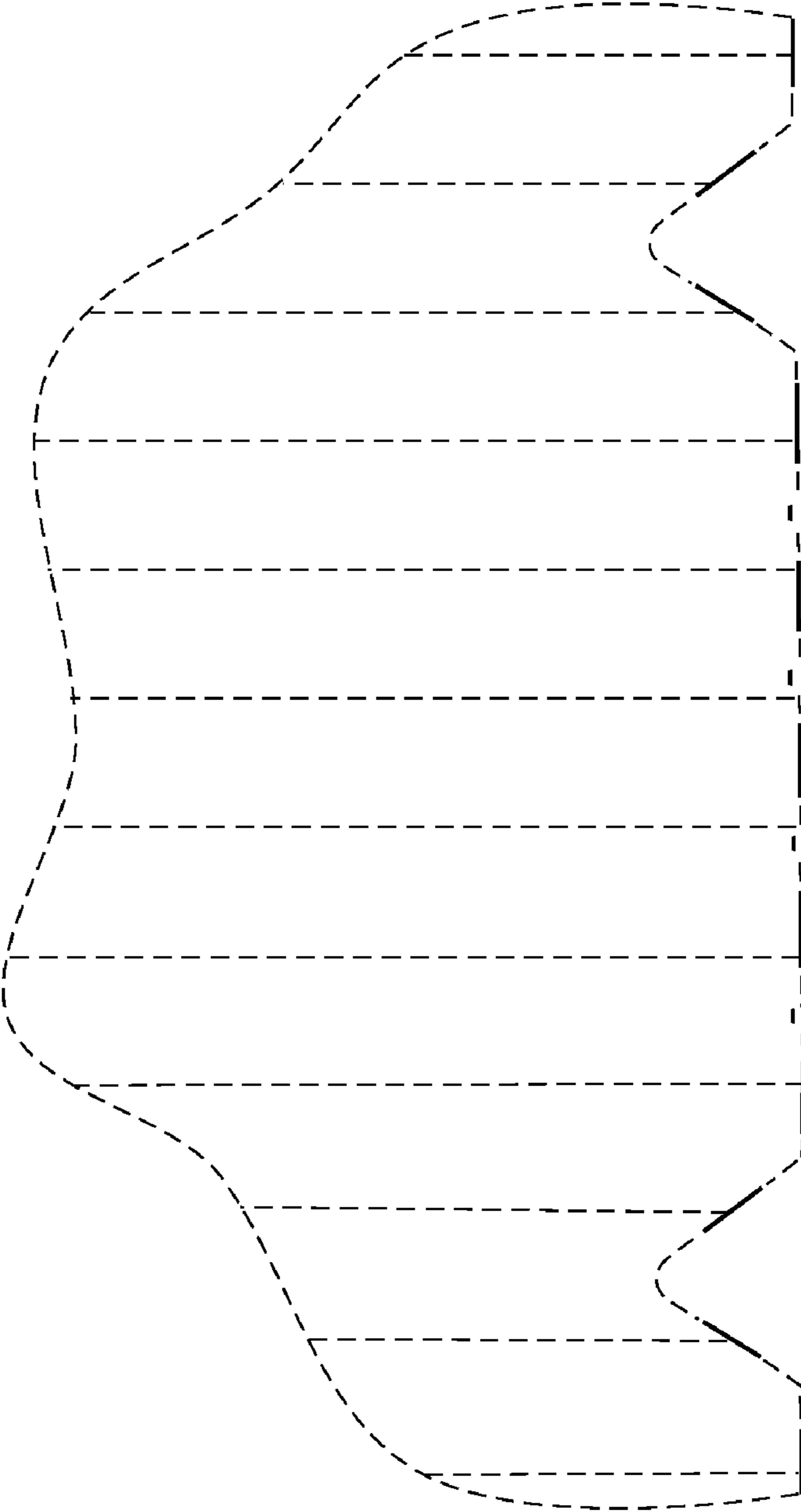

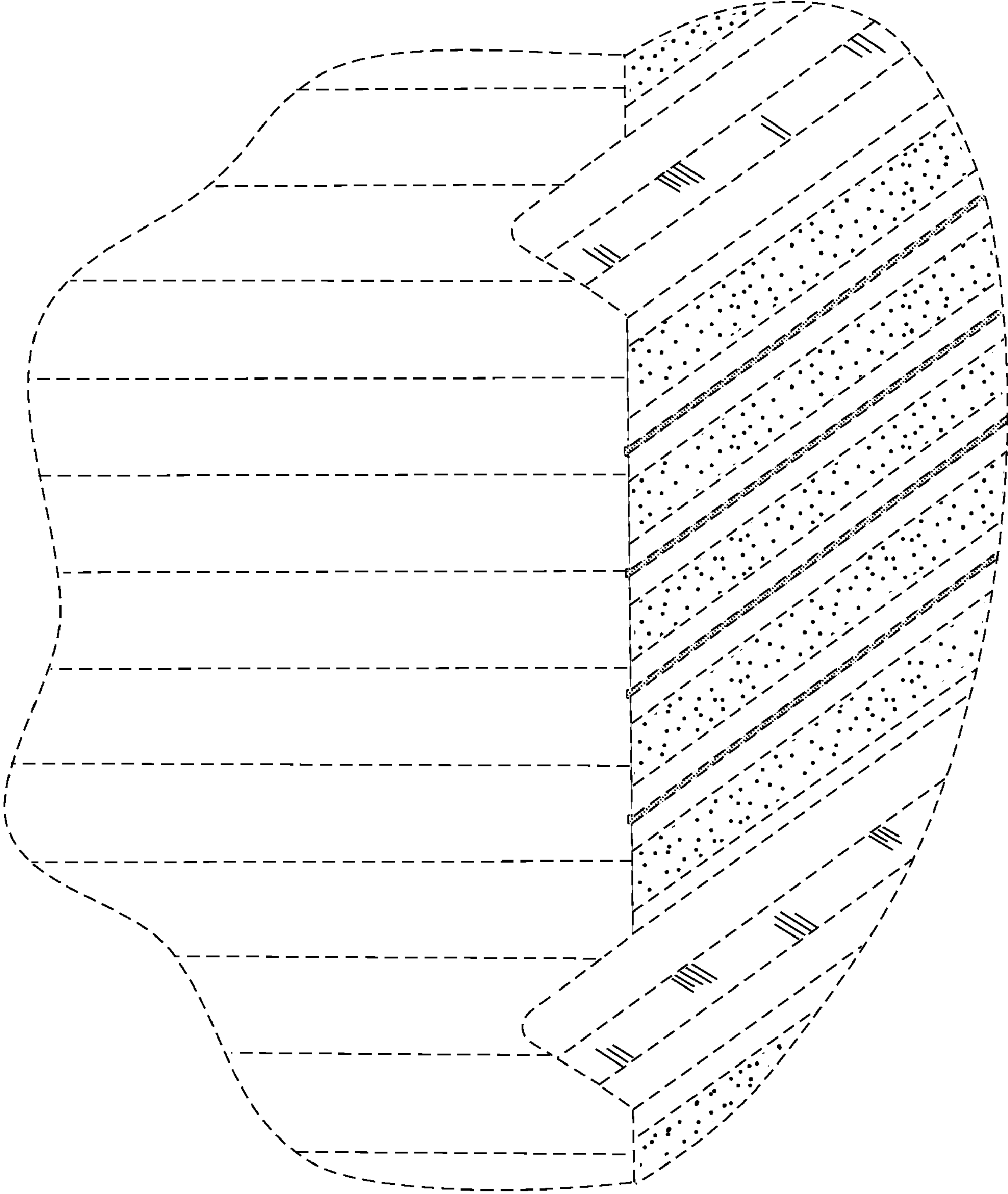

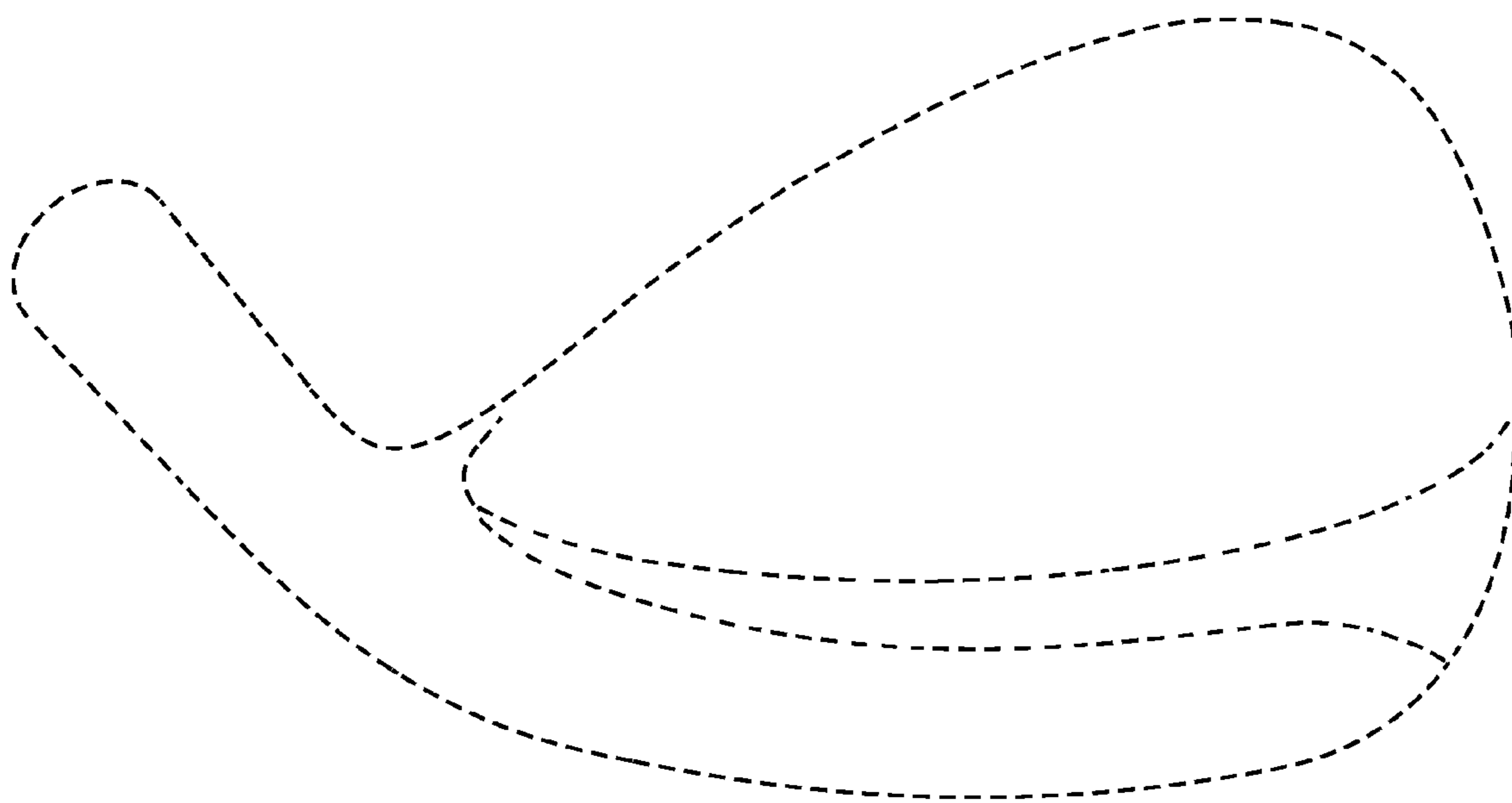

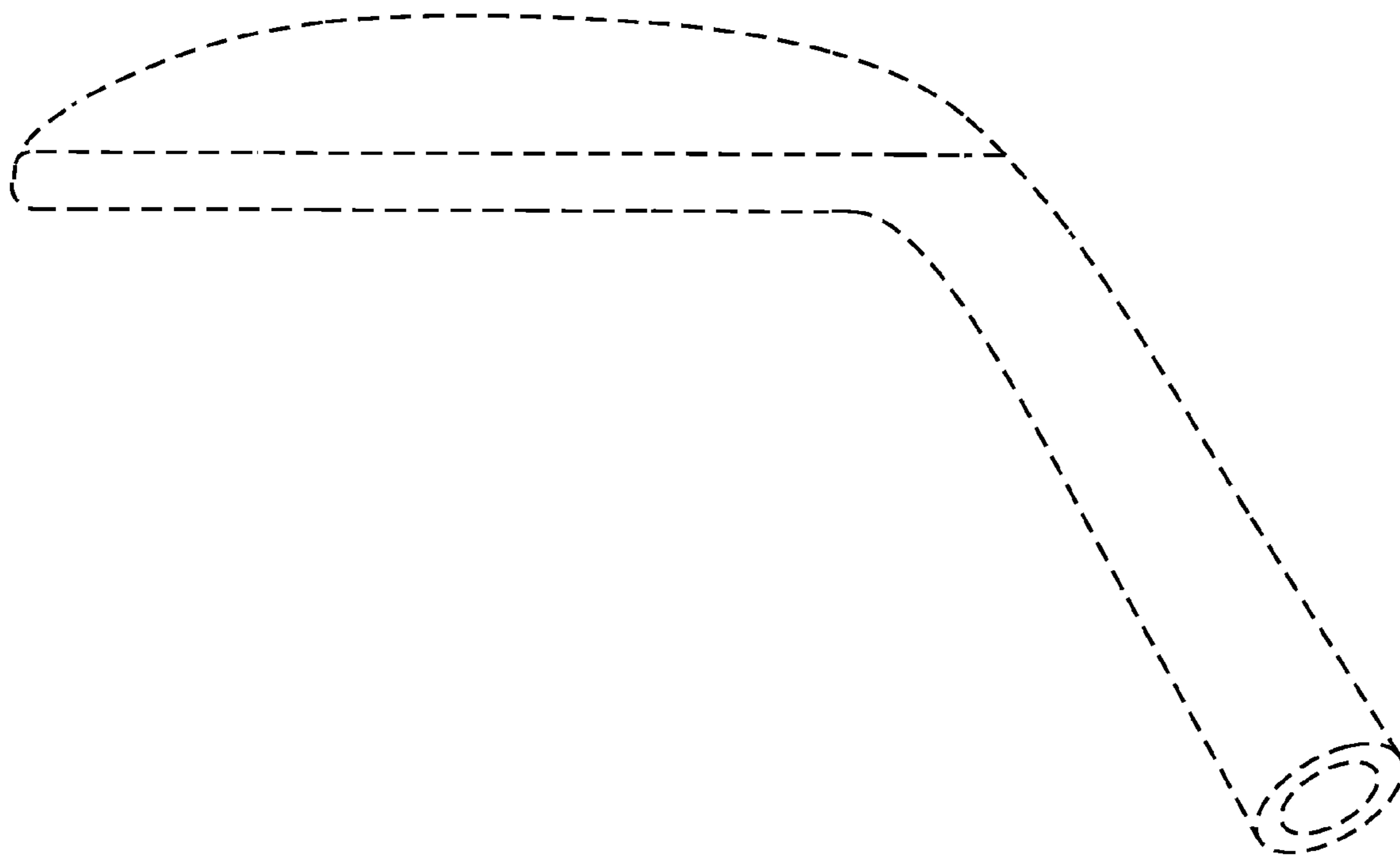

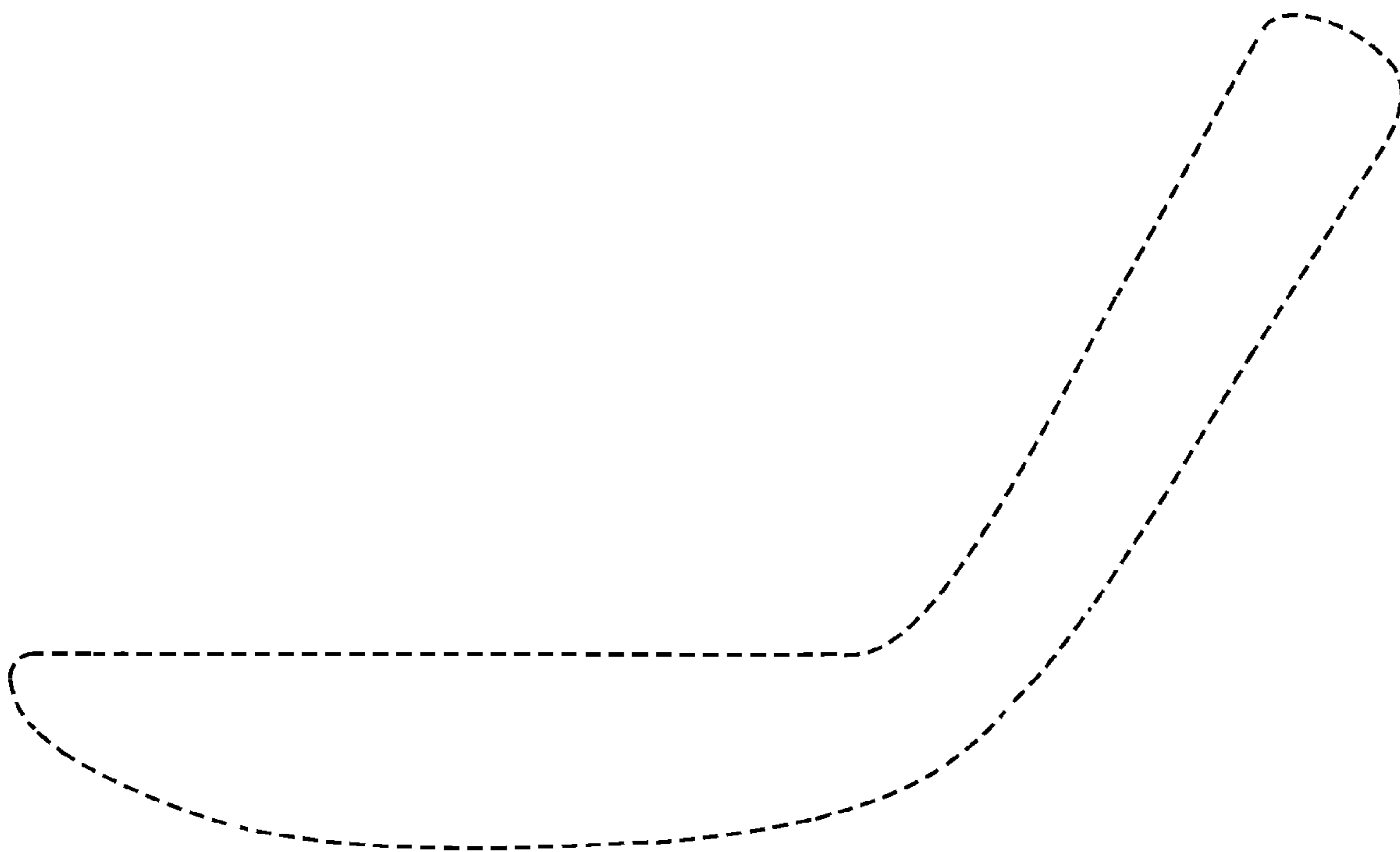

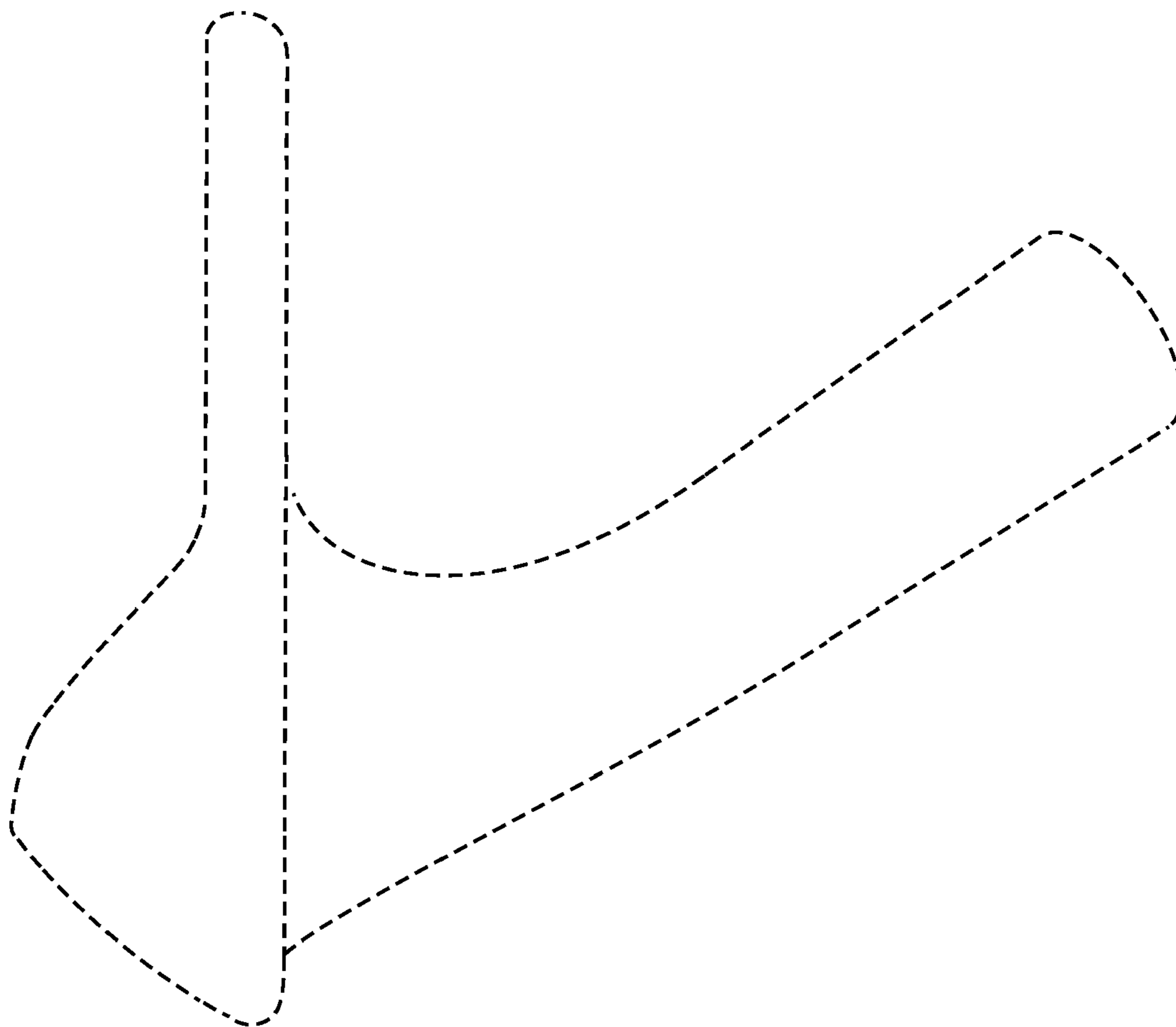

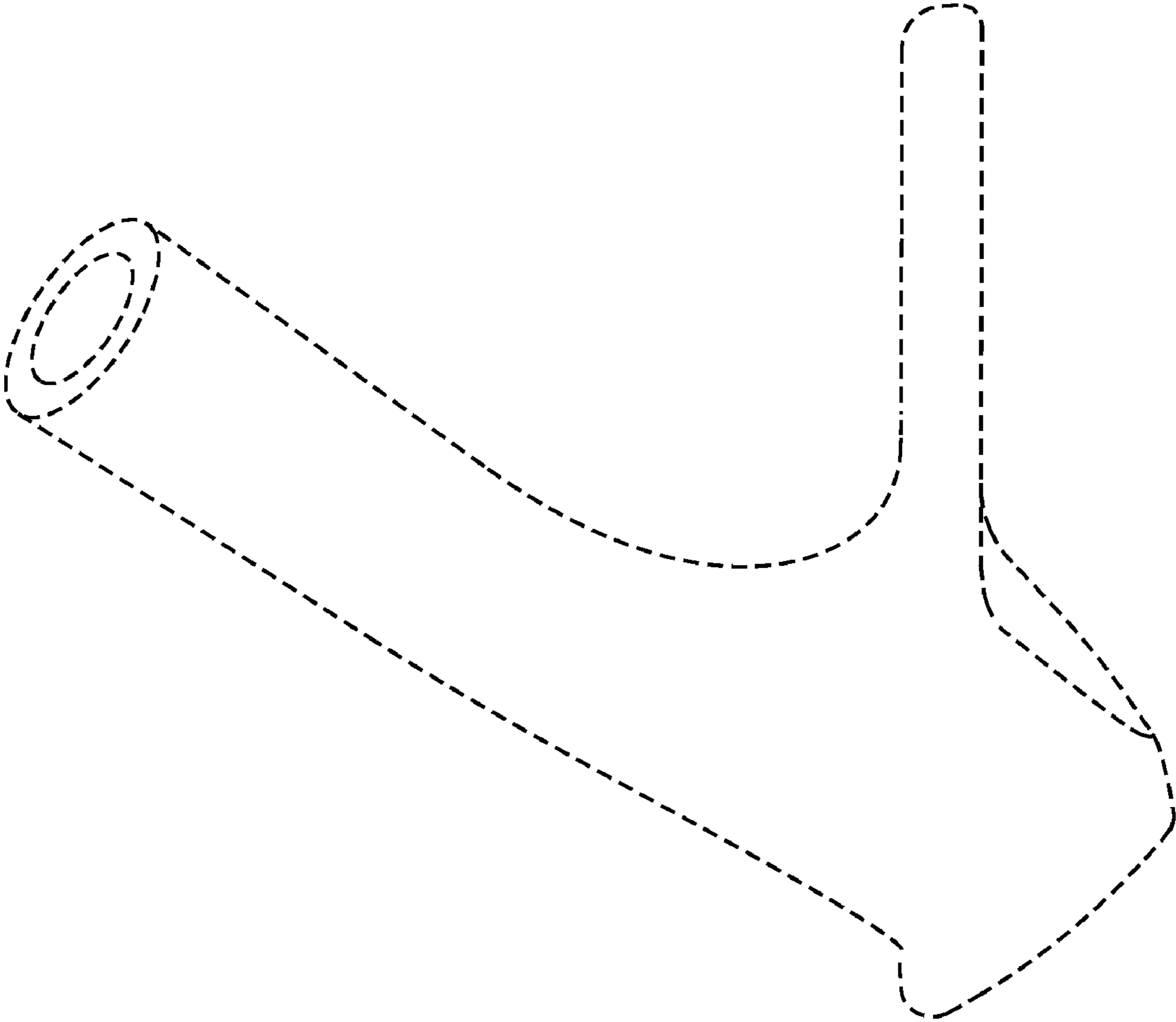
