FIG. 7 is a bottom view thereof;

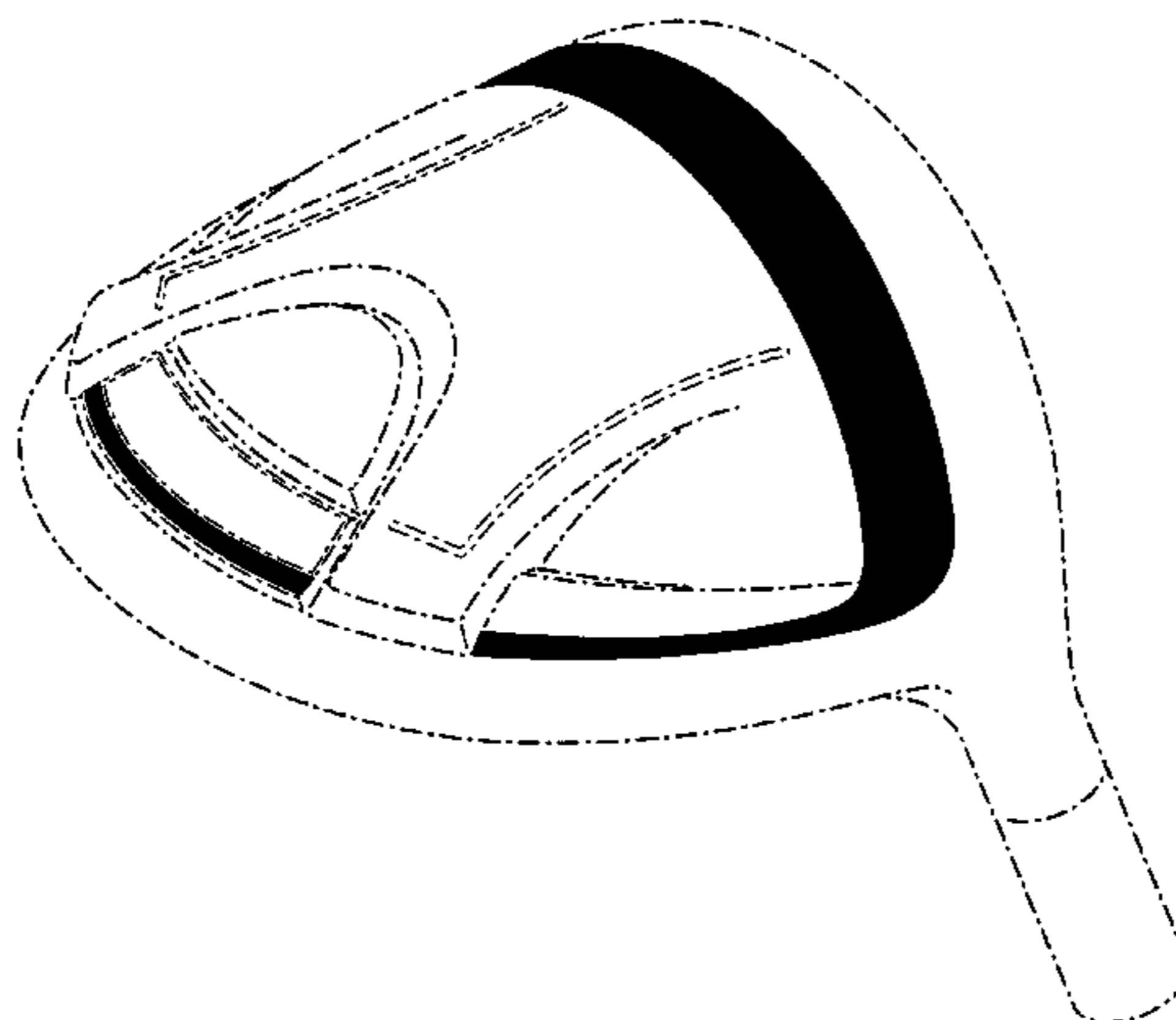
FIG. 8 is a rear view thereof;

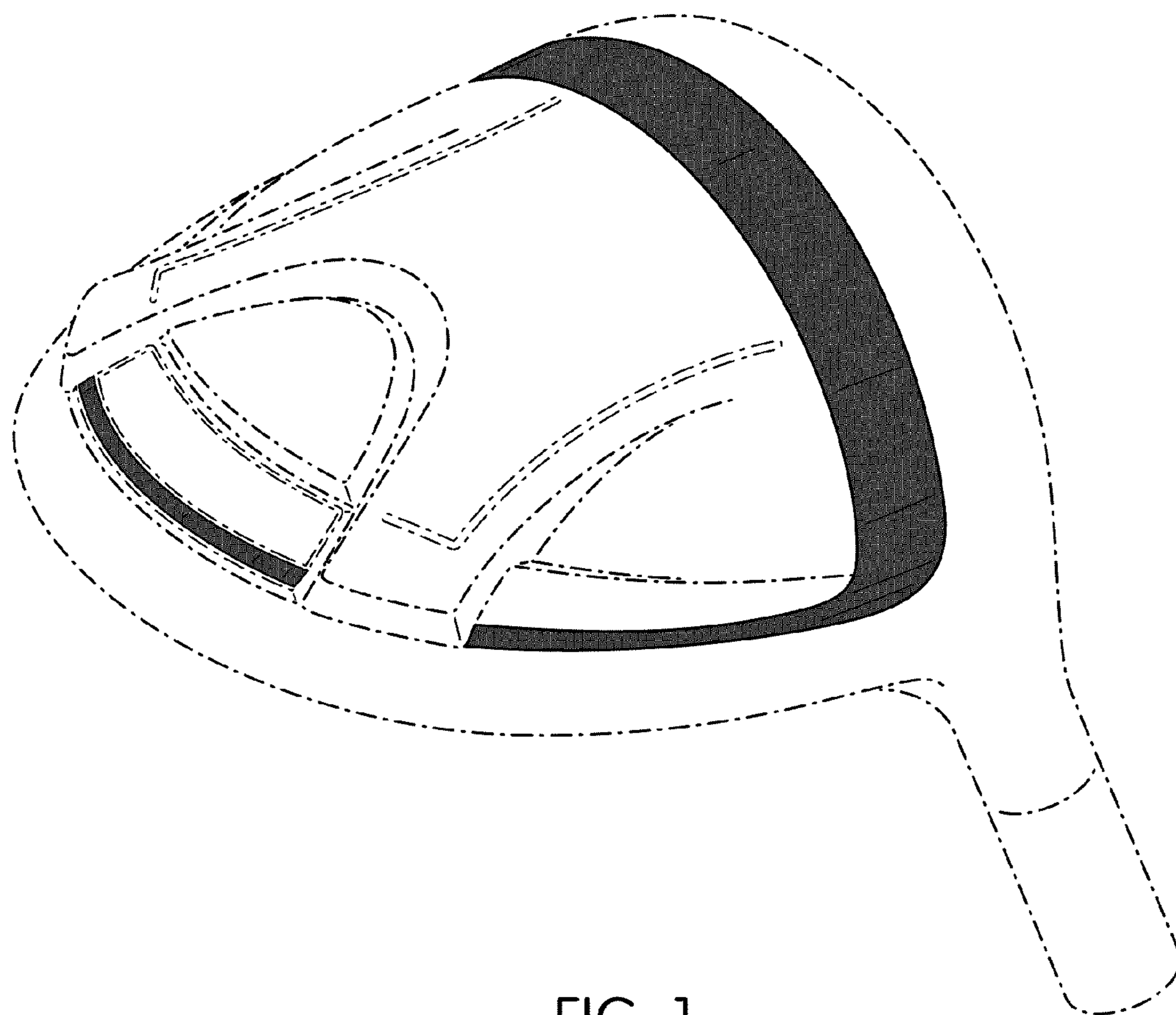

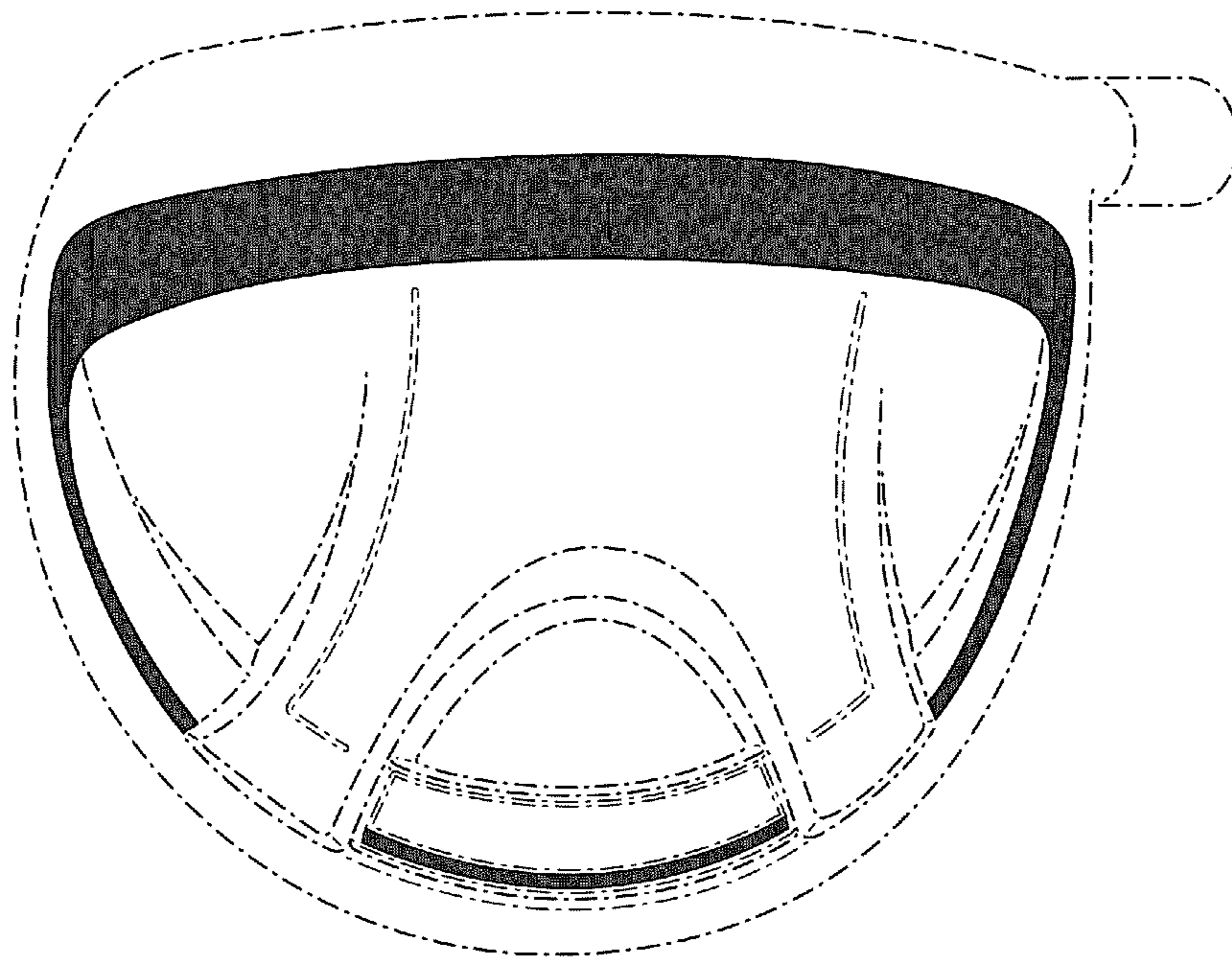

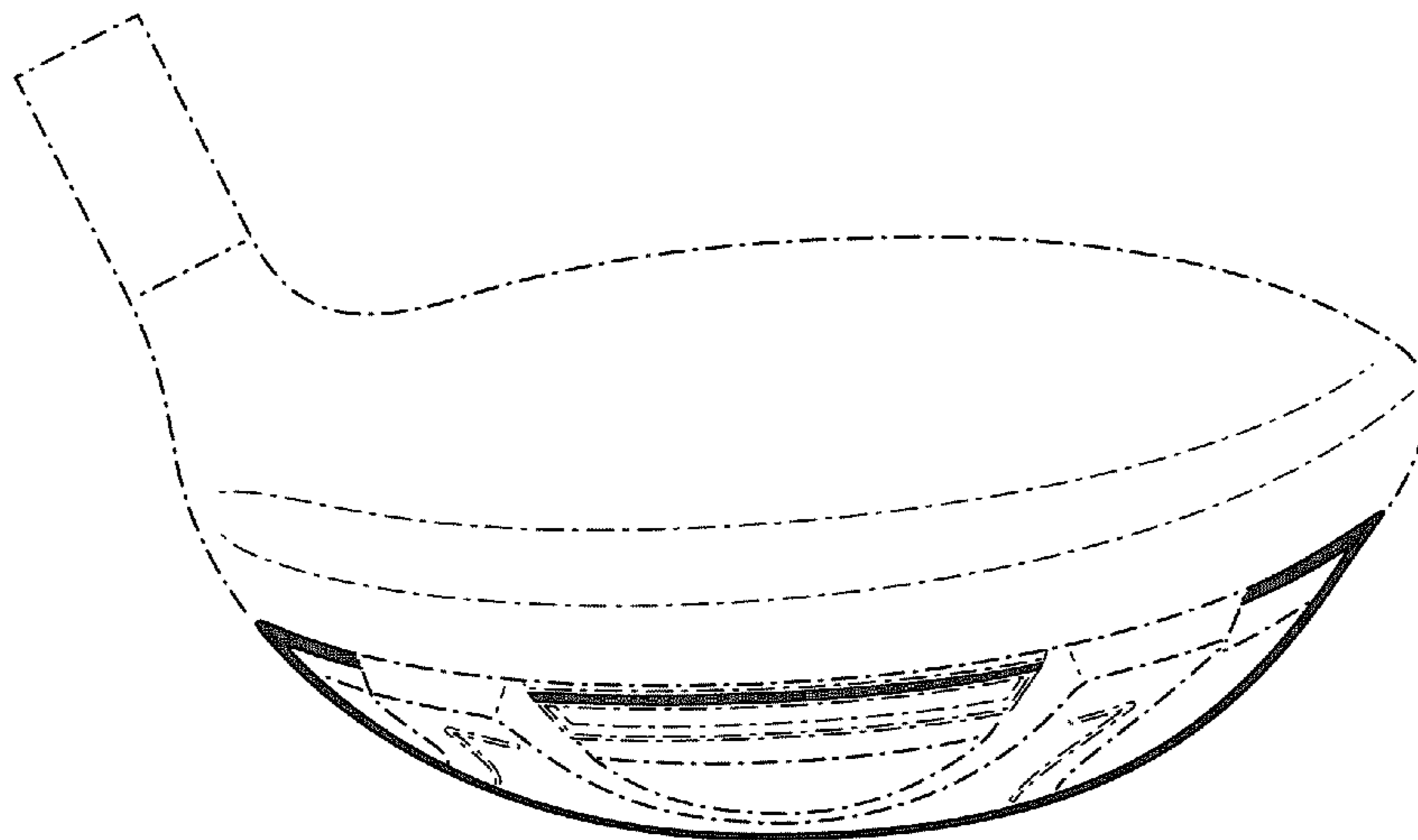

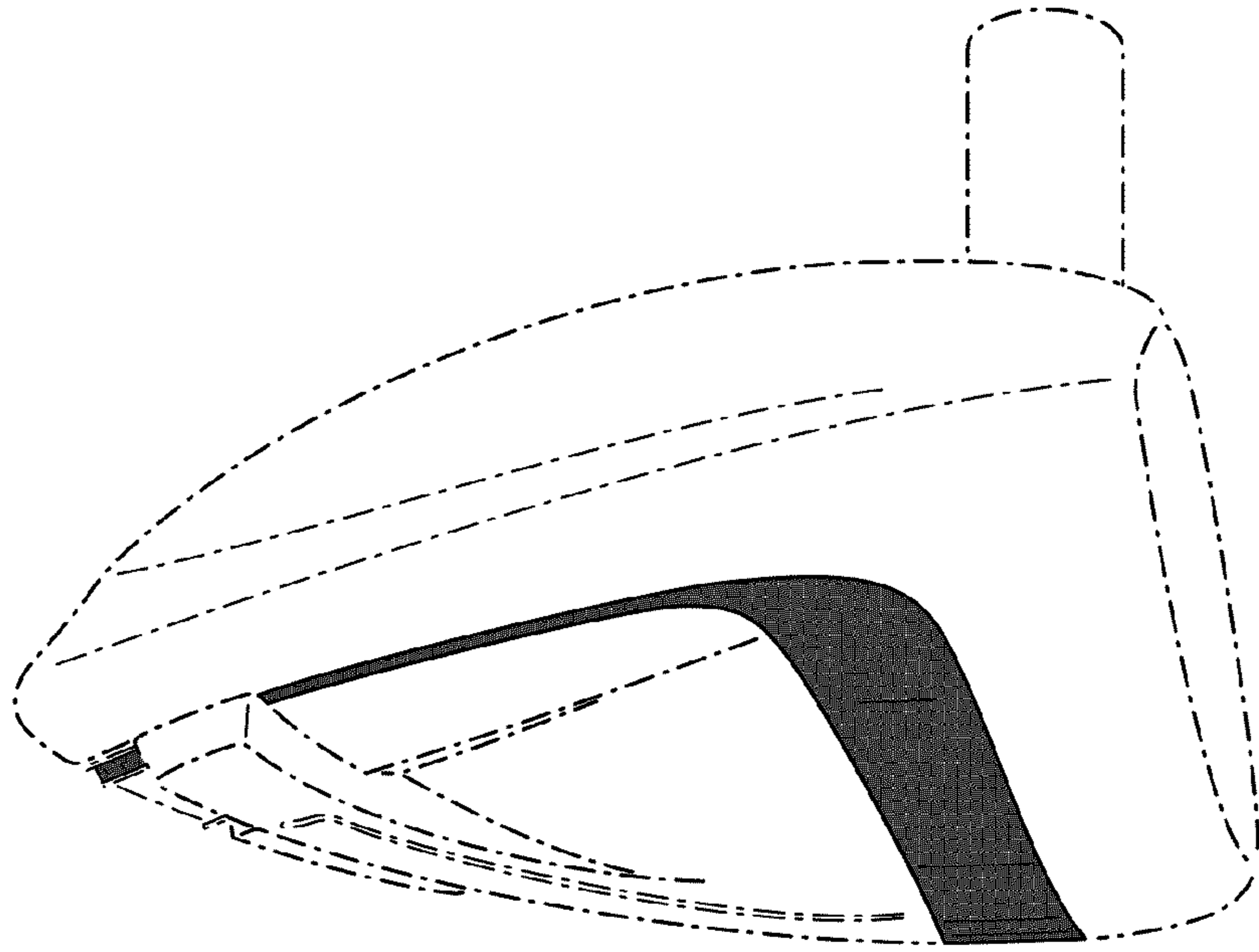

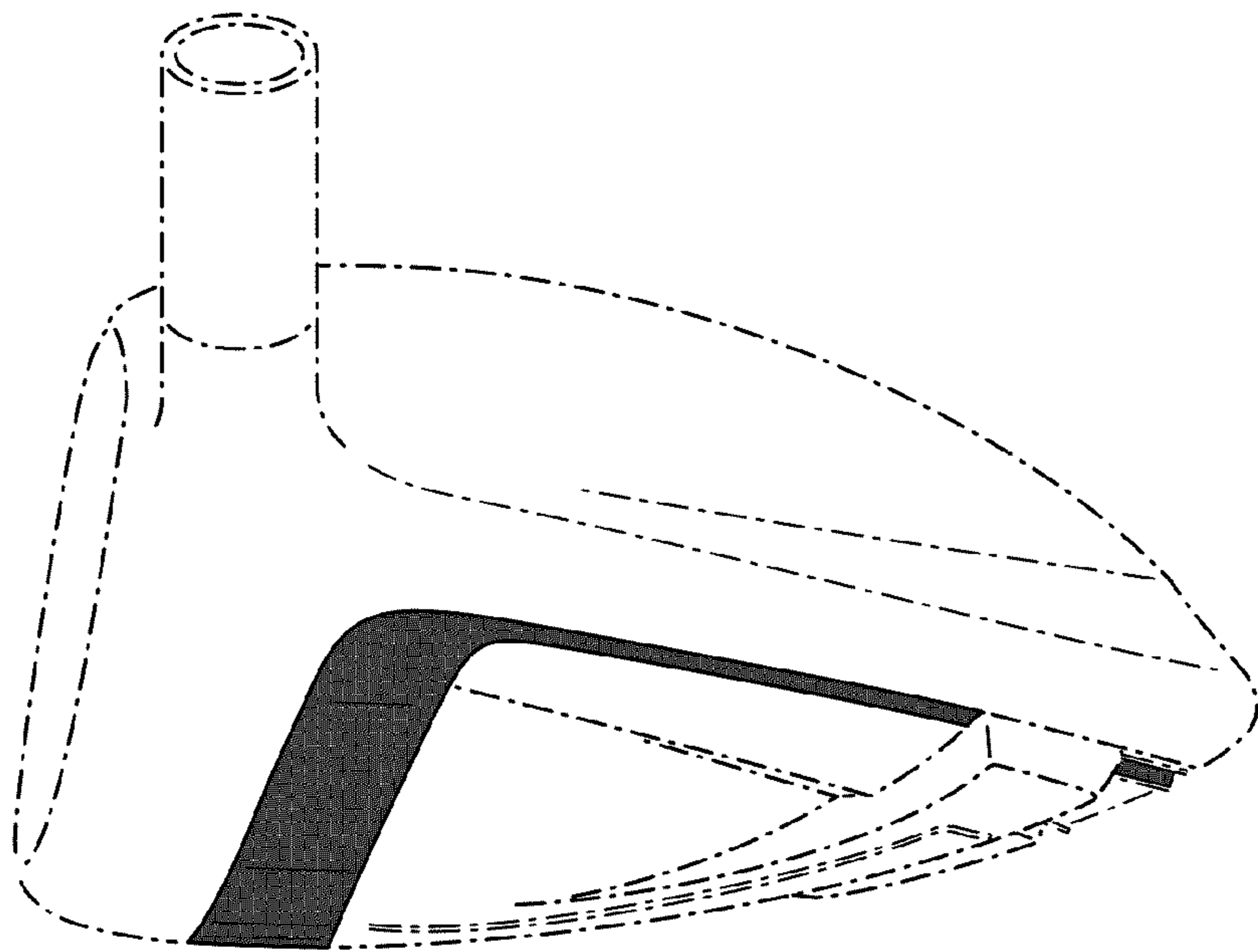

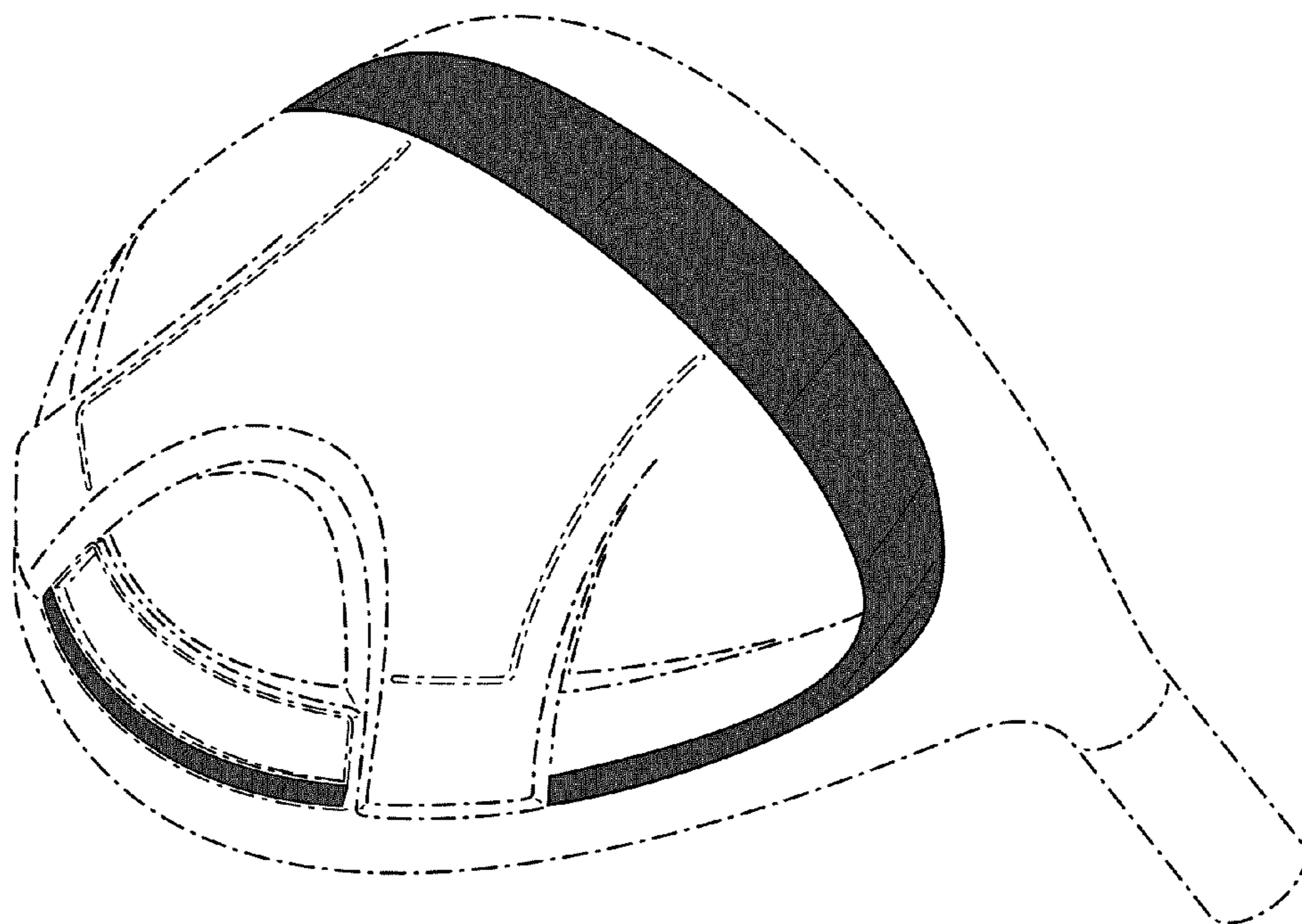

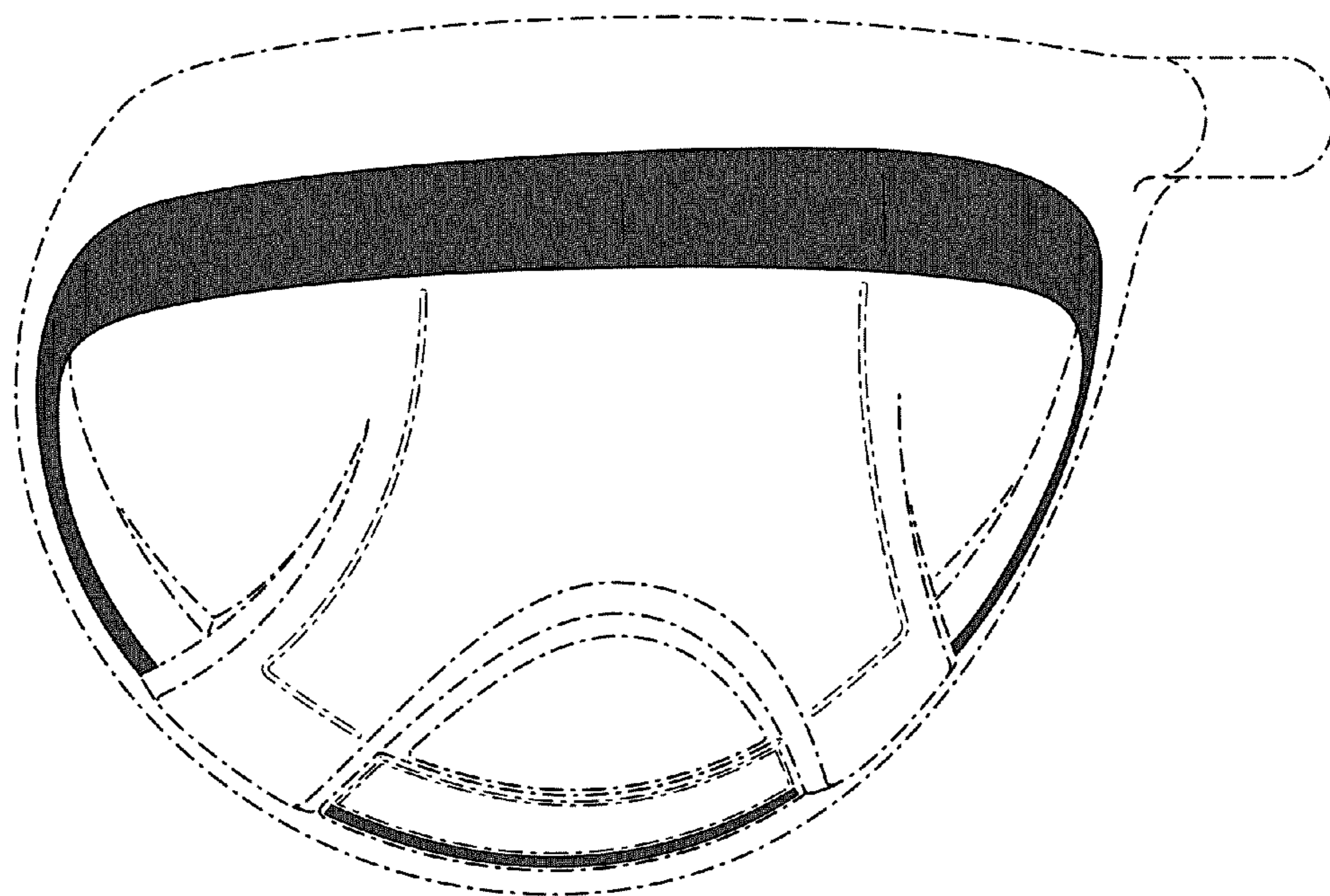

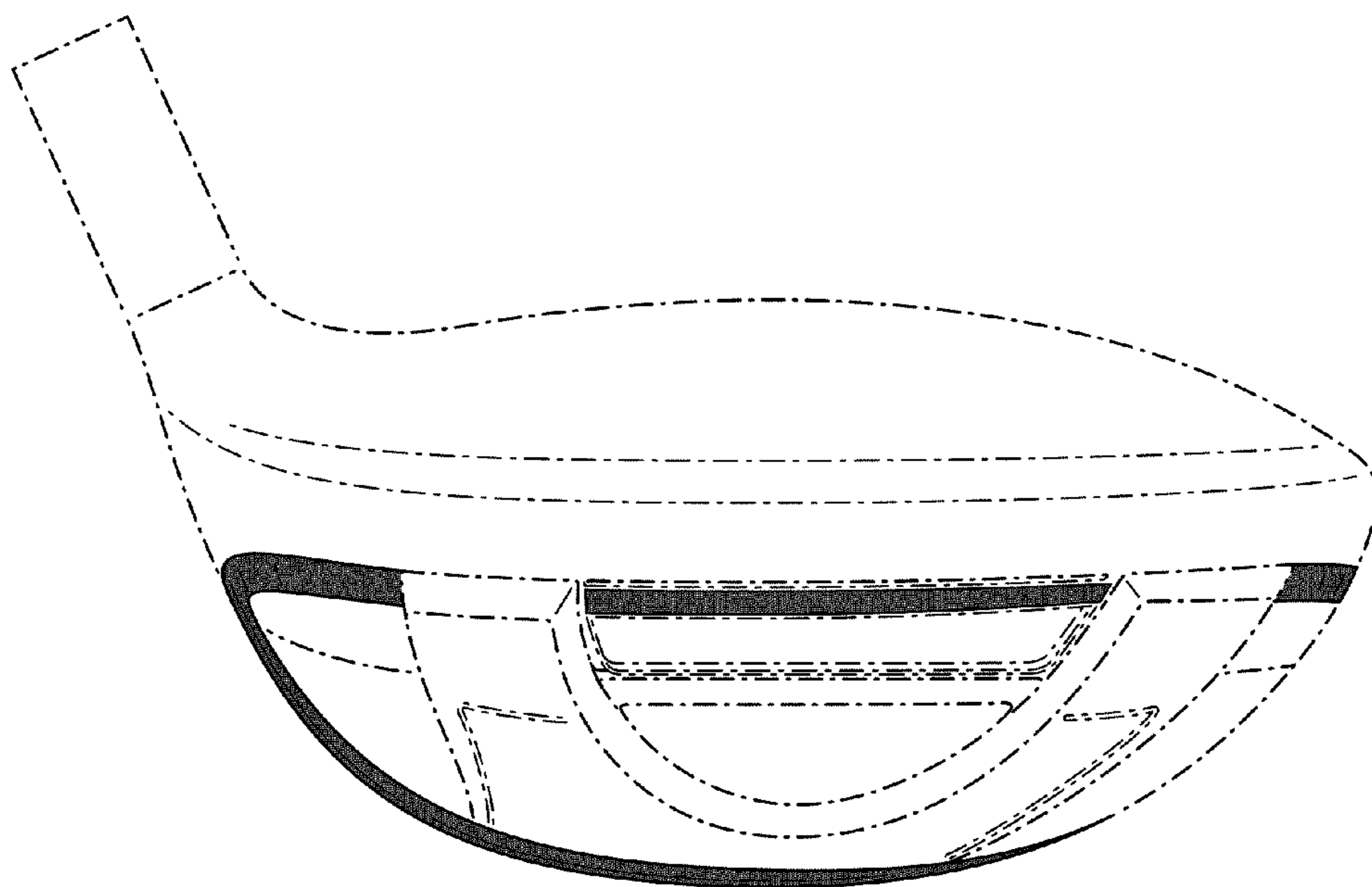

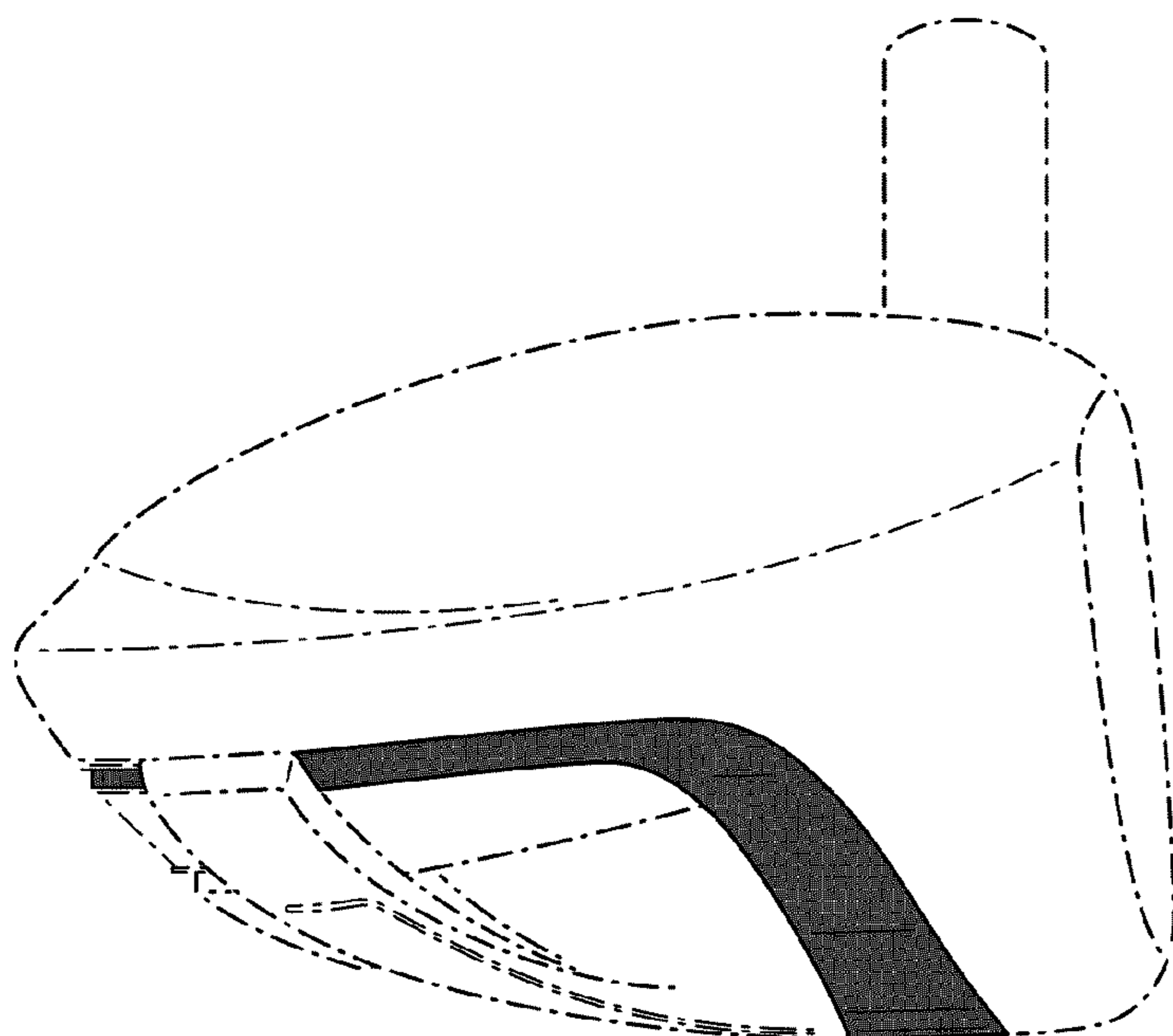

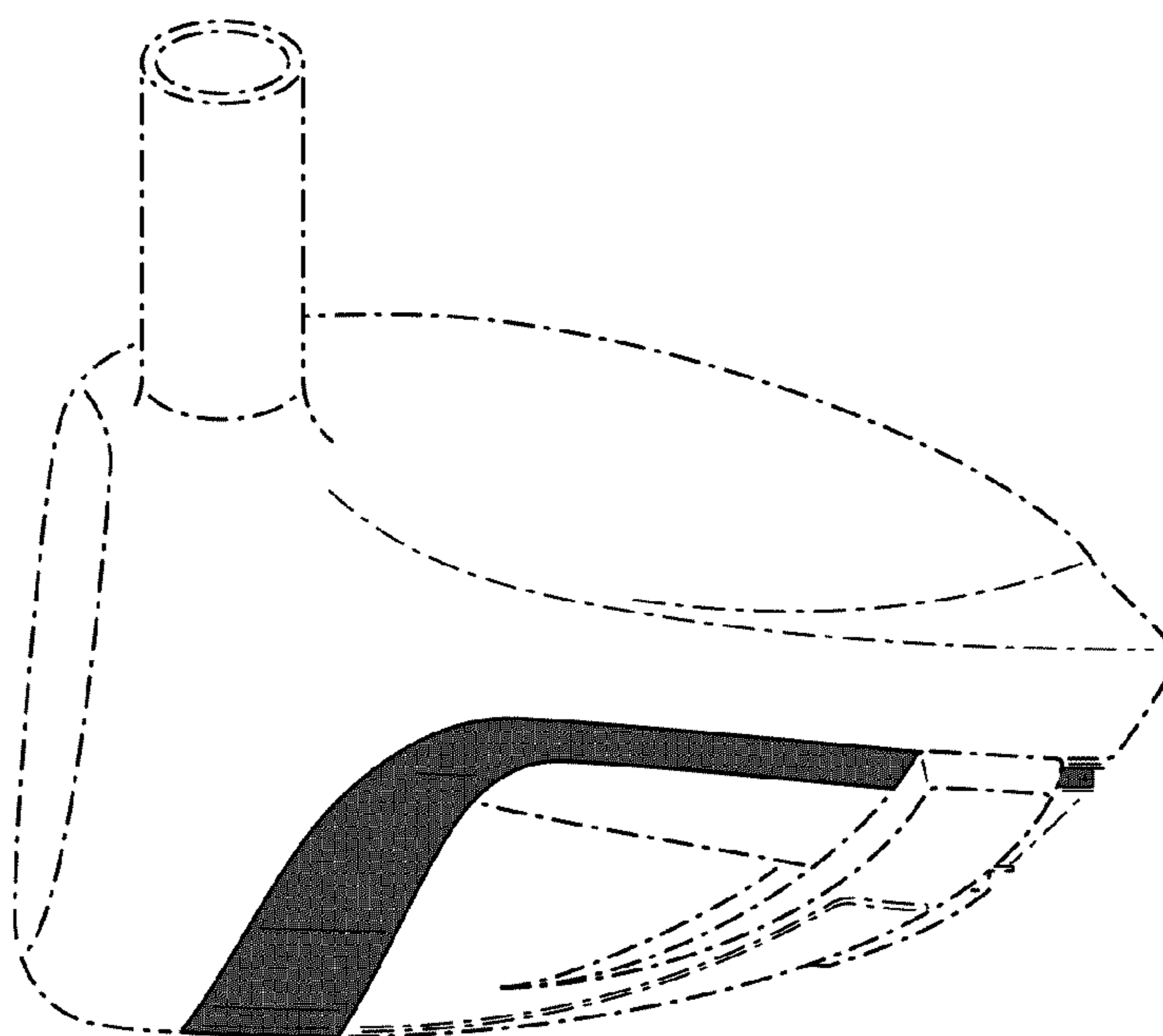
