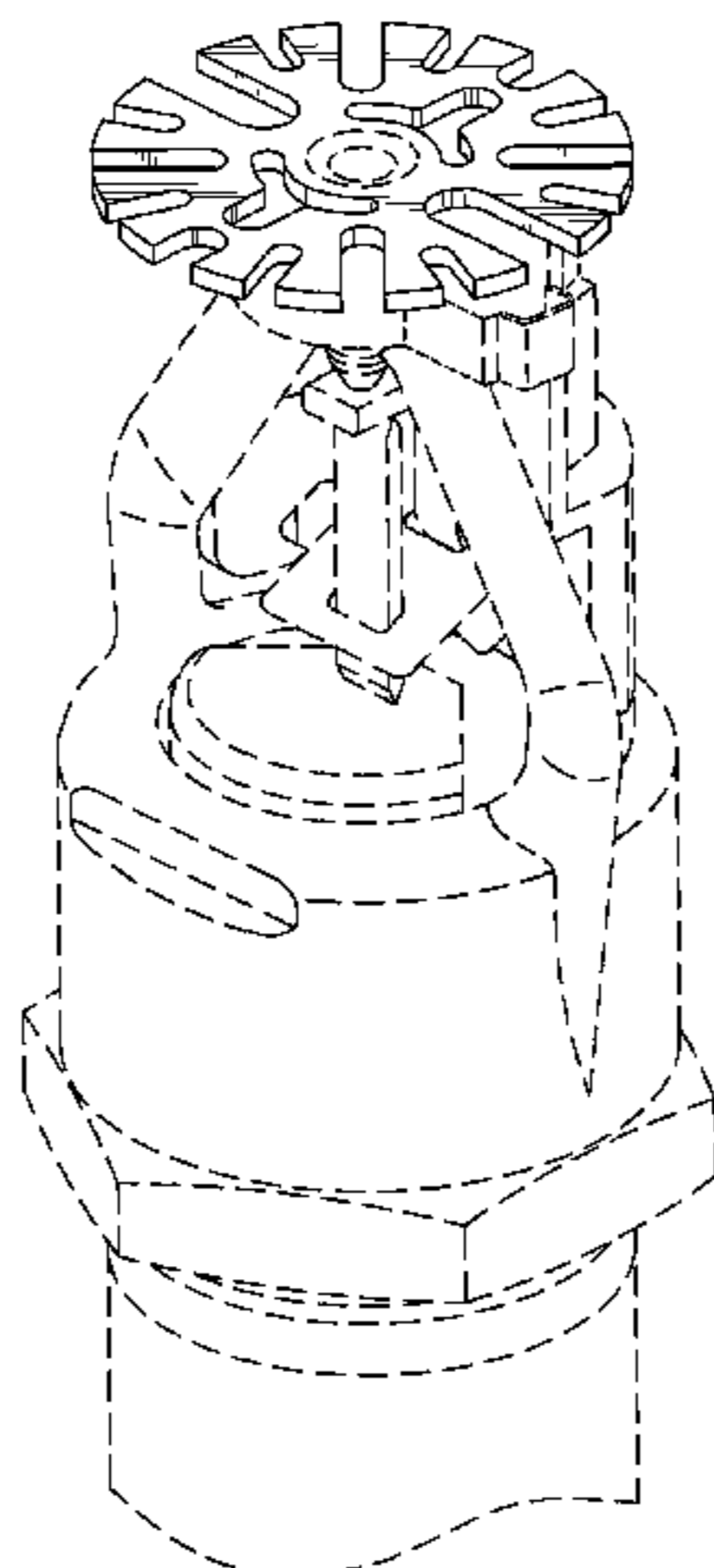
FIG. 1 is a front perspective view of a deflector for fire protection sprinkler (the dashed lines are for illustrative purposes only and do not form part of the invention);

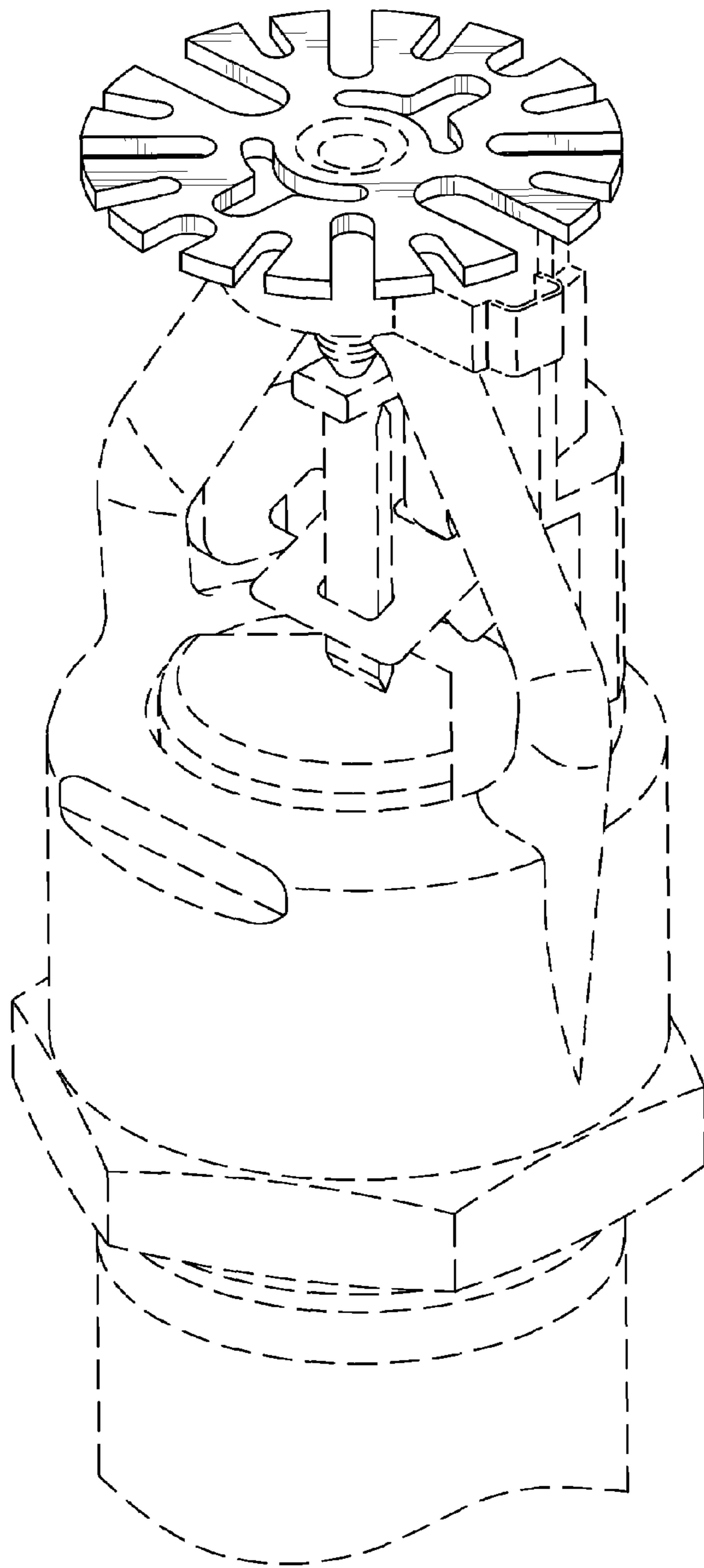

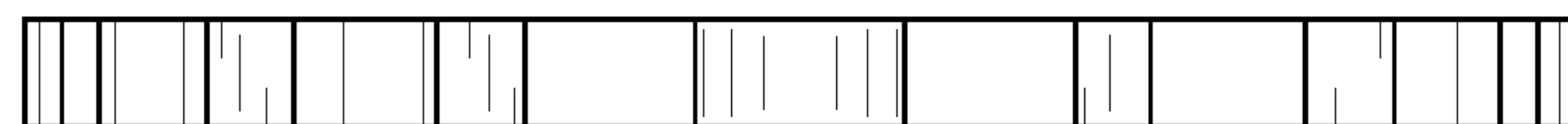

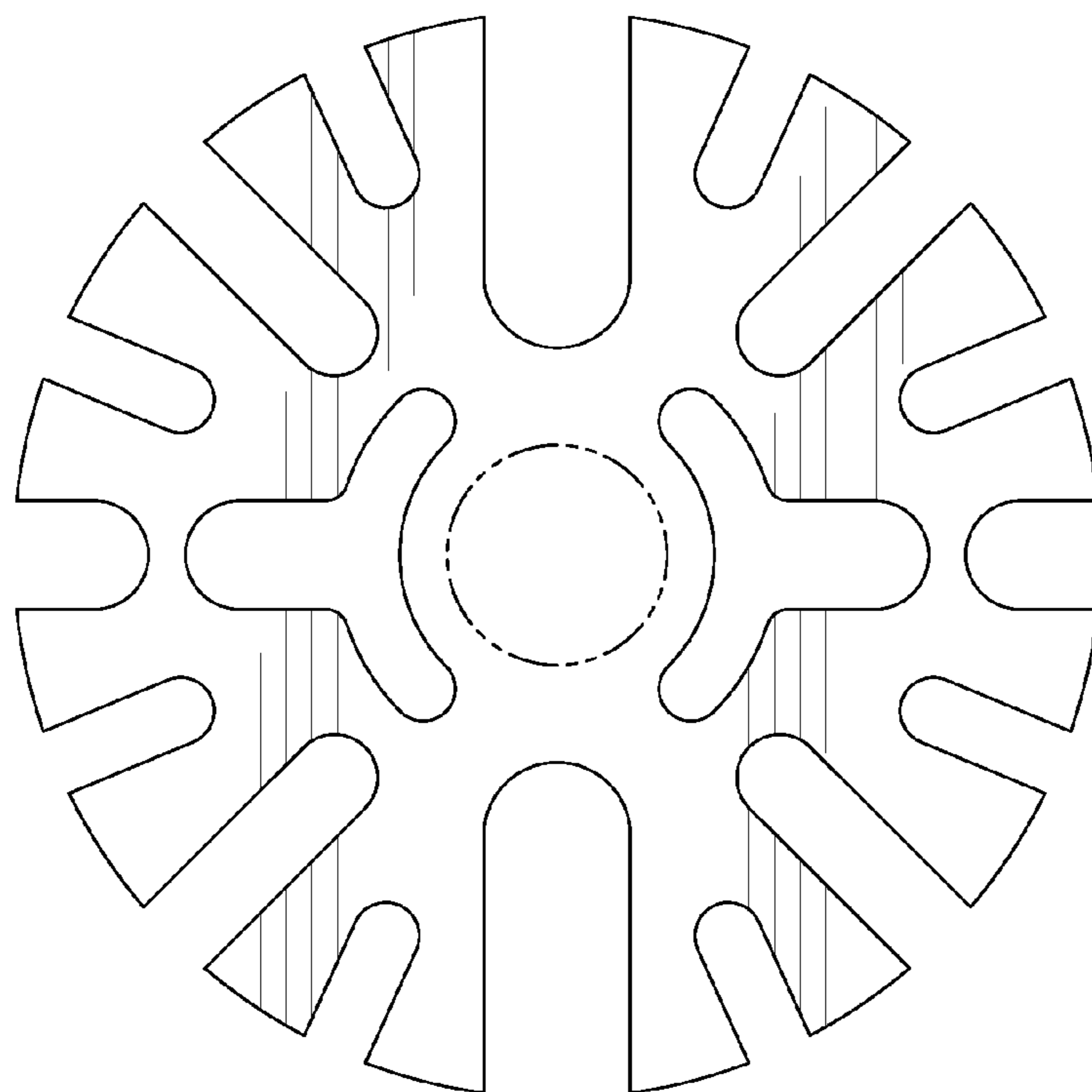

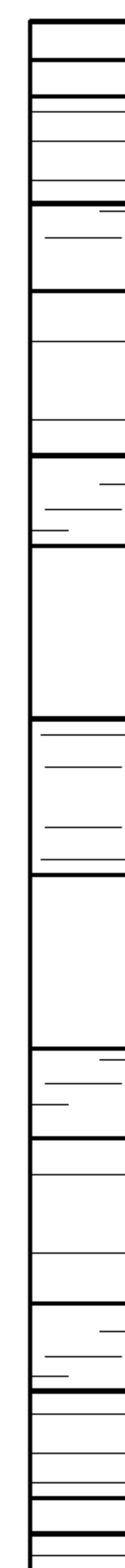
