(57) **CLAIM**

The ornamental design for an aromatic nebulizing diffuser with auto-light regulator, time-regulator, music player and lamp, as shown and described.

FIG. 4 is a left side view of the design;

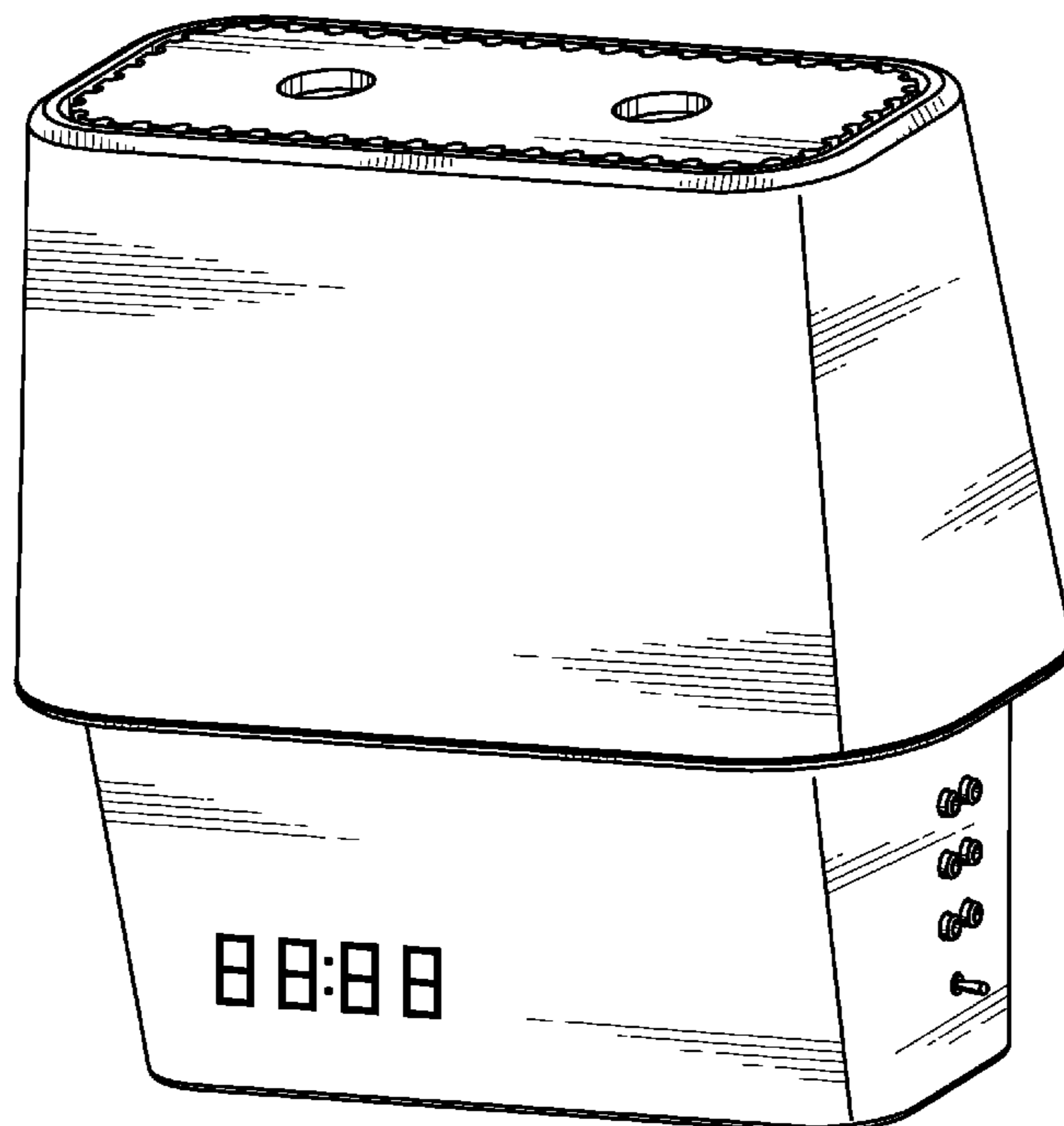
FIG. 5 is a right side view of the design;

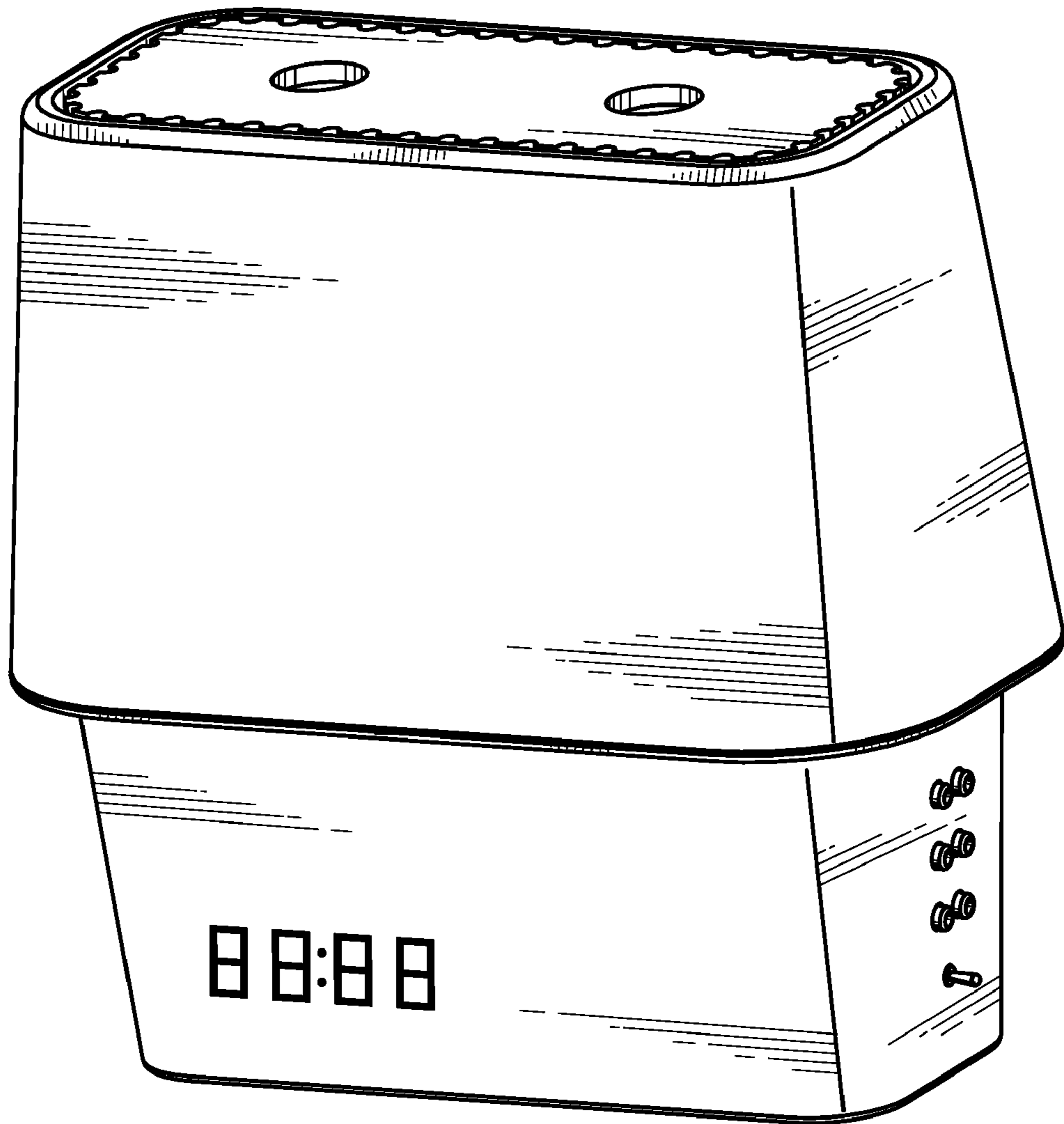

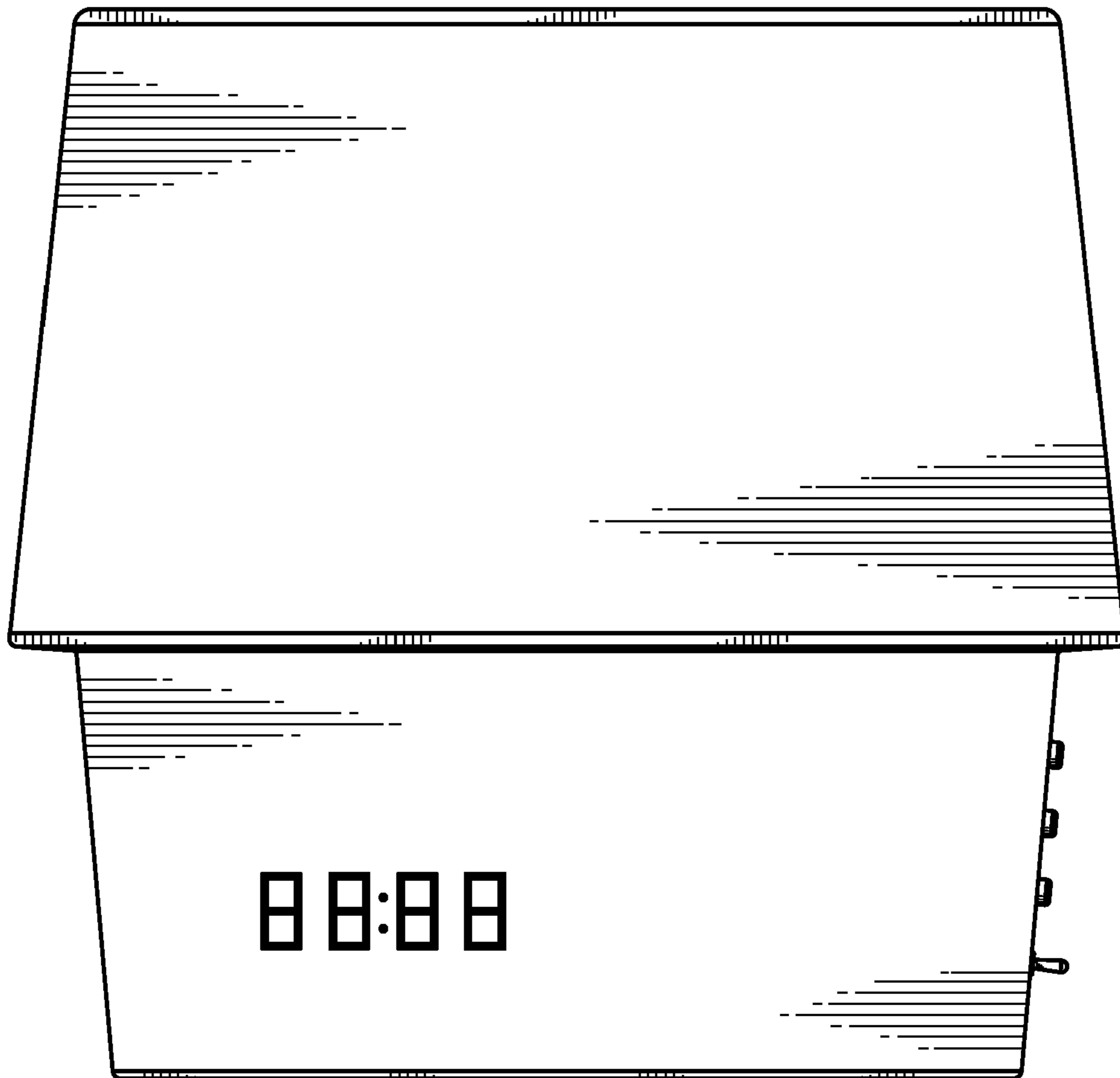

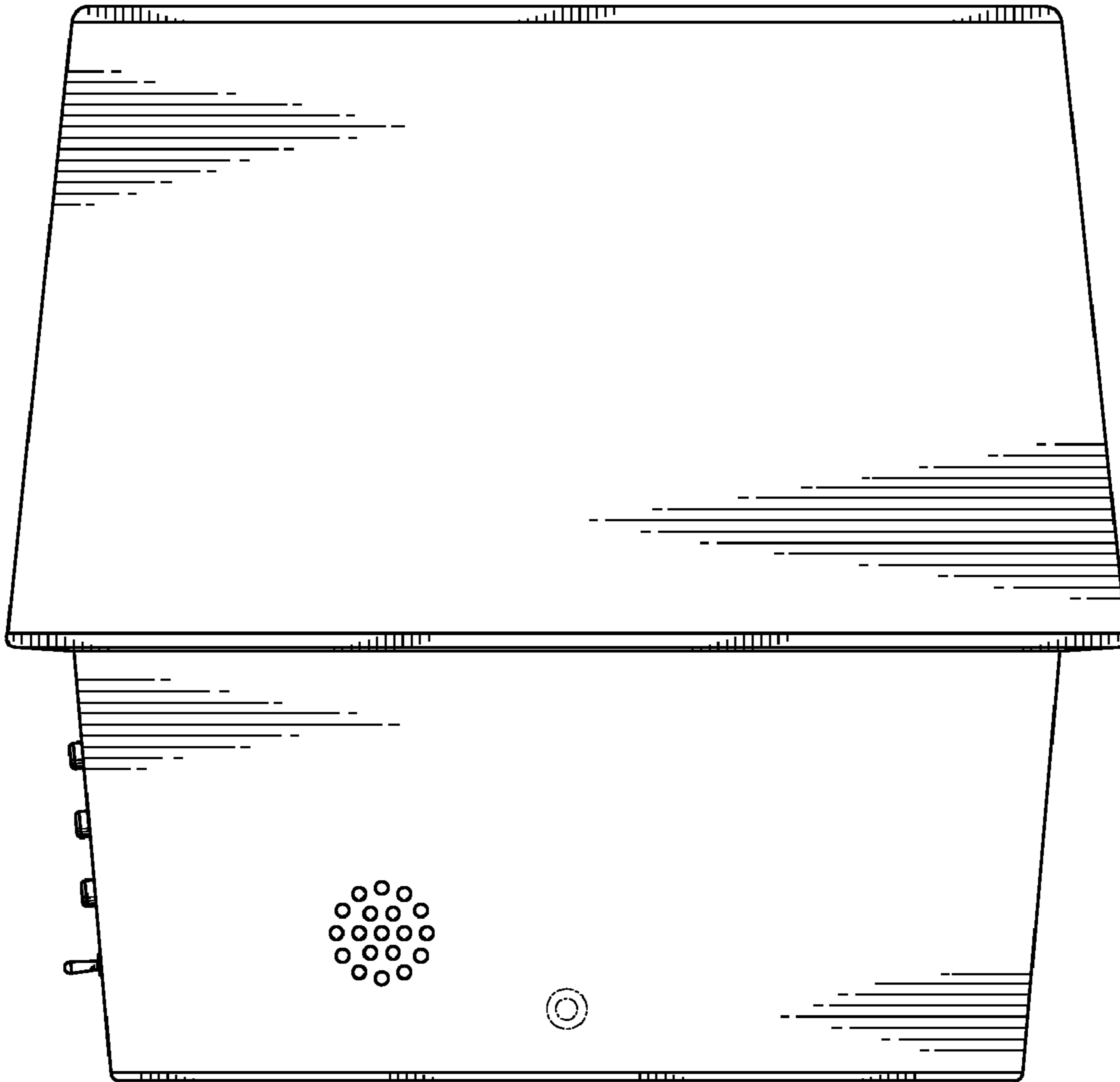

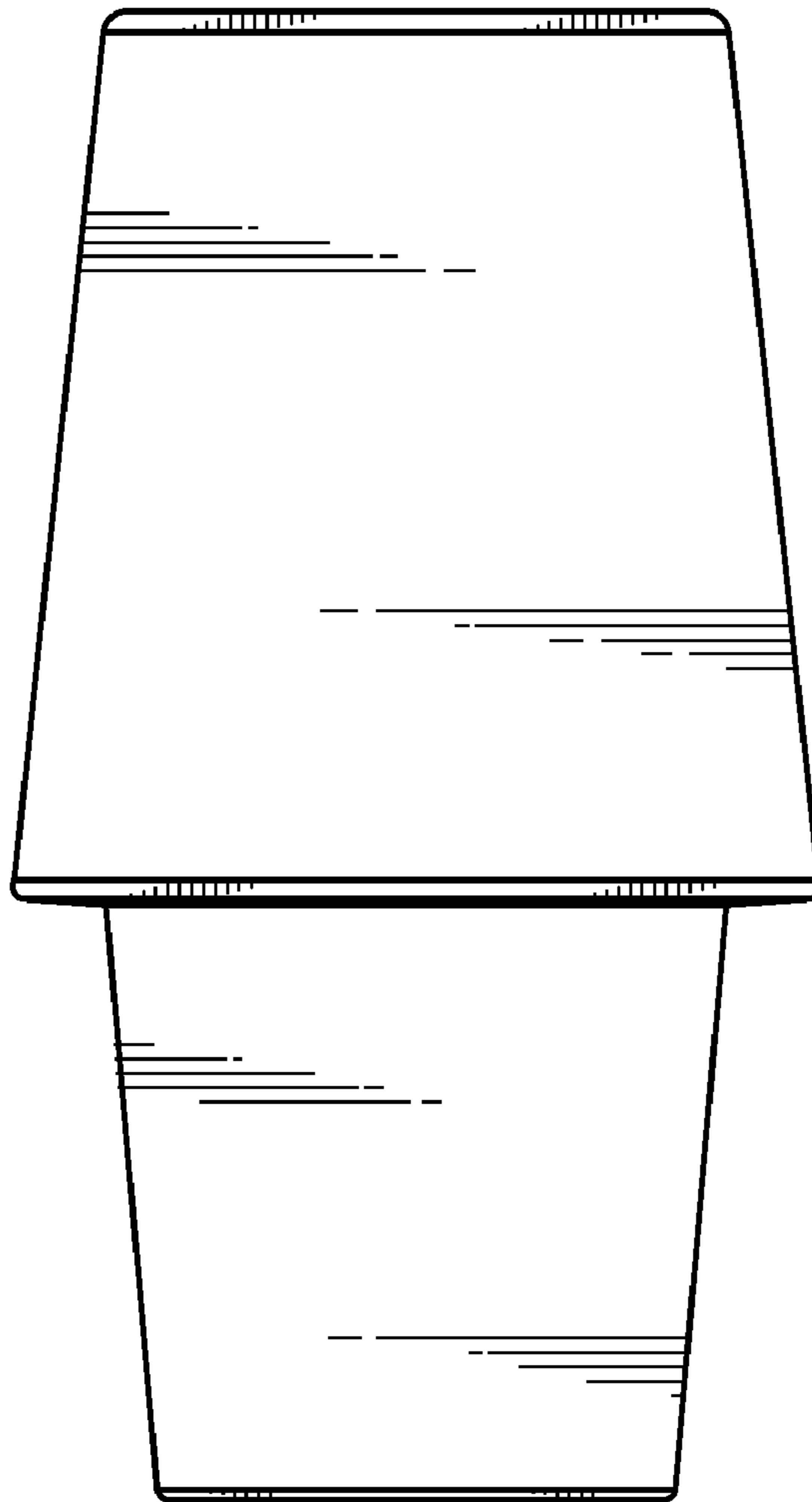

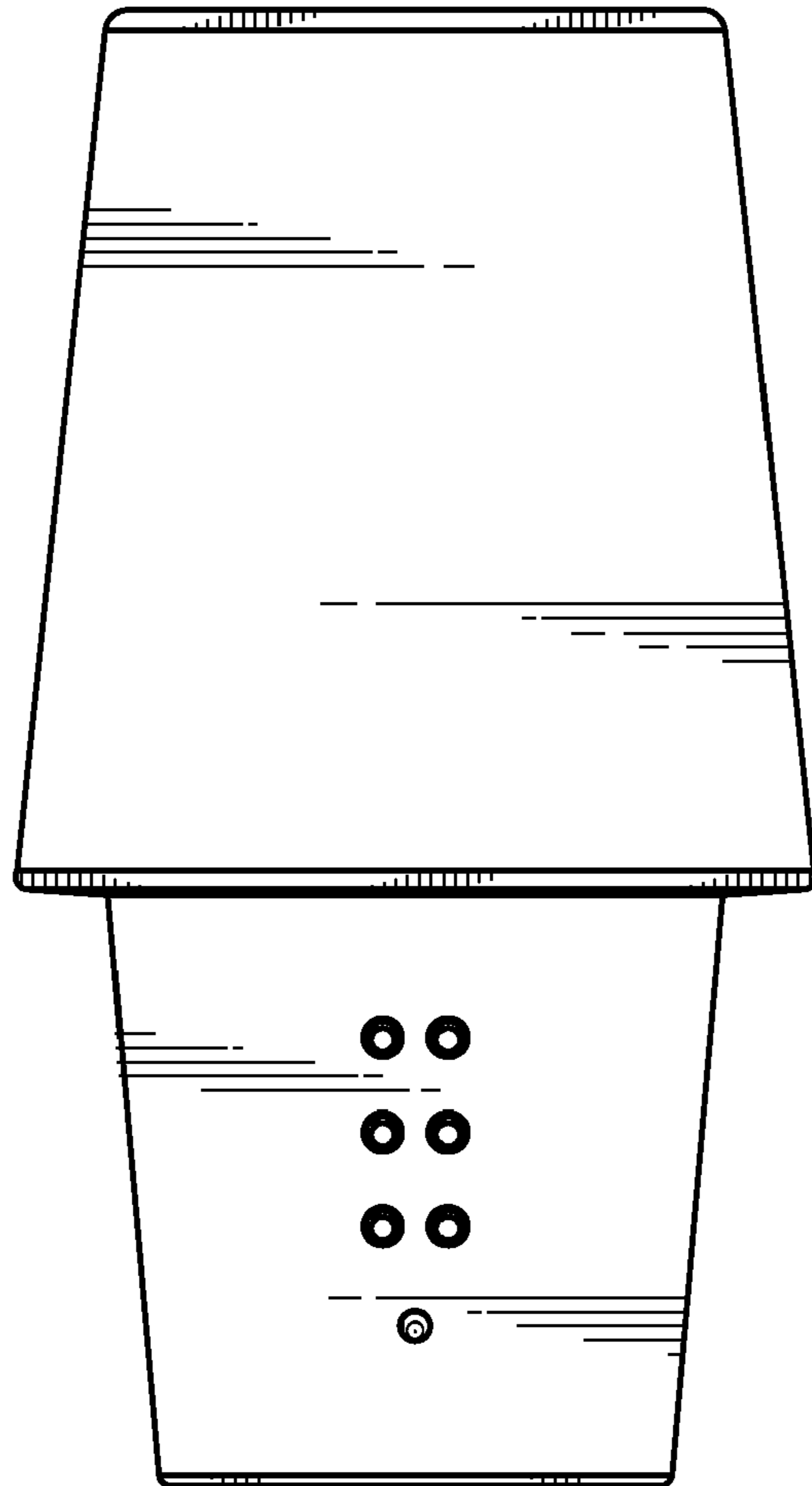

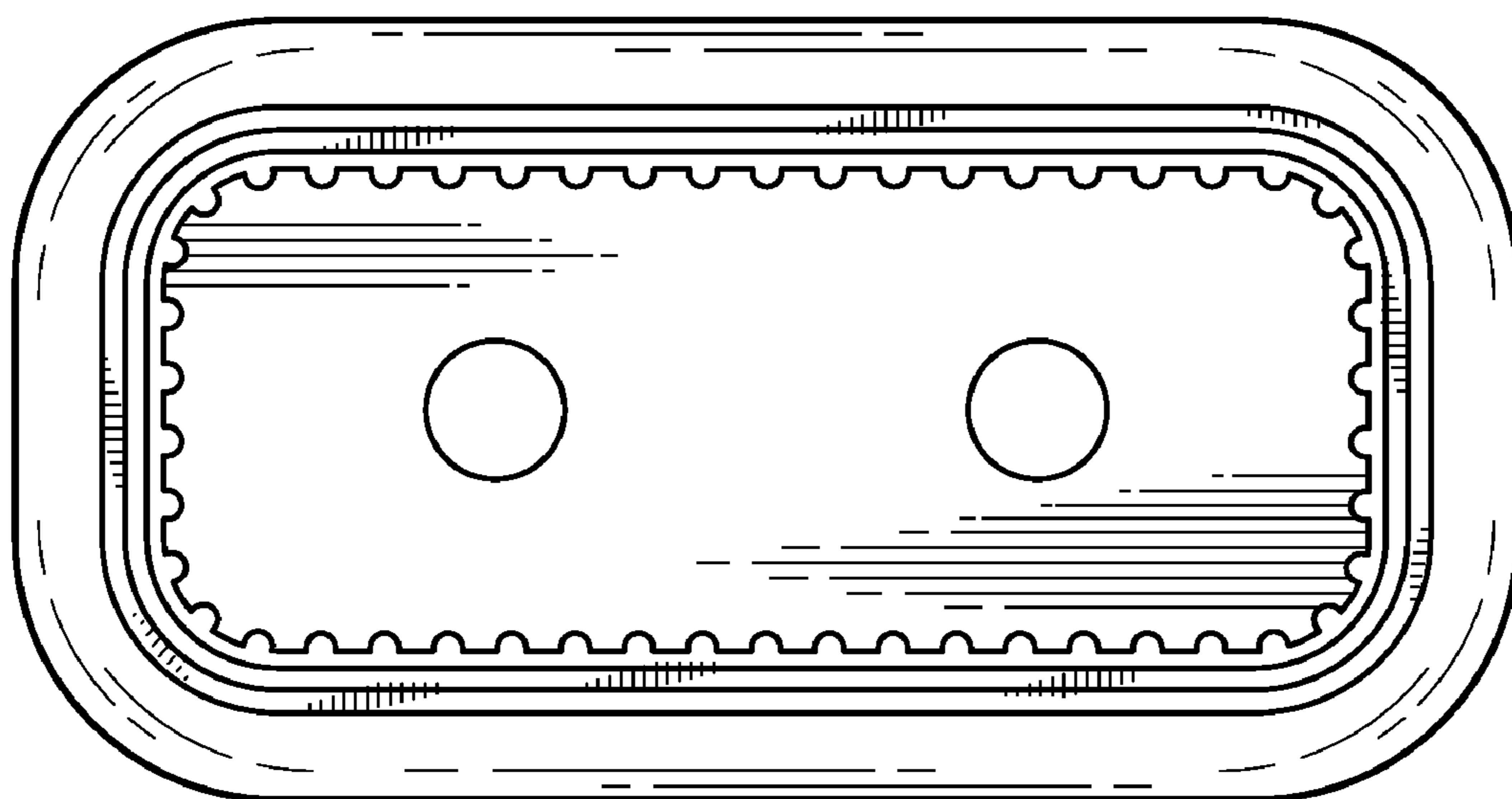

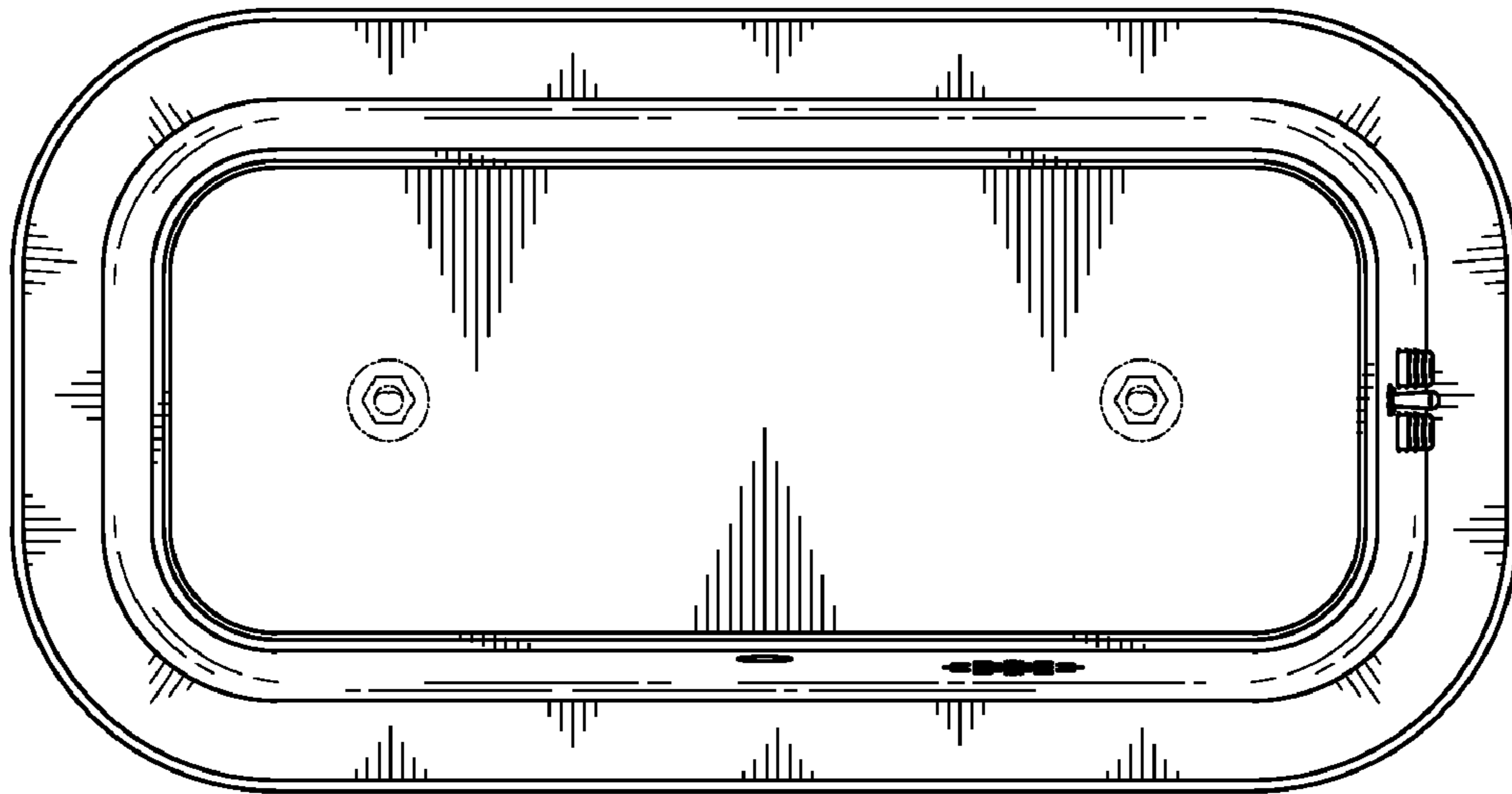
