FIG. 4 is a front view;

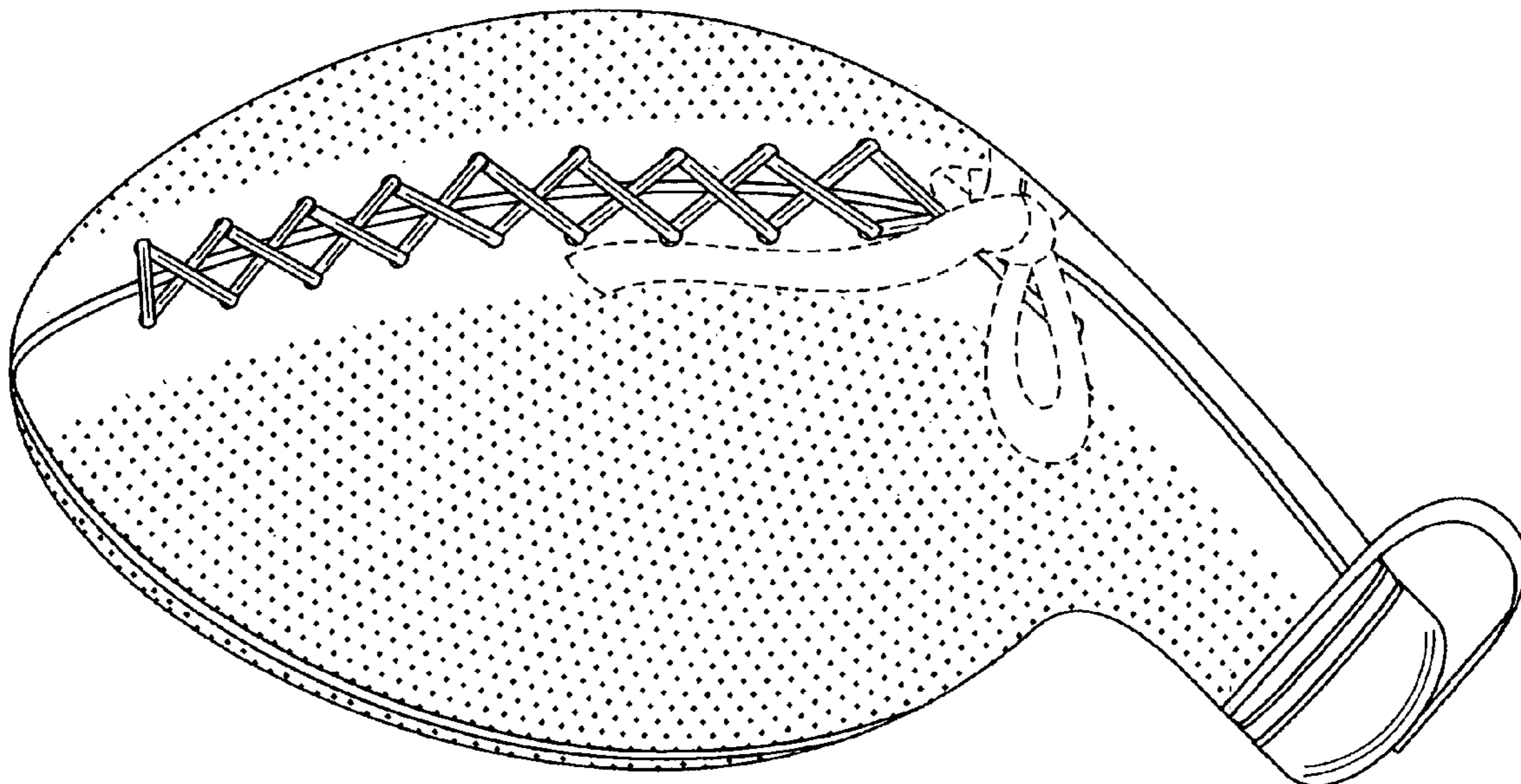
FIG. 5 is a rear view;

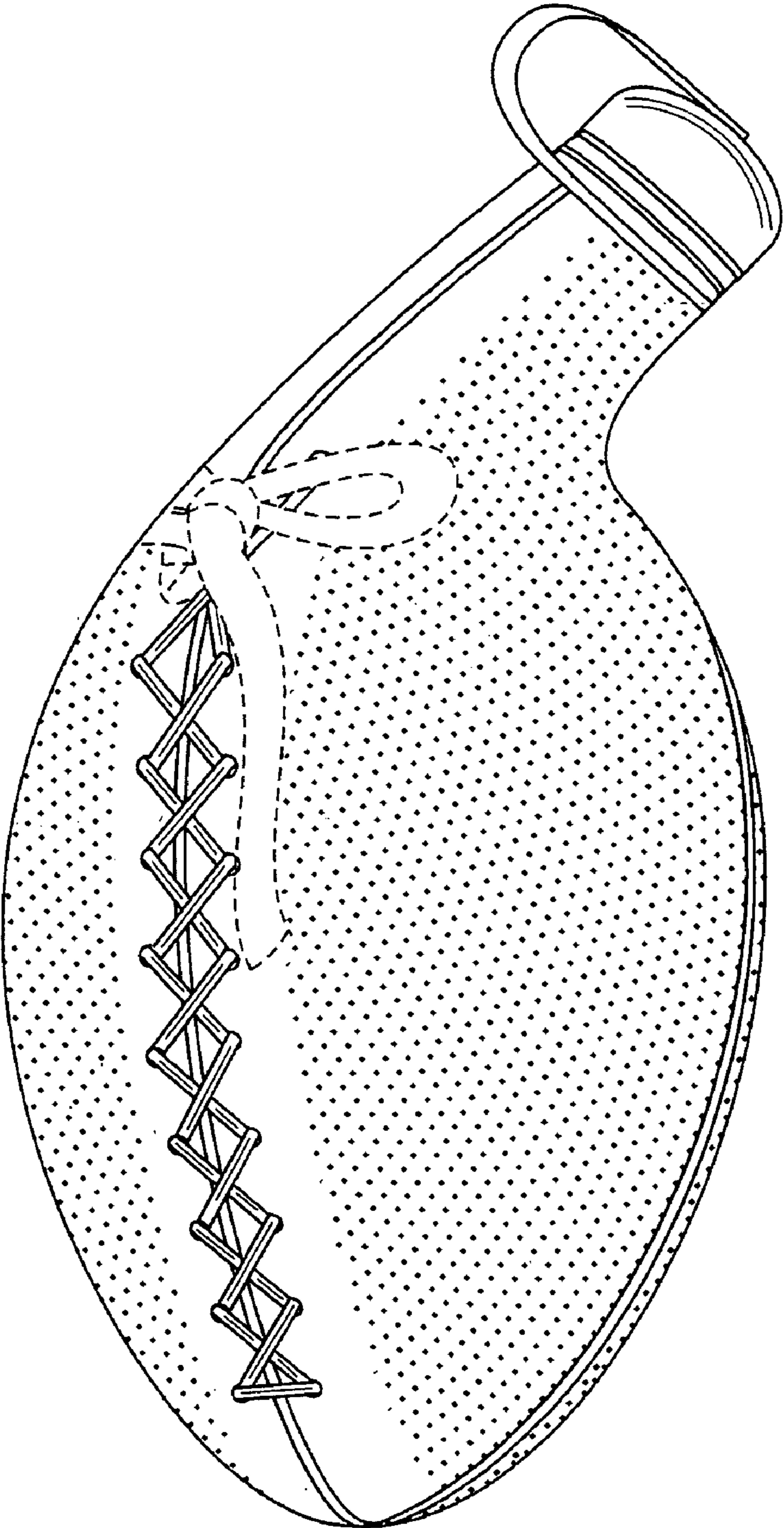

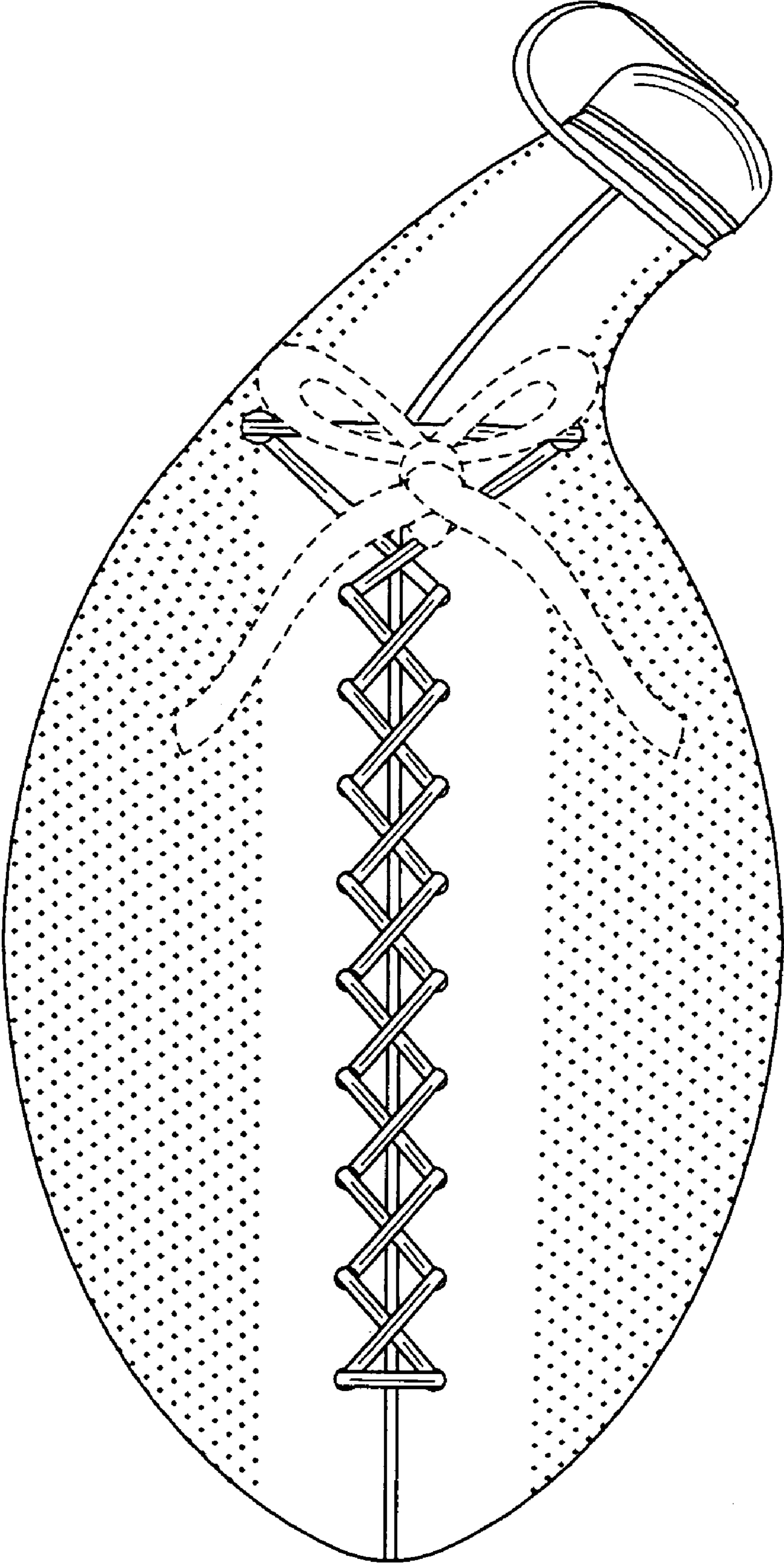

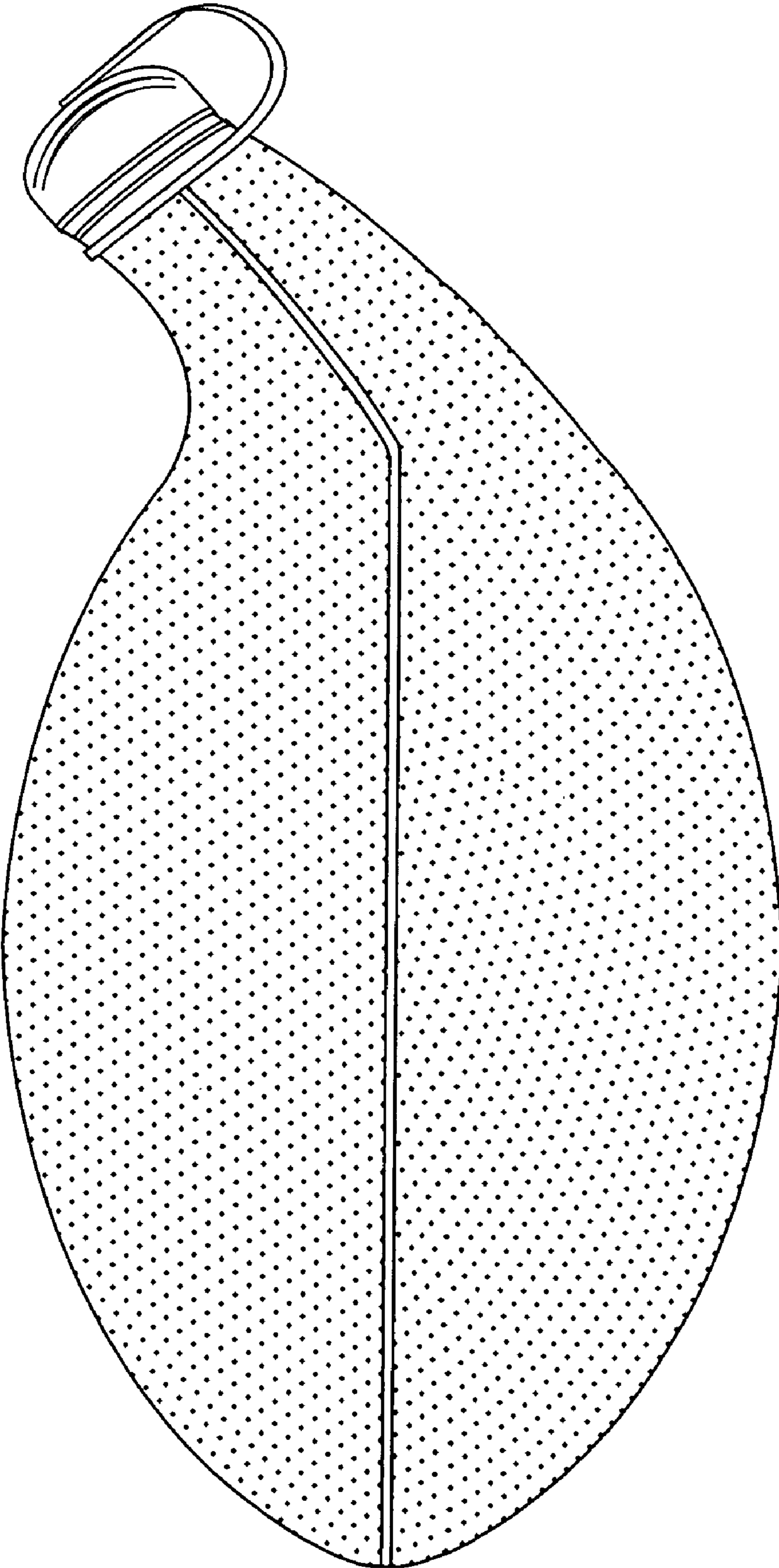

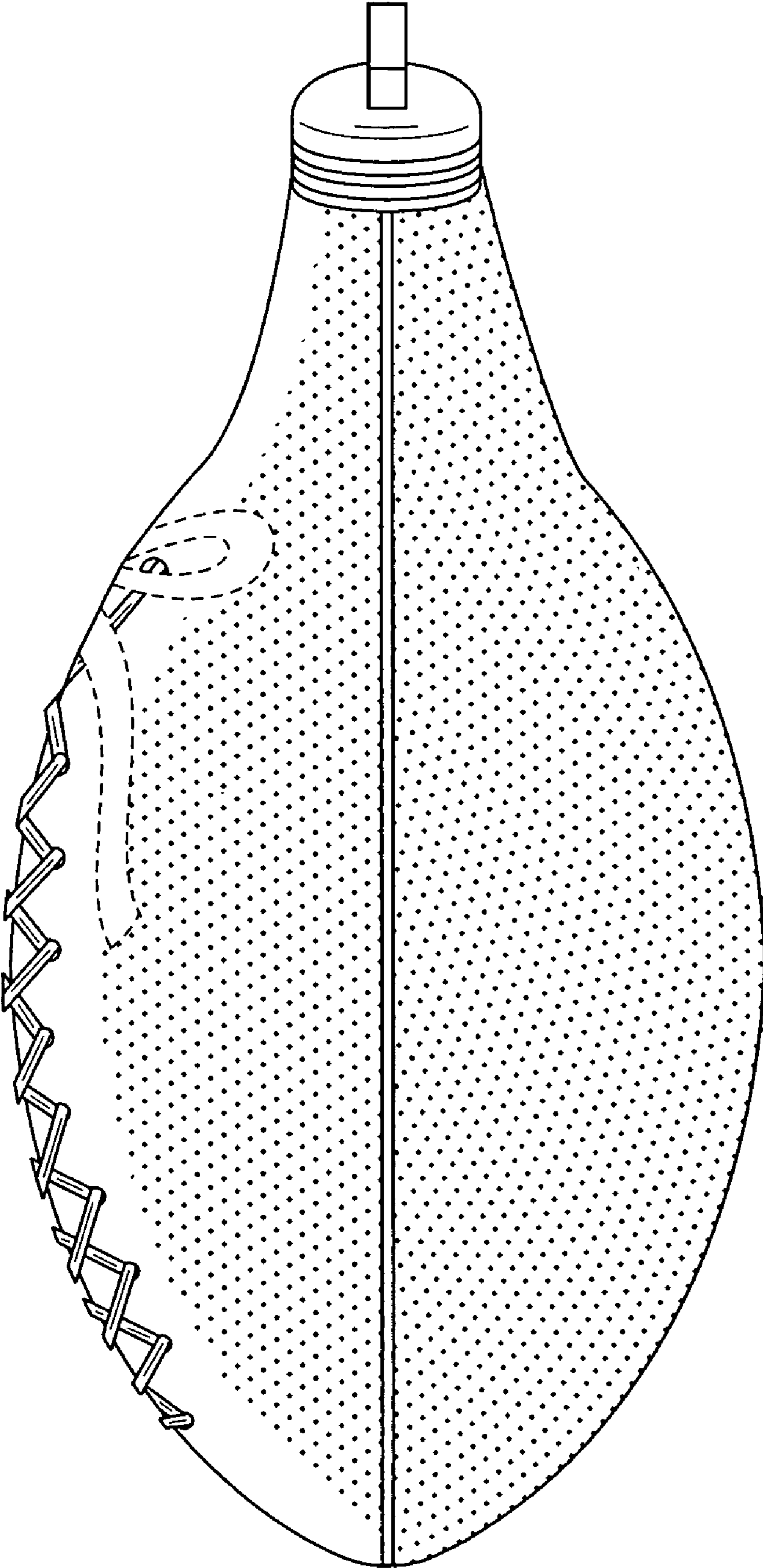

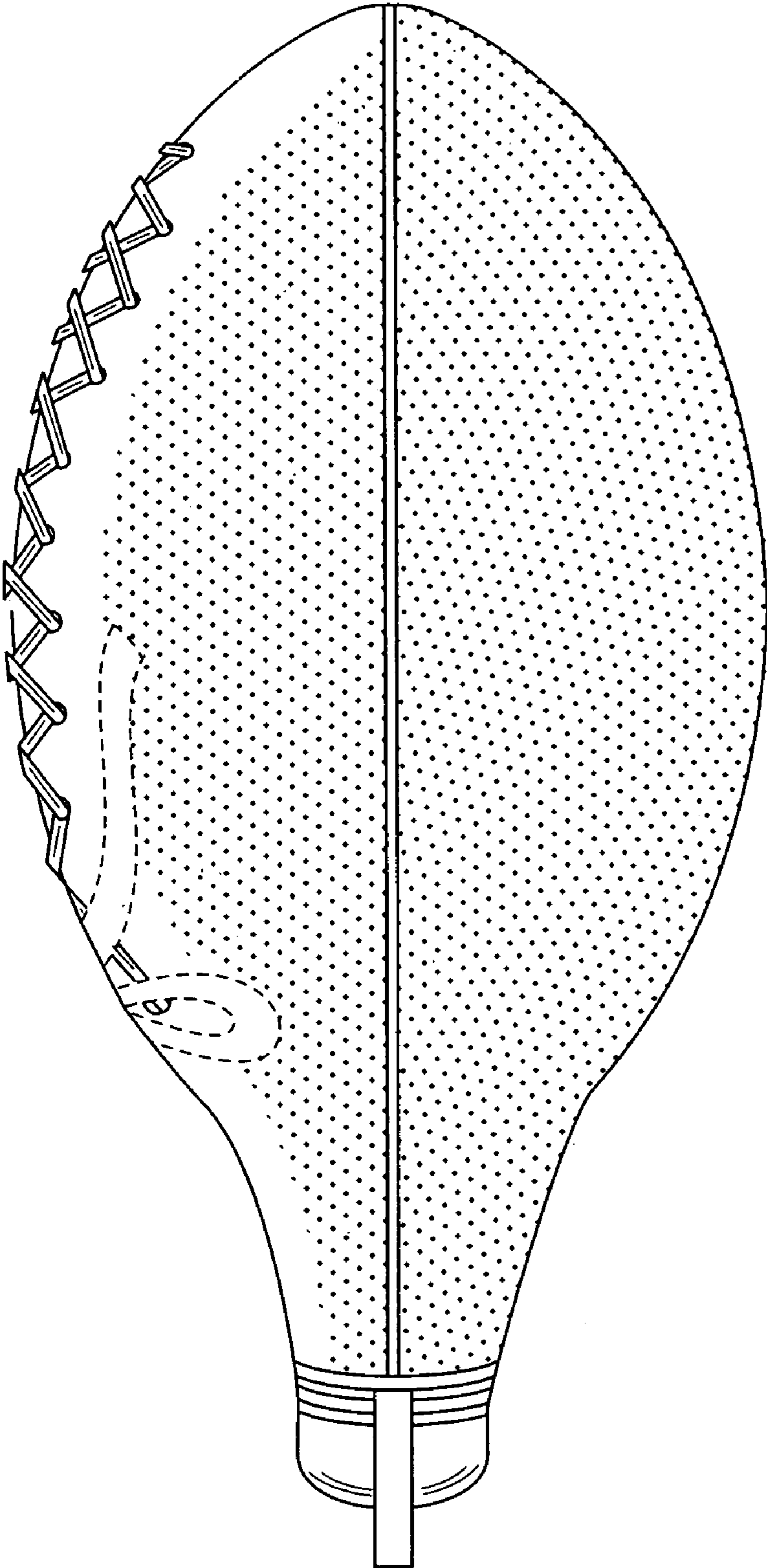

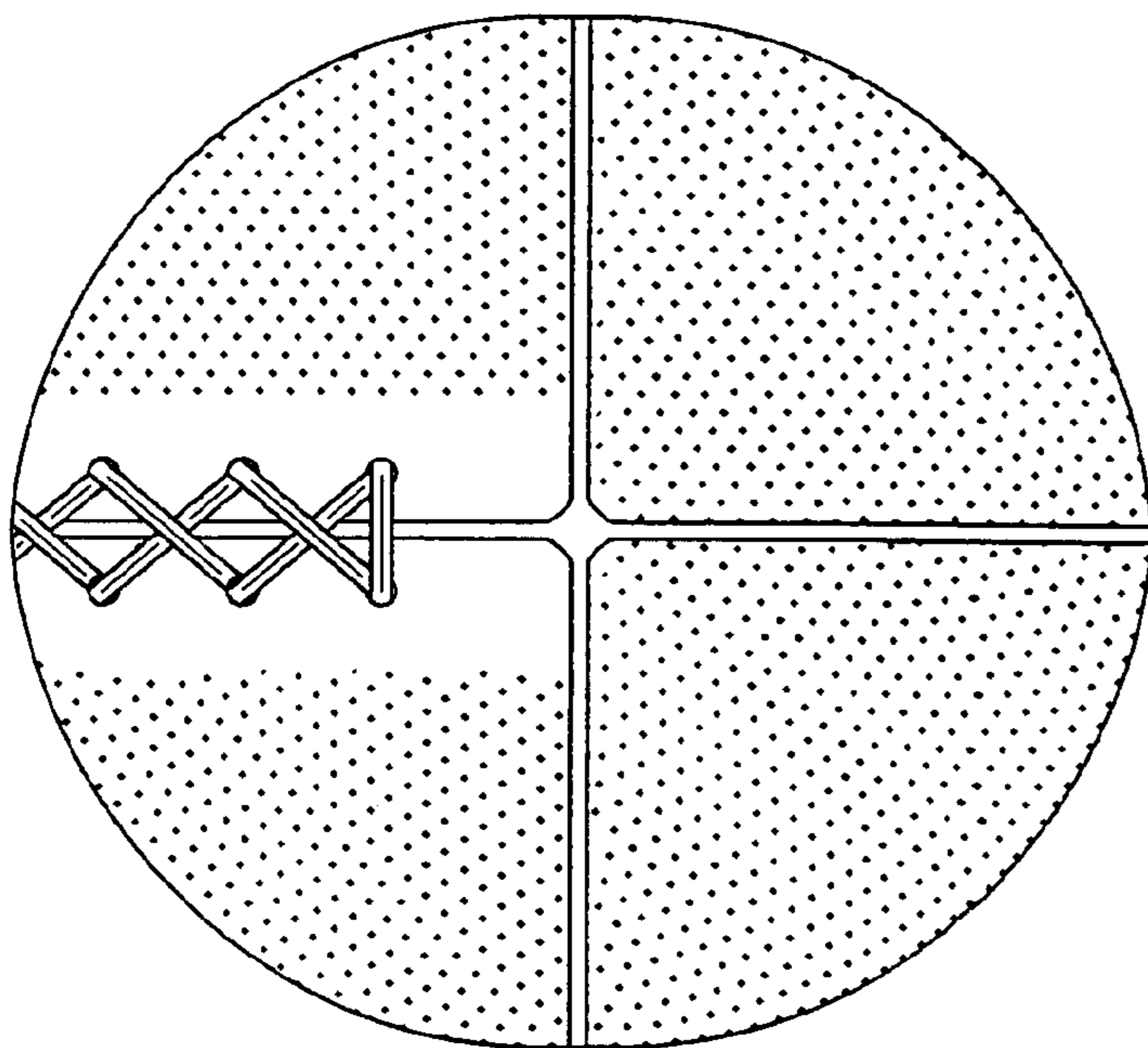

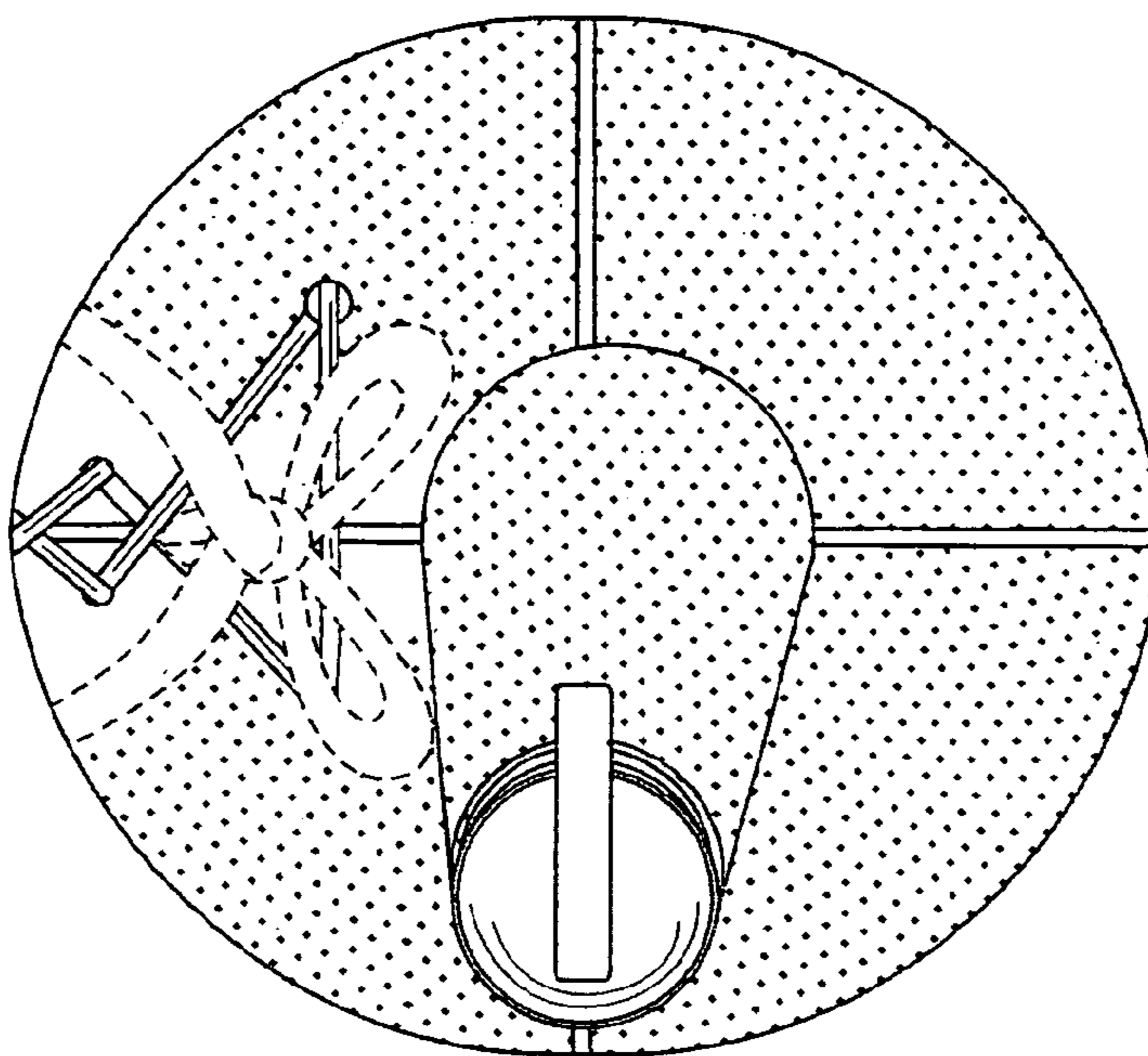
