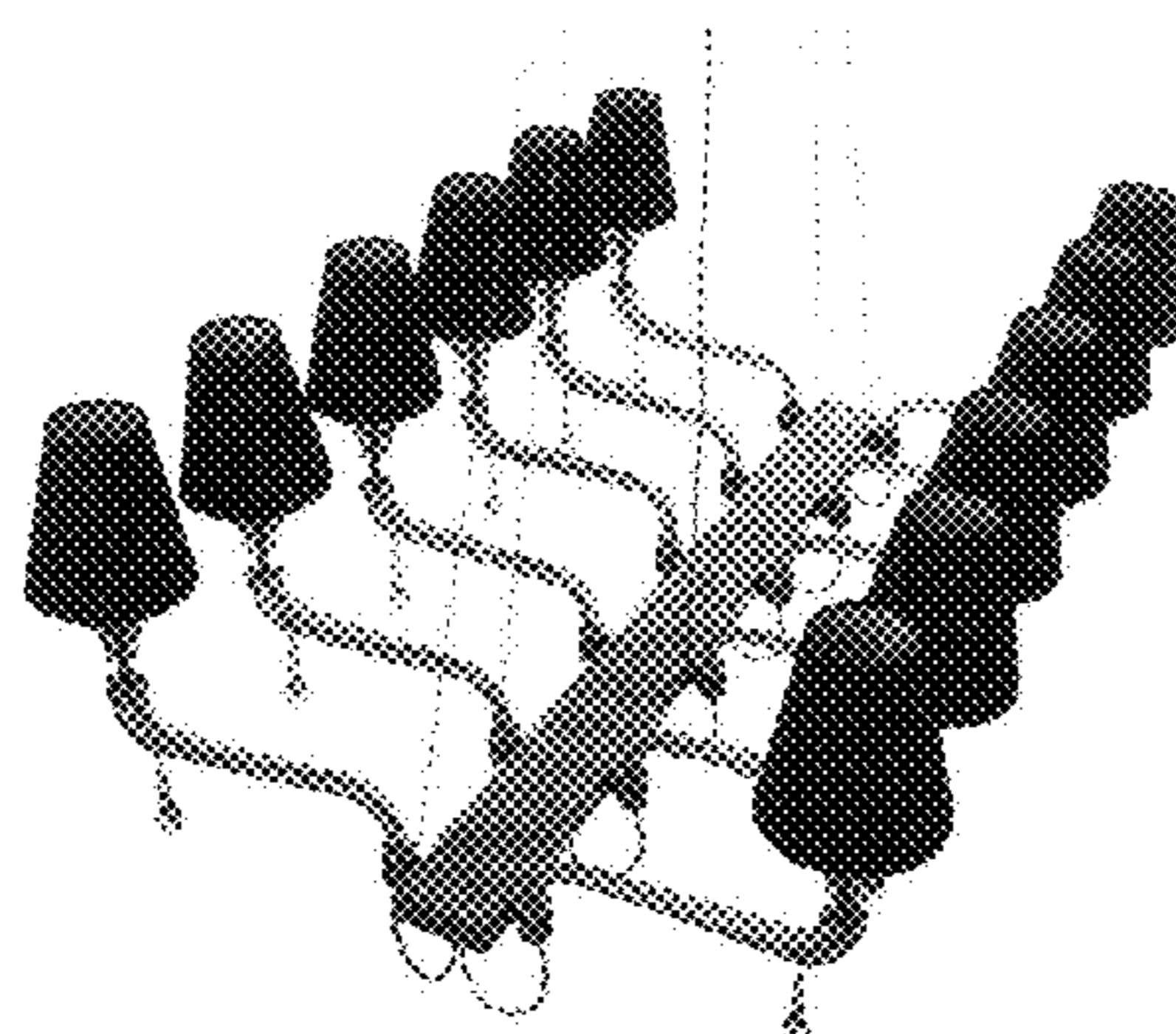
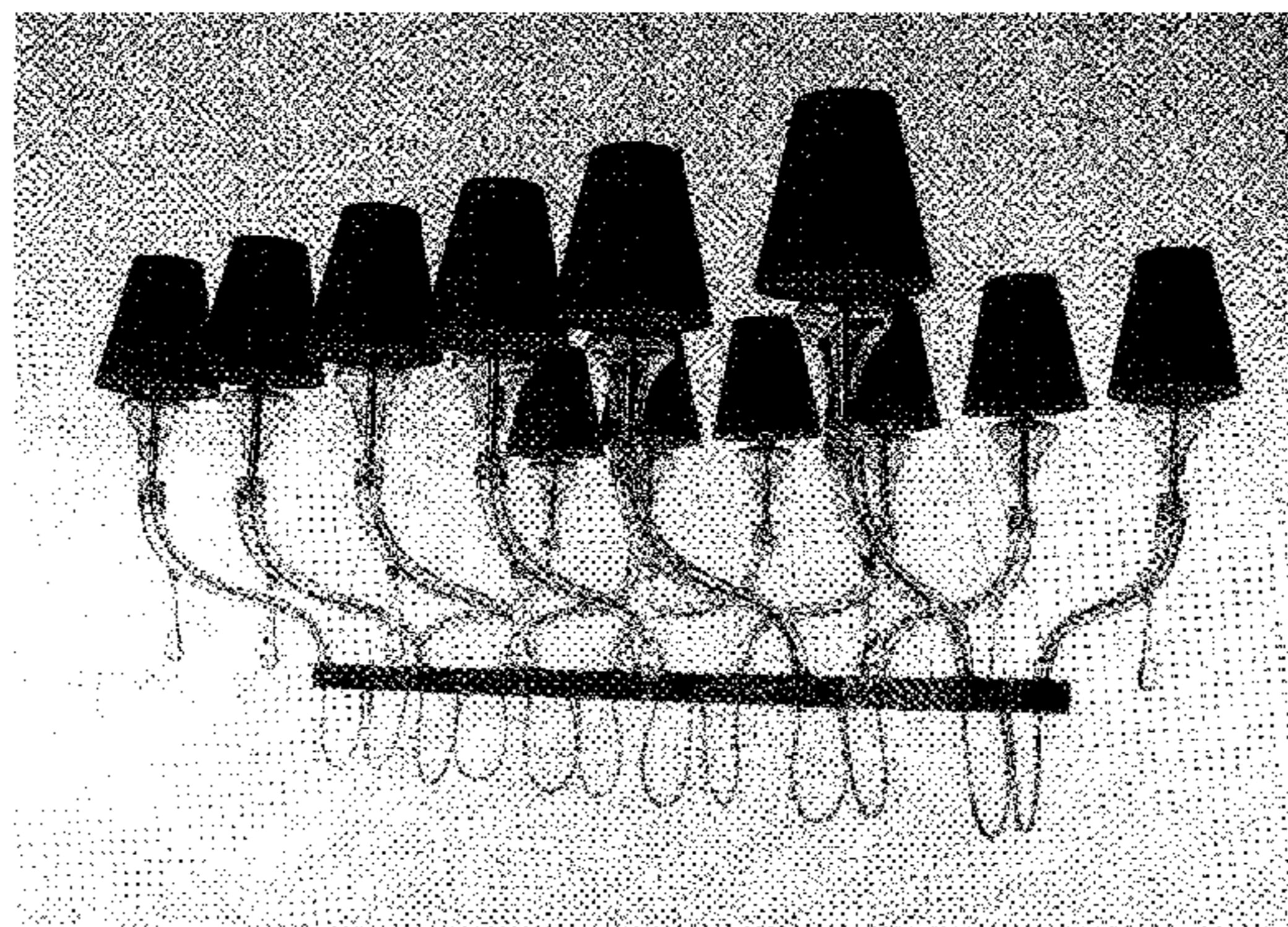
FIG. 12 is a magnified view of an alternate embodiment of the lamp.

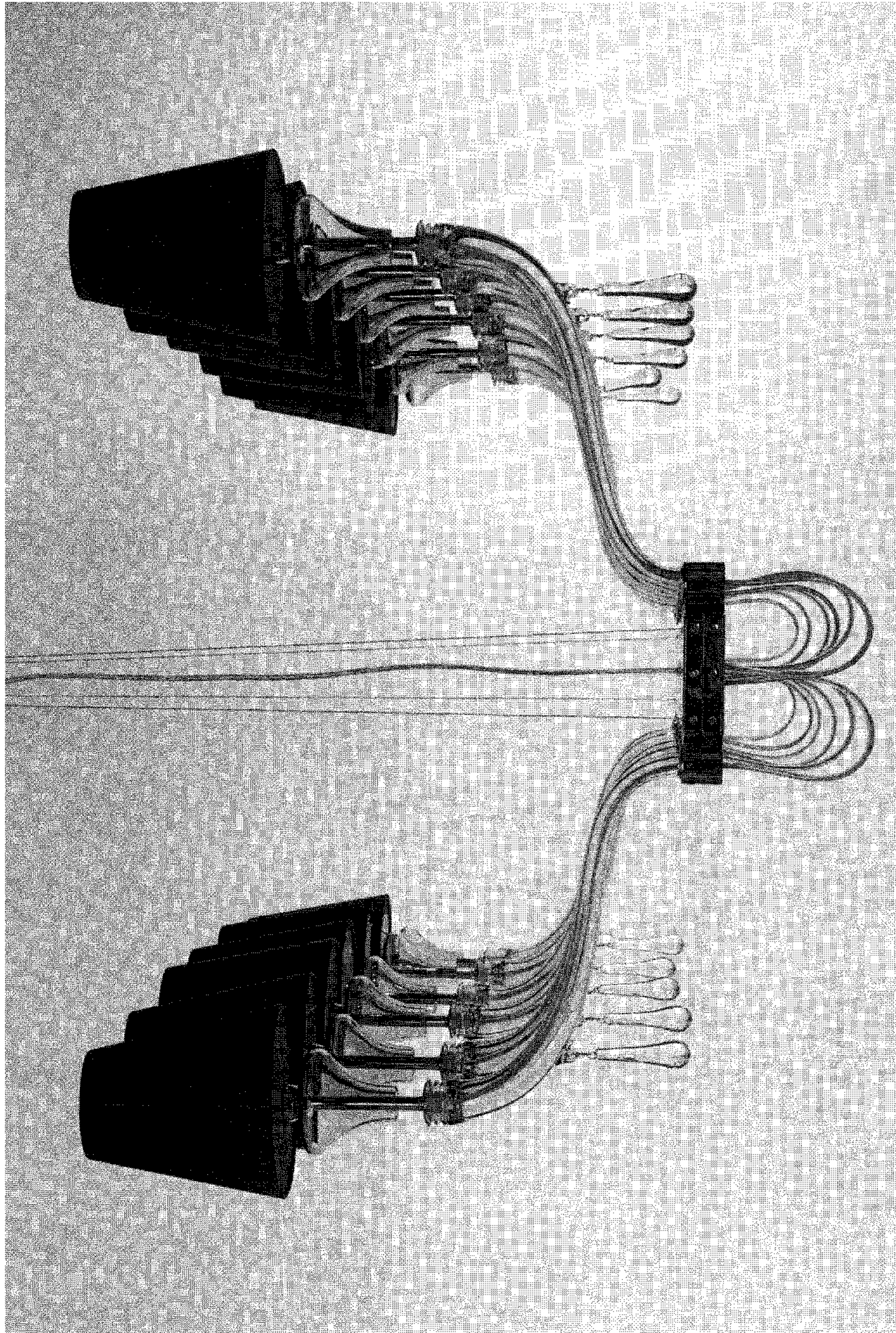

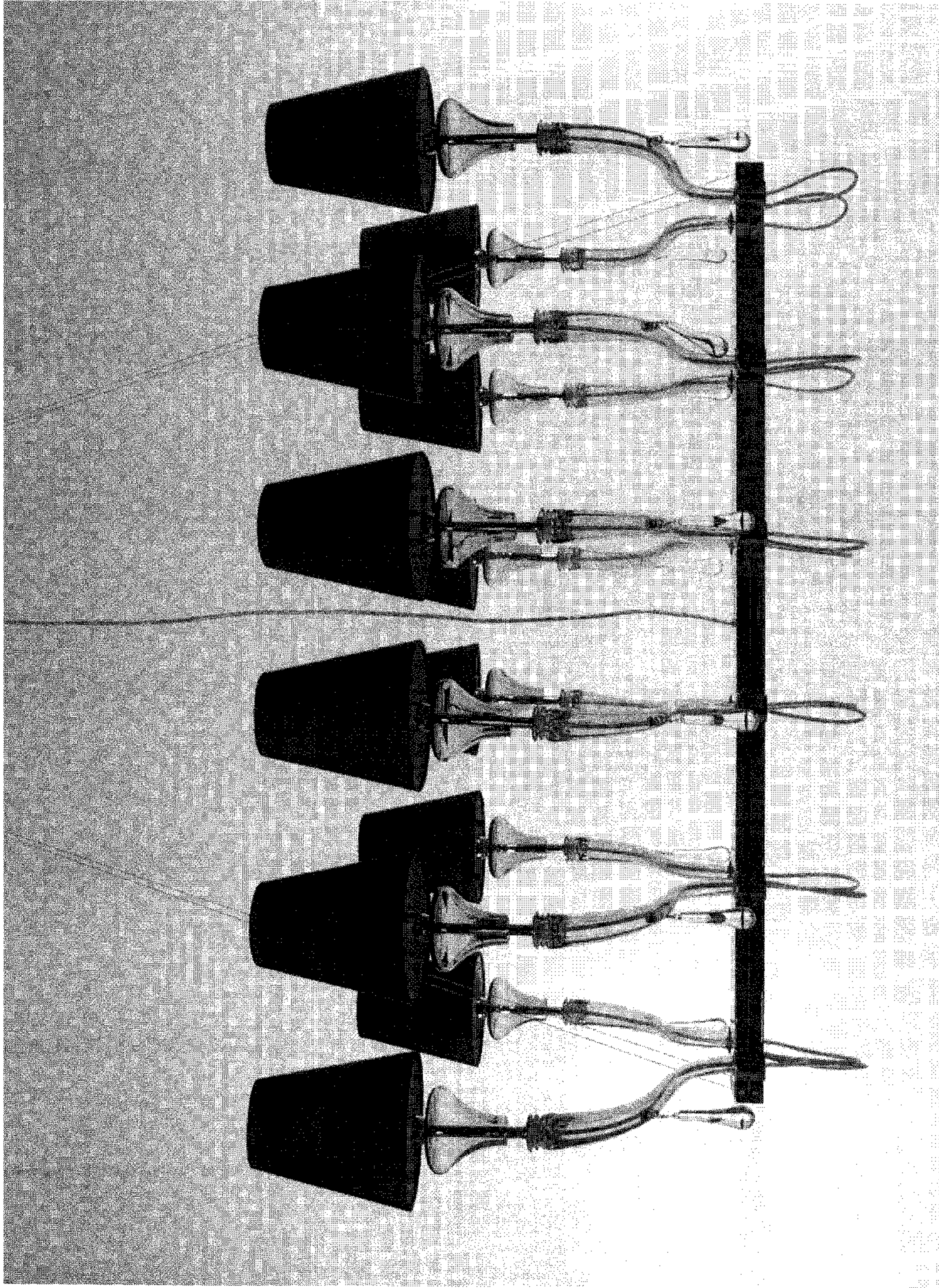

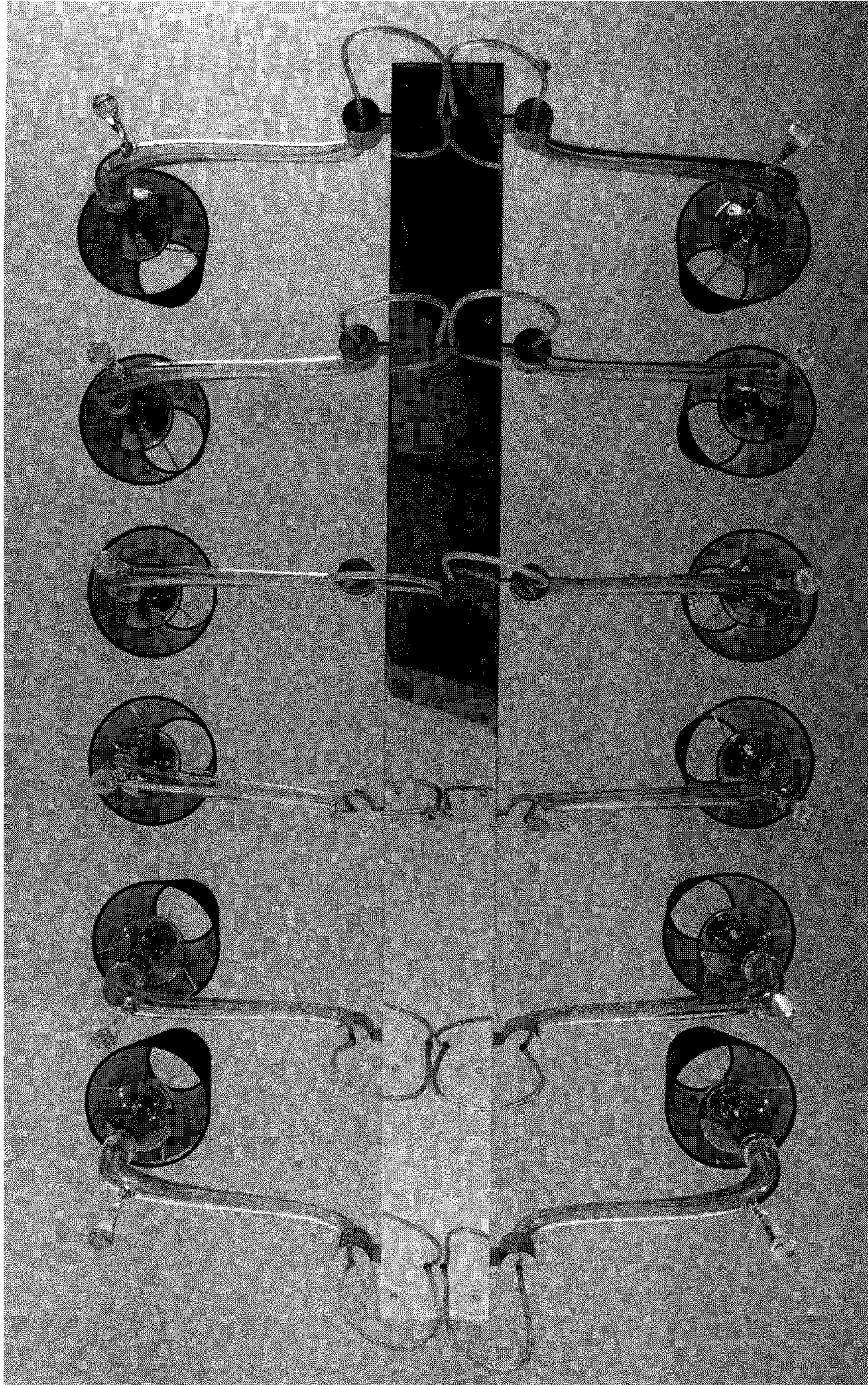

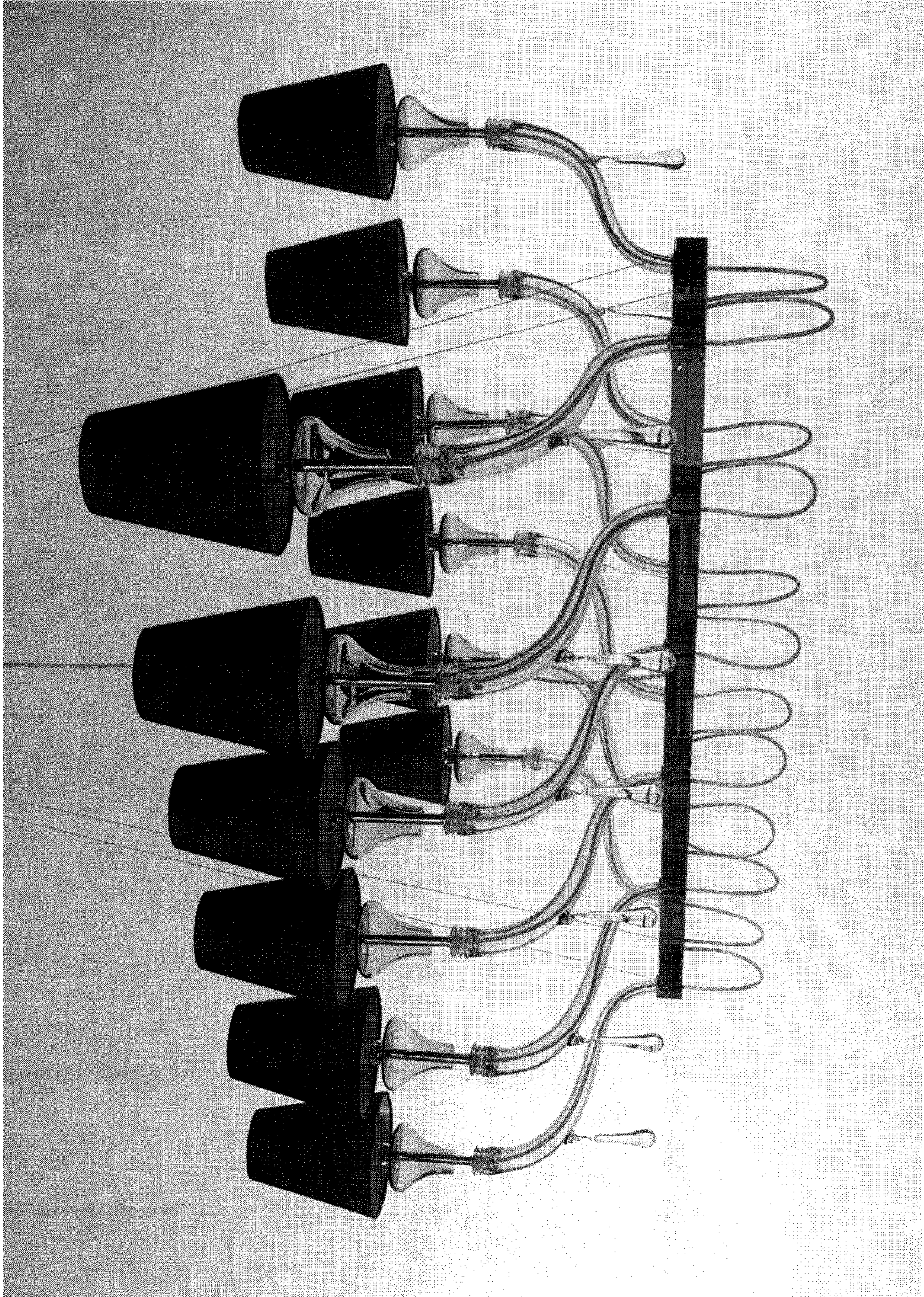

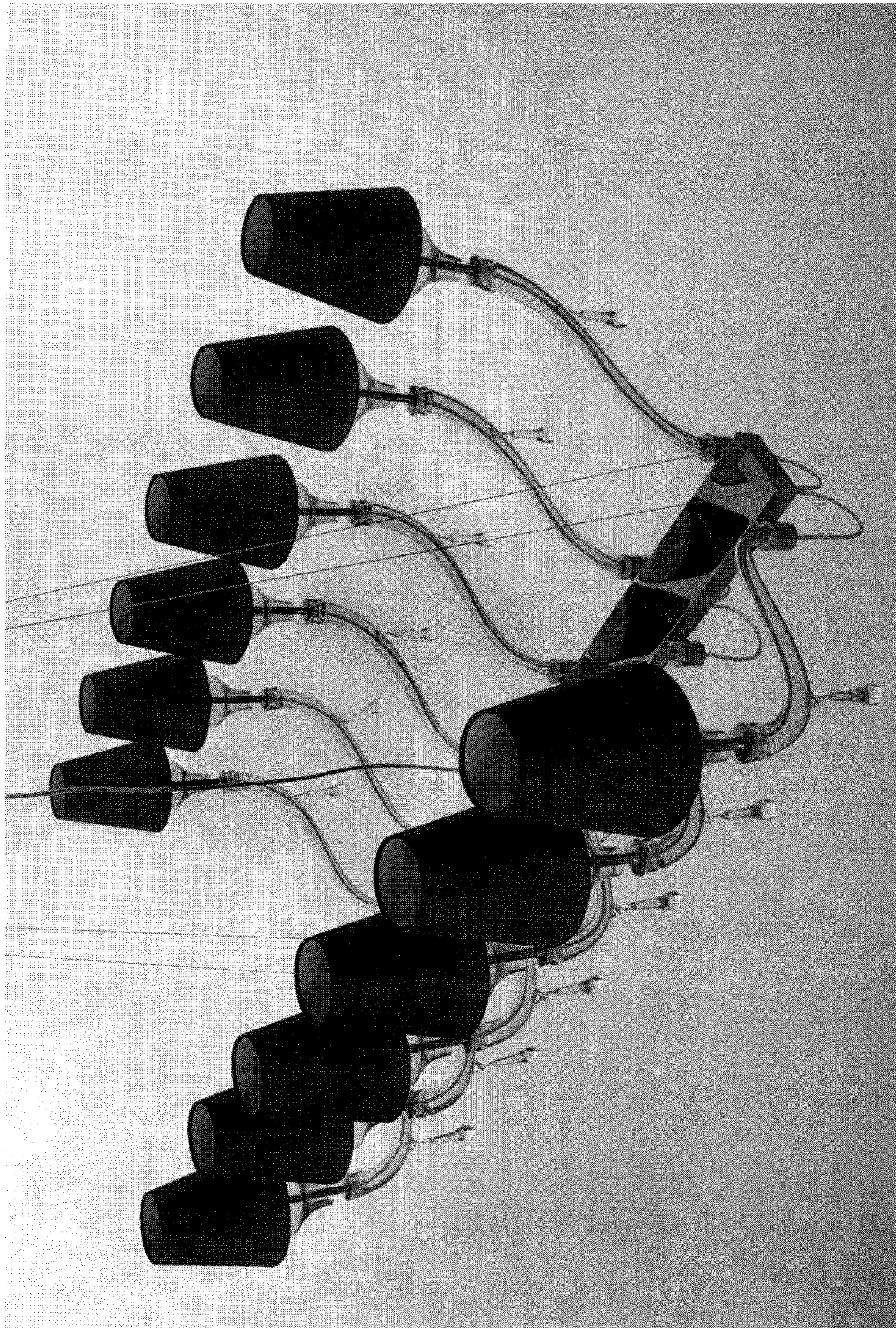

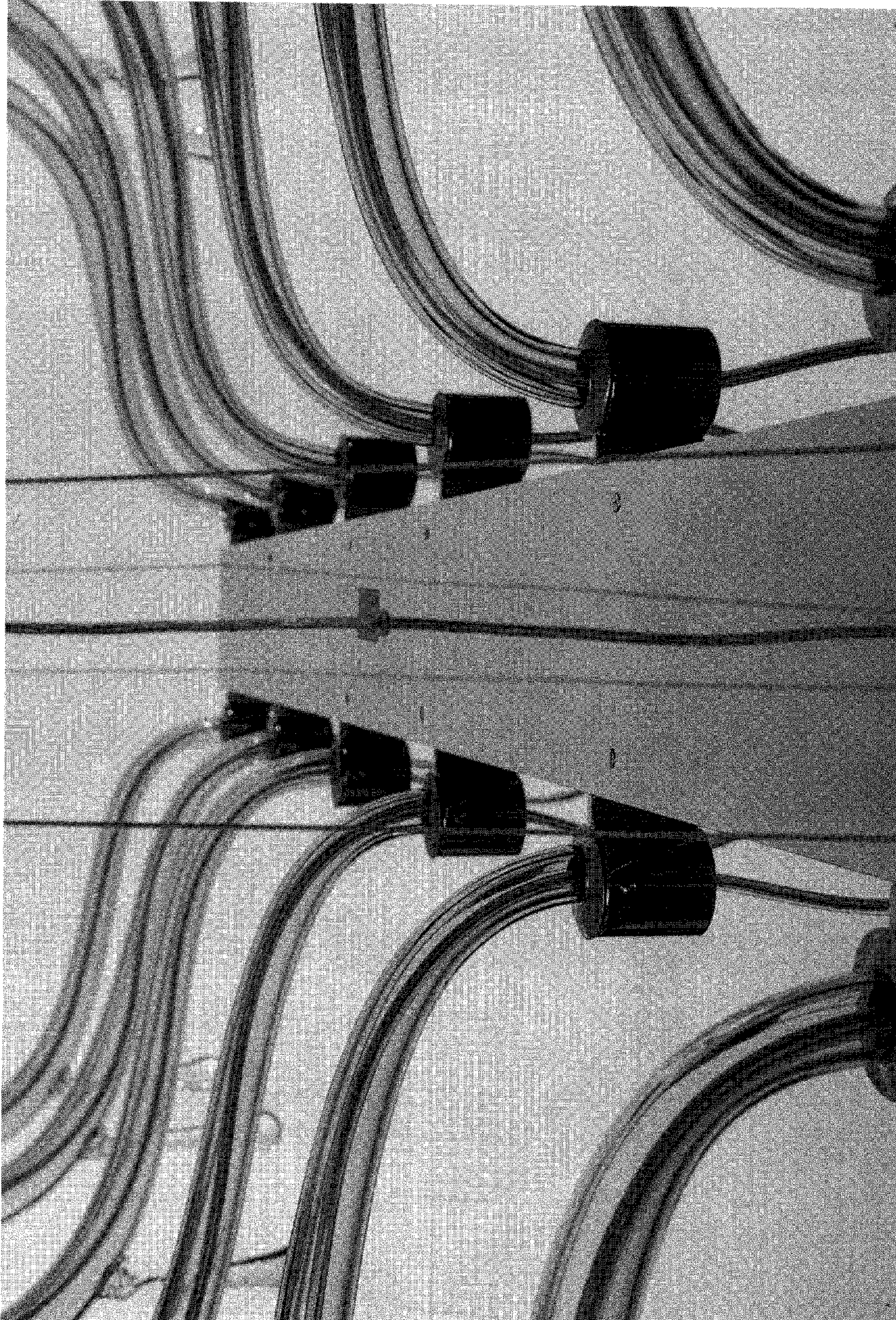

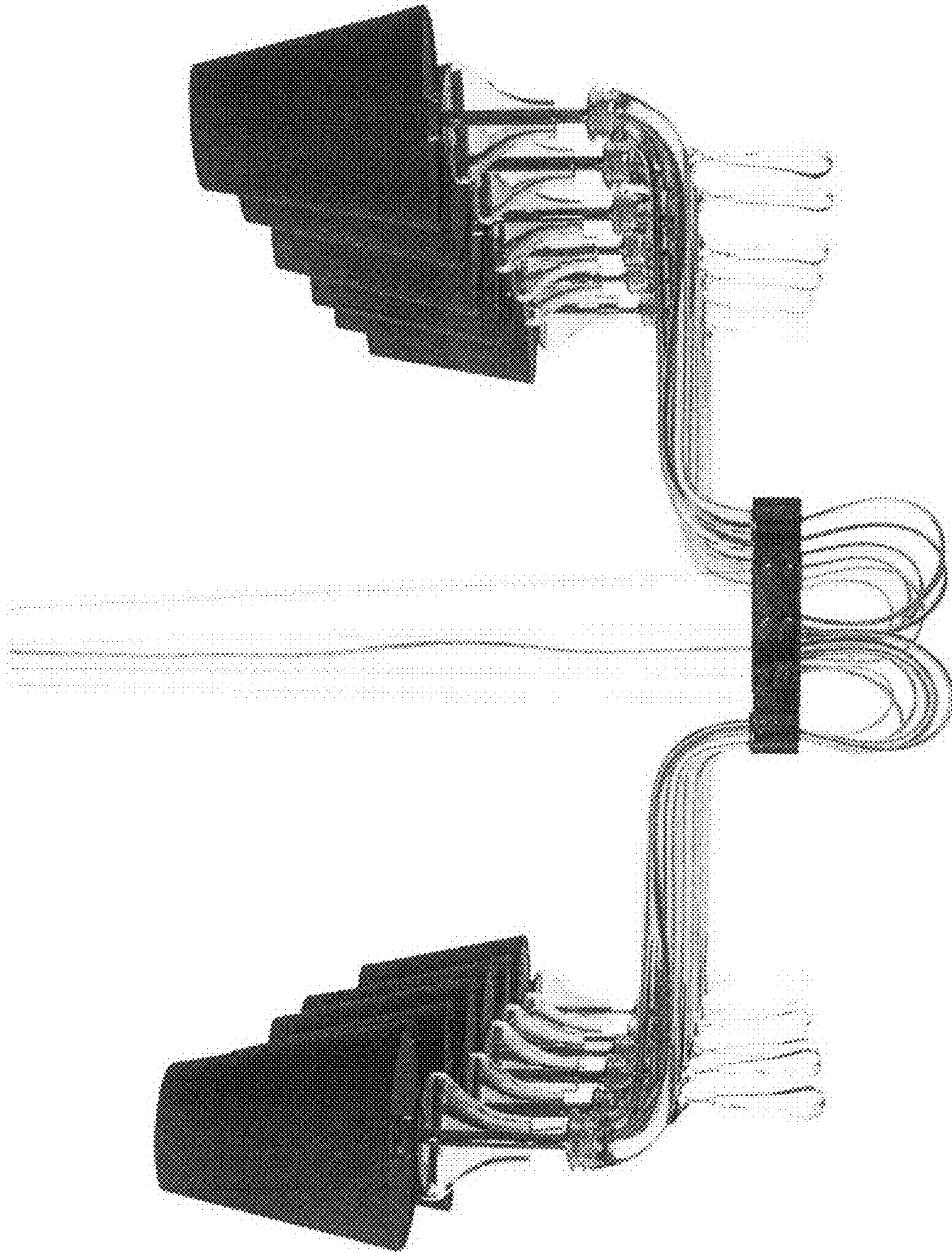

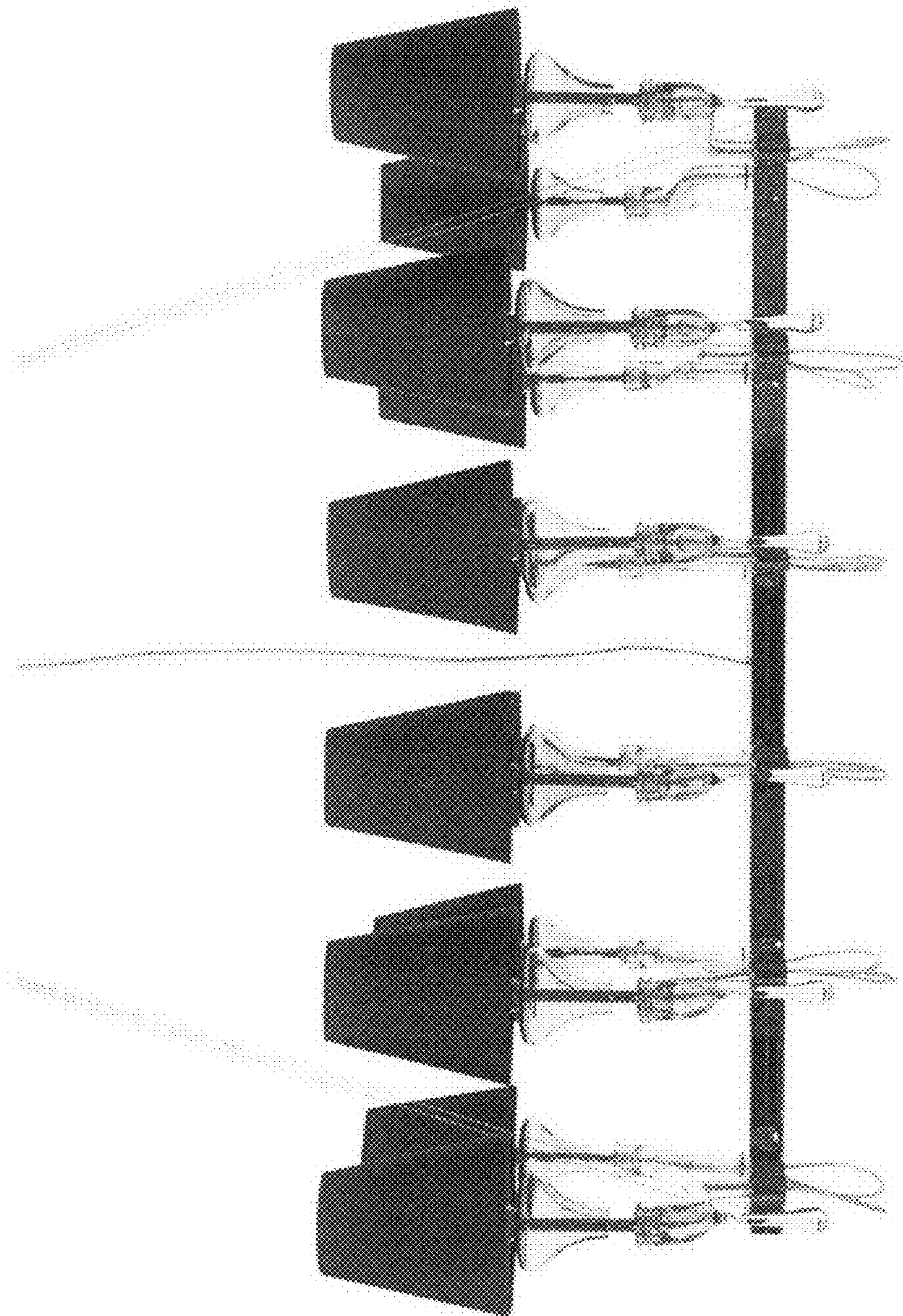

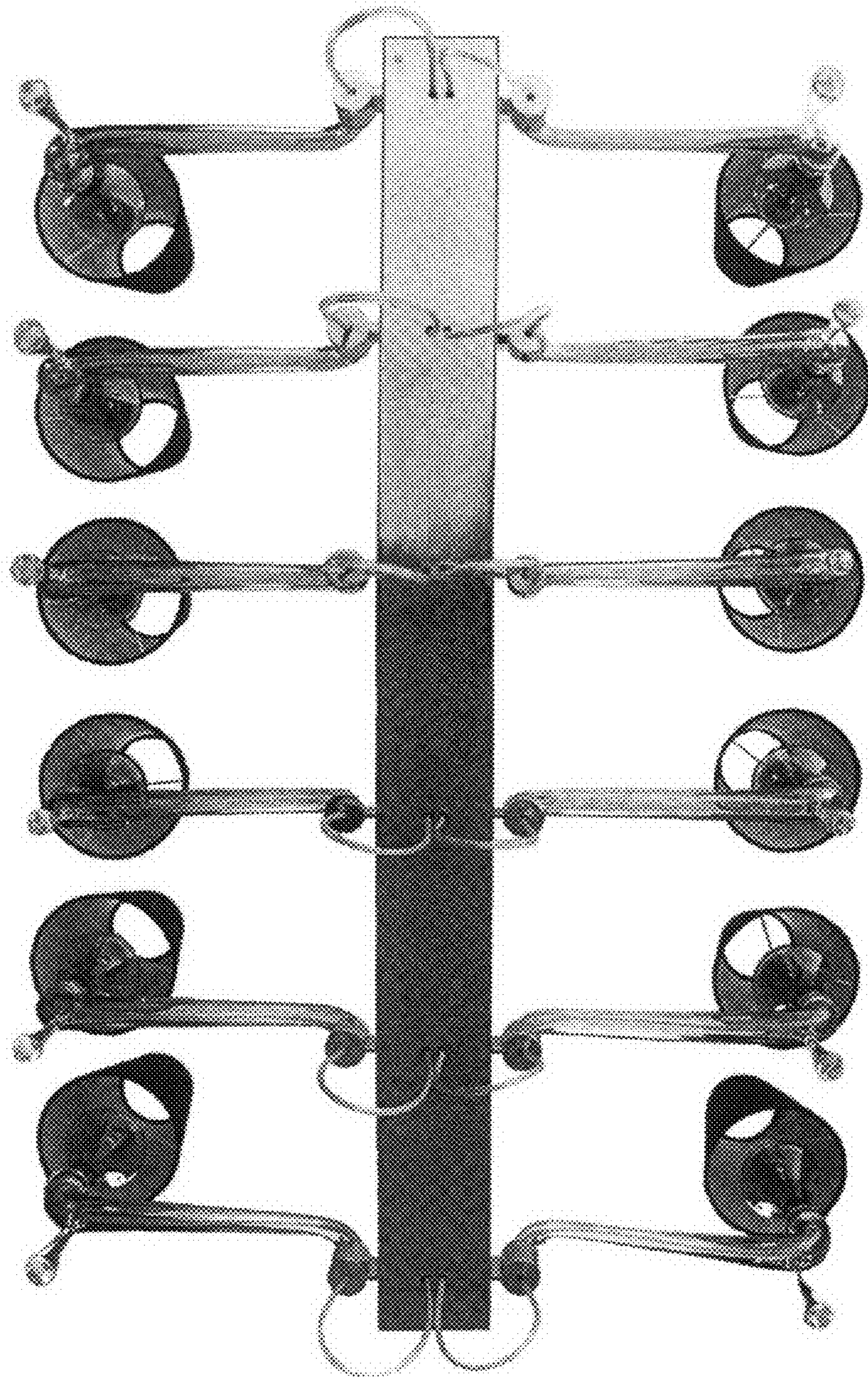

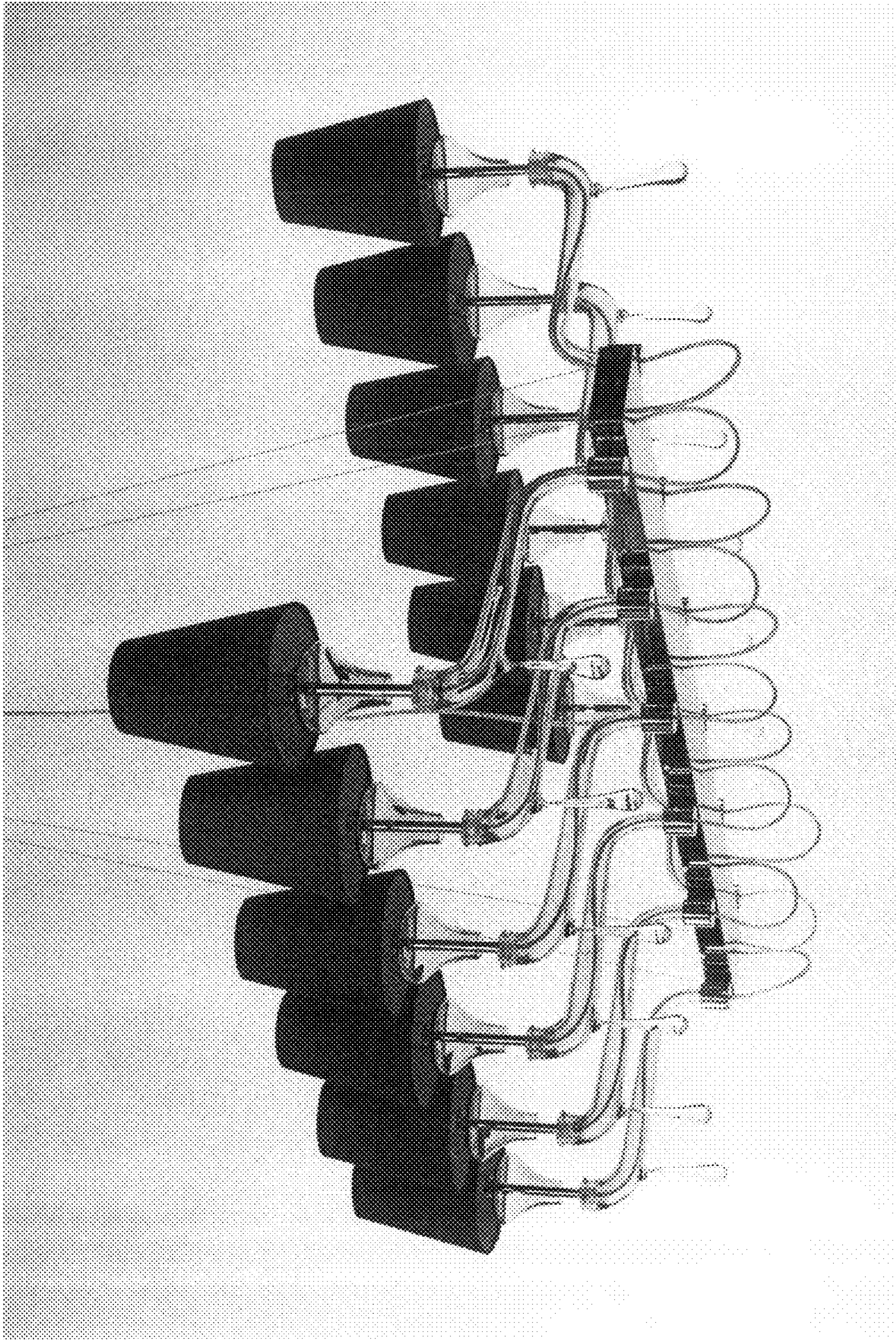

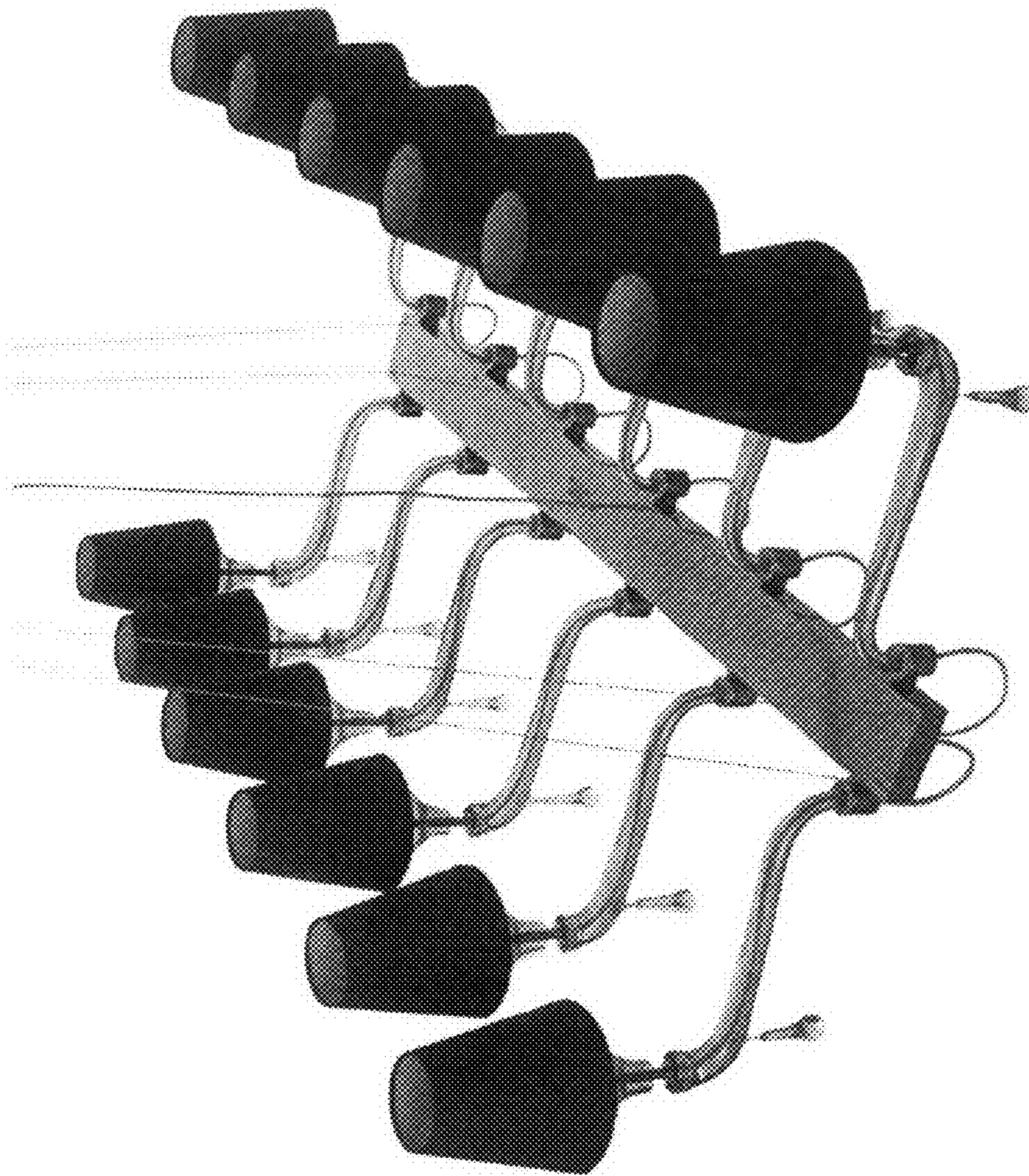

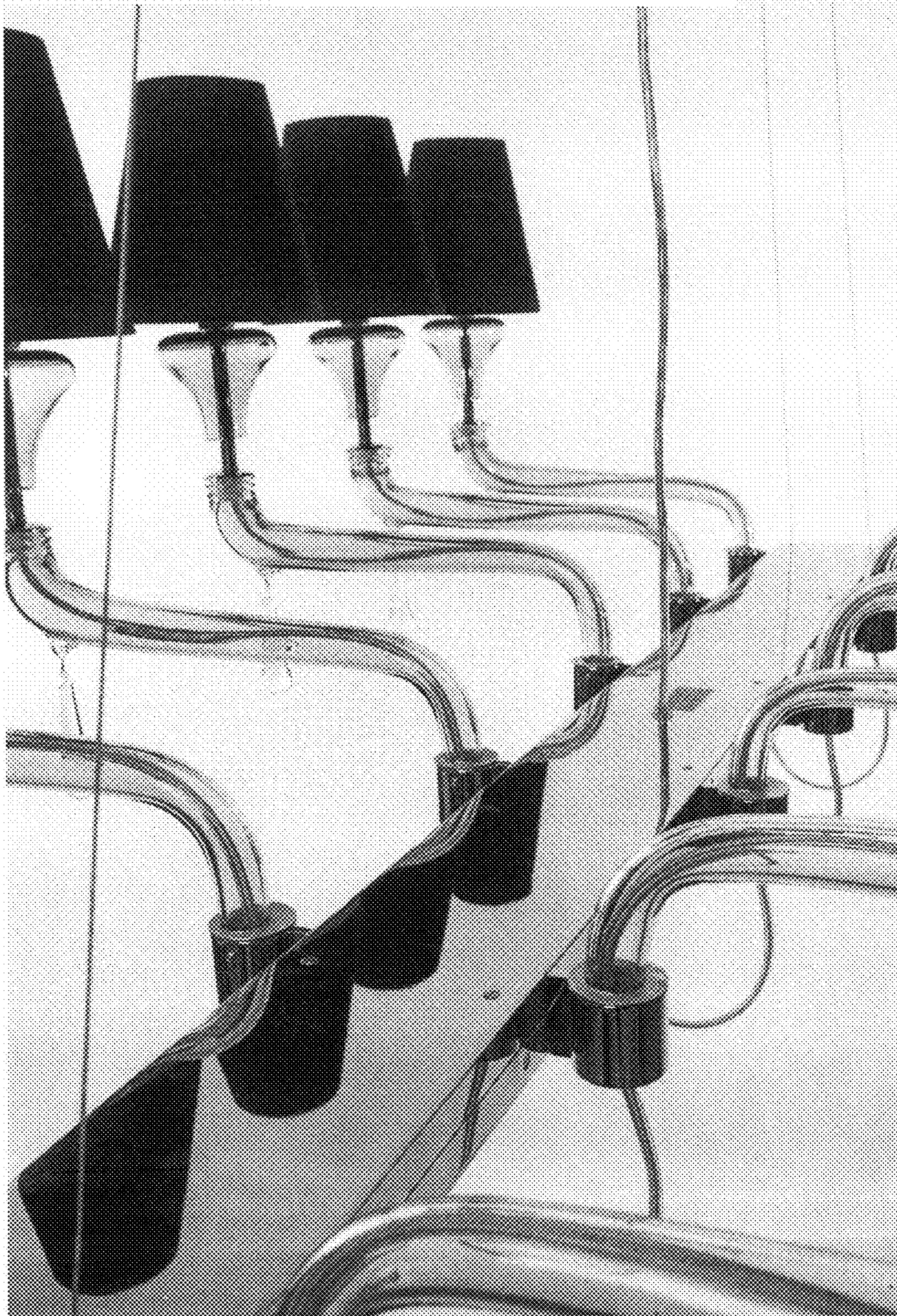
