FIG. 3 is a rear view of FIG. 1;

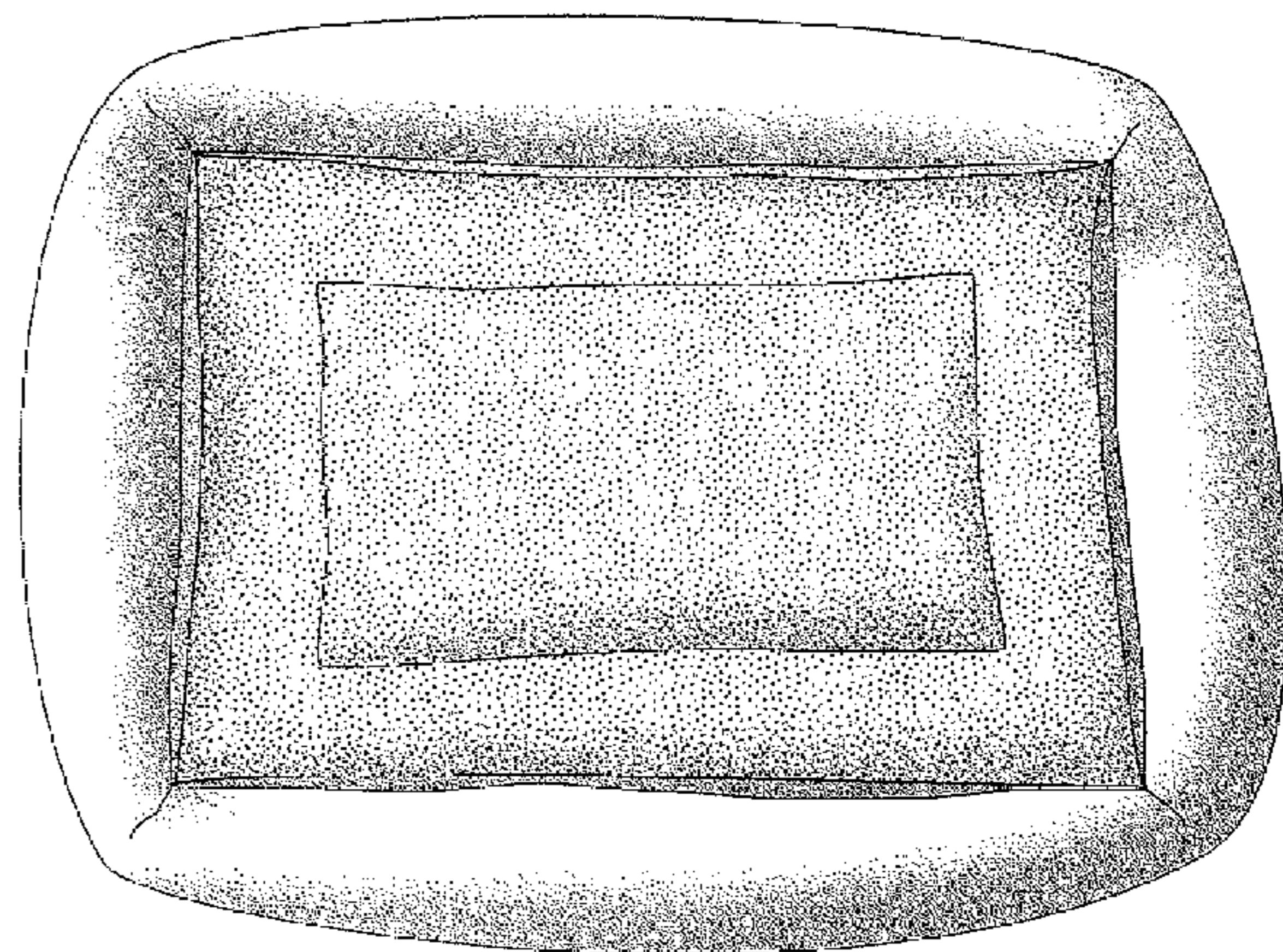
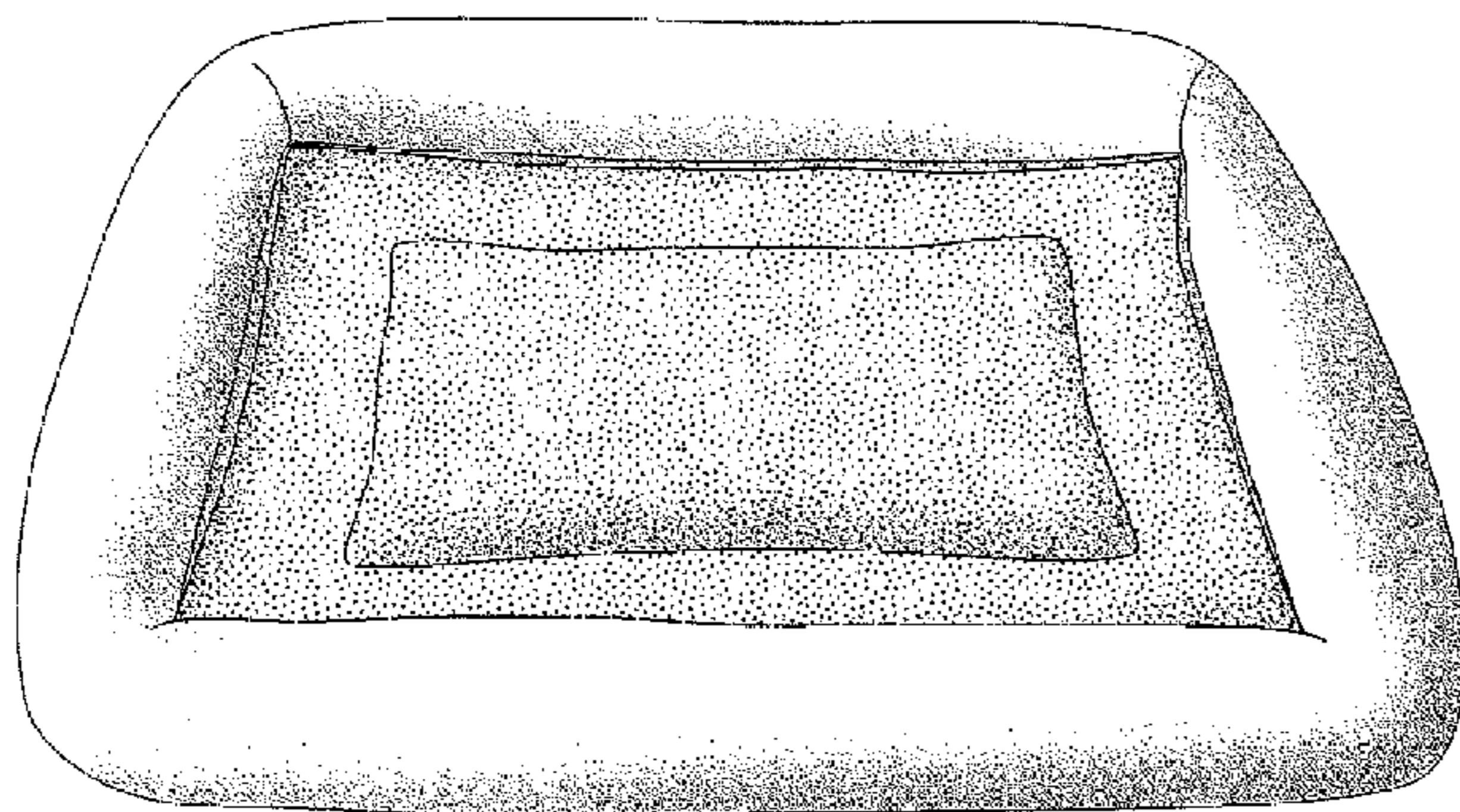
FIG. 4 is a right side view of FIG. 1;

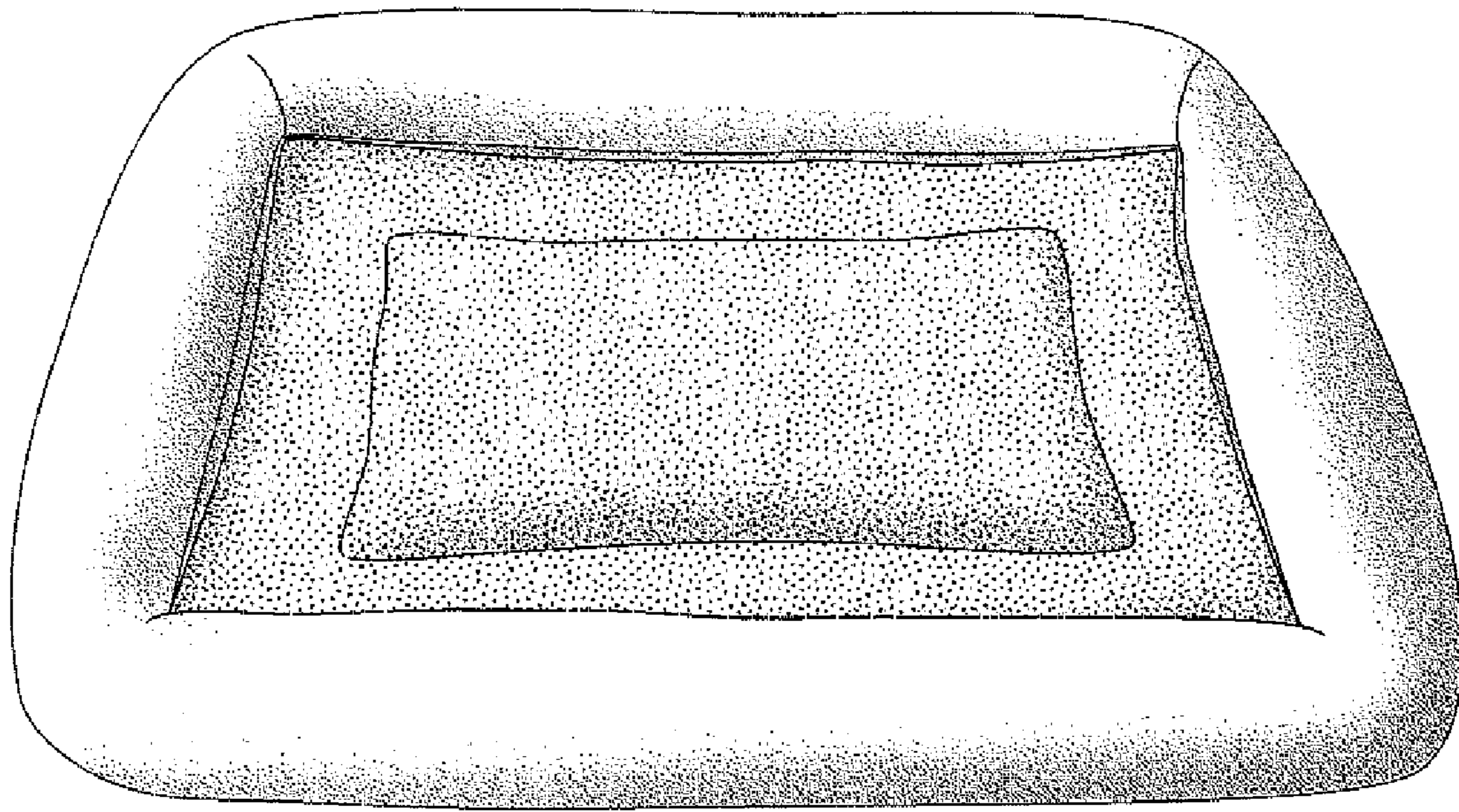

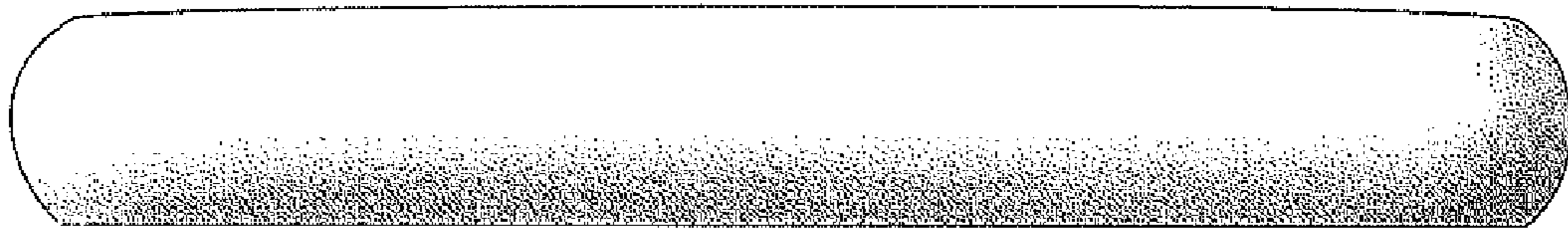

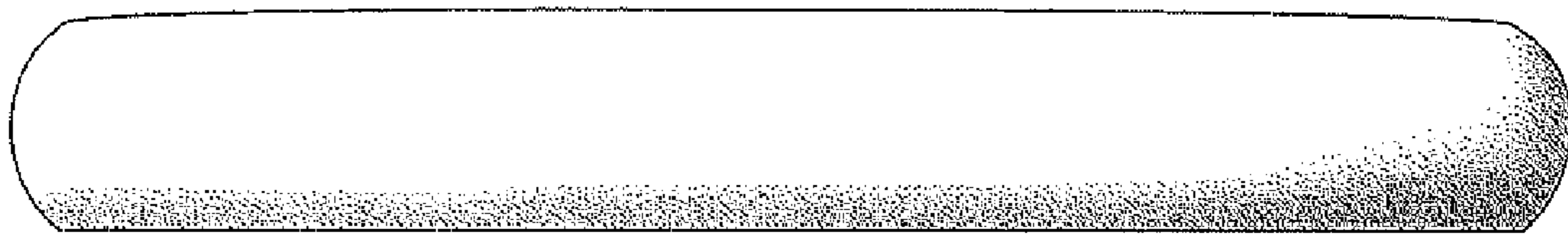

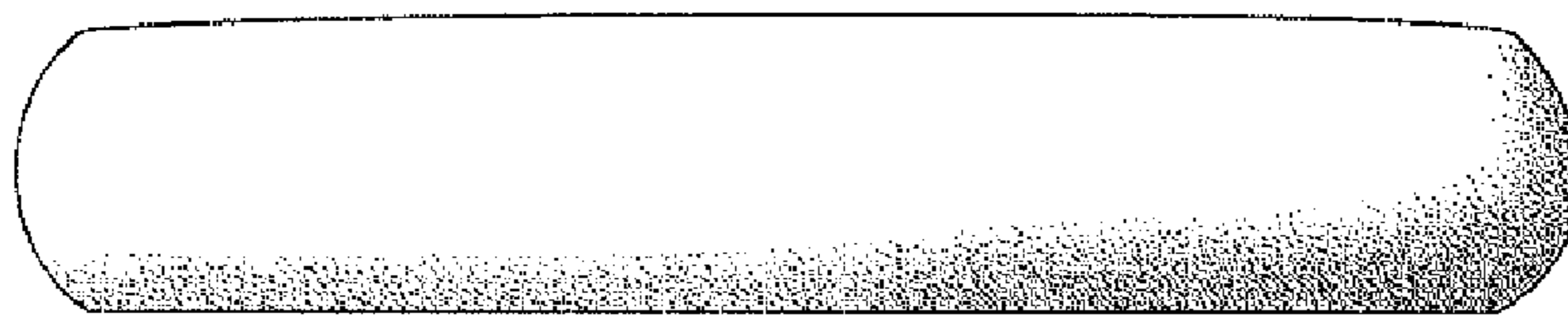

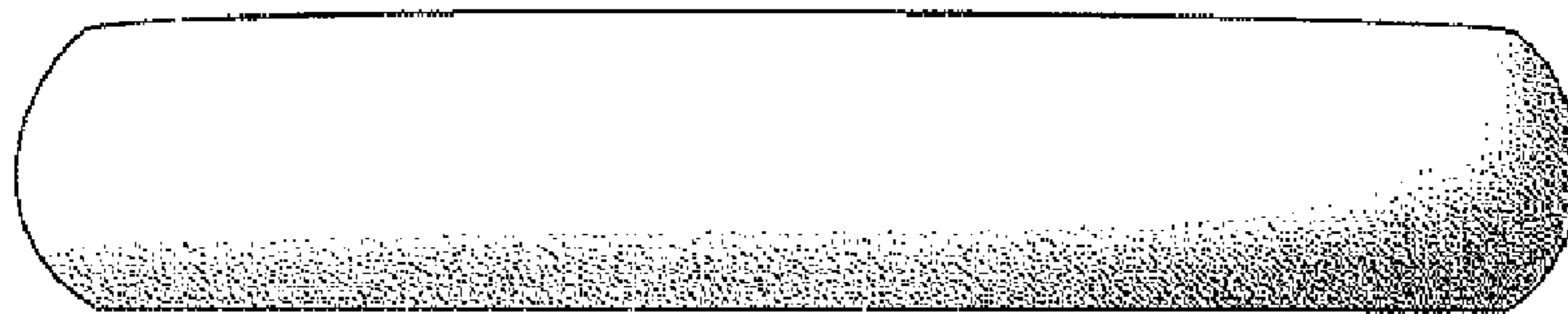

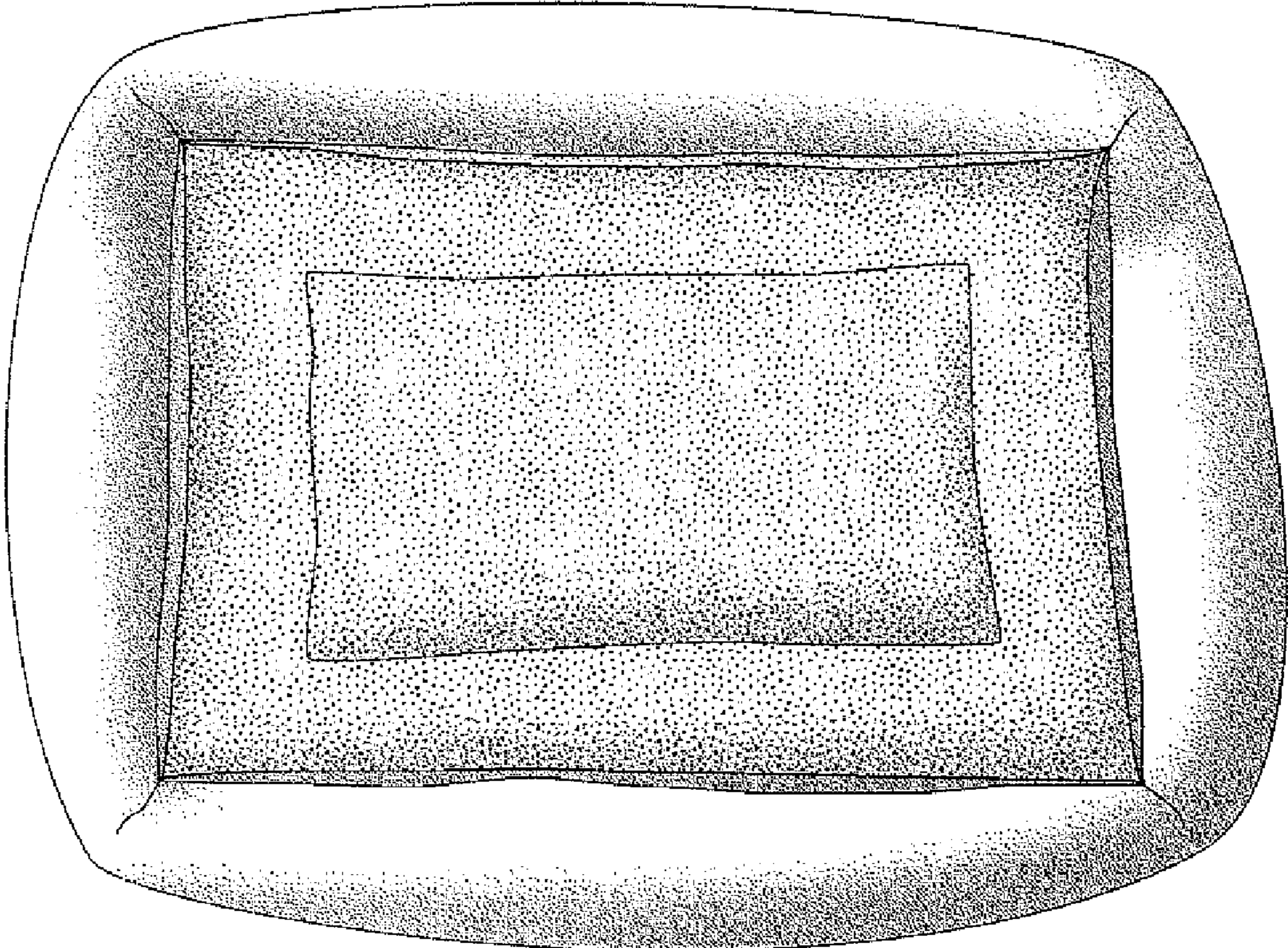

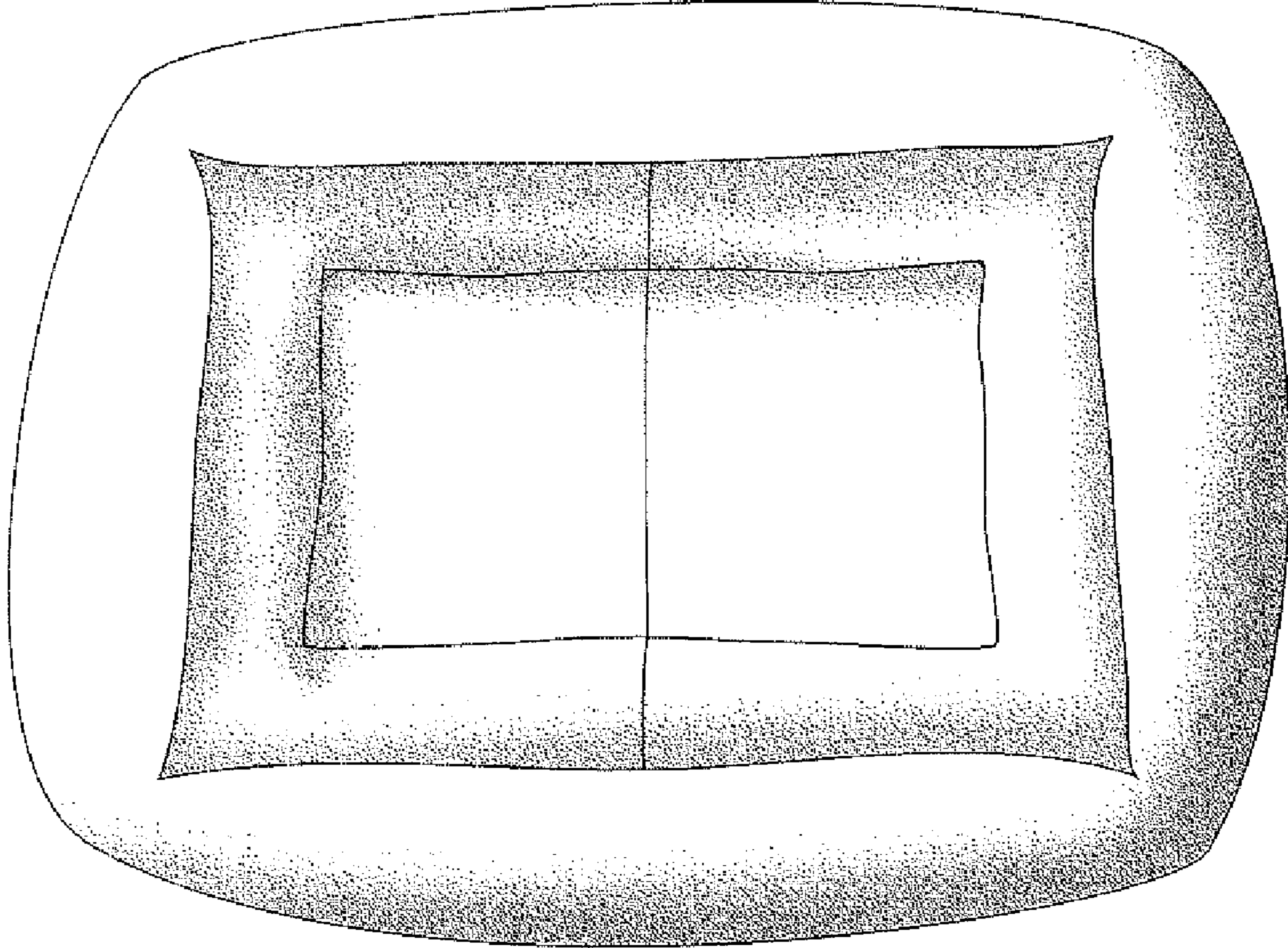
