FIG. 2 is a bottom-front-right perspective view thereof;

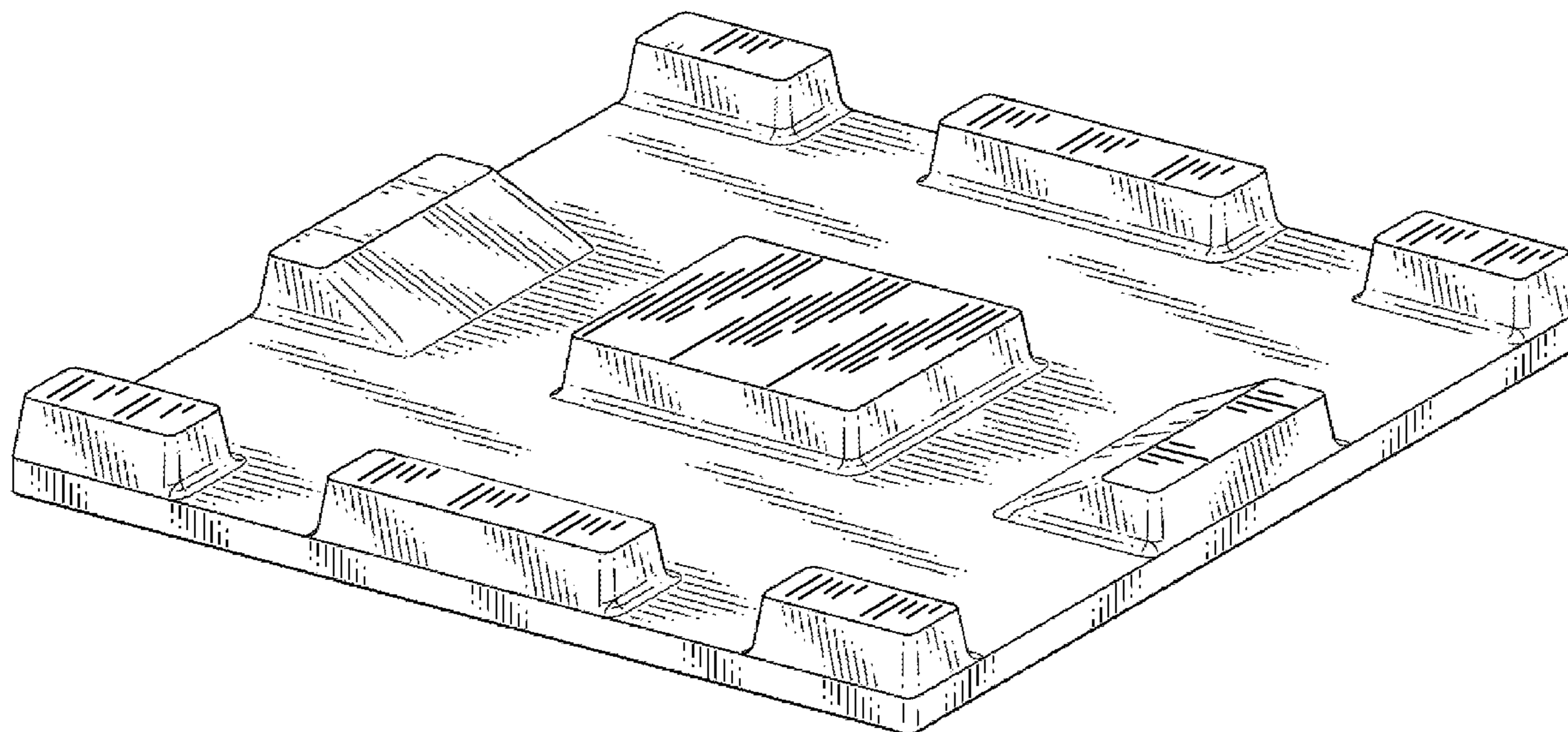
FIG. 3 is a bottom plan view thereof;

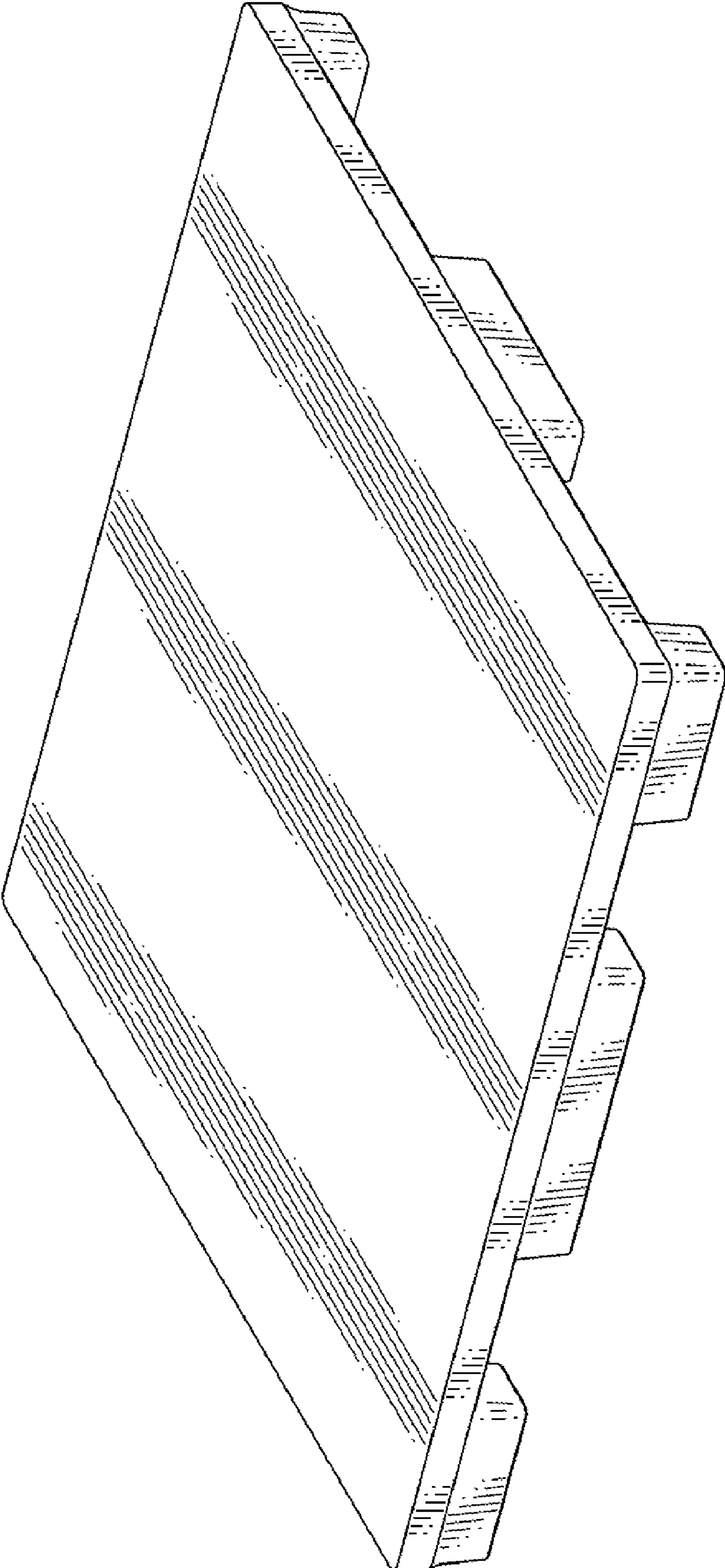
FIG. 4 is a front elevational view thereof; the back elevational view is a mirror image thereof;

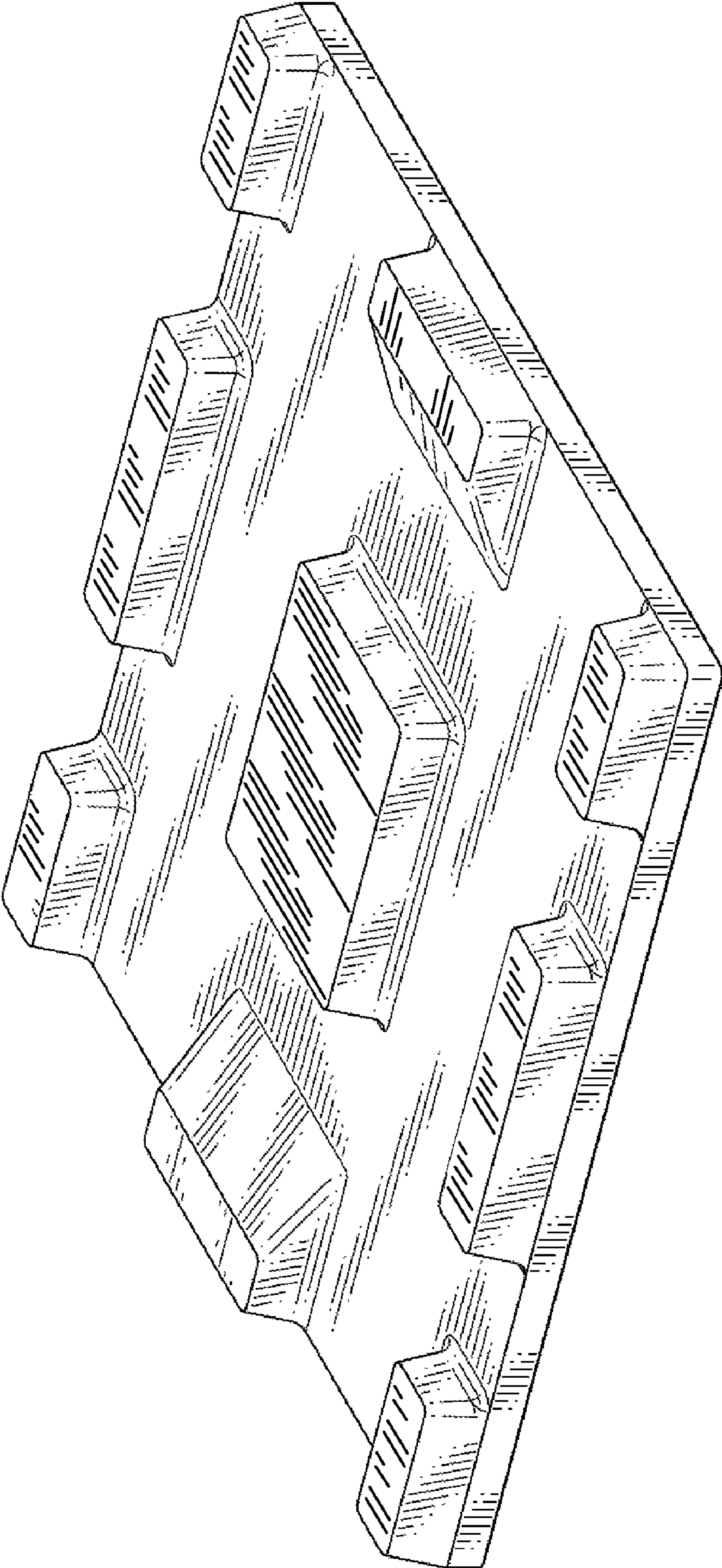

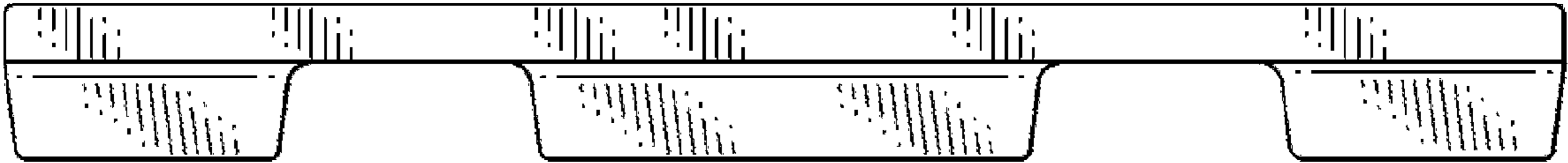
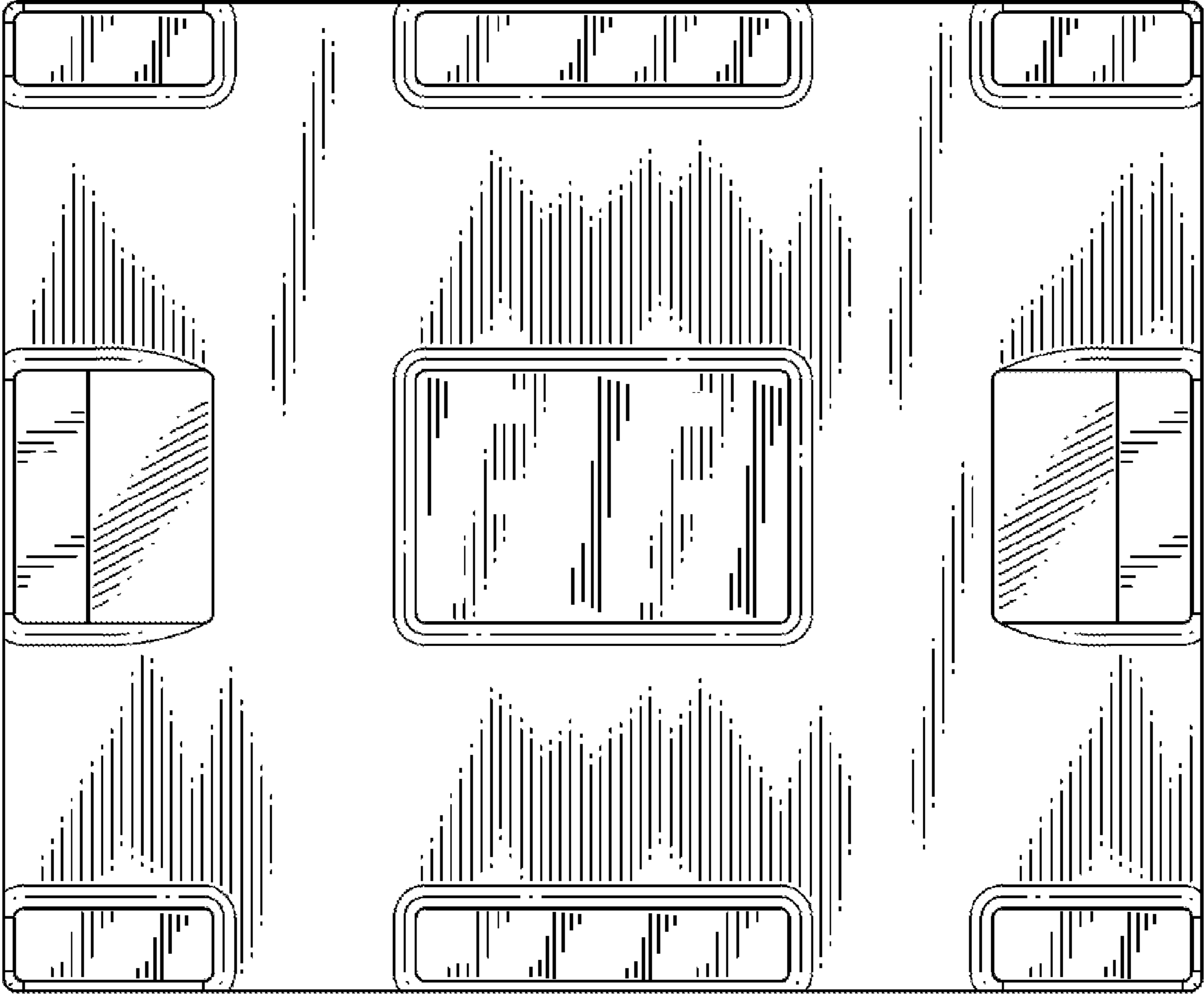
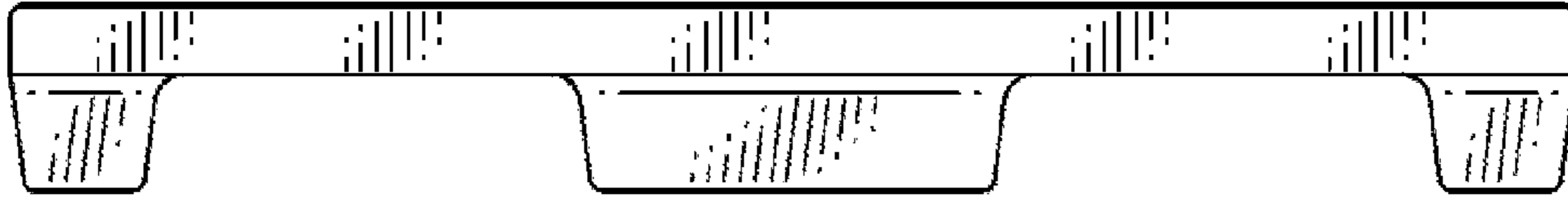
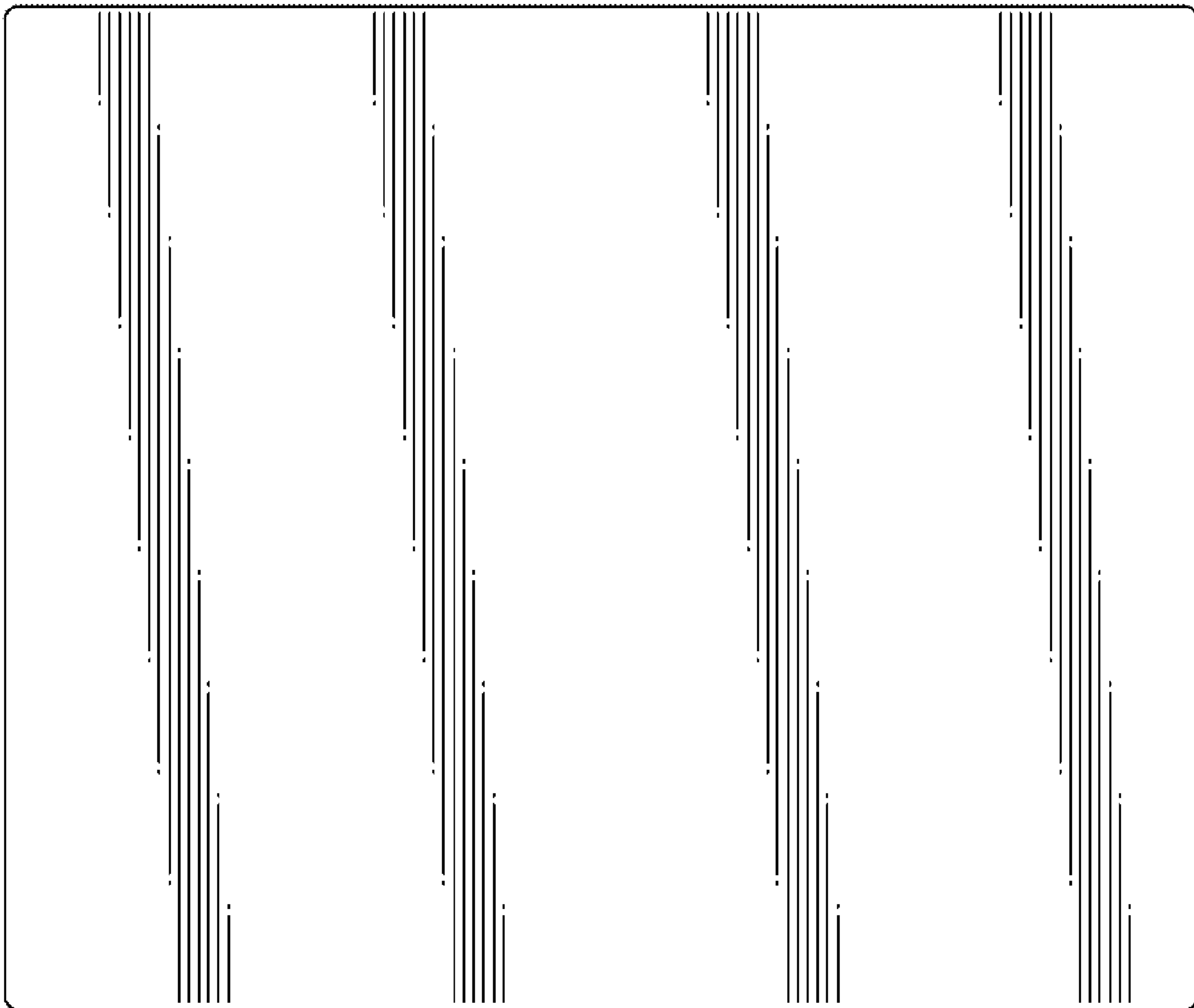
